(57) **CLAIM**

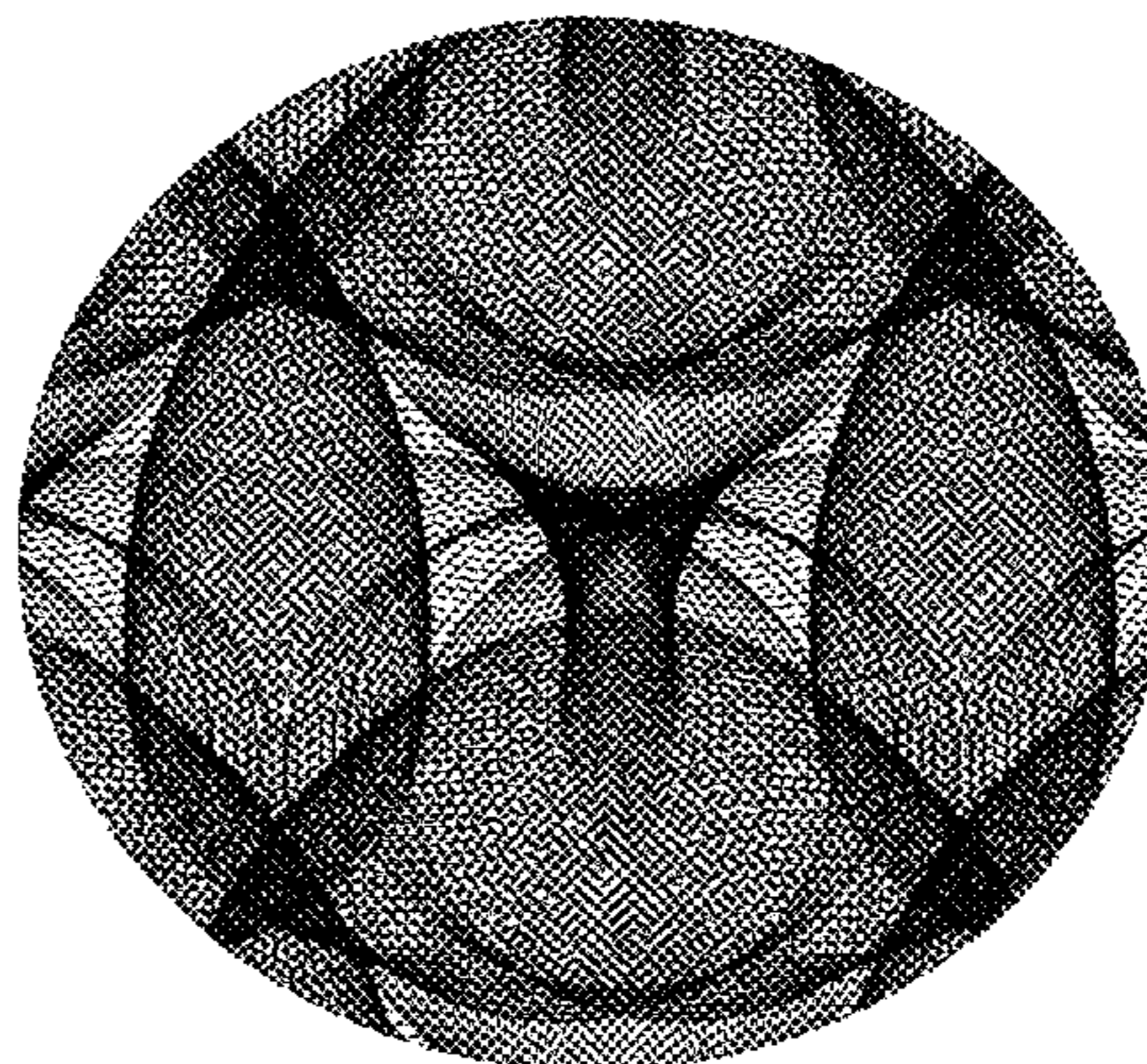
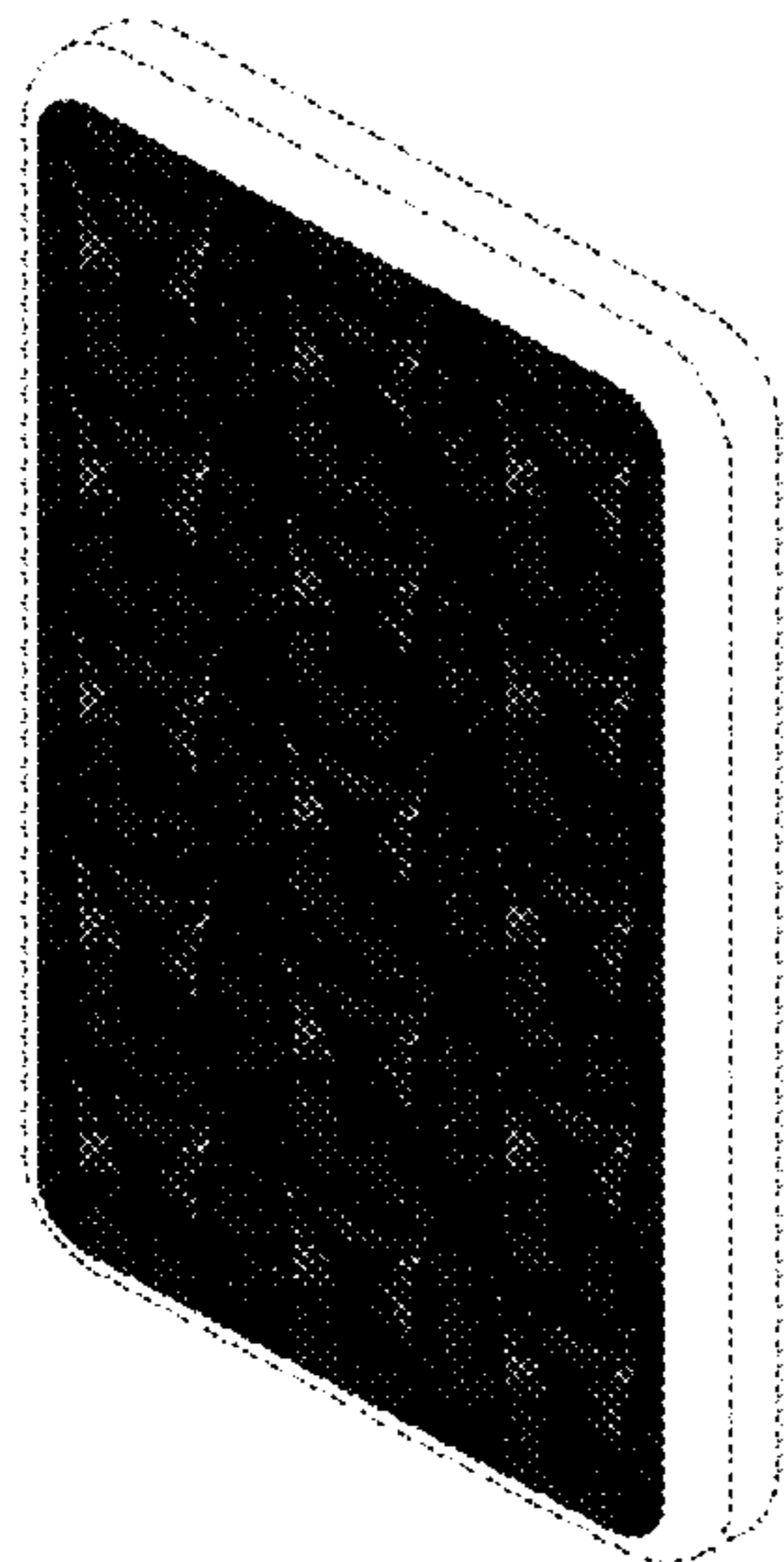
The ornamental design for a cover of an electronic device with surface pattern, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cover of an electronic device with surface pattern showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a side elevational view thereof; and, FIG. 4 is an enlarged view thereof, of circled portion 4 in FIG. 2.

In FIGS. 1-3, the evenly segmented broken lines indicate portions of the cover of an electronic device with surface pattern that form no part of the claimed design. In FIGS. 2 and 4, the alternating long-dash short-dash type broken lines represent the boundary of the portion of the electronic device with surface pattern that is shown on an enlarged scale in FIG. 4.

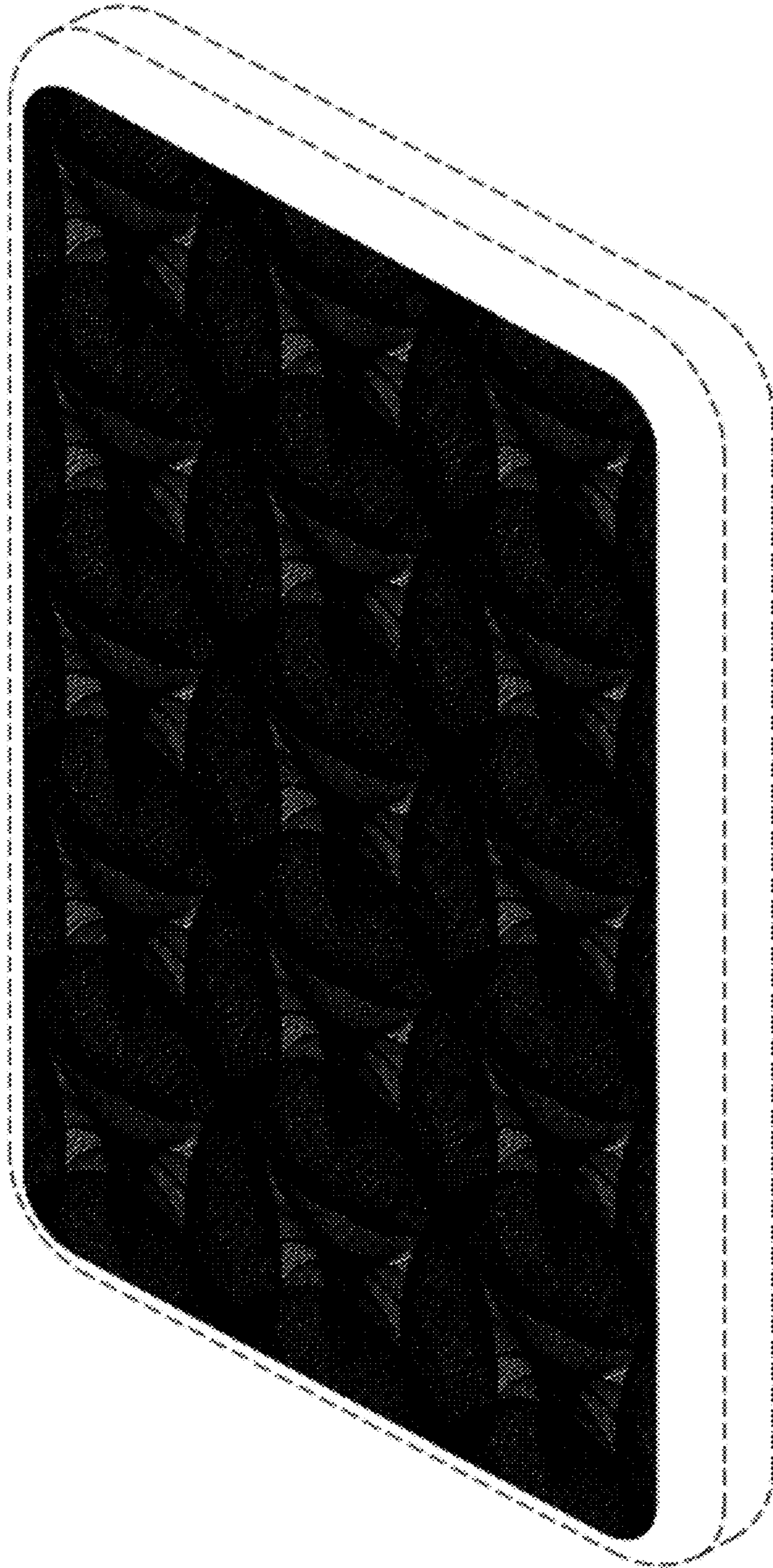

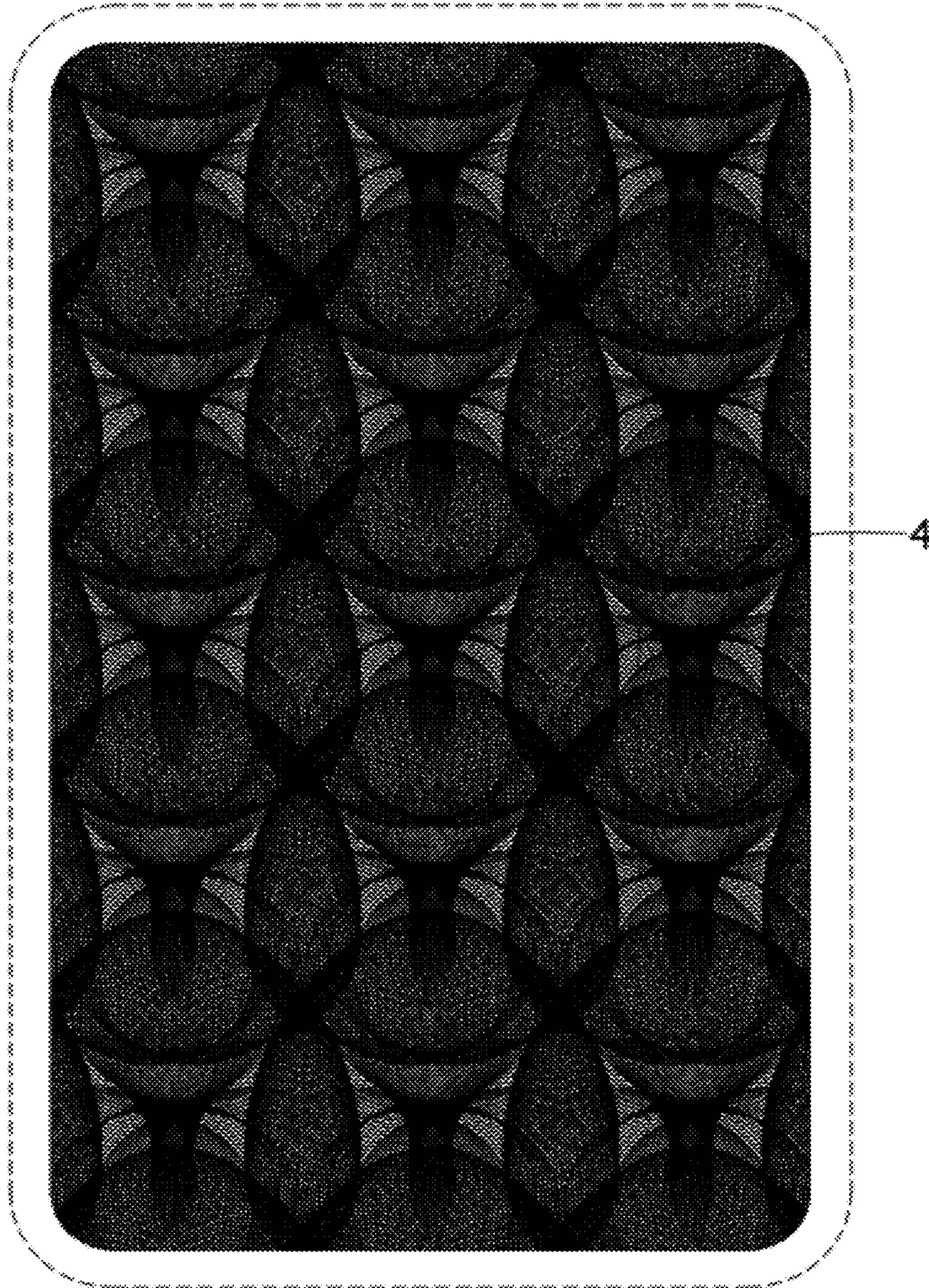

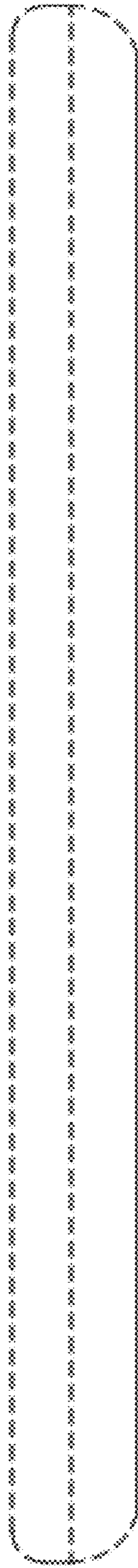

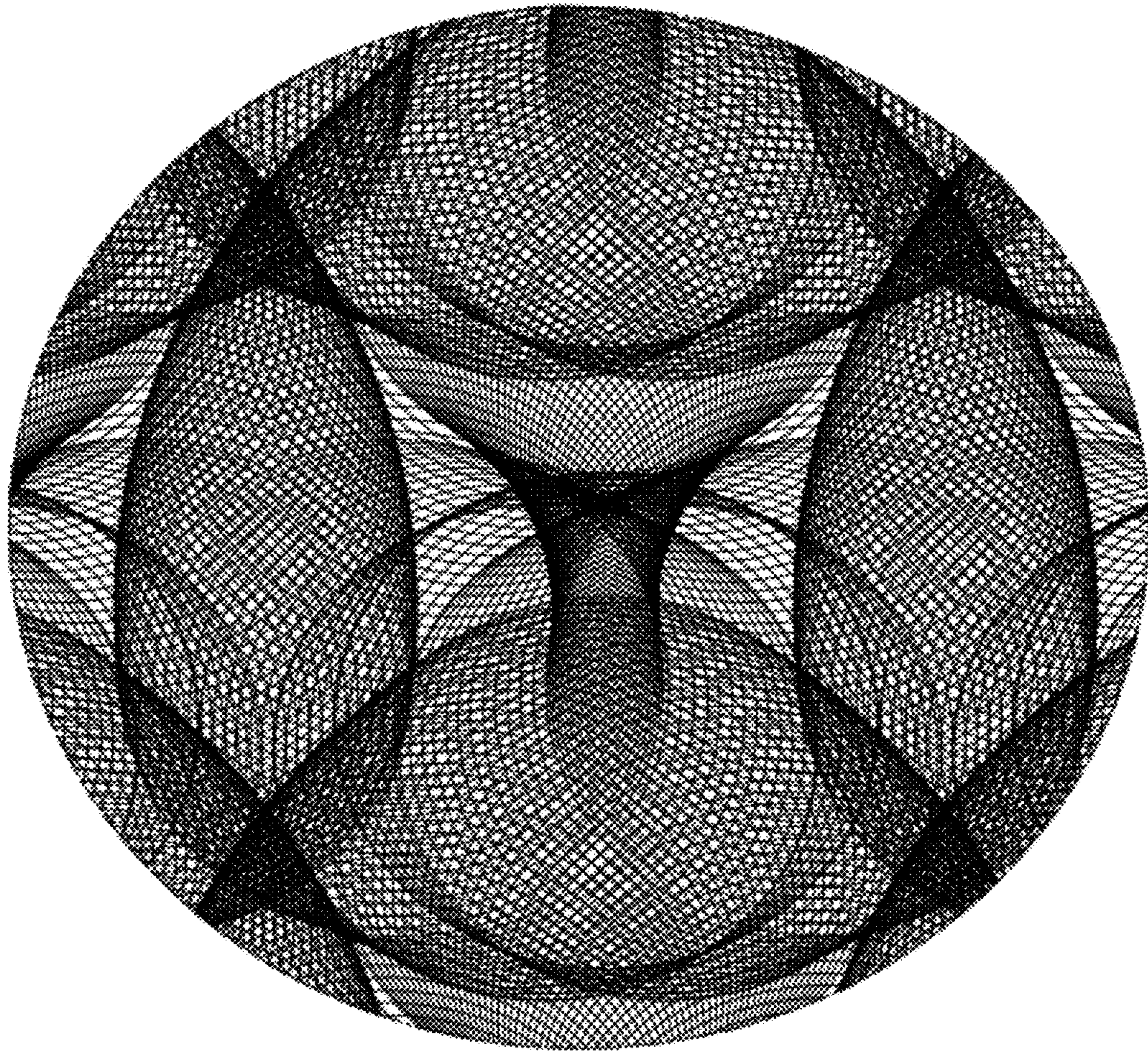
