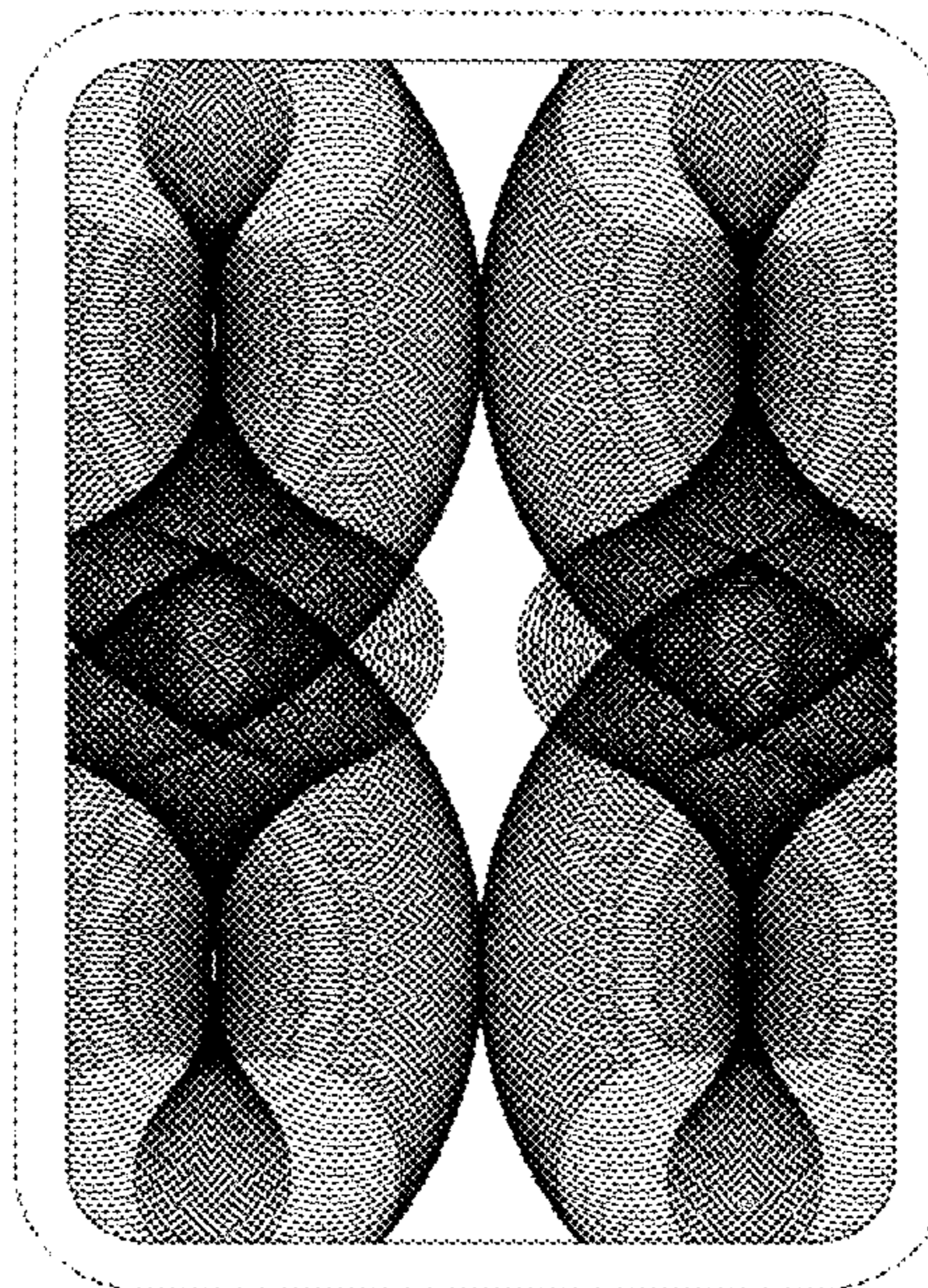
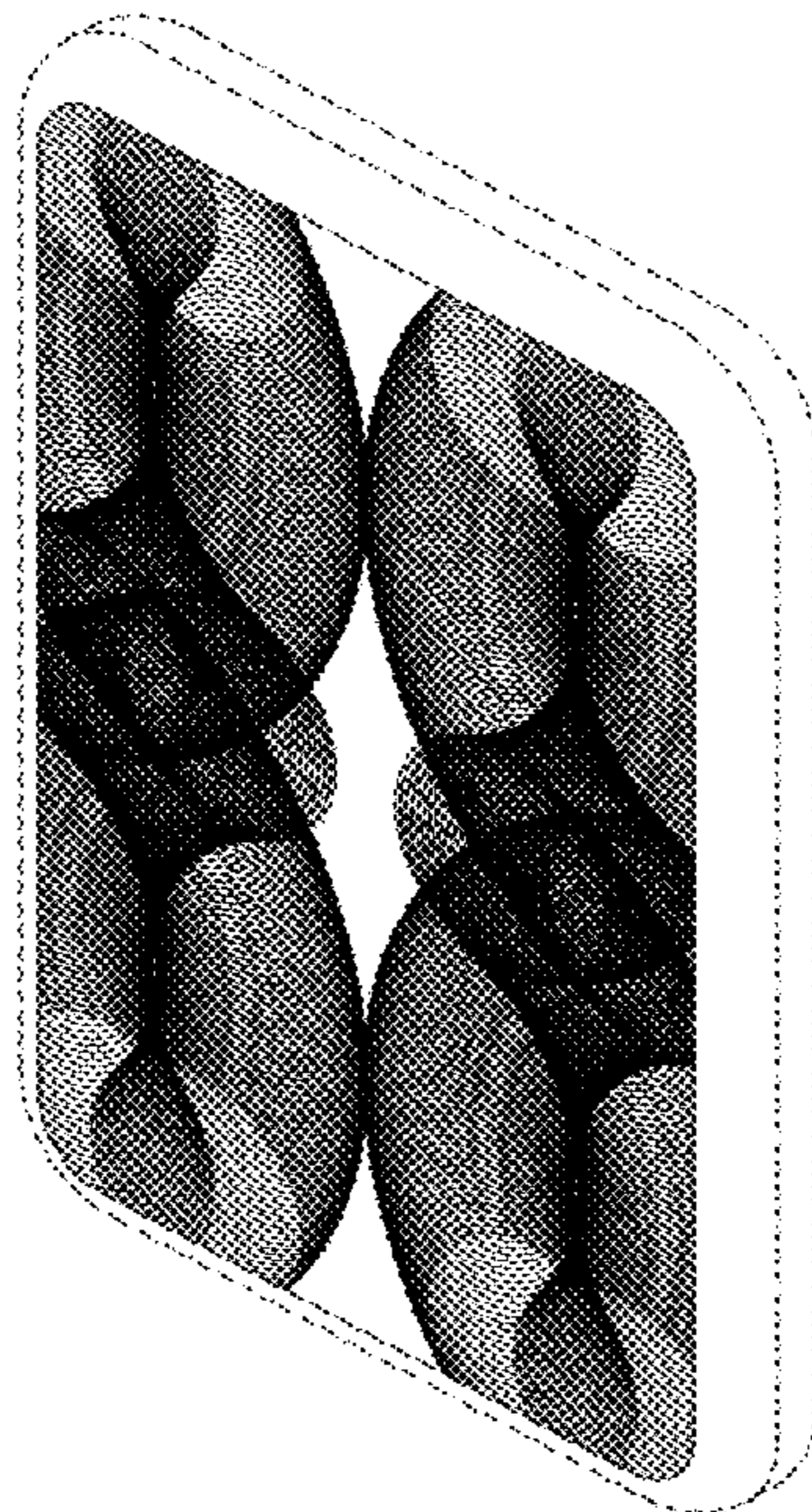

(57) **CLAIM**
The ornamental design for a cover of an electronic device with surface pattern, as shown and described.

DESCRIPTION

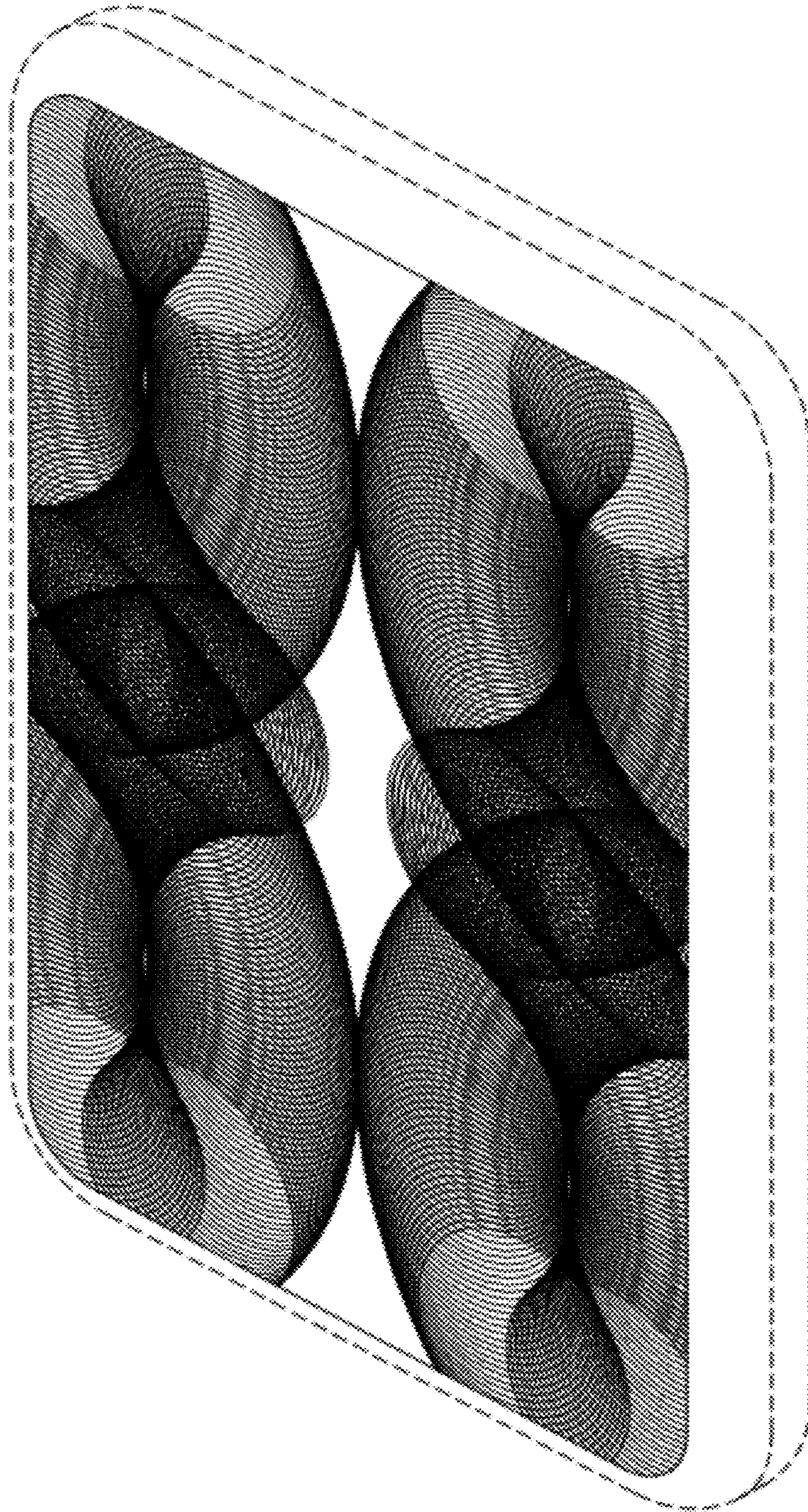

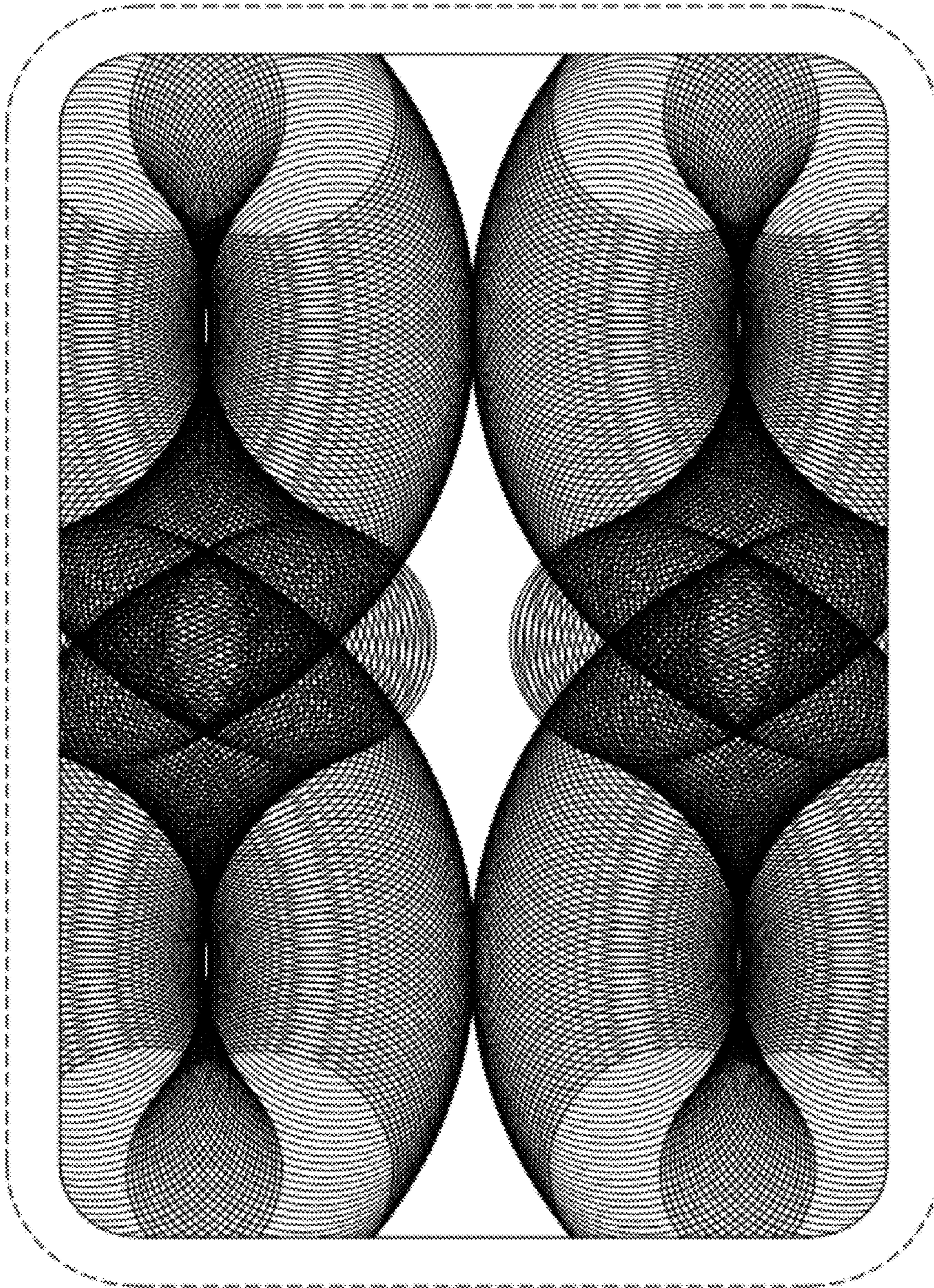
