The ornamental design for combined camera and housing therefor, as shown.

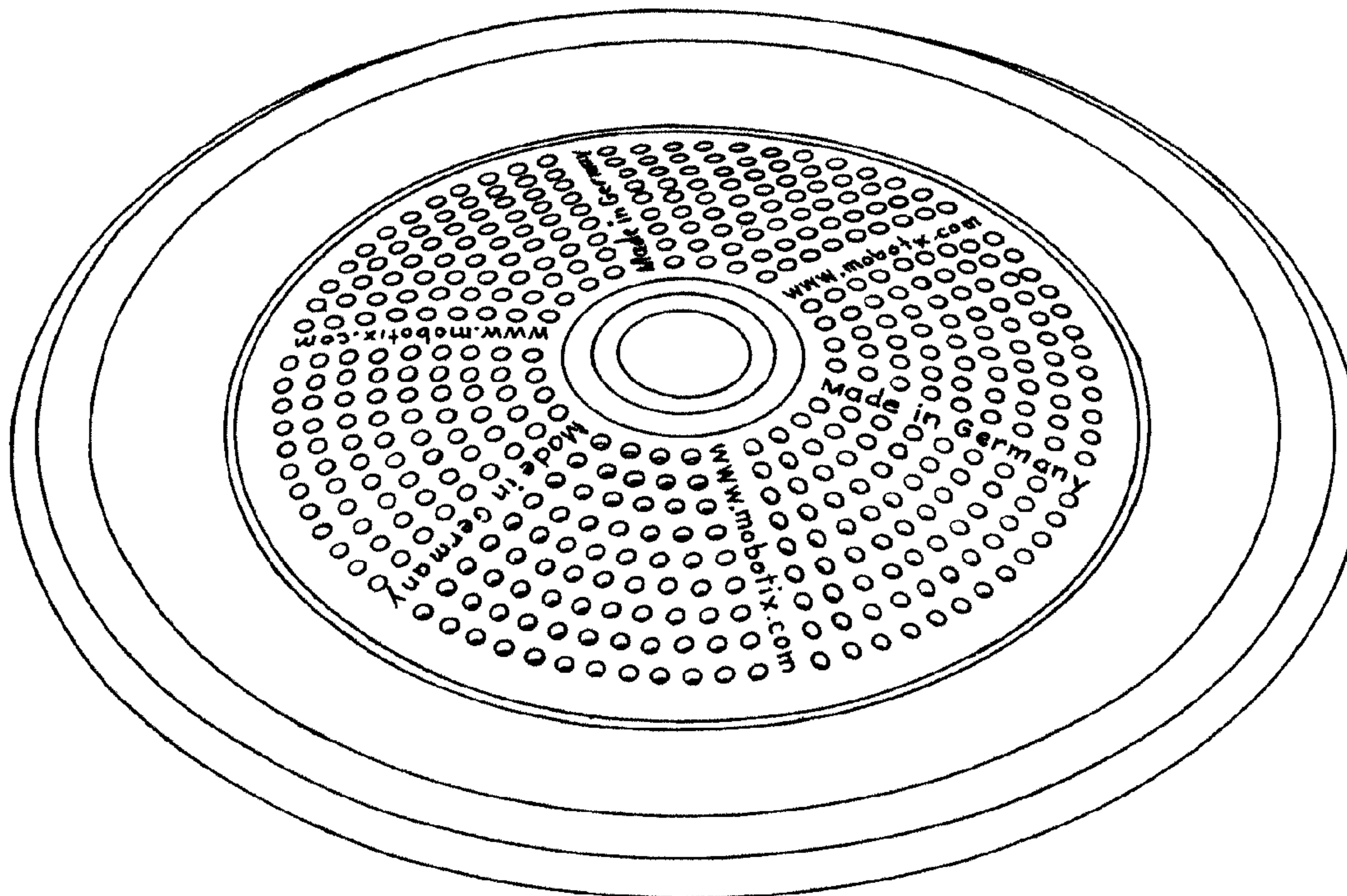
DESCRIPTION

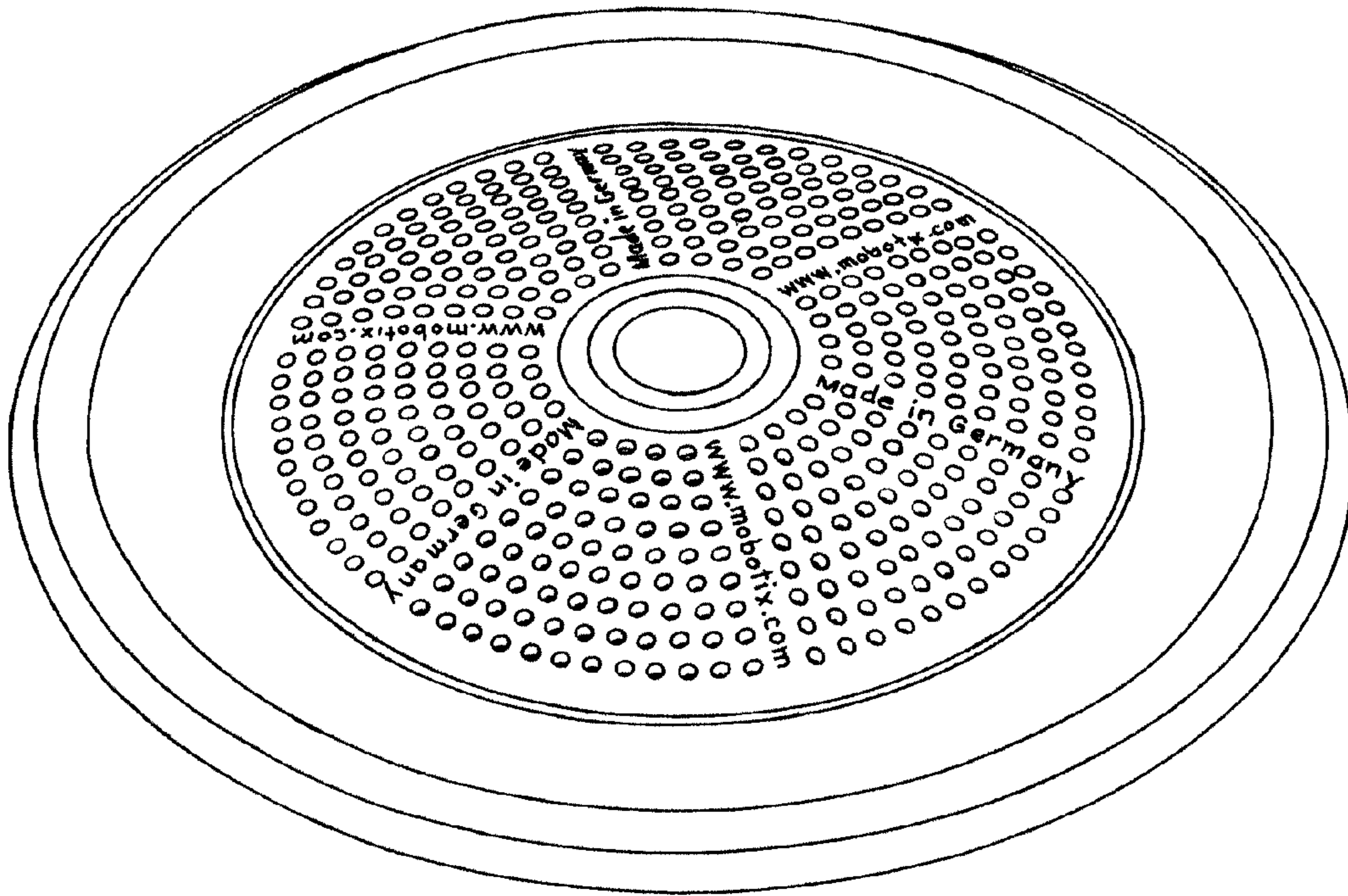

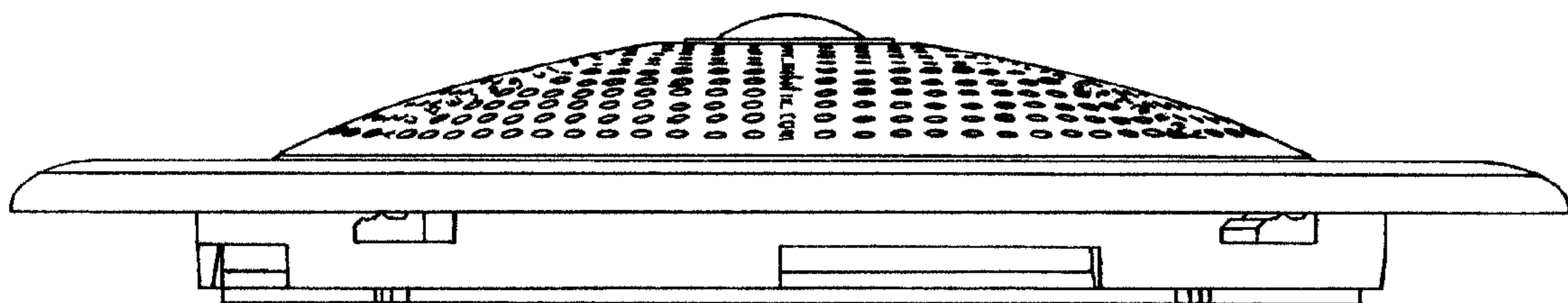

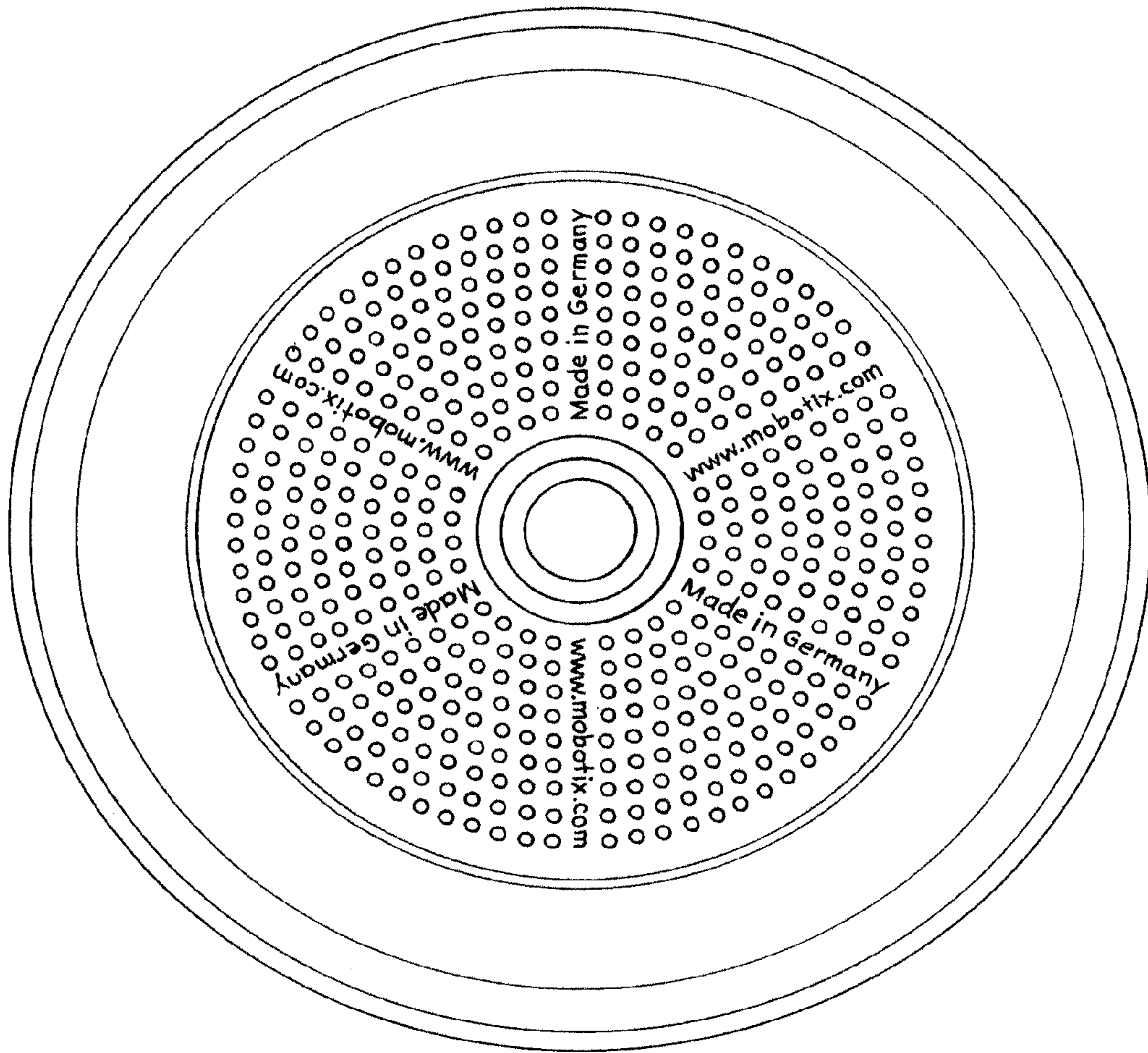
