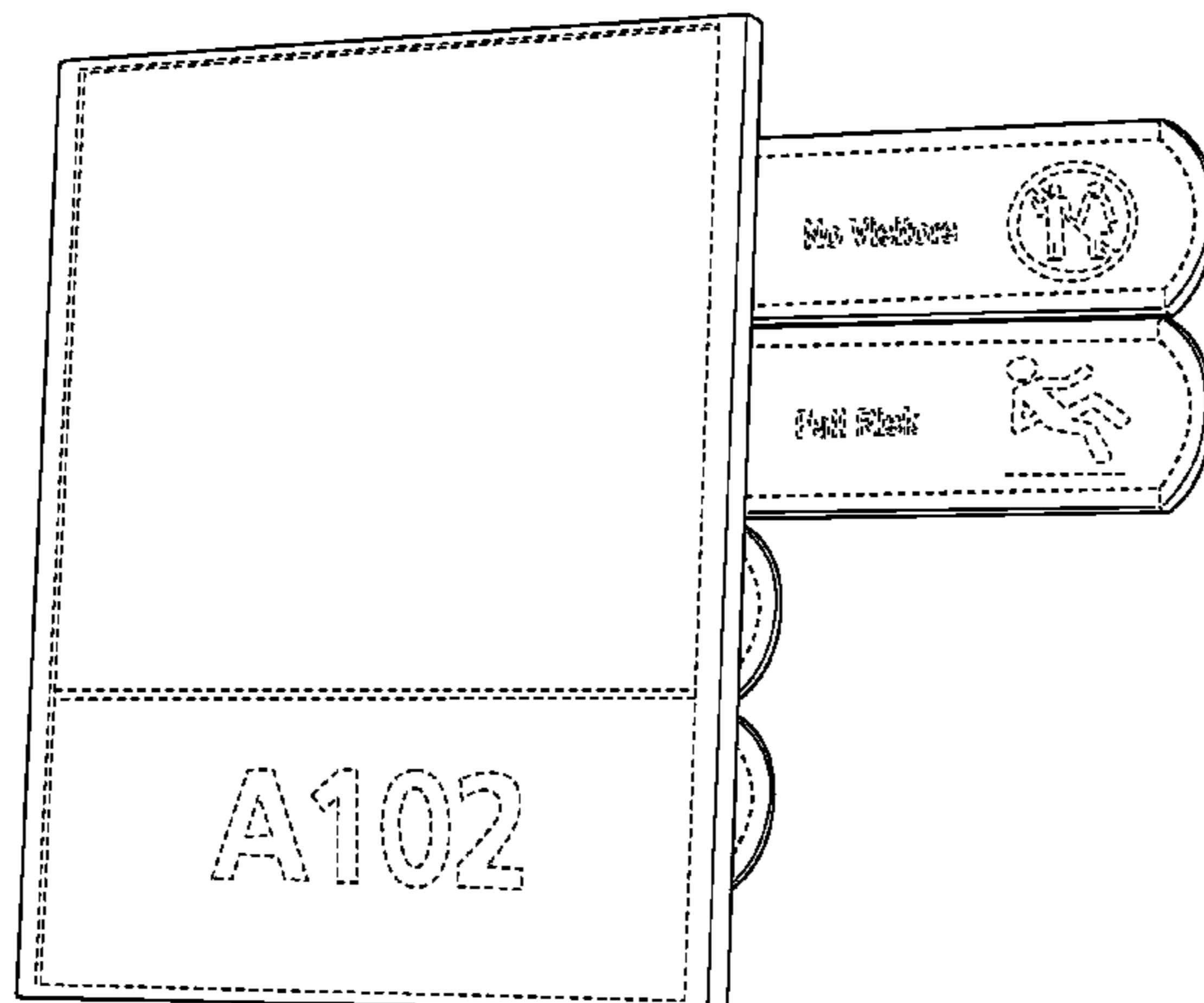
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of and information display according to our new design;
 FIG. 2 is a front plan view thereof;
 FIG. 3 is a rear plan view thereof;

 FIG. 5 is a right side elevation view thereof;
 FIG. 6 is a top plan view thereof;

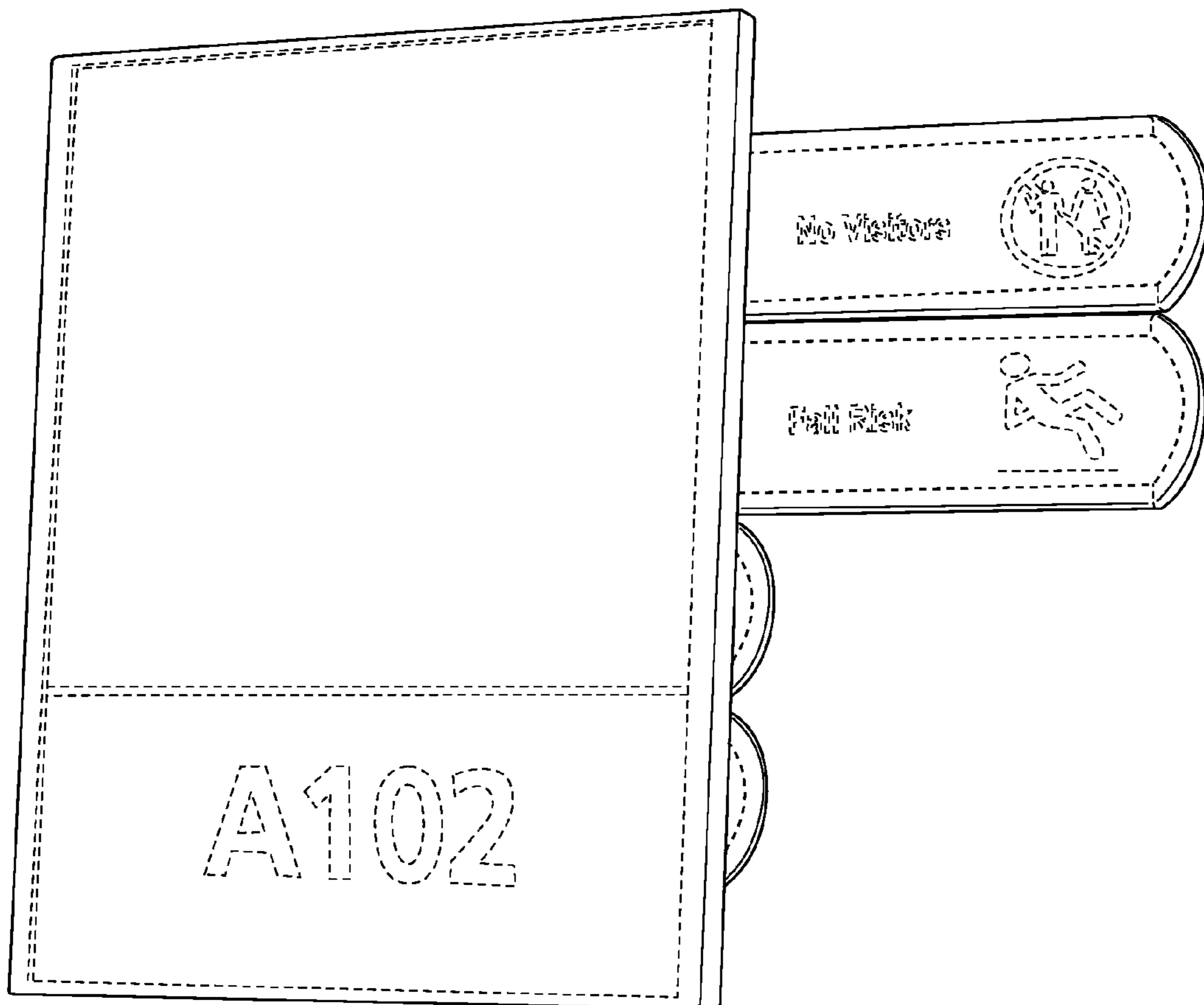

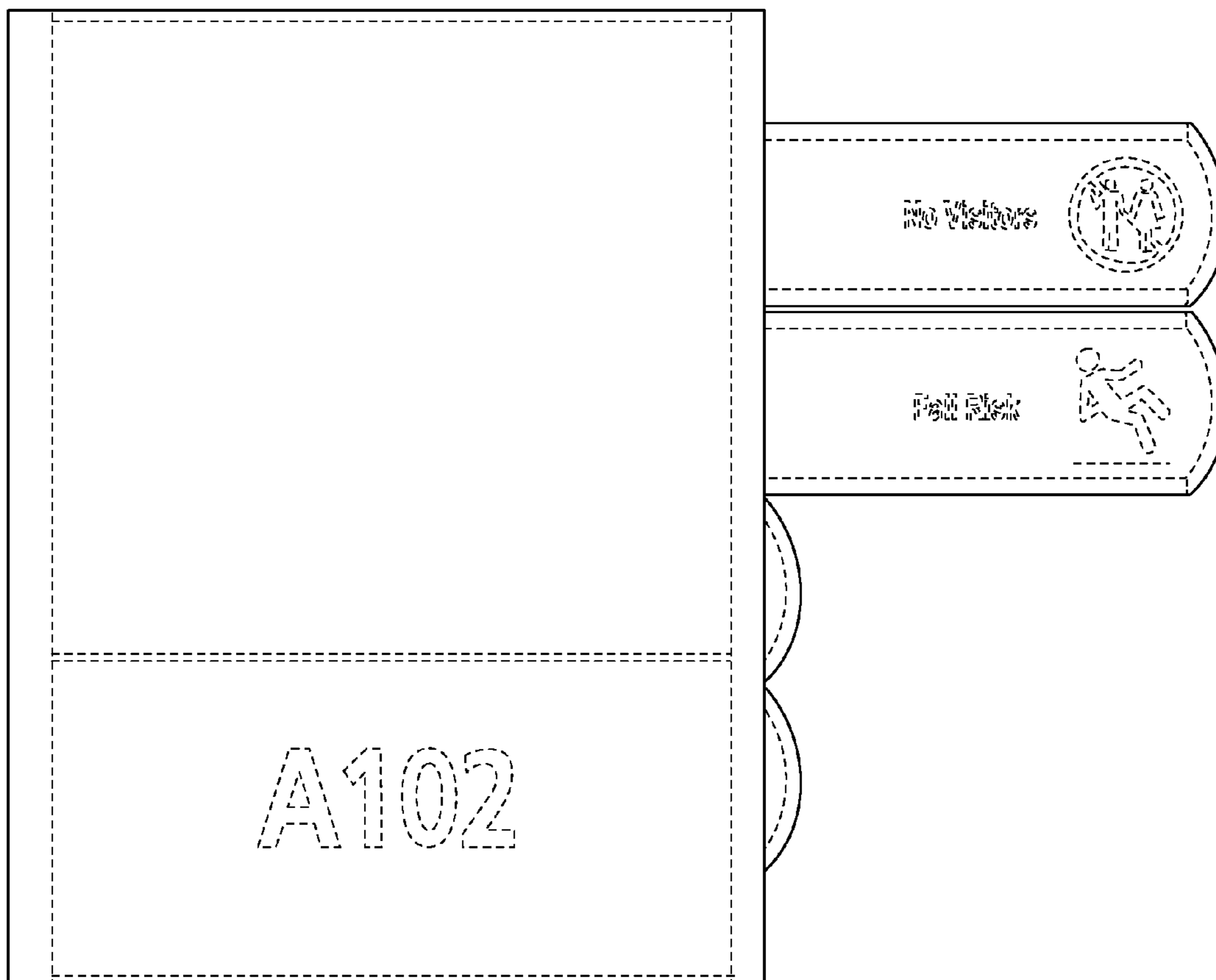

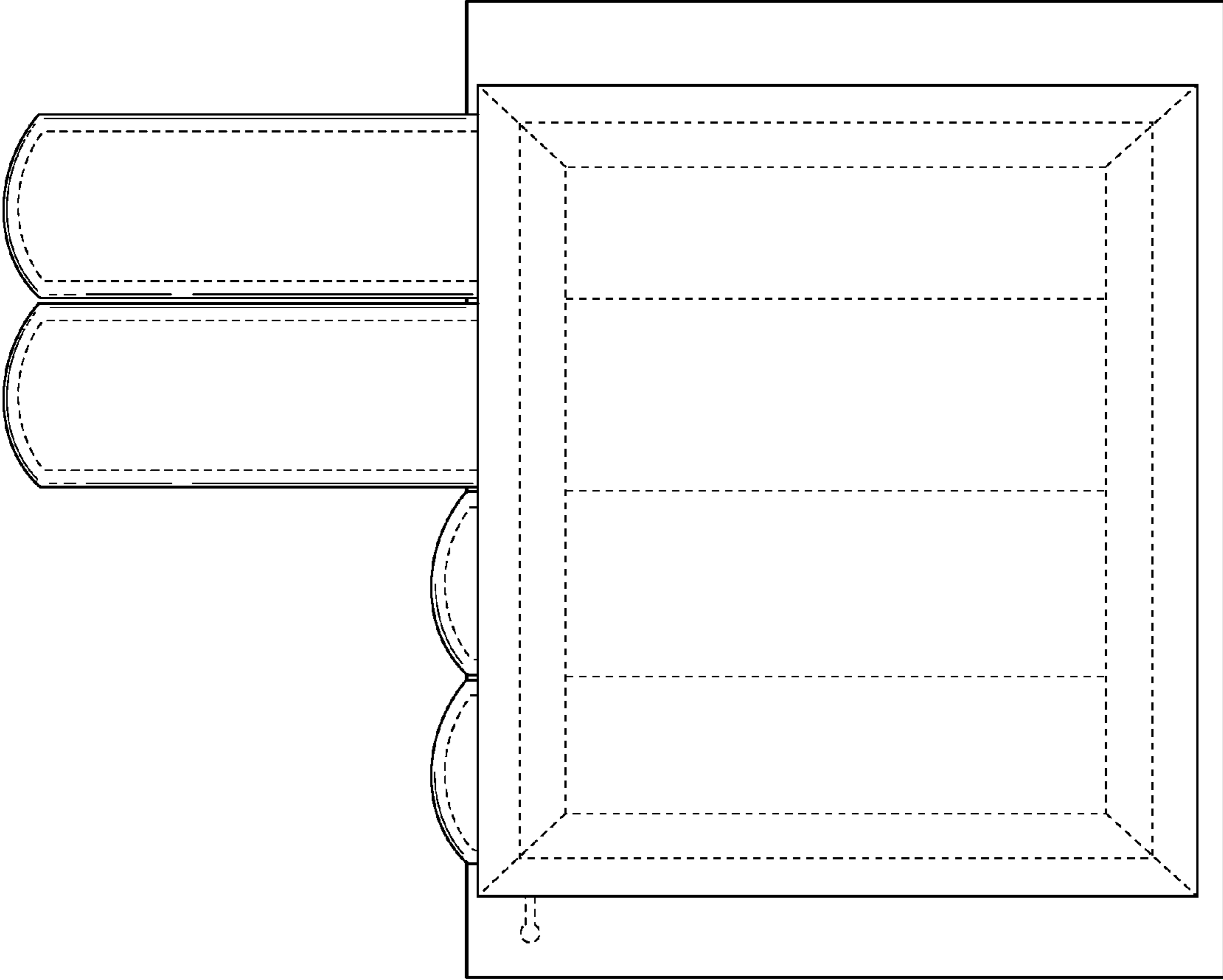

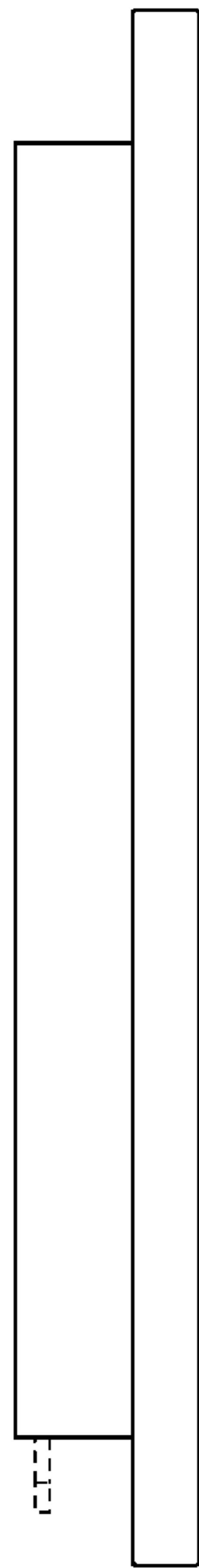

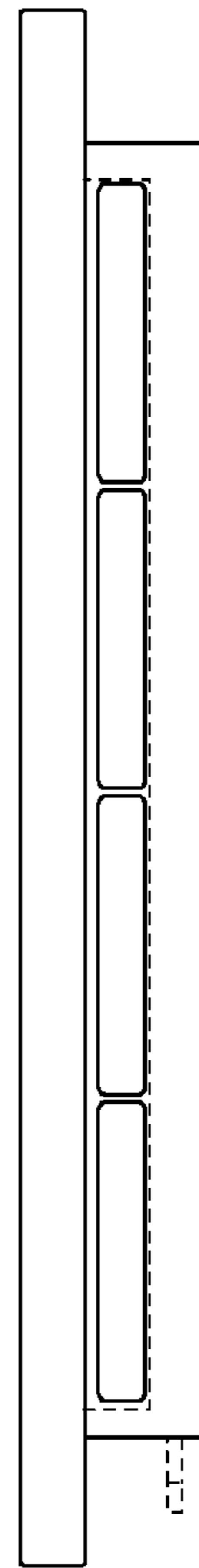

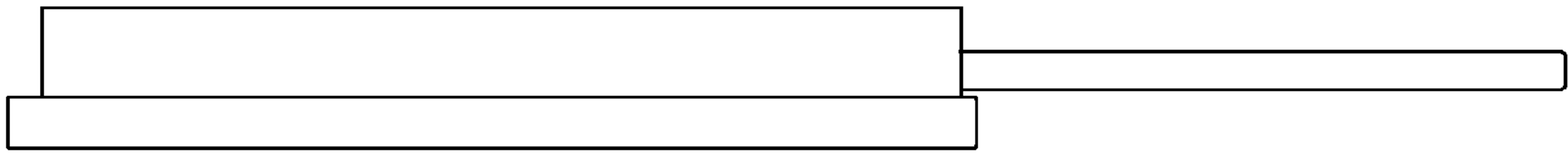

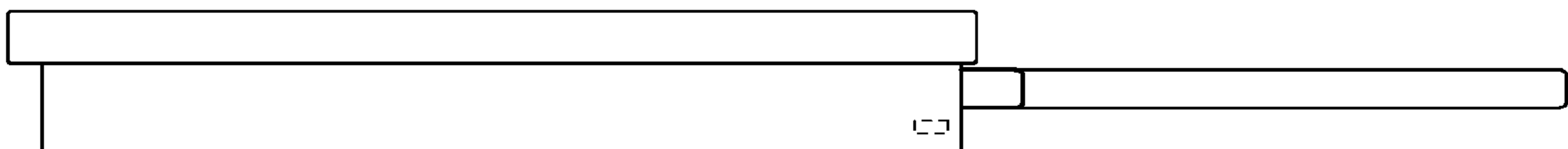

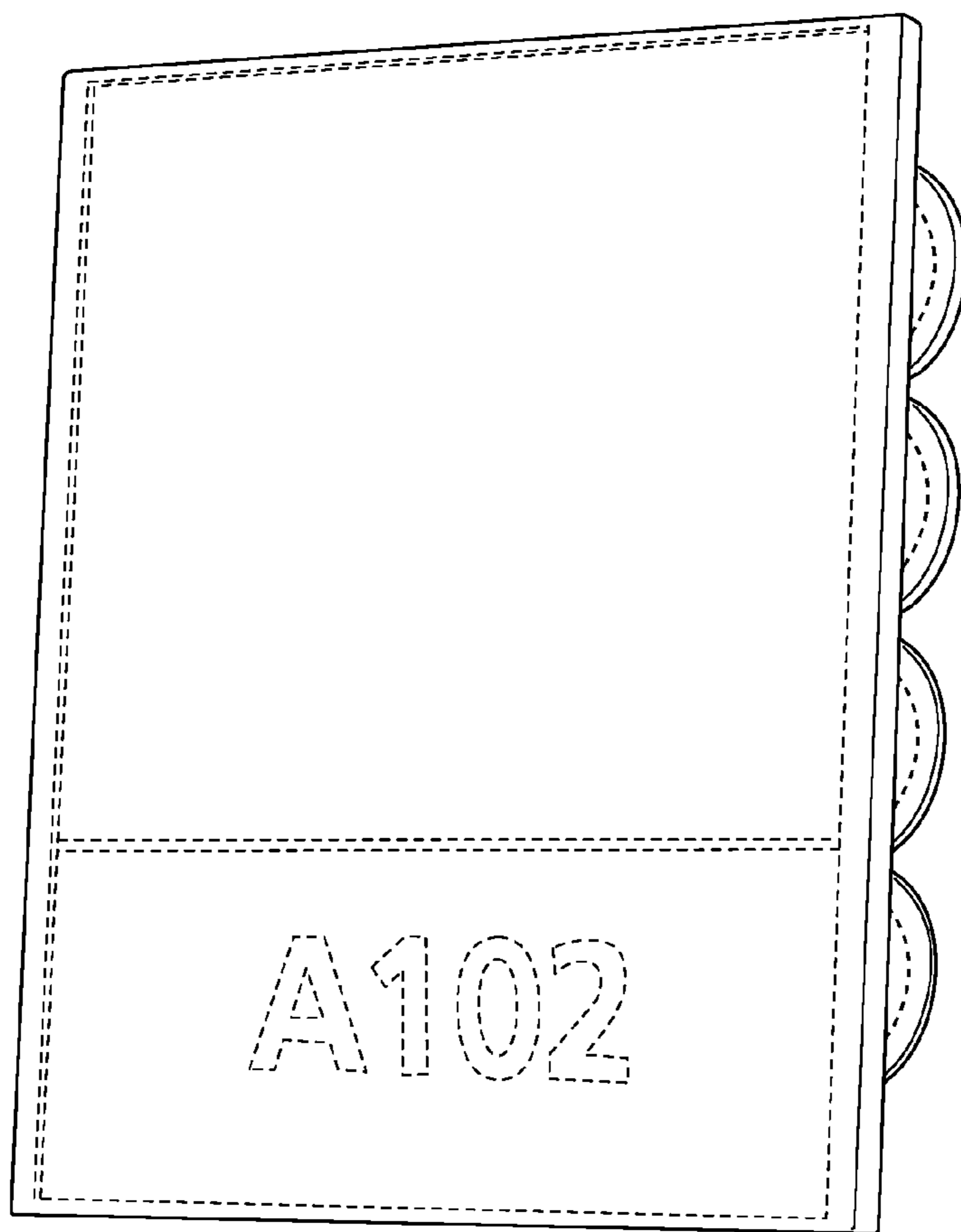

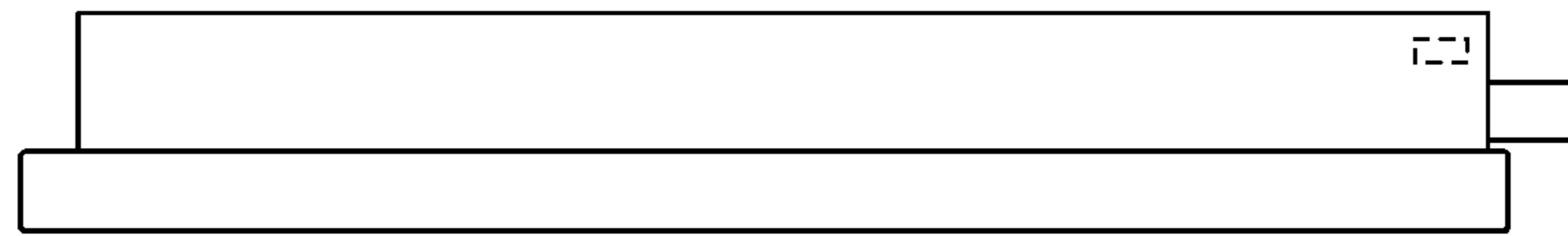

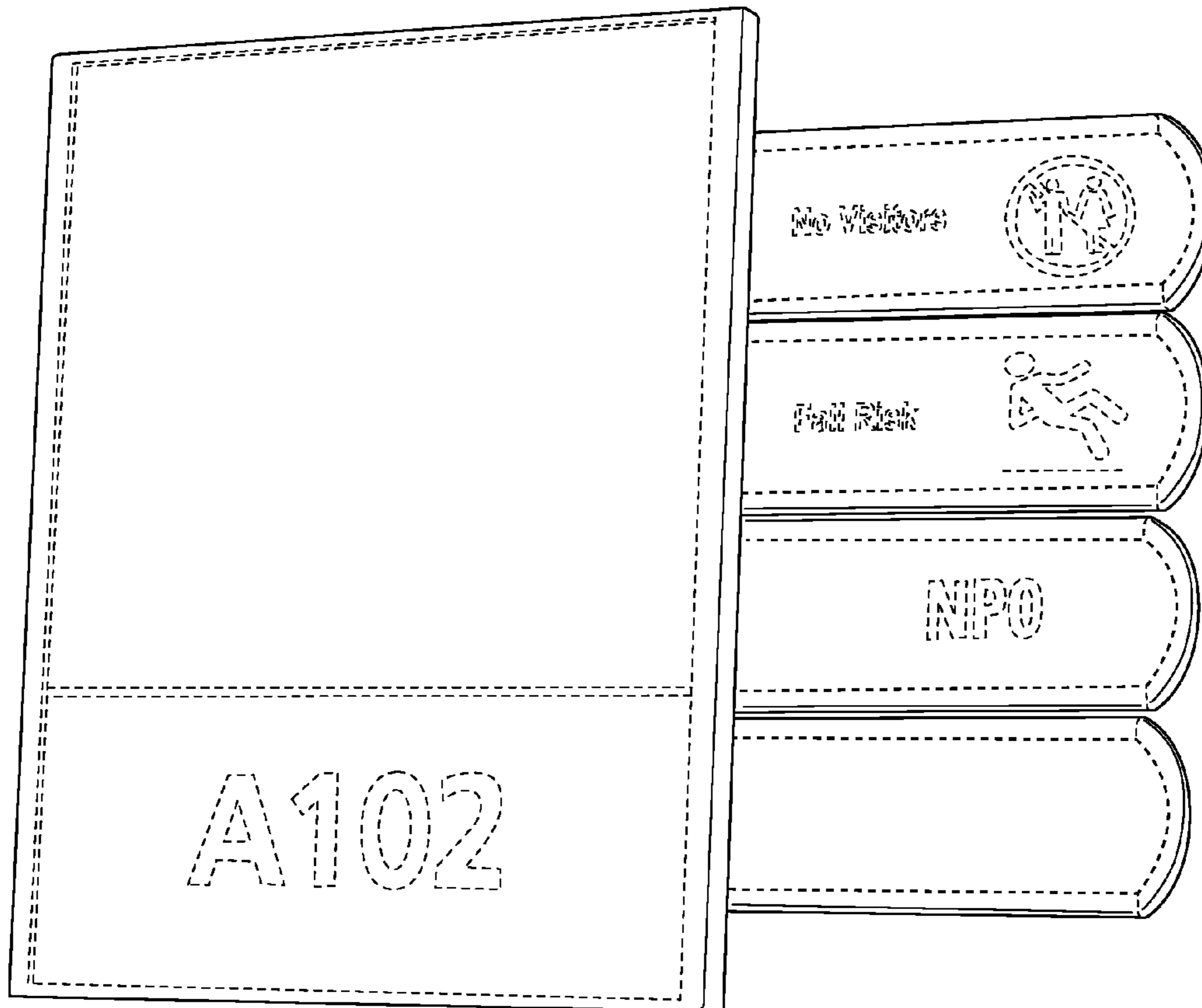
