FIG. 4 is a right plan view thereof;

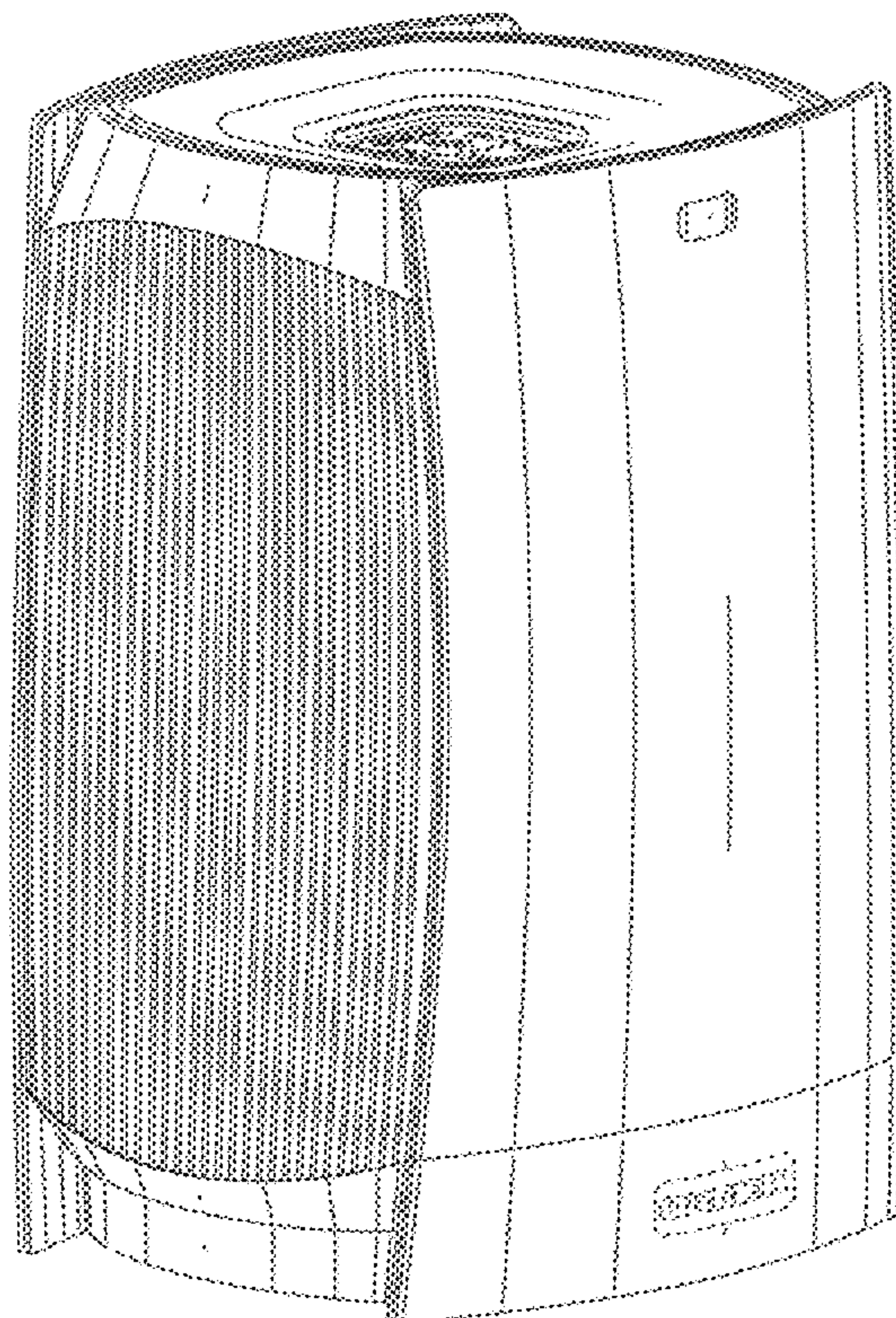
FIG. 5 is a left plan side view thereof;

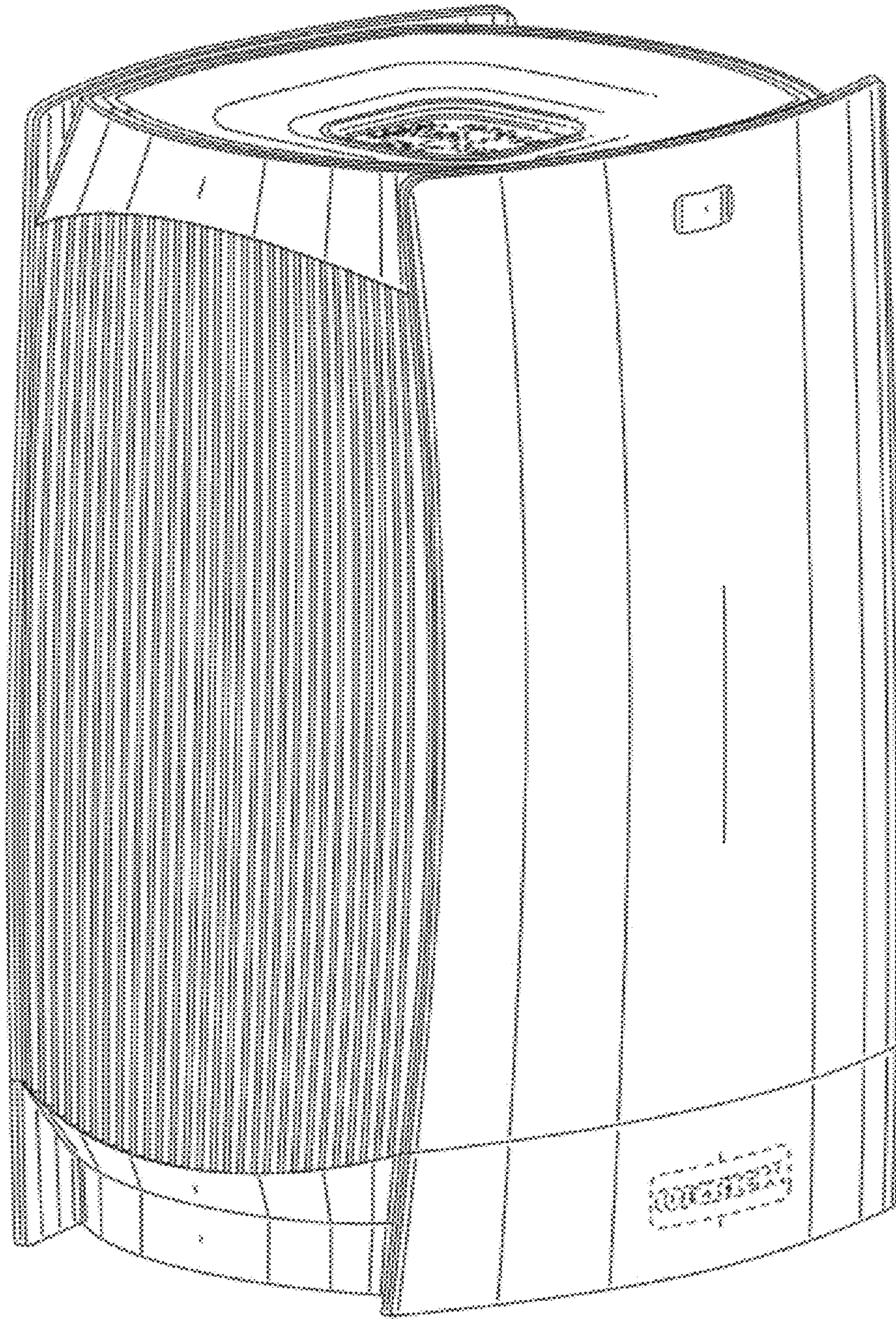

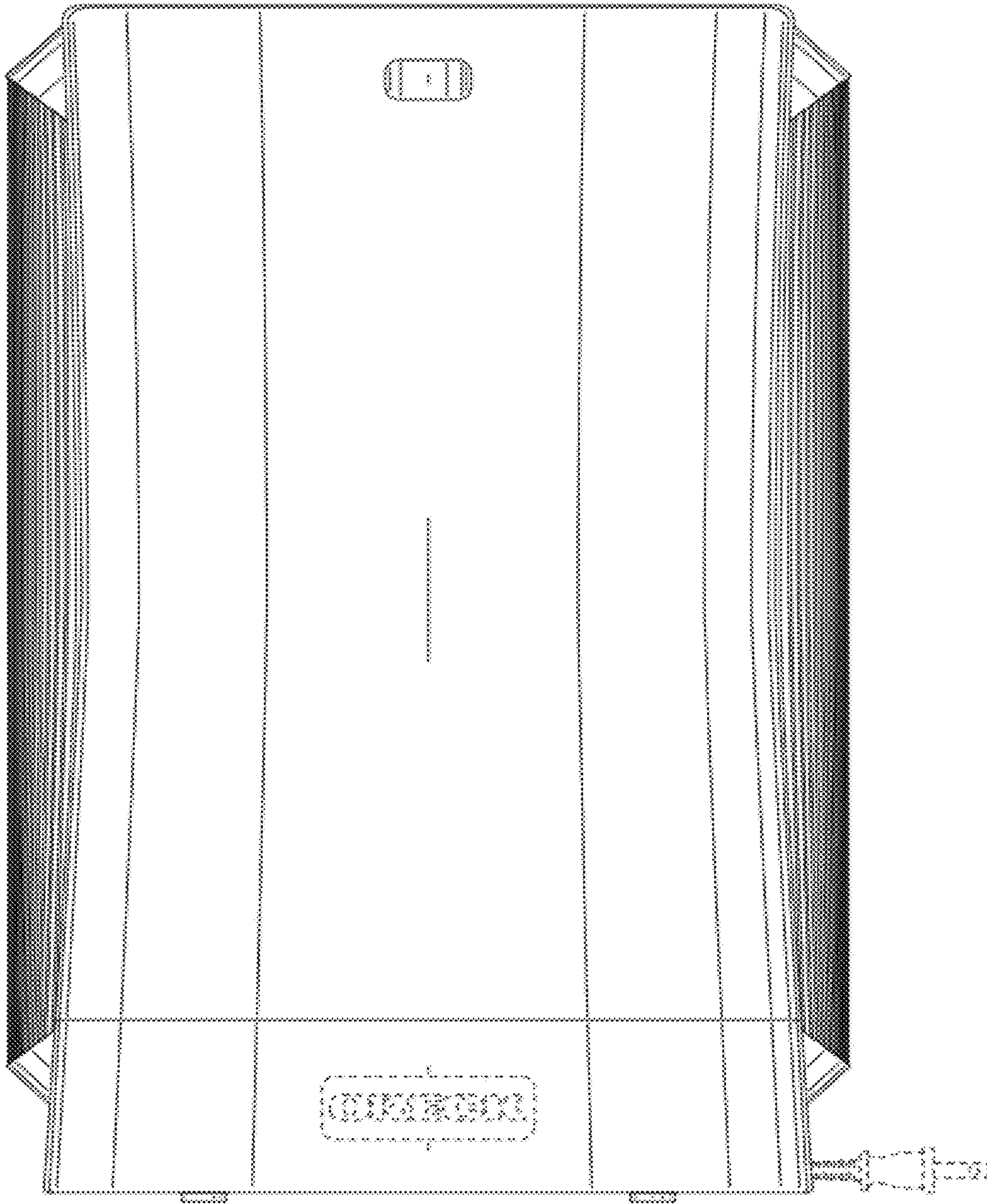

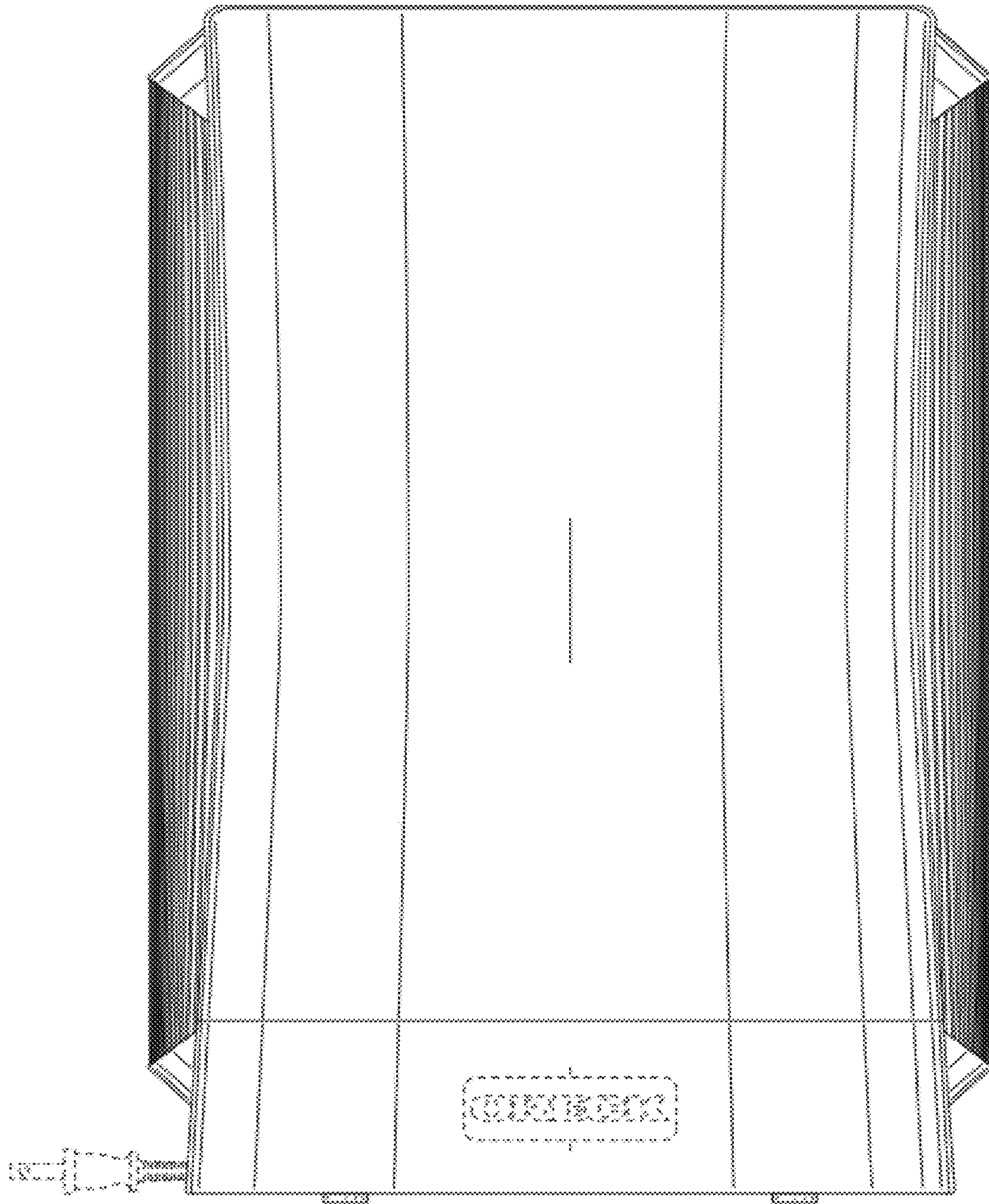

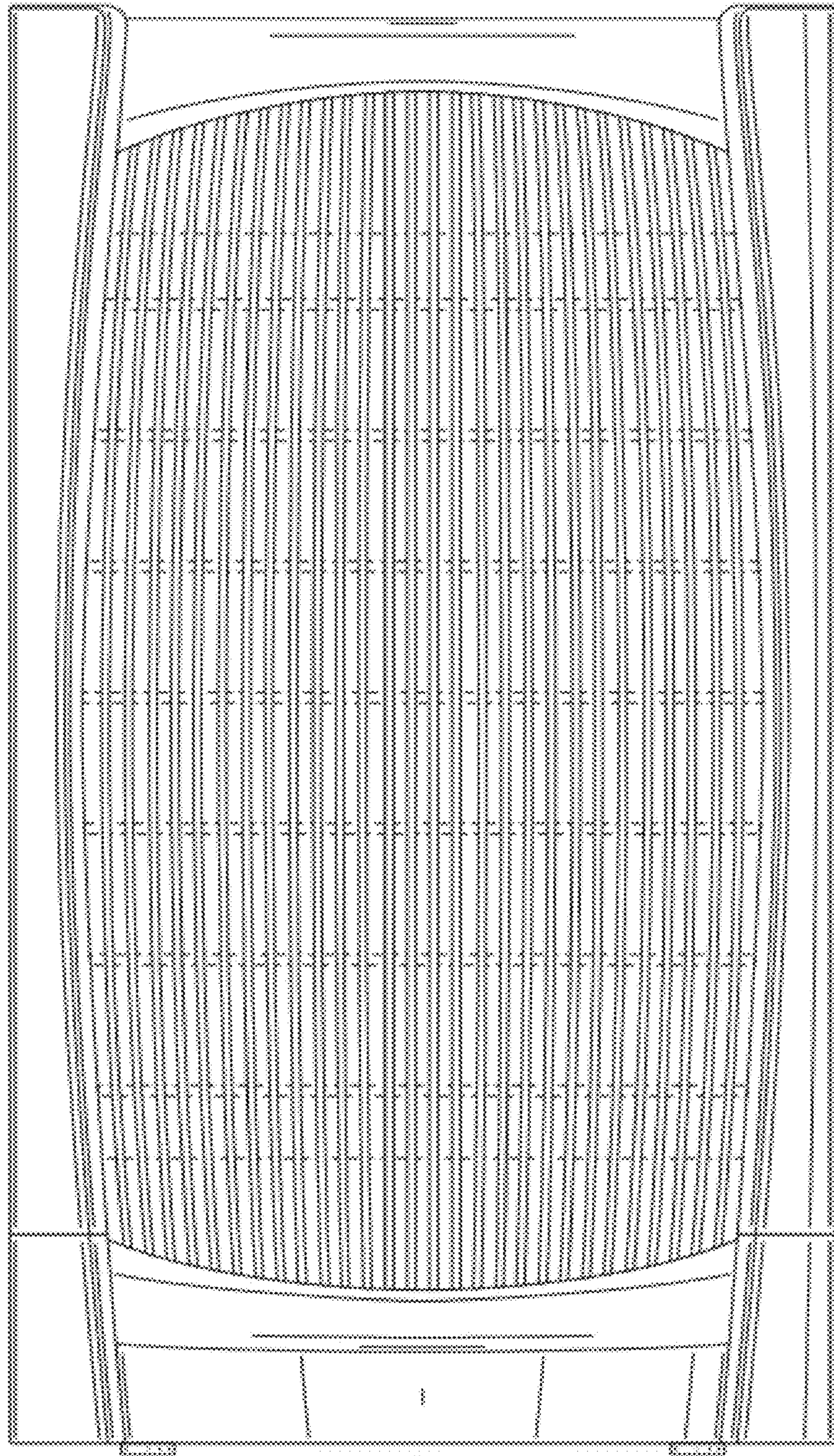

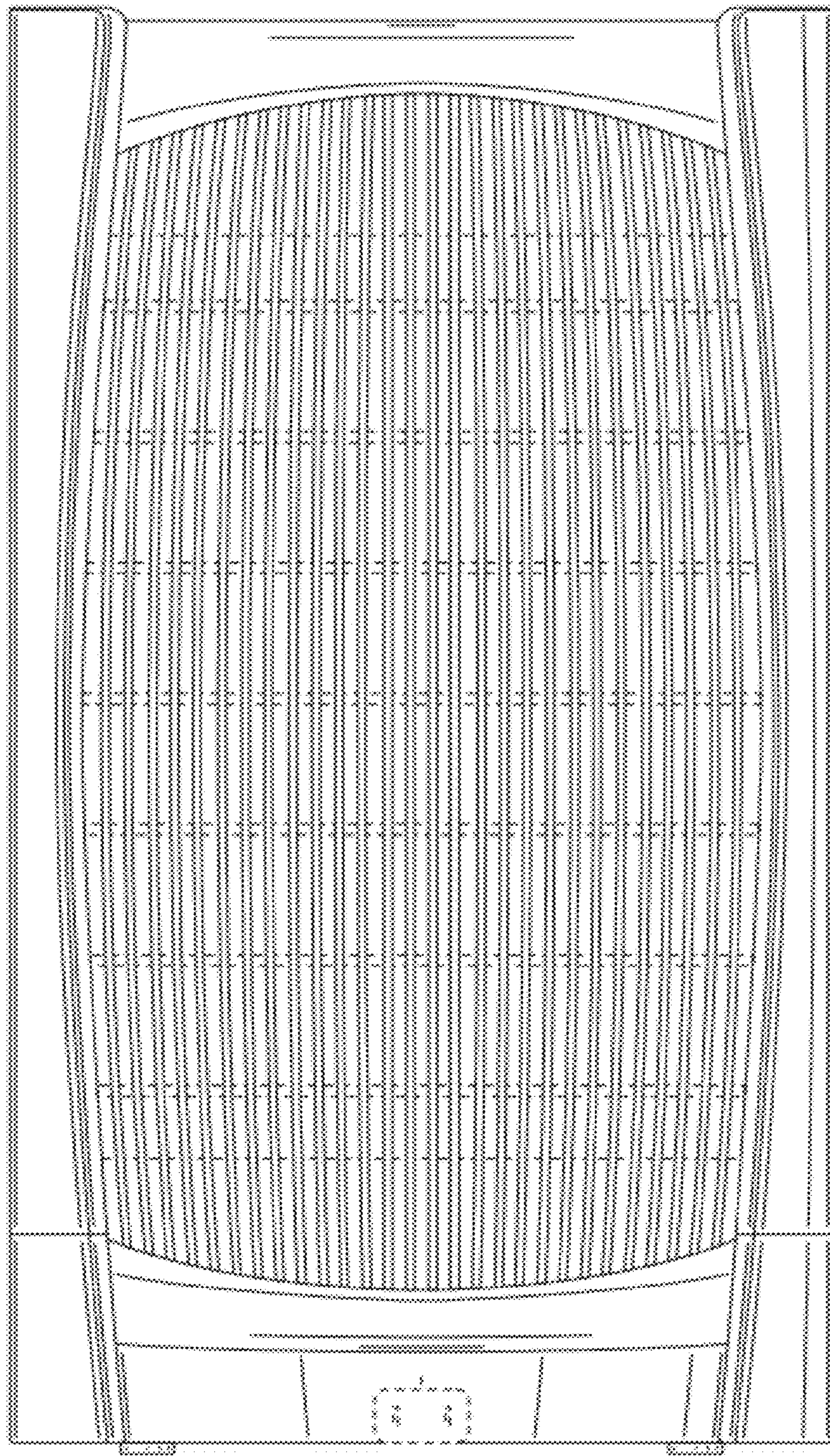

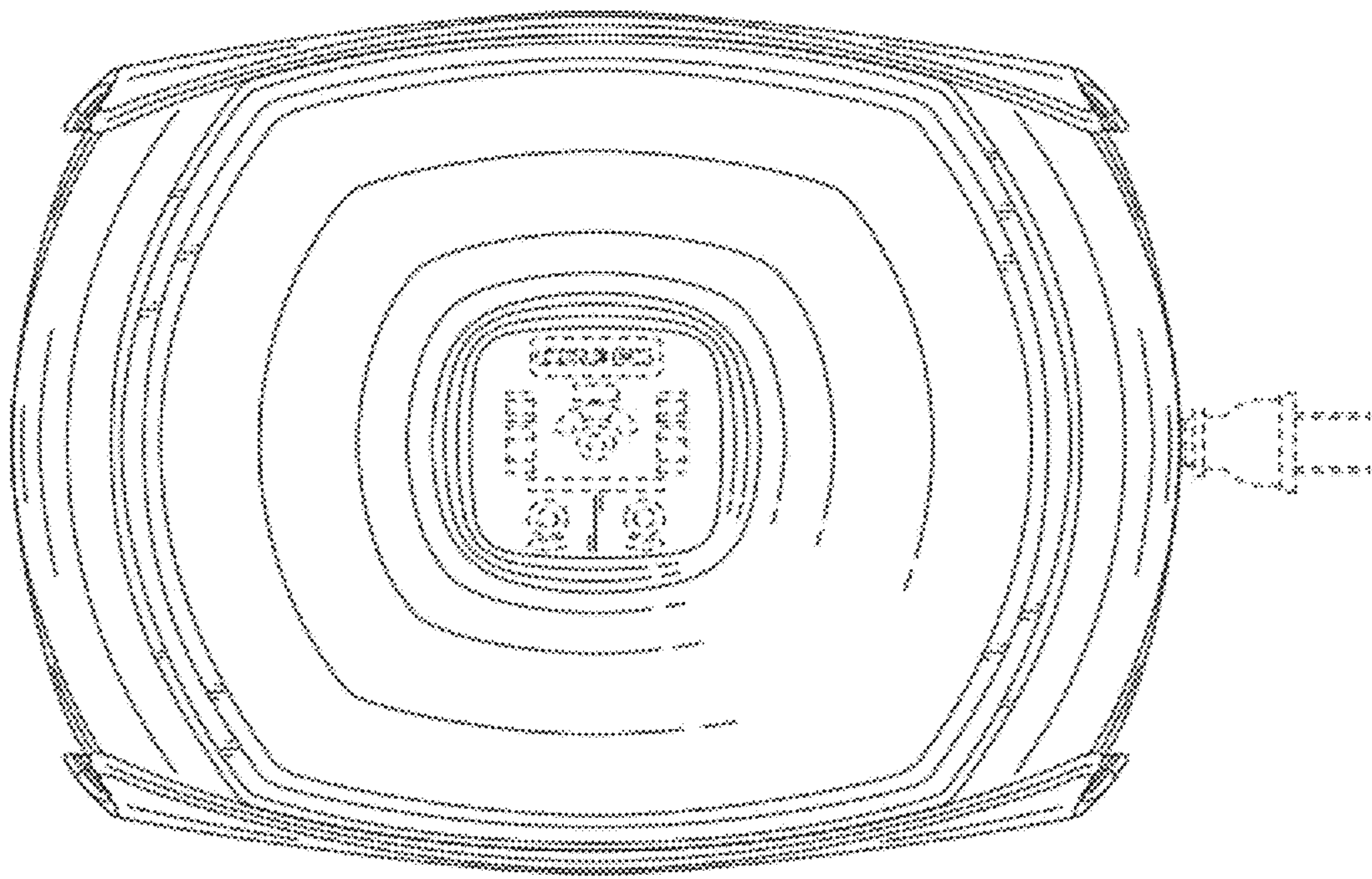

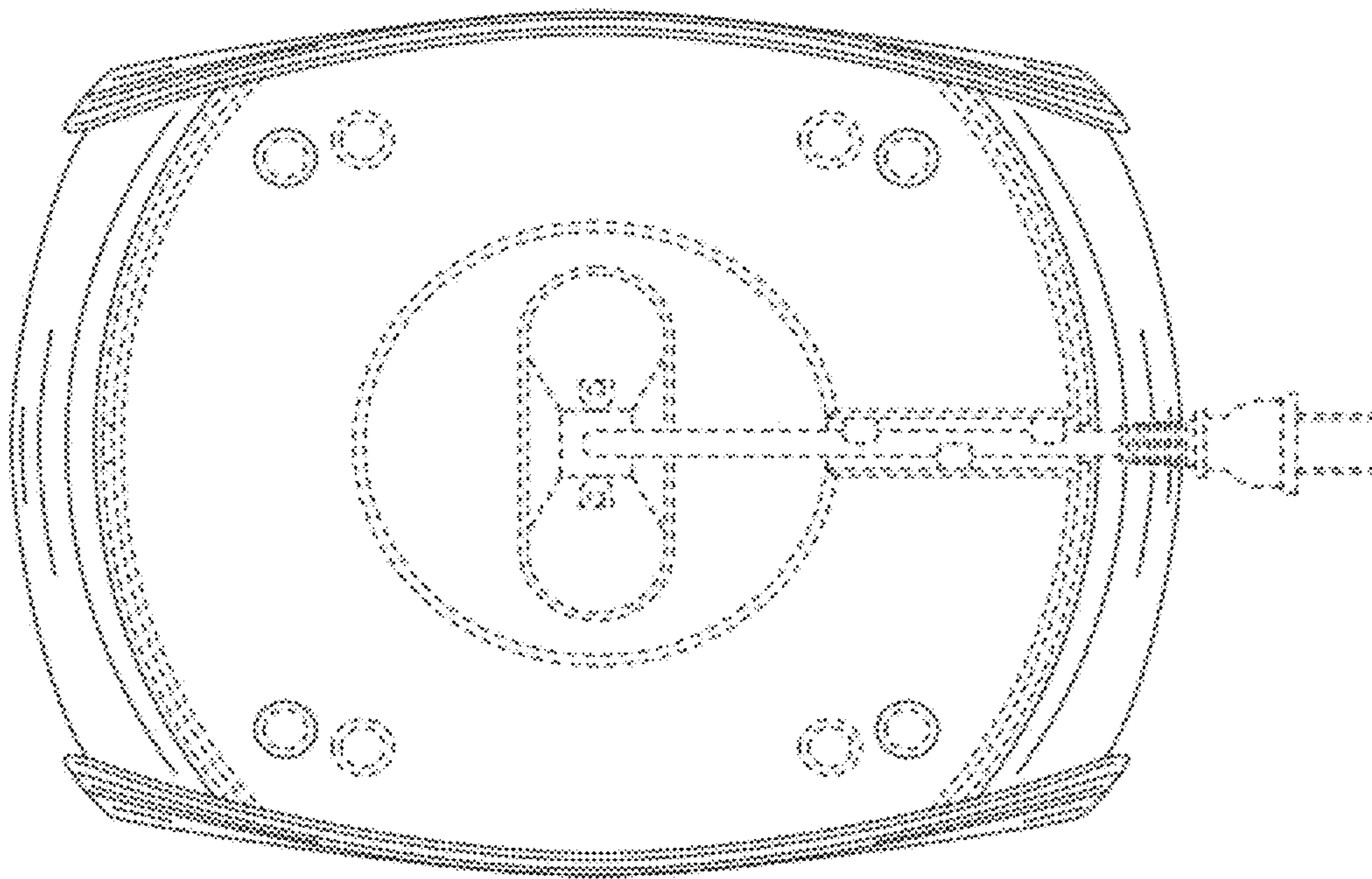
