(57) **CLAIM**

The ornamental design for a bollard luminaire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bollard luminaire, showing my new design;

FIG. 11 is a right-side elevation view of the luminaire of FIG. 8;



FIG. 12 is a left-side elevation view of the luminaire of FIG. 8;
























