FIG. 4 is a top plan view of FIG. 1;

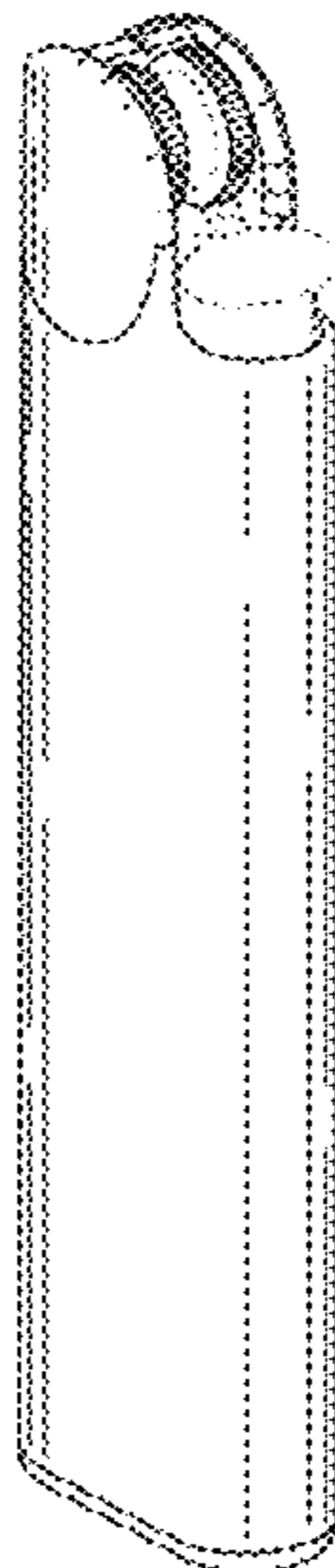
FIG. 5 is a right elevational view thereof;

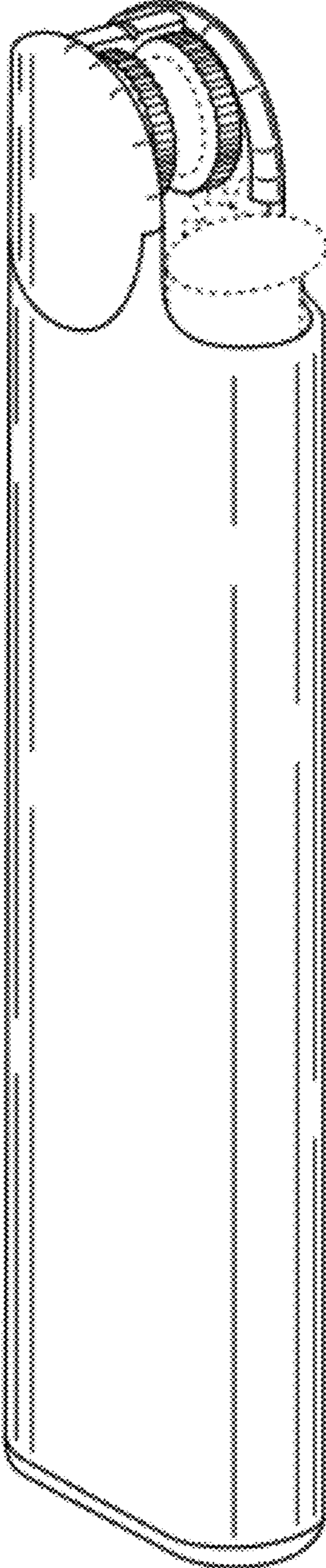
FIG. 6 is a left elevational view thereof; and,

FIG. 7 is a front elevational view thereof.

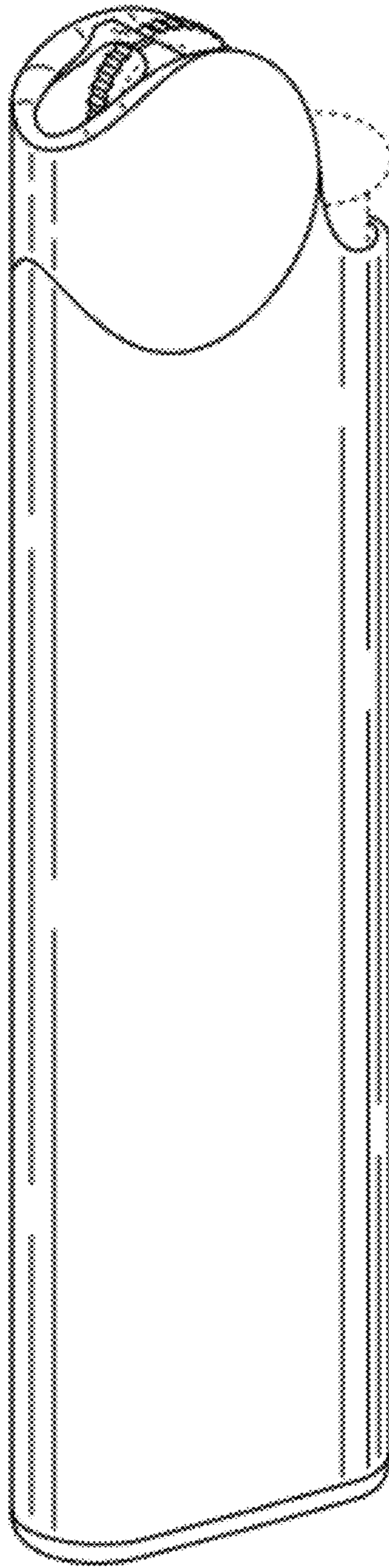
The broken lines shown in the drawings illustrate portions of the lighter that form no part of the claimed design.

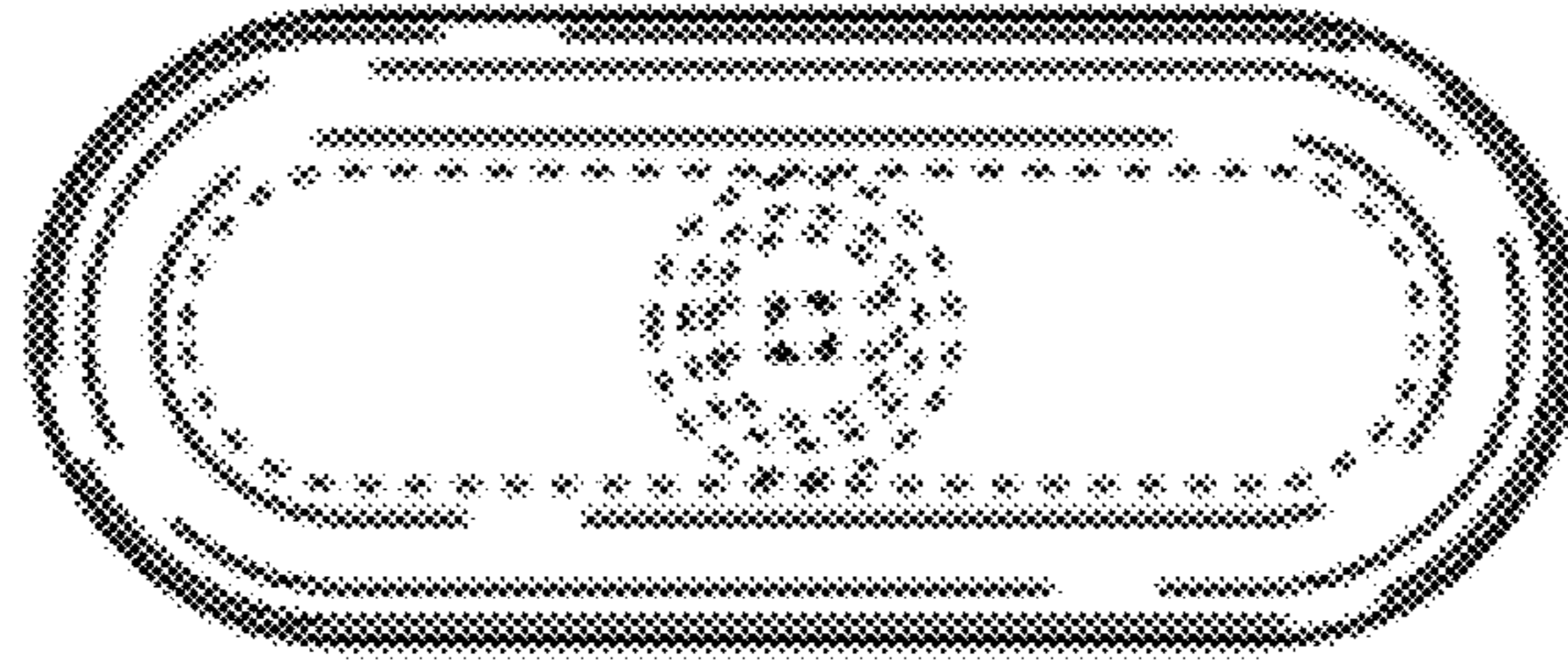




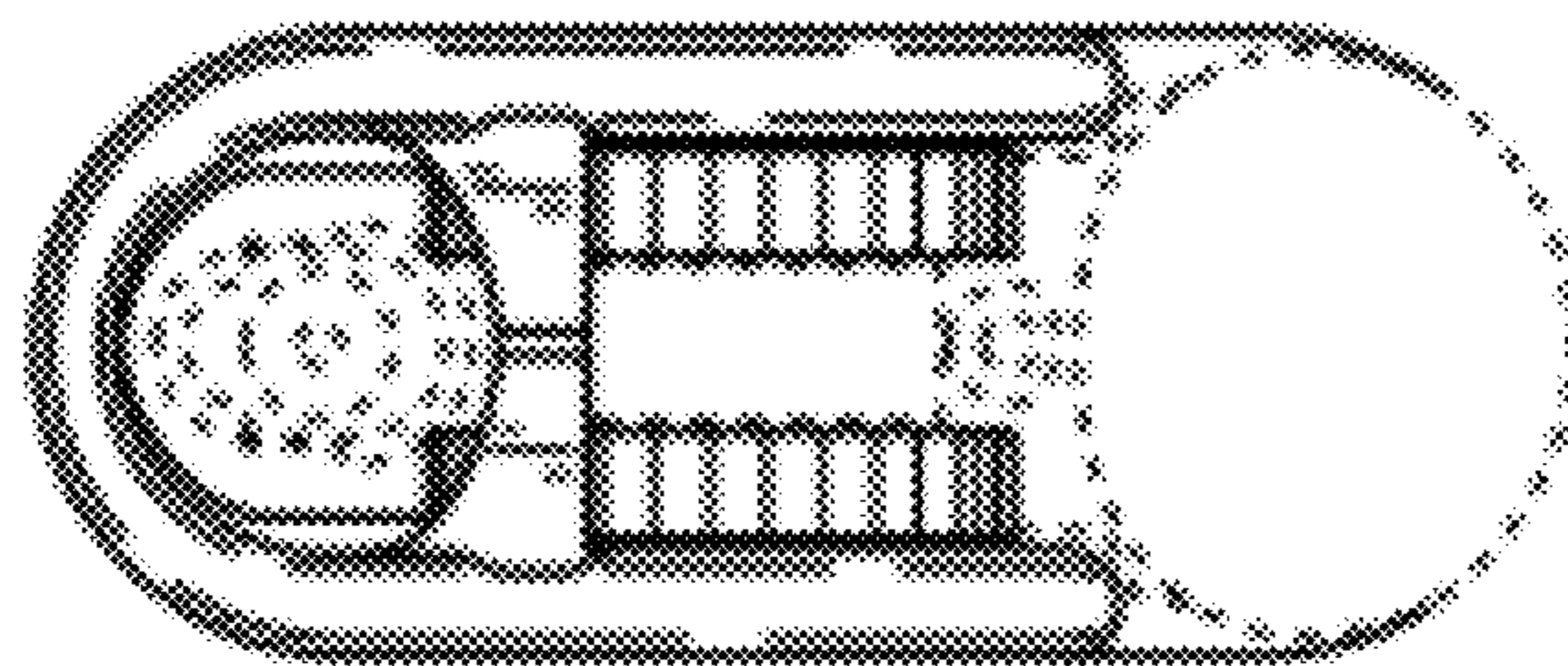

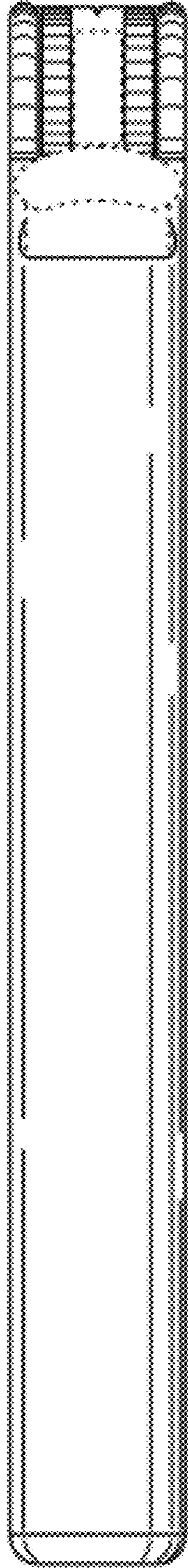

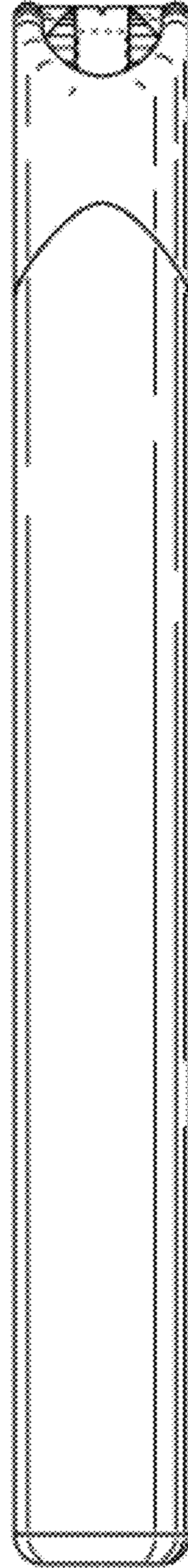

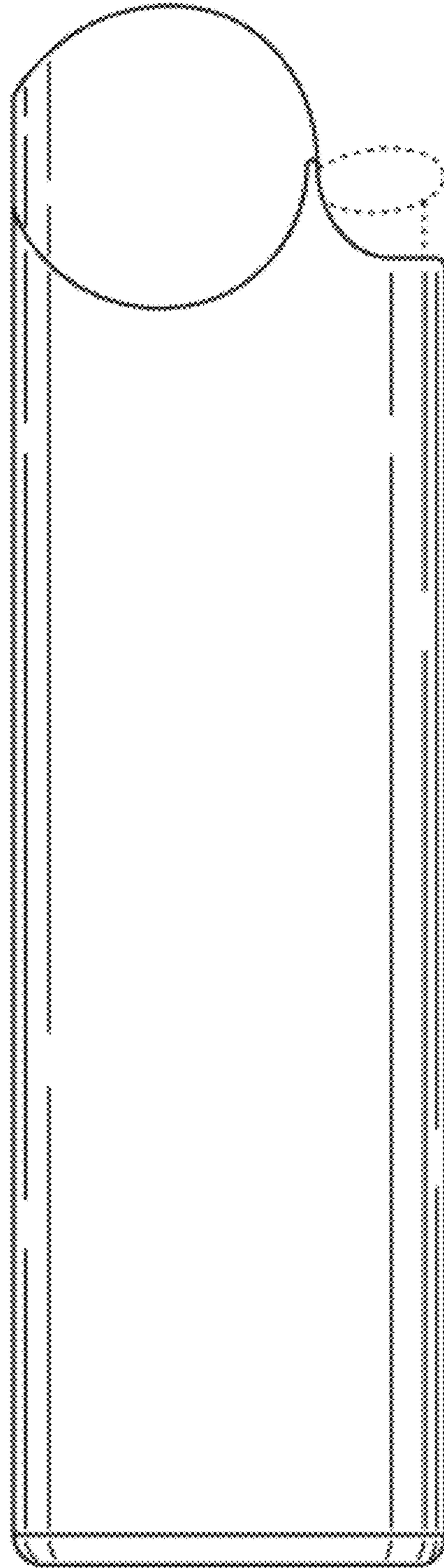
