We claim the ornamental design for a top plate for a filter bag,
as shown and described.

DESCRIPTION

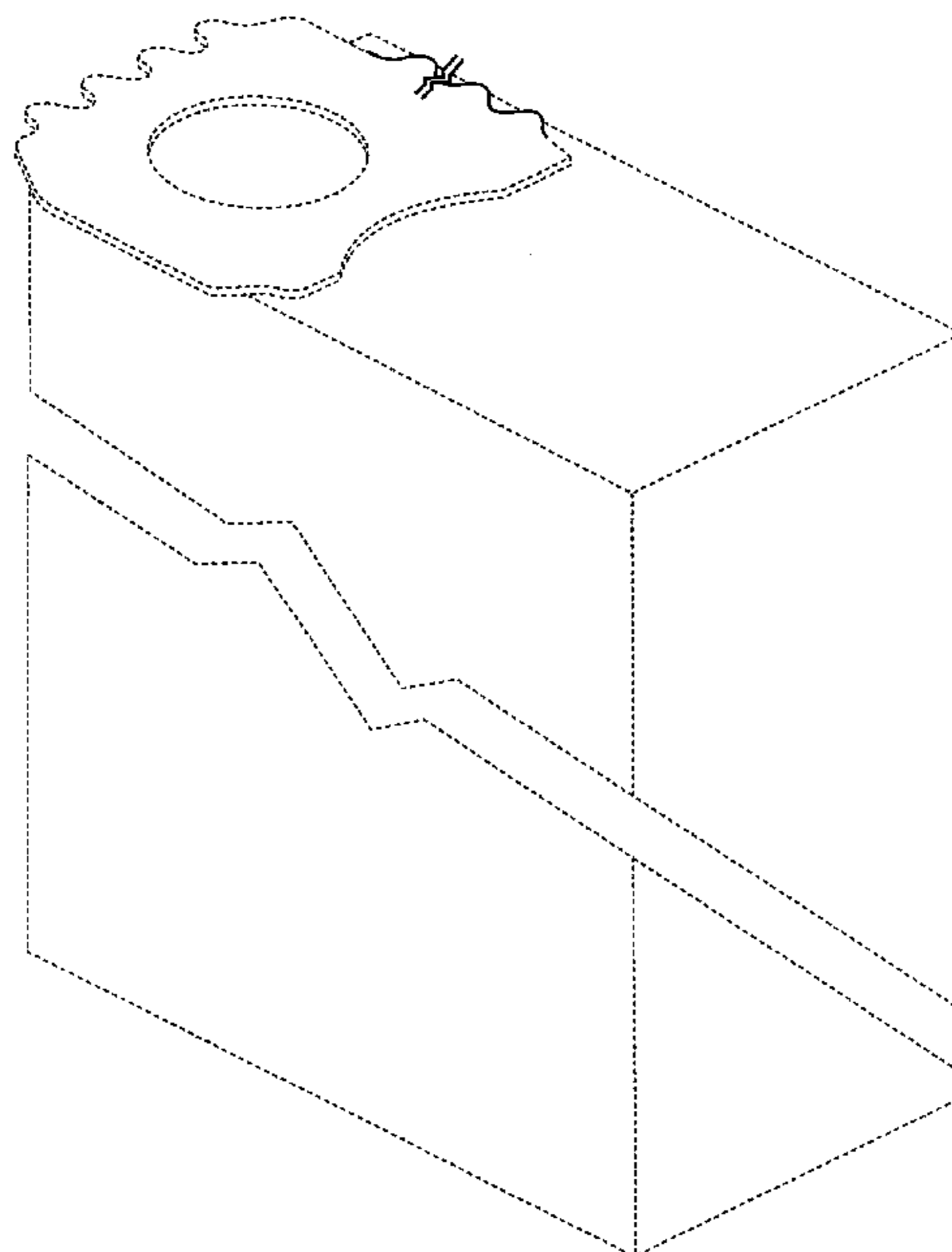
FIG. 1 is a perspective view of a top plate for a filter bag showing our new design;
FIG. 2 is a top plan view of the top plate of FIG. 1;
FIG. 3 is a front elevation view of the top plate shown in FIG. 1;
FIG. 4 is a rear elevation view of the top plate shown in FIG. 1;
FIG. 5 is a left side elevation view of the top plate shown in FIG. 1;
FIG. 6 is a right side elevation view of the top plate shown in FIG. 1; and,
FIG. 7 is an enlarged fragmentary view of a portion of FIG. 2. The additional broken lines in FIG. 7 depict the boundaries of the fragmentary view and form no part of the claimed design. The broken away symbols in the drawings indicate that any portion of the article beyond what is shown forms no part of the claimed design.

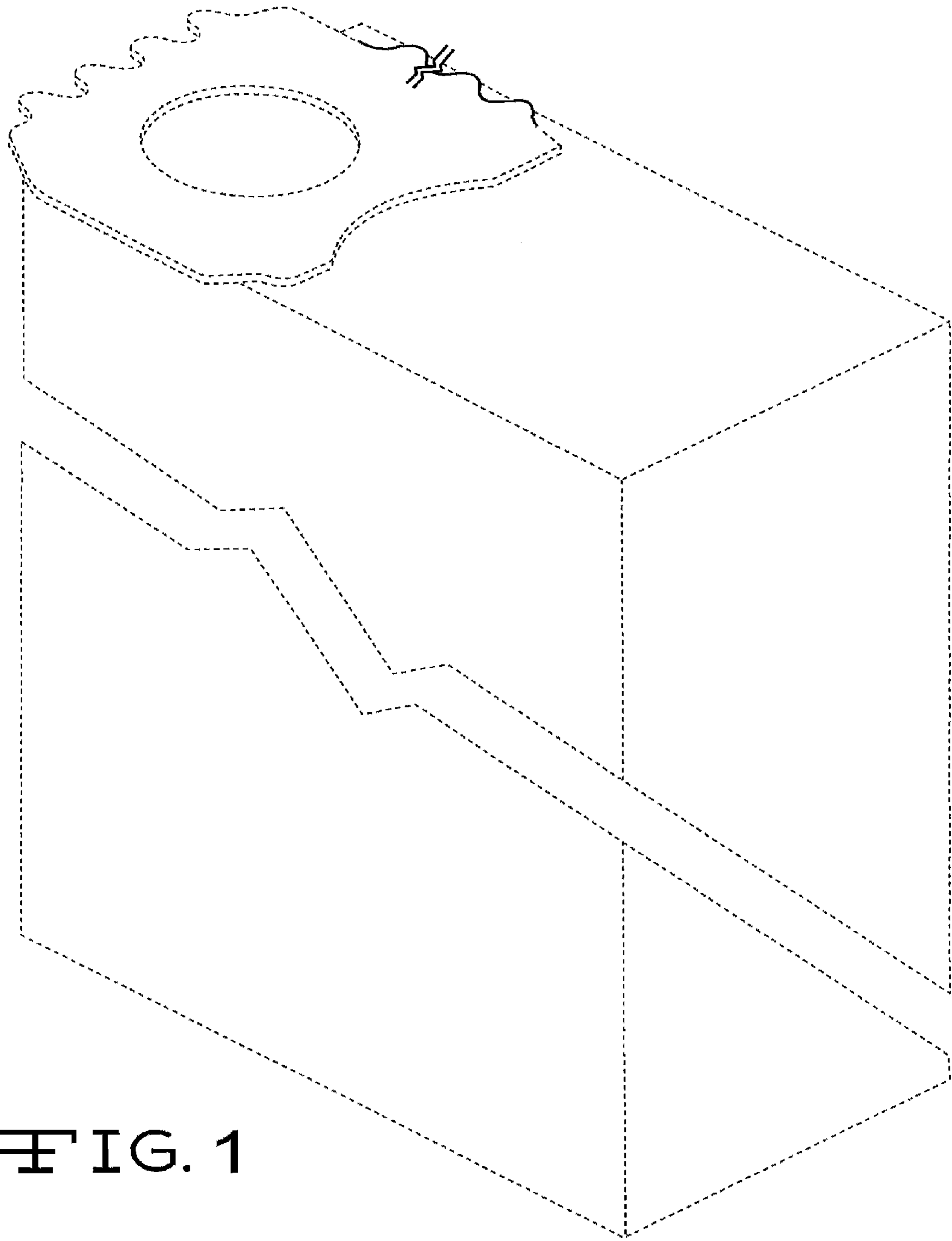

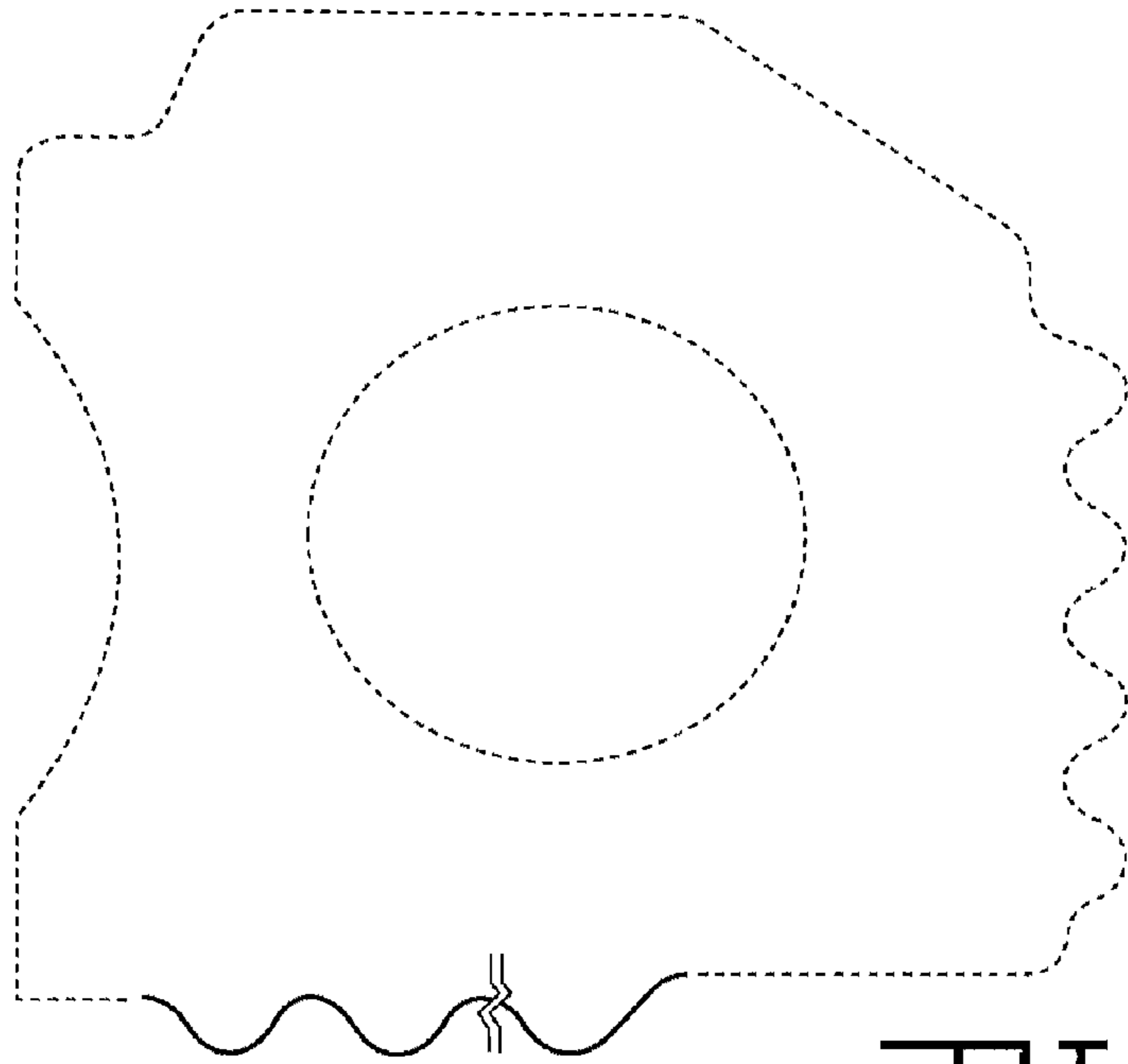

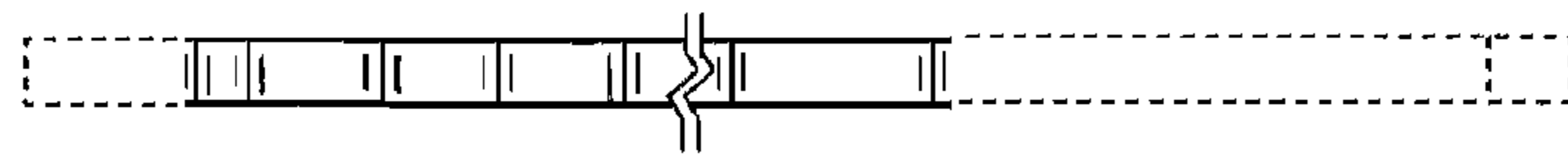

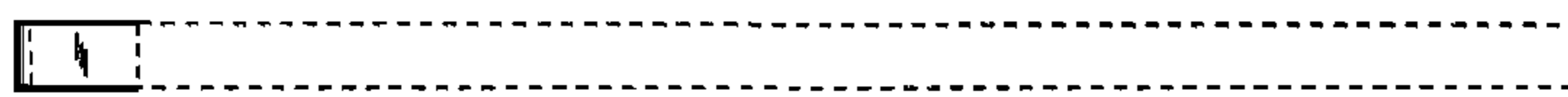

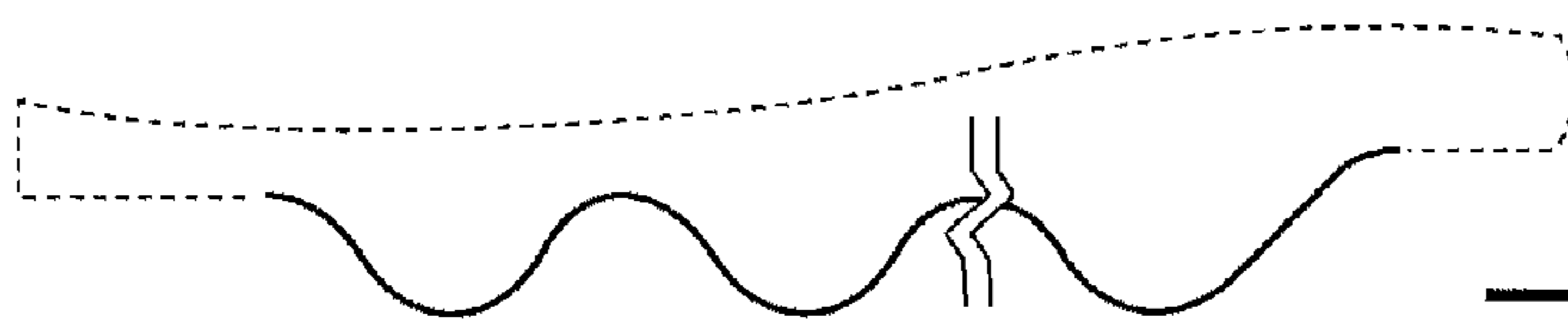
