FIG. 2 is a back perspective view of the shoe in accordance with my design;

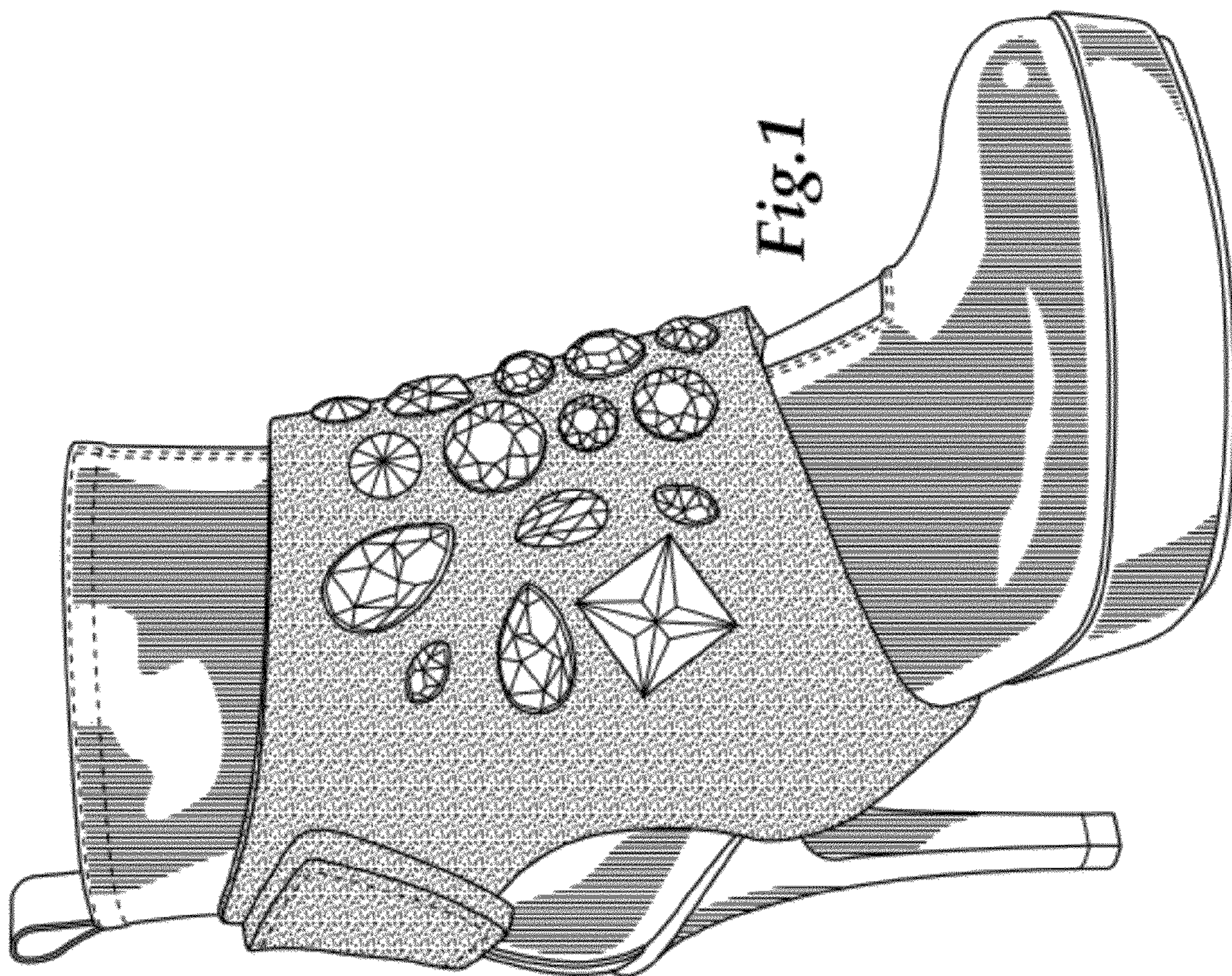
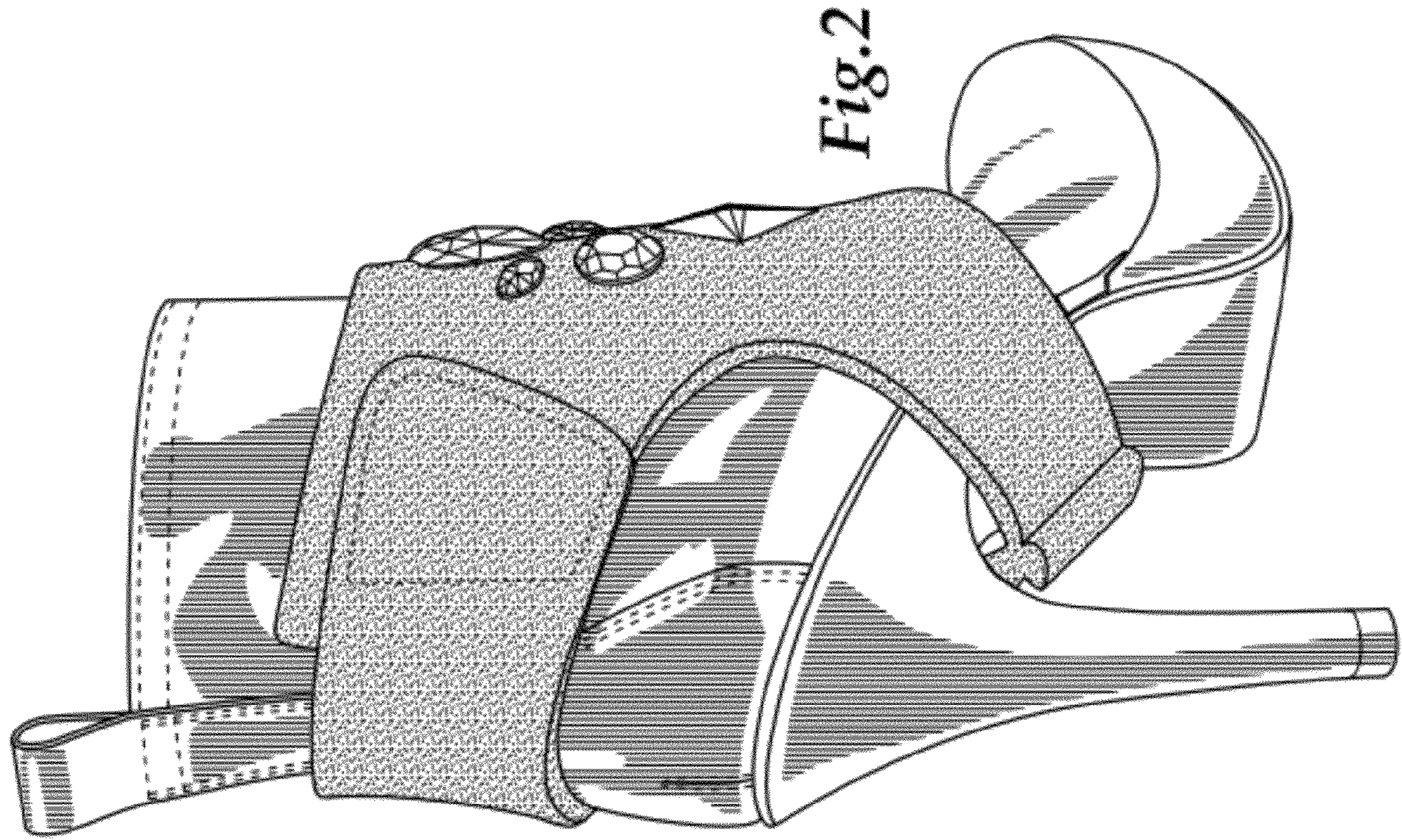
FIG. 3 is a side elevation view of the shoe in accordance with my design; and,

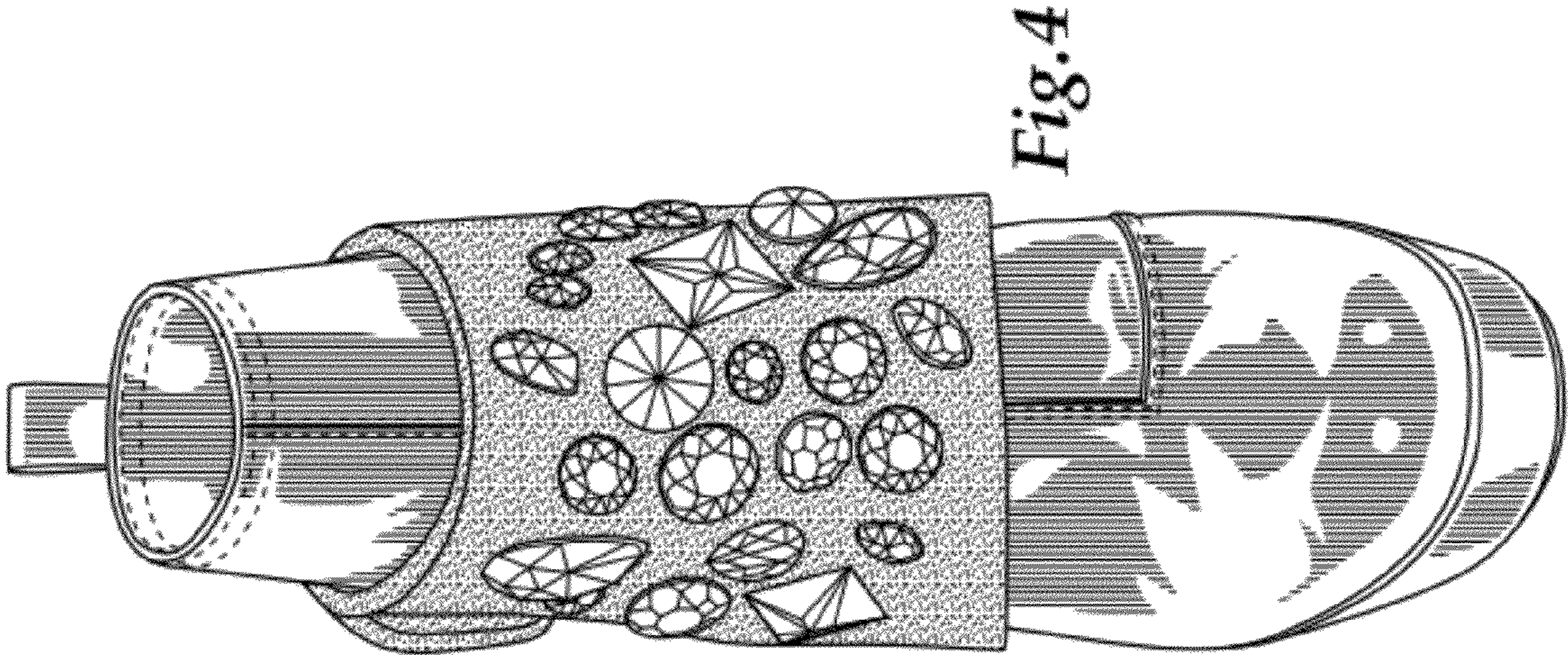

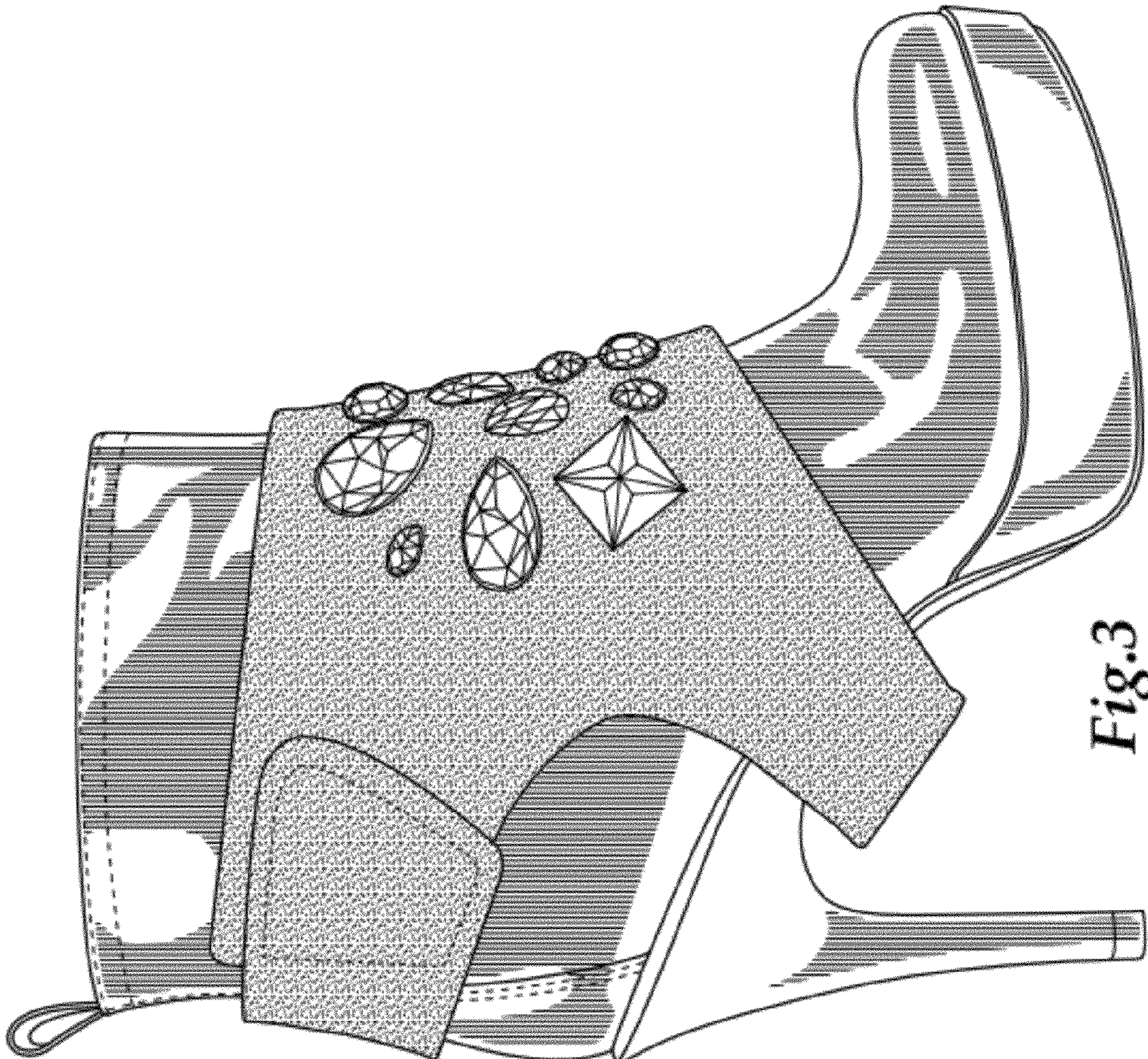
