DESCRIPTION

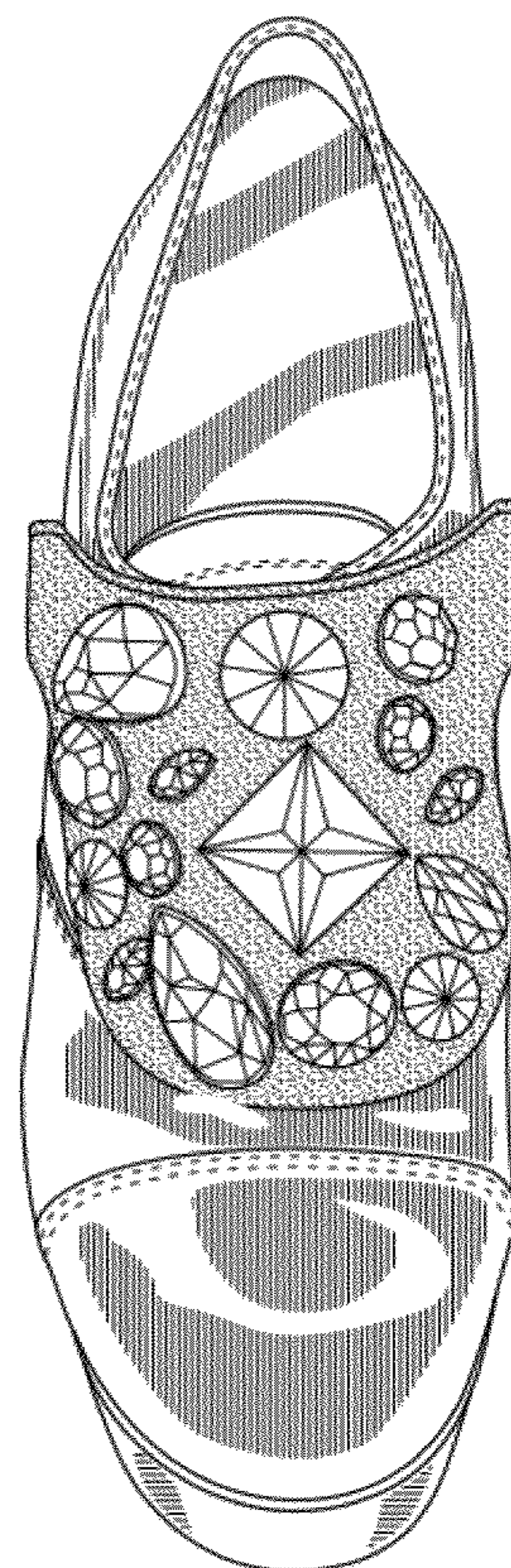
FIG. 1 is a front perspective view of a shoe in accordance with my design;

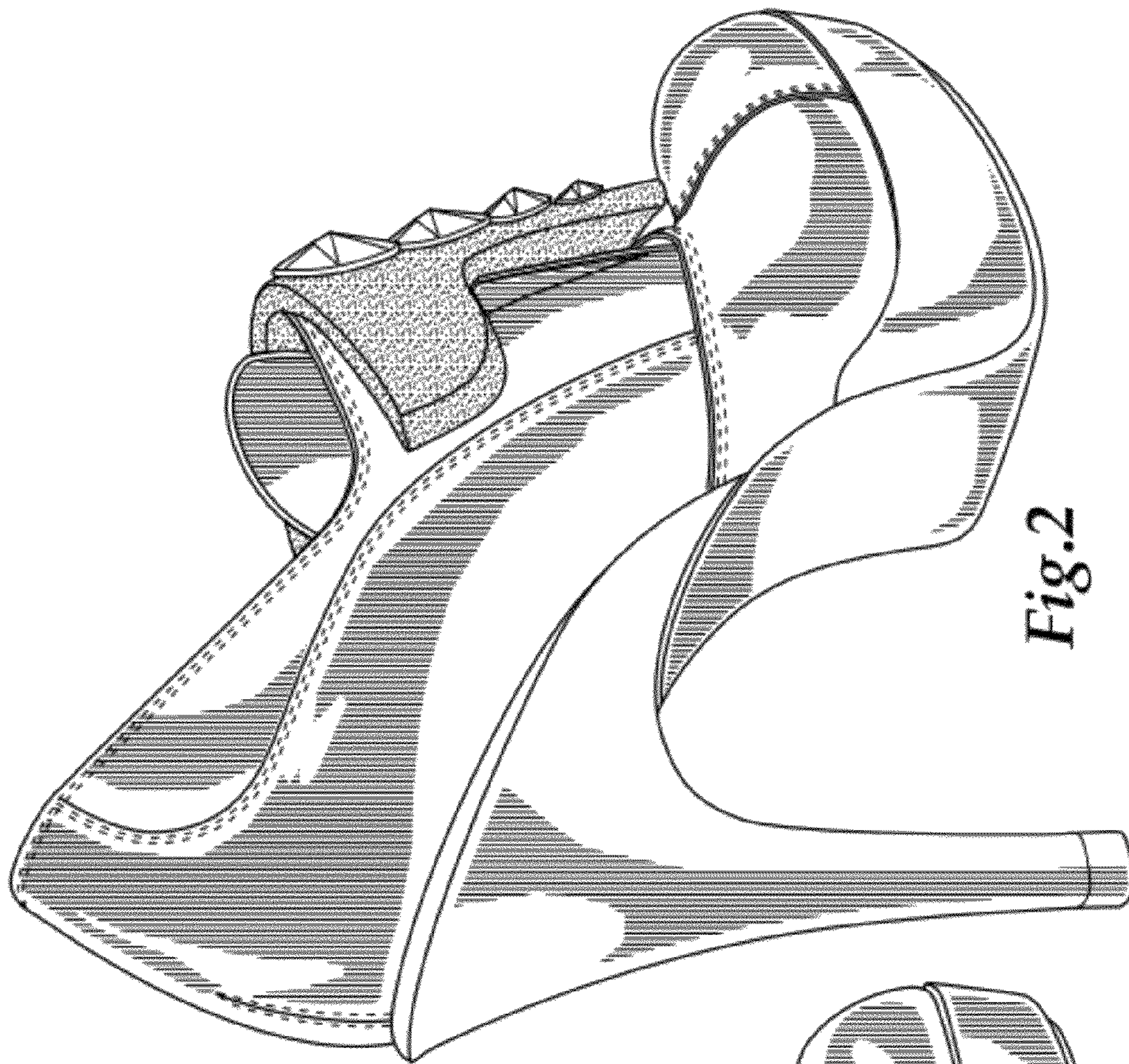

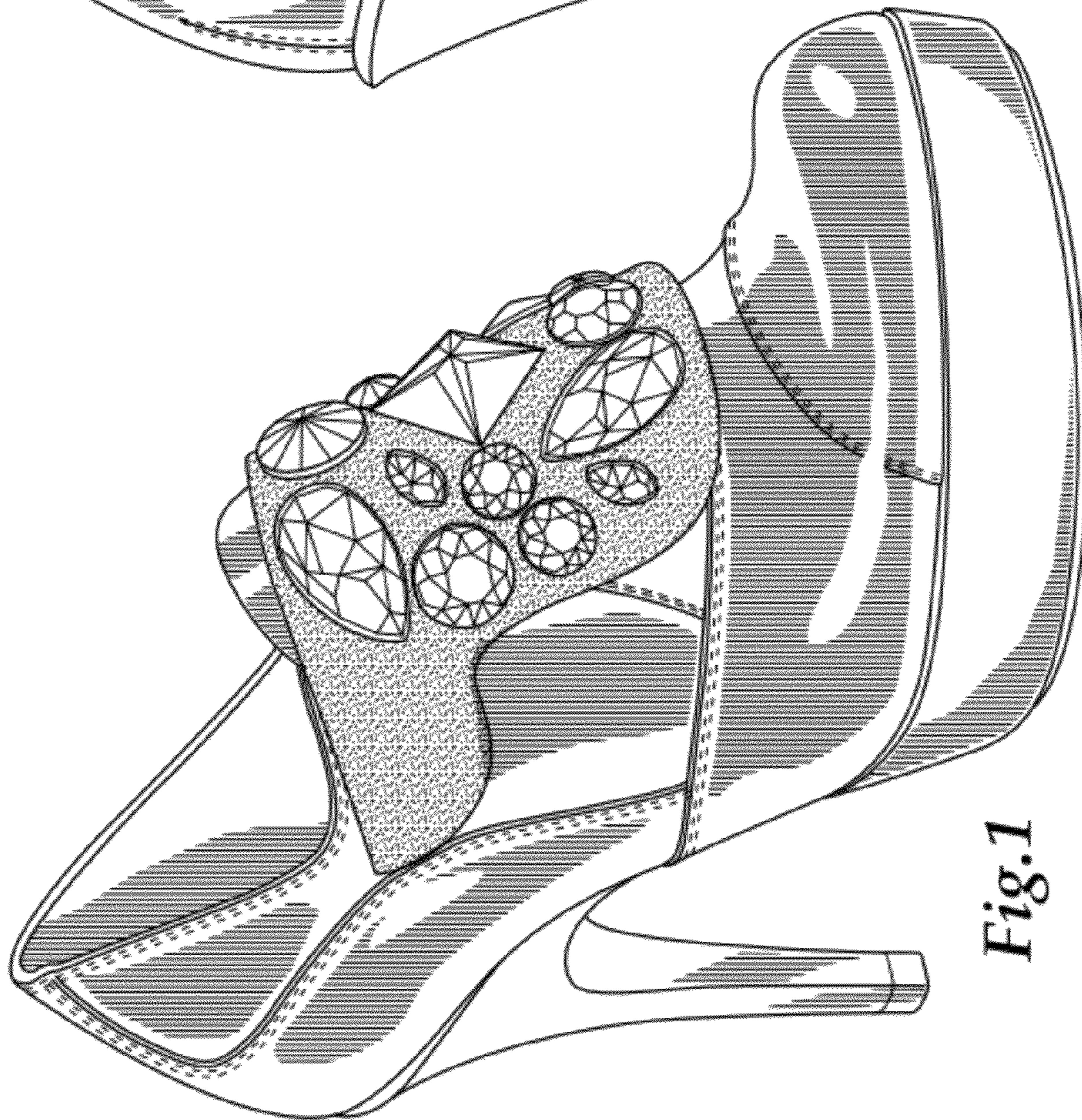

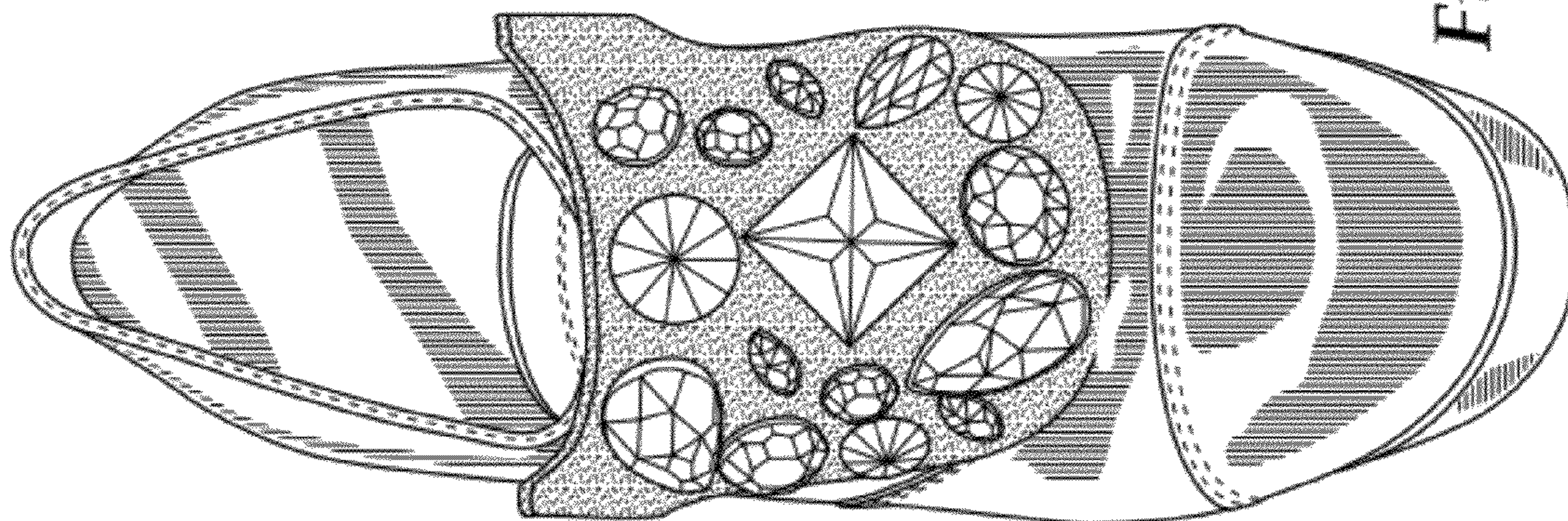

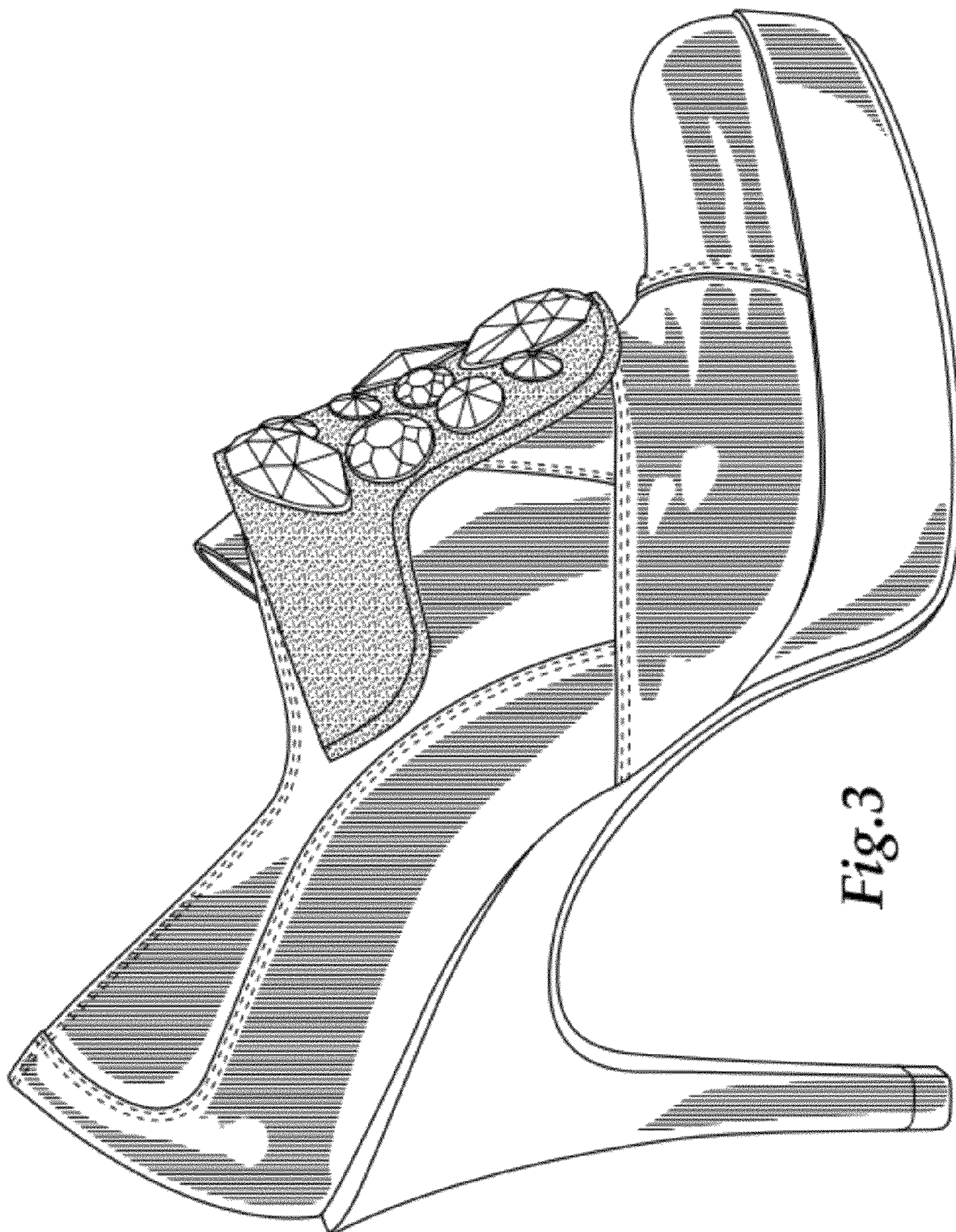
