(57) **CLAIM**

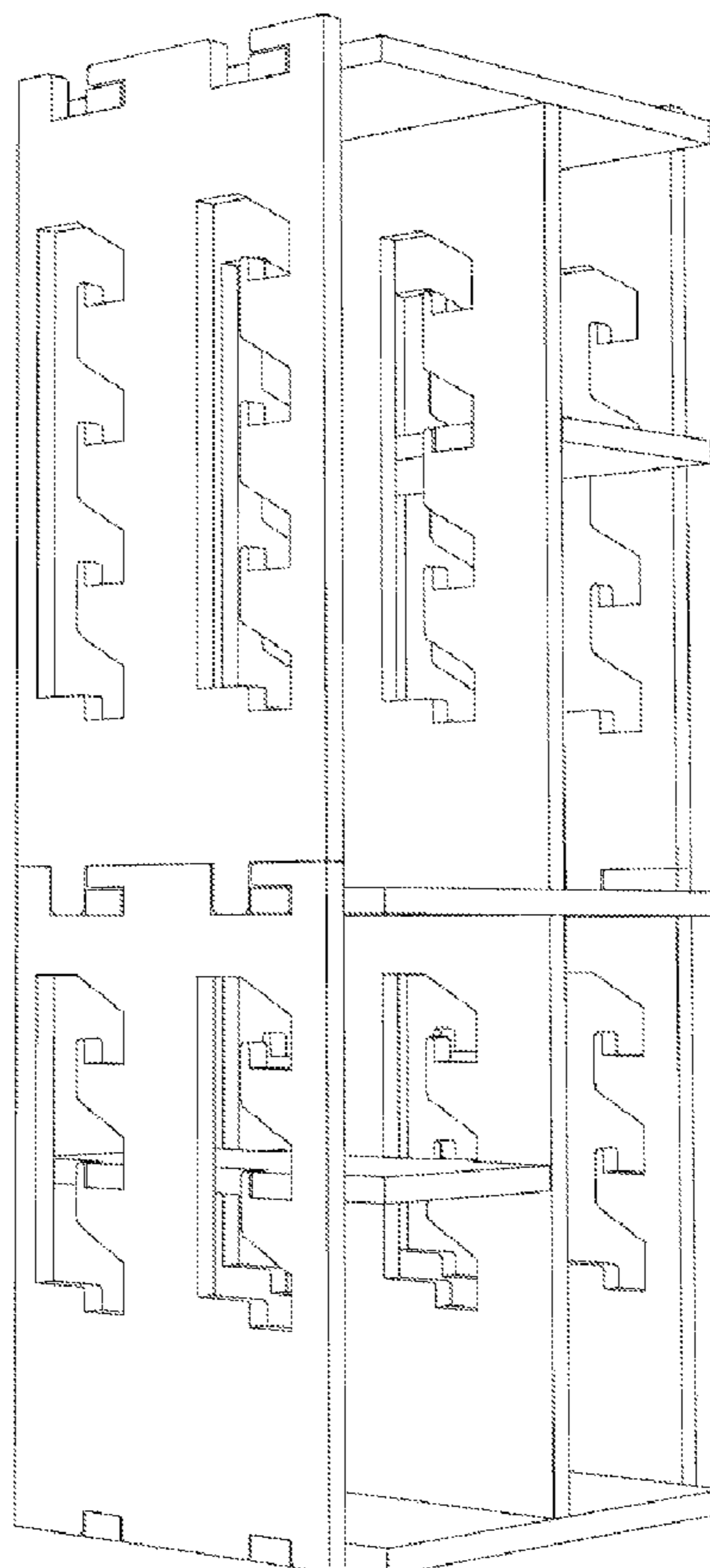
The ornamental design for a locker organizer, as shown and described.

DESCRIPTION

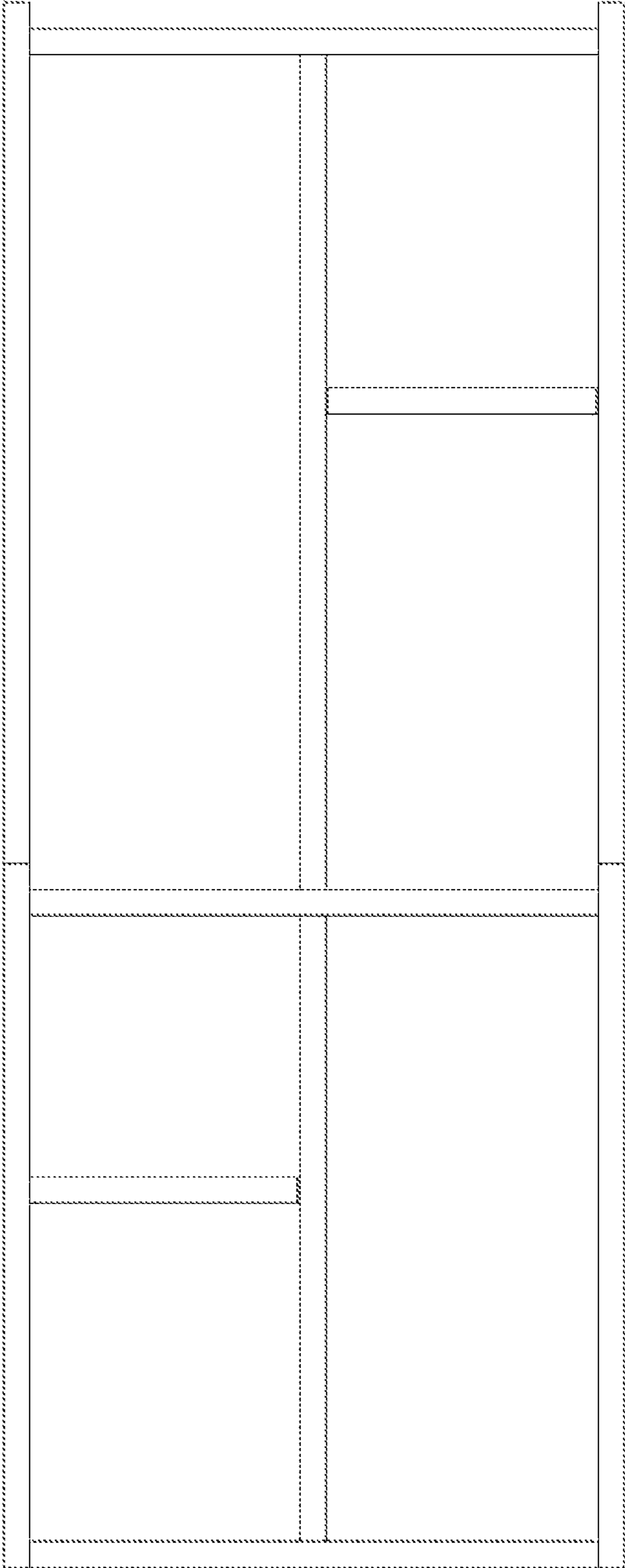

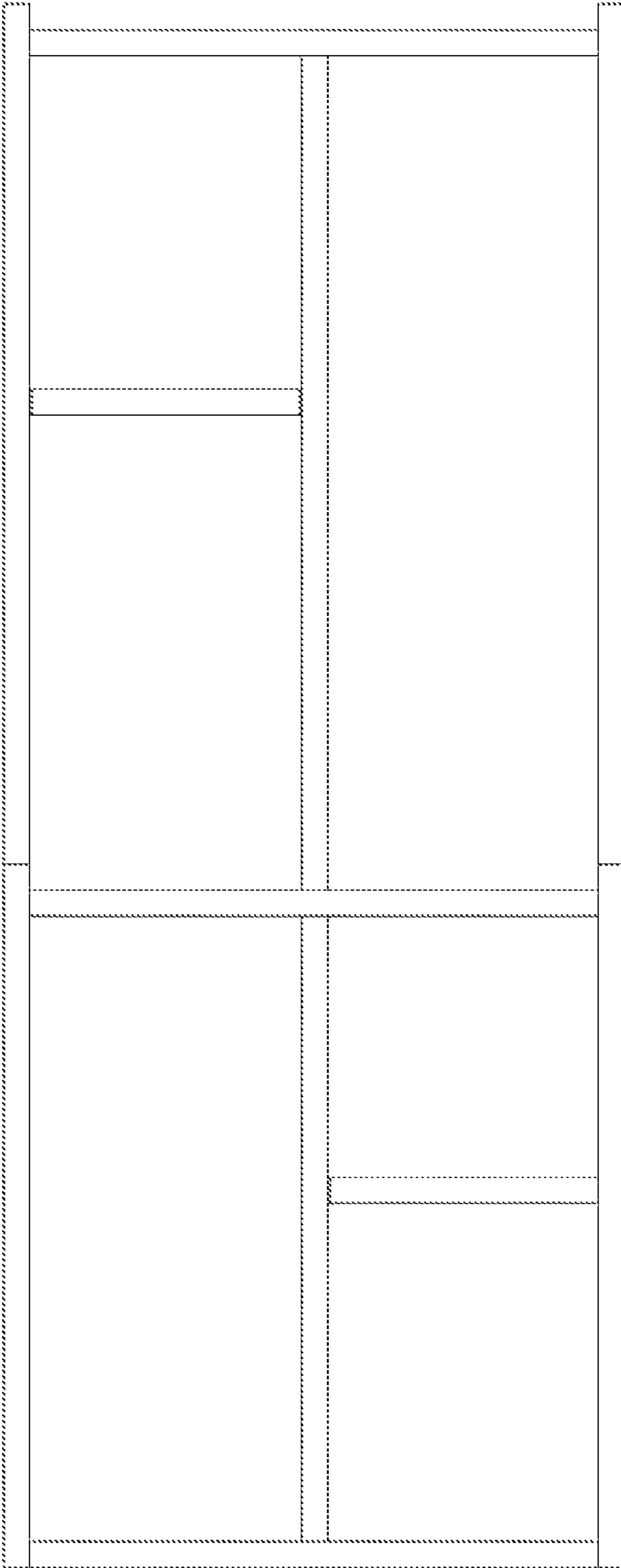

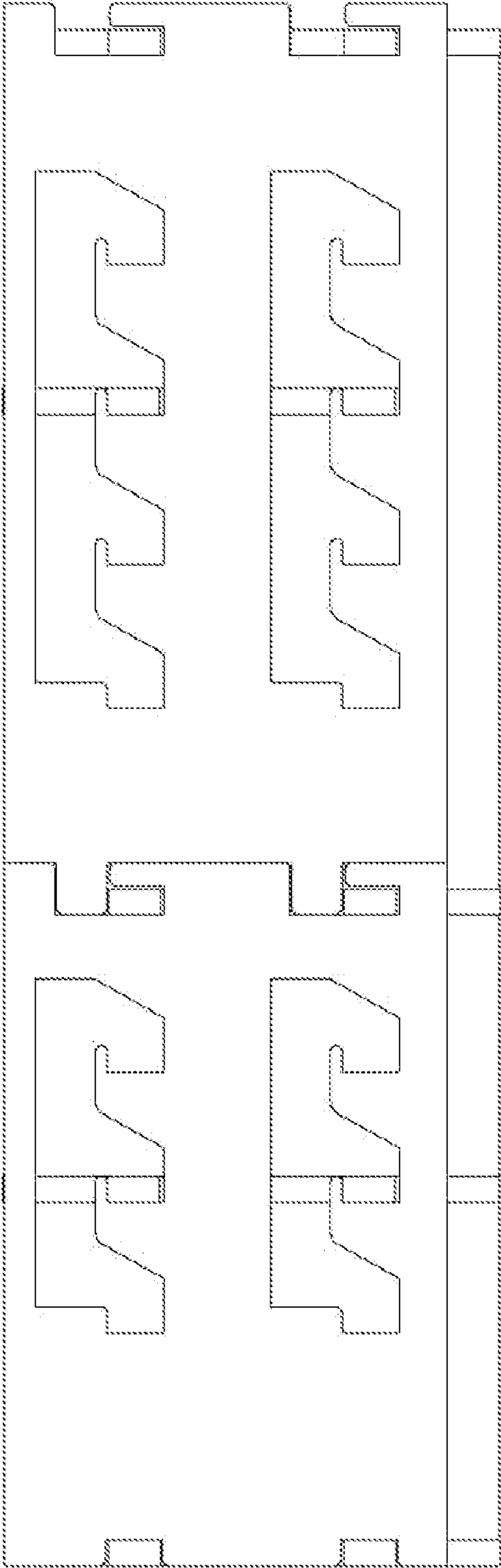

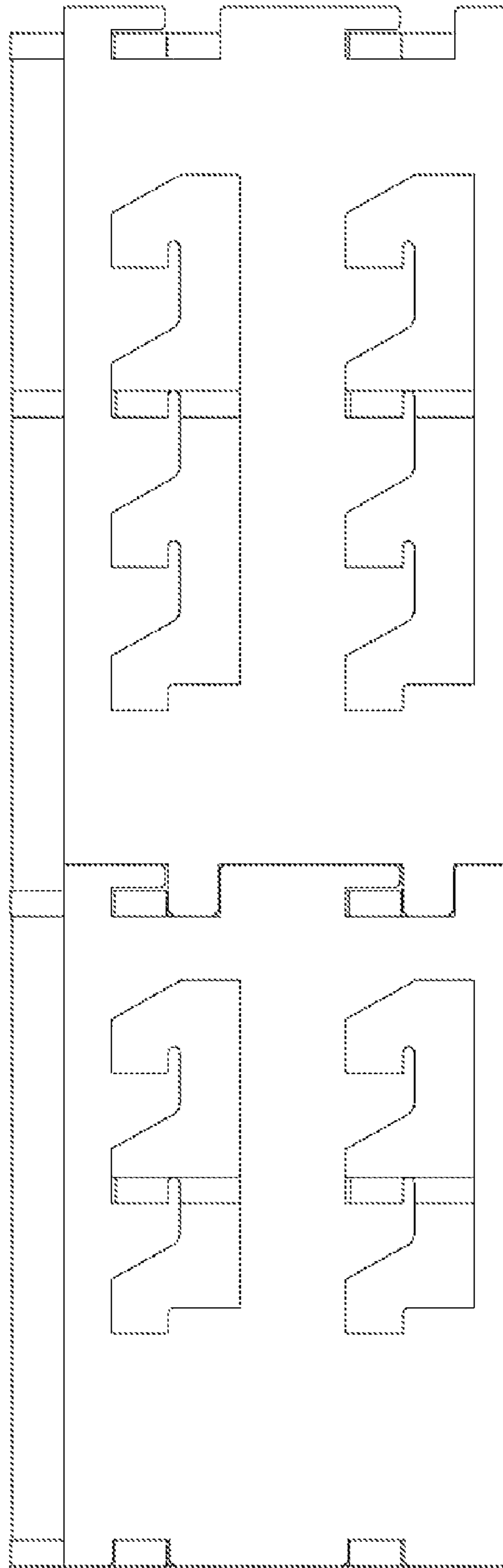

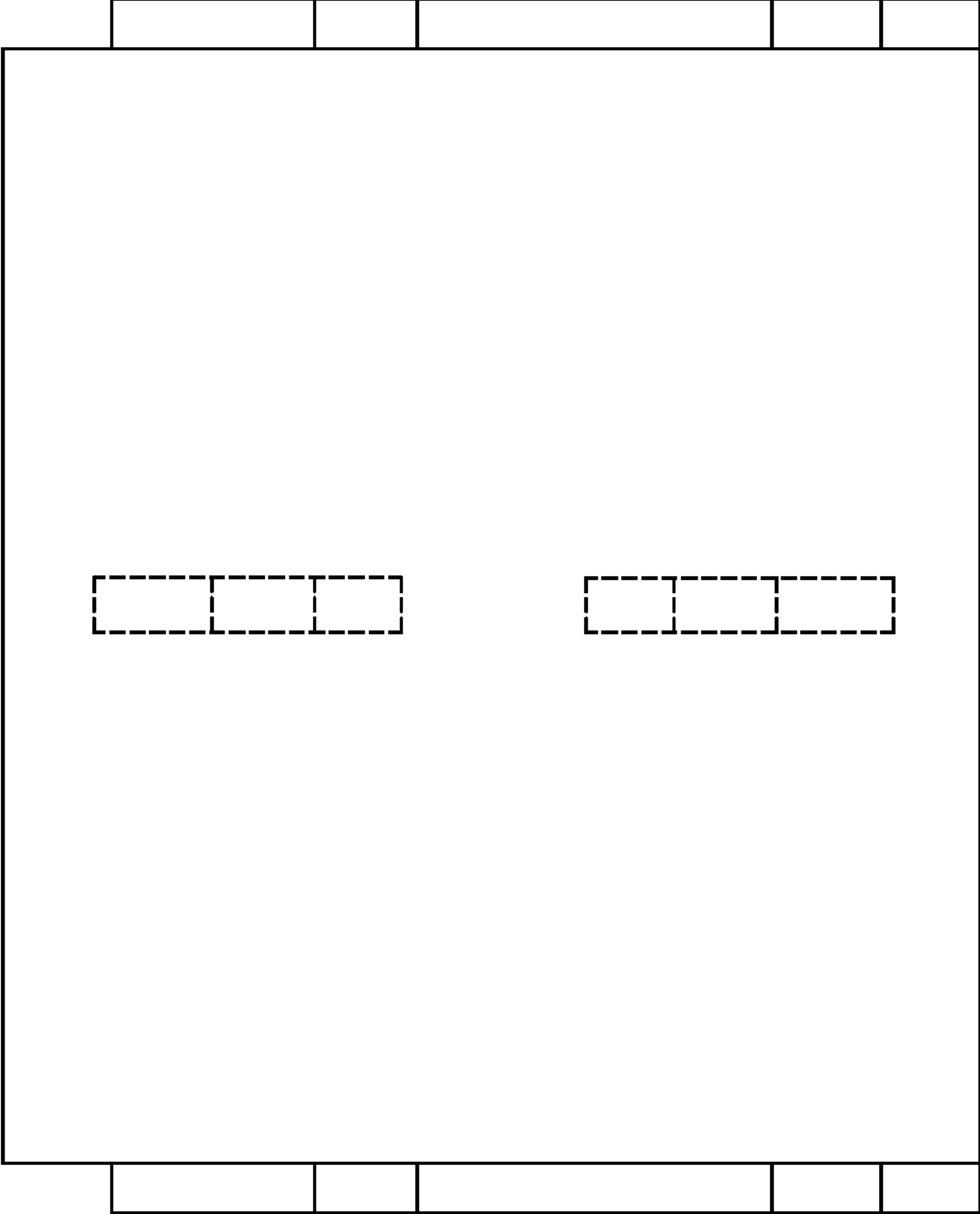

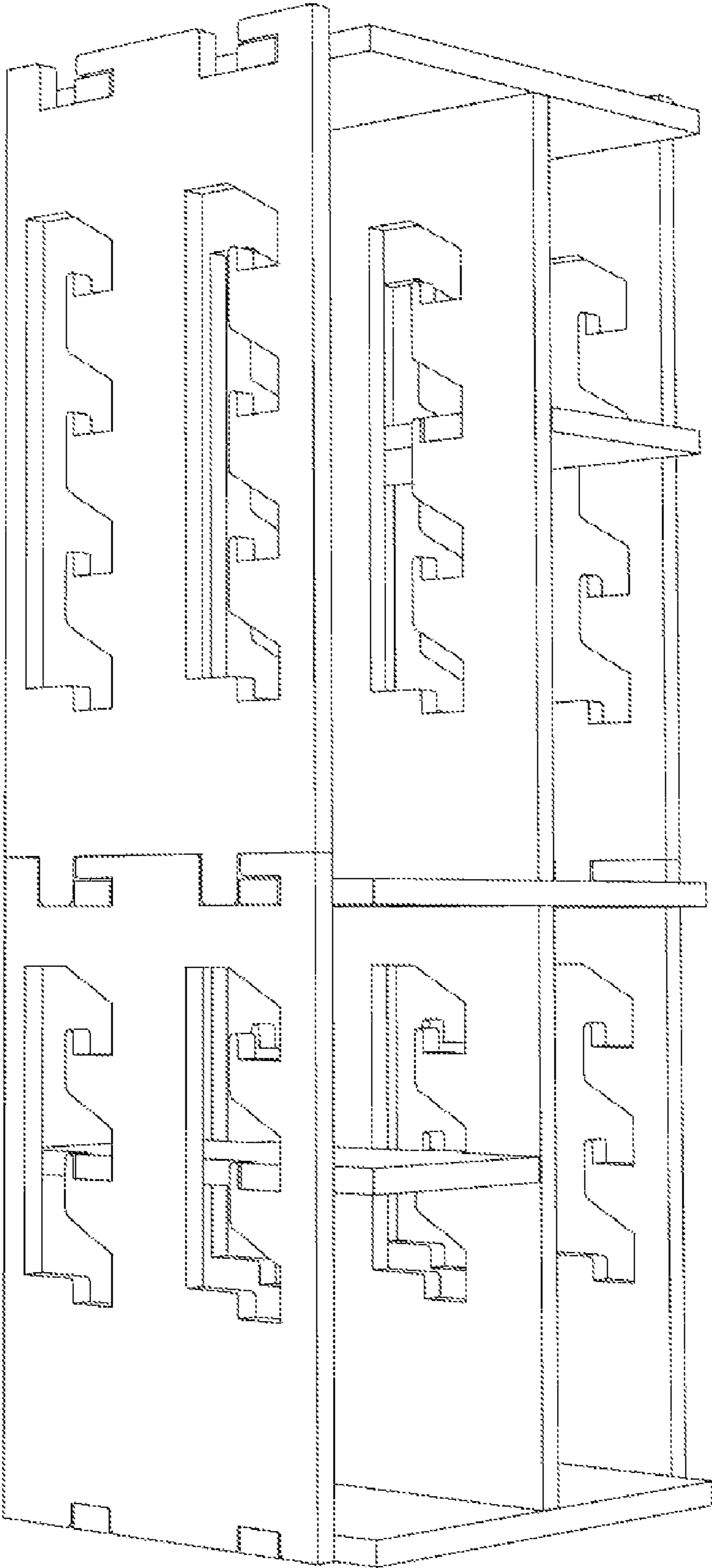

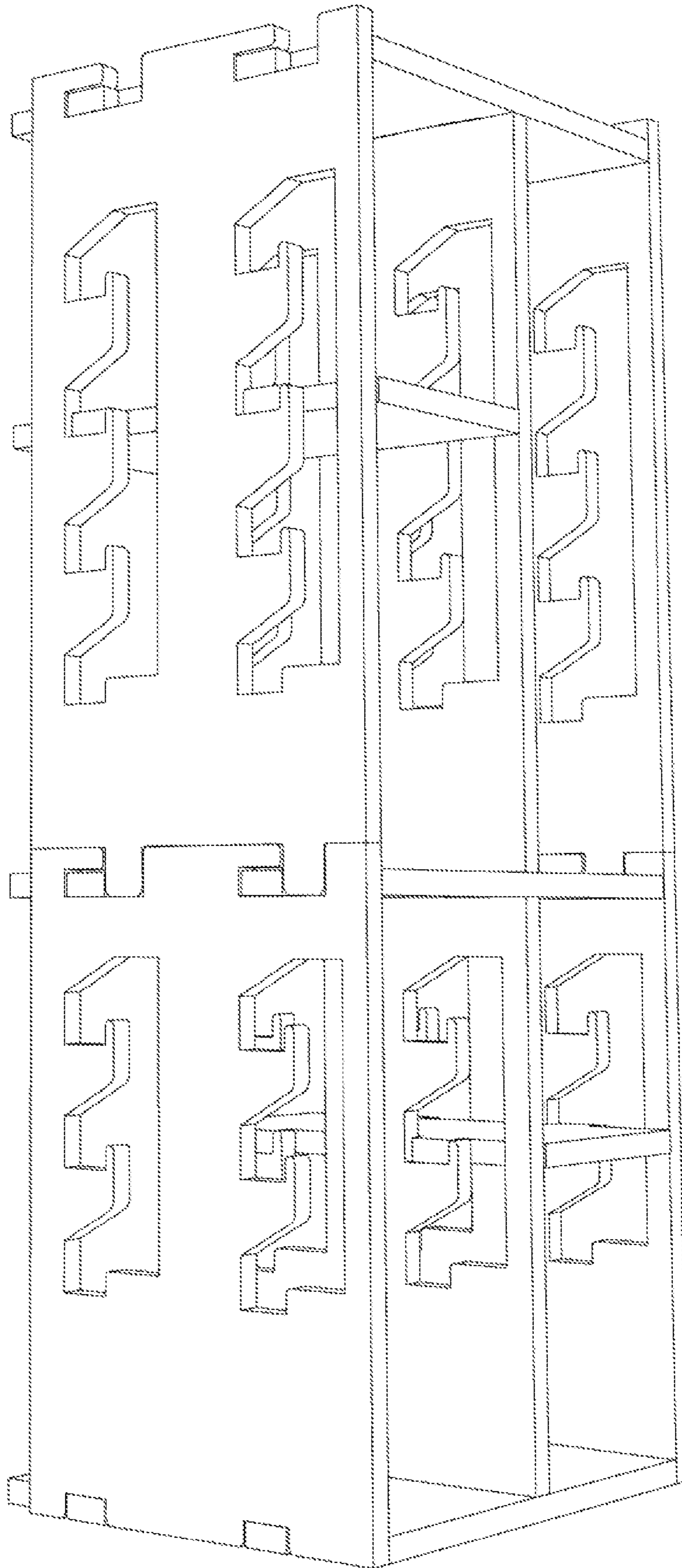

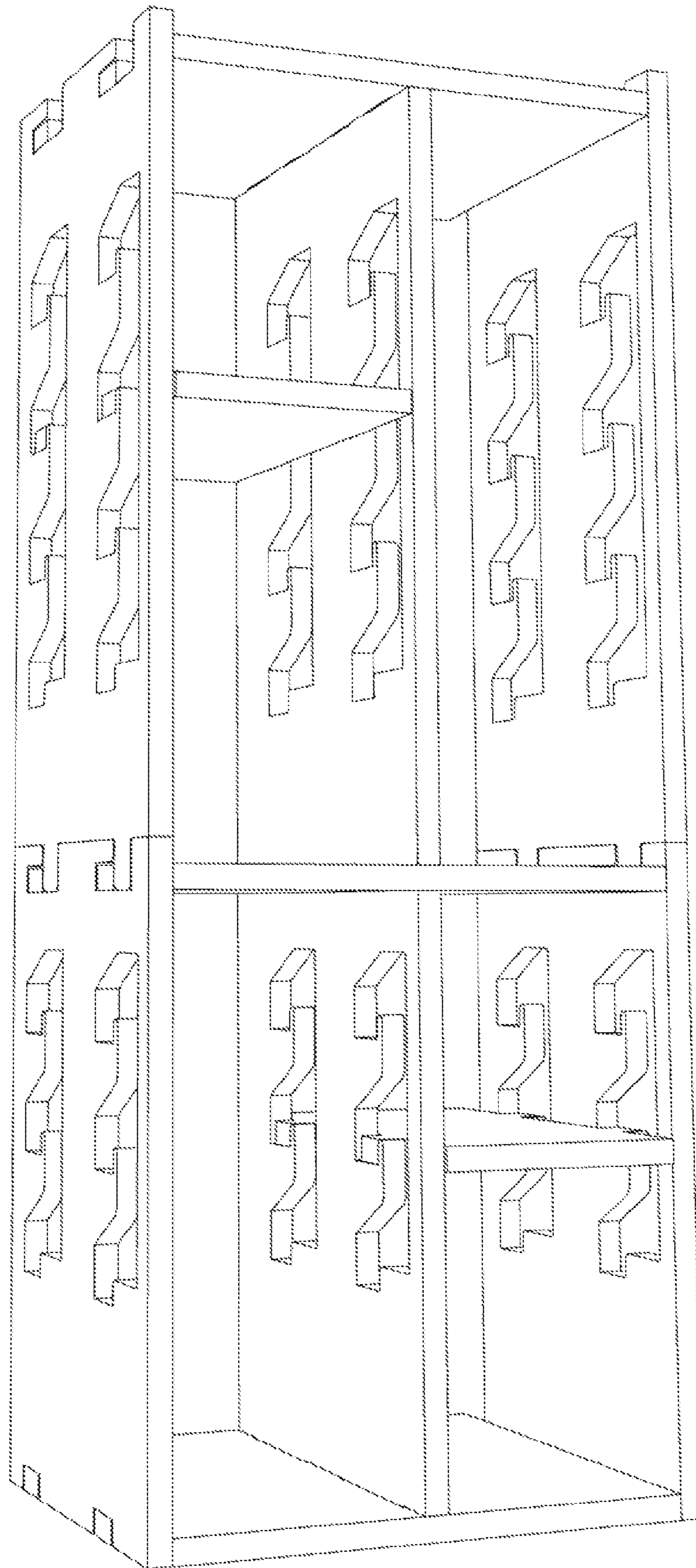

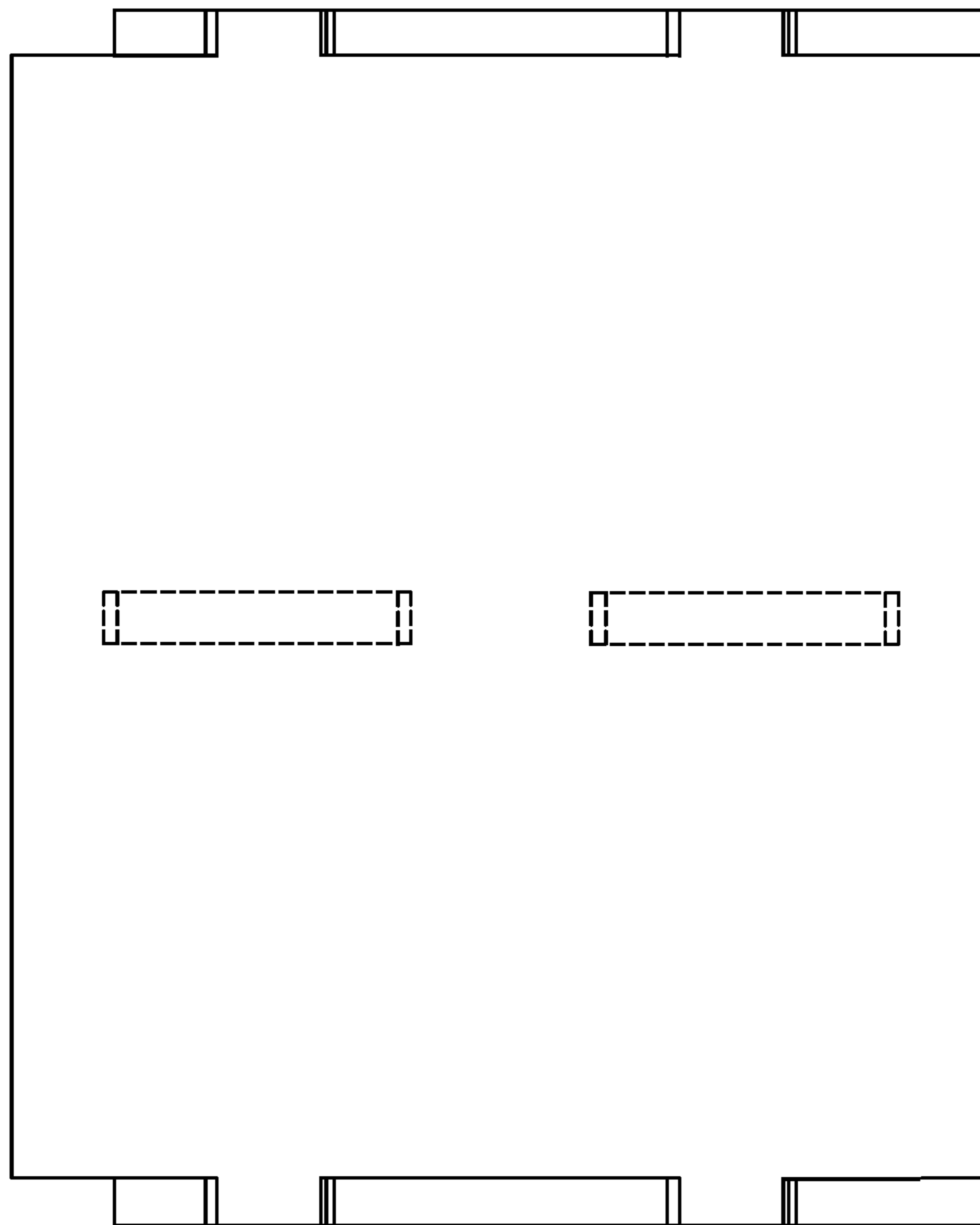
