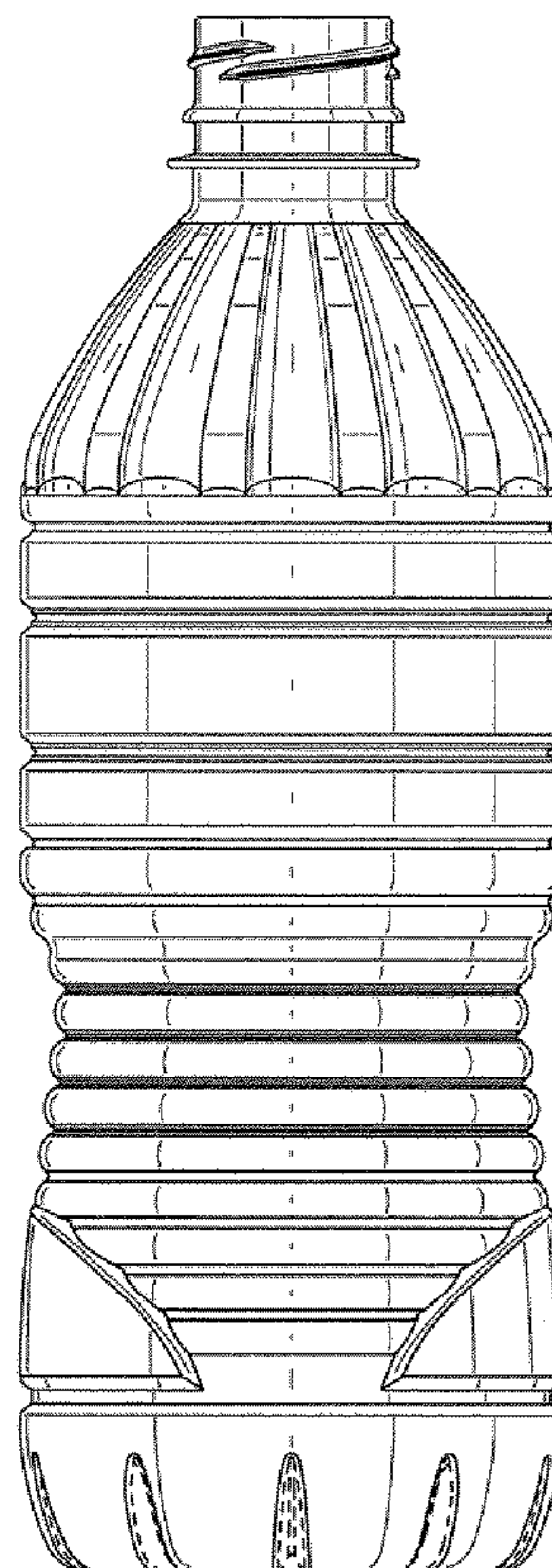
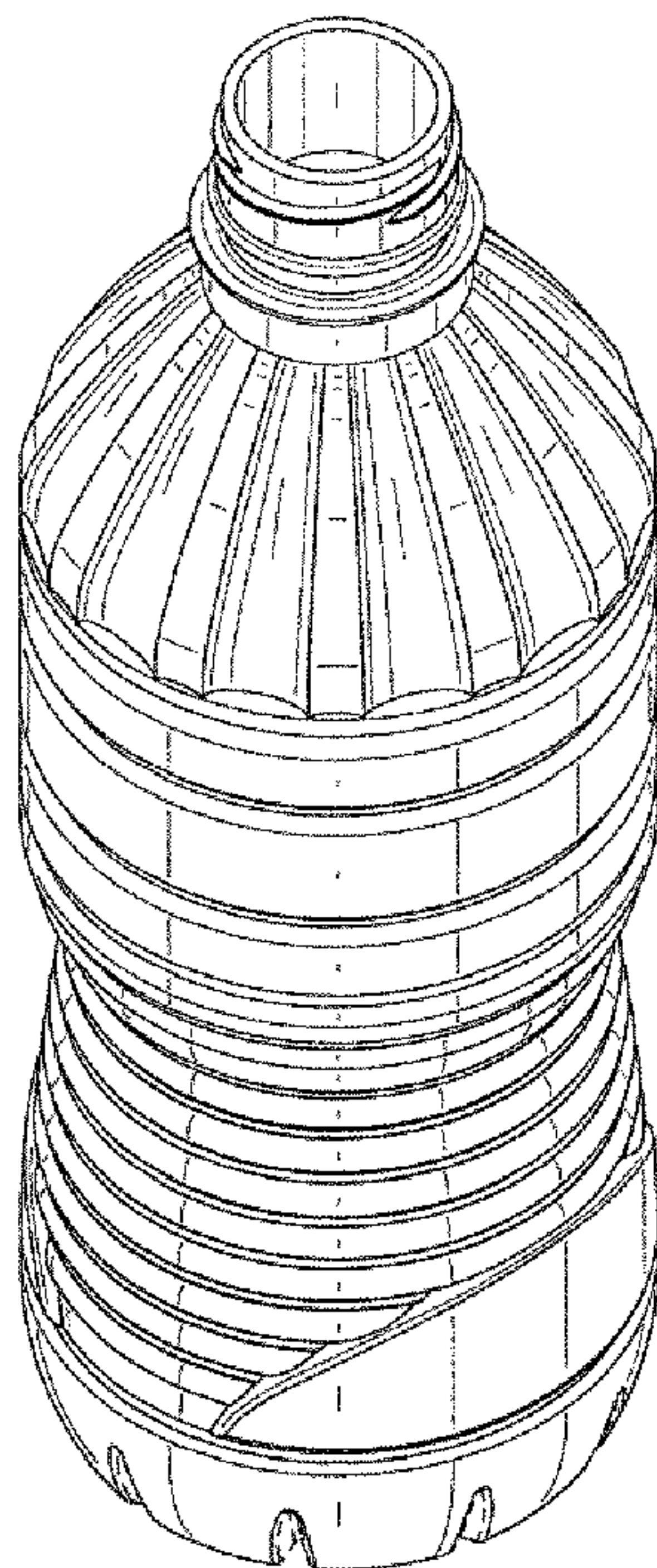
The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a bottle;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof; and,
FIG. 4 is a top plan view thereof.

The broken line showing of a portion of the bottom edge surface is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

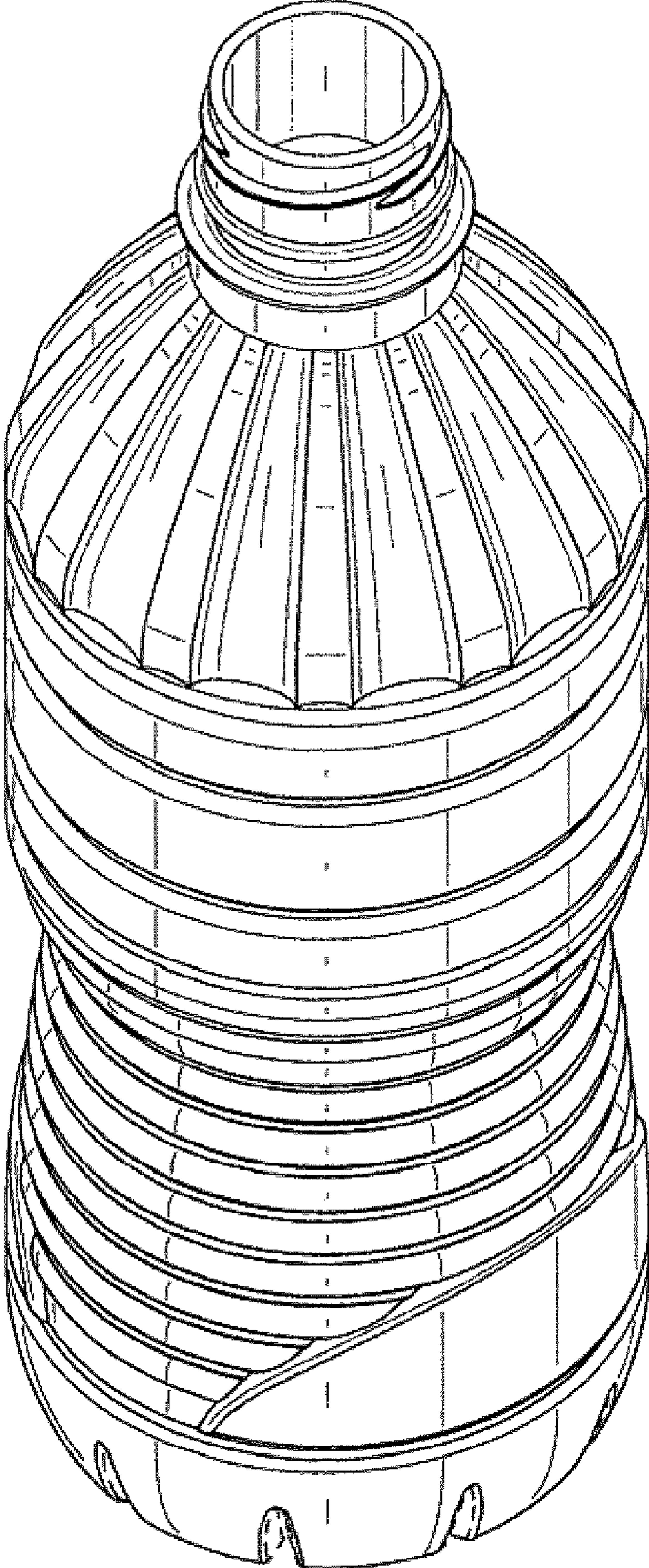

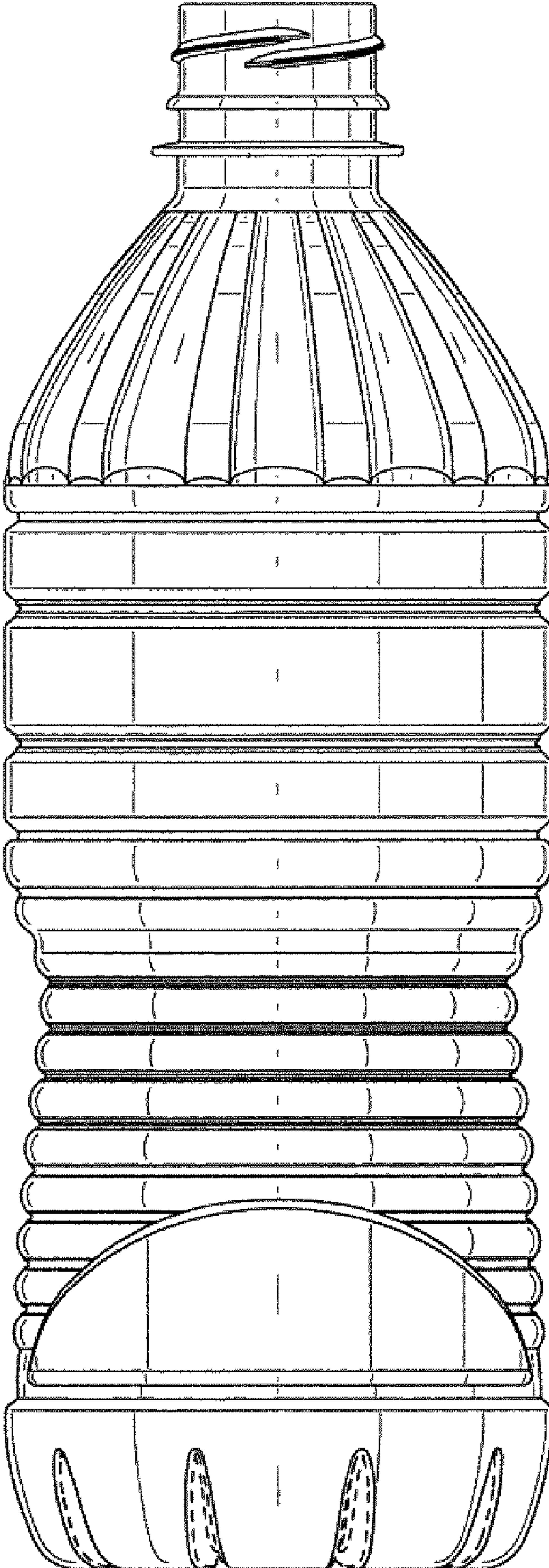

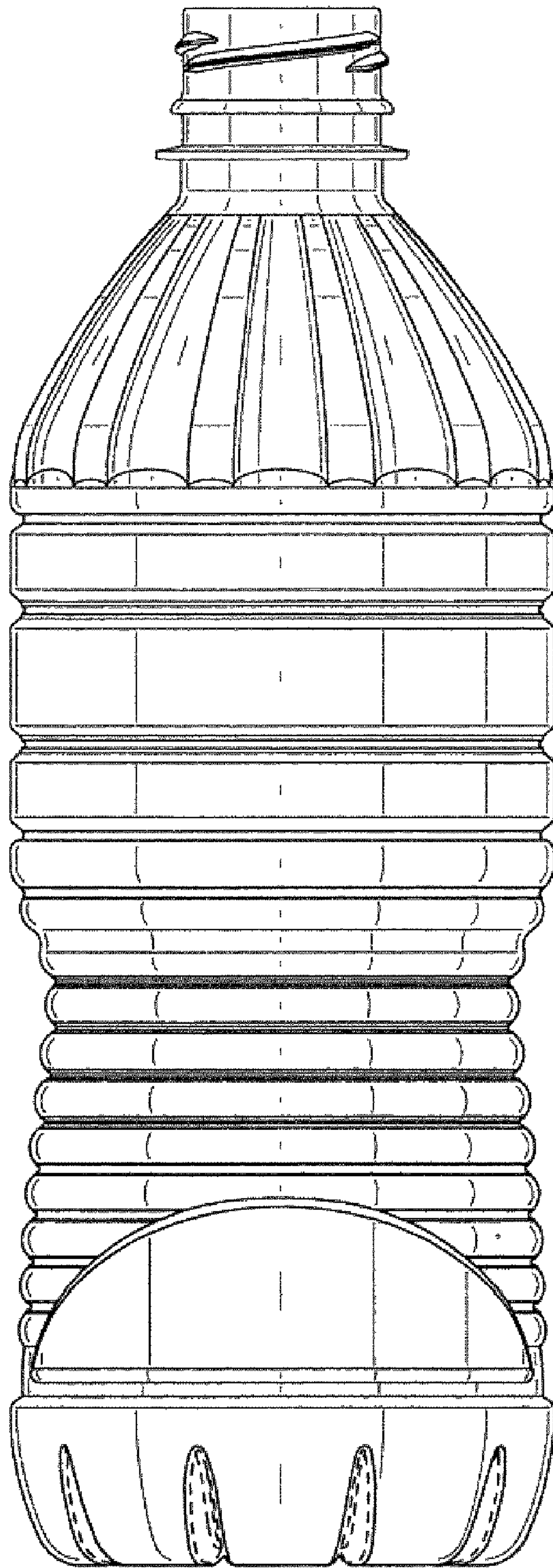

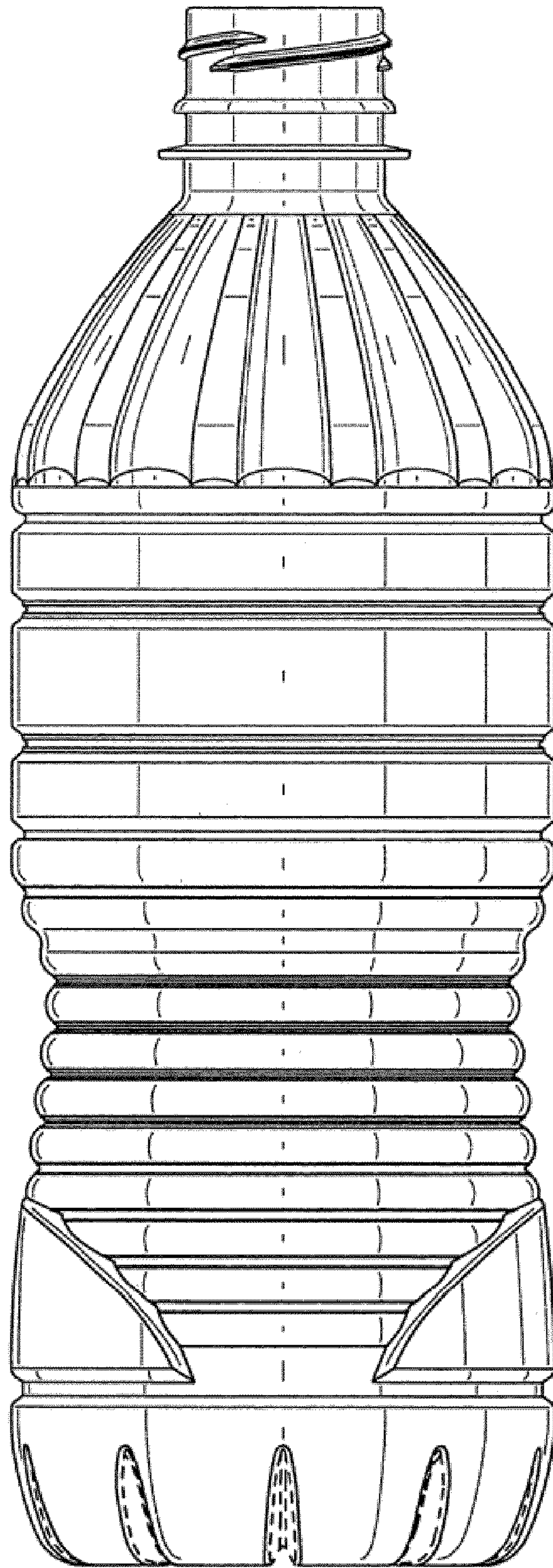
