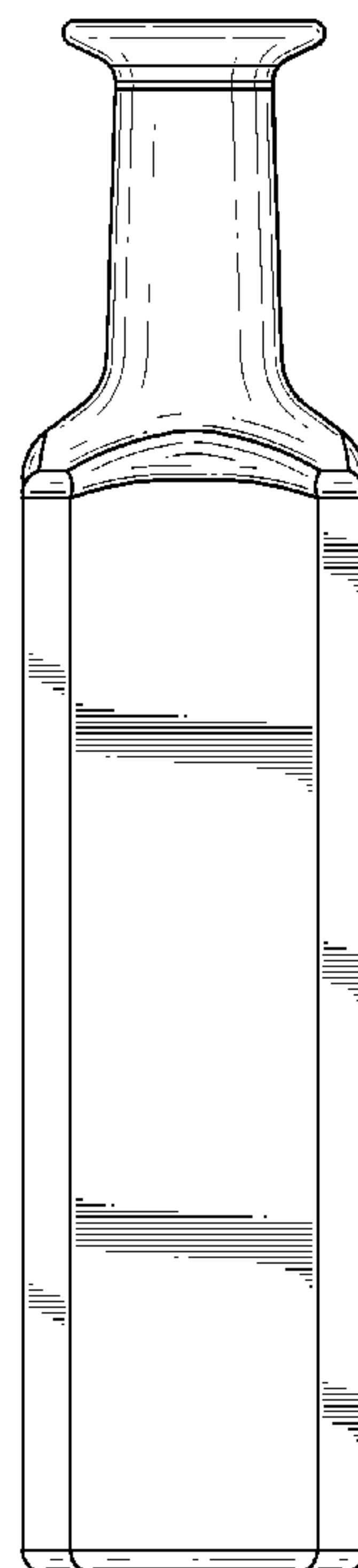
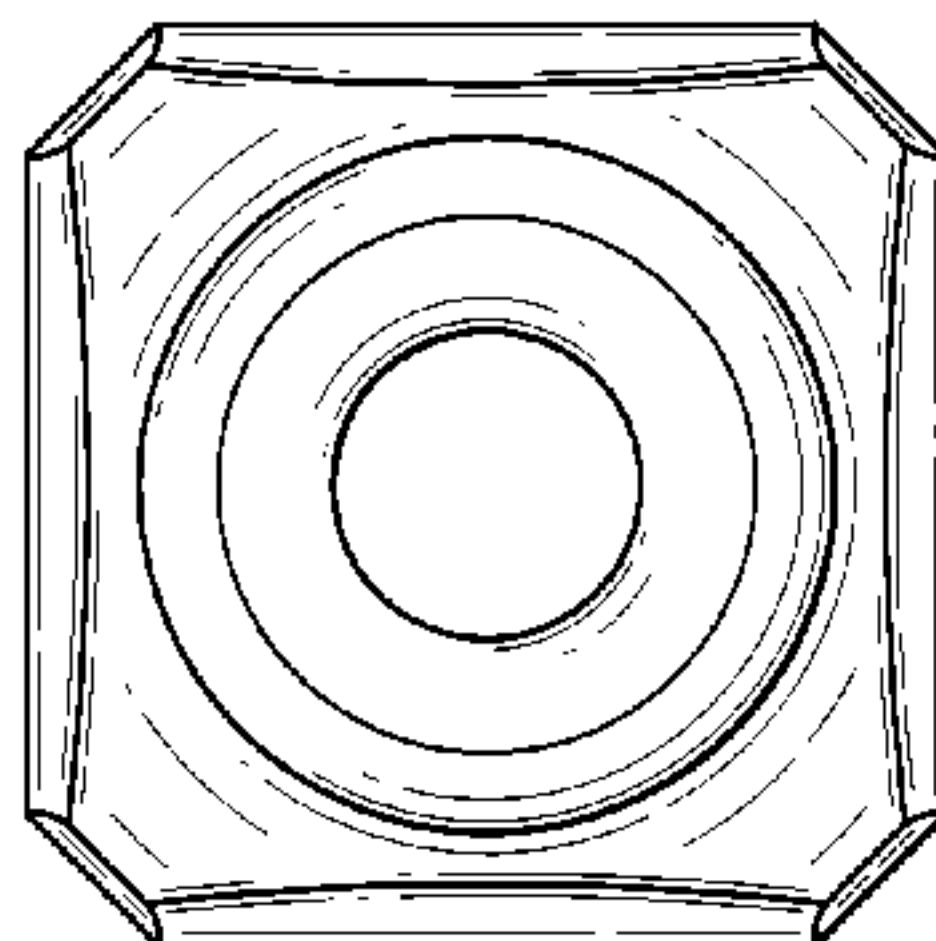
The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a bottle showing my new design; FIG. 2 is a front elevational view thereof shown at a reduced scale, the rear elevational view being identical; FIG. 3 is a right side elevational view thereof, the left side elevational view being identical; and, FIG. 4 is a bottom plan view thereof shown at an enlarged scale.

The broken lines in the drawings illustrate the portion of the design that forms no part of the claimed design.

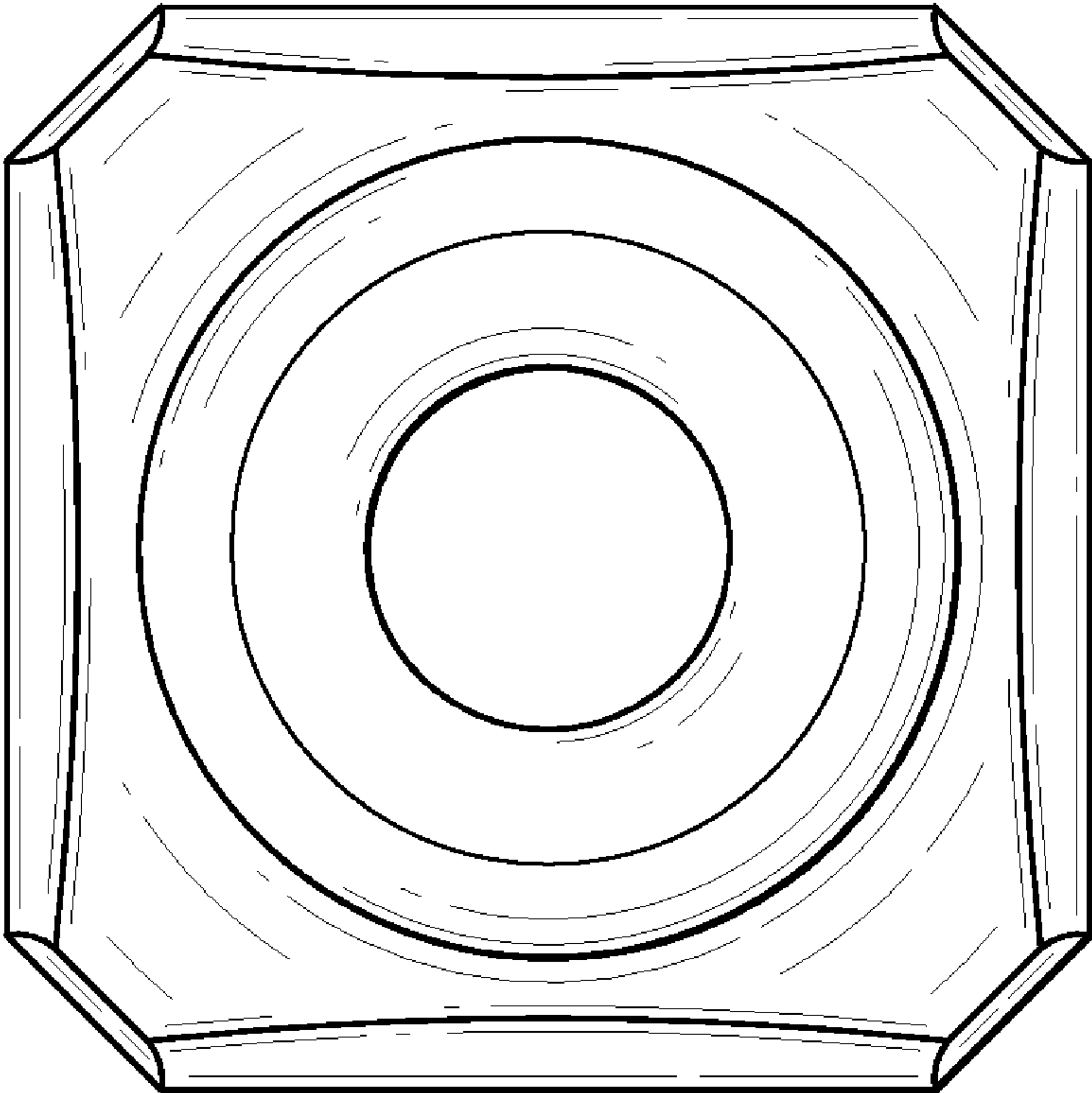

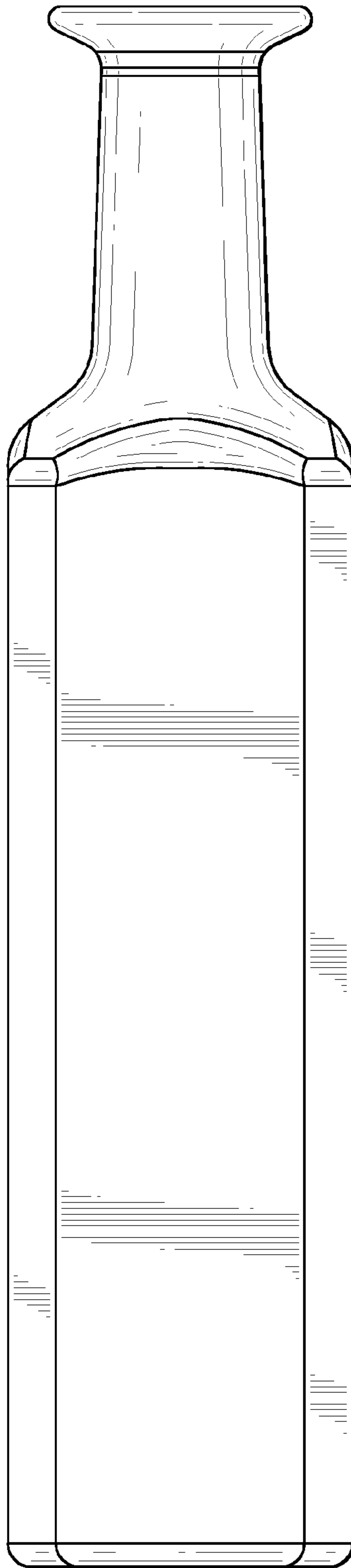

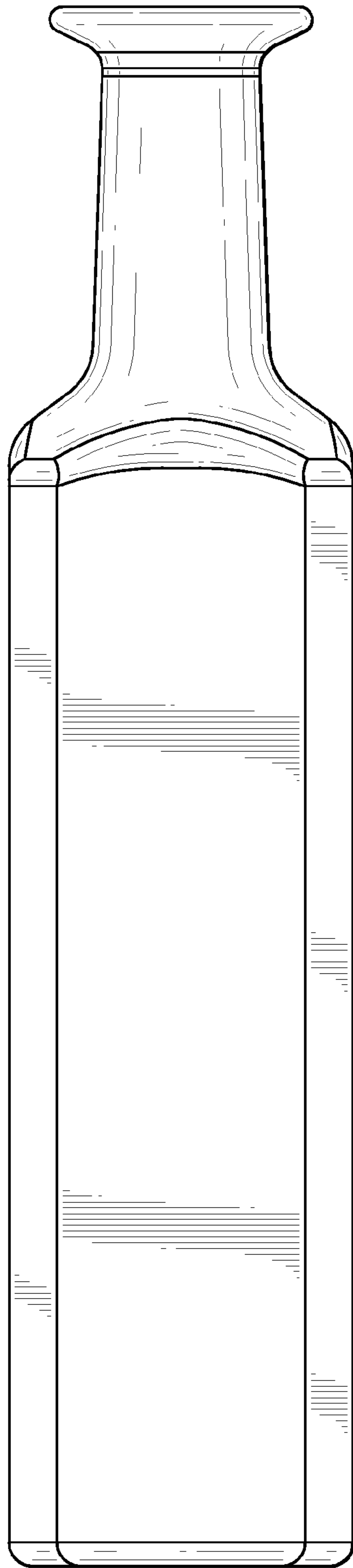

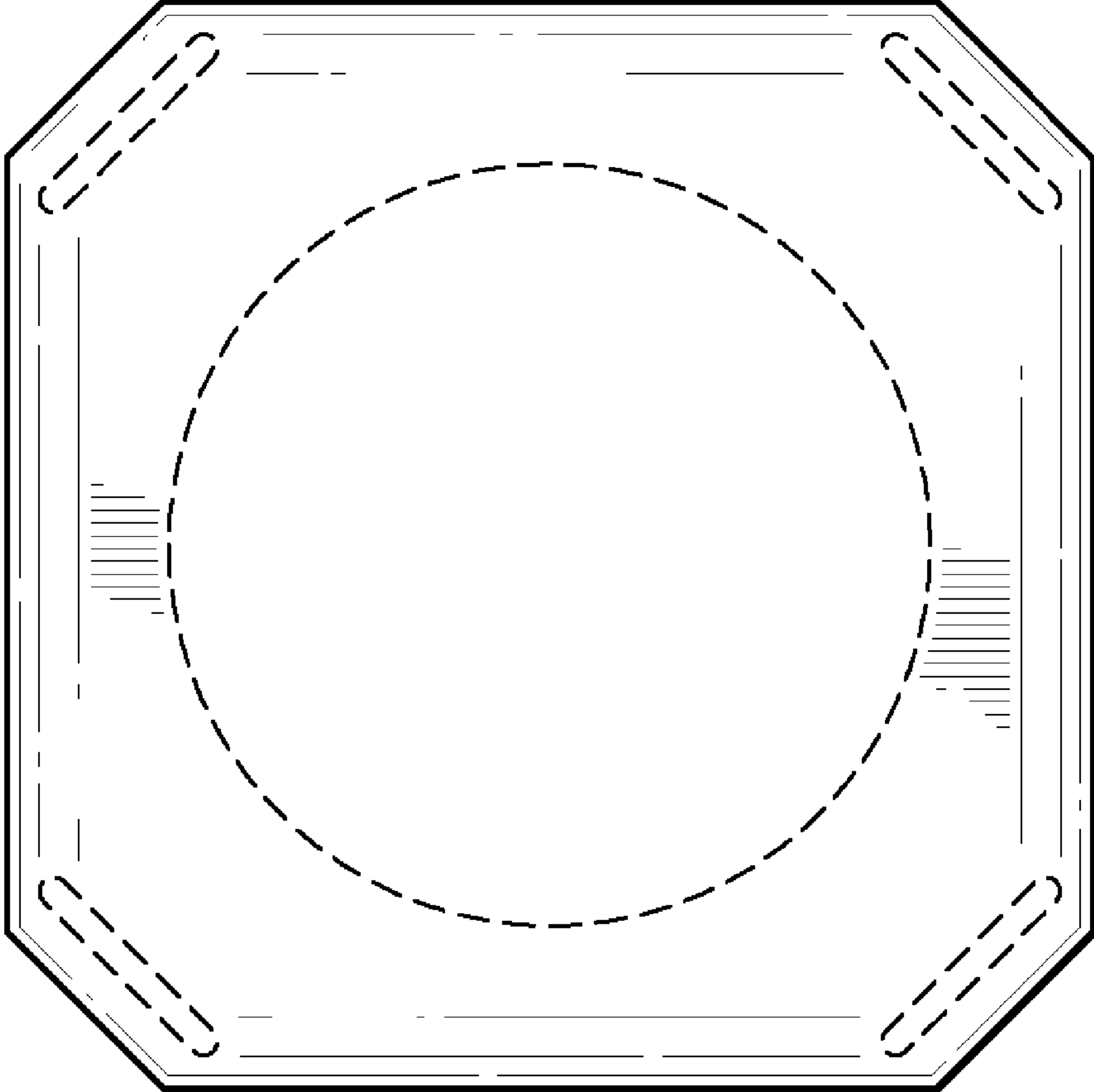
