(57) **CLAIM**

The ornamental design for a monitor stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a monitor stand showing my new design, with the top removed from the base;

FIG. 2 is a right side view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a right side elevational view of the monitor stand with the cover mounted on the base in the highest position;

FIG. 8 is a side elevational view thereof;

FIG. 9 is a right side elevational view of the monitor stand with the cover mounted on the base in the intermediate position;

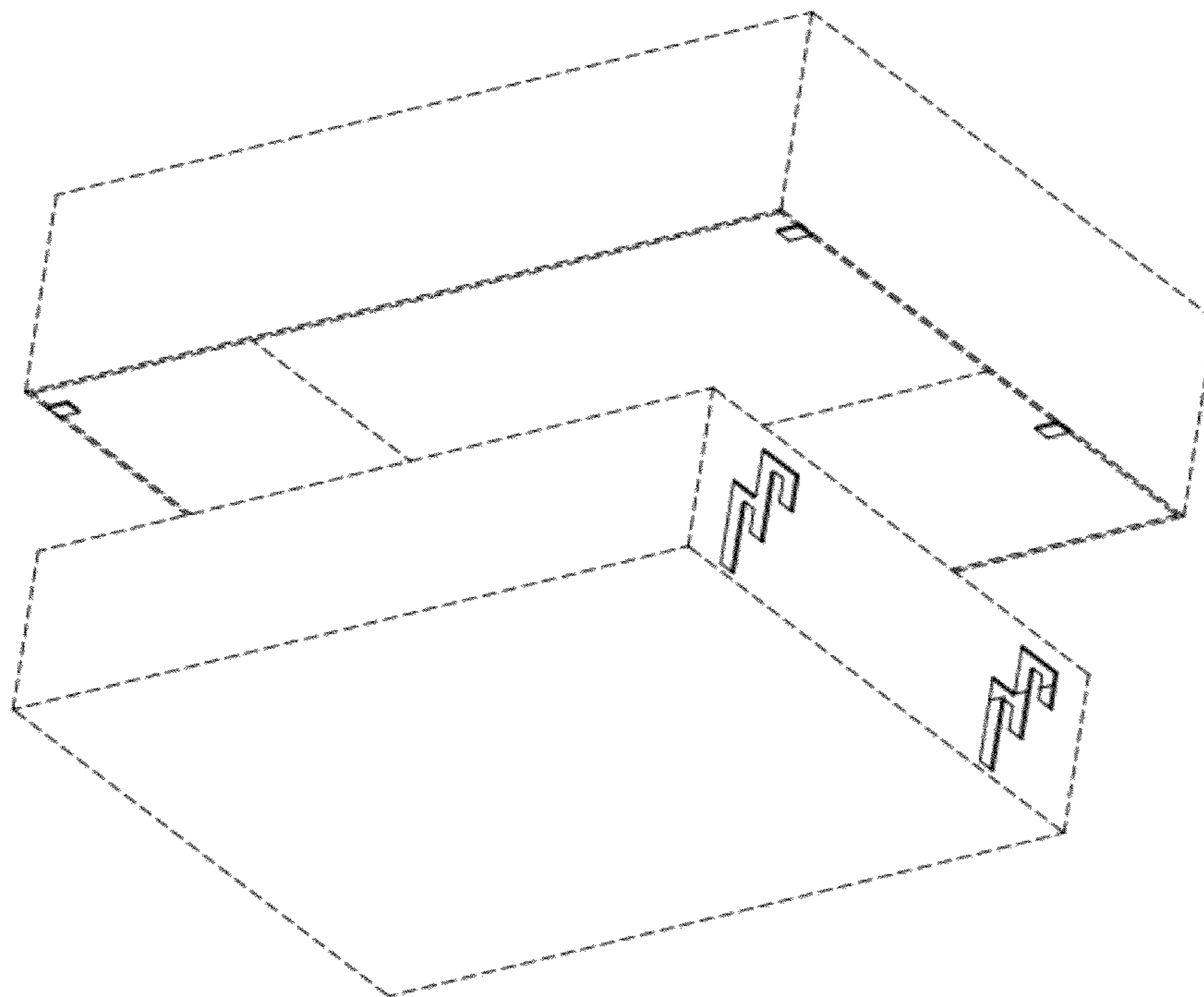
FIG. 10 is a side elevational view thereof;

FIG. 11 is a right side elevational view of the monitor stand with the cover mounted on the base in the lowest position; and,

FIG. 12 is a side elevational view thereof.

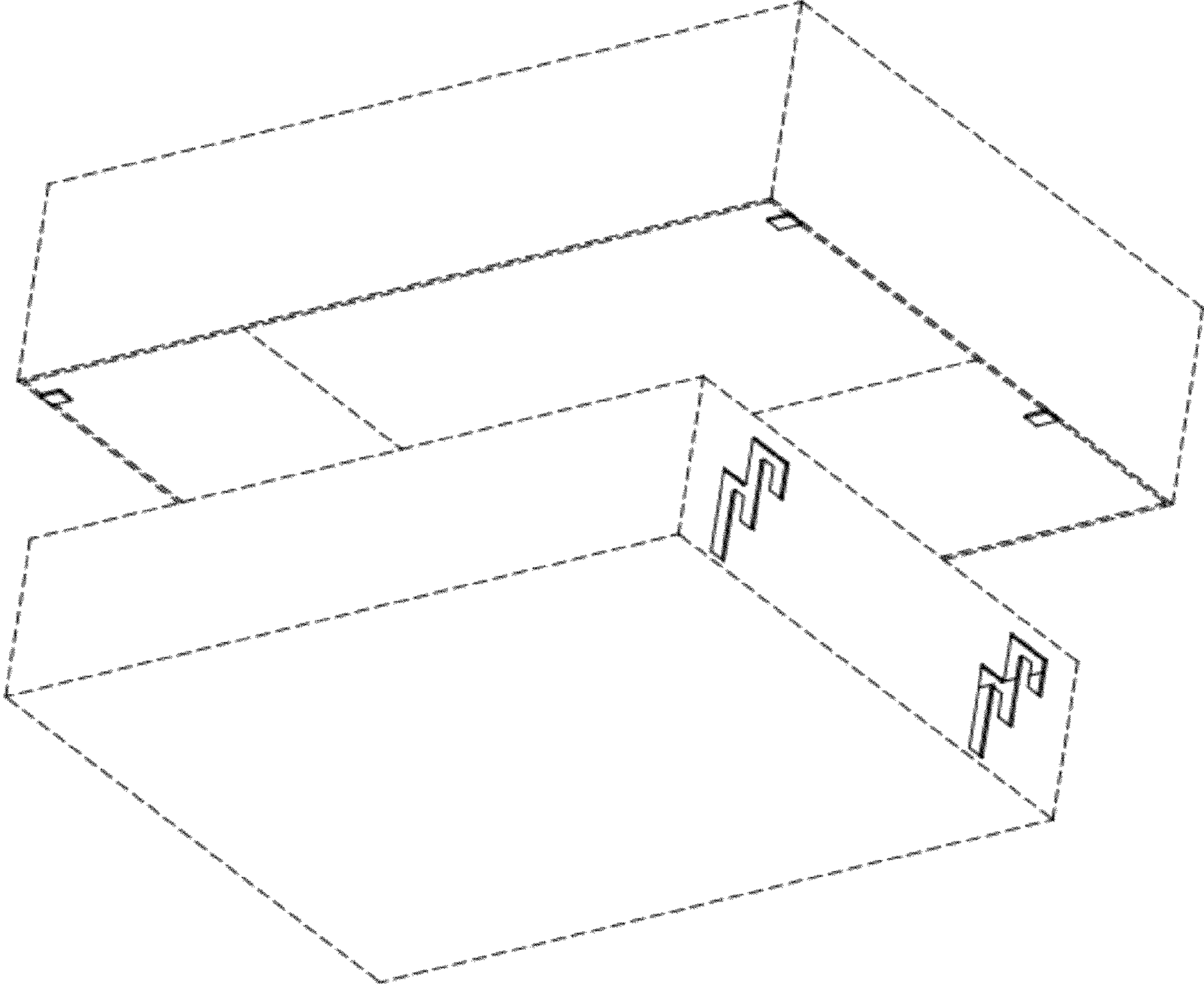

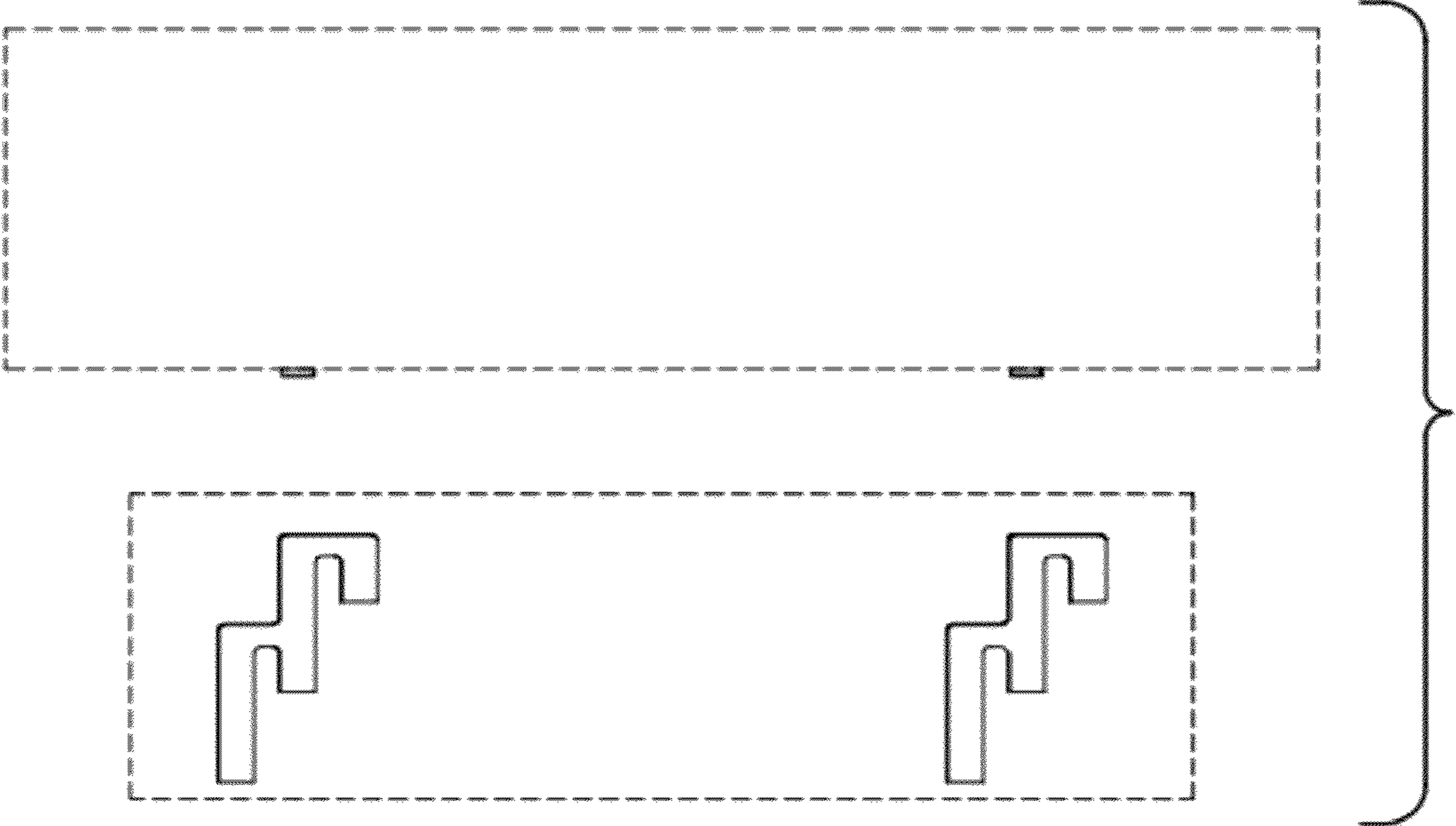

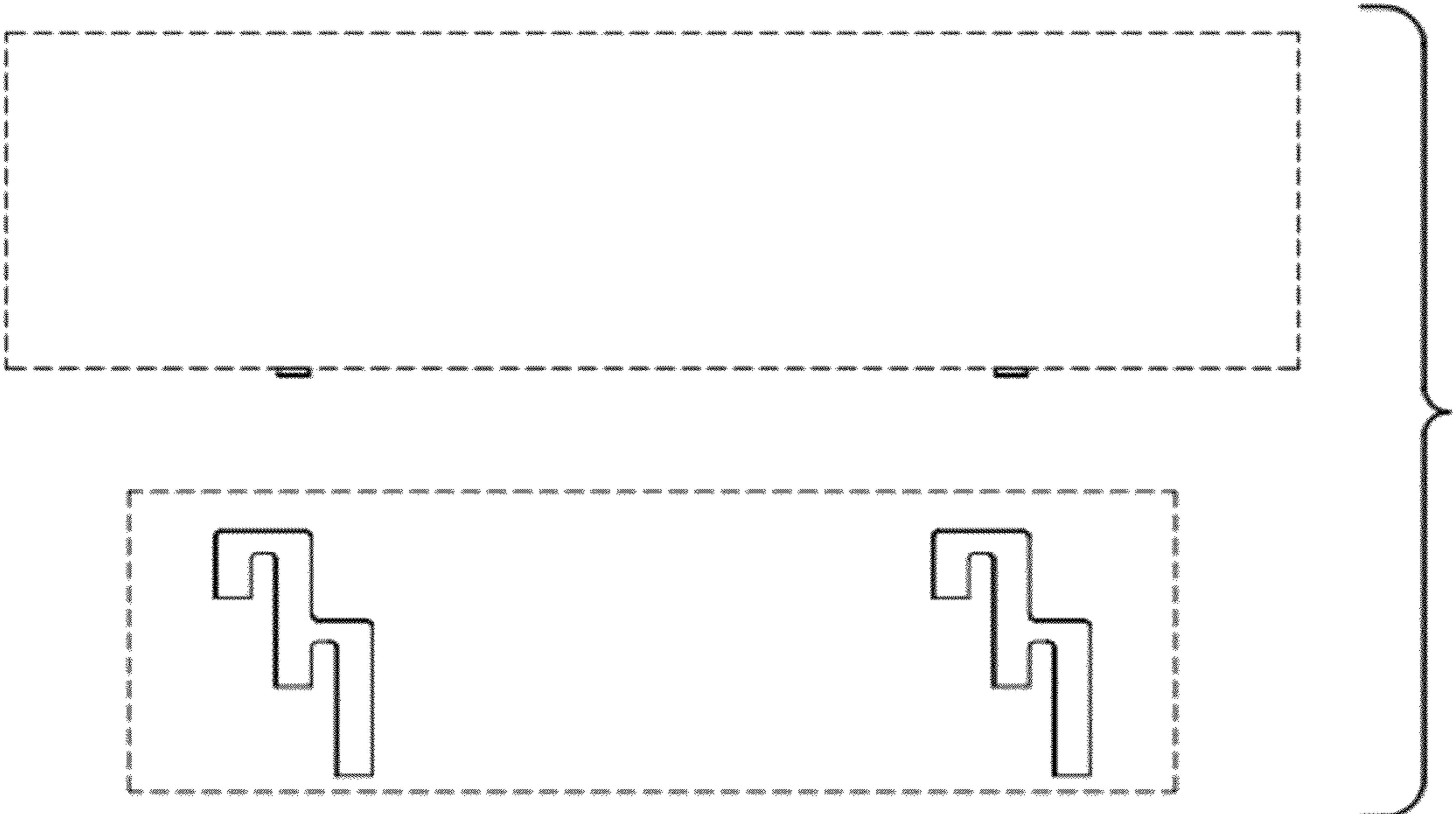

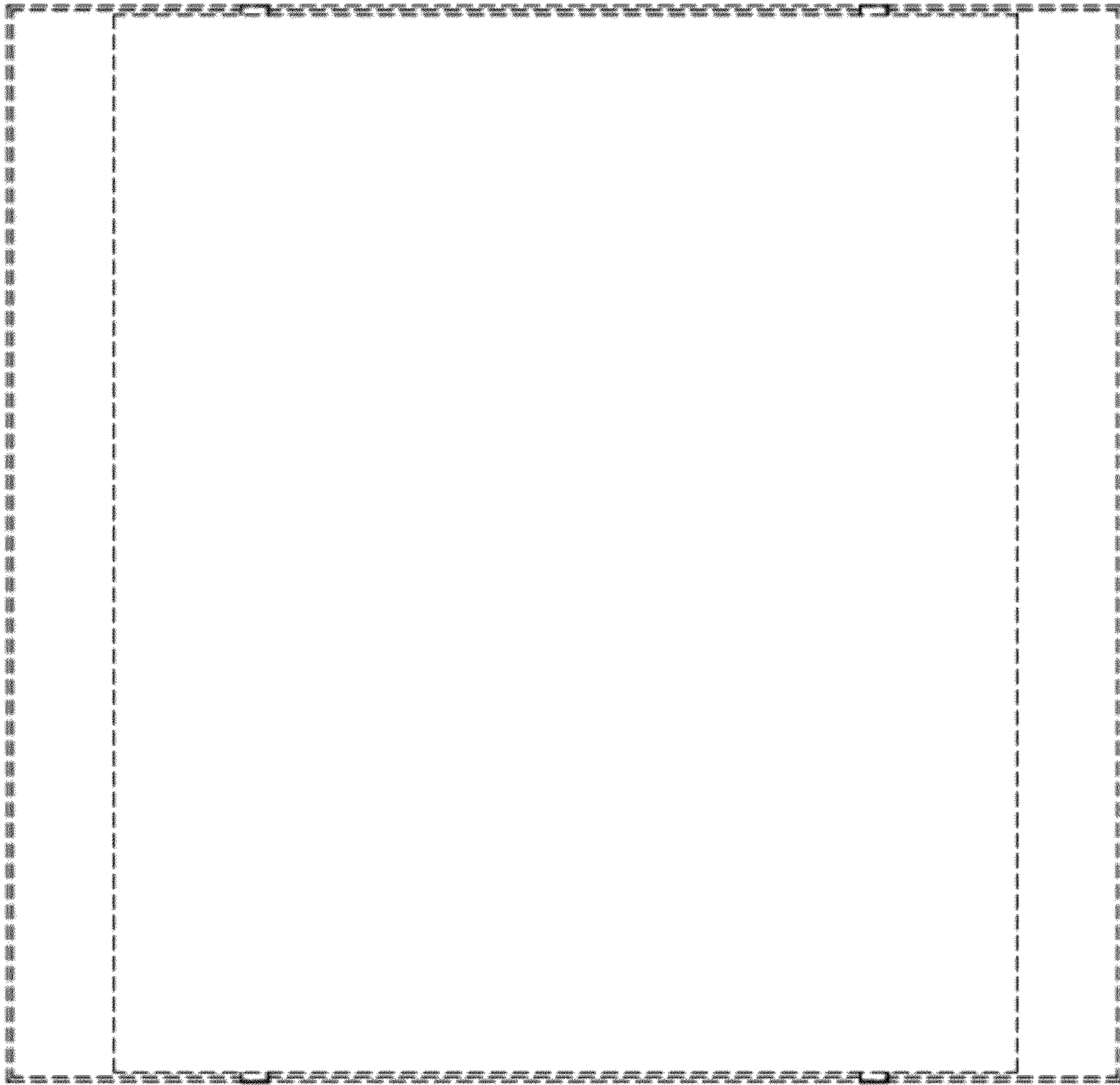

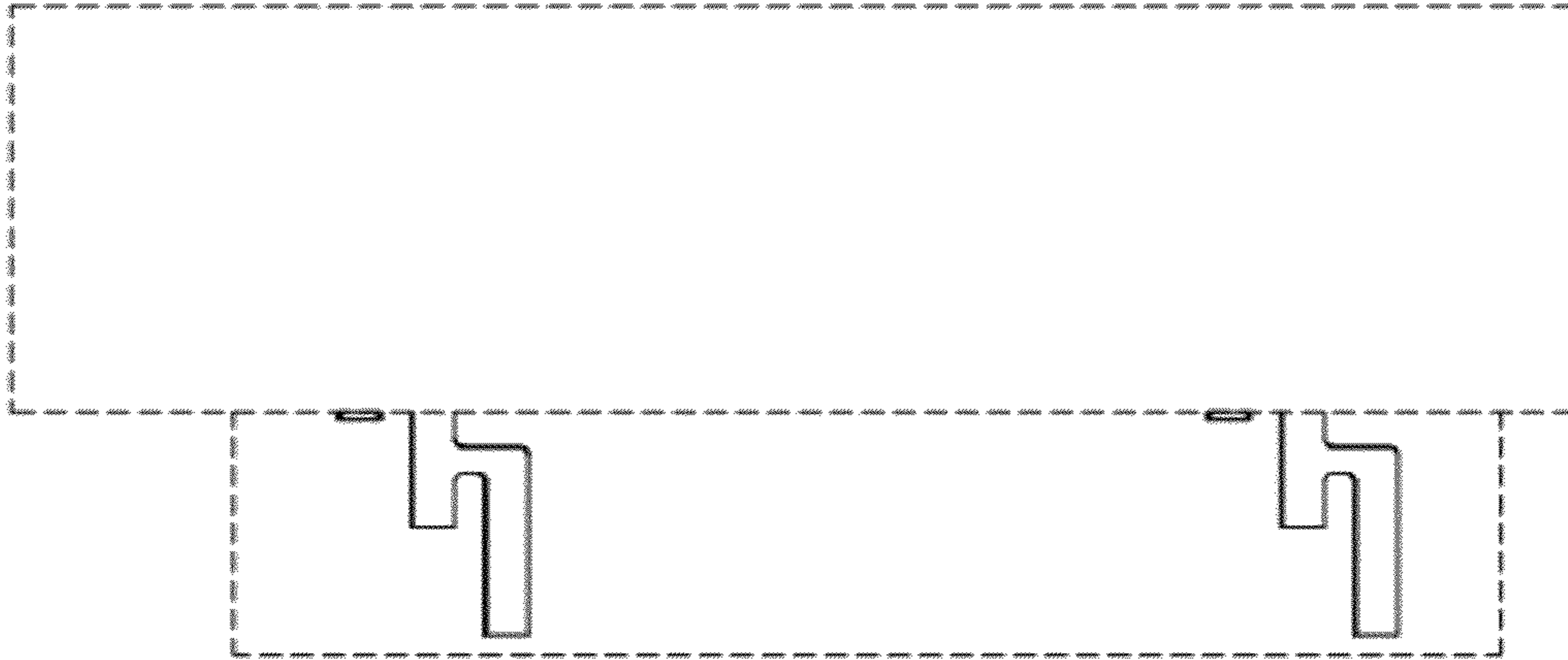

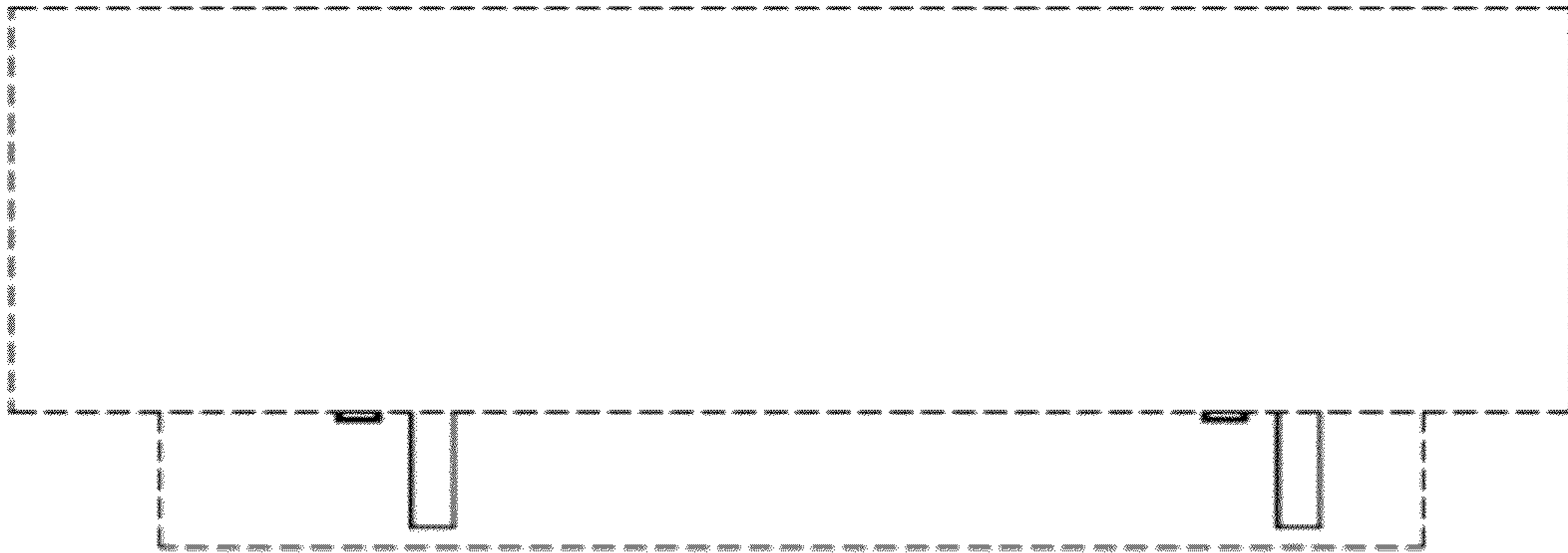

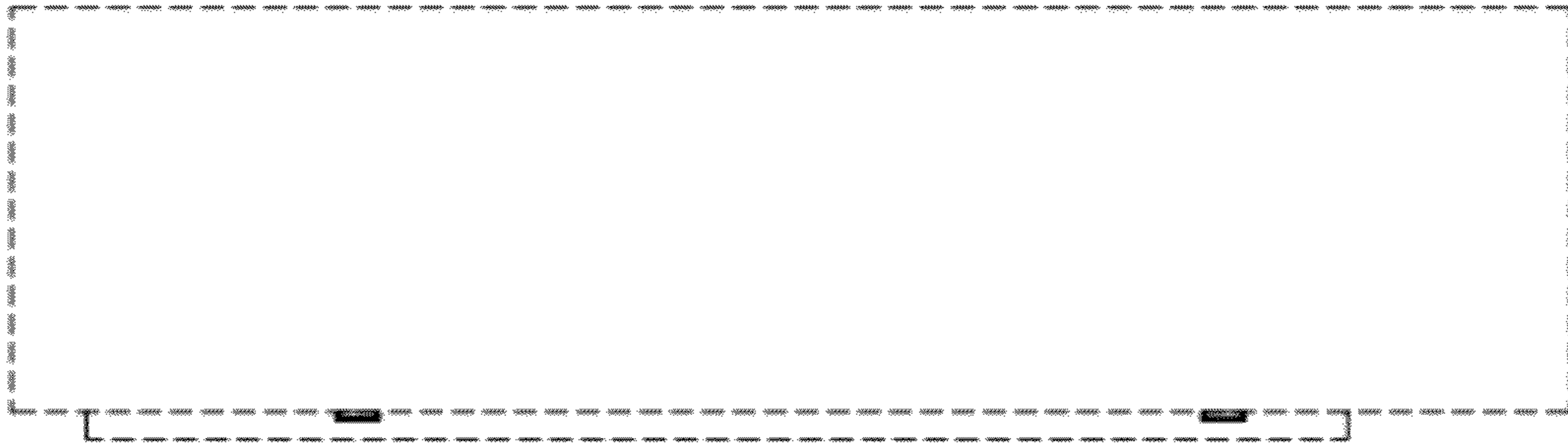
