The ornamental design for a music device, as shown.

DESCRIPTION

FIG. 13 is a top view of the music device of FIG. 9;

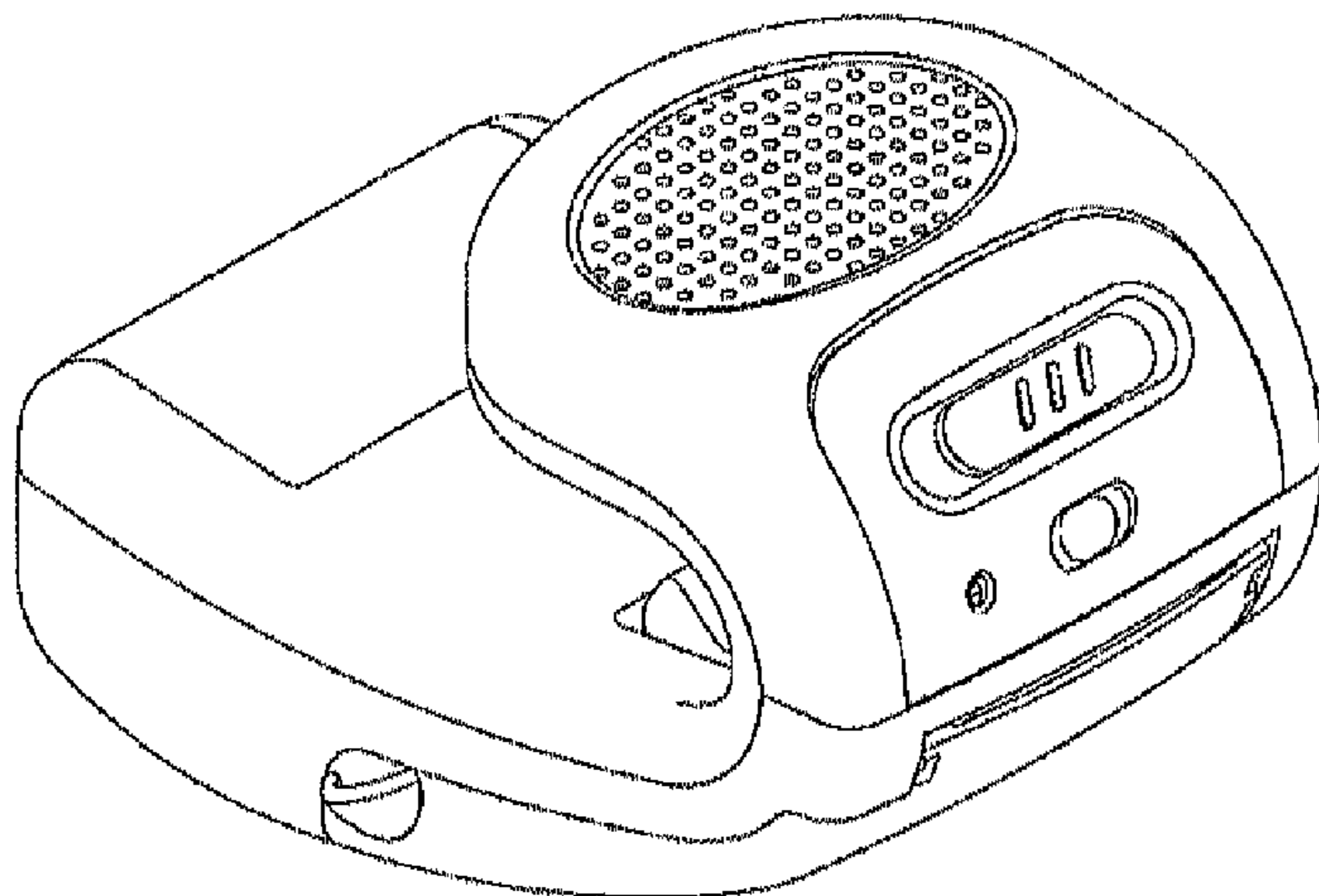
FIG. 14 is a bottom view of the music device of FIG. 9;

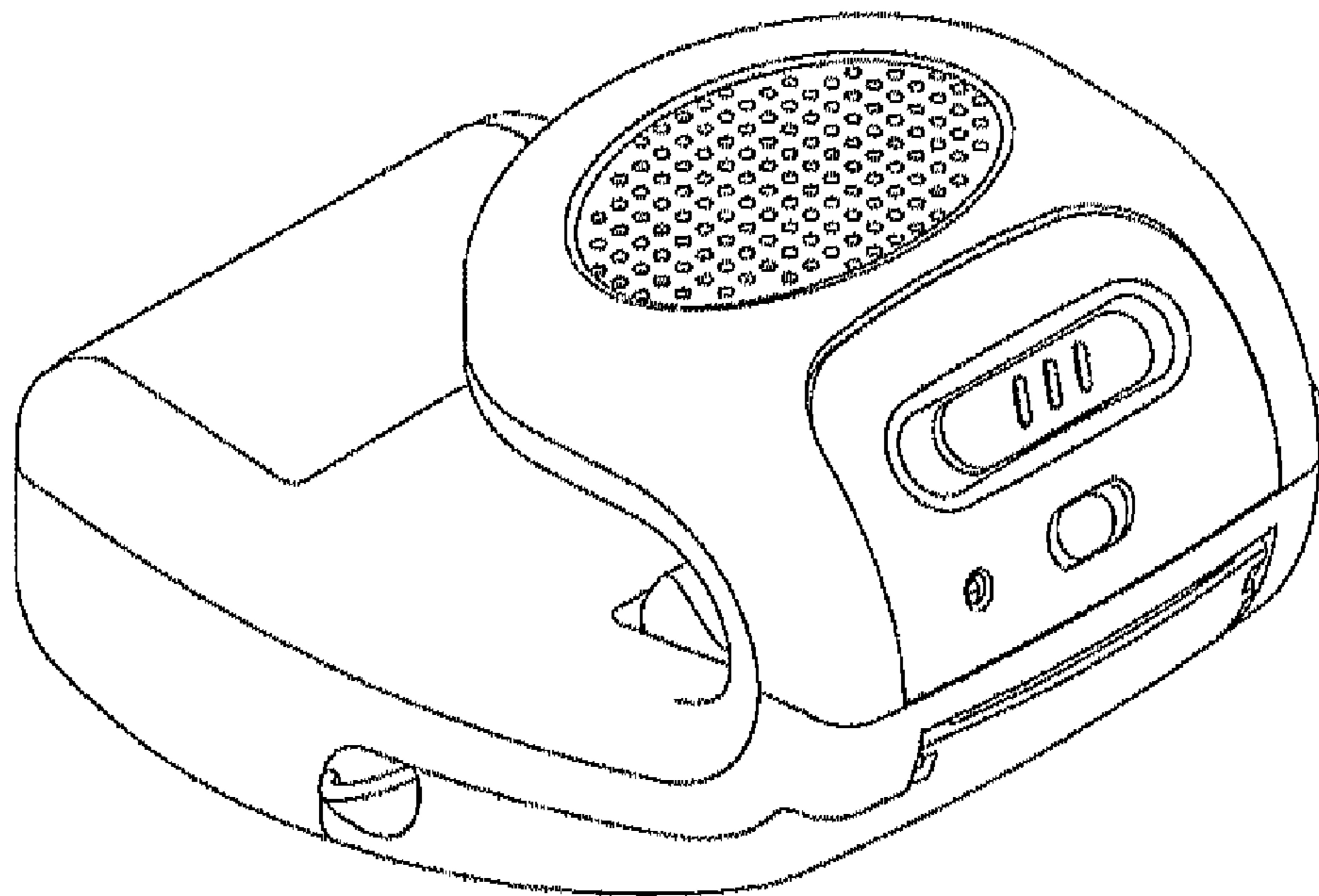

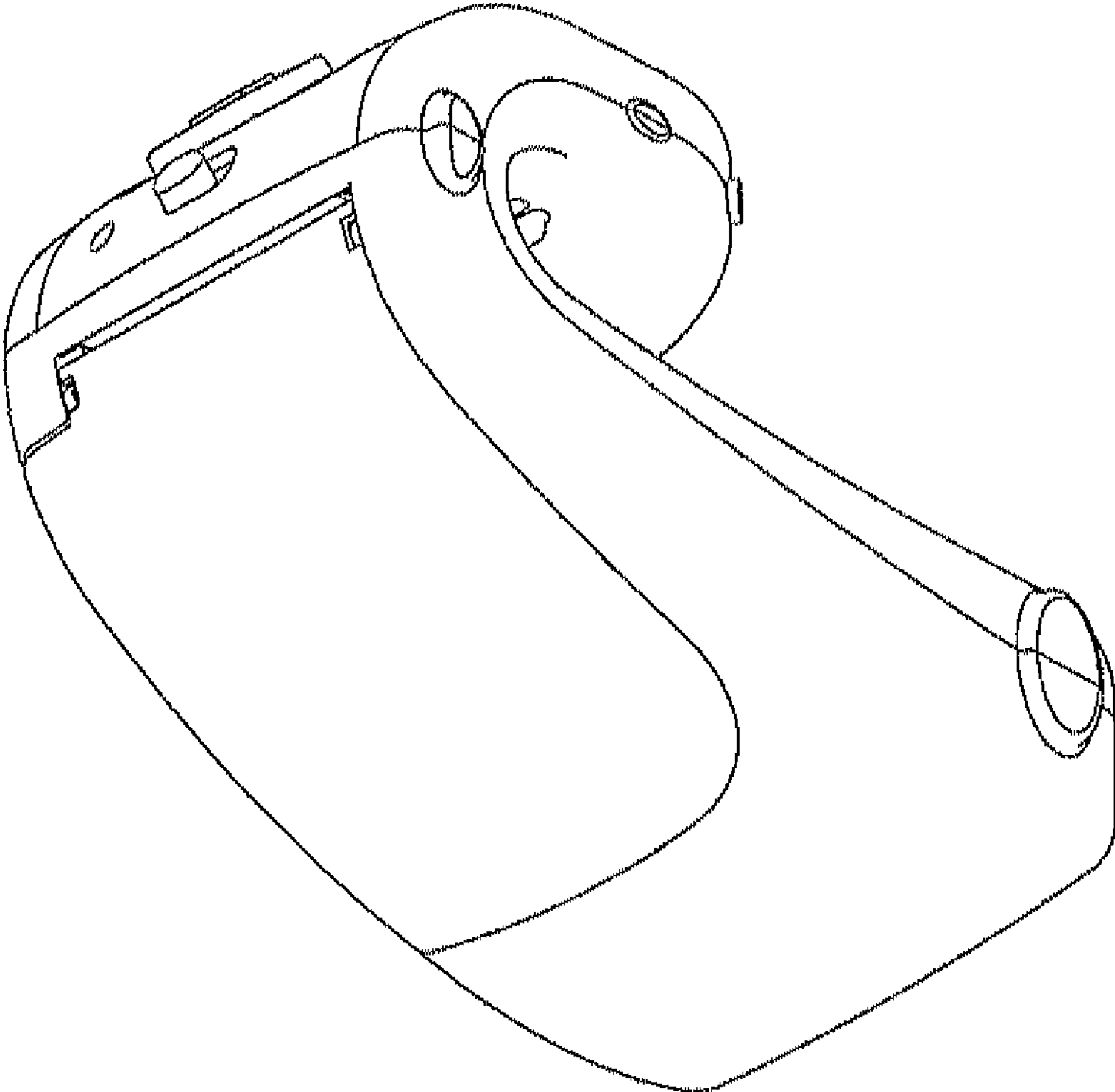

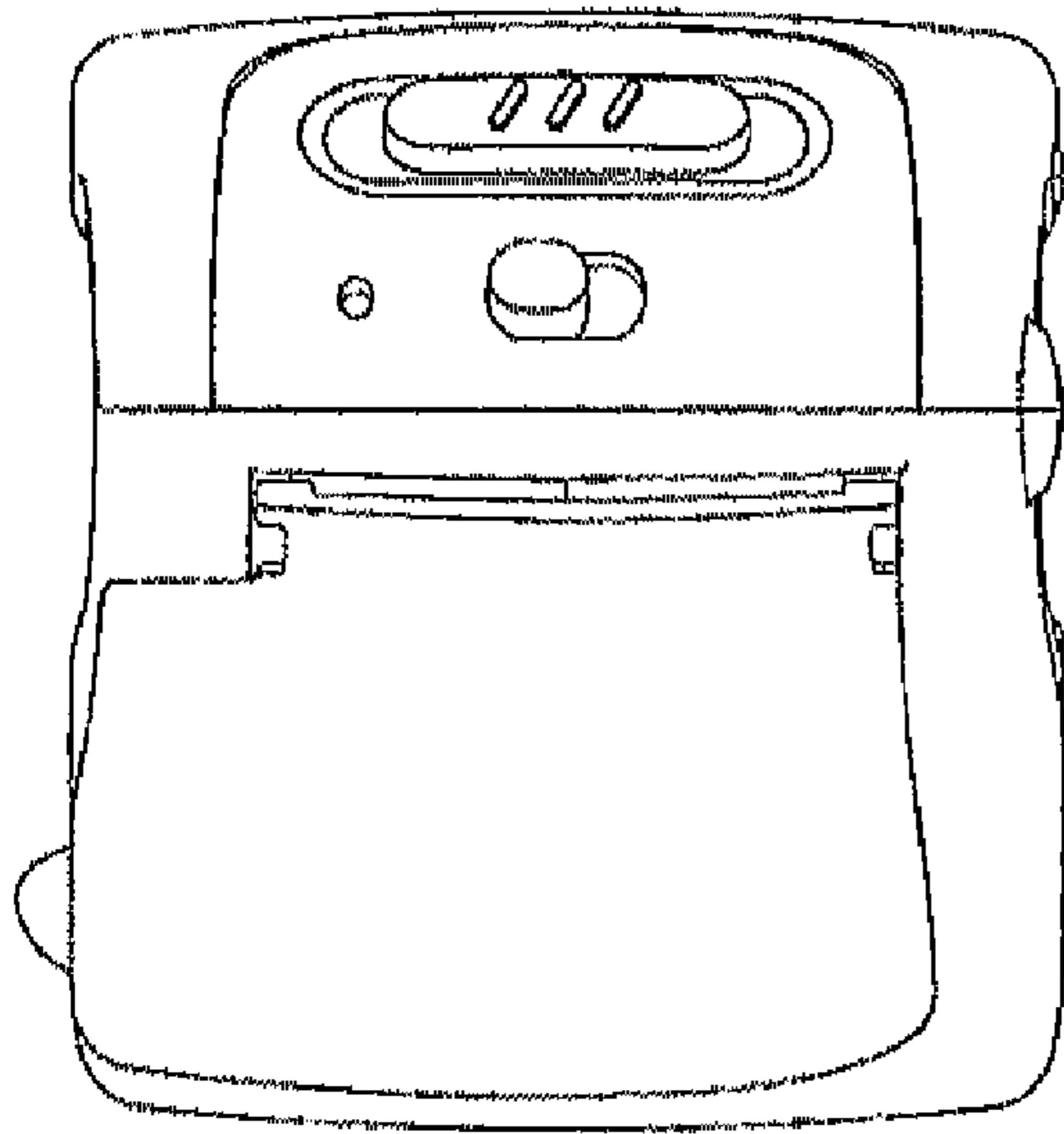

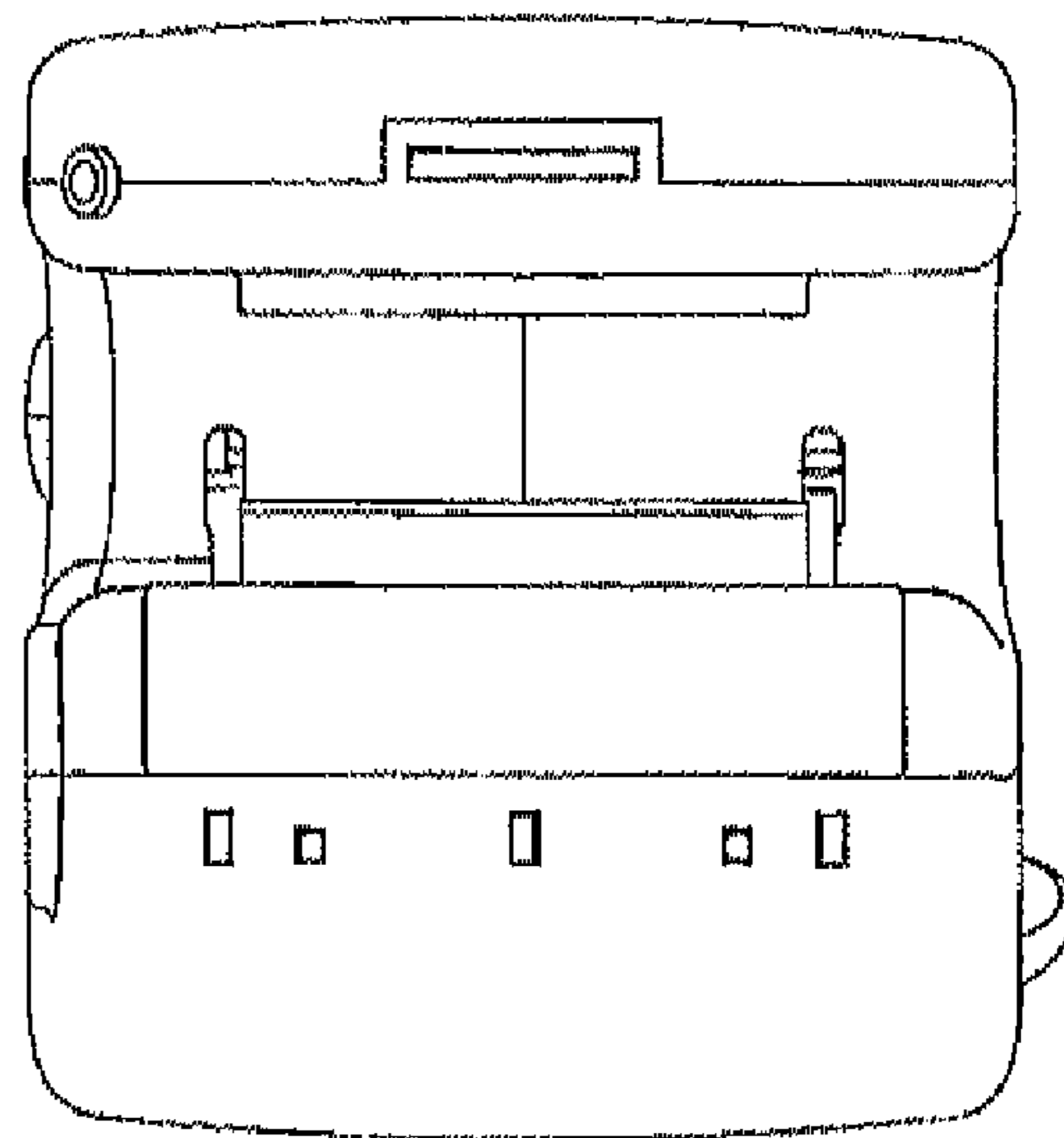

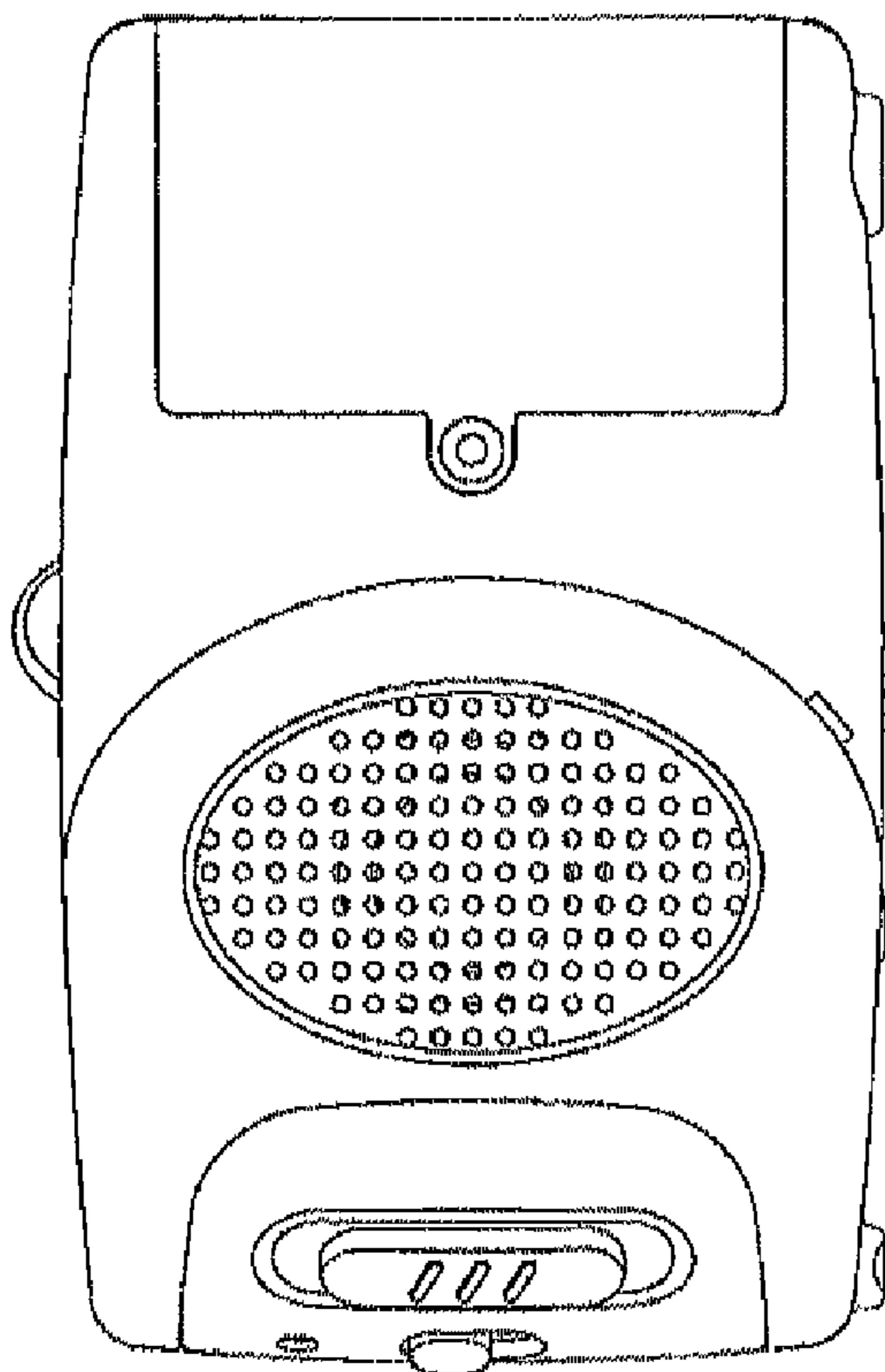

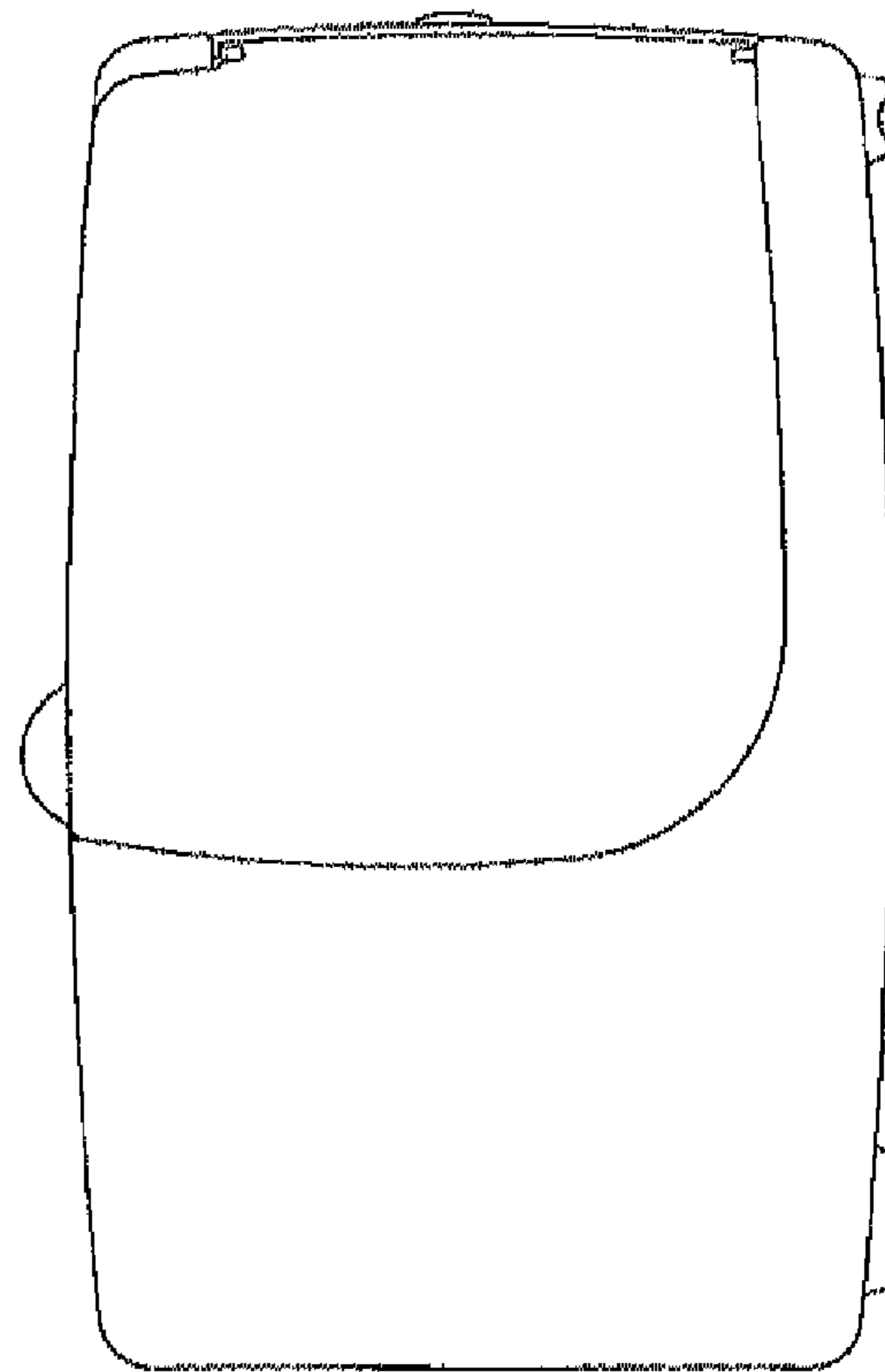

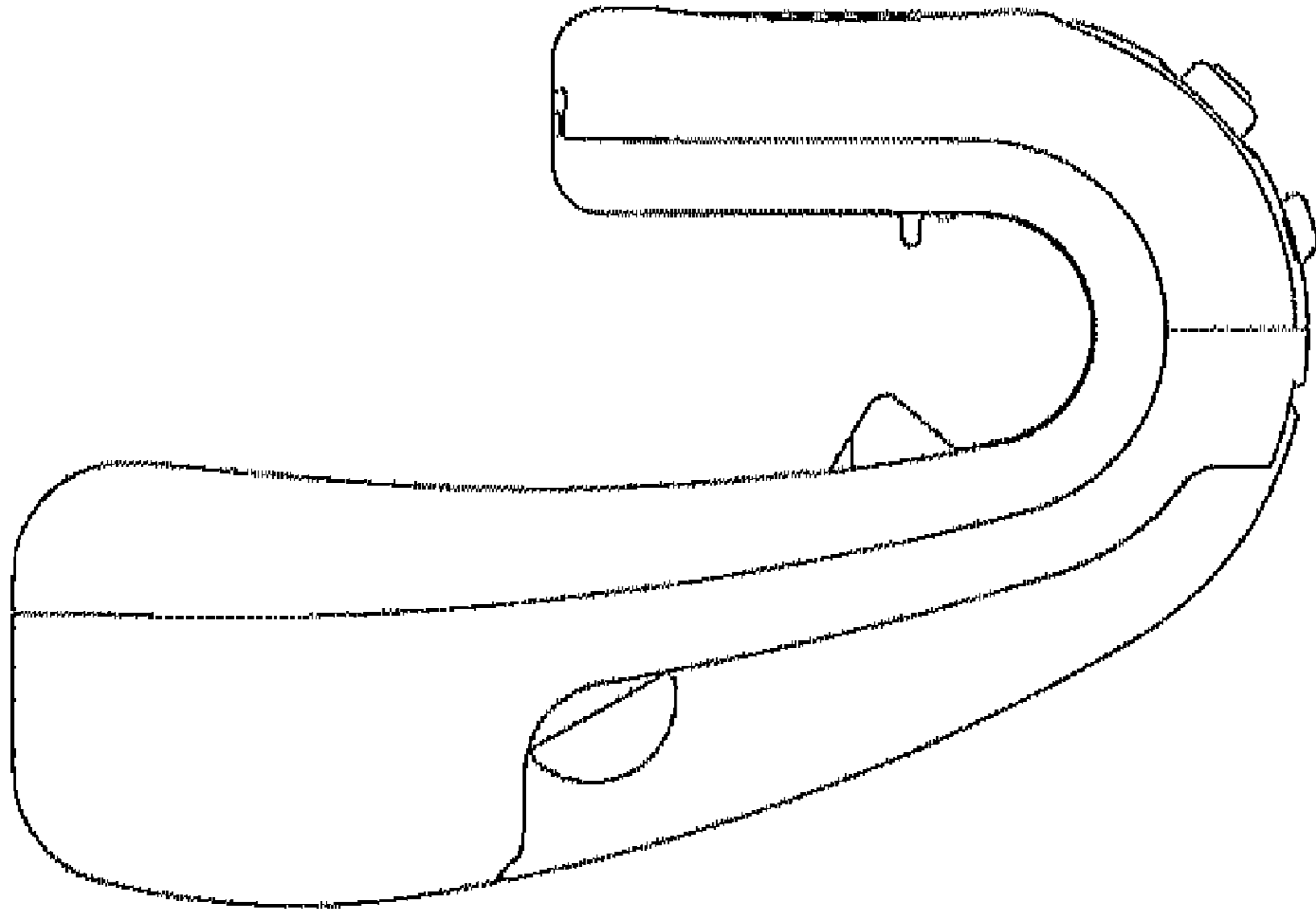

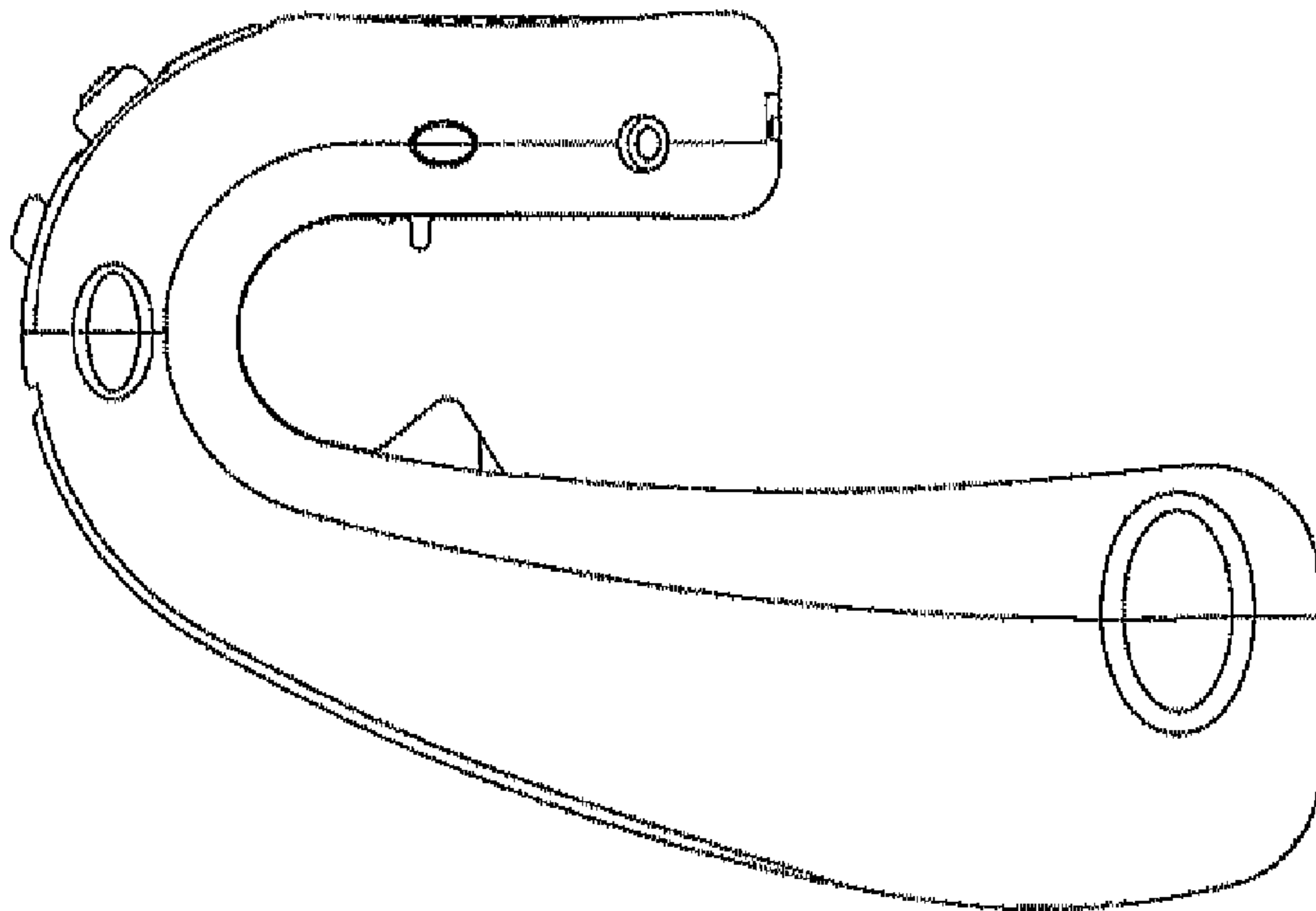

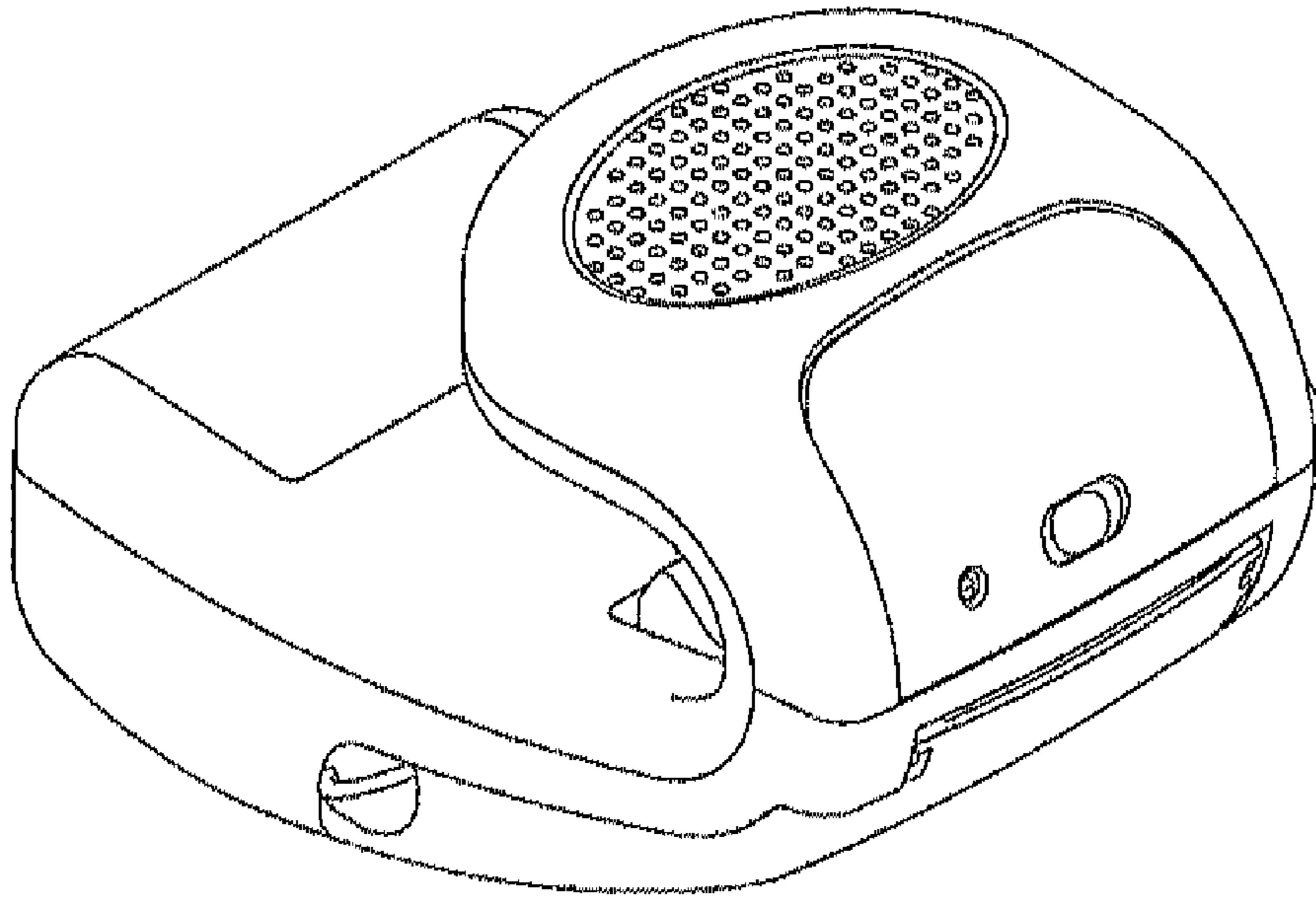

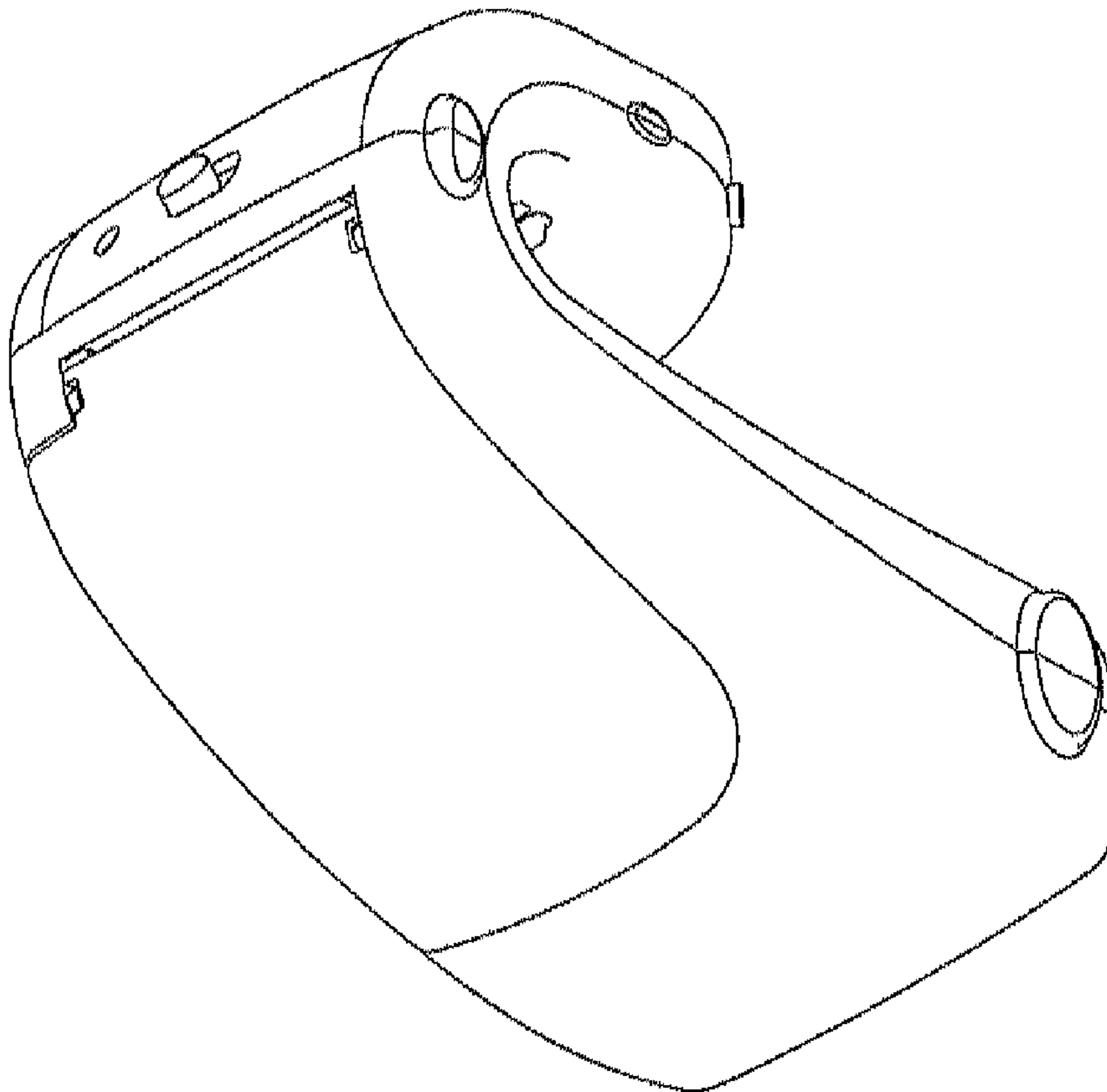

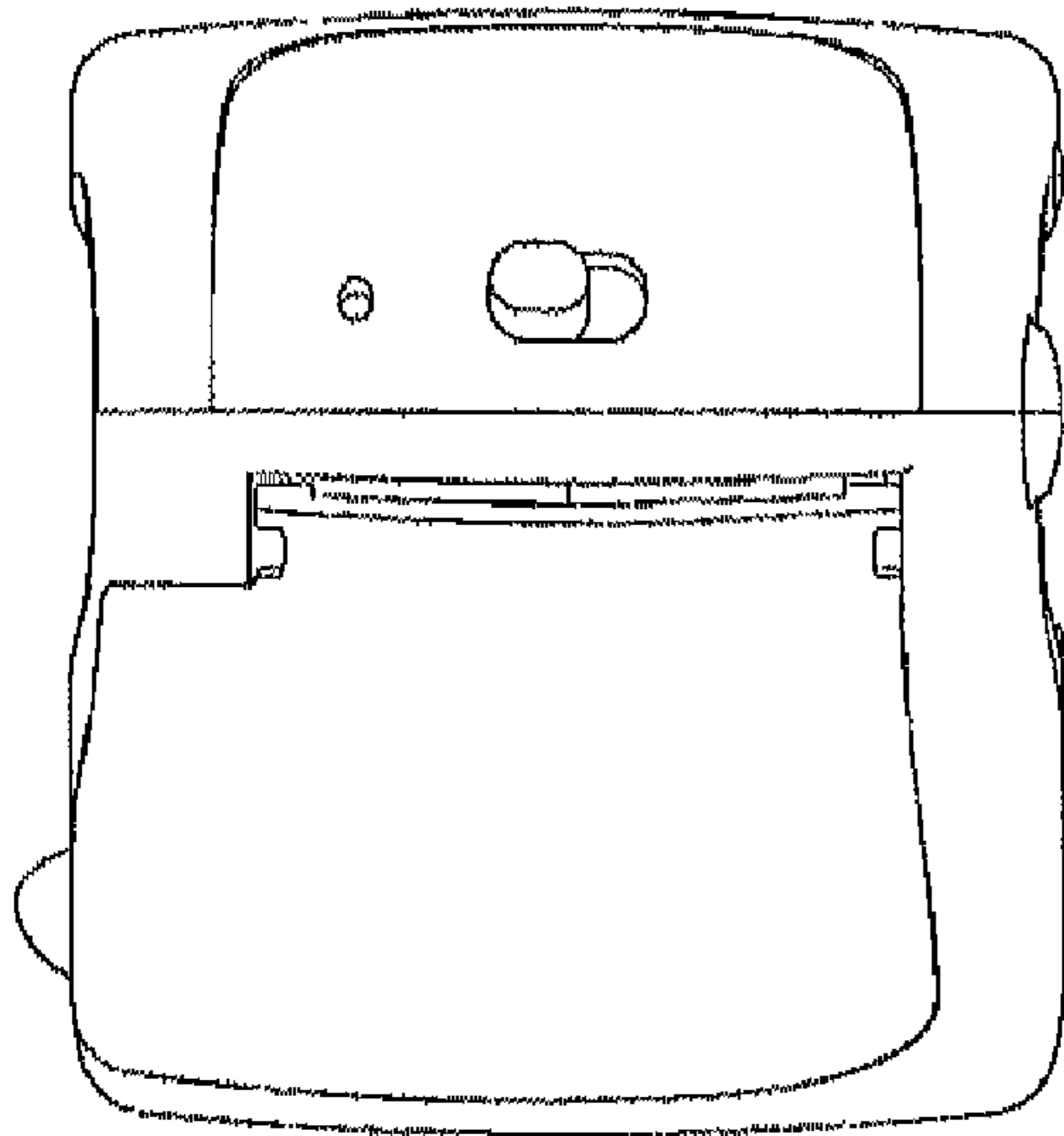

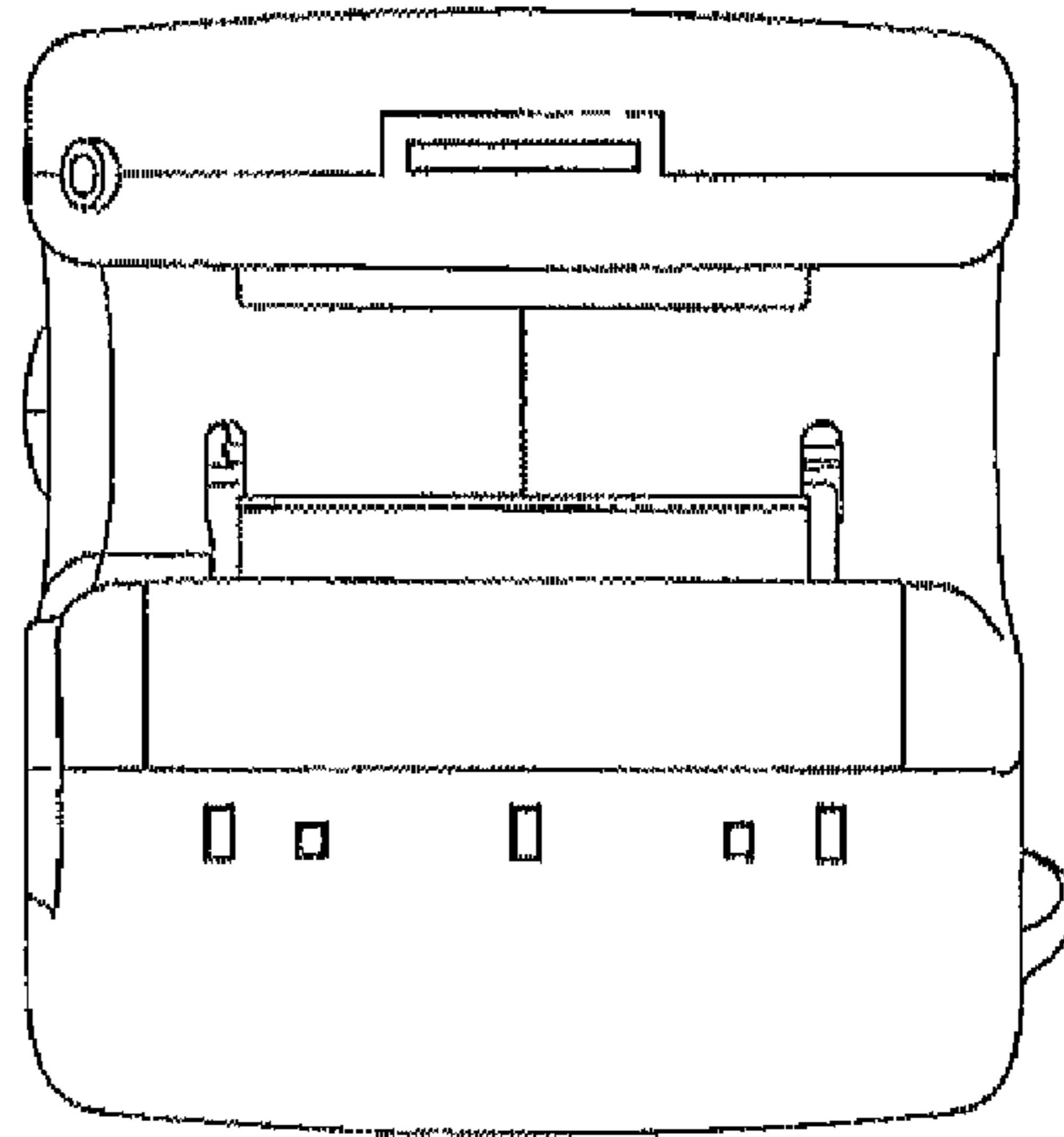

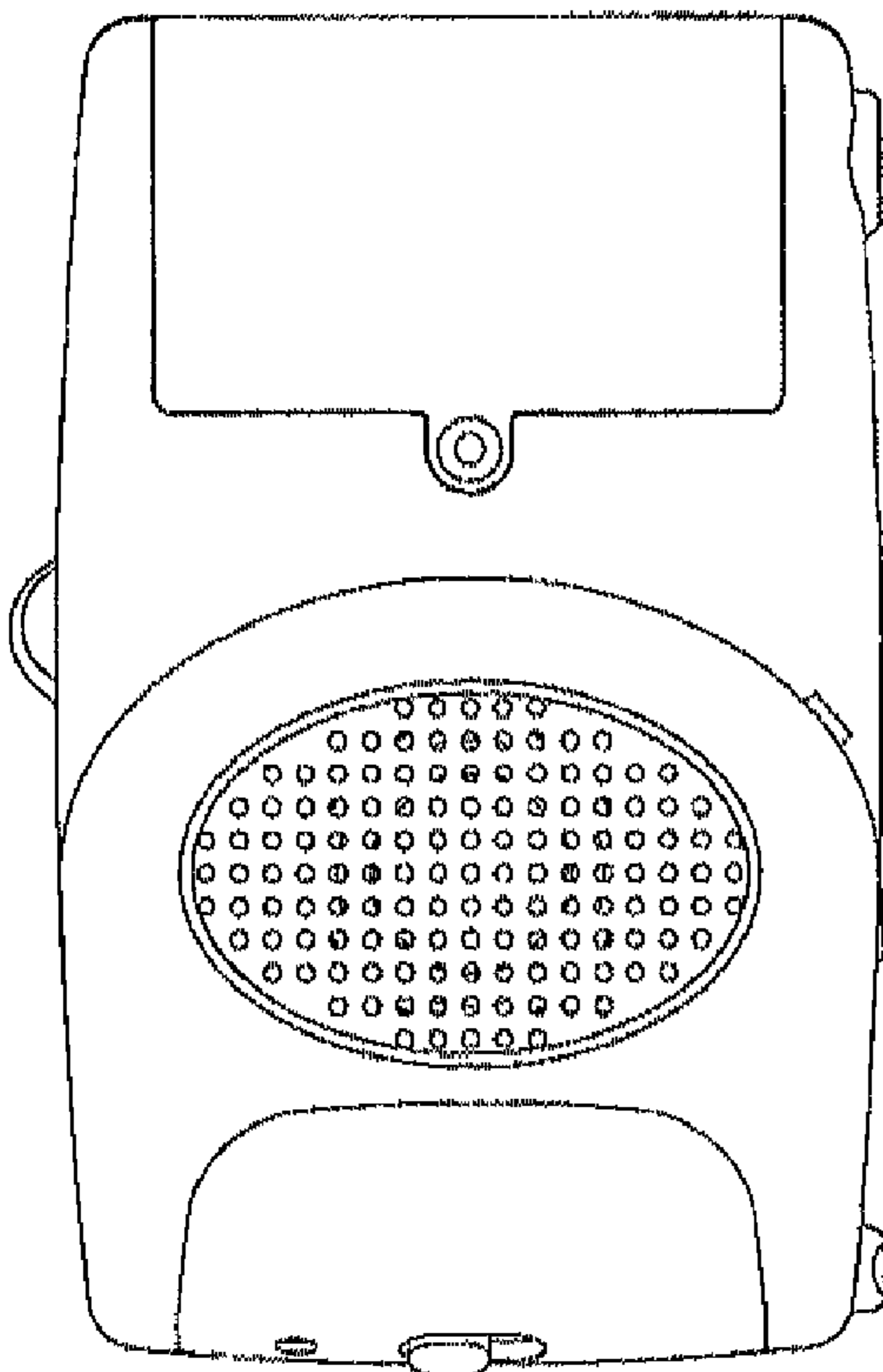

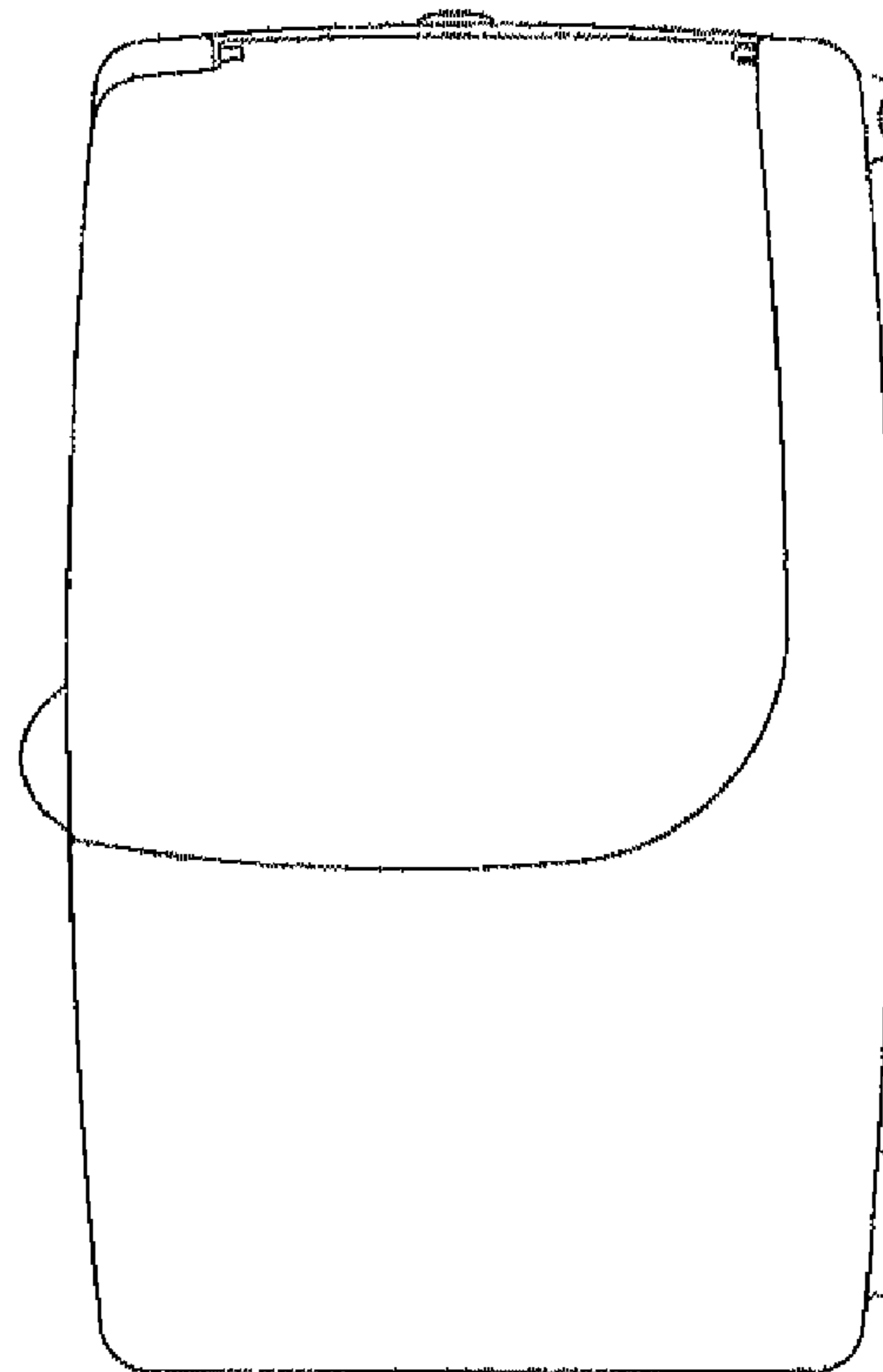

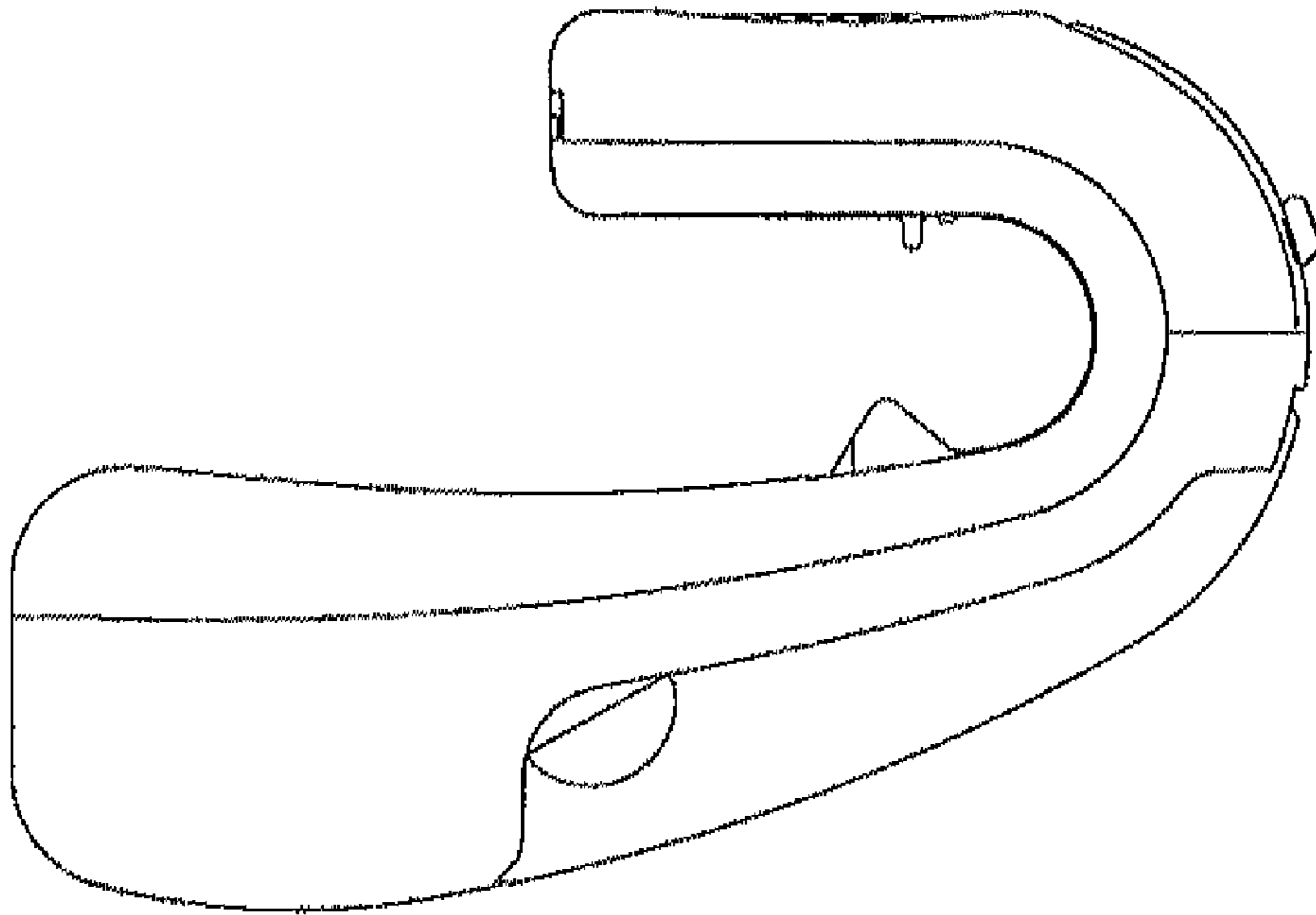

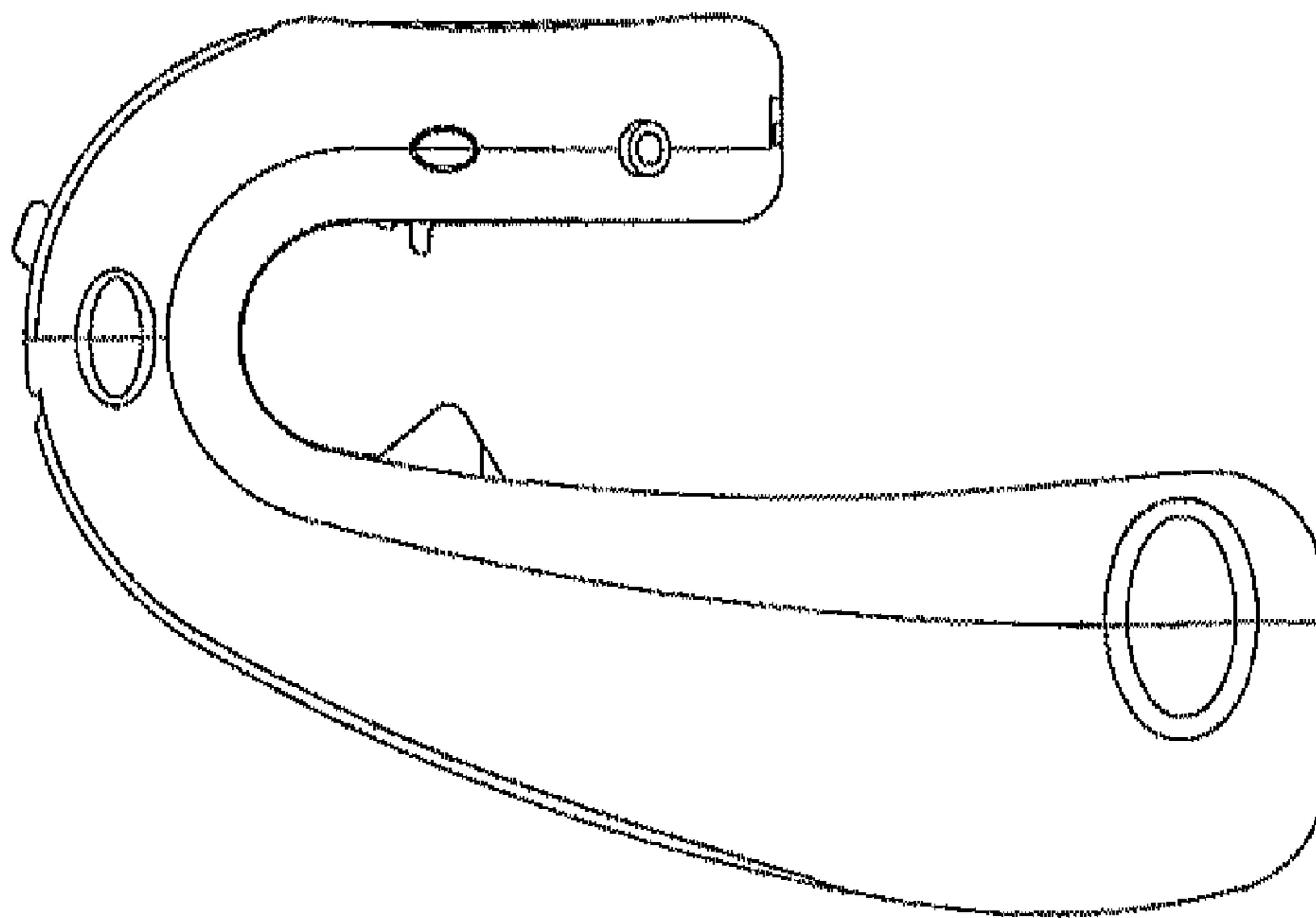
