(57) **CLAIM**

The ornamental design for a power steering motor for vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a power steering motor for vehicle, showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a reference perspective view with a connector 01 installed; FIG. 9 is a reference perspective view with a connector 02 installed; FIG. 10 is a reference perspective view with a connector 03 installed; FIG. 11 is a reference perspective view with a connector 04 installed; FIG. 12 is a reference view with change connection part 01; and, FIG. 13 is a reference view with change connection part 02. The broken lines are for illustrating environmental structure only and form no part of the claimed design.

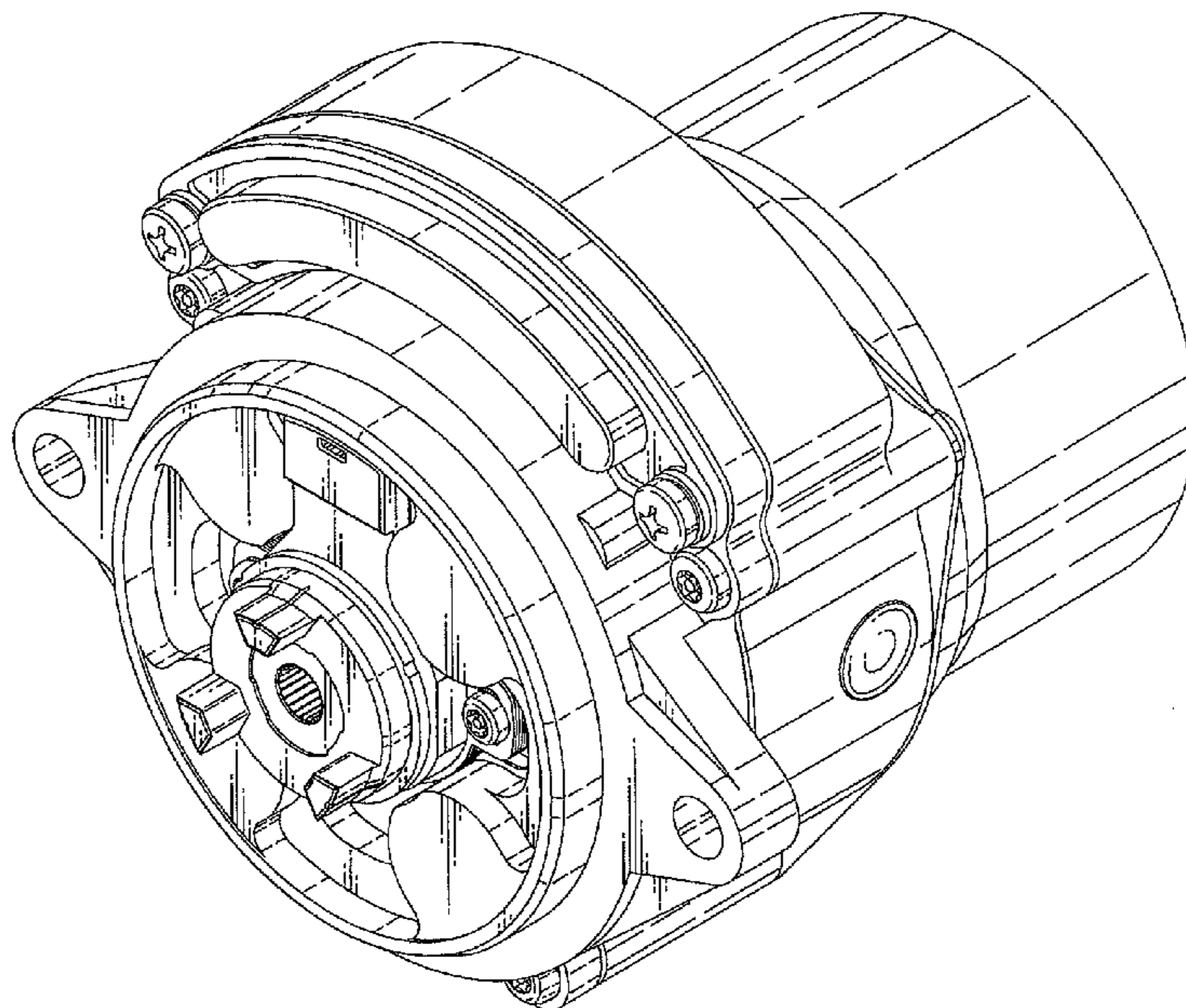

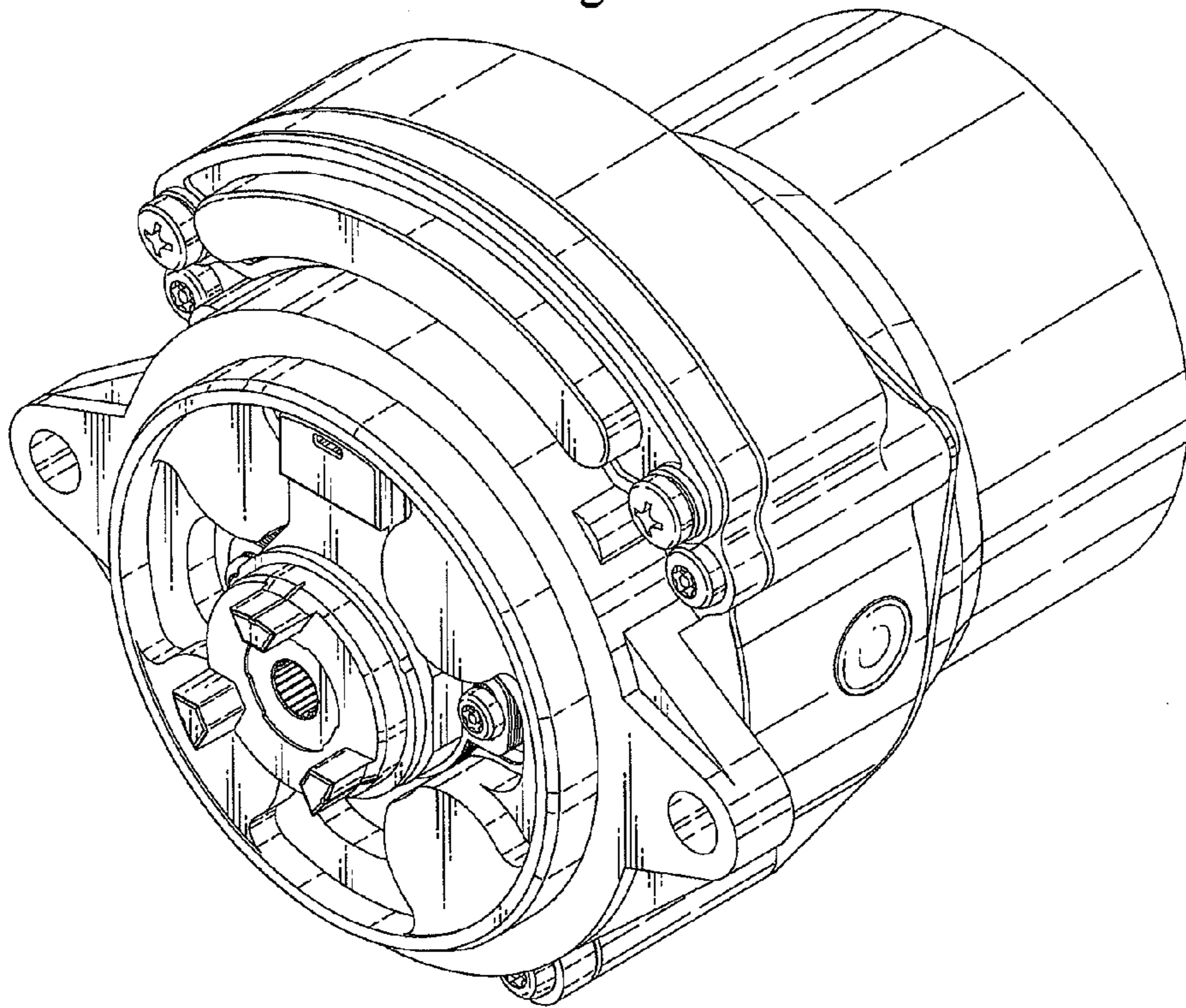
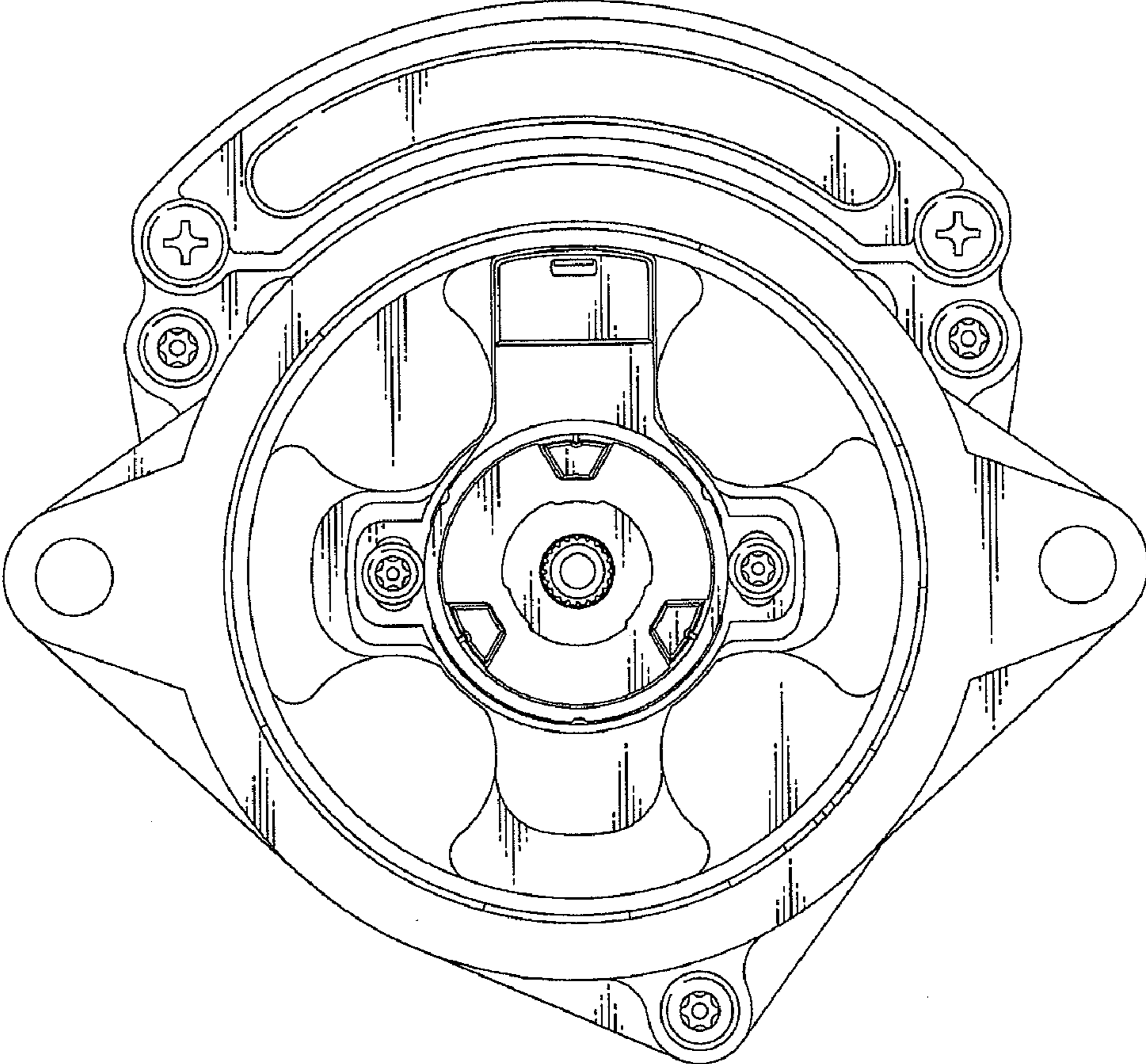

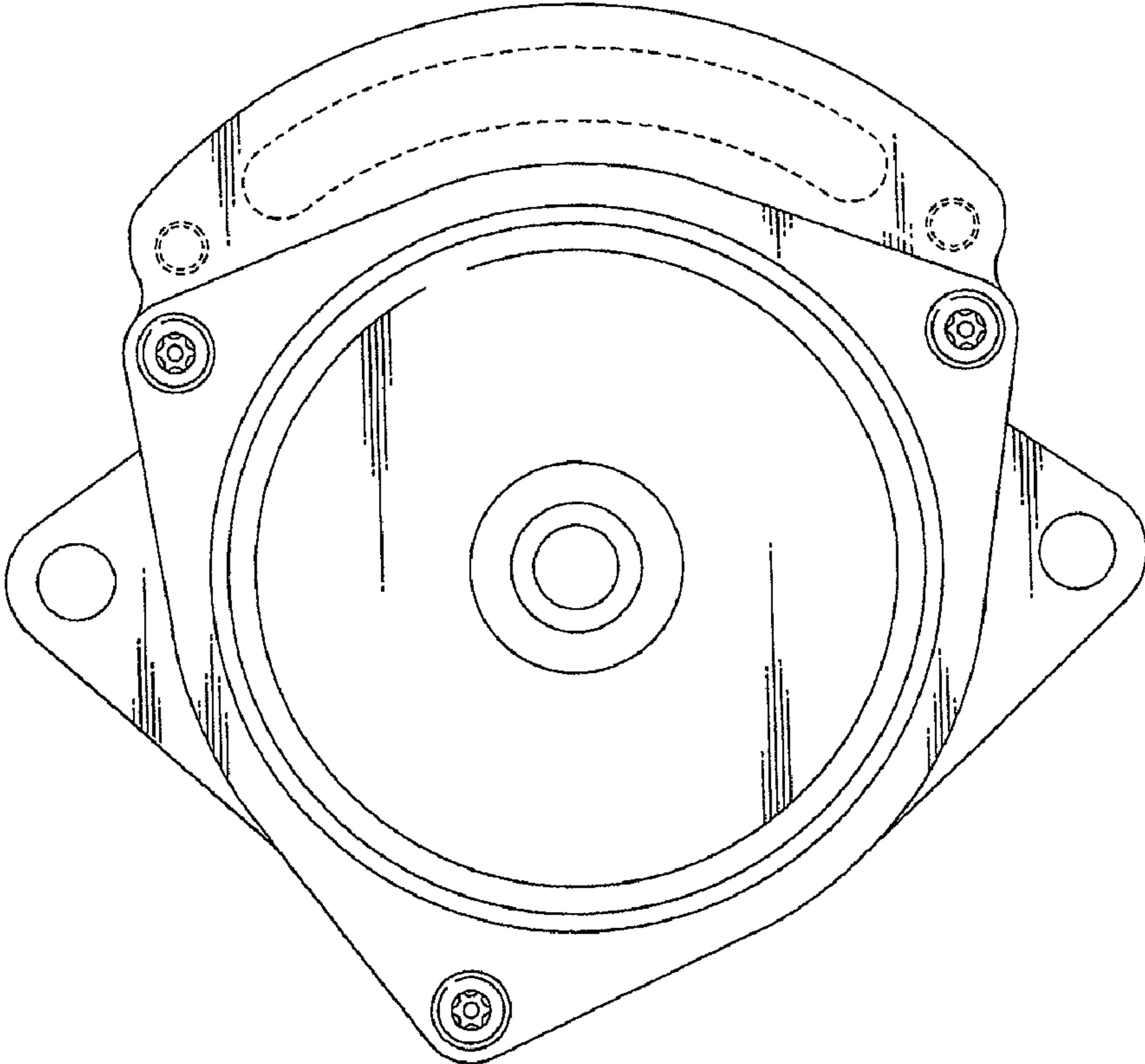

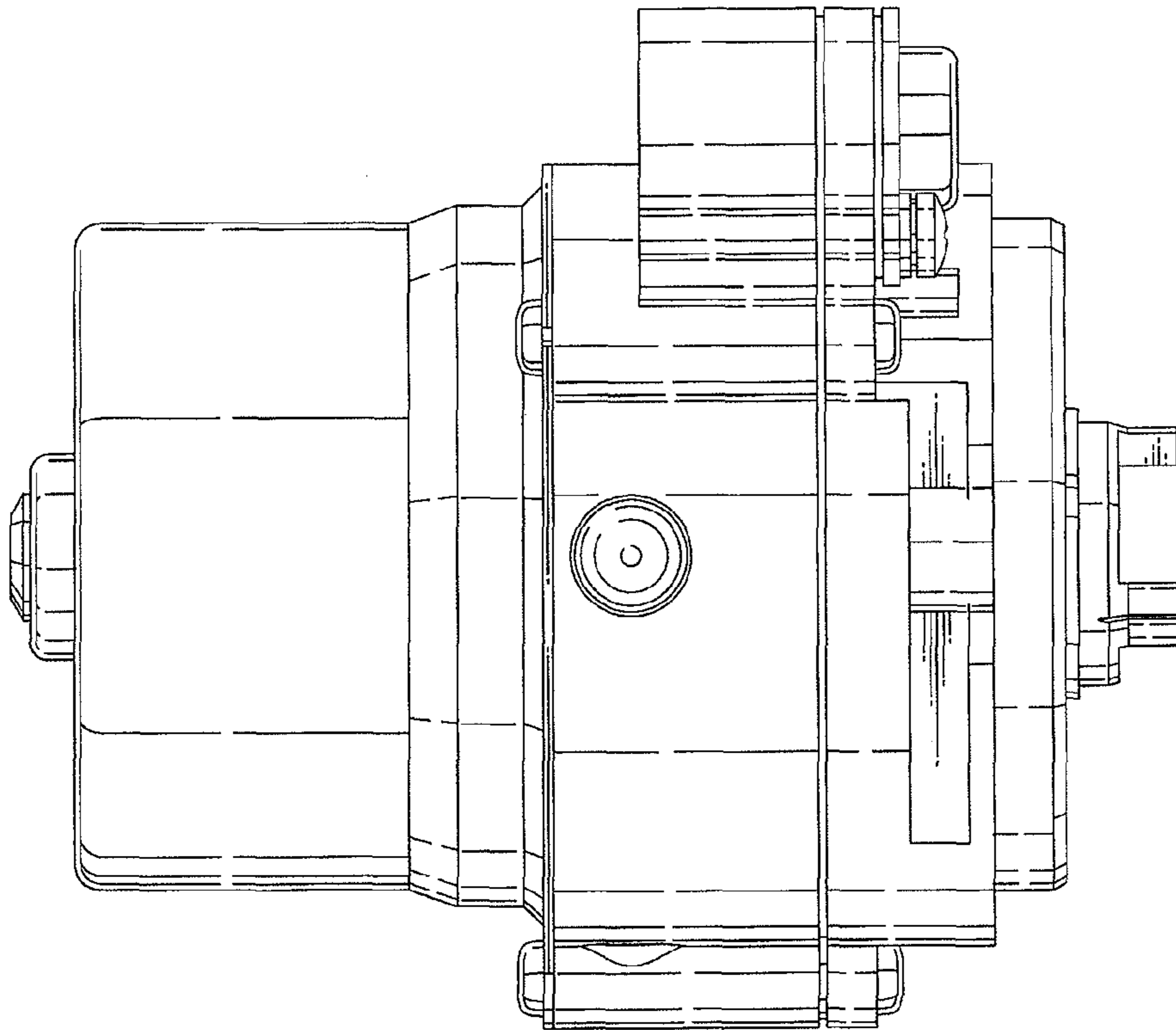

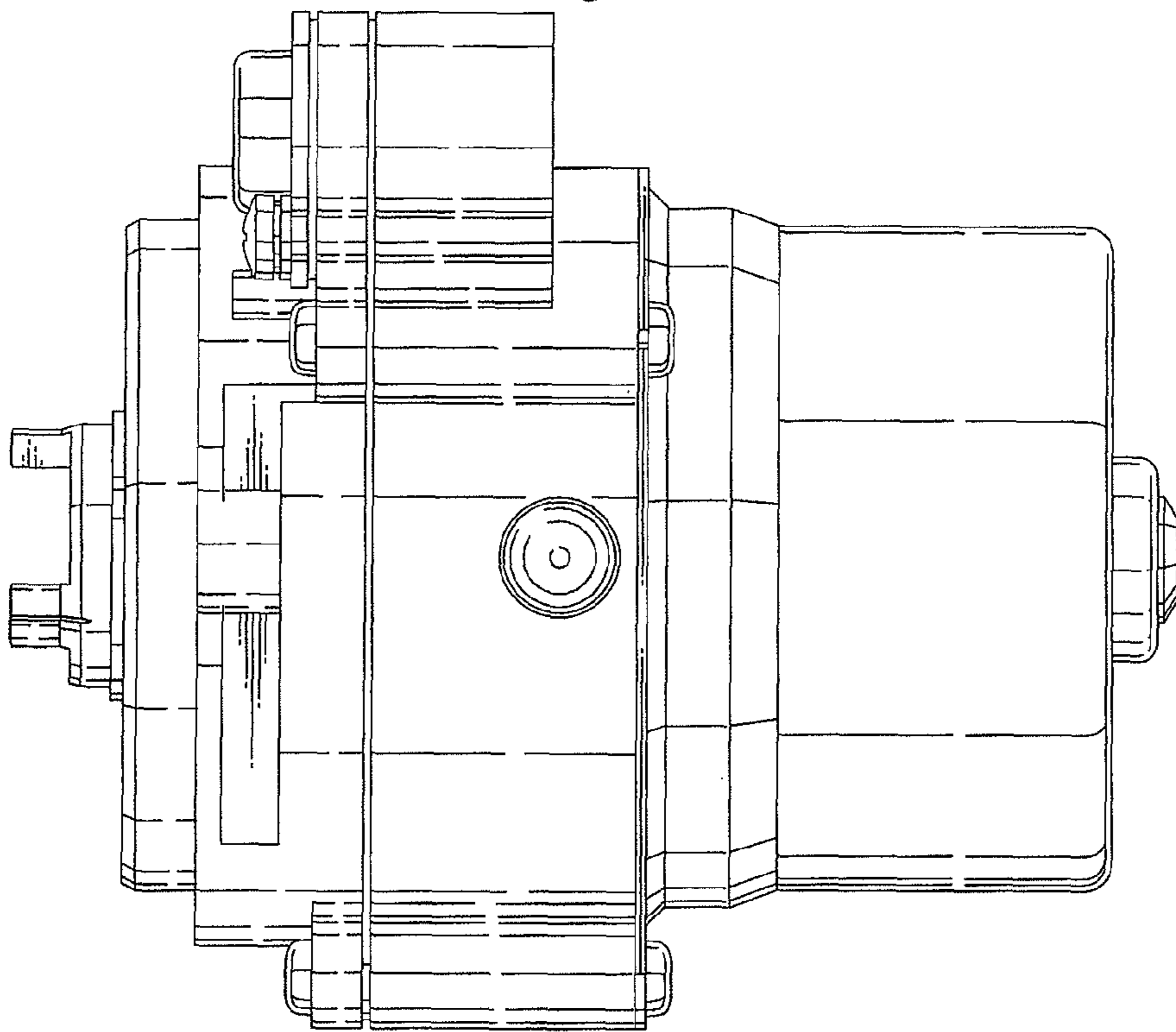

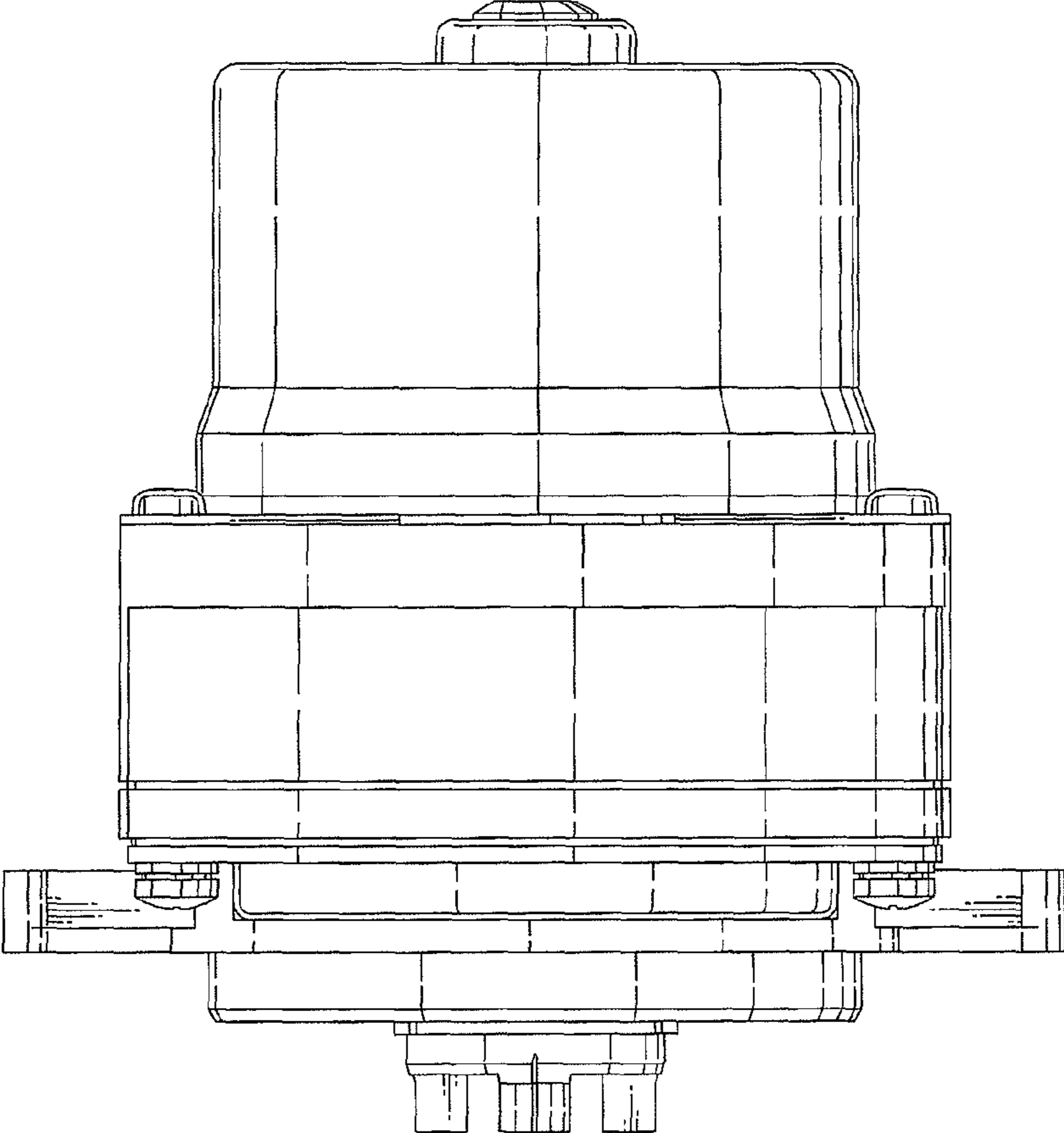
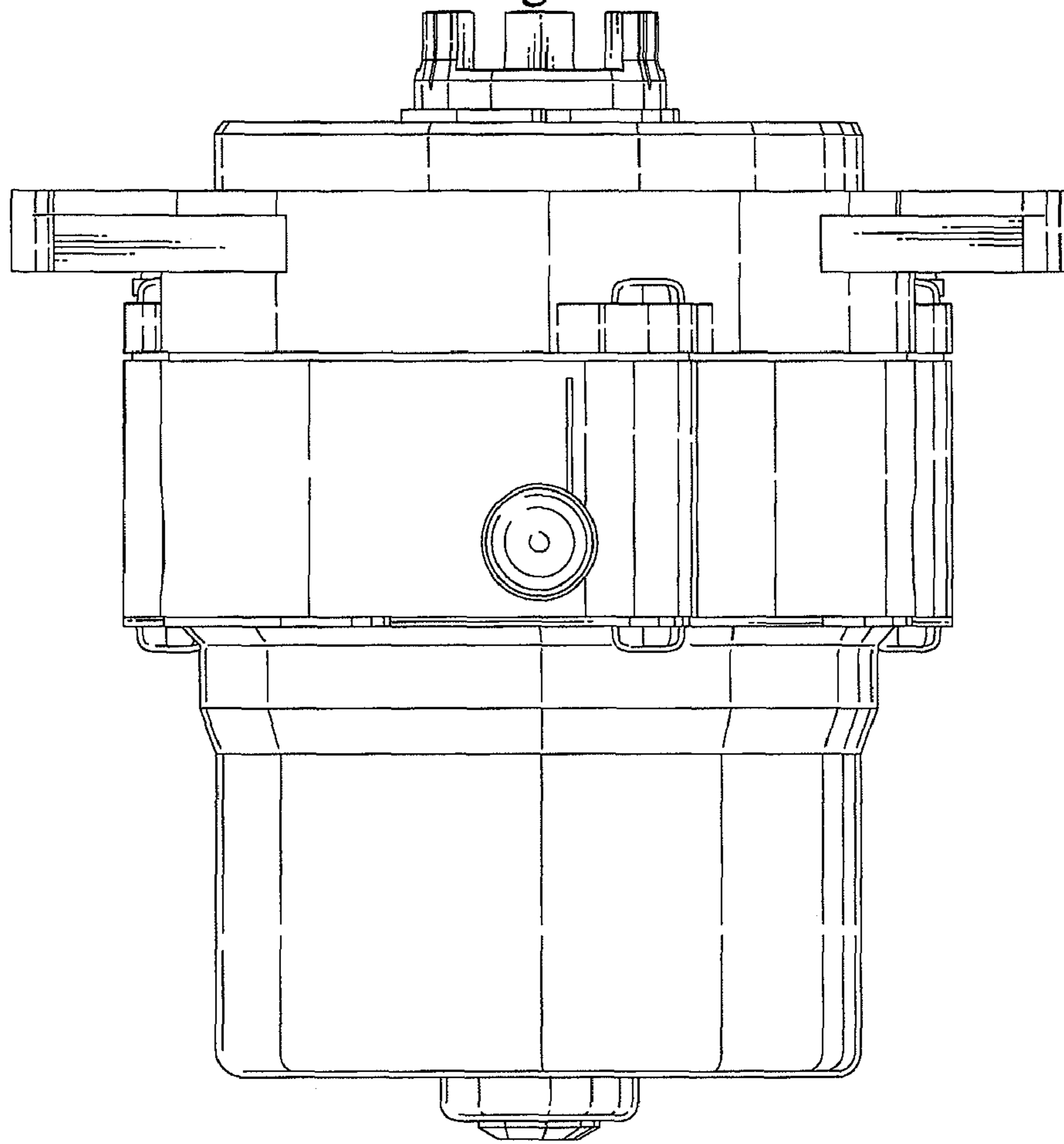

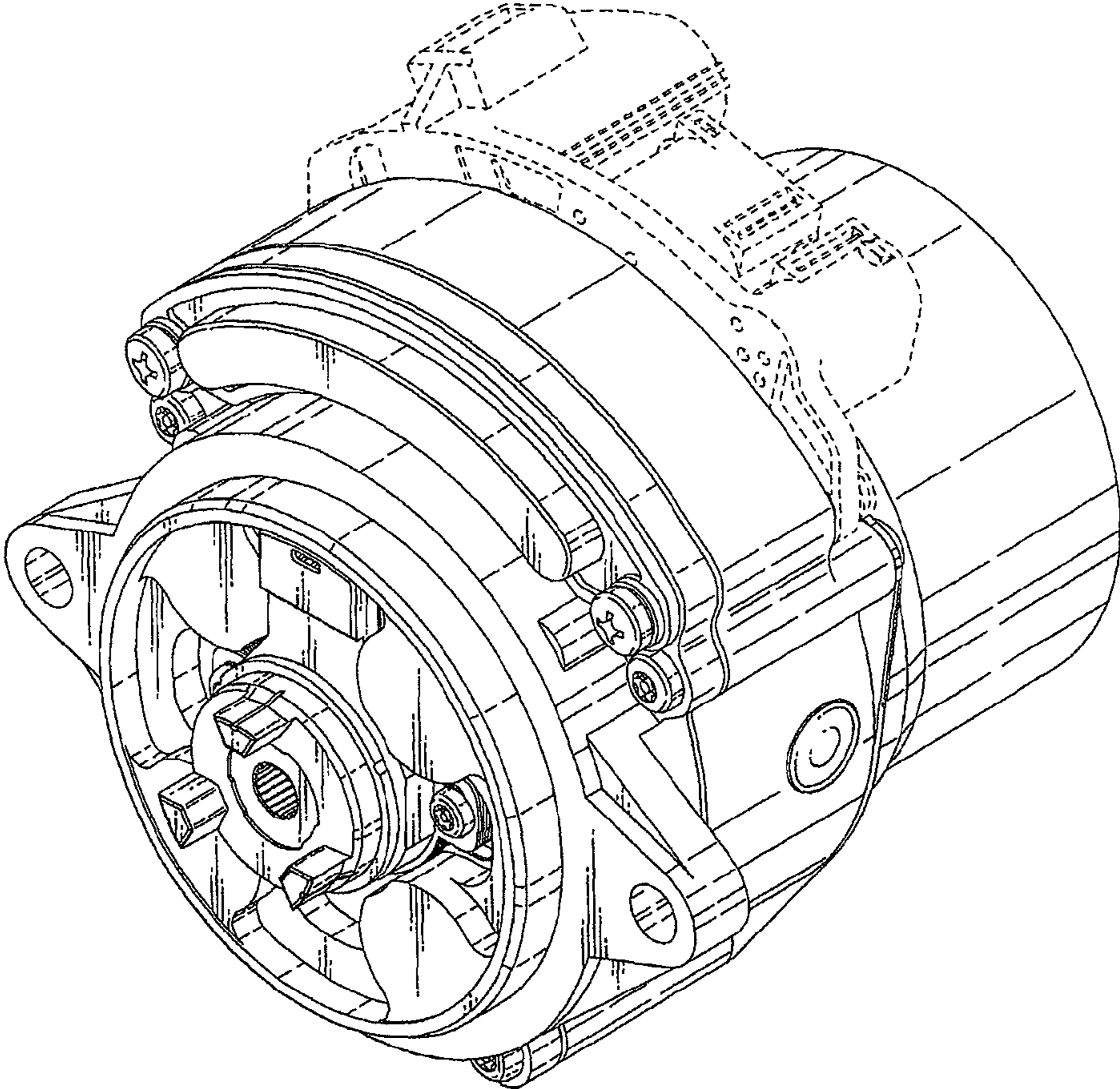

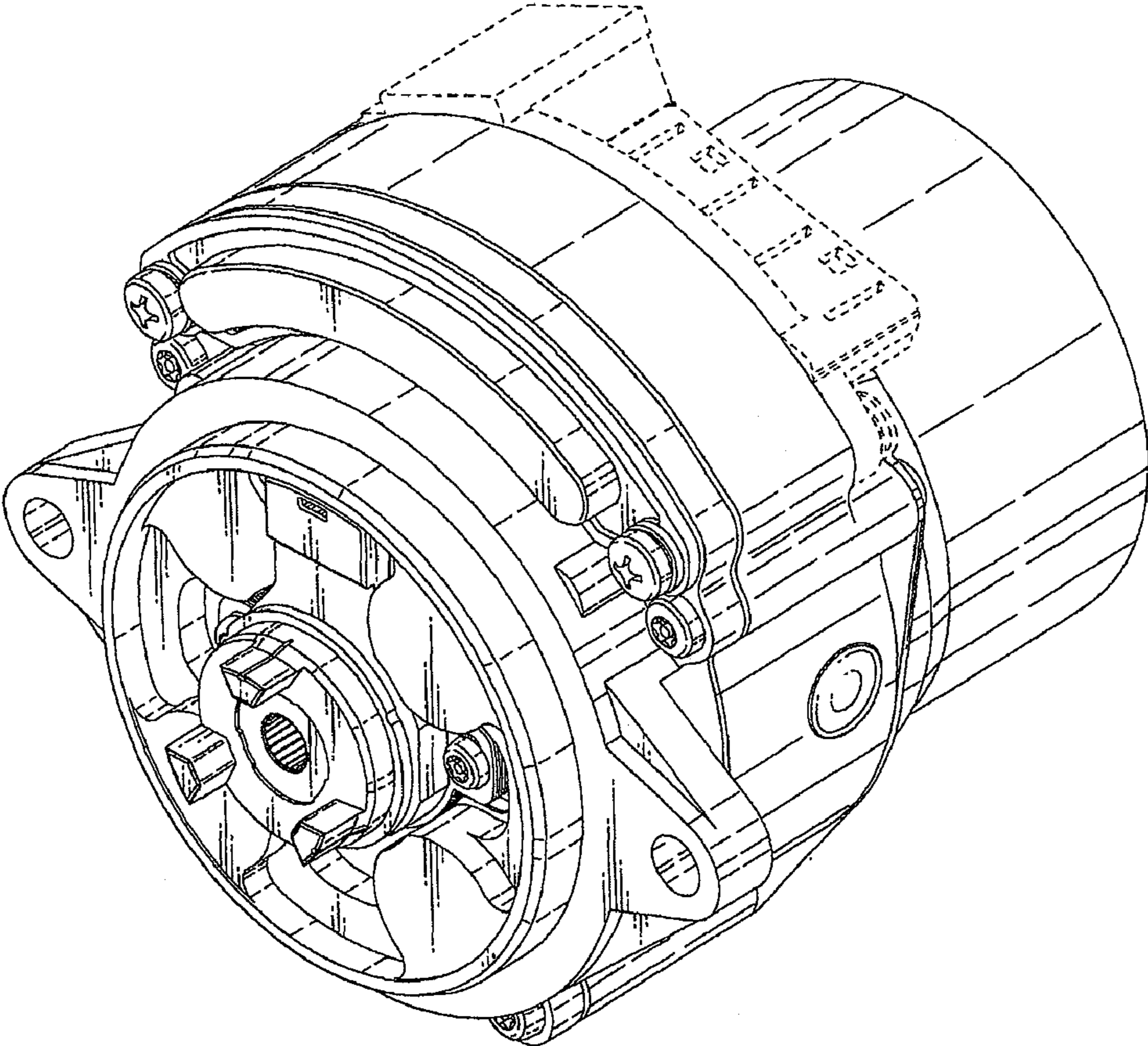

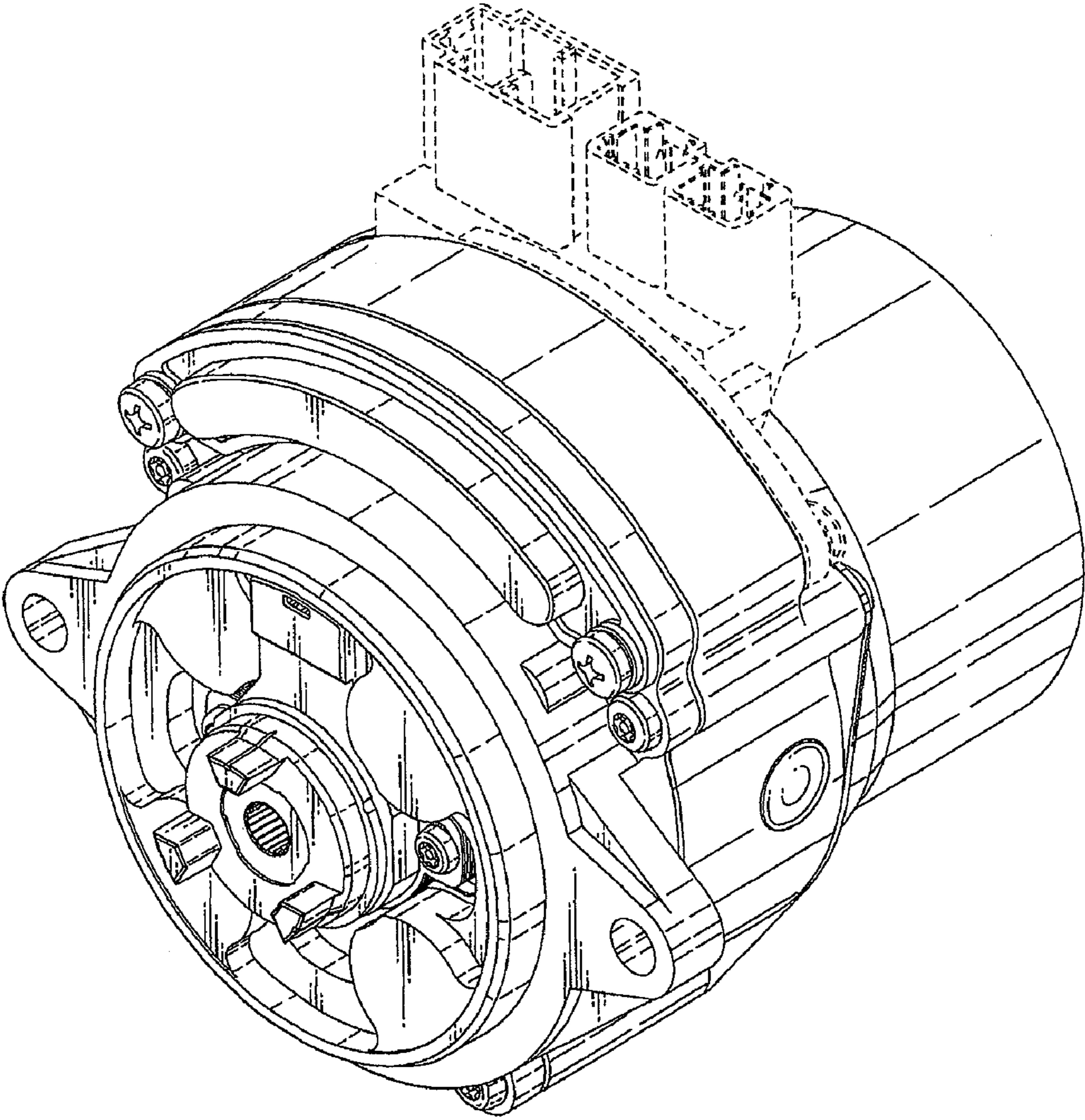

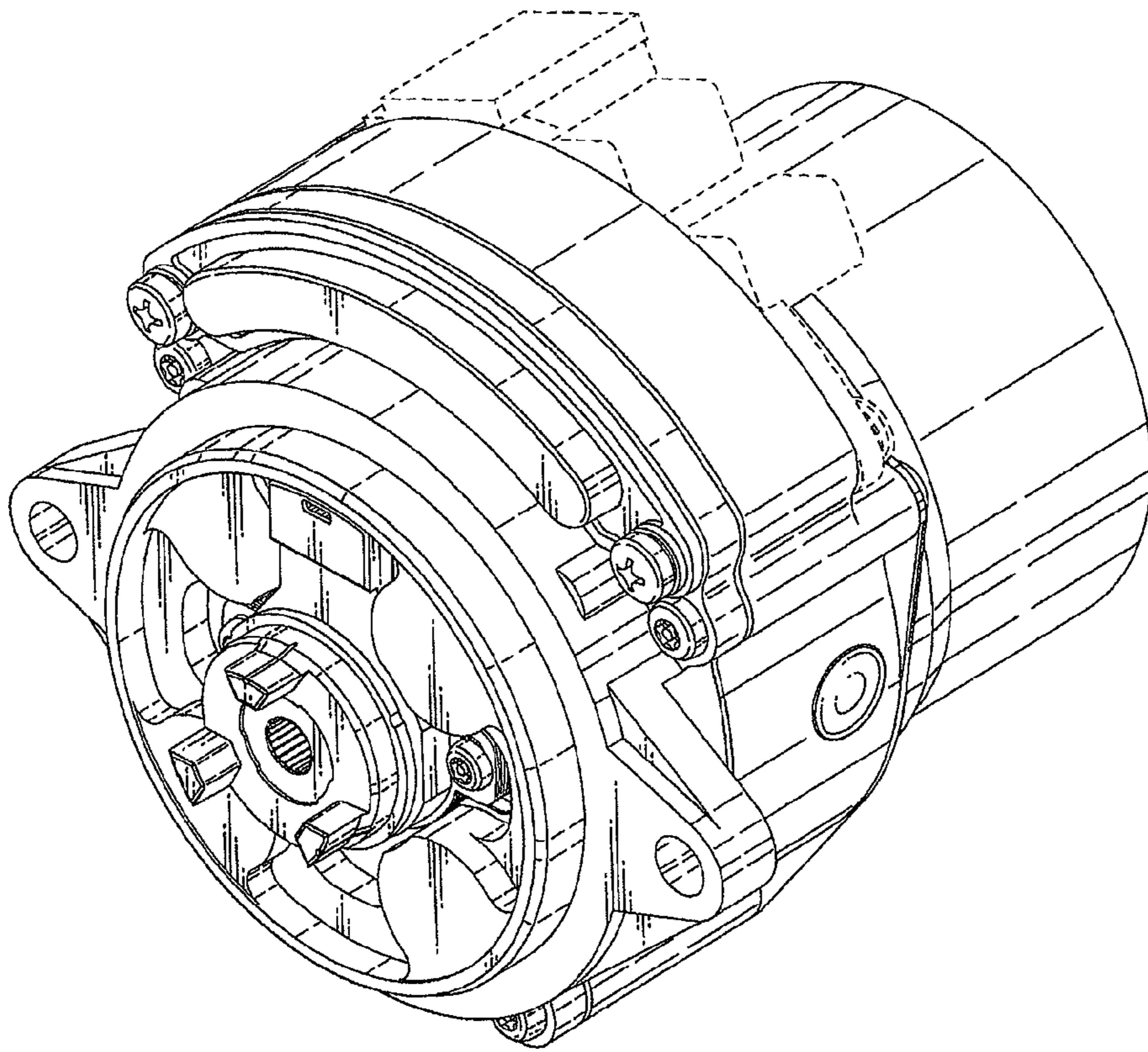

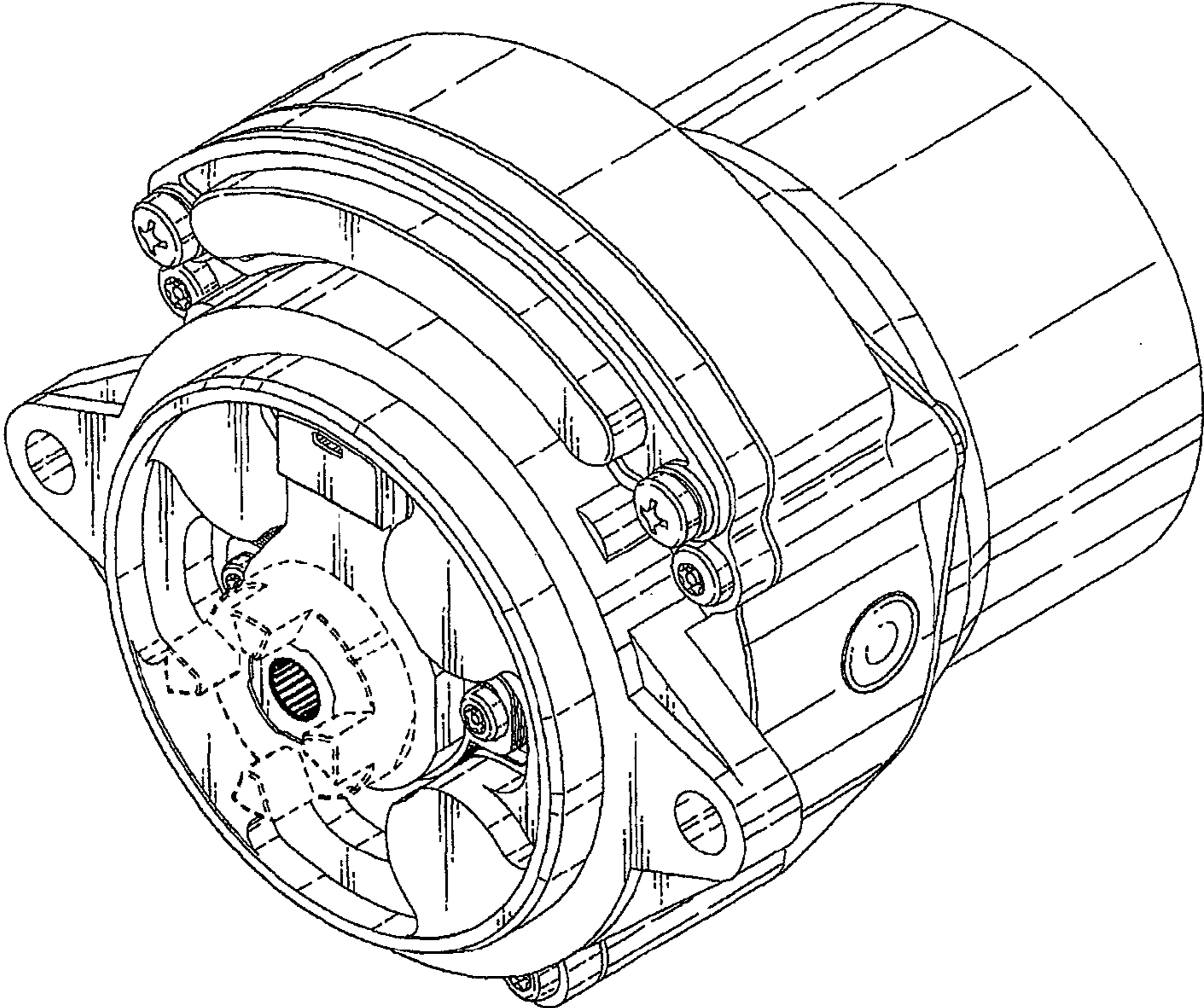

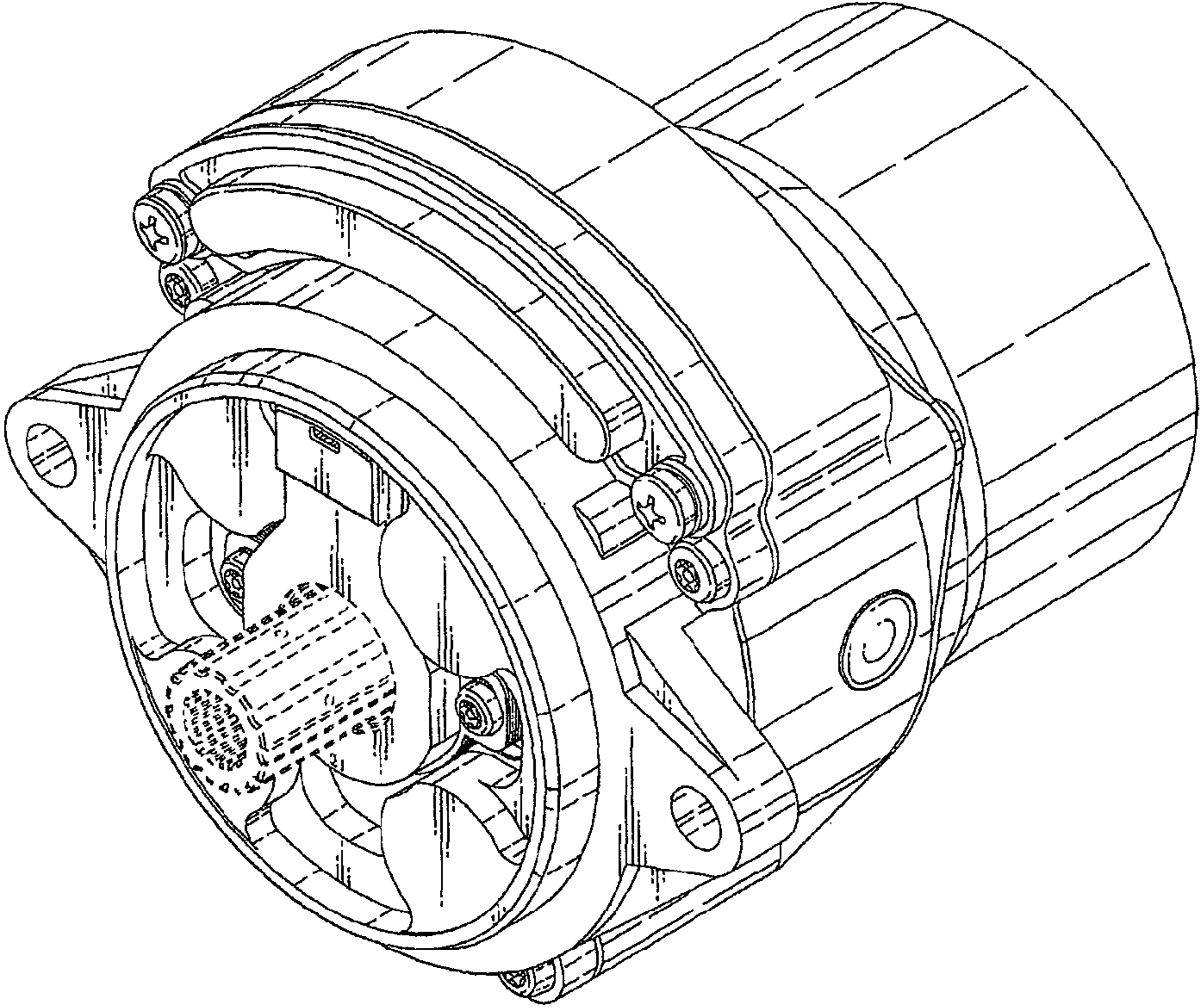
