(57) **CLAIM**

The ornamental design for a hand sign, as shown and described.

FIG. 1 is a right-side elevational view of a first embodiment of a left-hand hand sign according to the invention;

 FIG. 21 is a reduced scale bottom plan view of the left-hand hand sign of FIG. 17;

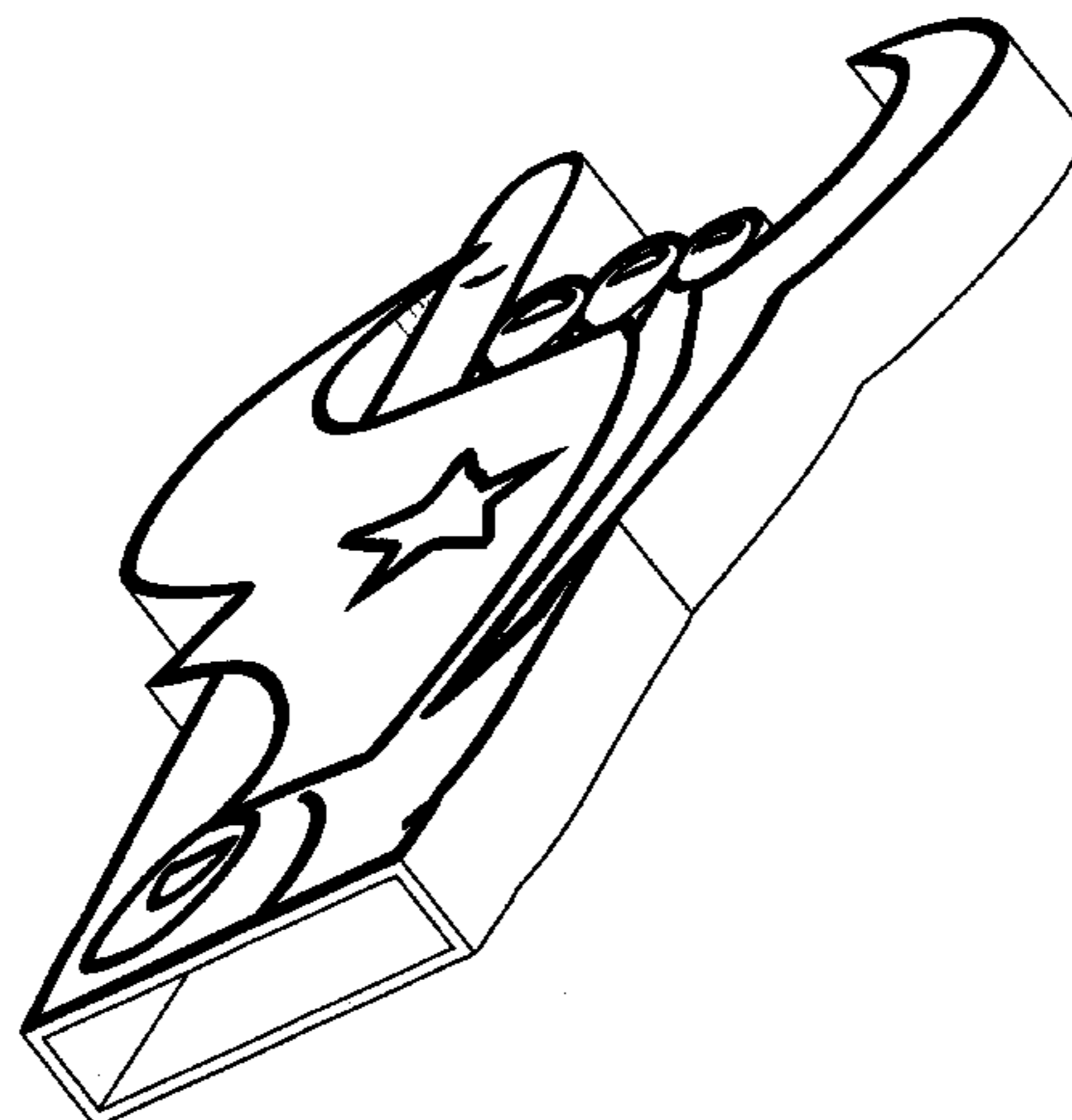


FIG. 22 is a reduced scale front elevational view of the left-hand hand sign of FIG. 17;

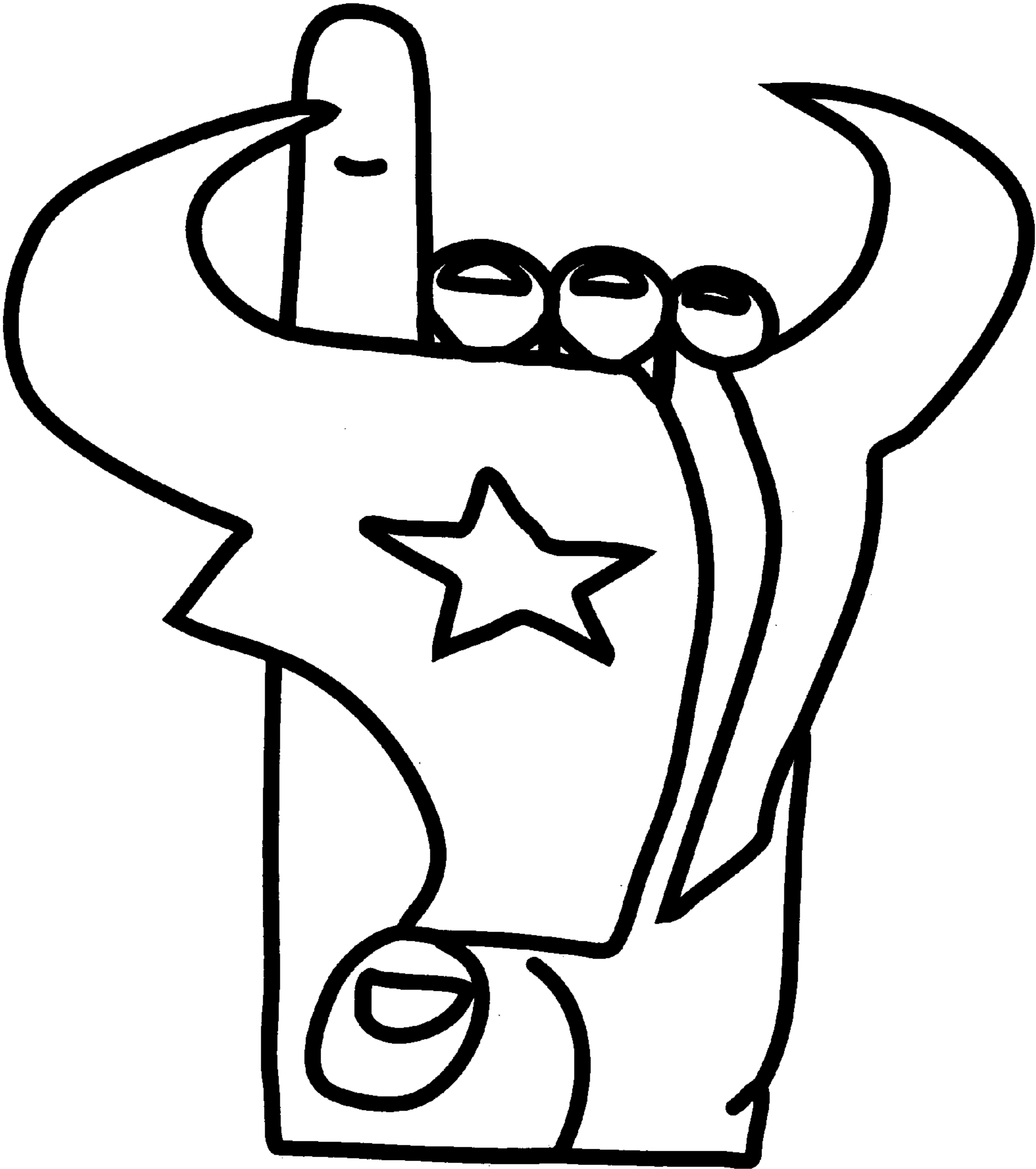

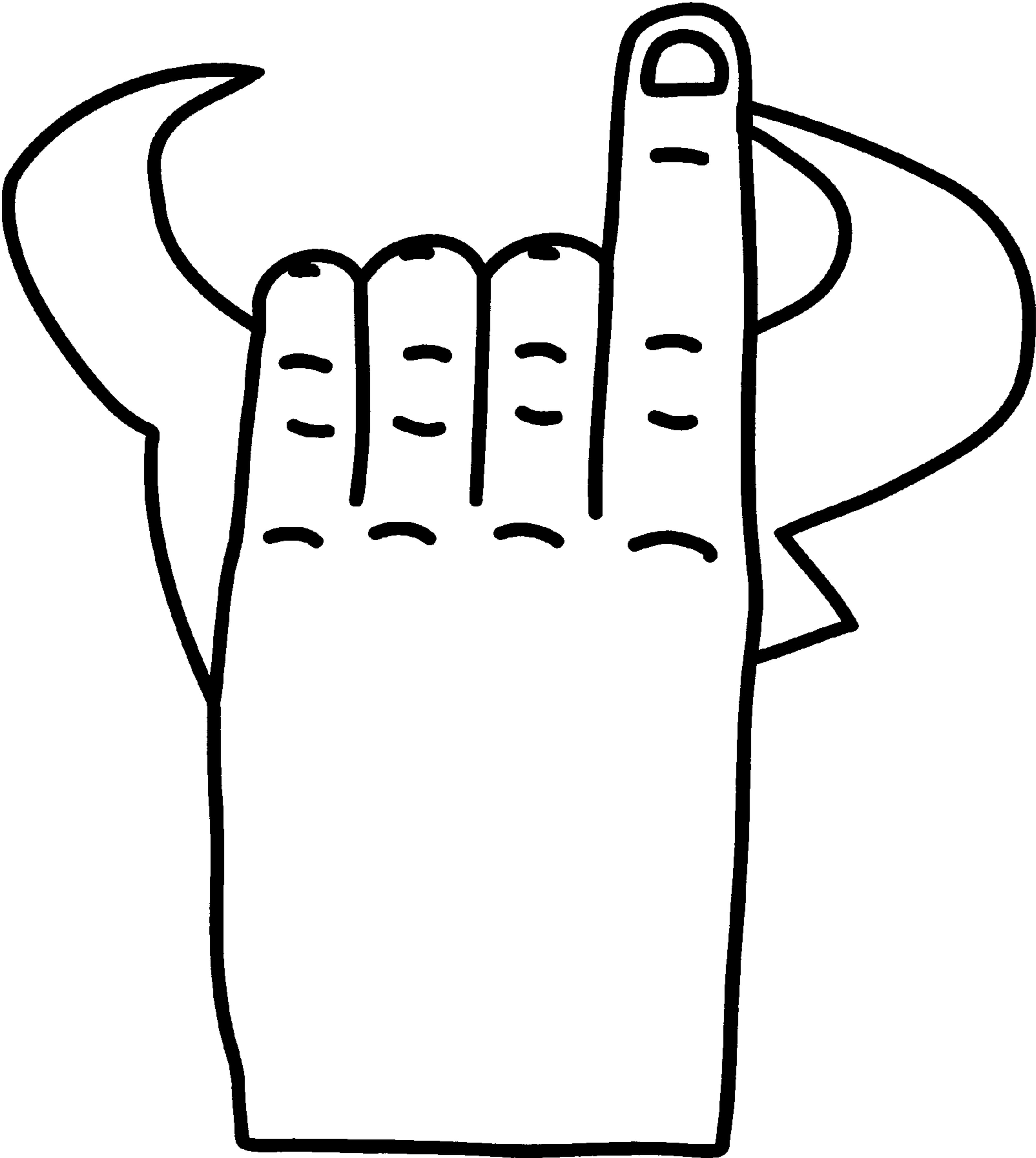

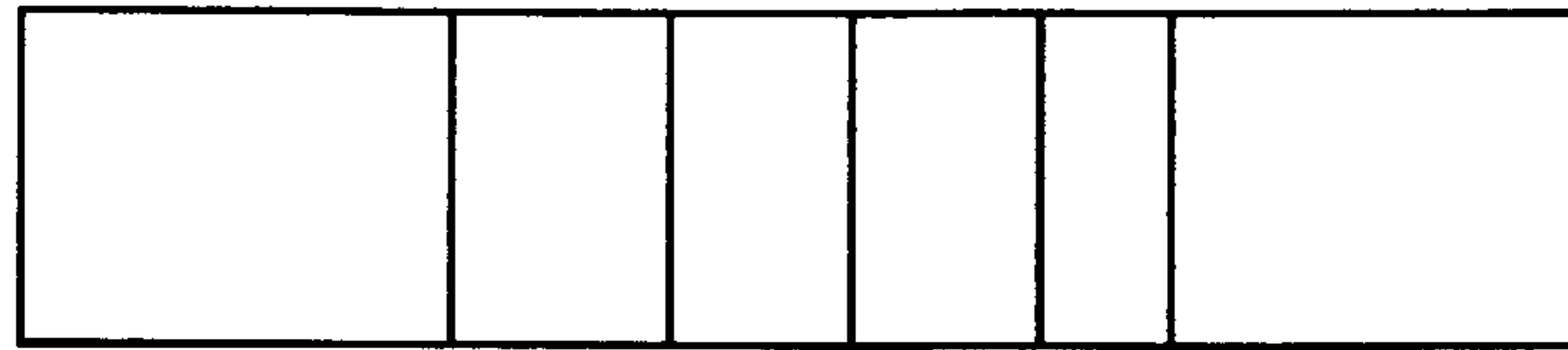

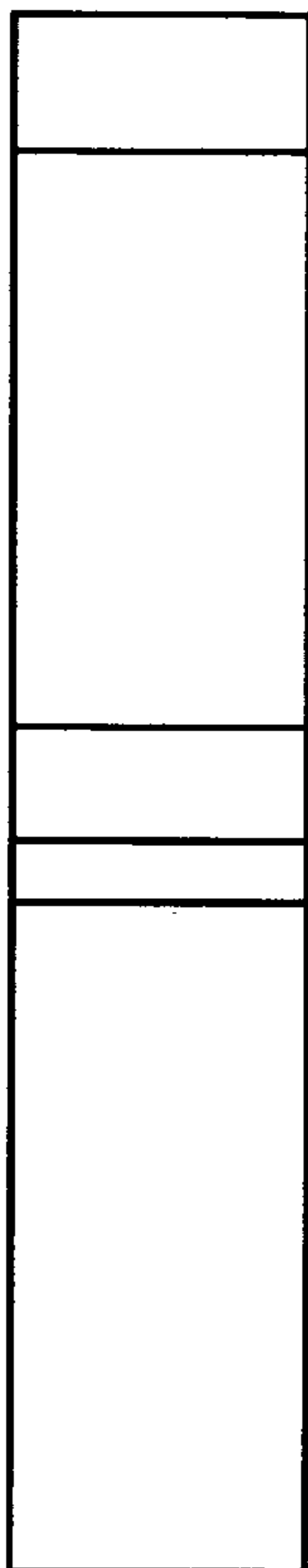

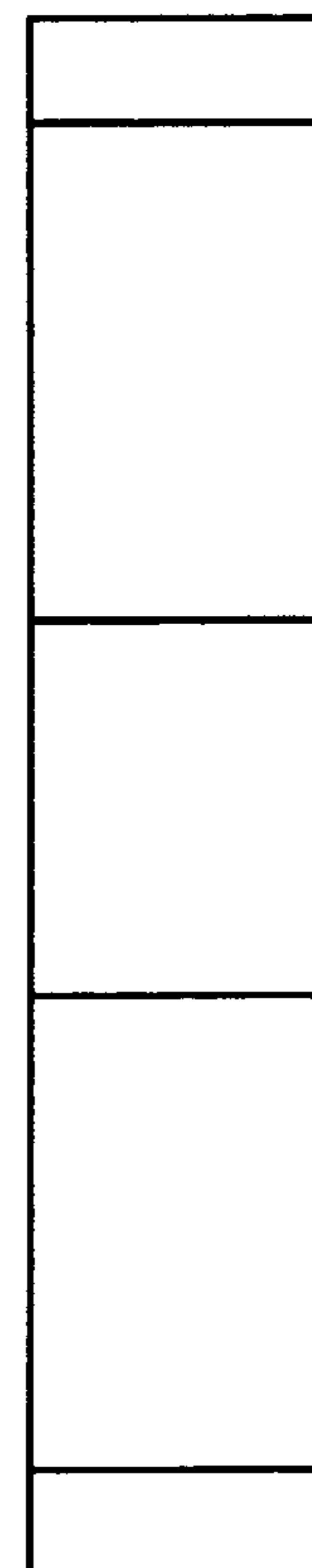

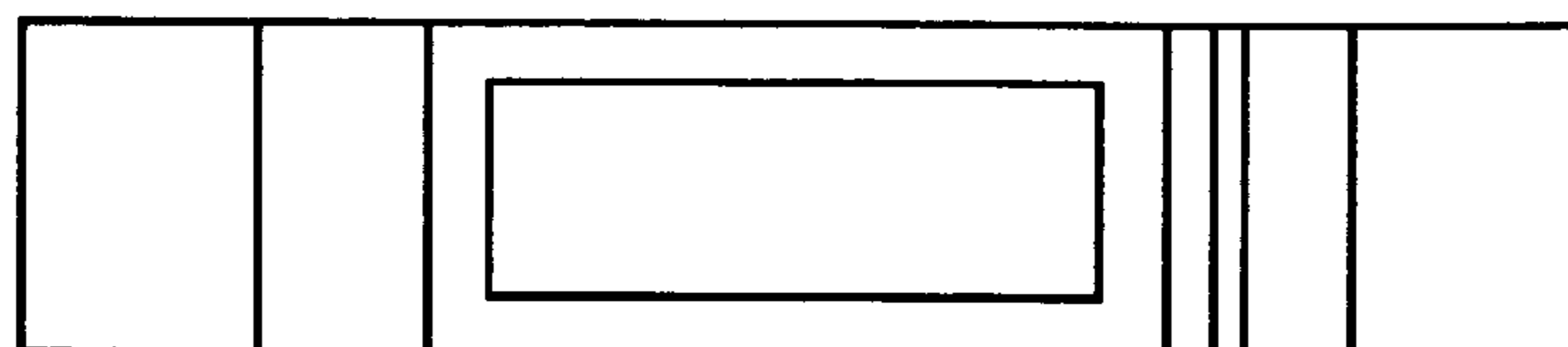

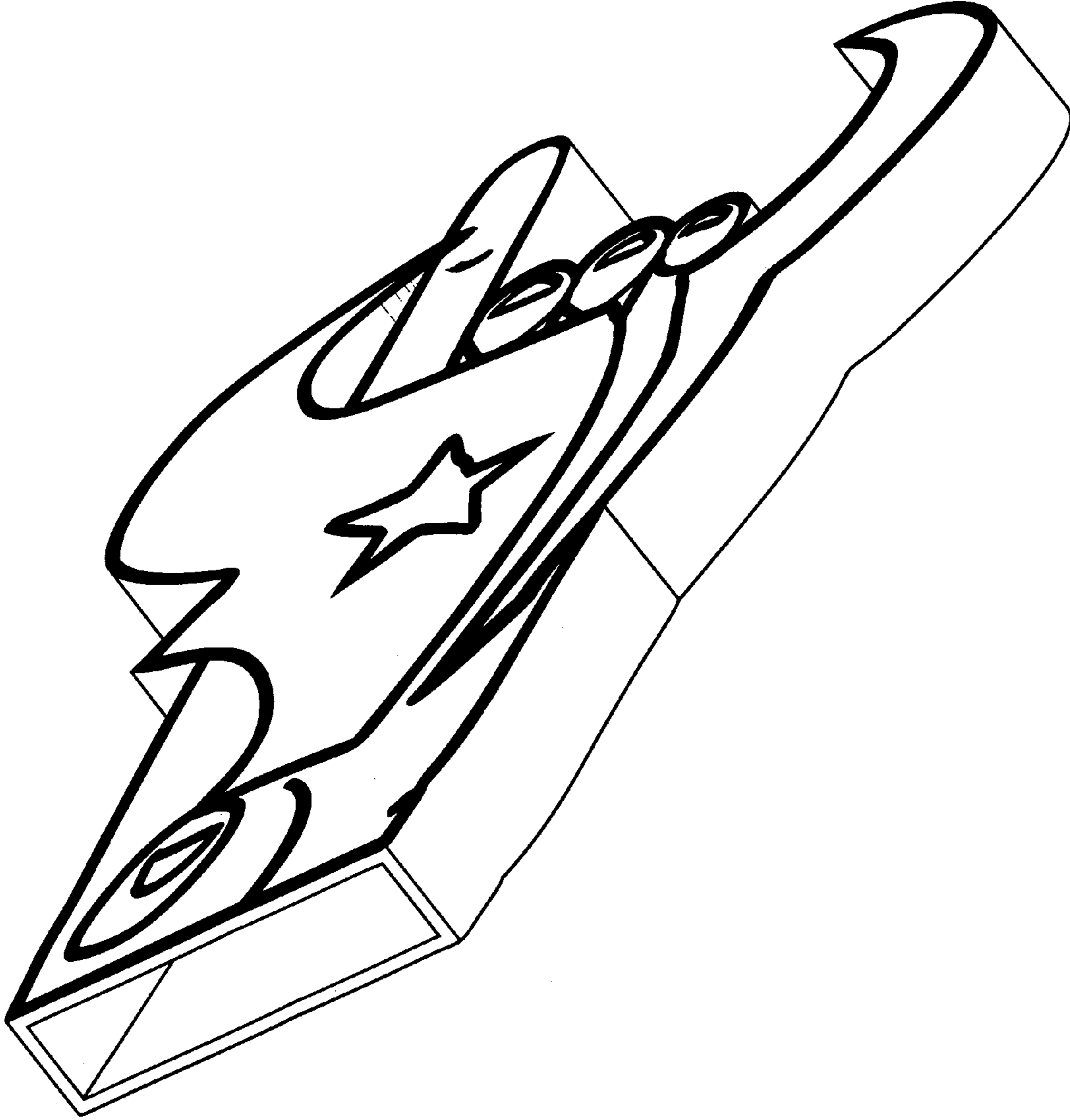

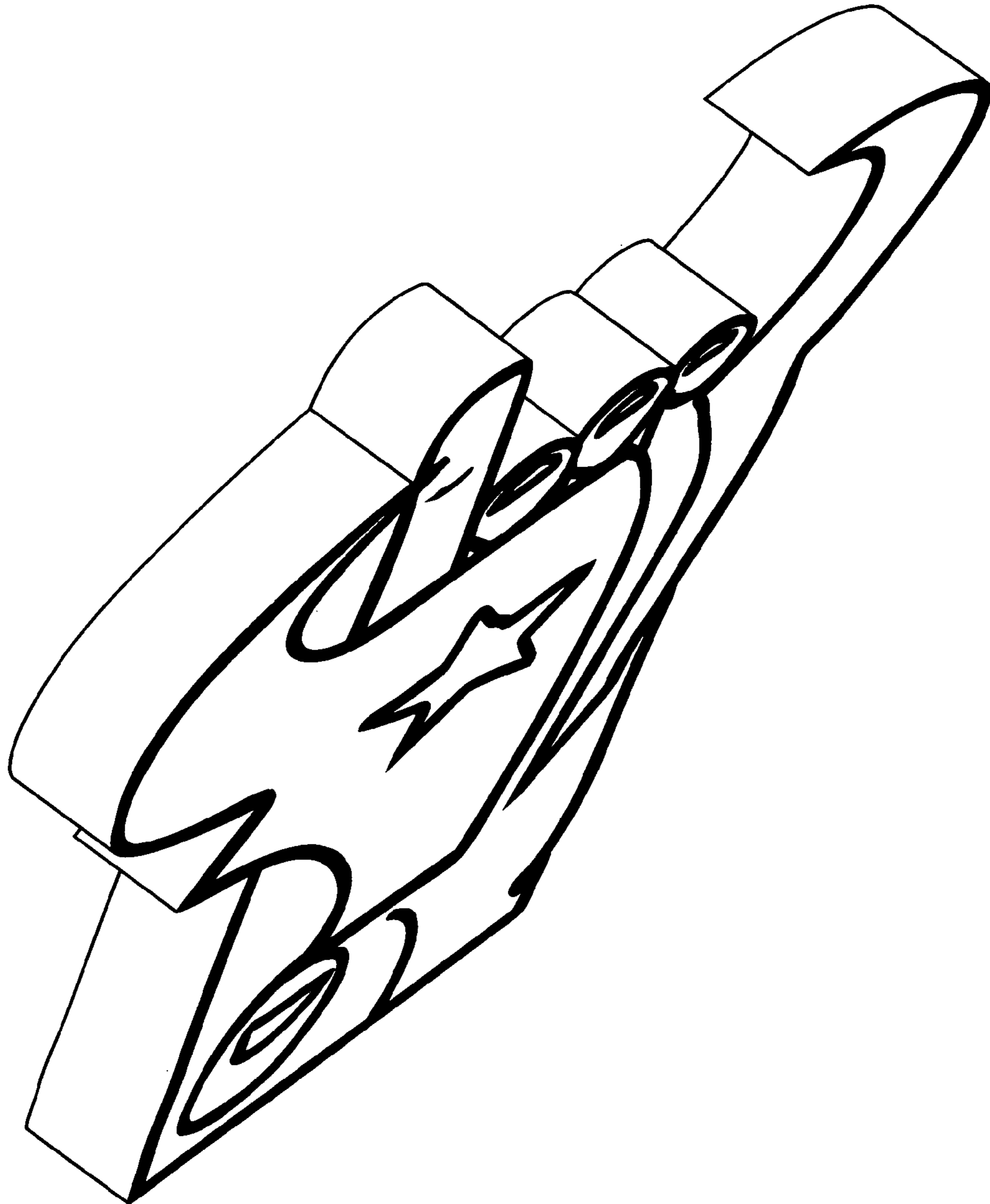

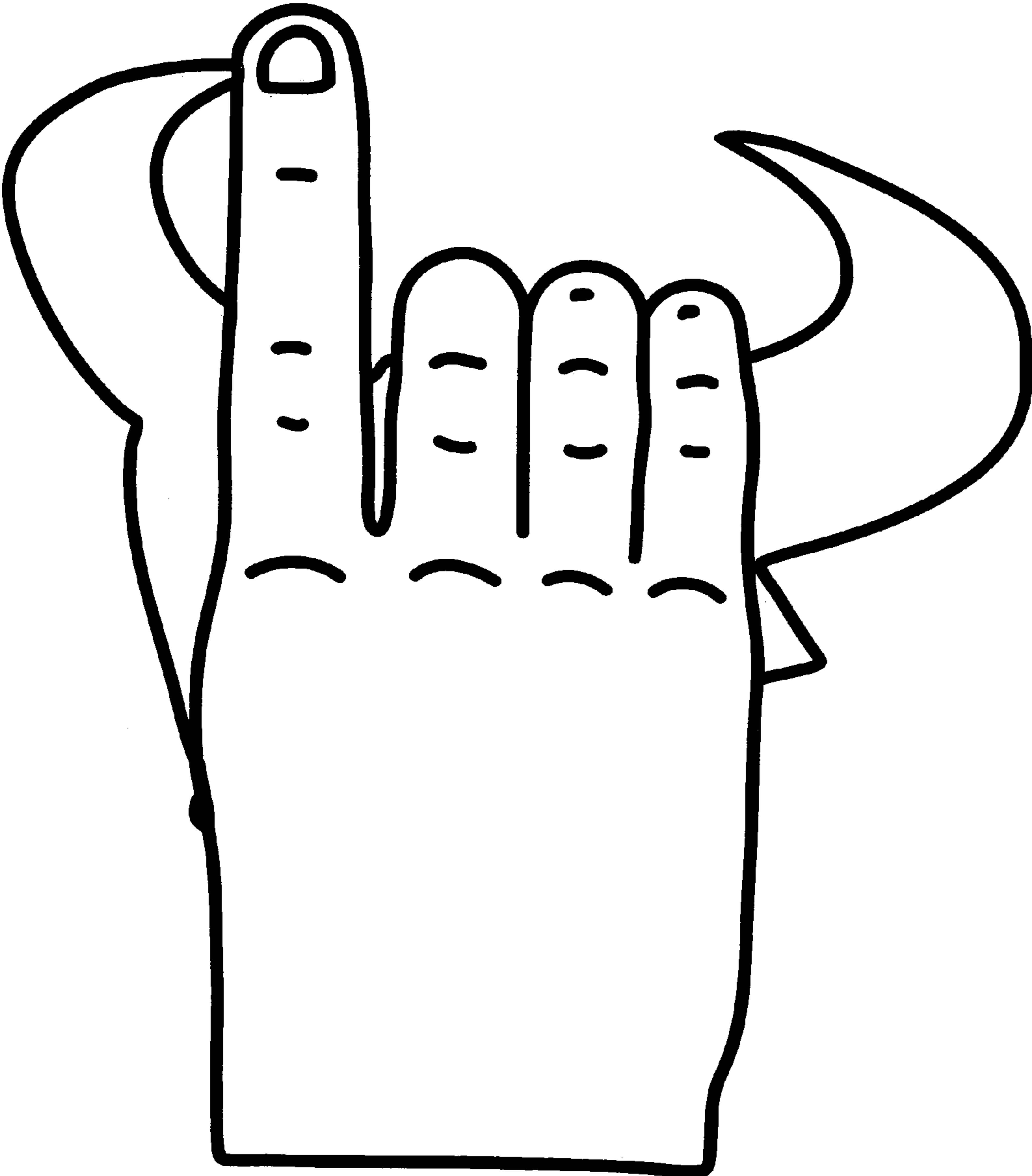

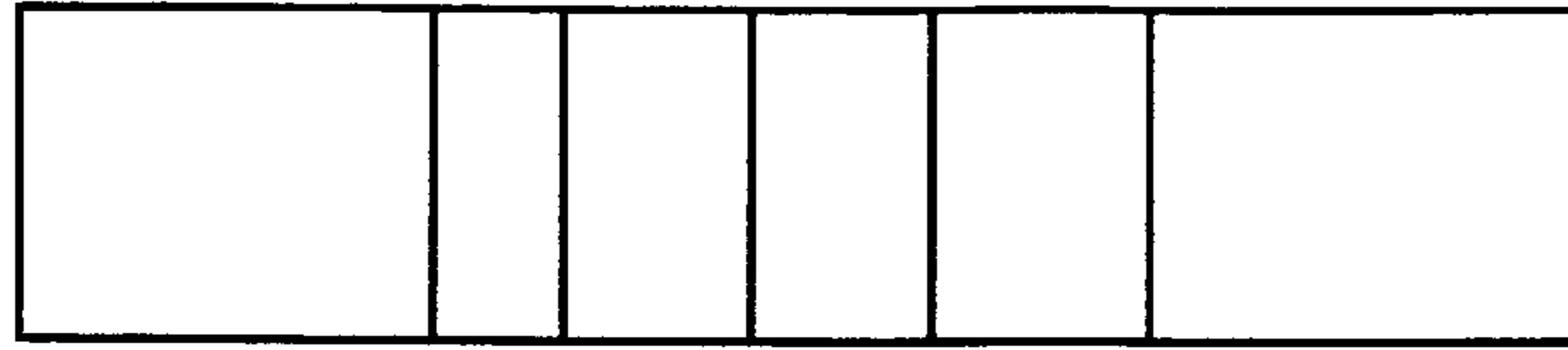

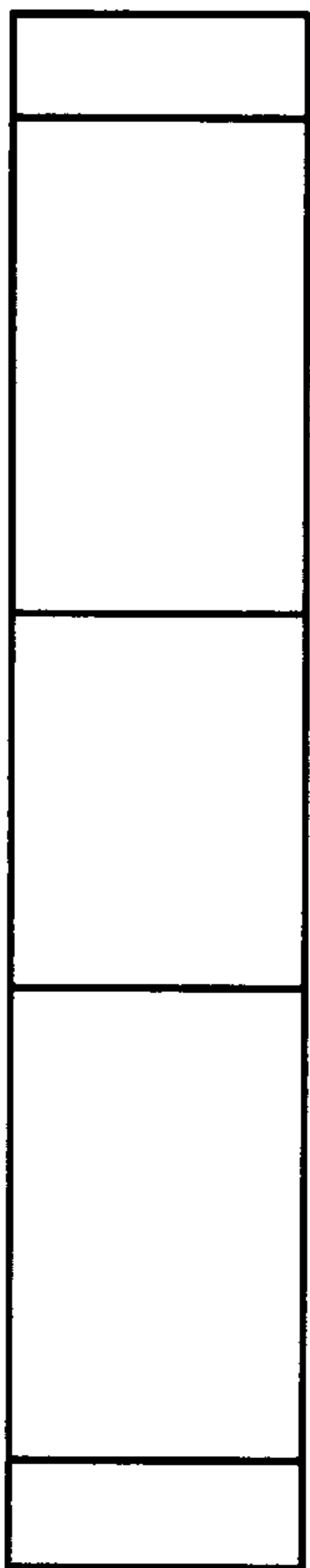

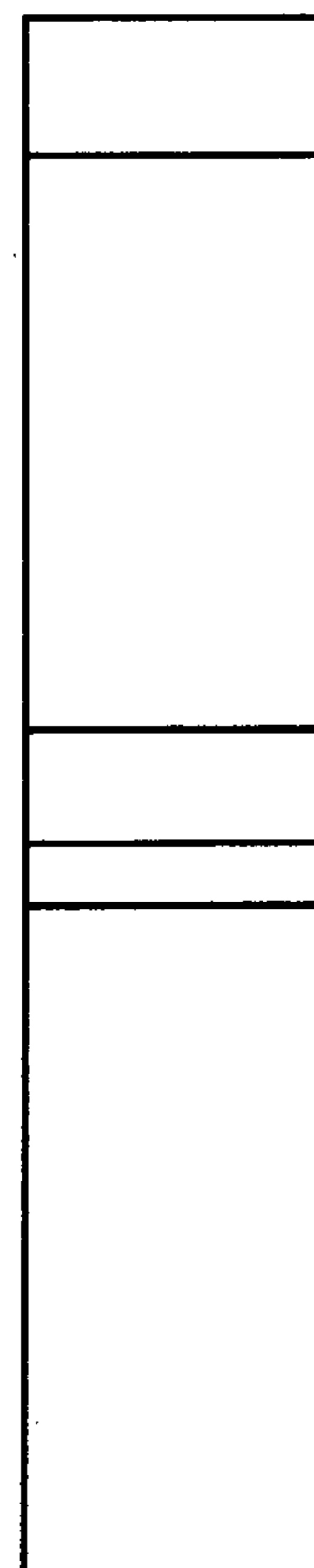

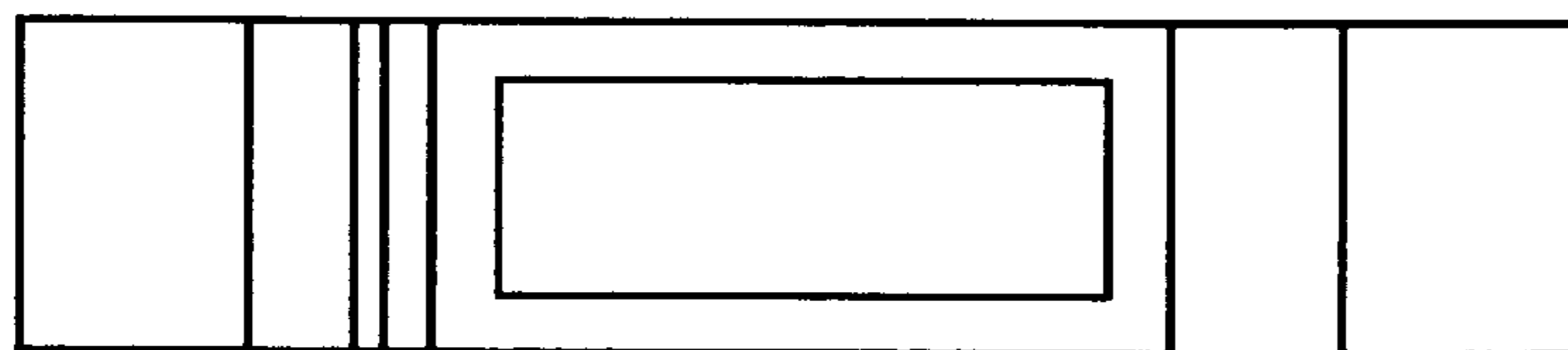

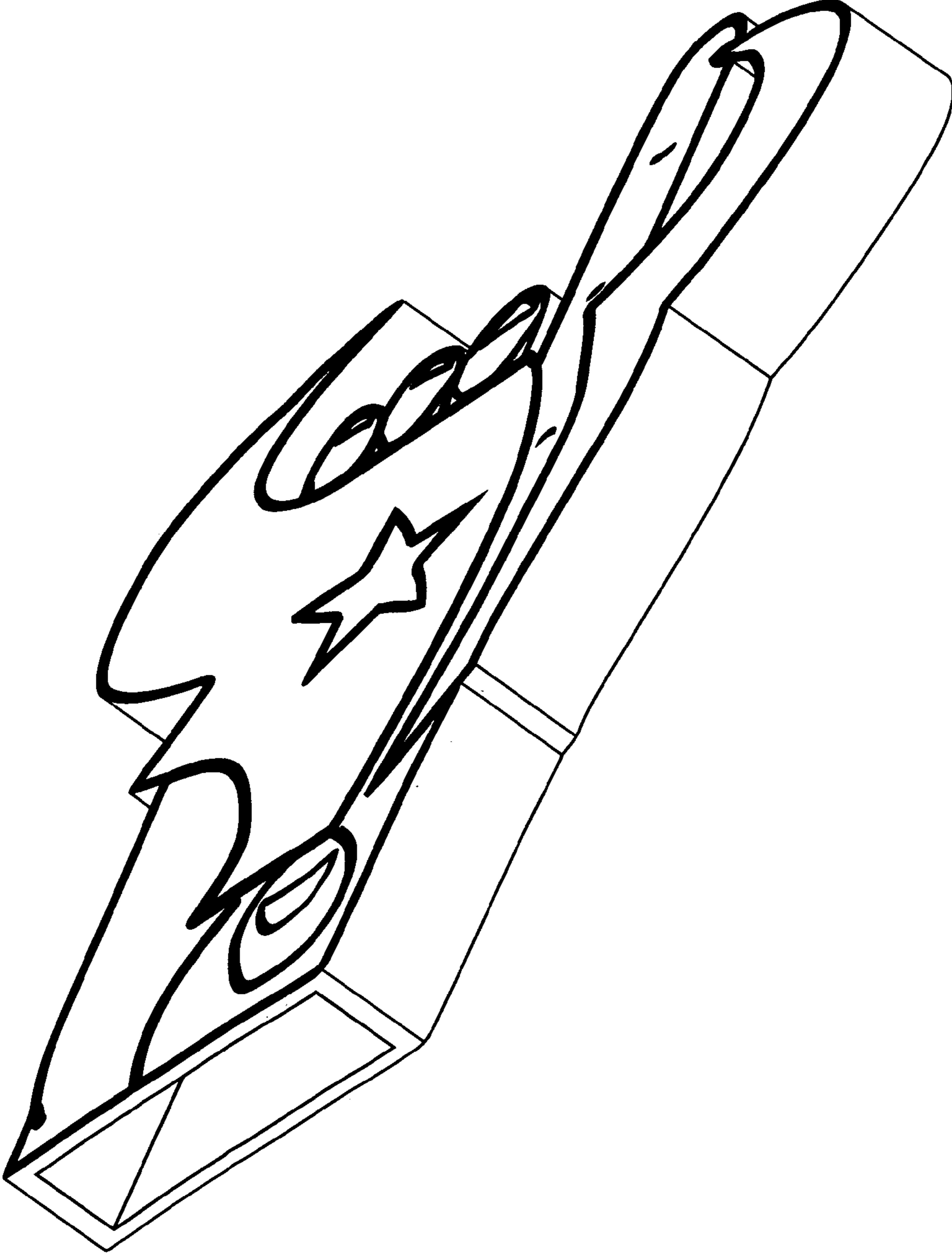

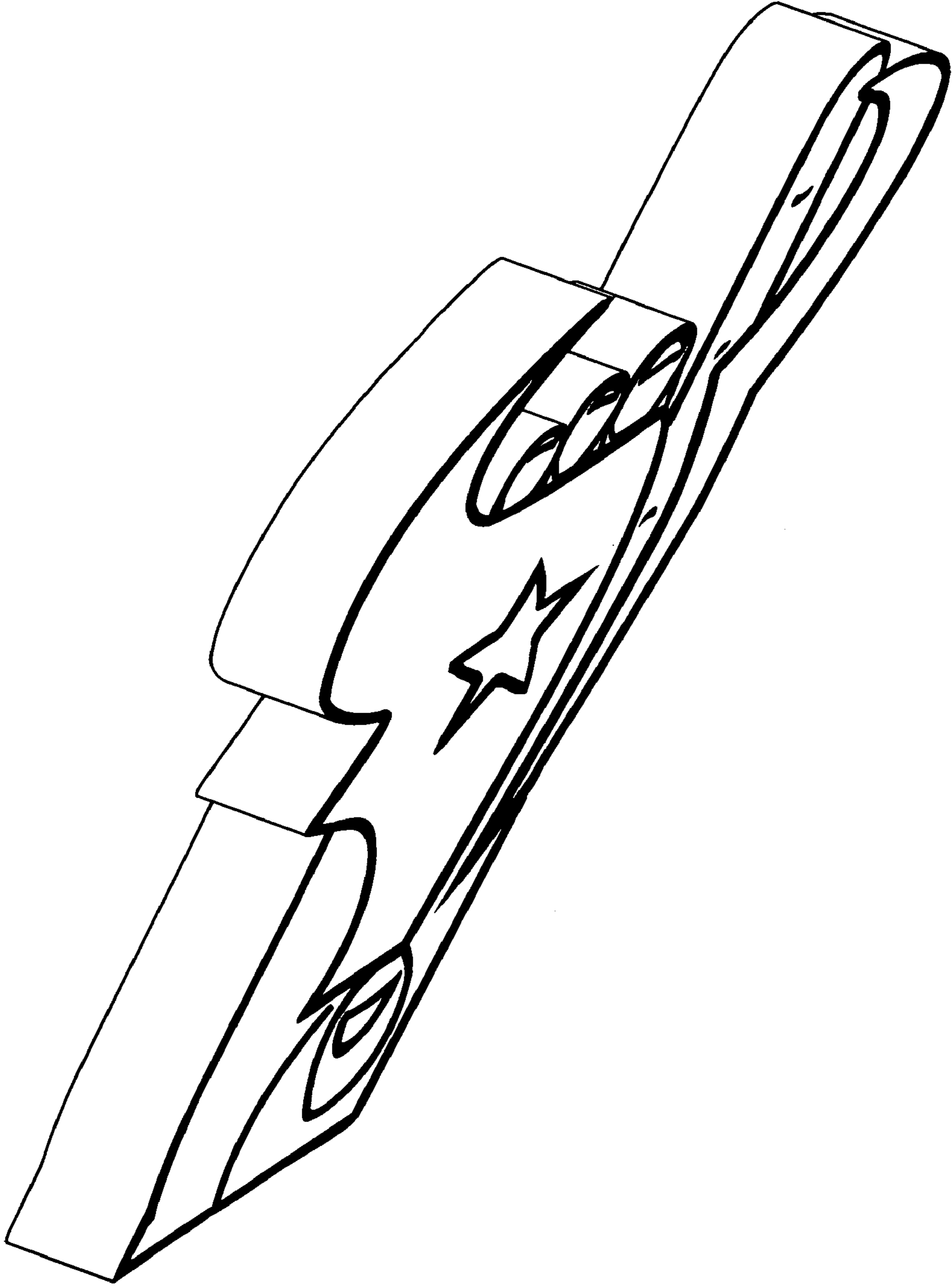

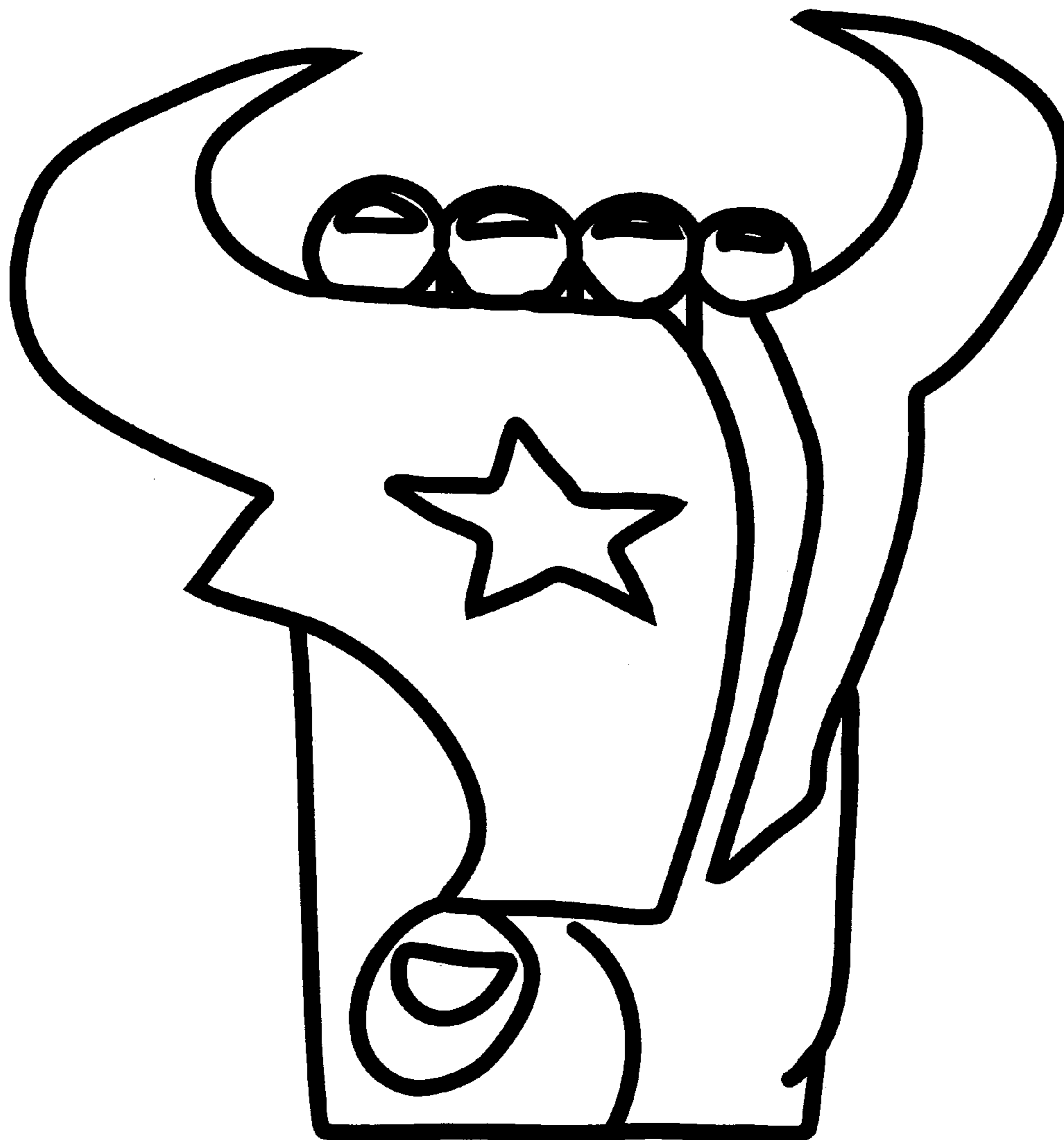

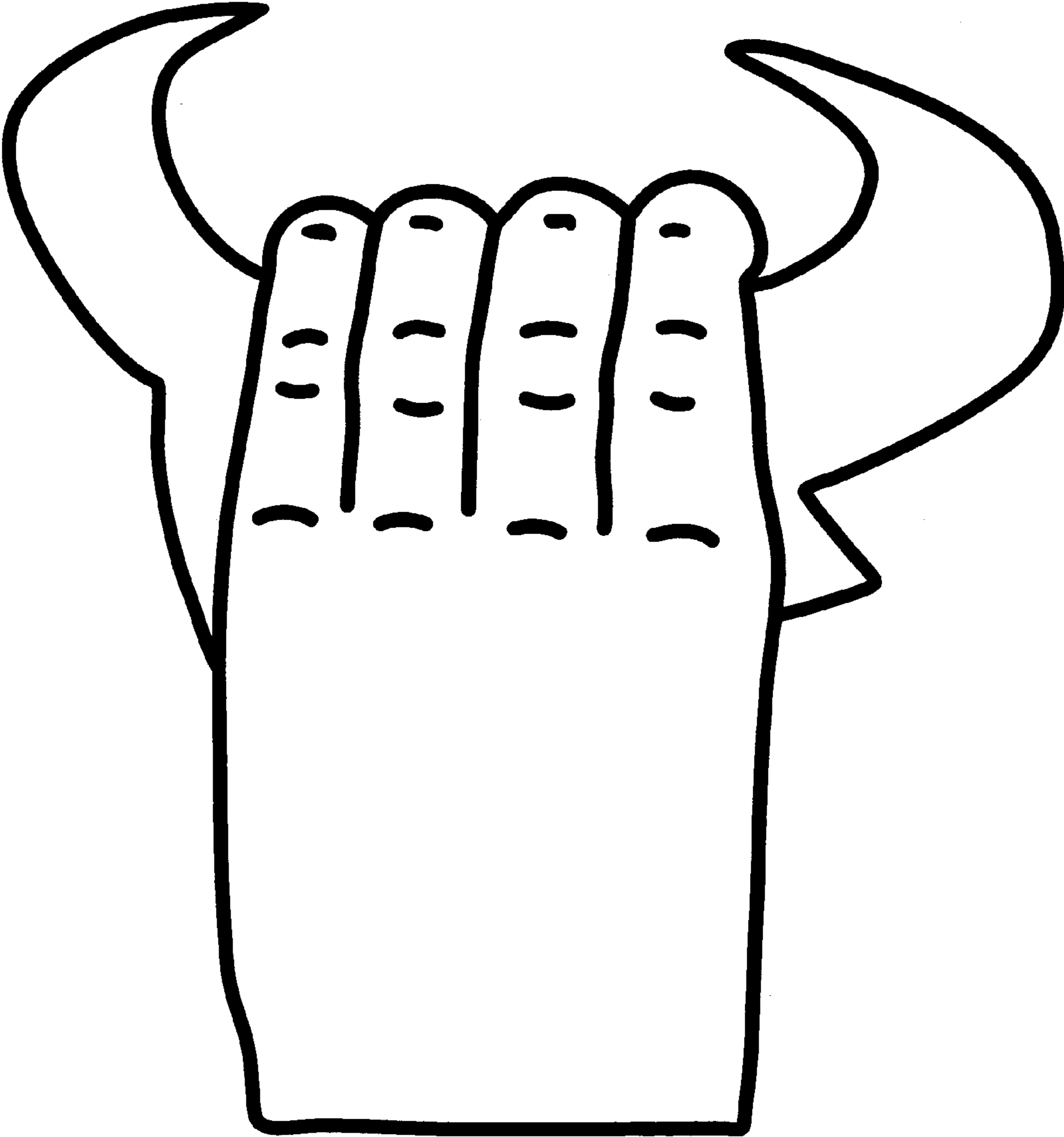

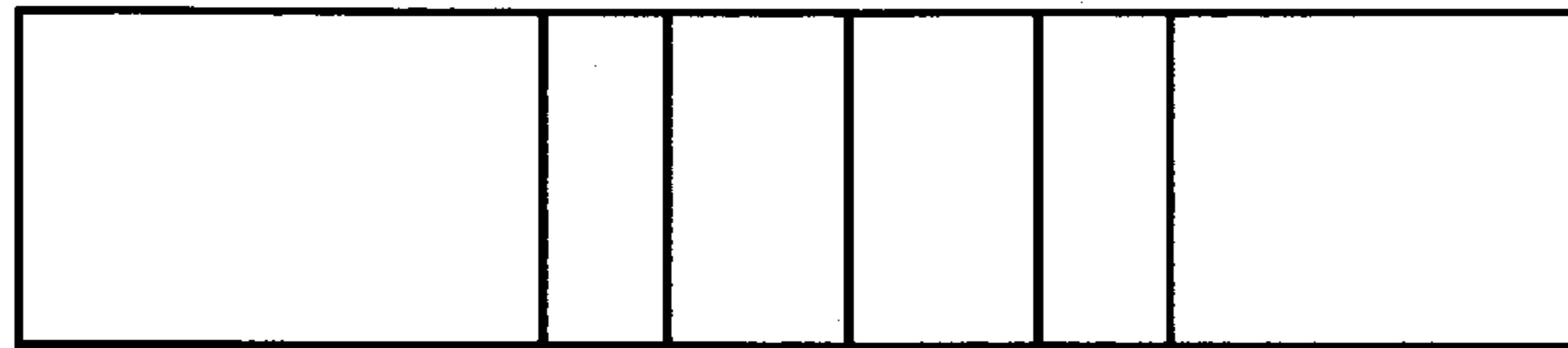

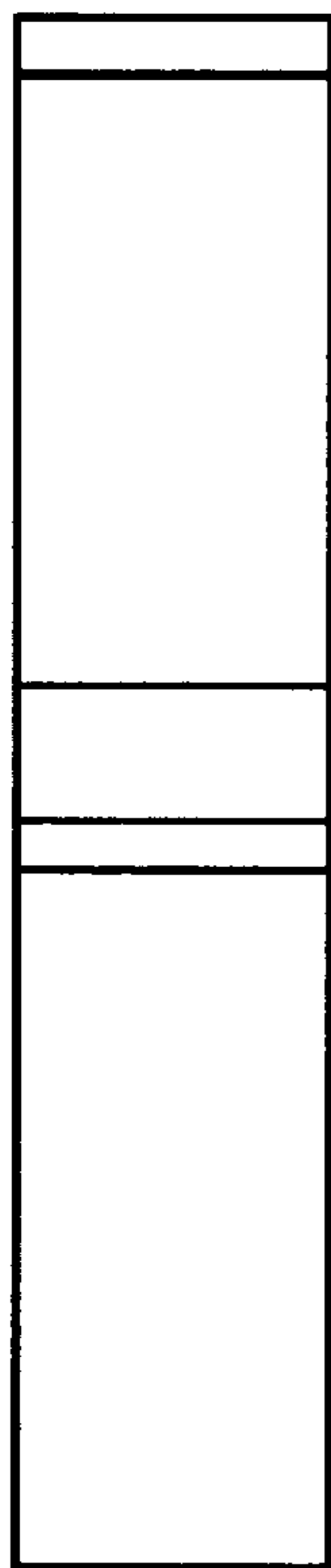

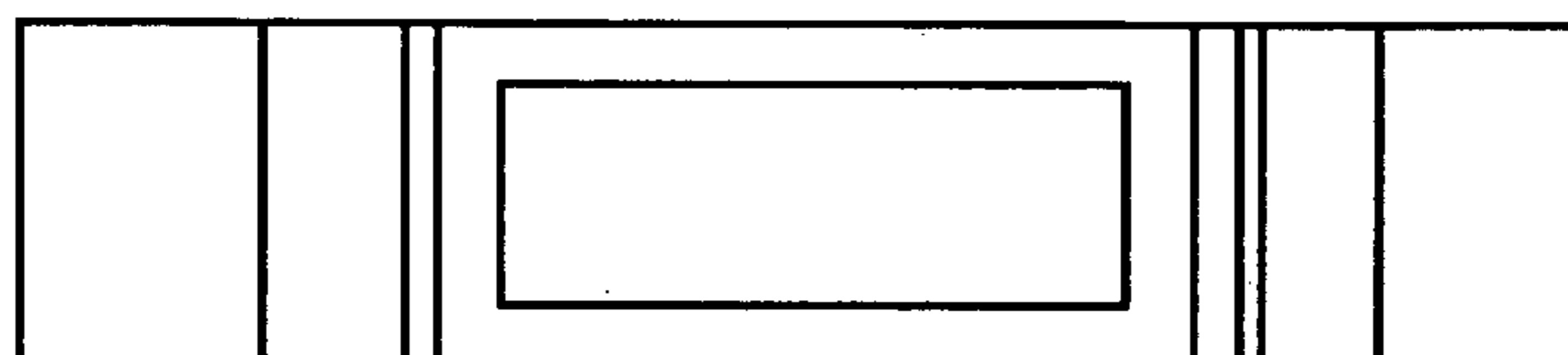

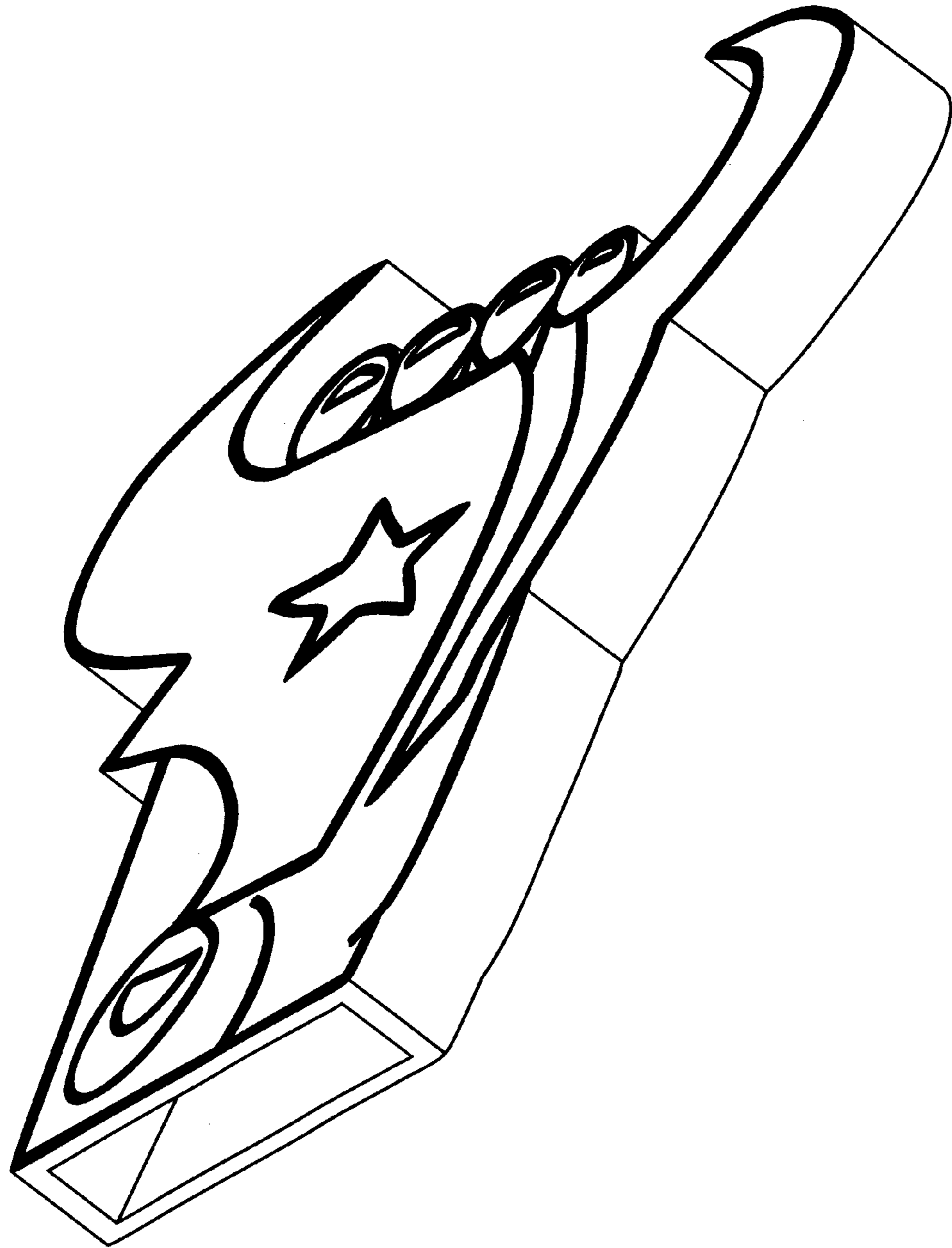

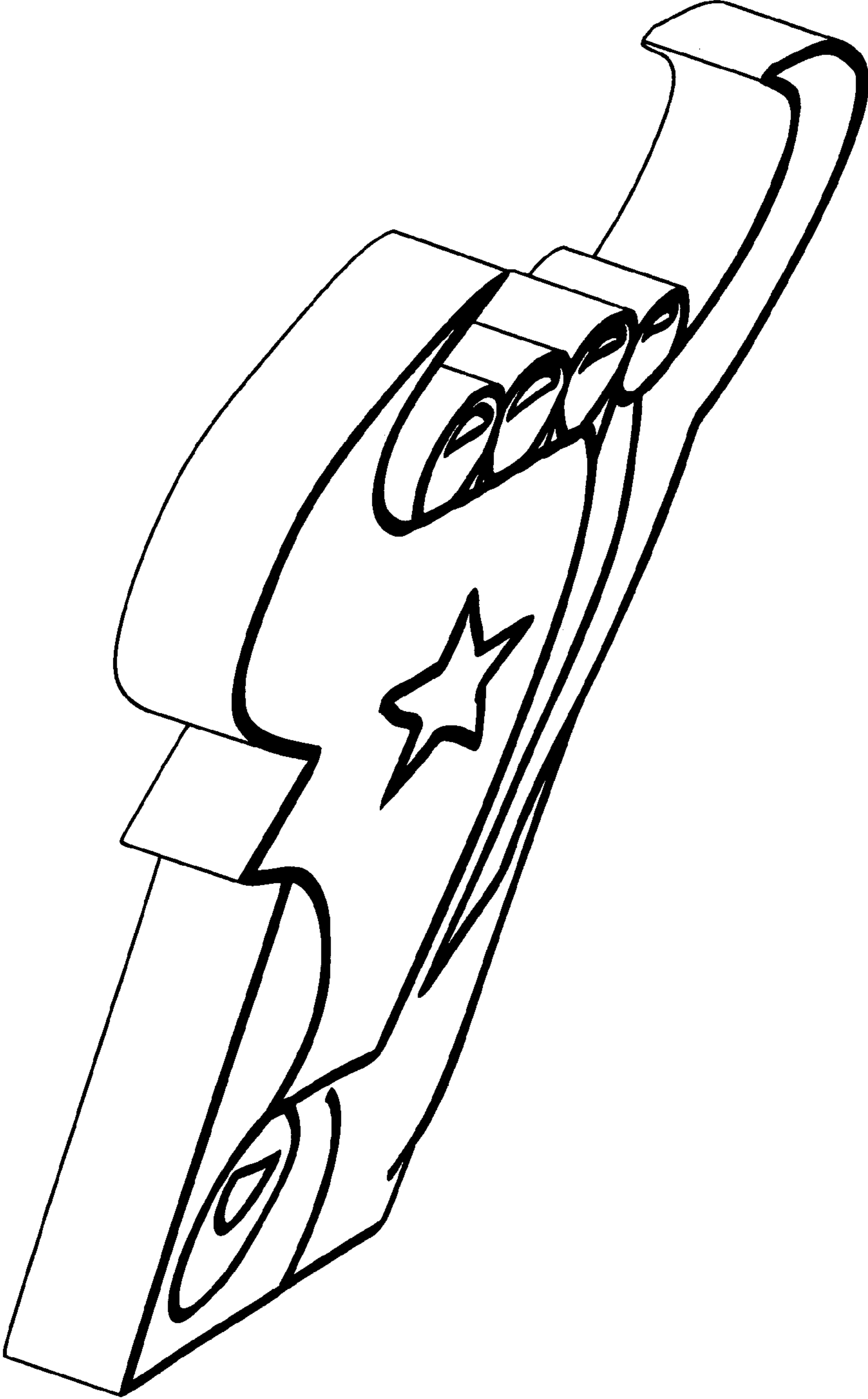

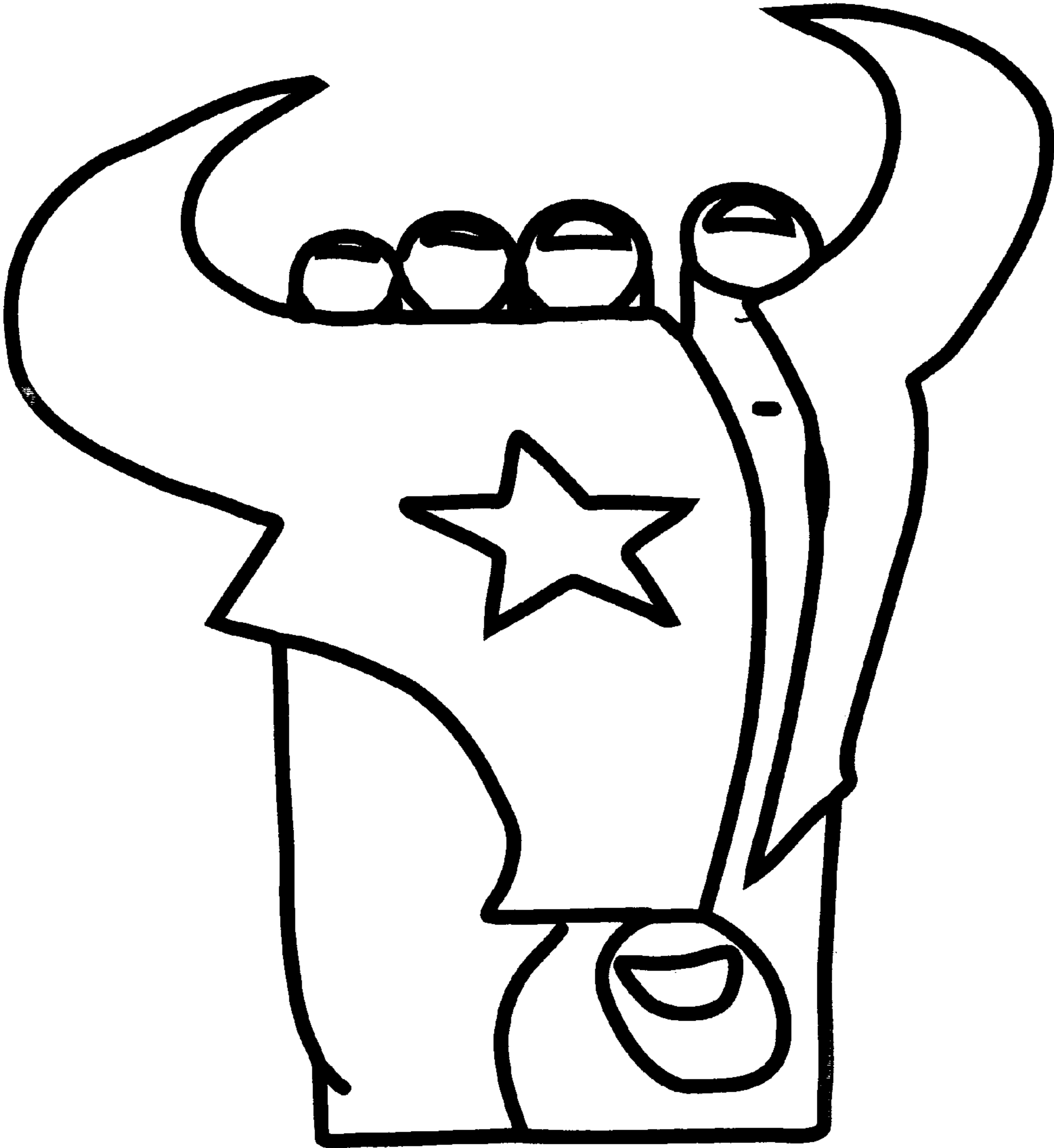

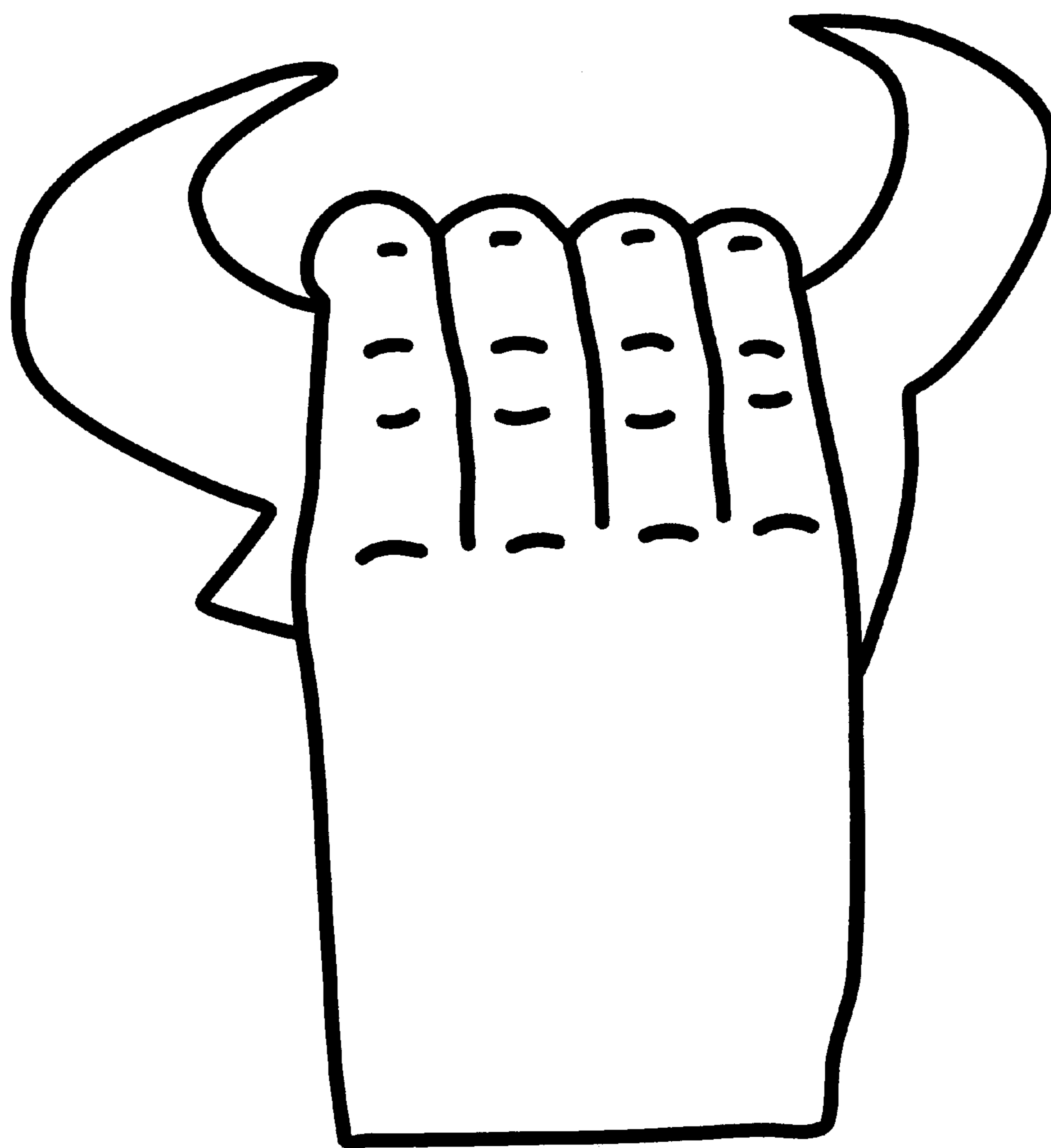

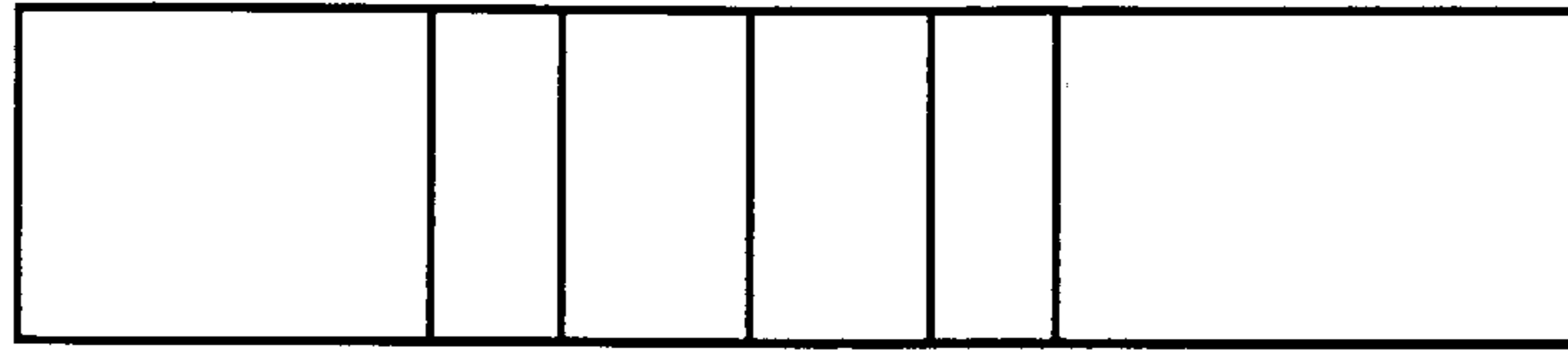

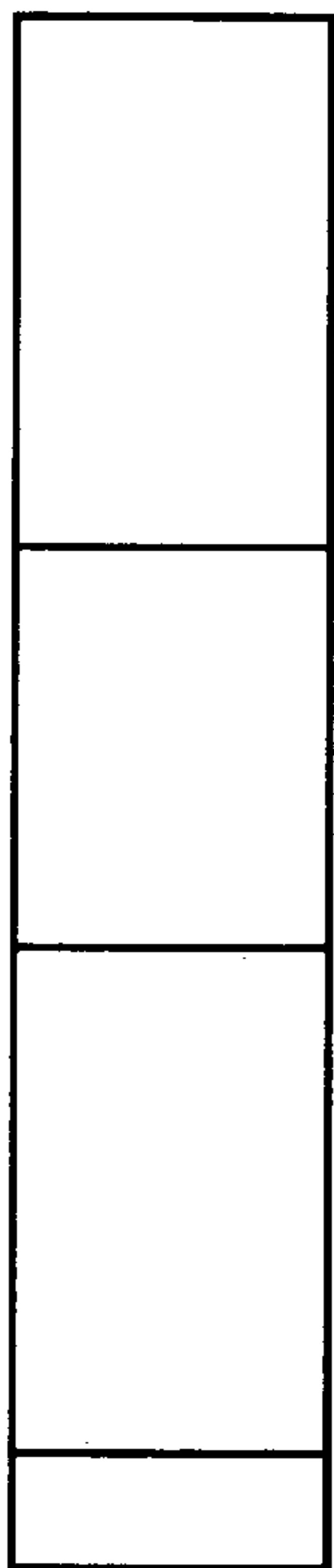

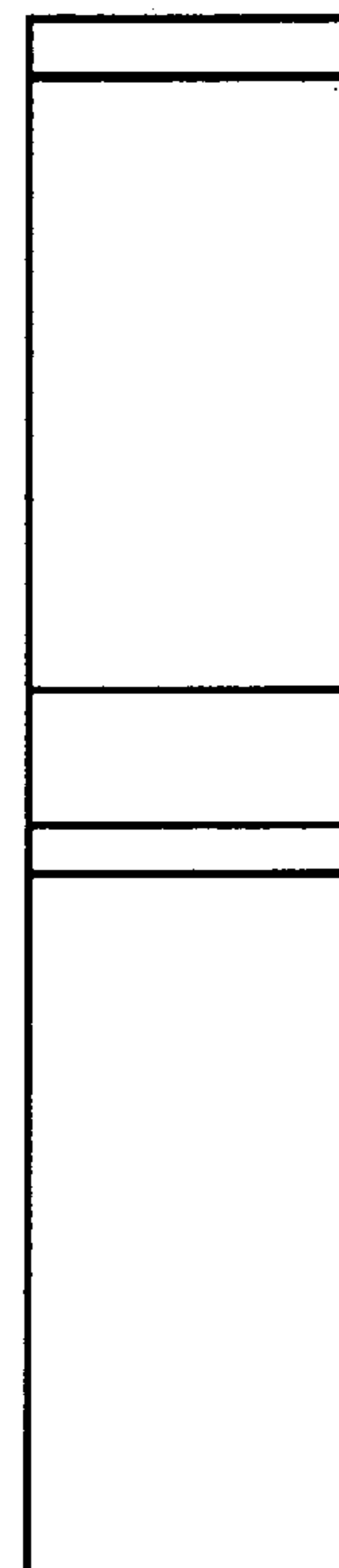

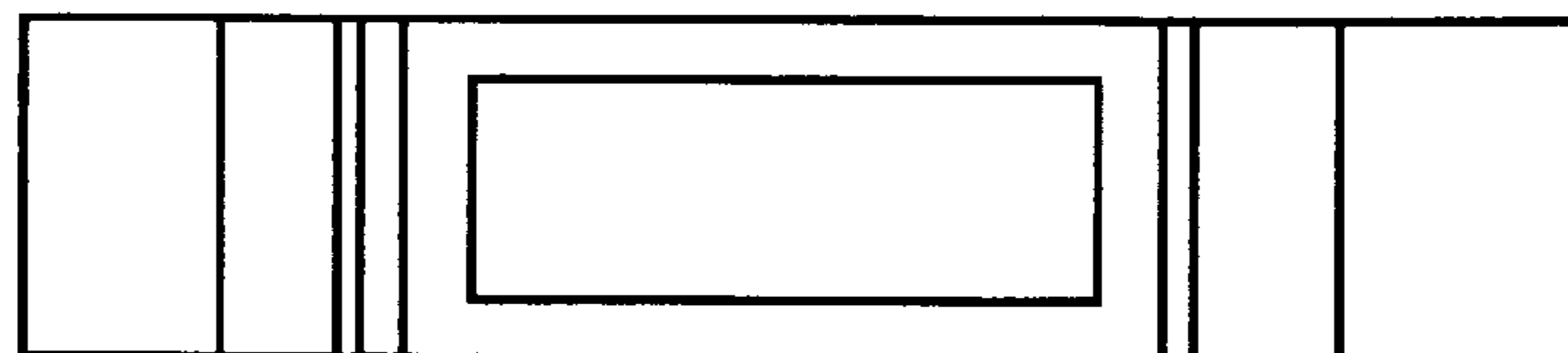

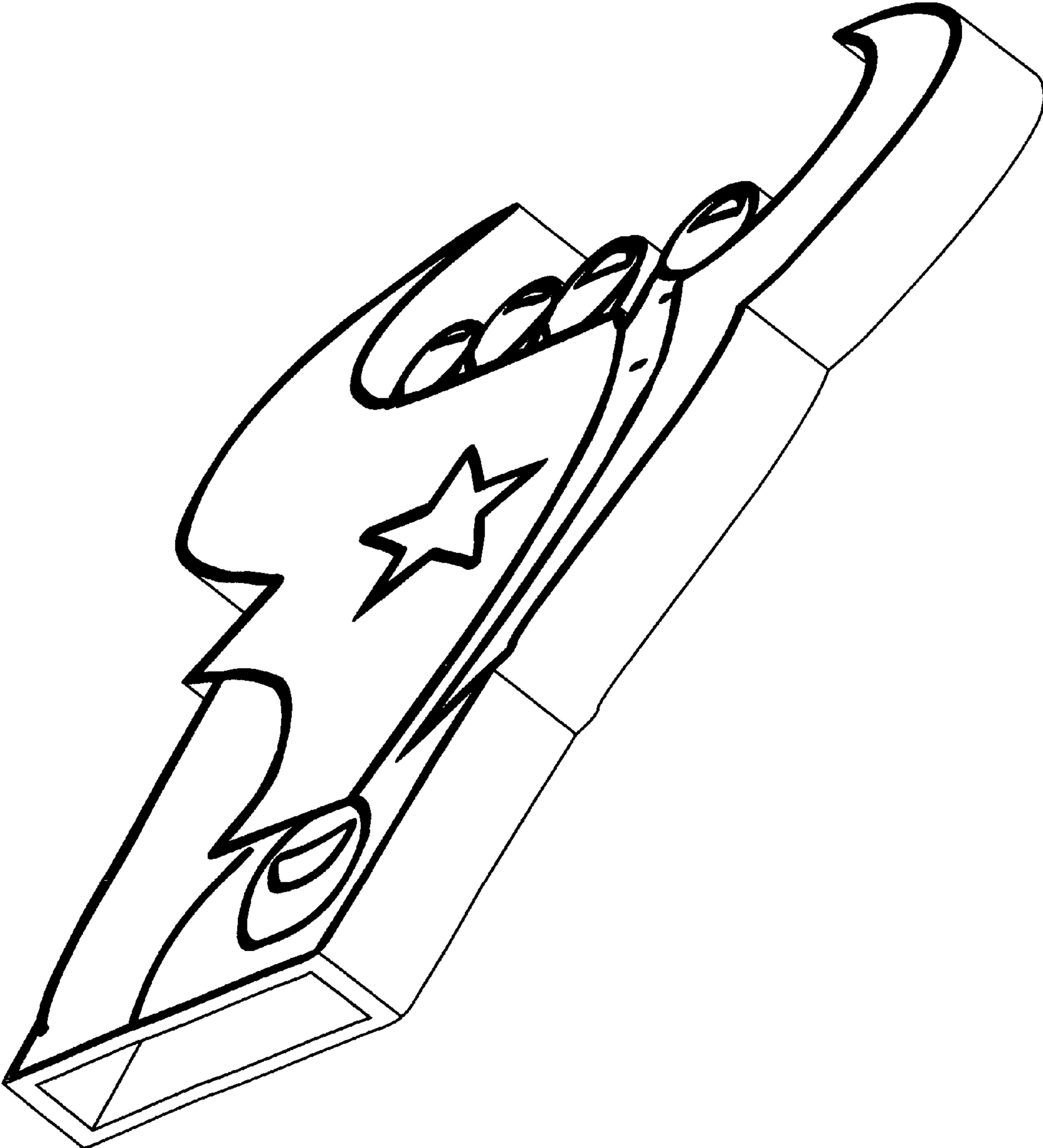

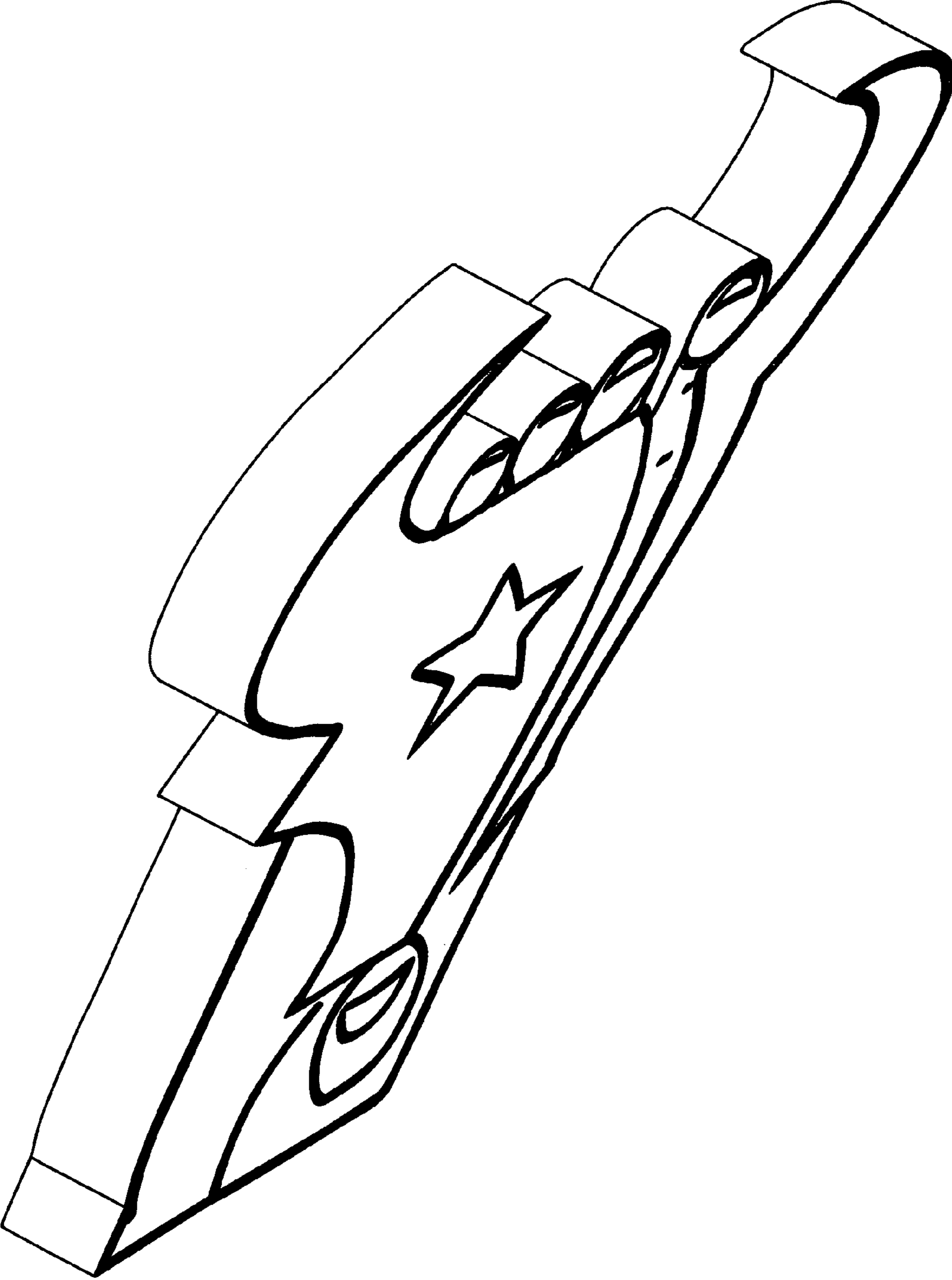
