(57) **CLAIM**

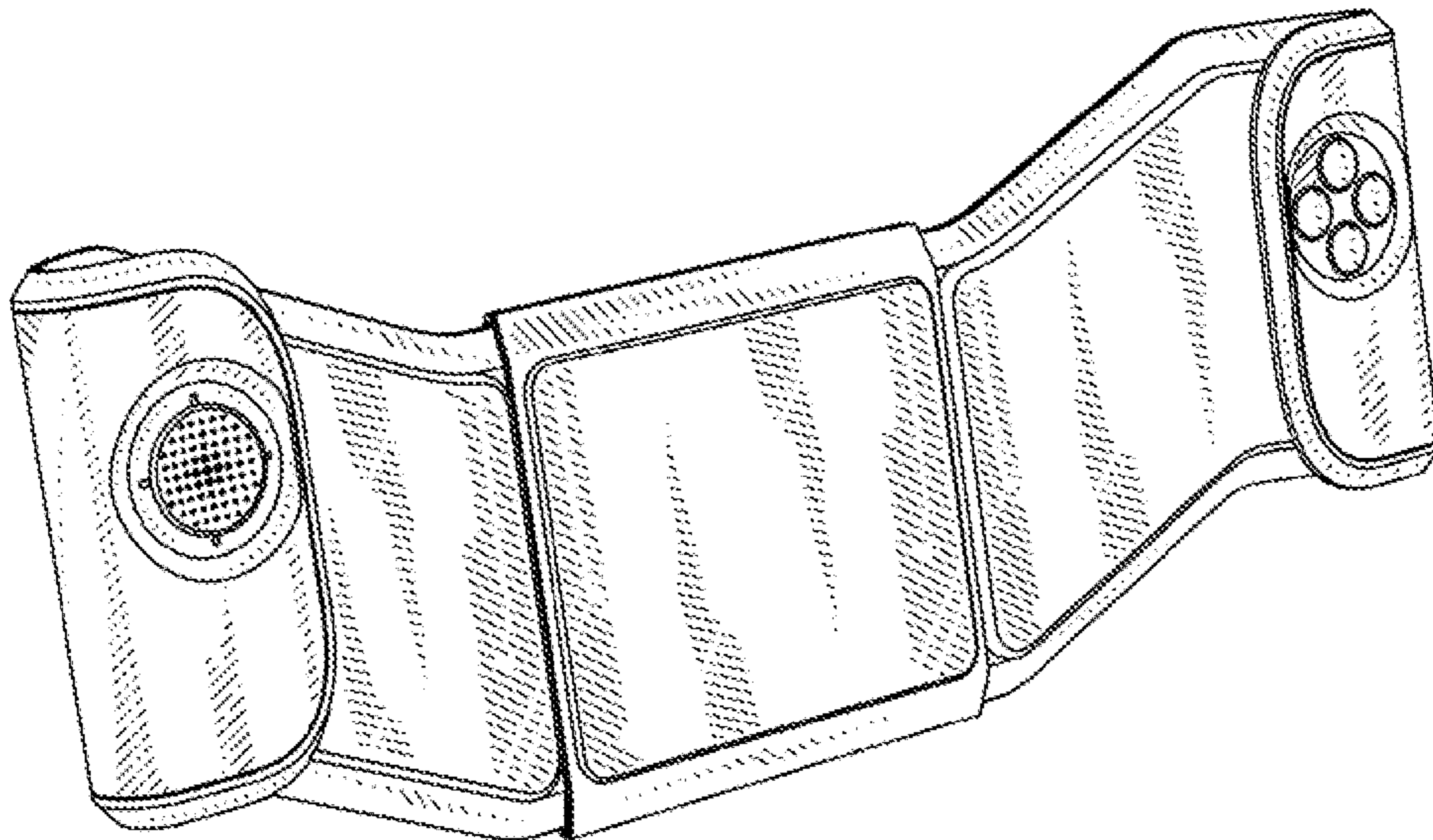
The ornamental design for a gaming cradle for pad, as shown and described.

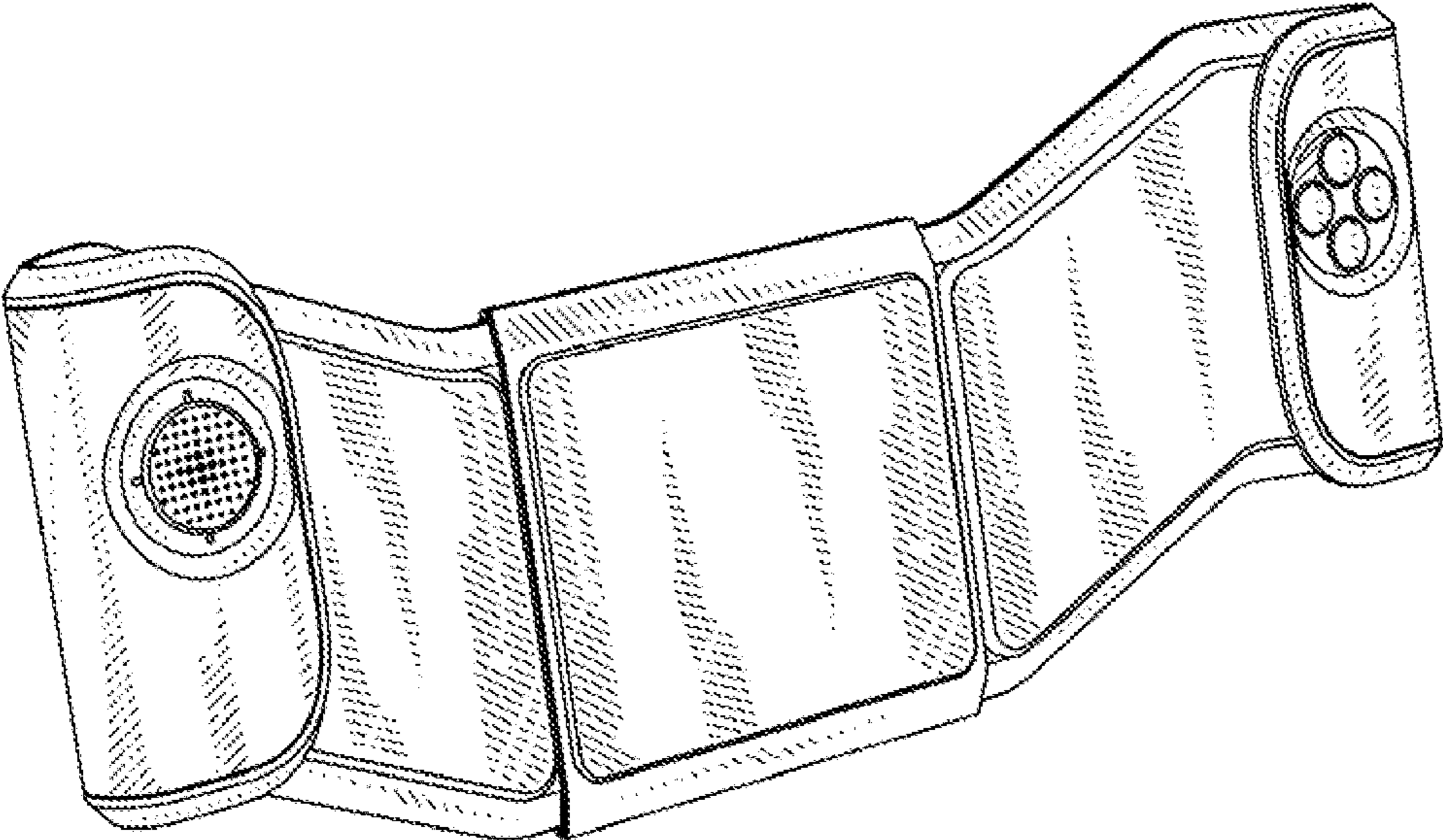

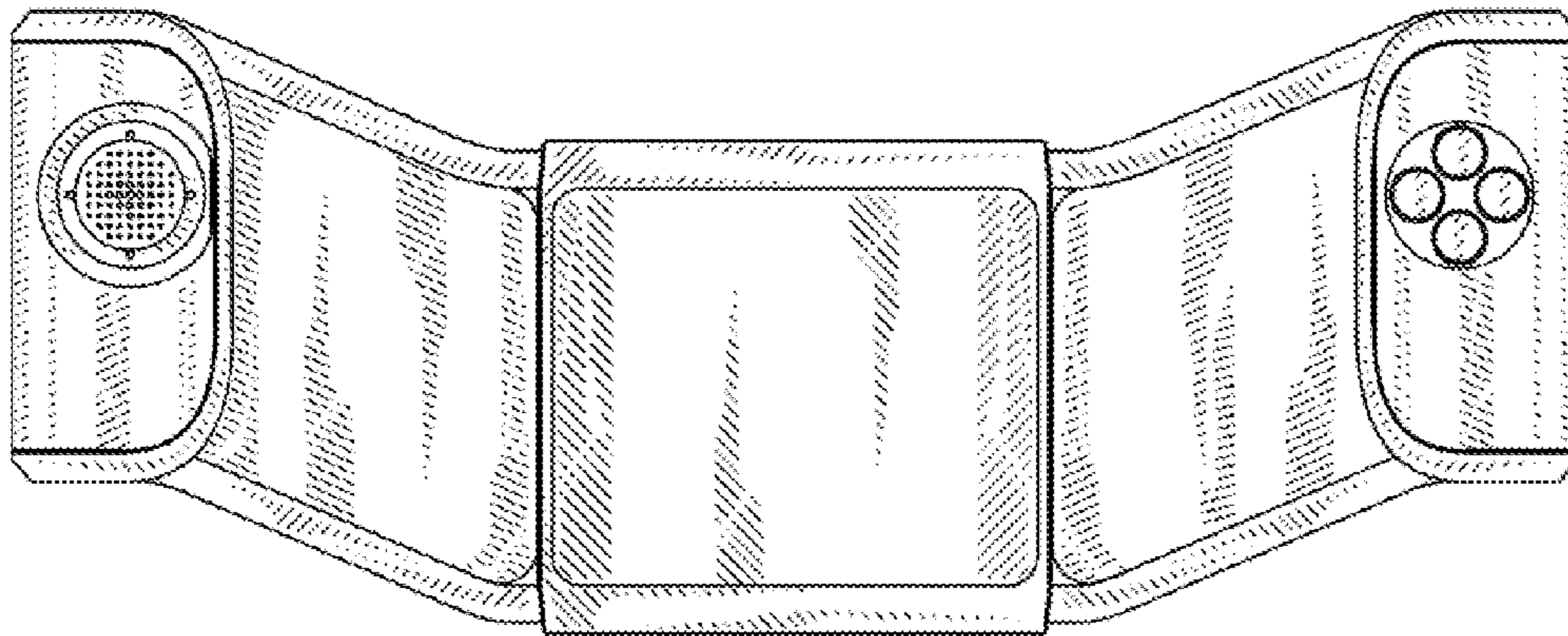

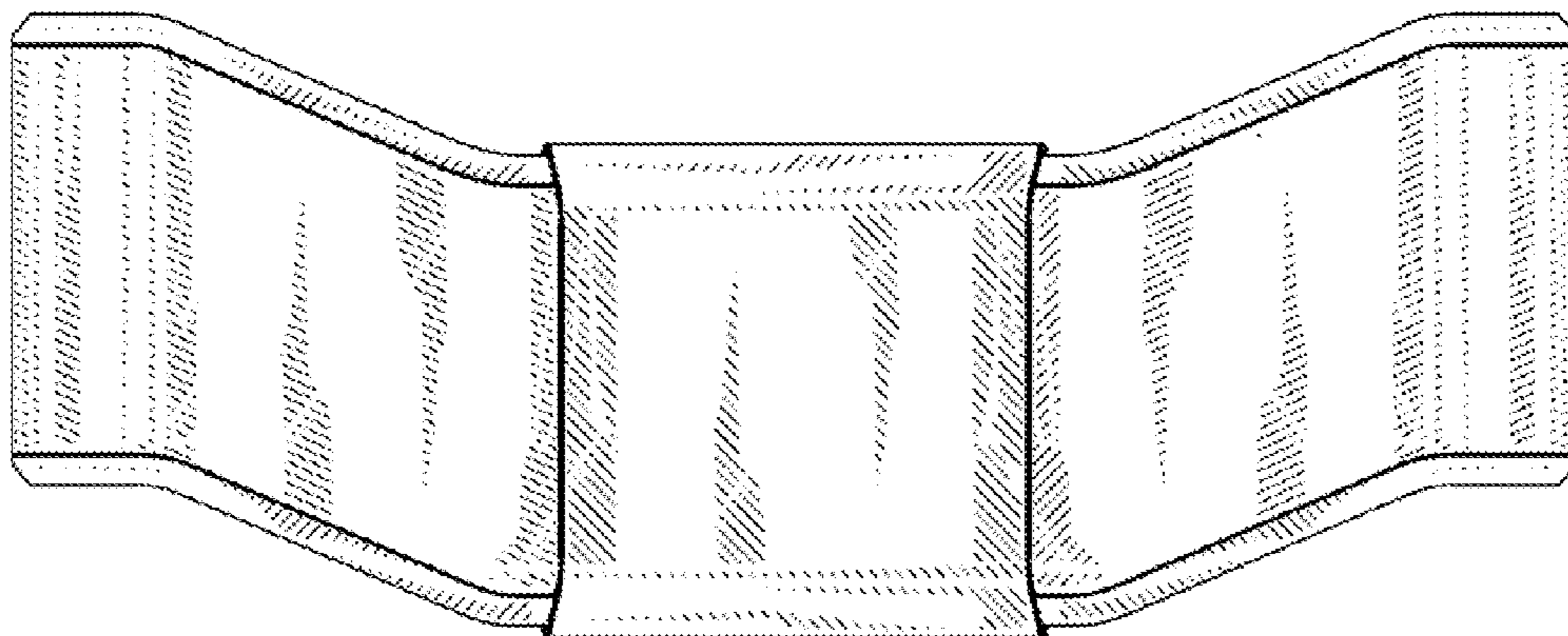

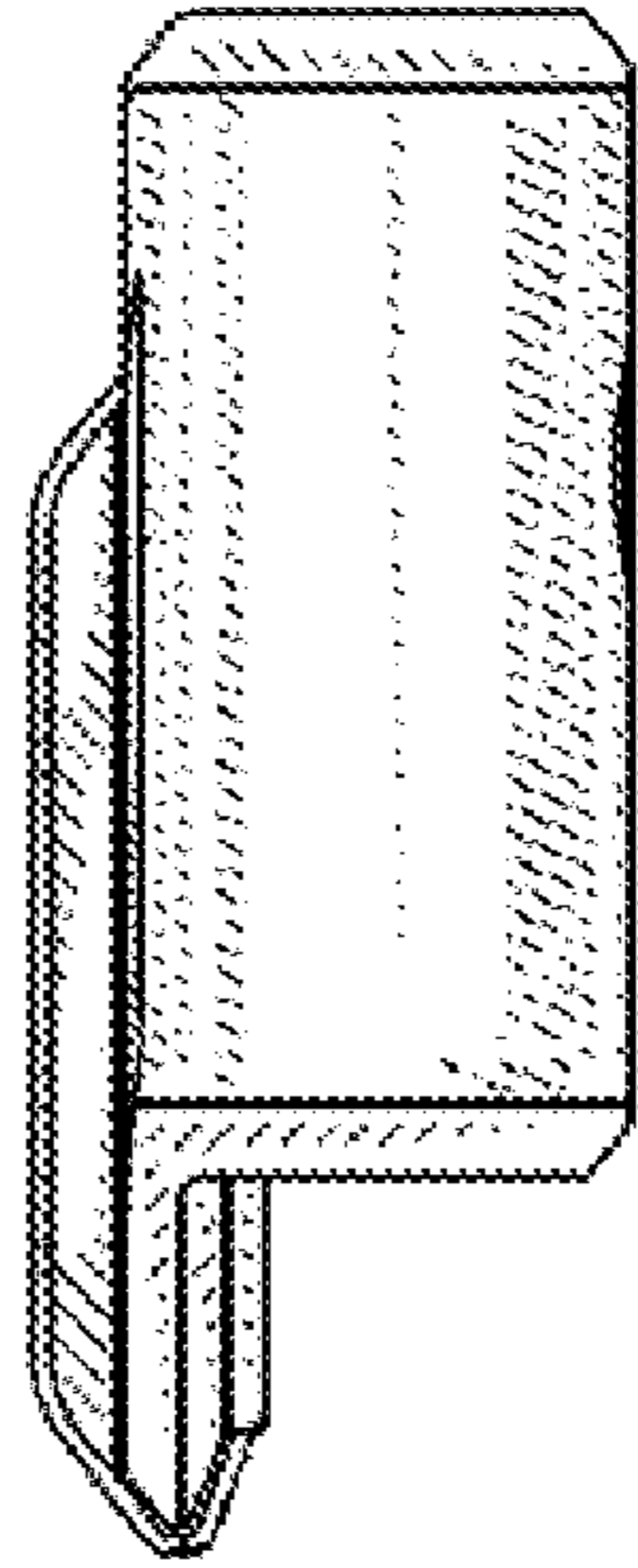

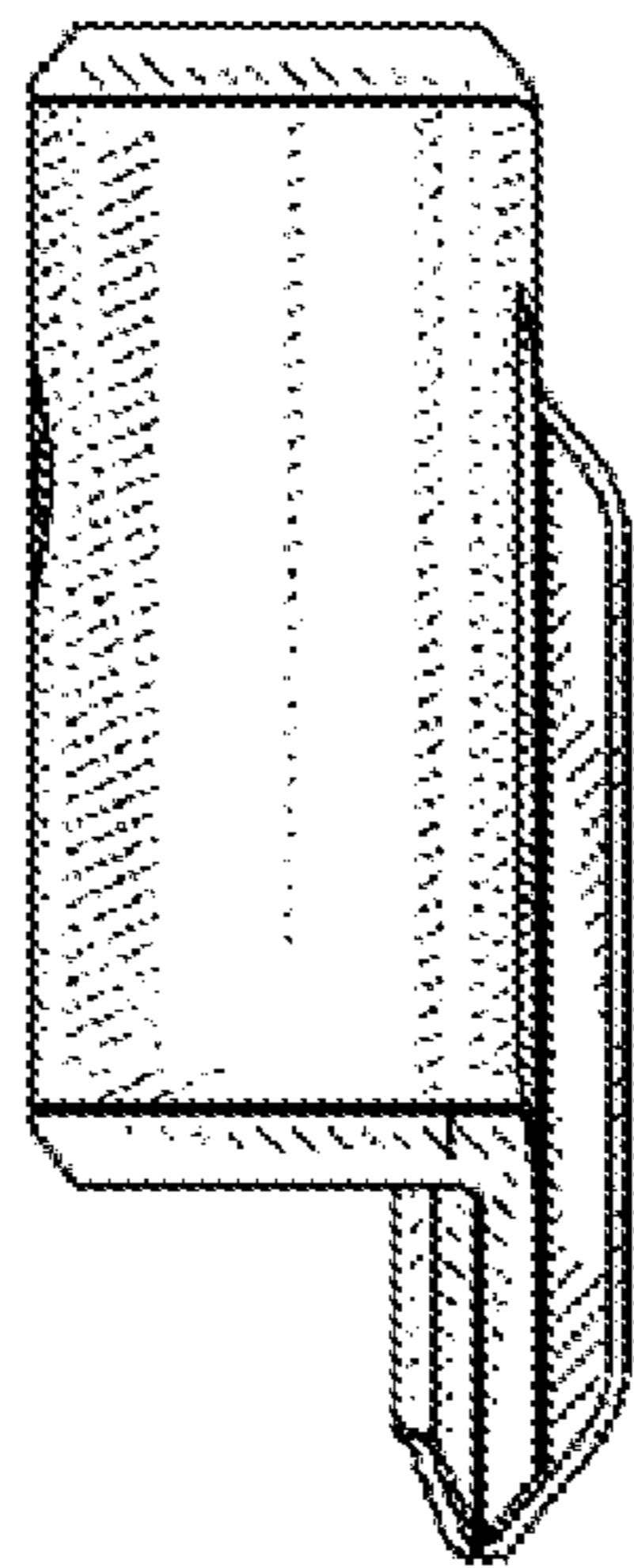

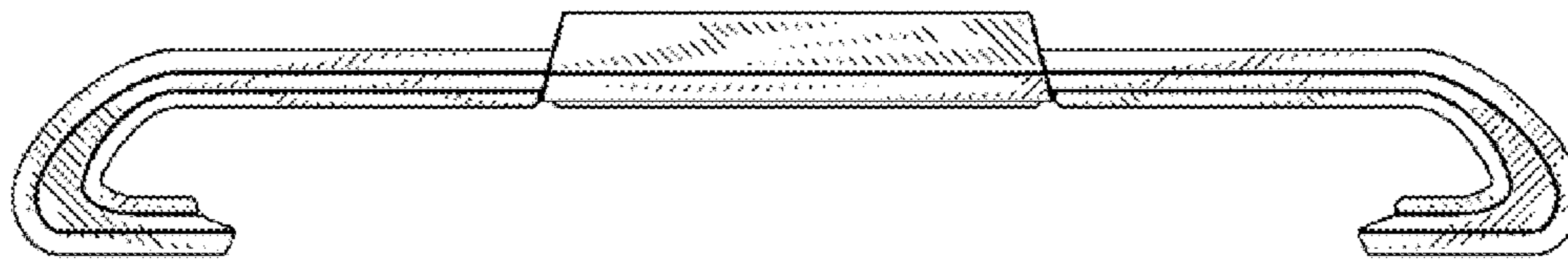

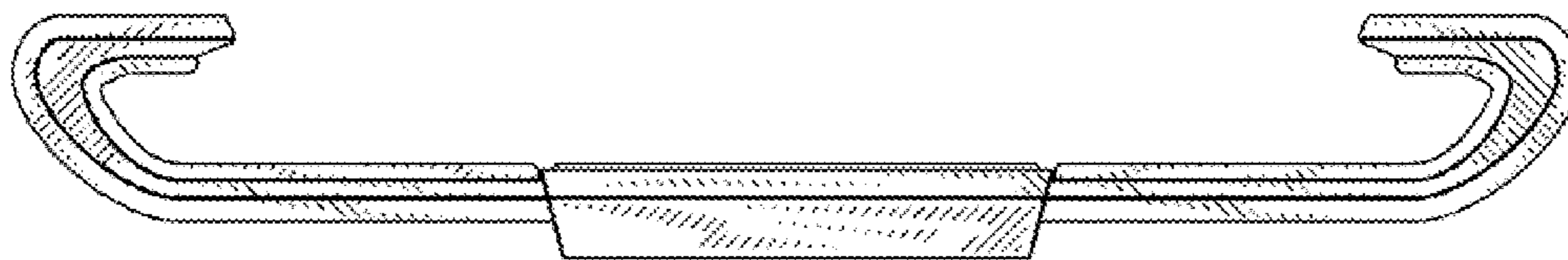

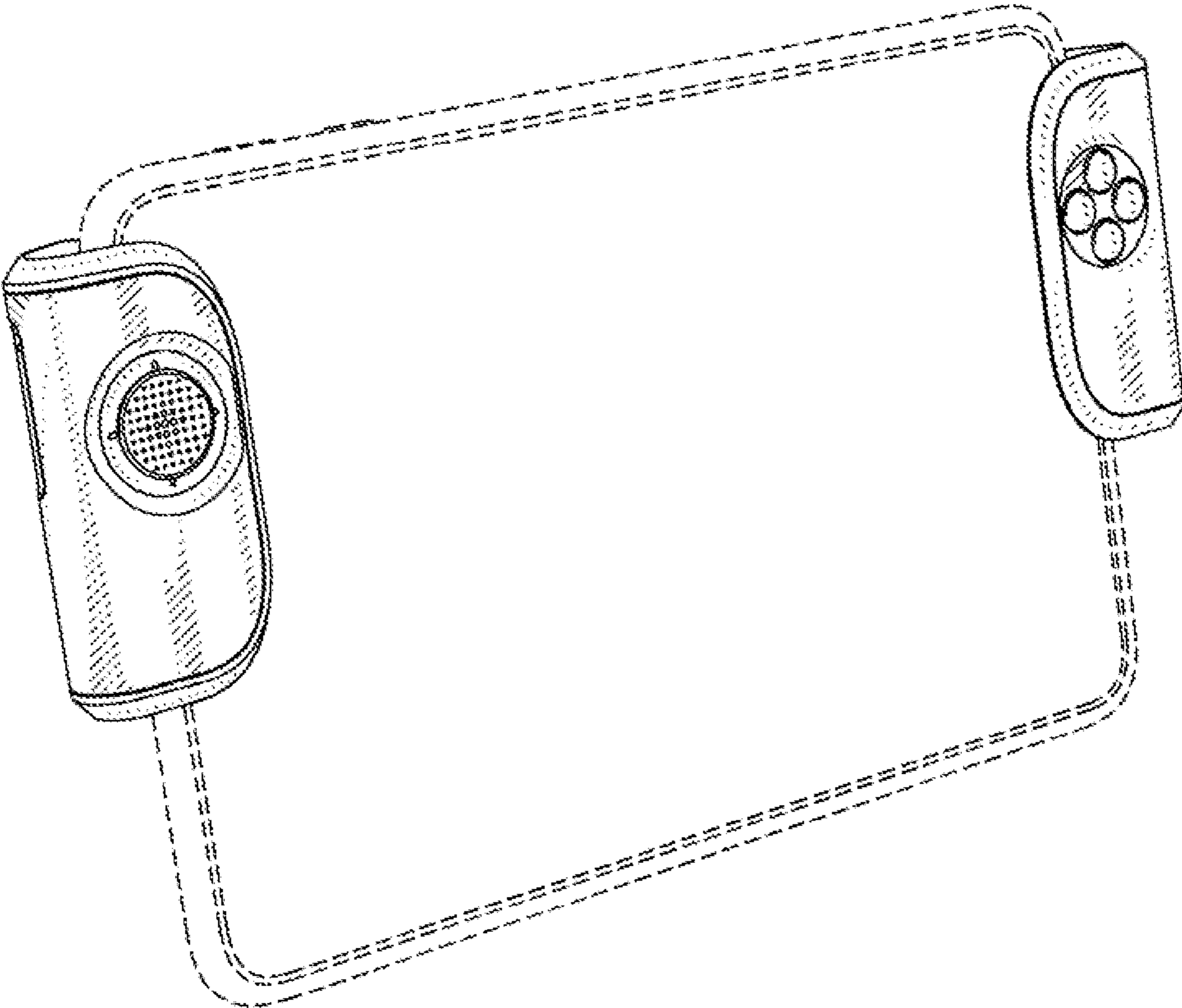

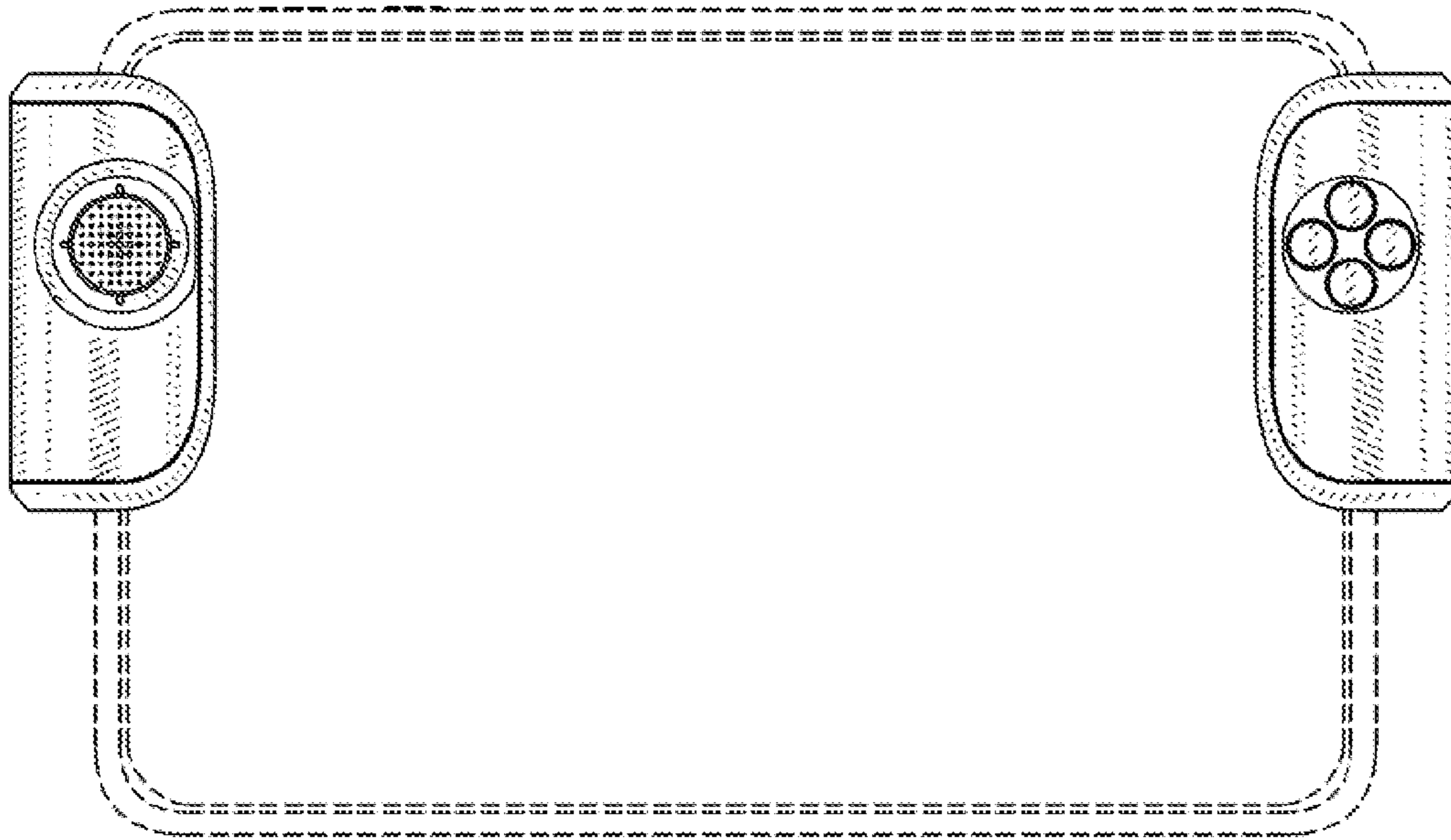

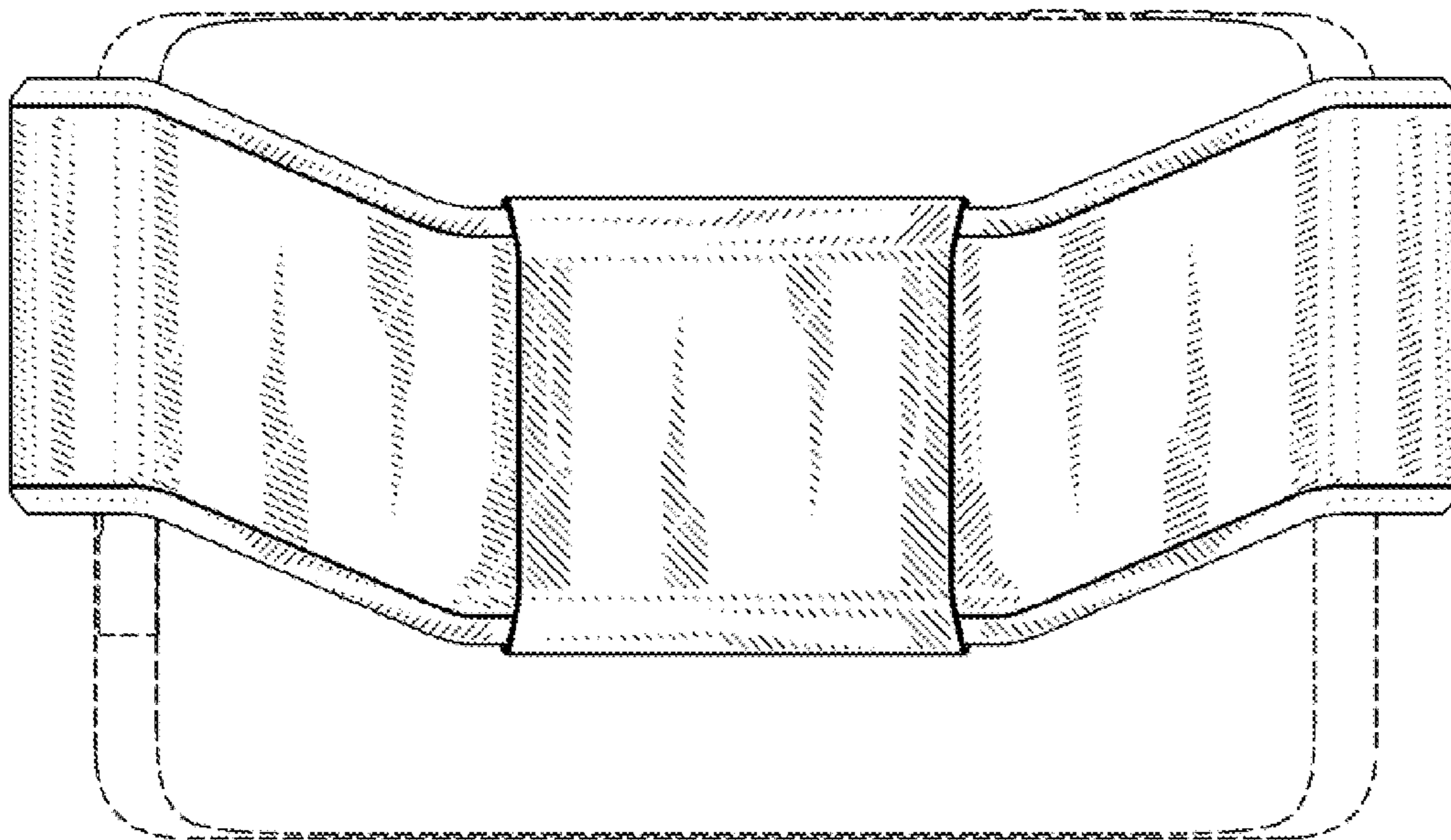

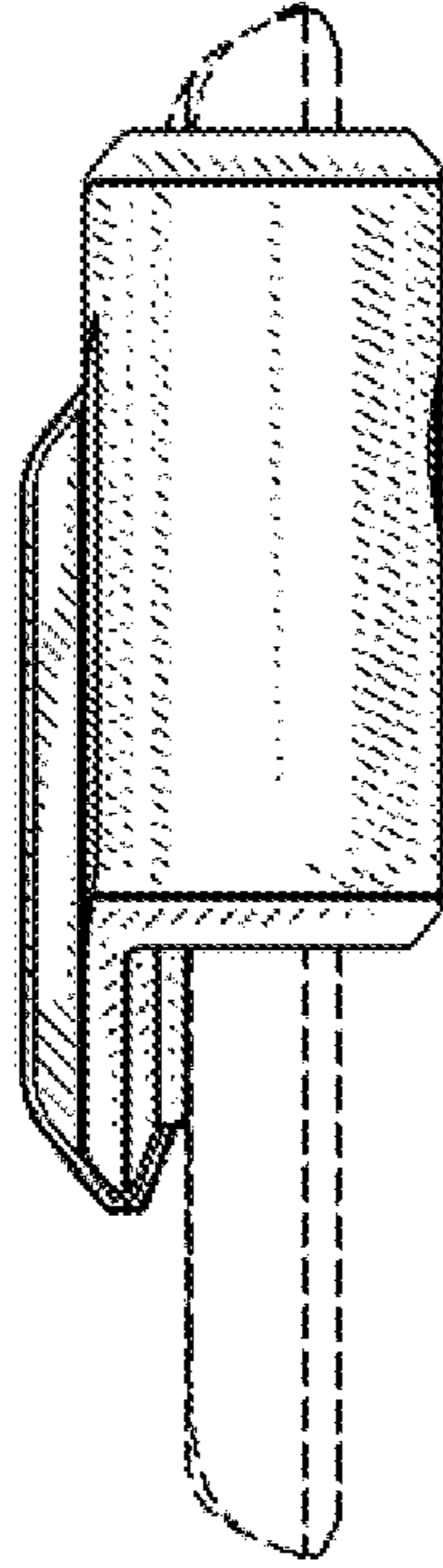

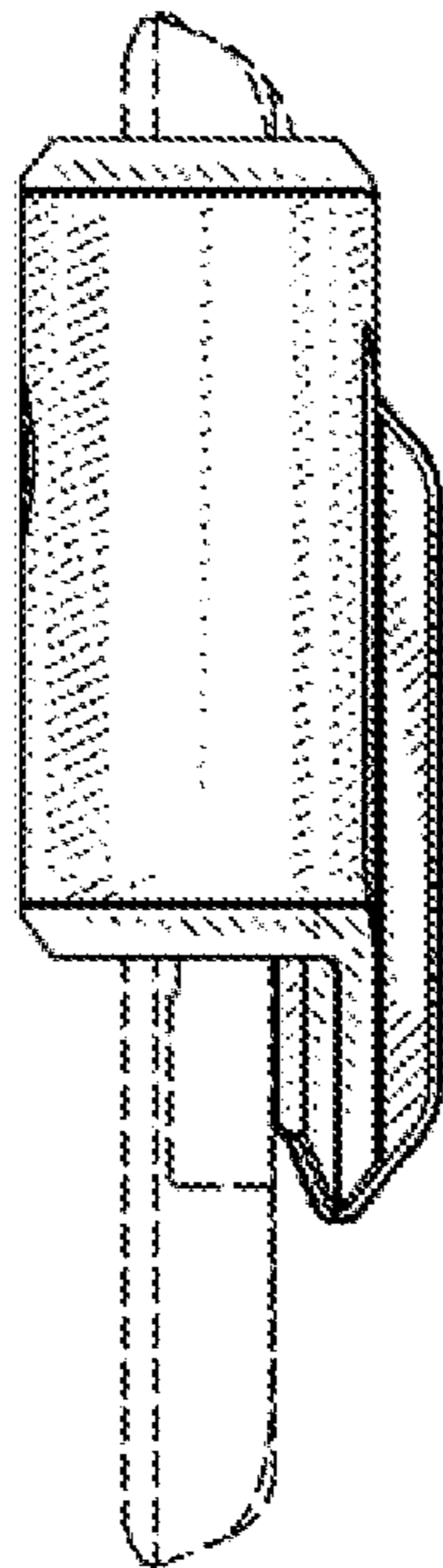

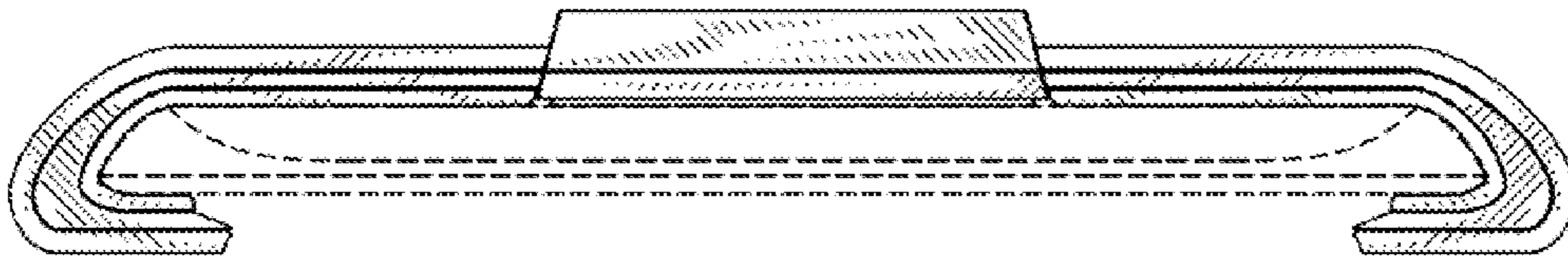

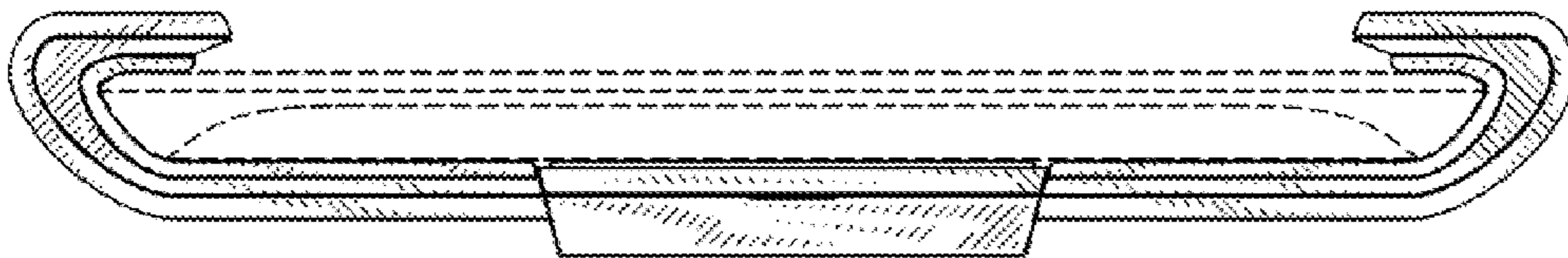
