(57) **CLAIM**

An ornamental design for a plush fairy, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a front view of a plush fairy in accordance with an exemplary embodiment. The broken lines on the clothing represent stitching;

FIG. 2 is a back view of the plush fairy of FIG. 1 illustrating the back pocket on the dress of the plush fair;

FIG. 3 is a left side view of the plush fairy of FIG. 1 with the plush fairy facing left;

FIG. 4 is a right side view of the plush fairy of FIG. 1 with the plush fairy facing right;

FIG. 5 is a top view of the plush fairy of FIG. 1 with the plush fairy facing toward the top of the page. The top edge of the back pocket is viewable on the backside of the dress of the plush fairy;

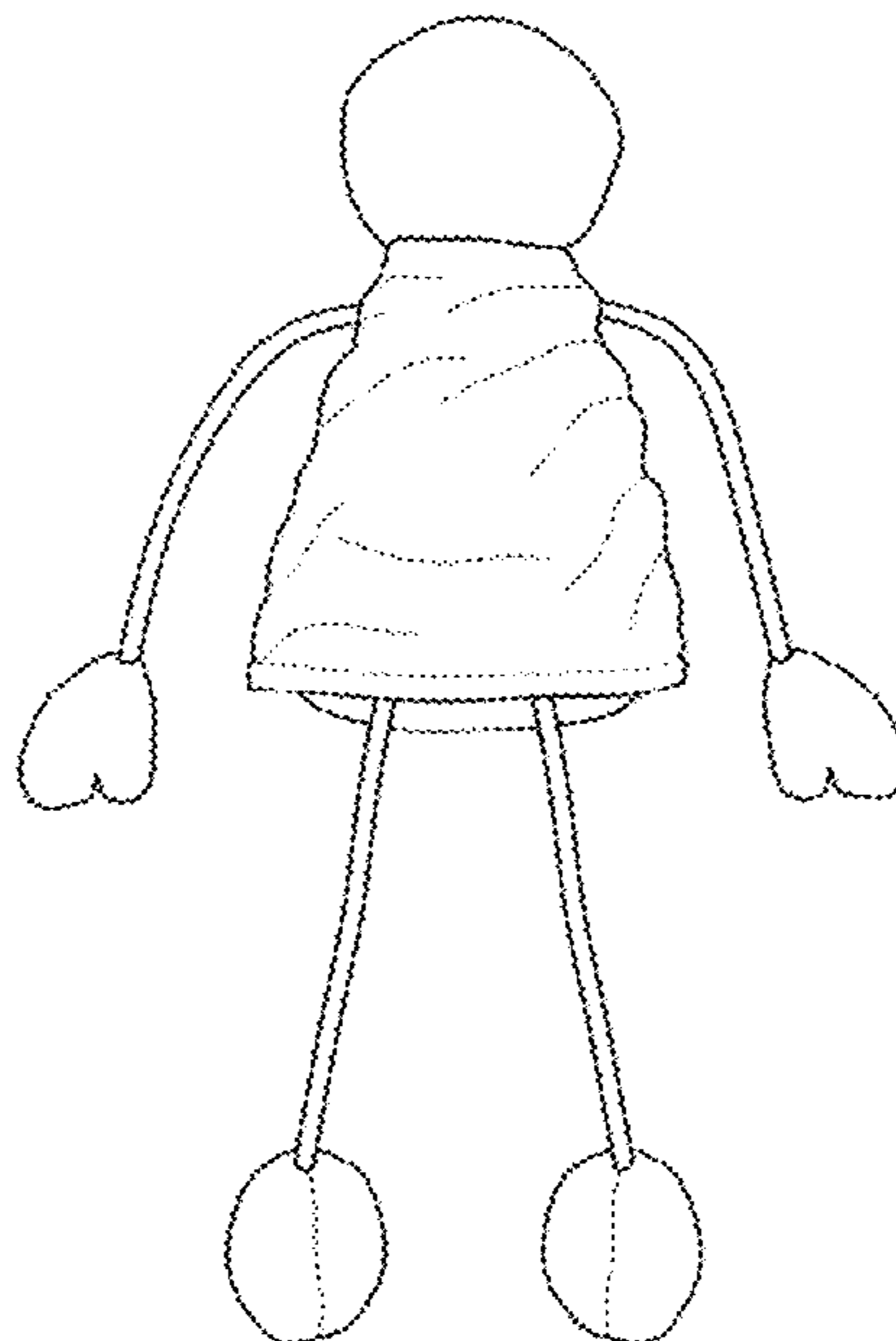
FIG. 6 is a bottom view of the plush fairy of FIG. 1 with the plush fairy facing toward the bottom of the page. The hem of the dress illustrates the fold of the hem, the stitching of the hem, and the edge of the dress material;

FIG. 7 is a perspective view of the plush fairy of FIG. 1;

FIG. 8 is a perspective view of the plush fairy of FIG. 1 with hair, a face, and wings. The broken lines of the hair, face, and wings indicate that hair, face, and wings are for illustration purposes only and do not form part of the claim; and,

FIG. 9 is a perspective back view of the plush fairy of FIG. 1 with hair, wings and a card inserted in the back pocket of the dress. The broken lines of the hair, wings, and card indicate that hair, wings, and card are for illustration purposes only and do not form part of the claim.

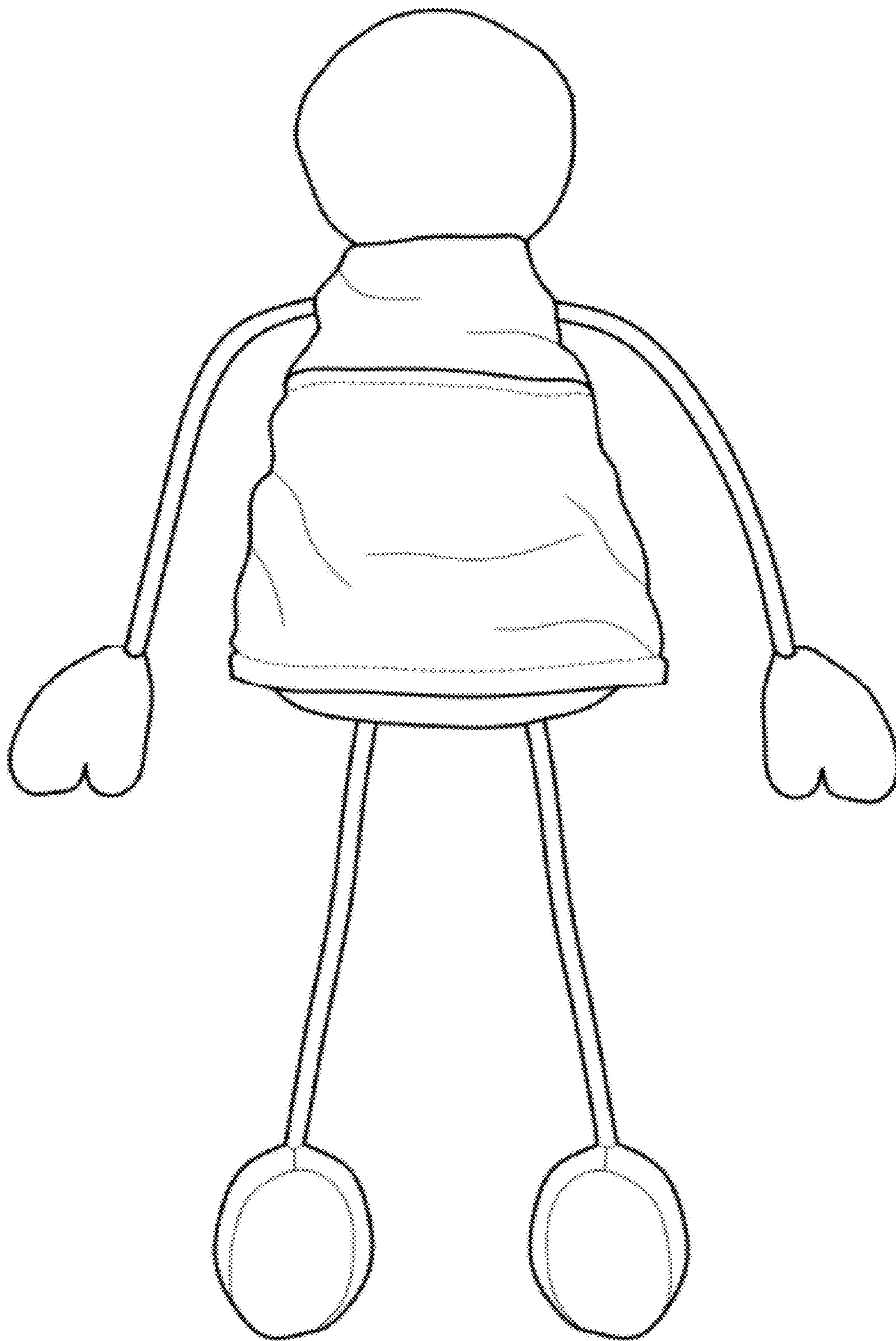

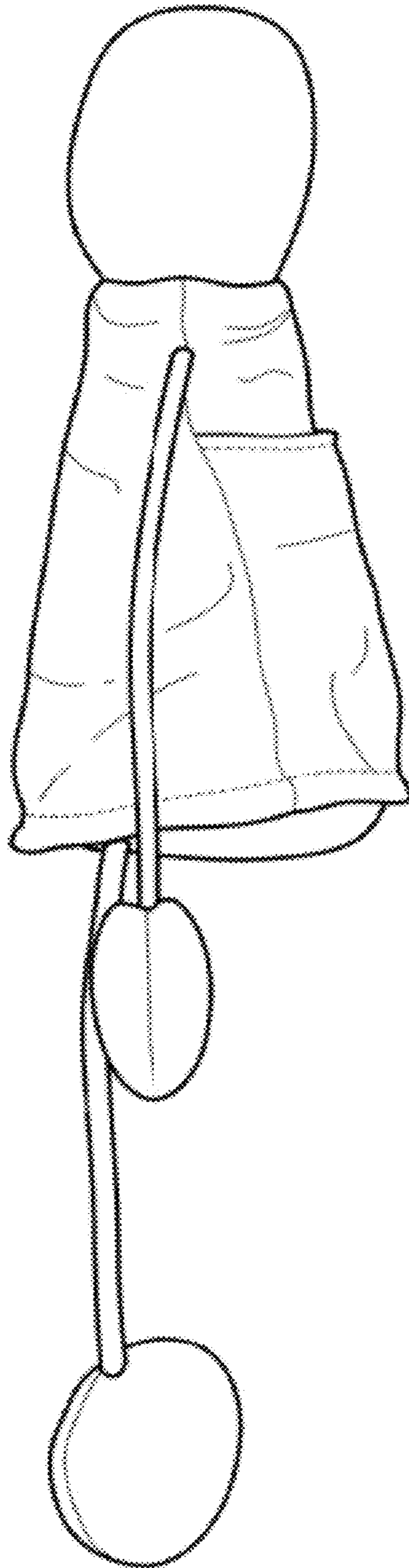

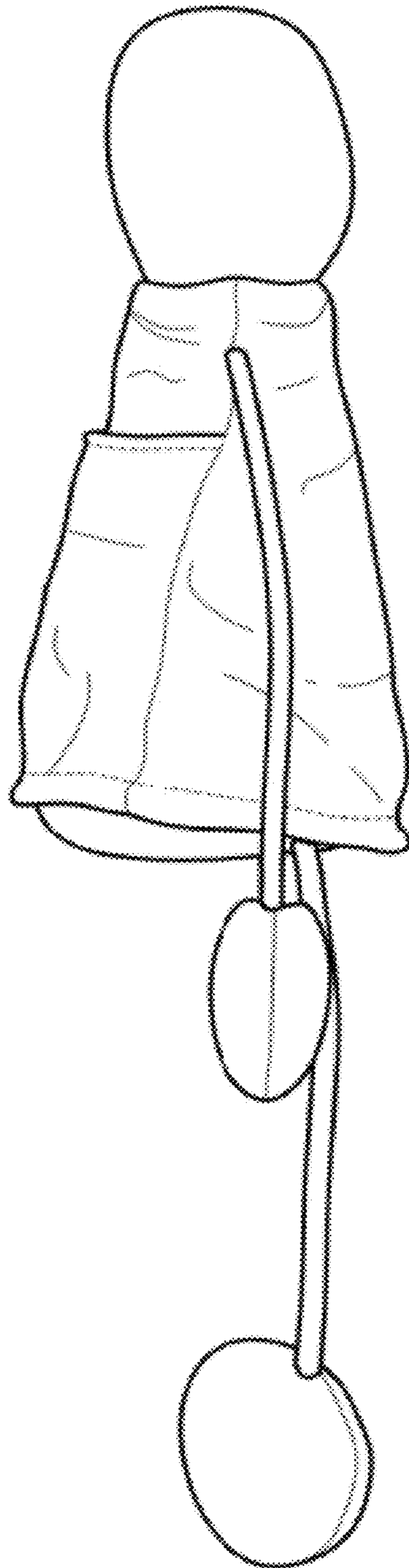

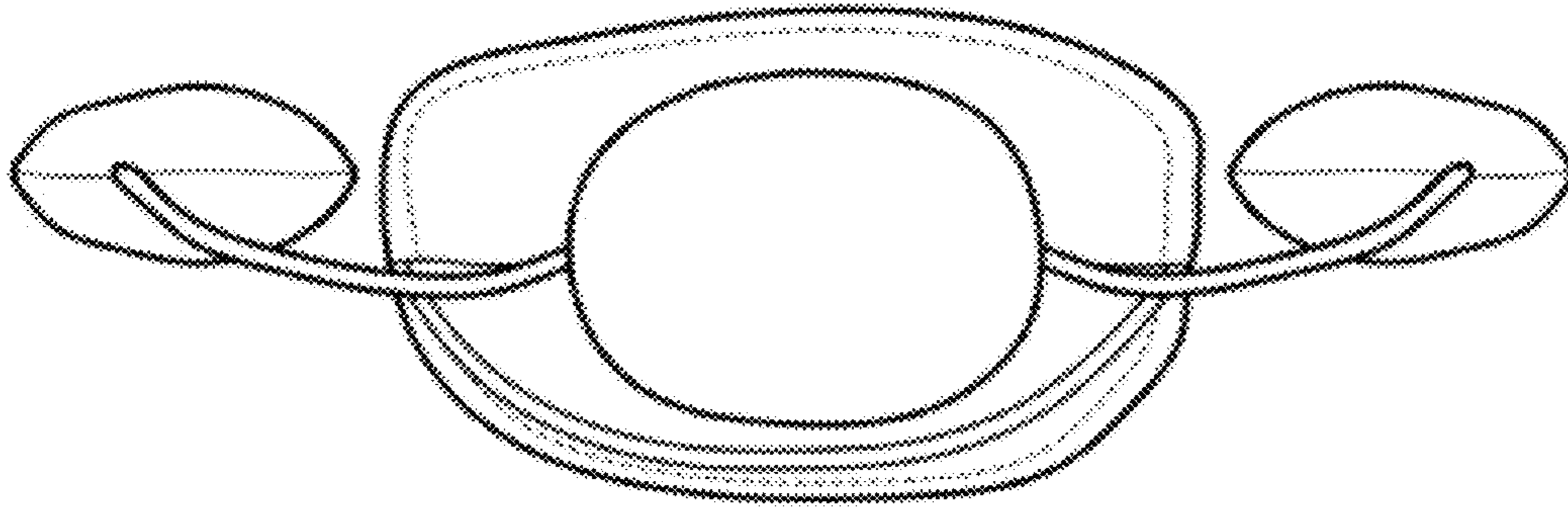

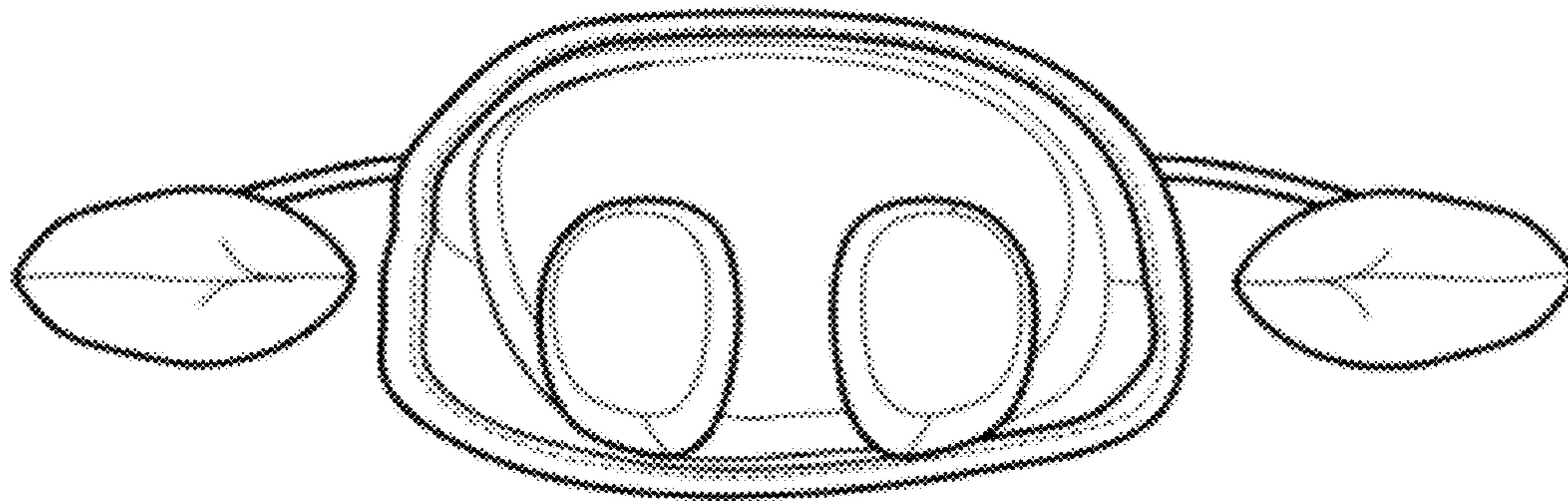
