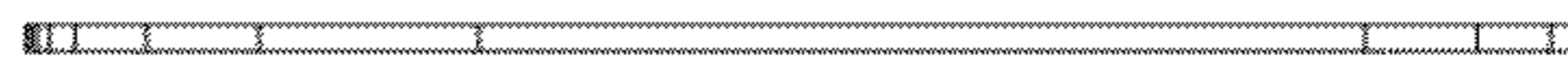
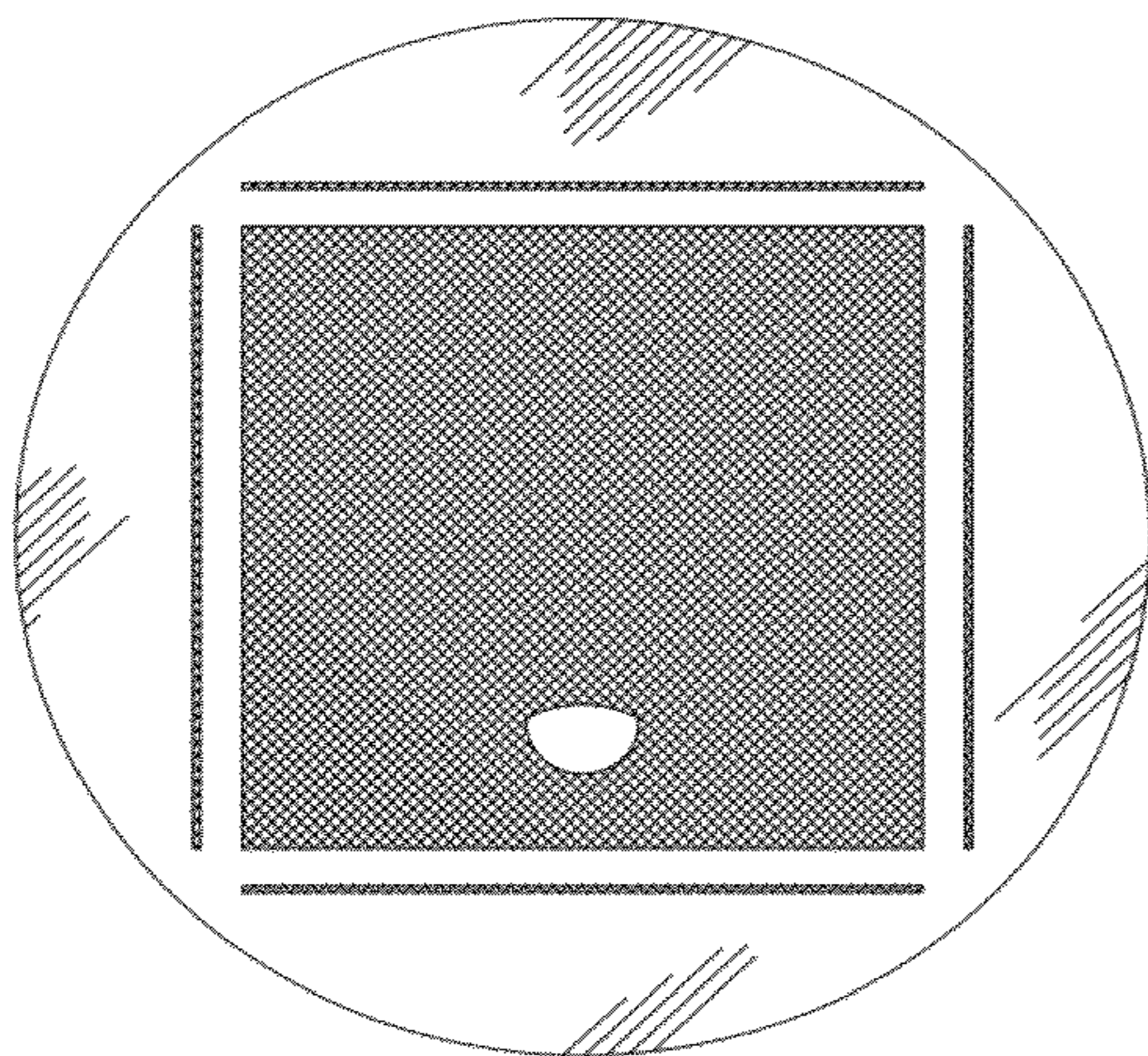
(57) **CLAIM**

The ornamental design for a template, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a template showing my new design; FIG. 2 is a side view of the template, the opposite side being a mirror image thereof; FIG. 3 is a bottom view of the template; and, FIG. 4 is a perspective view of the template. The cross-hatching in the figures denotes the color black.

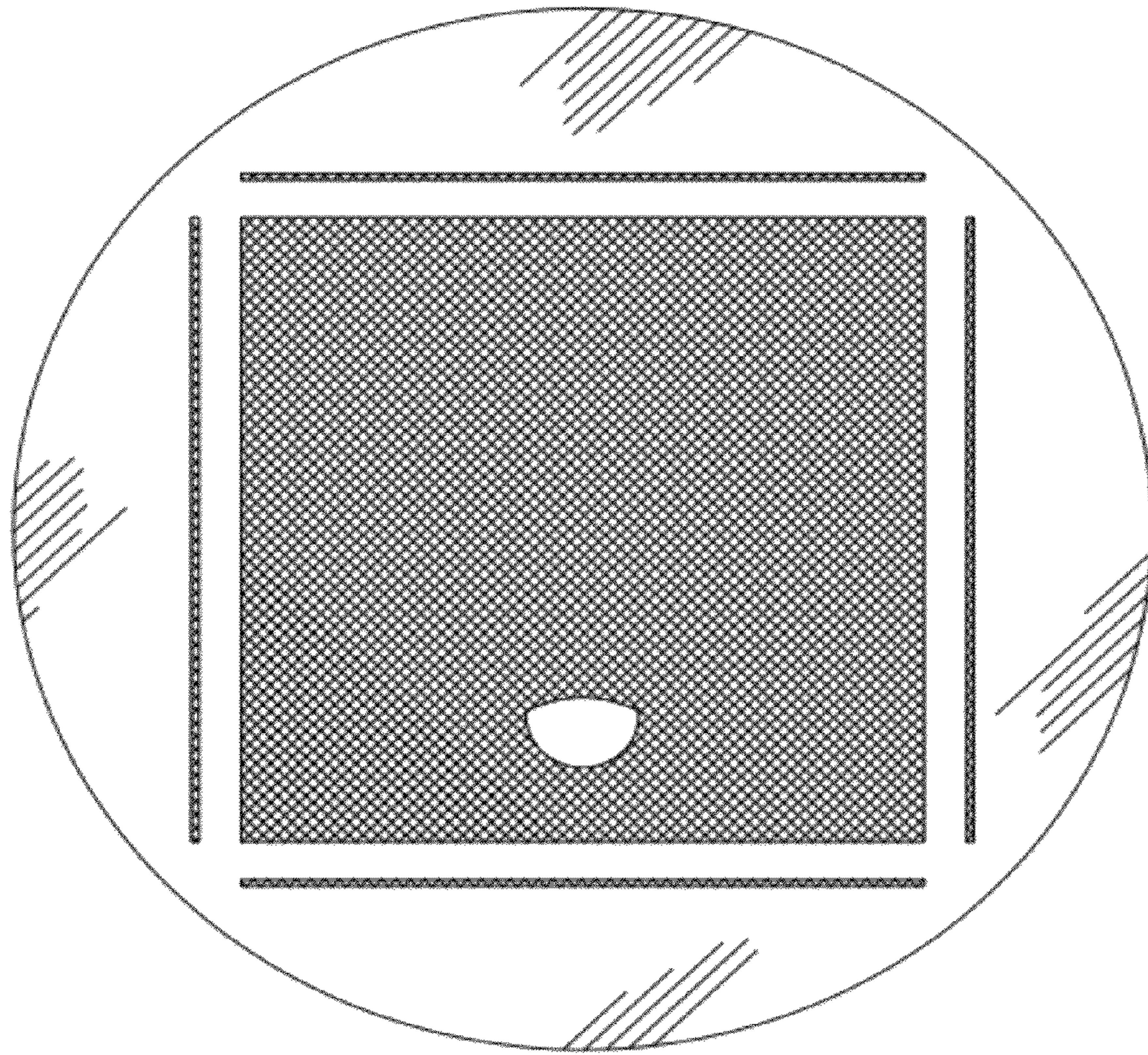

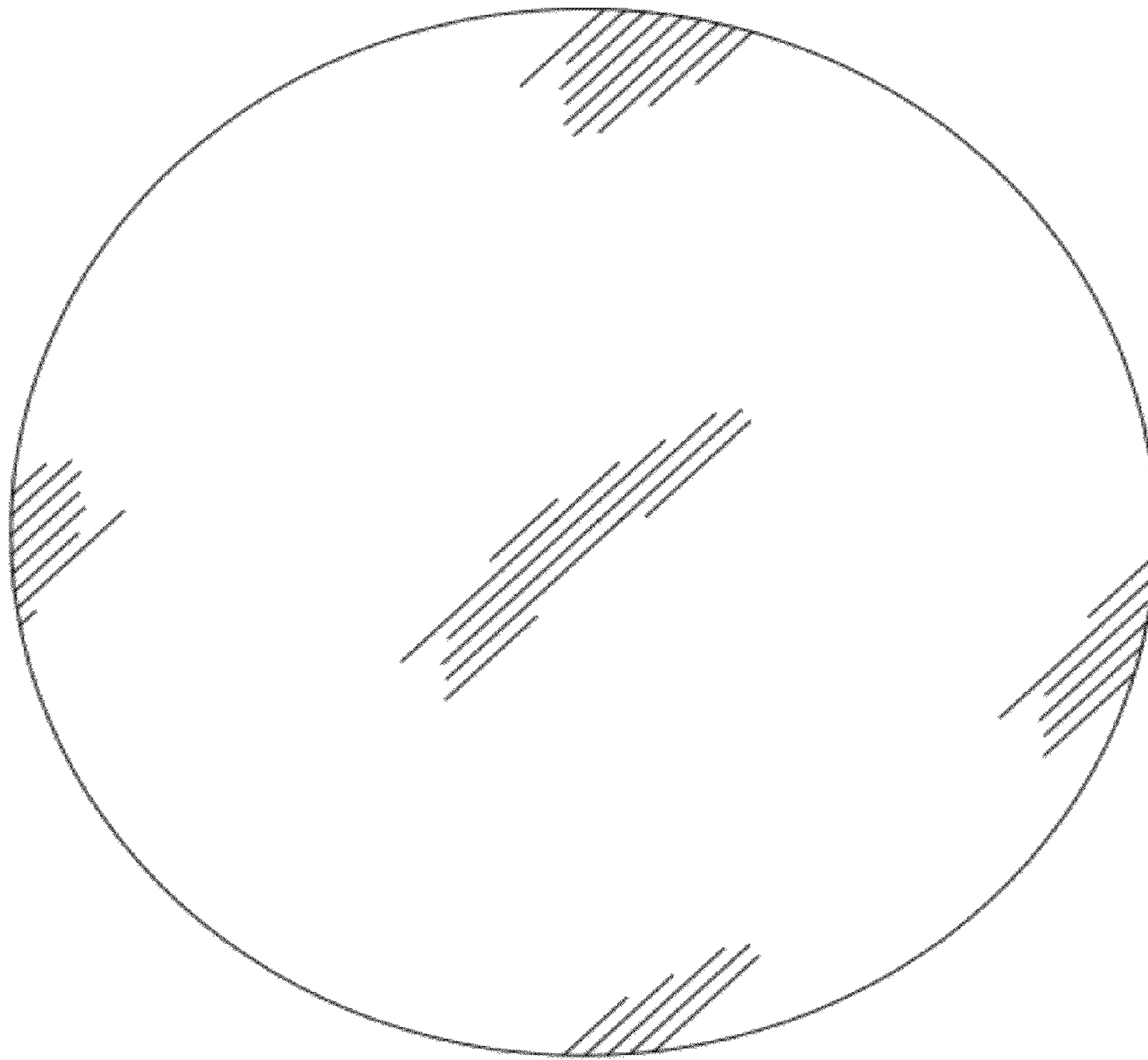

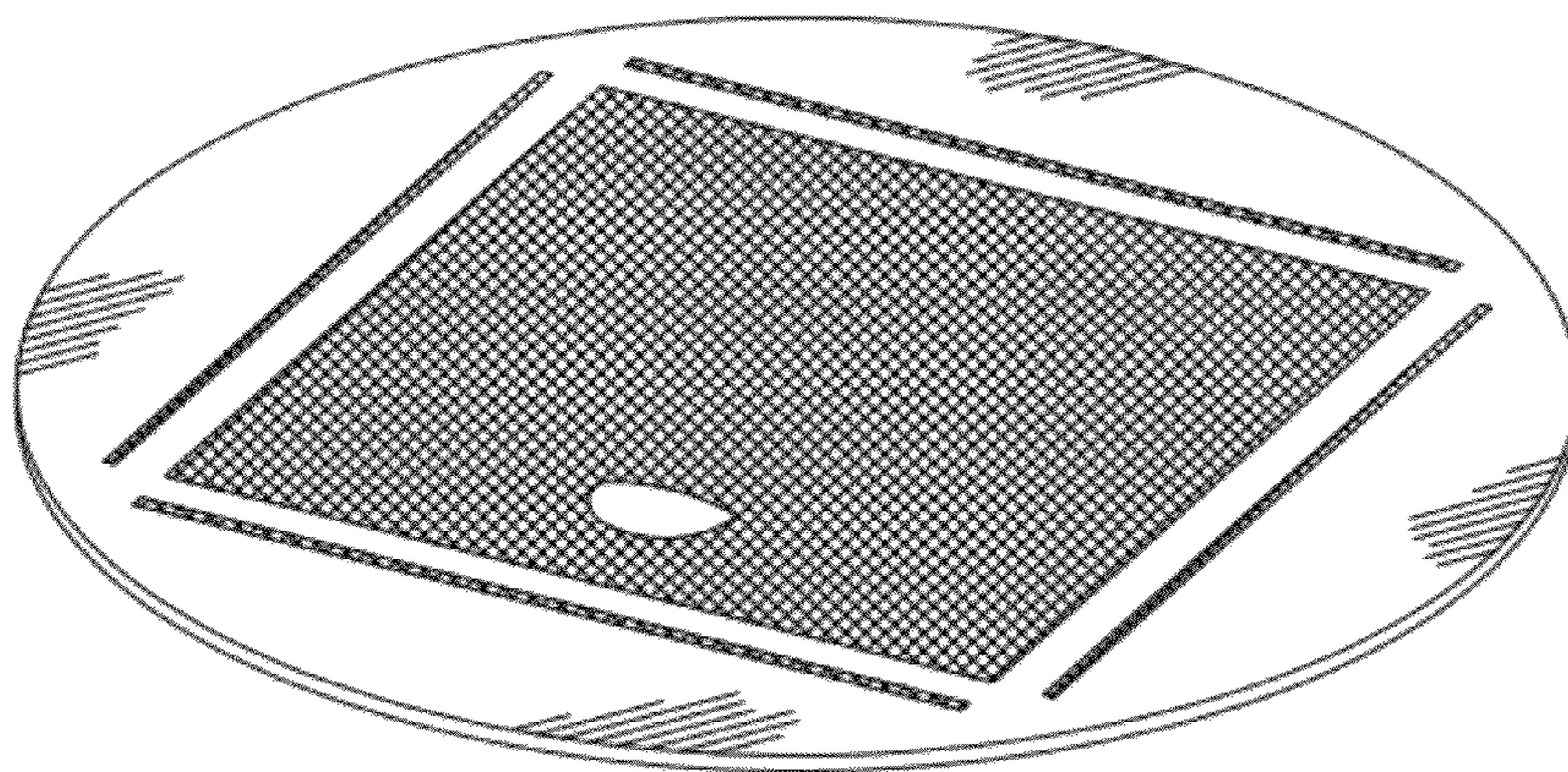
