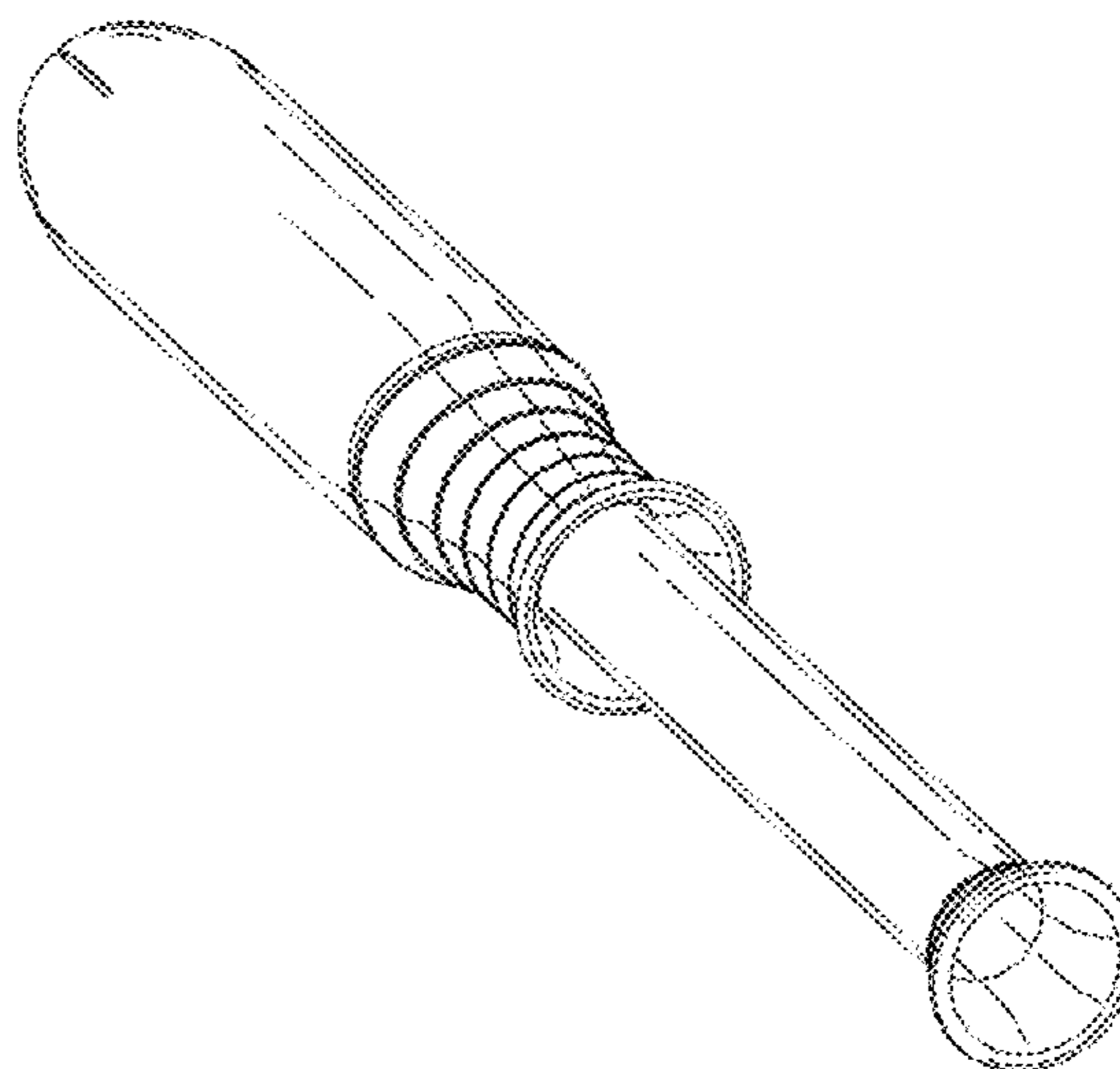
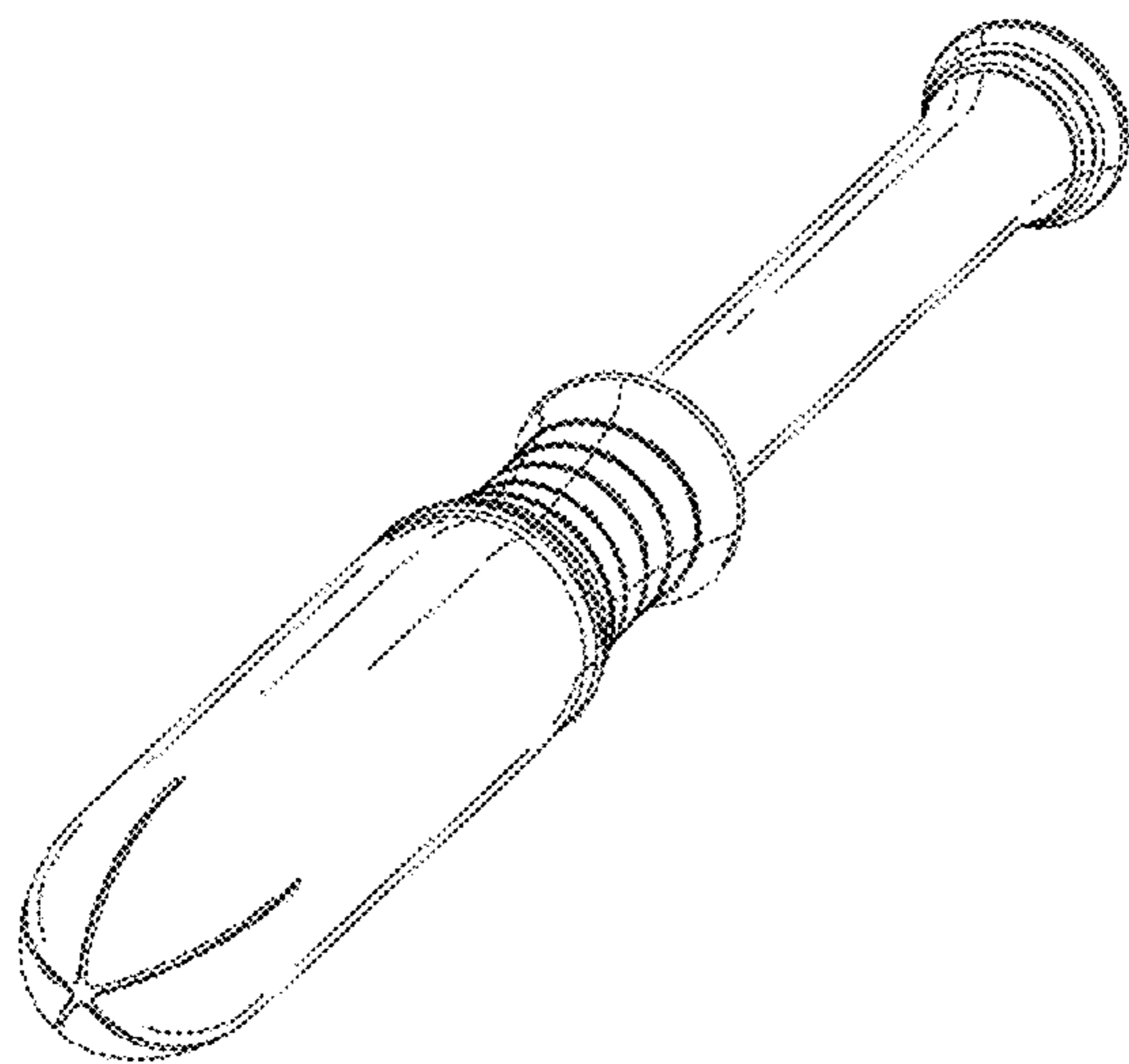
(57) **CLAIM**

The ornamental design for a tampon applicator, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a tampon applicator showing the new design;
FIG. 2 is a front perspective view of the tampon applicator shown in FIG. 1;
FIG. 3 is an enlarged rear elevation view of the tampon applicator shown in FIG. 1;
FIG. 4 is an enlarged front elevation view of the tampon applicator shown in FIG. 1;
FIG. 5 is a top plan view of the tampon applicator shown in FIG. 1; and,
FIG. 6 is a bottom plan view of the tampon applicator shown in FIG. 1.

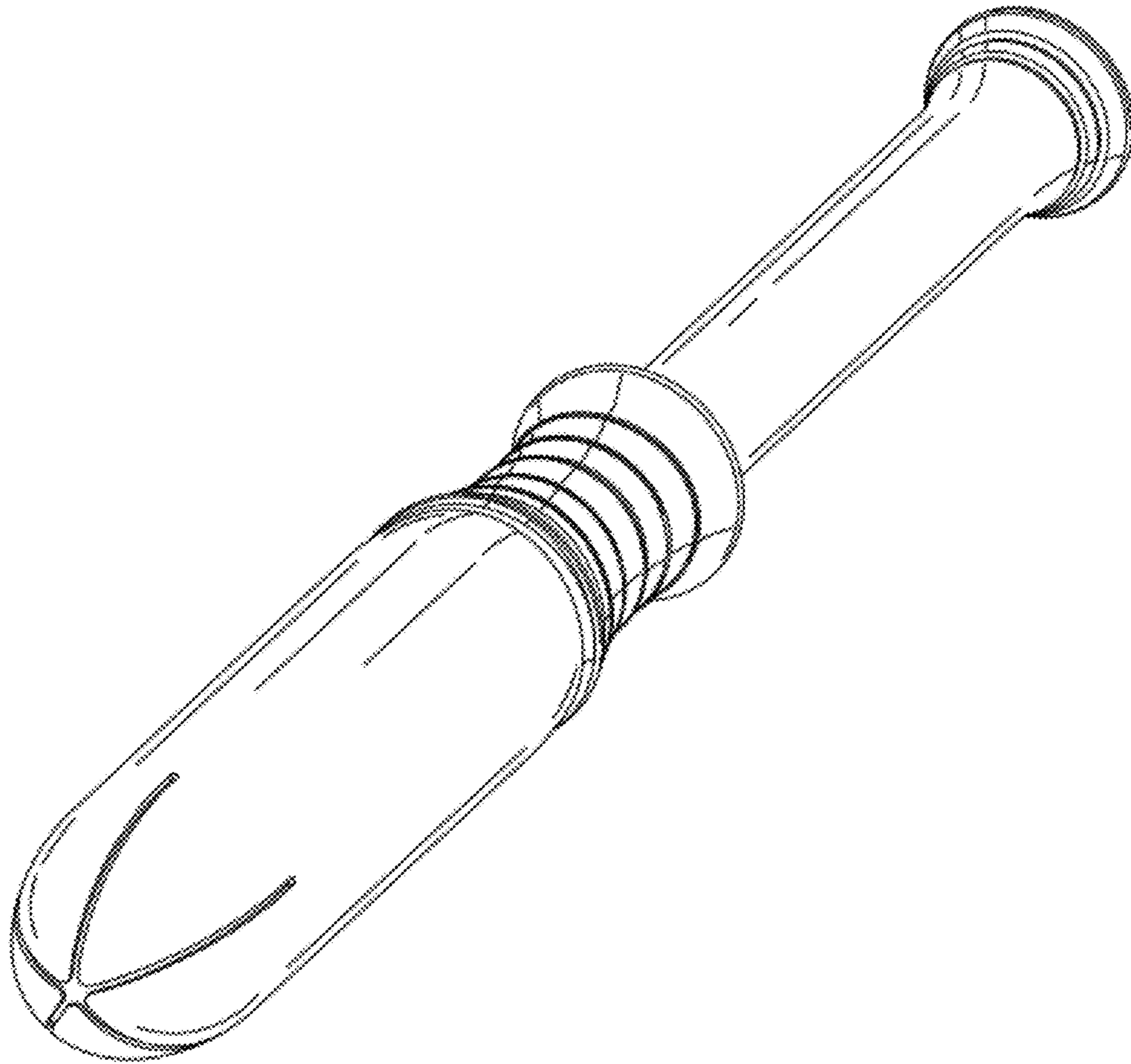

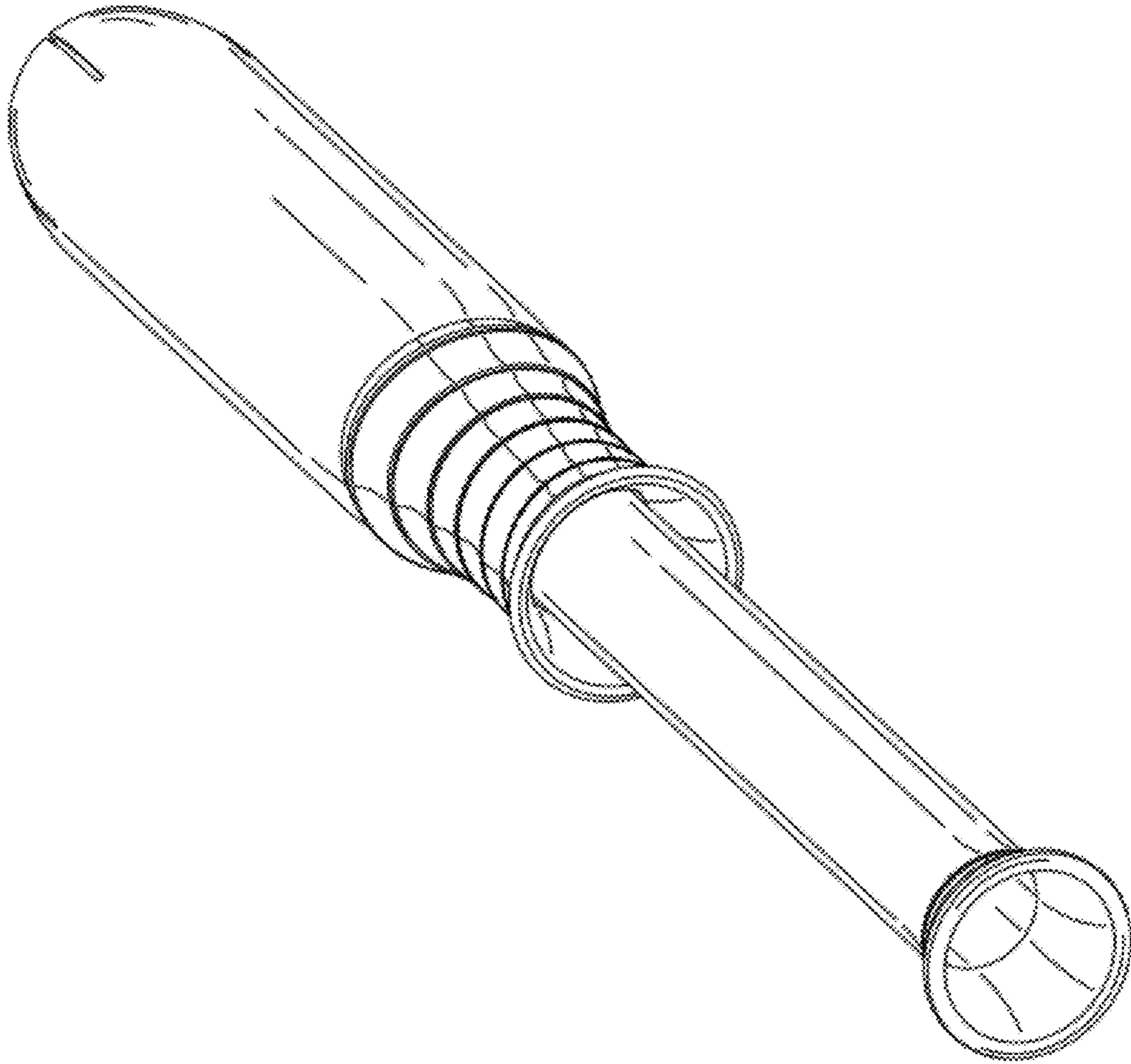

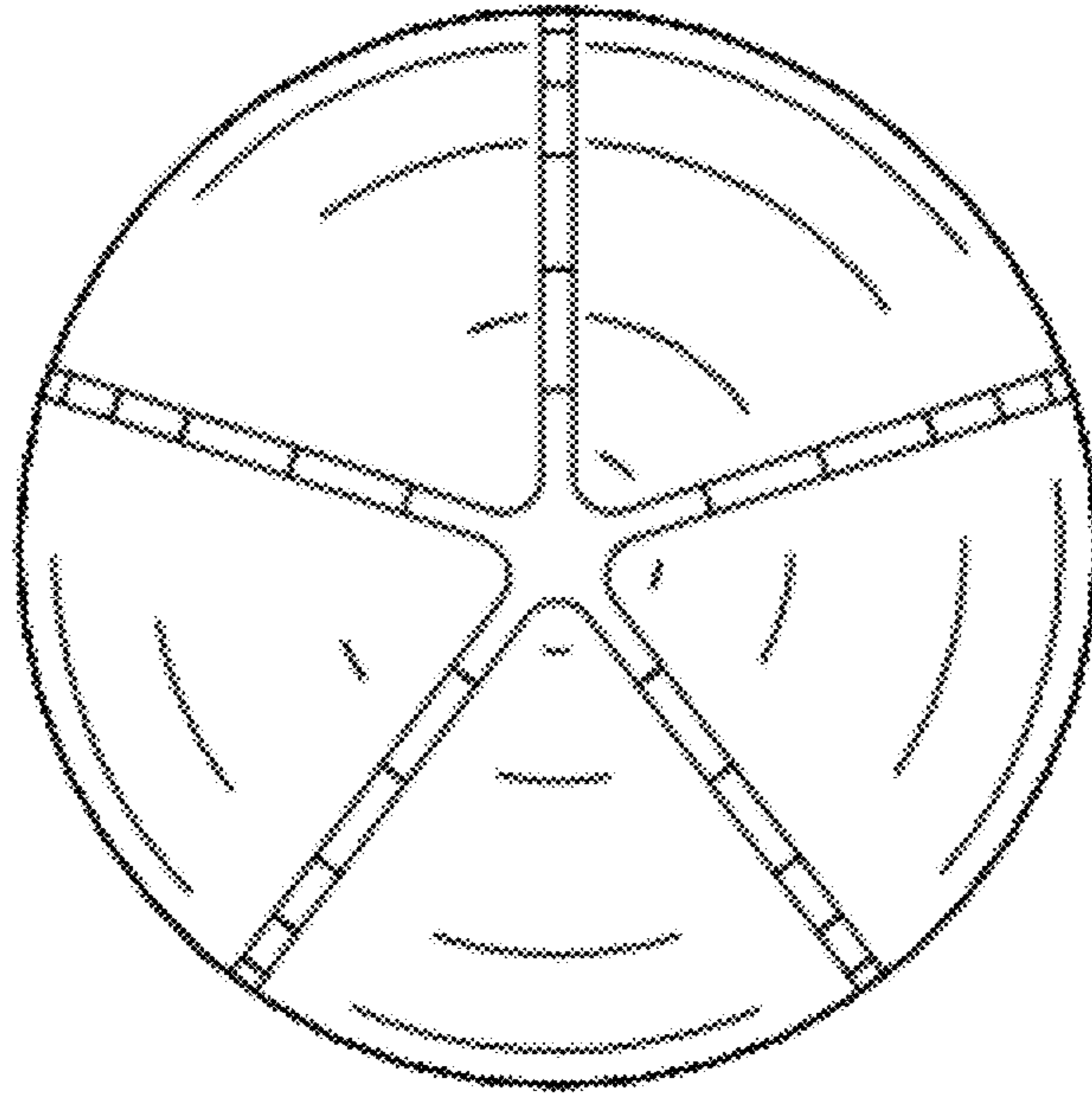

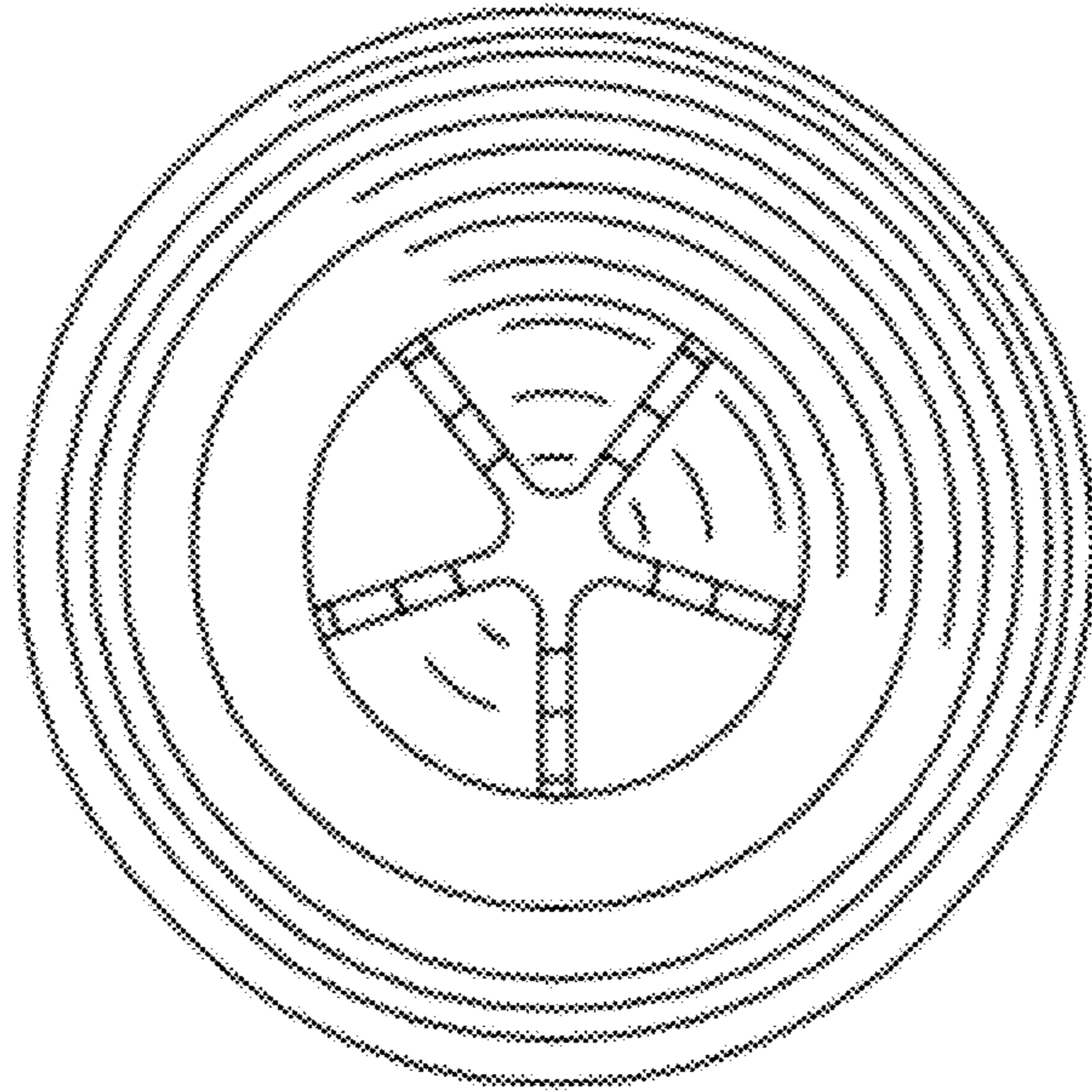

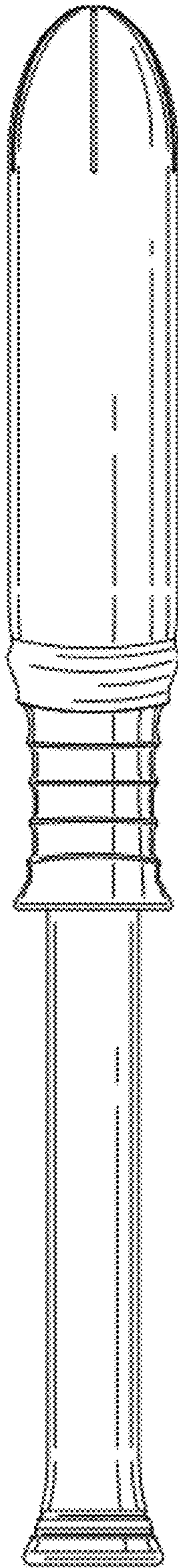

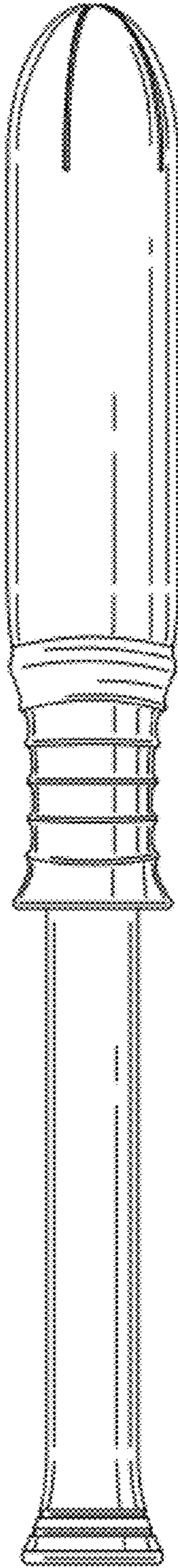
