DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of my design, with the rear elevational view being a mirror image thereof;

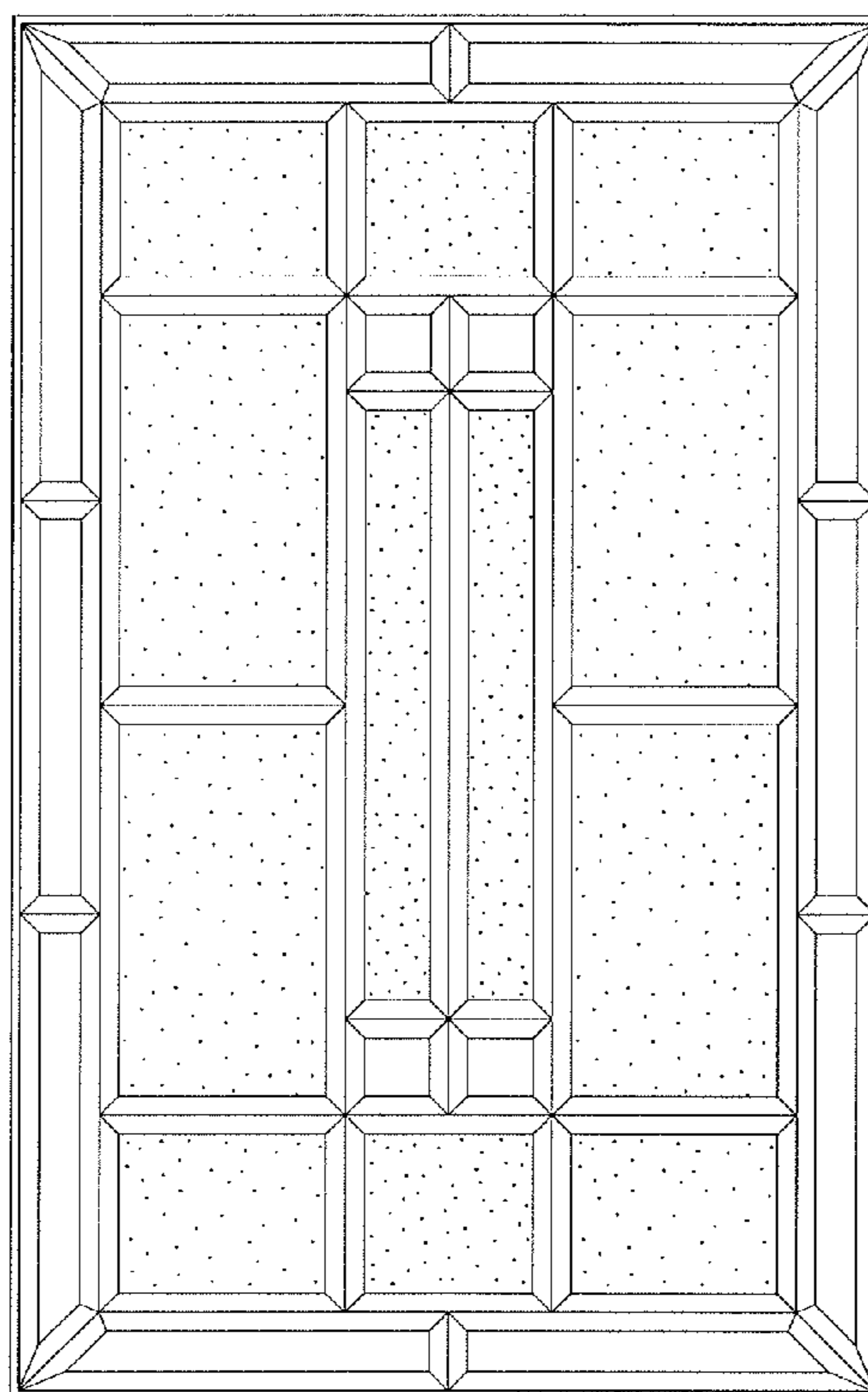

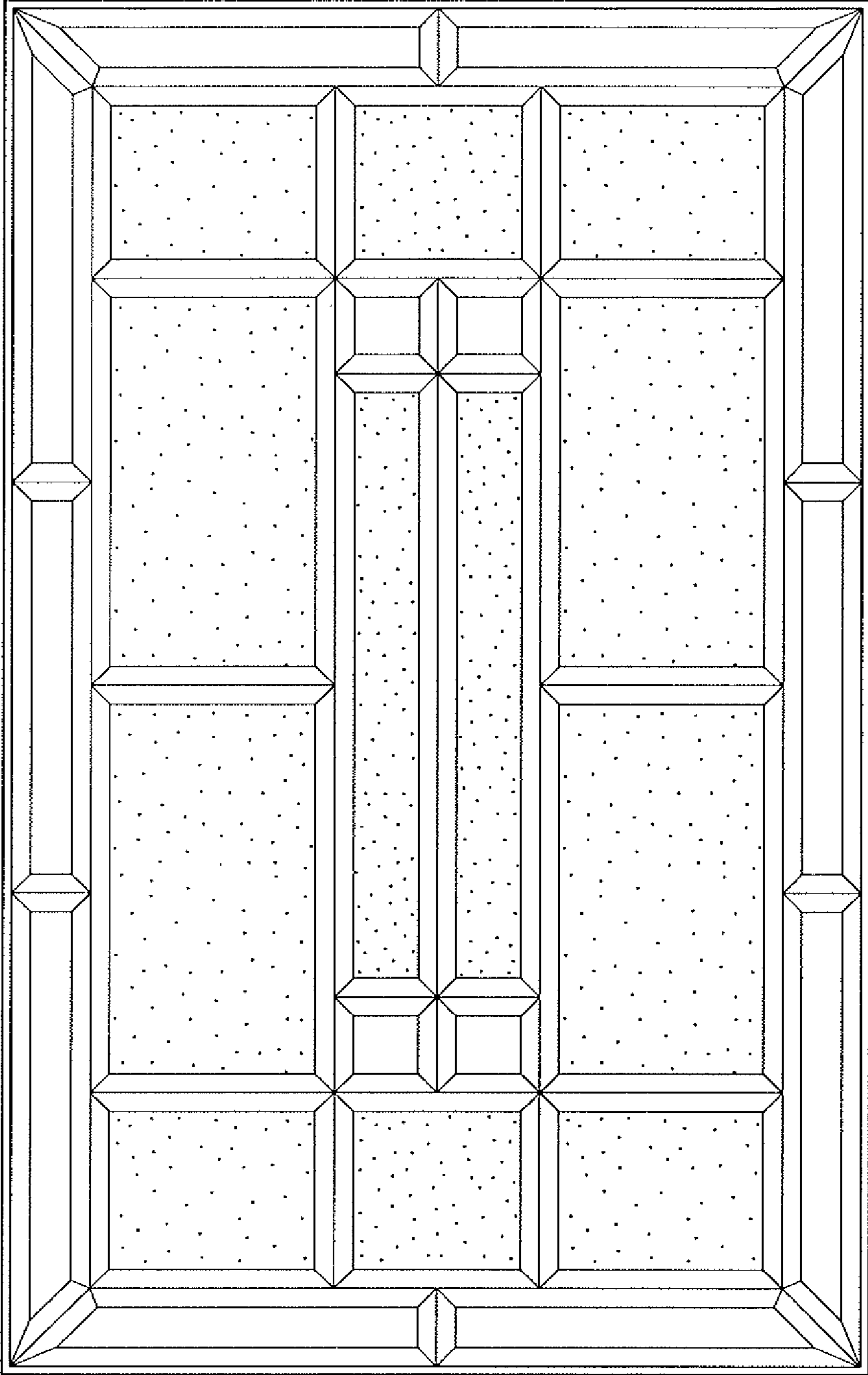

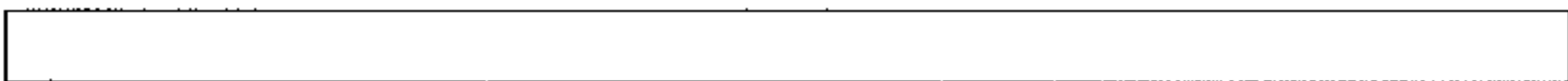

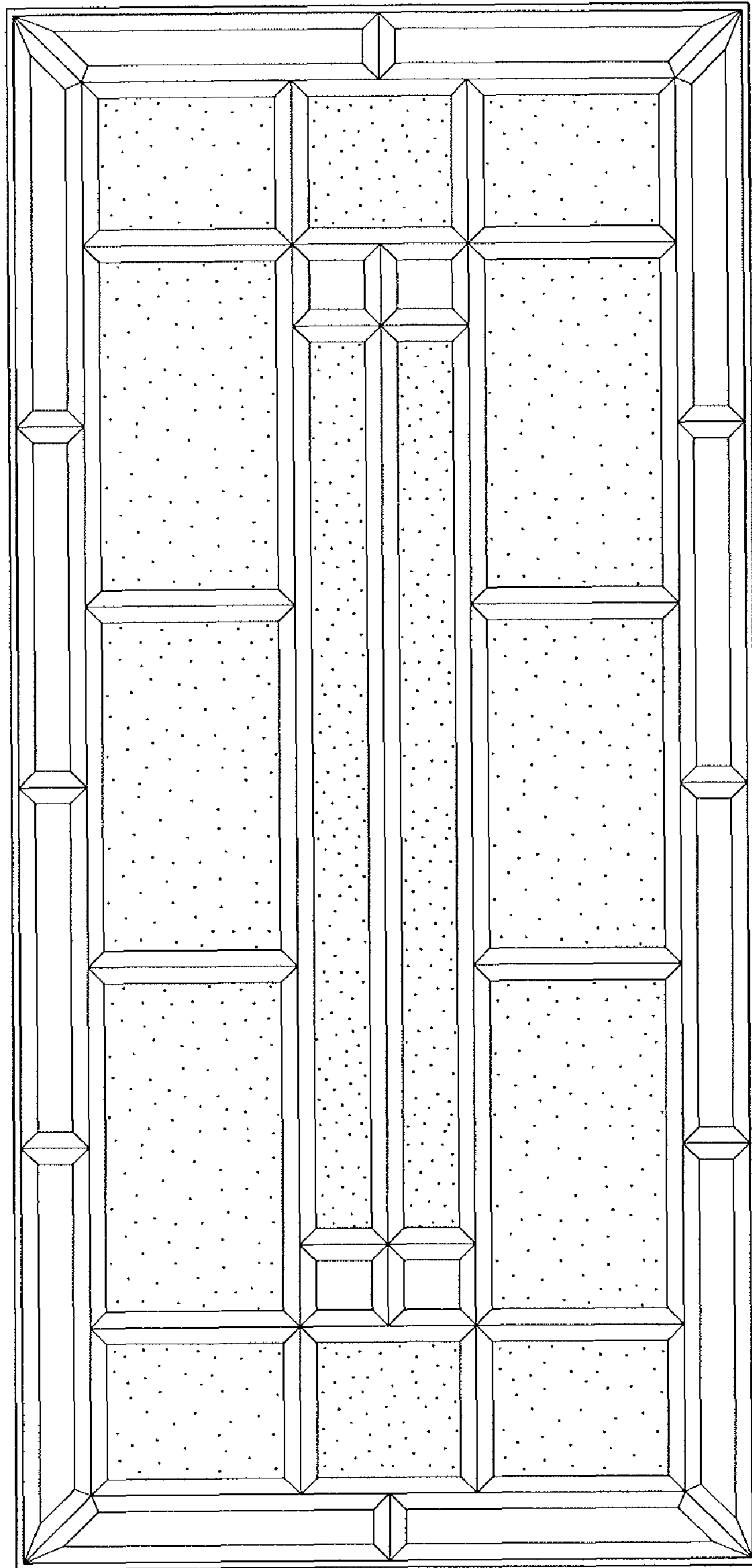

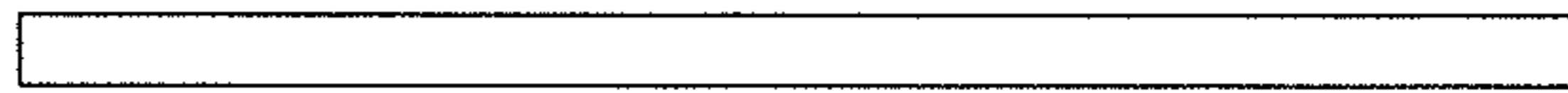

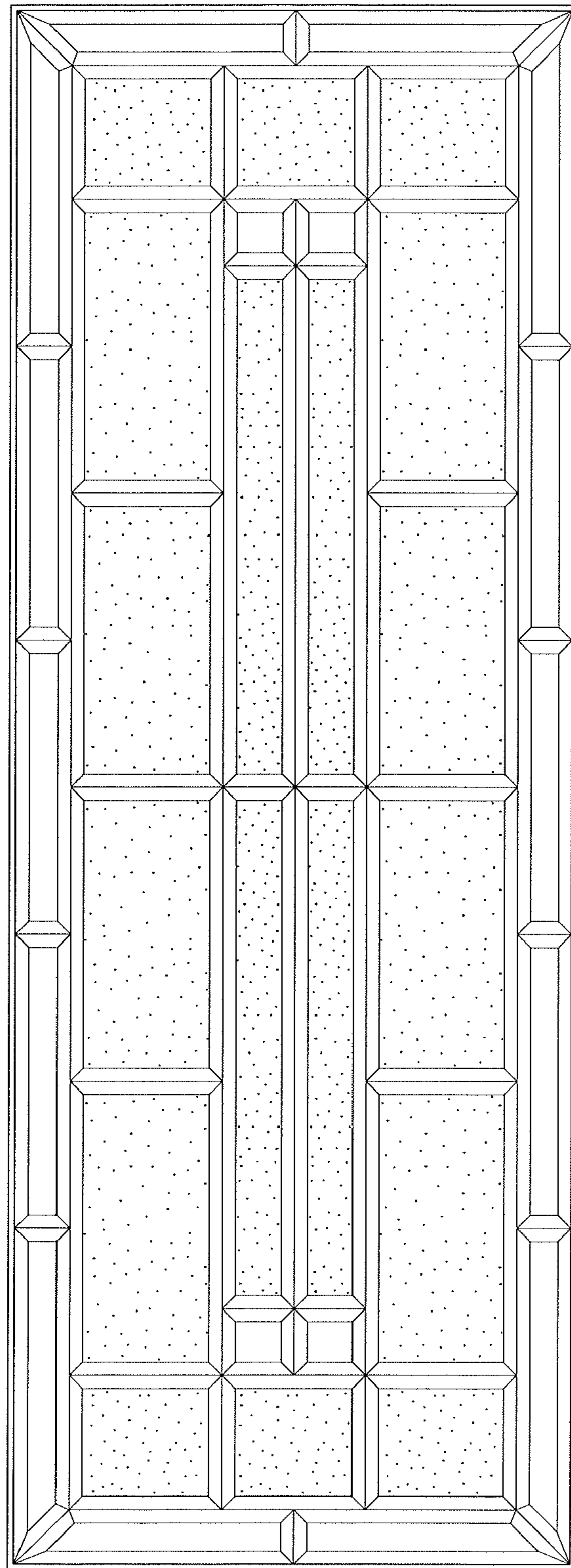

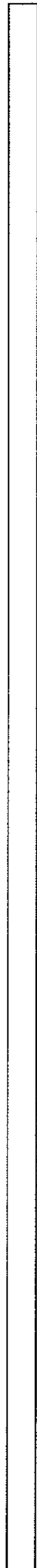

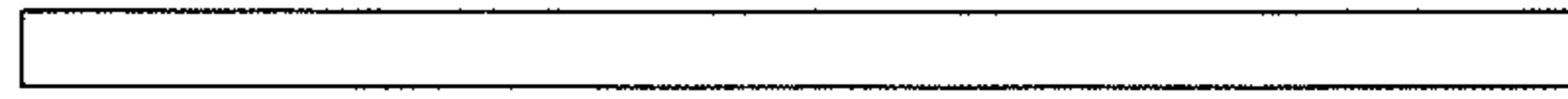
