DESCRIPTION

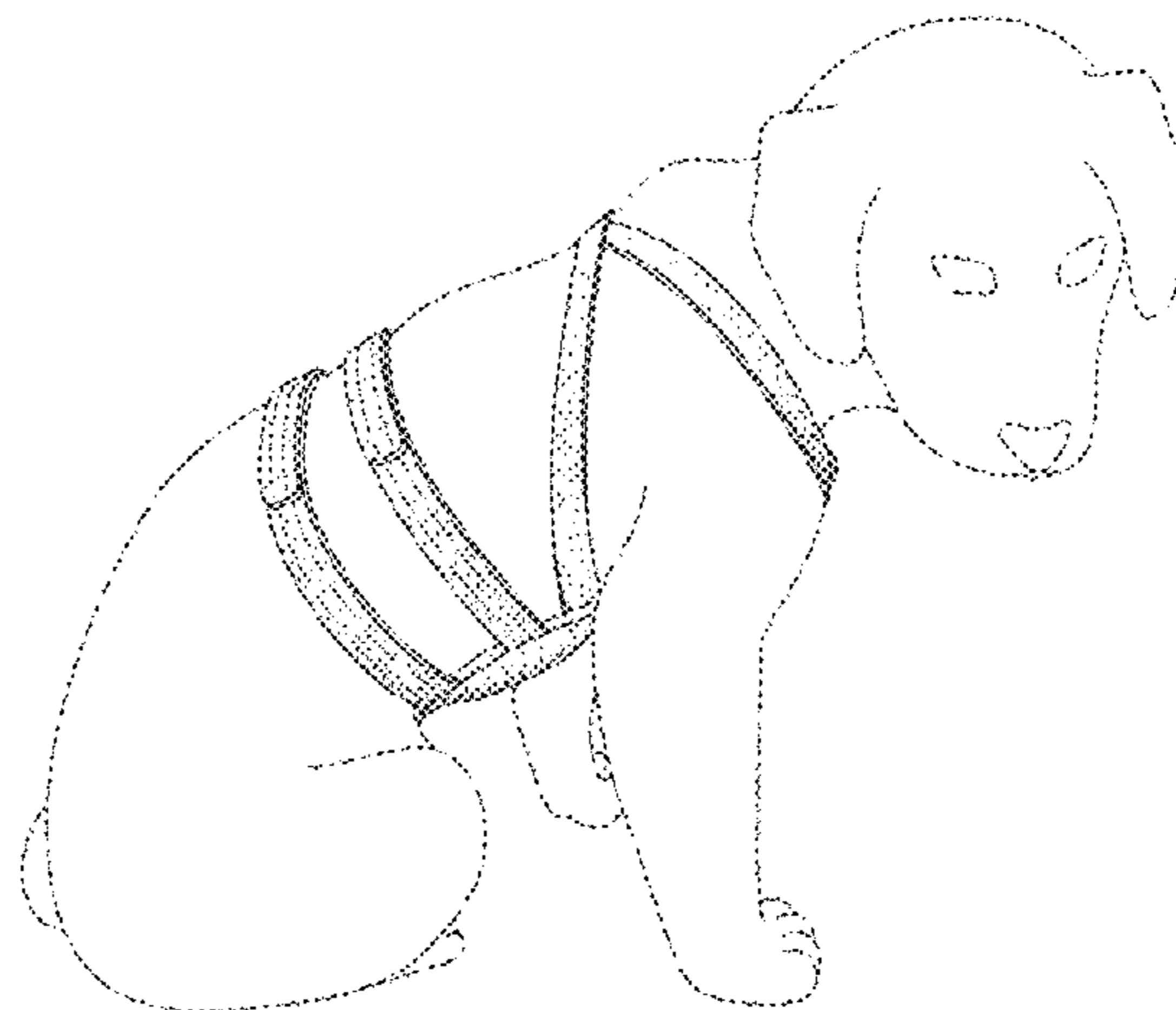
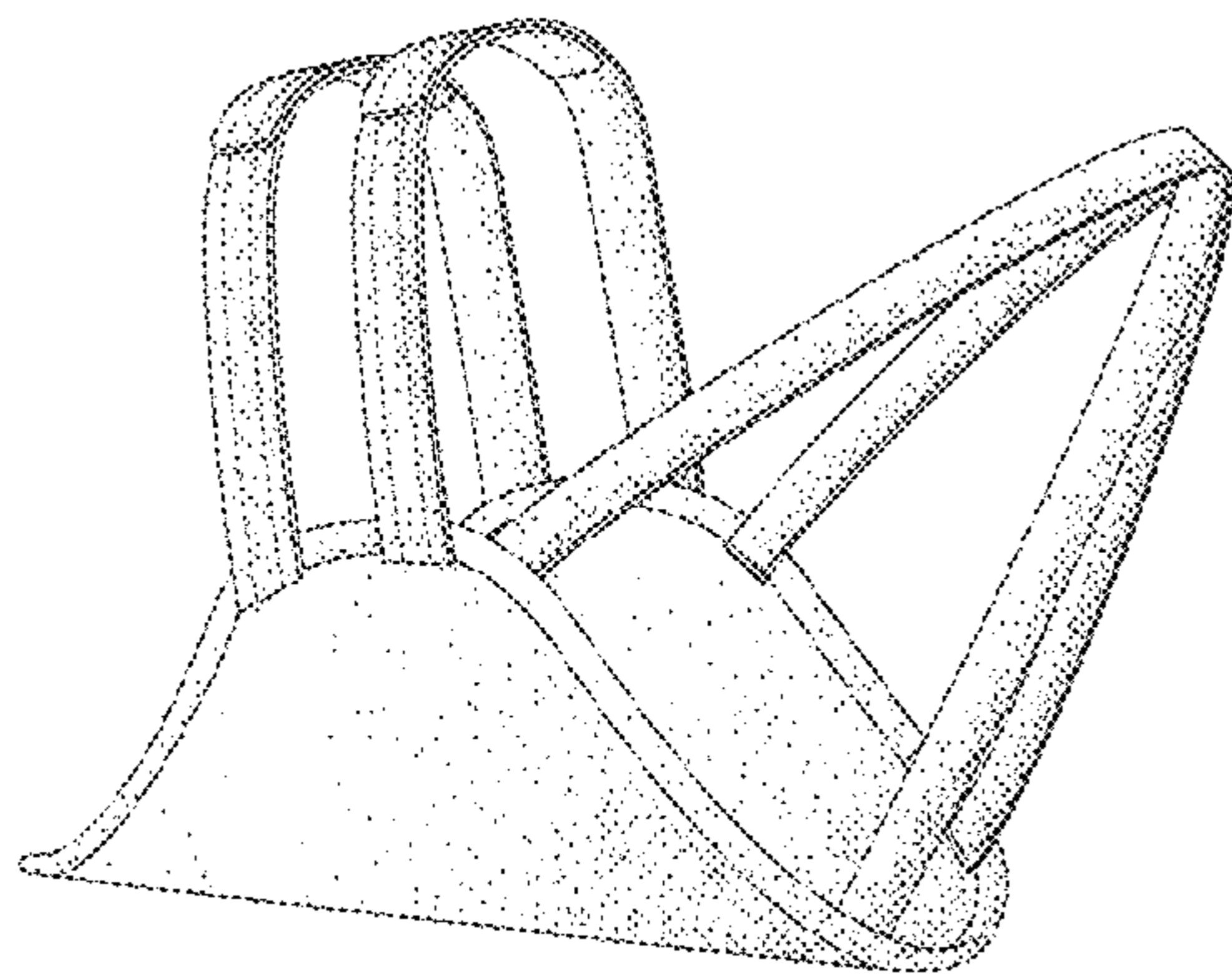

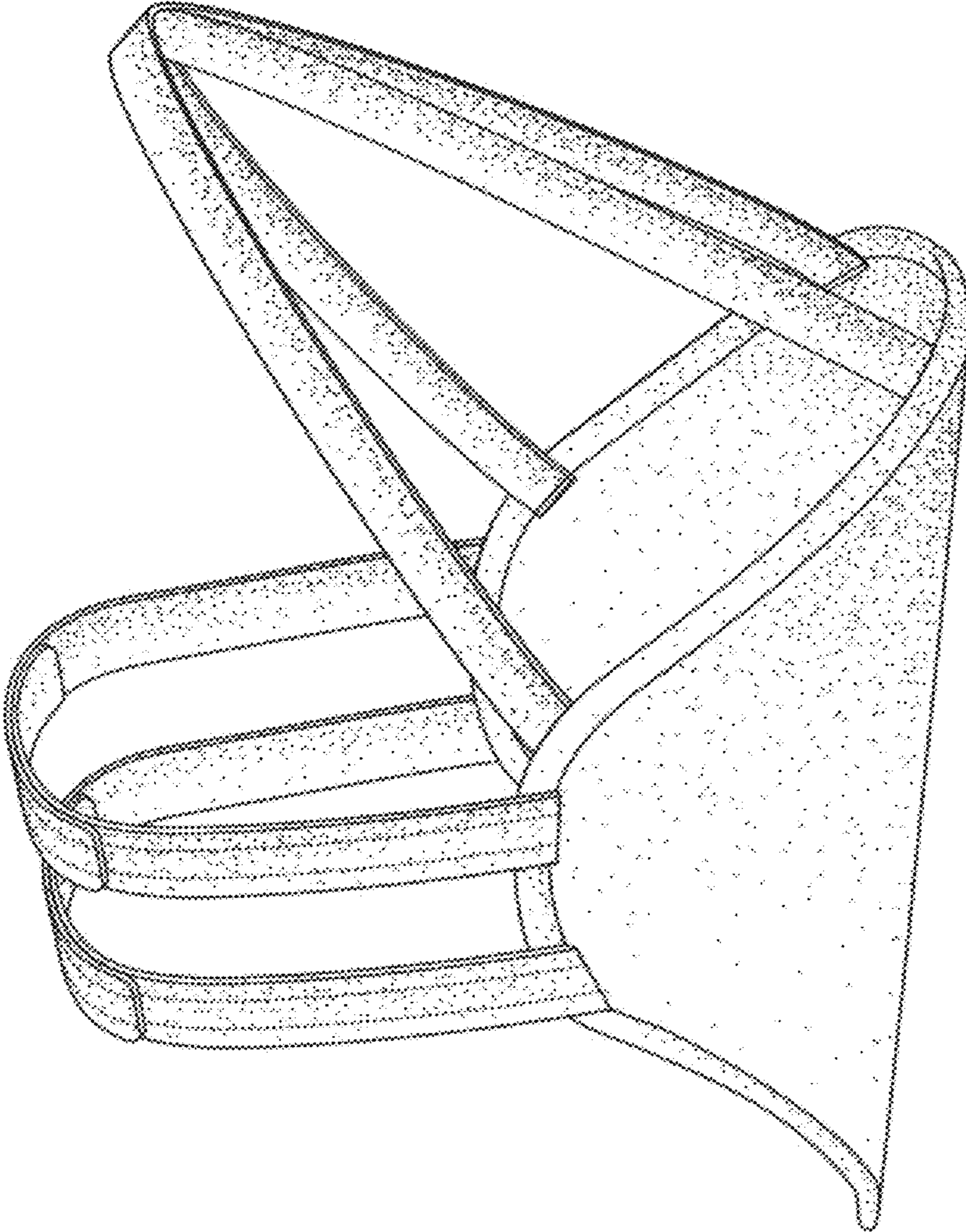

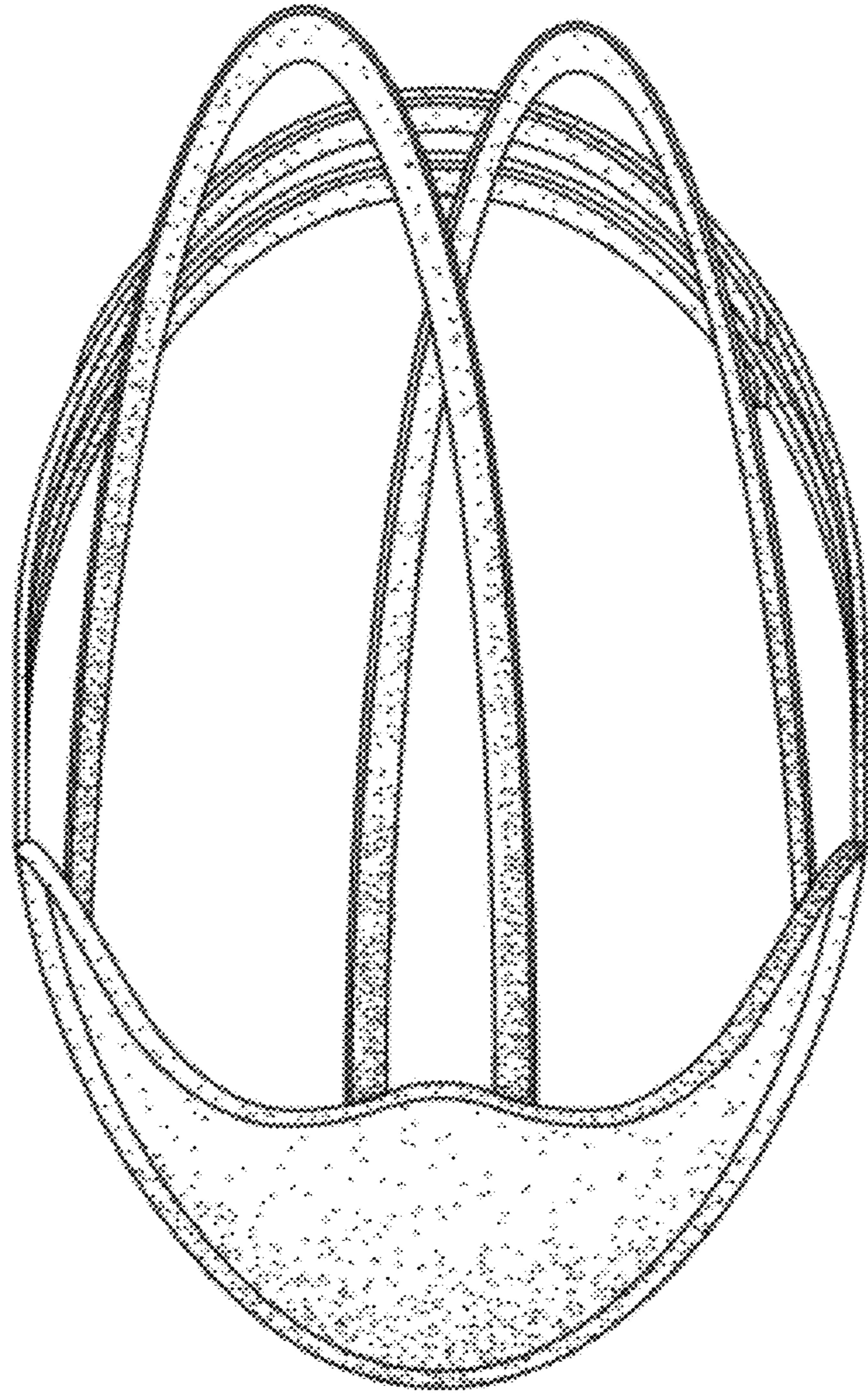

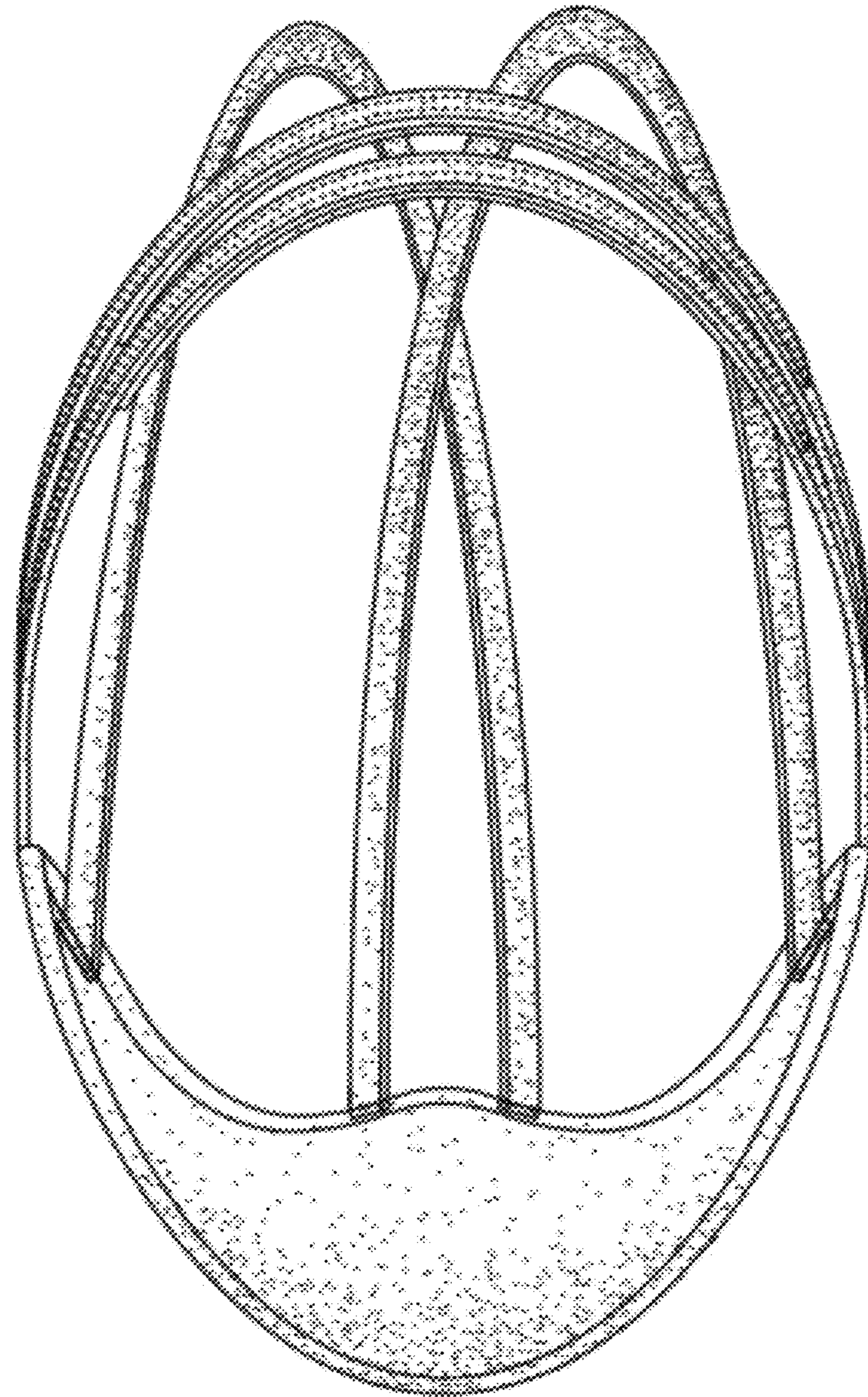

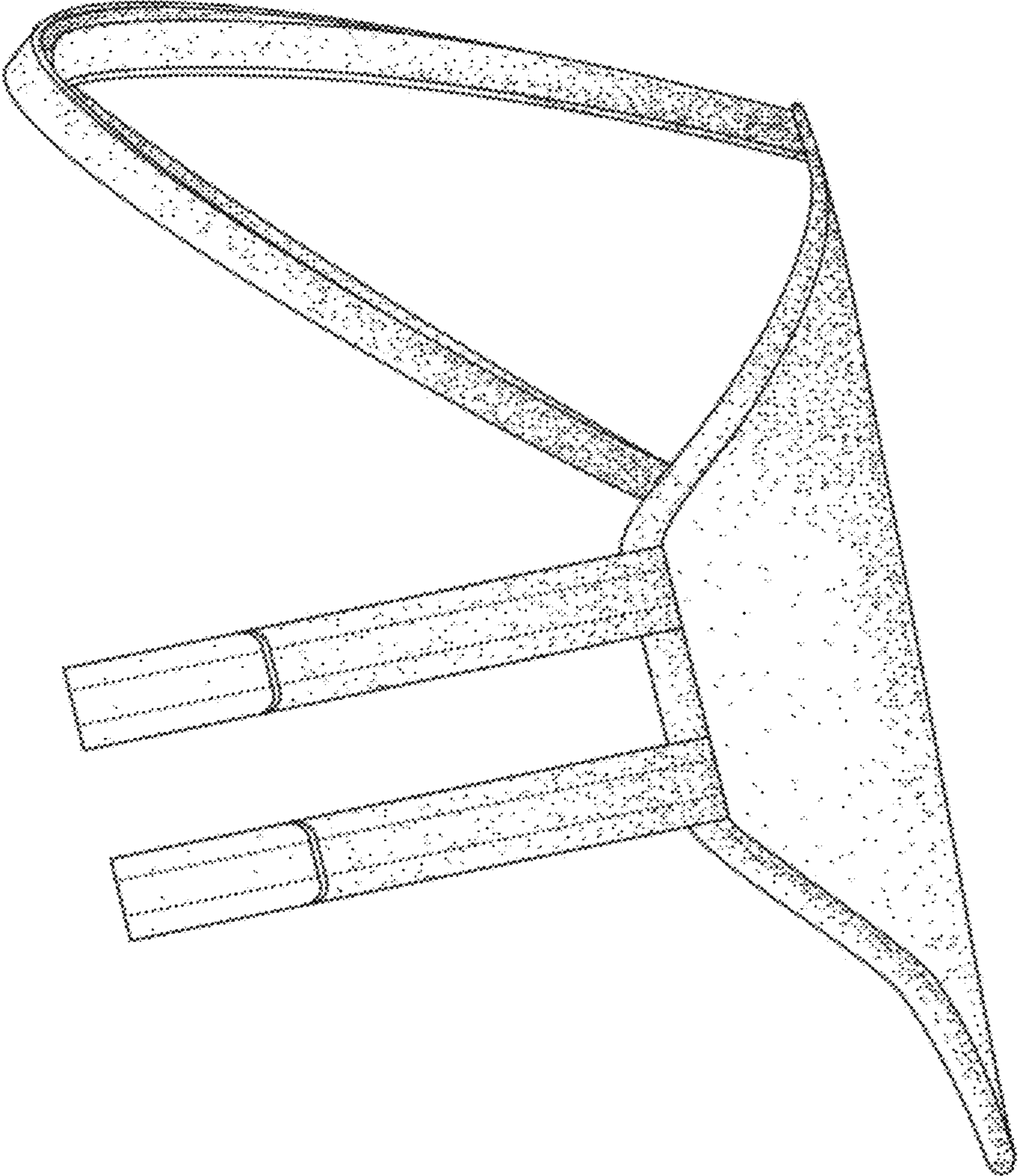

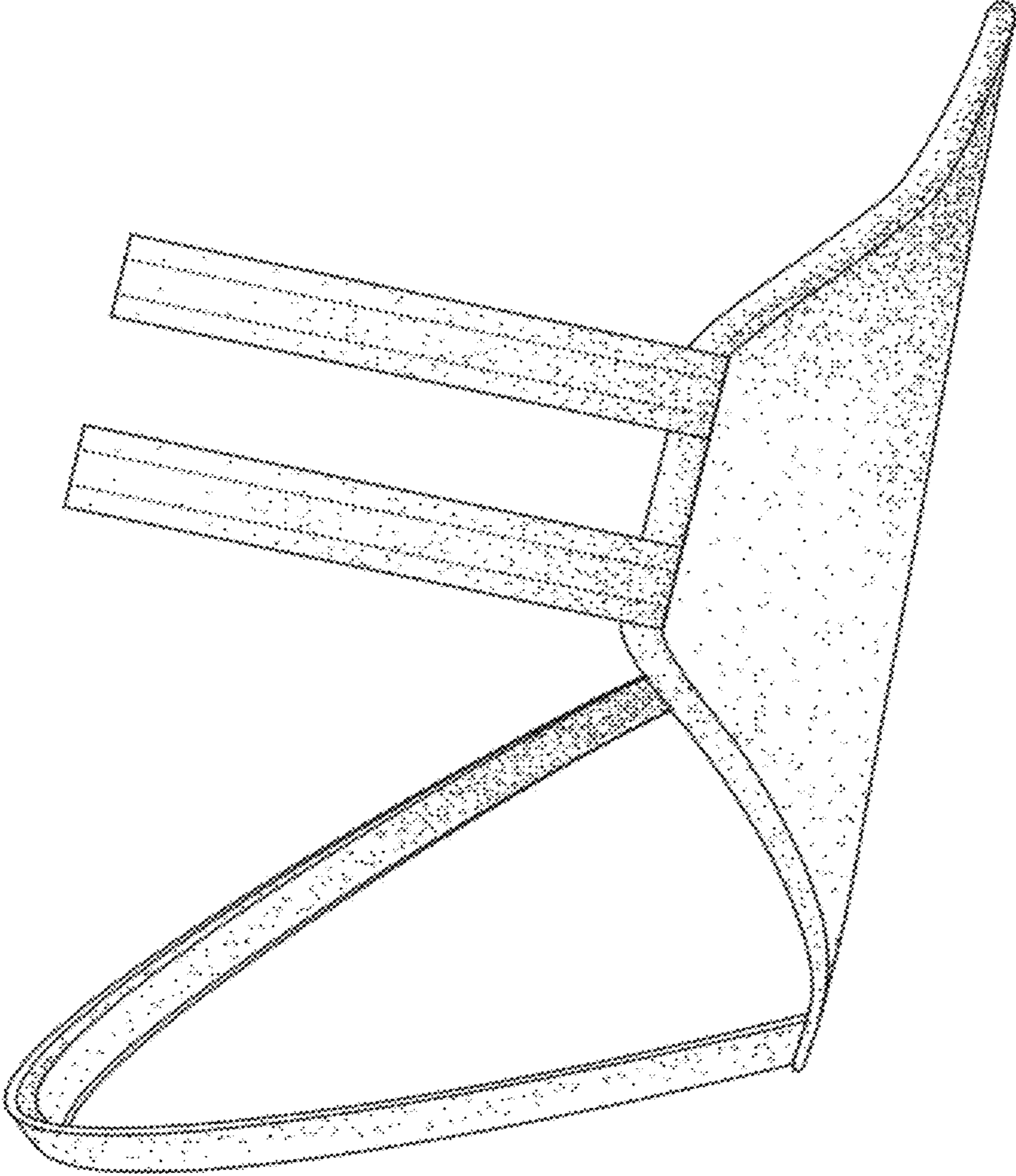

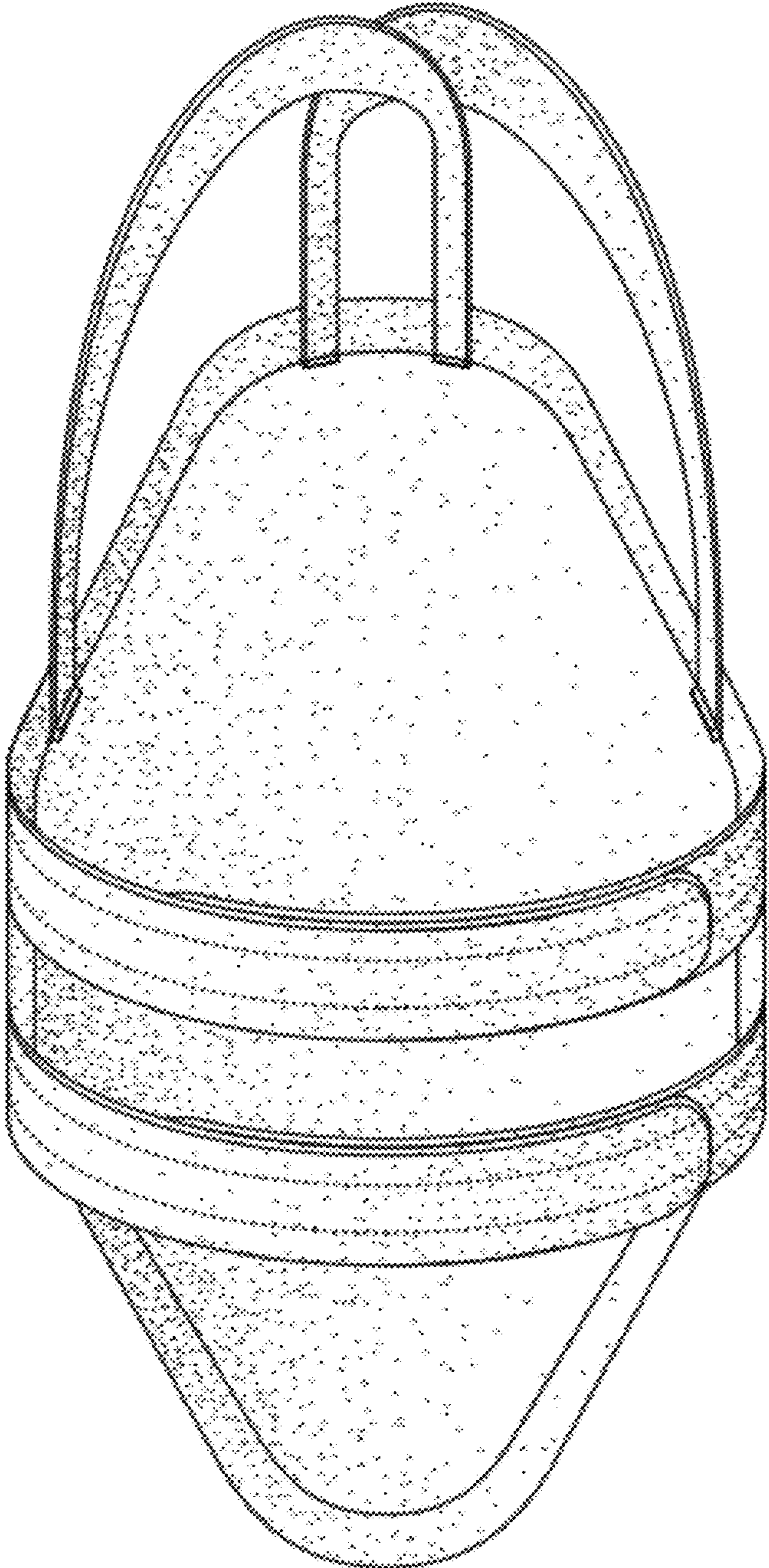

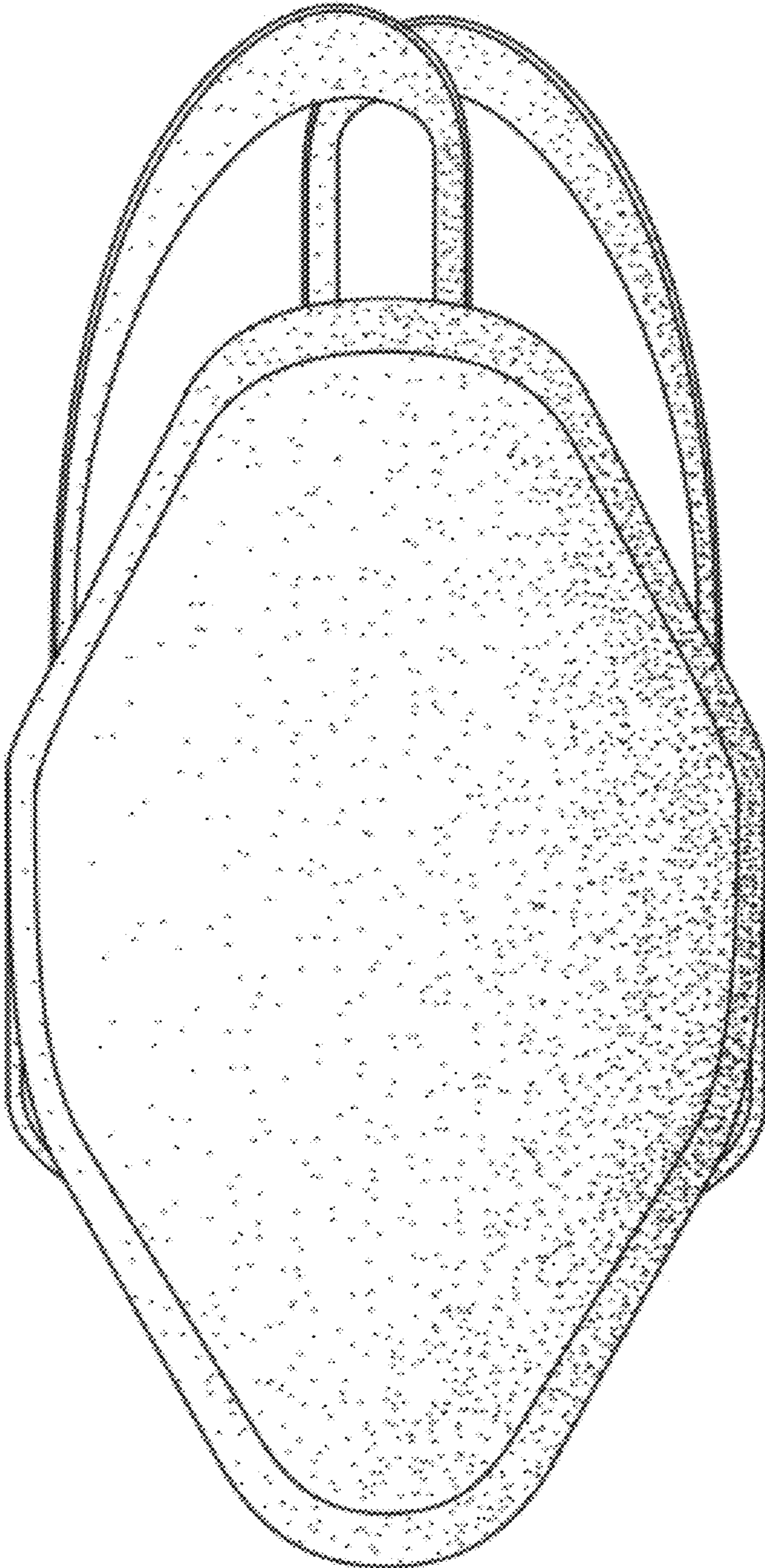

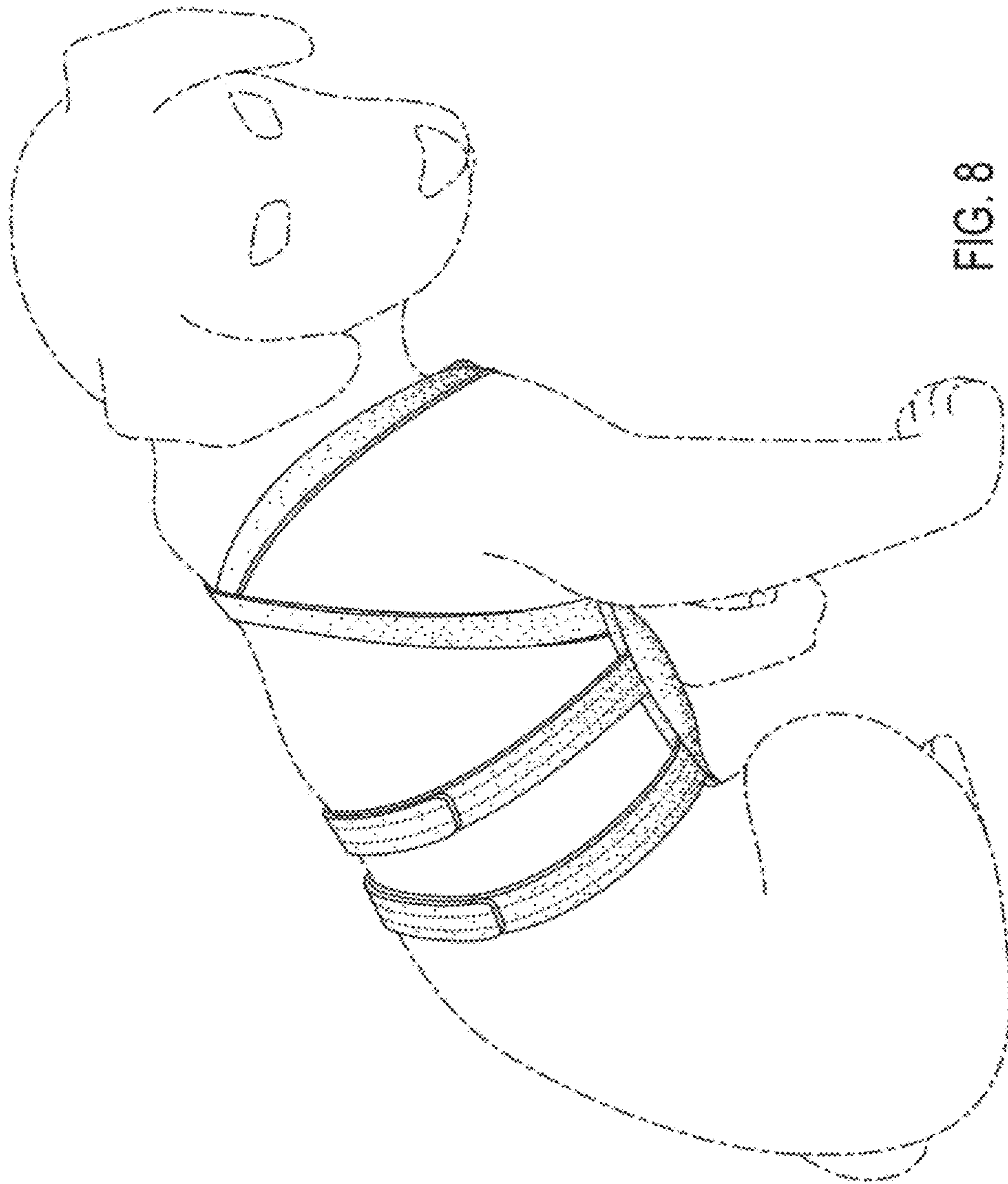

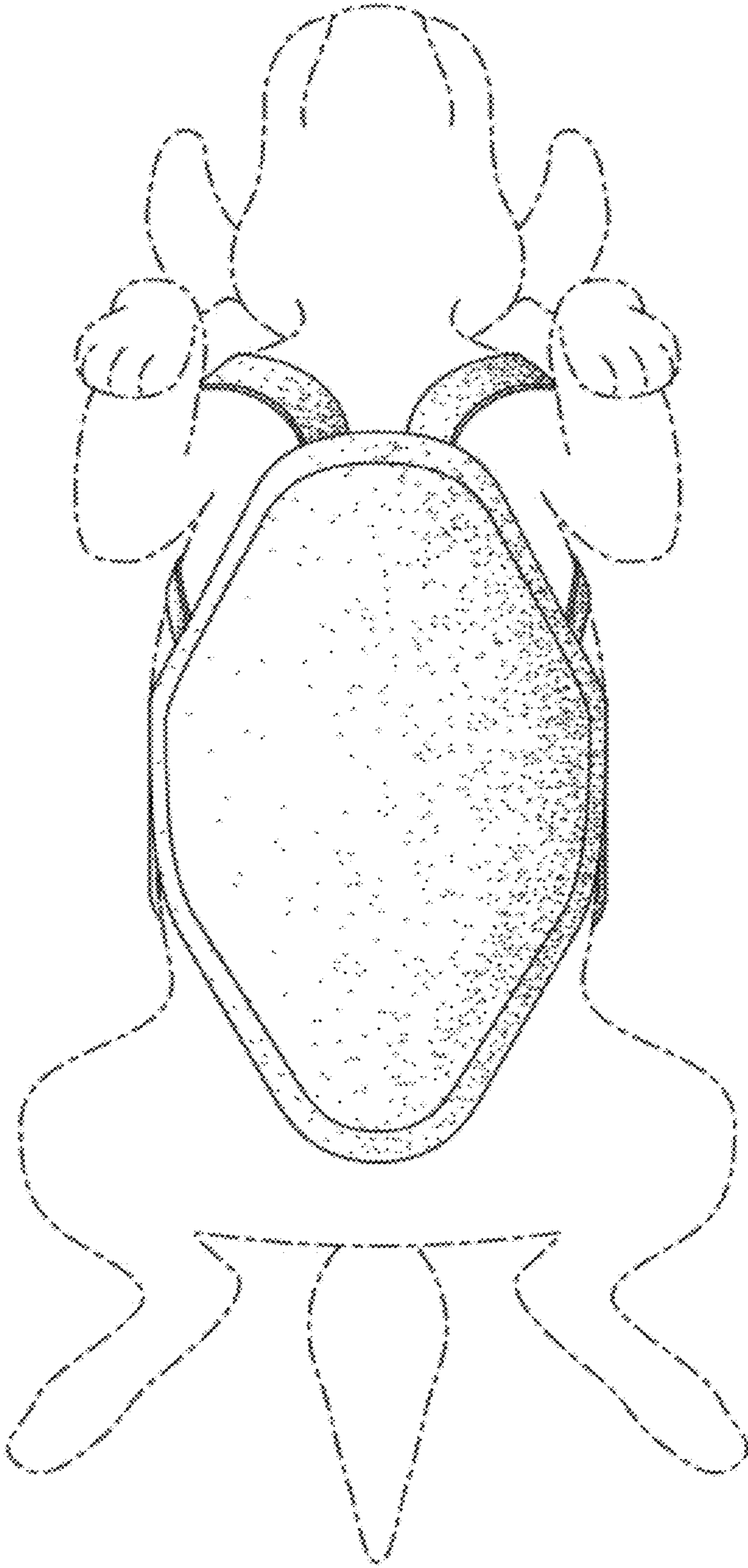
