The ornamental design for a nursing garment, as shown and described.

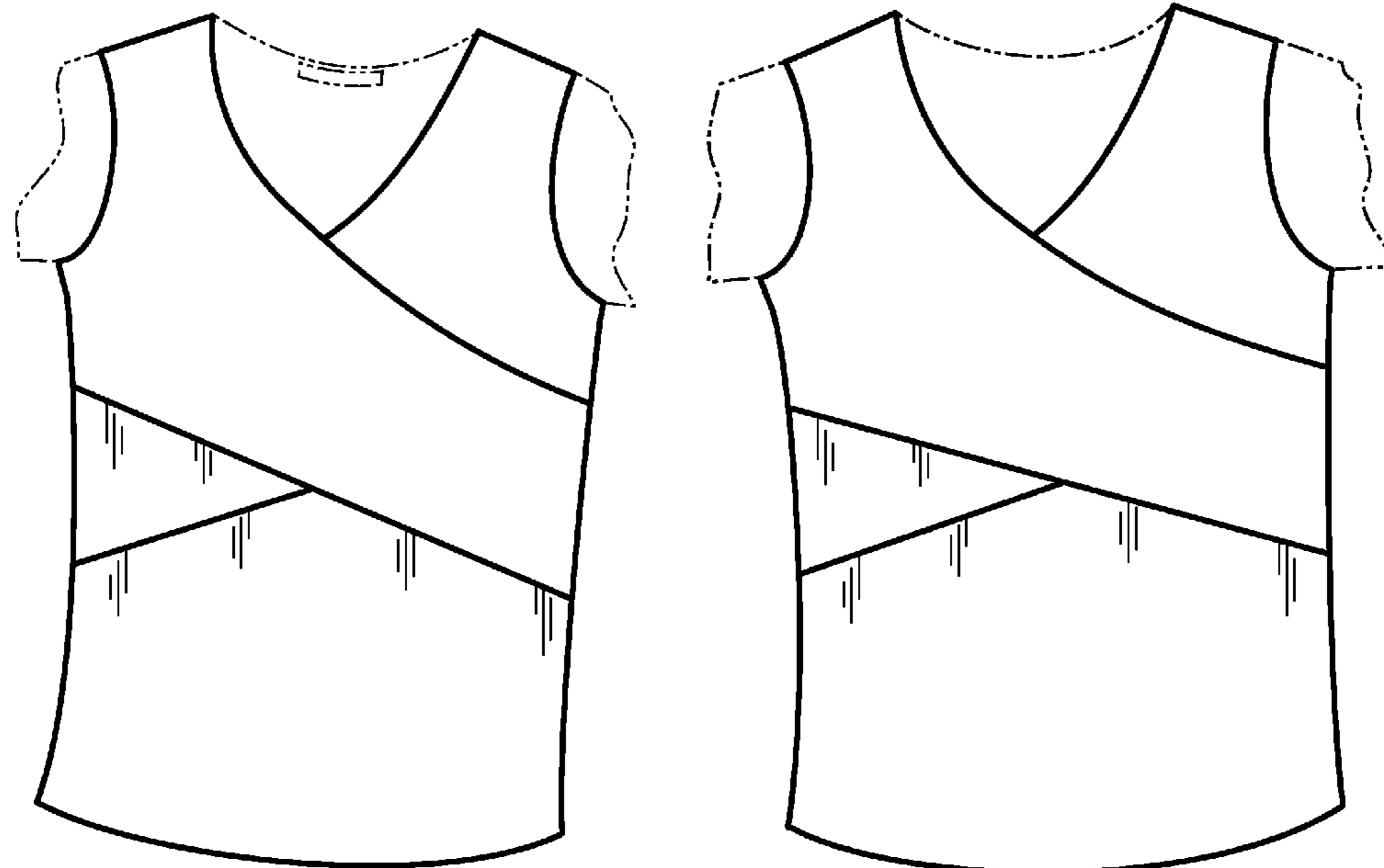
**DESCRIPTION**

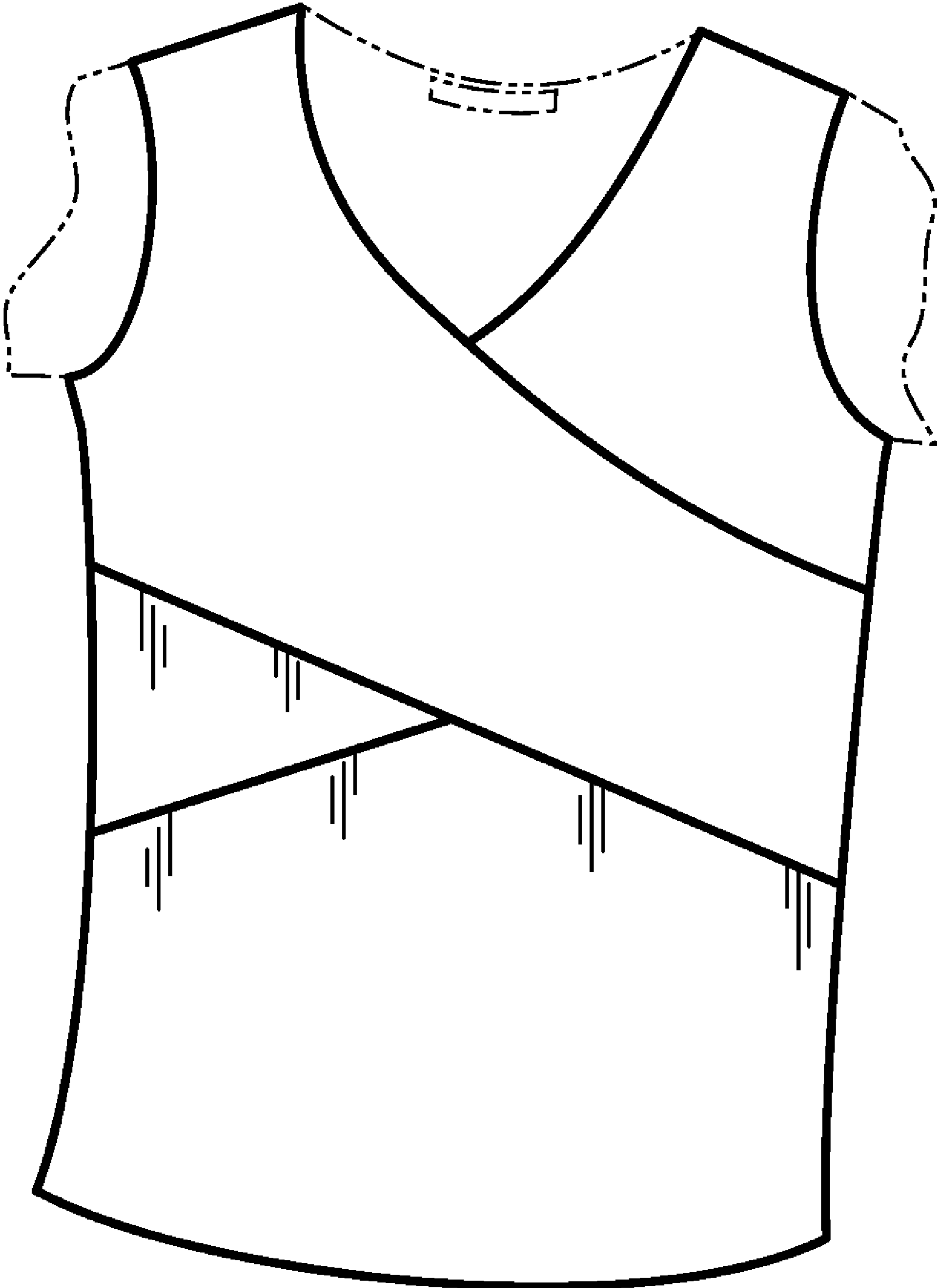

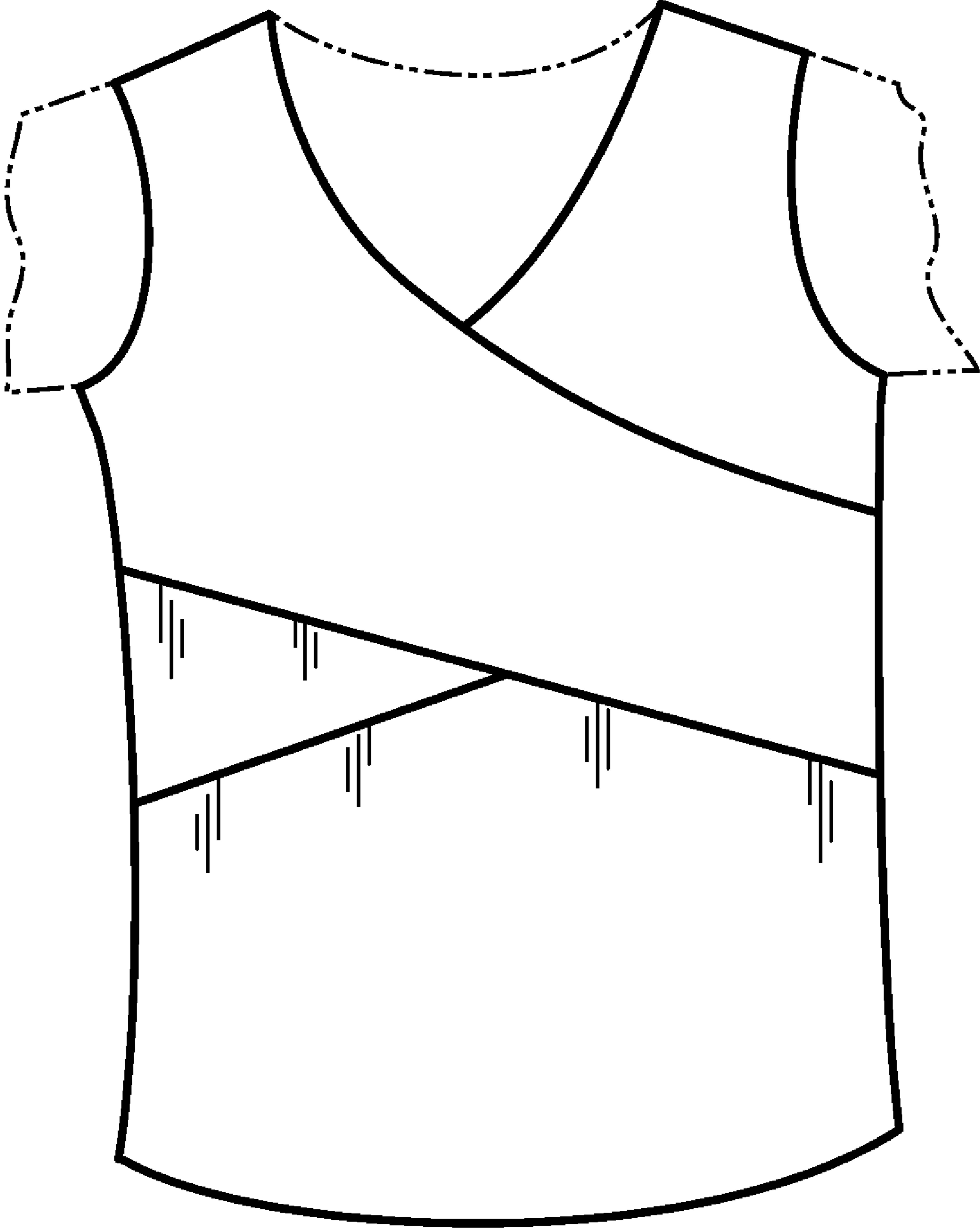
