(57) **CLAIM**

I claim the ornamental design for a floppy hat with netting under brim and bow, as shown and described.

DESCRIPTION

FIG. 4 is a front elevation view thereof.

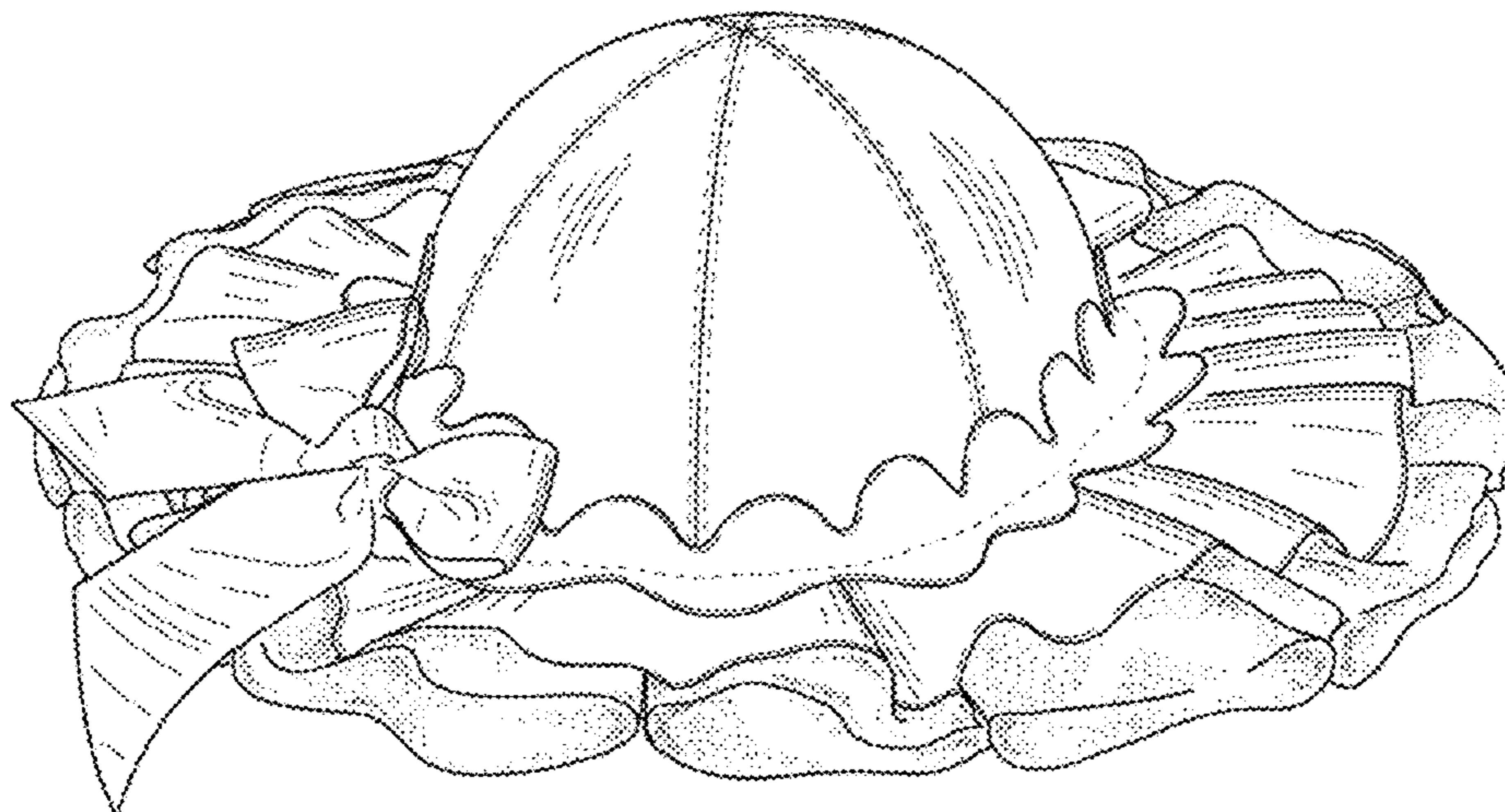
FIG. 5 is a back elevation view thereof.

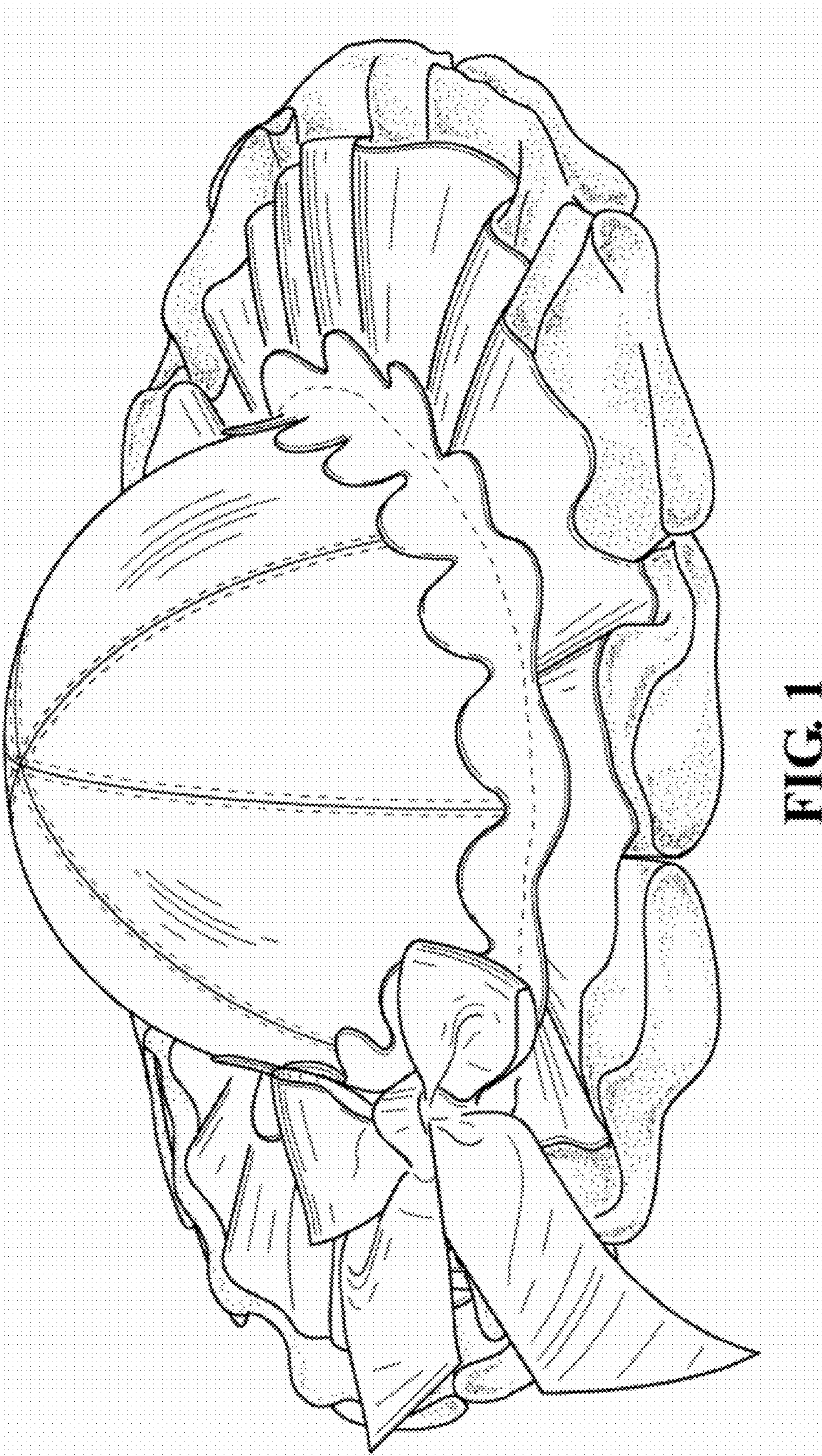

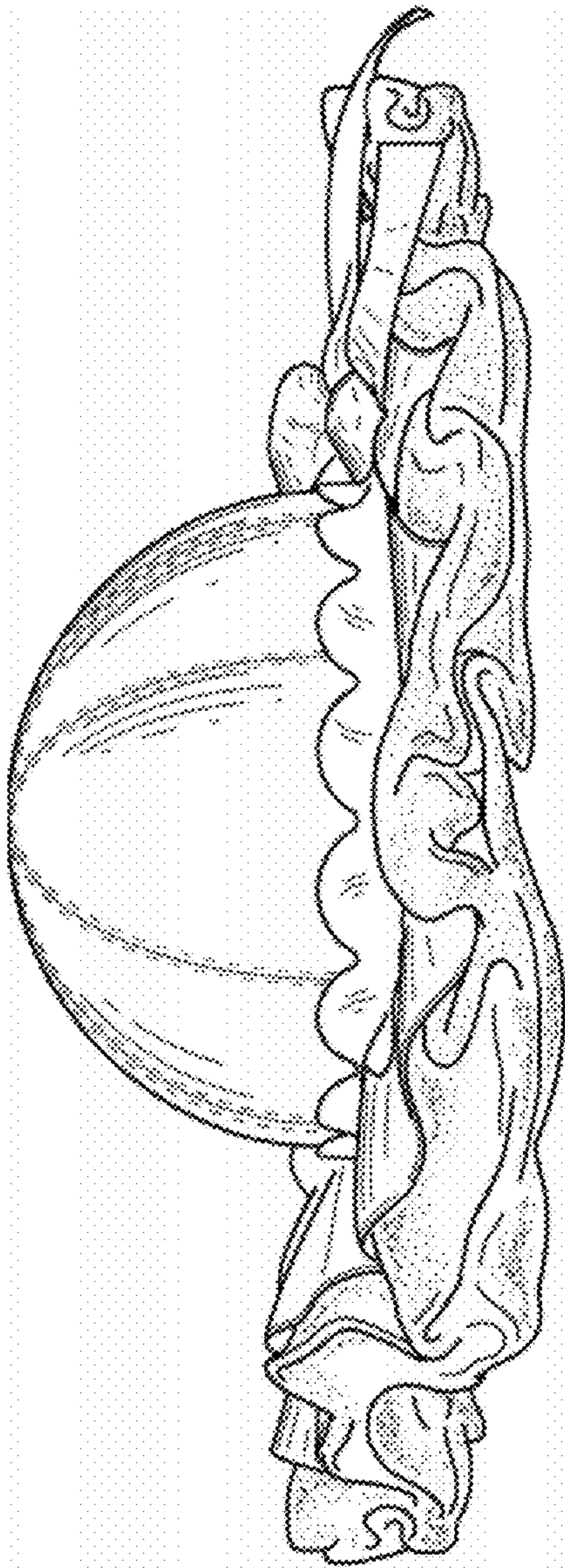

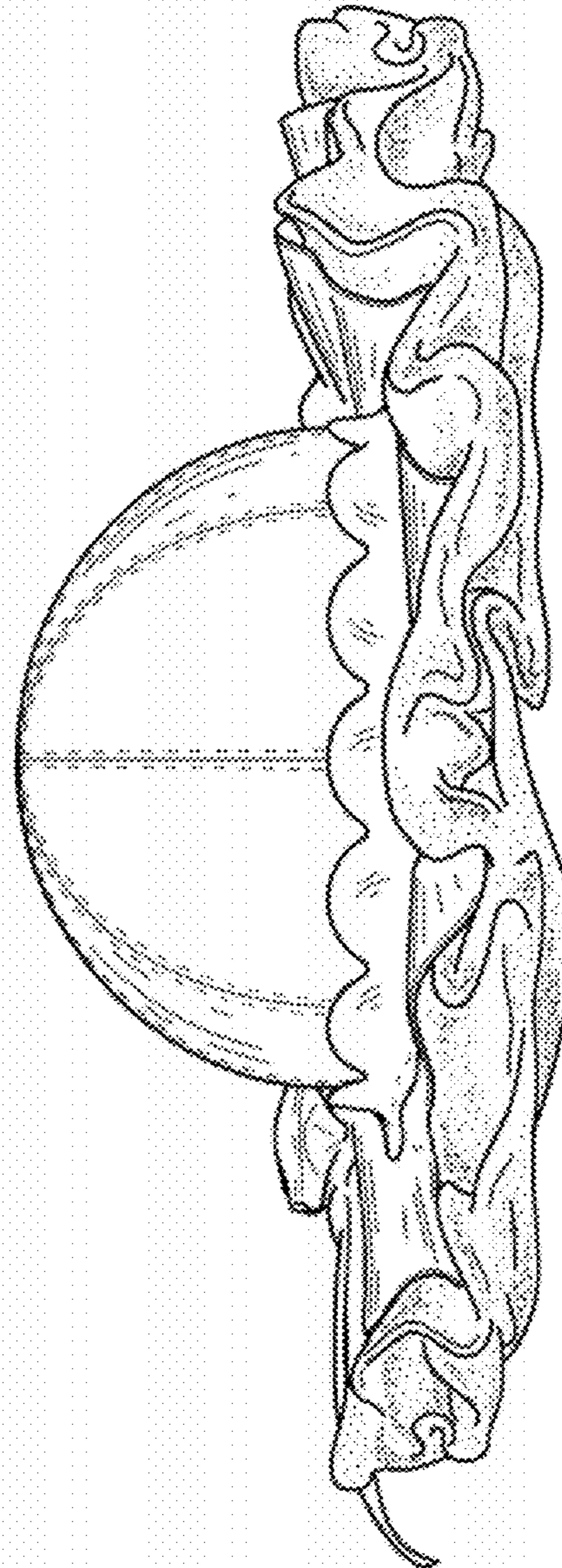

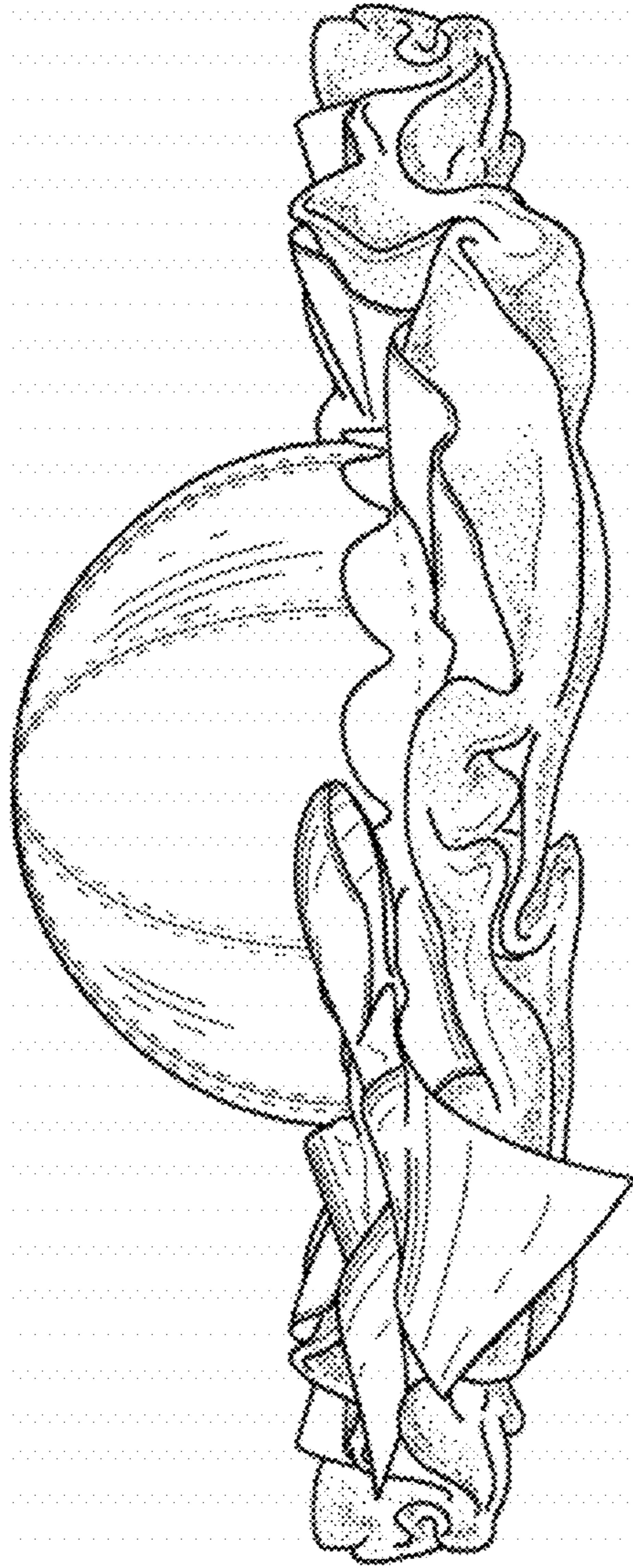

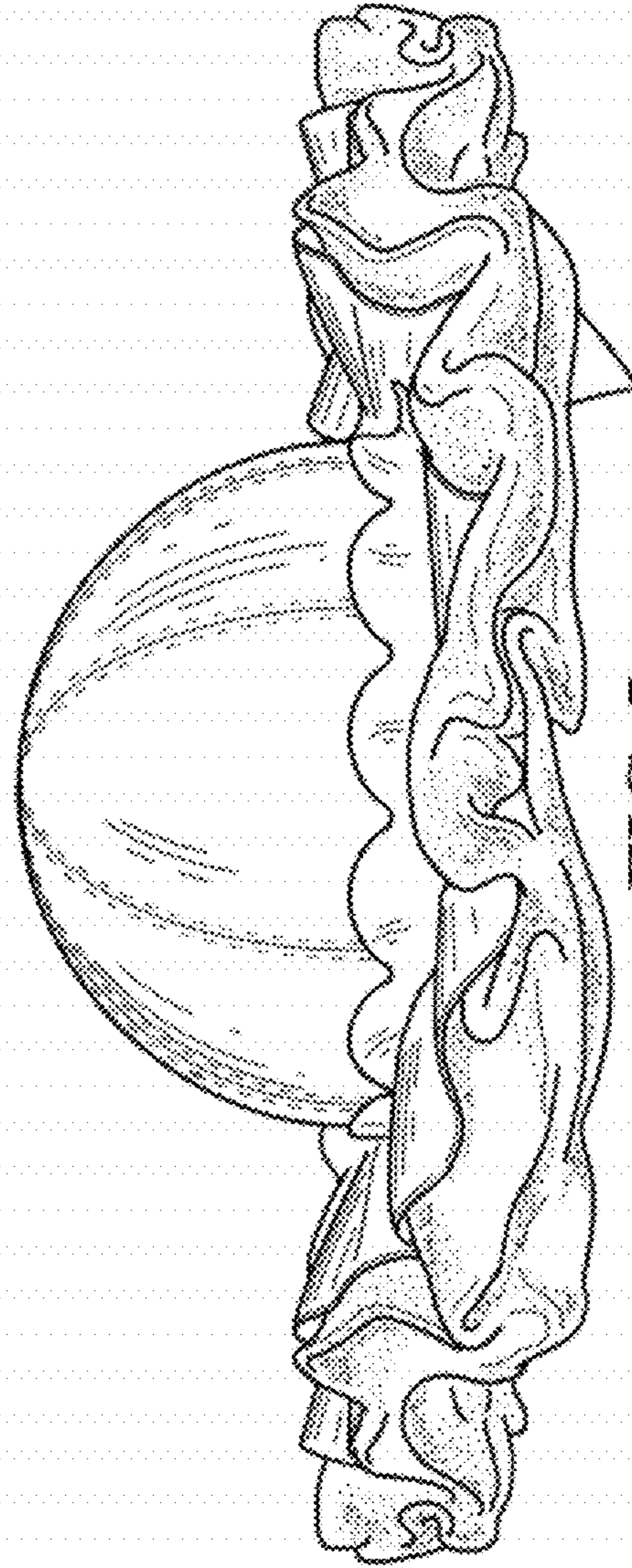

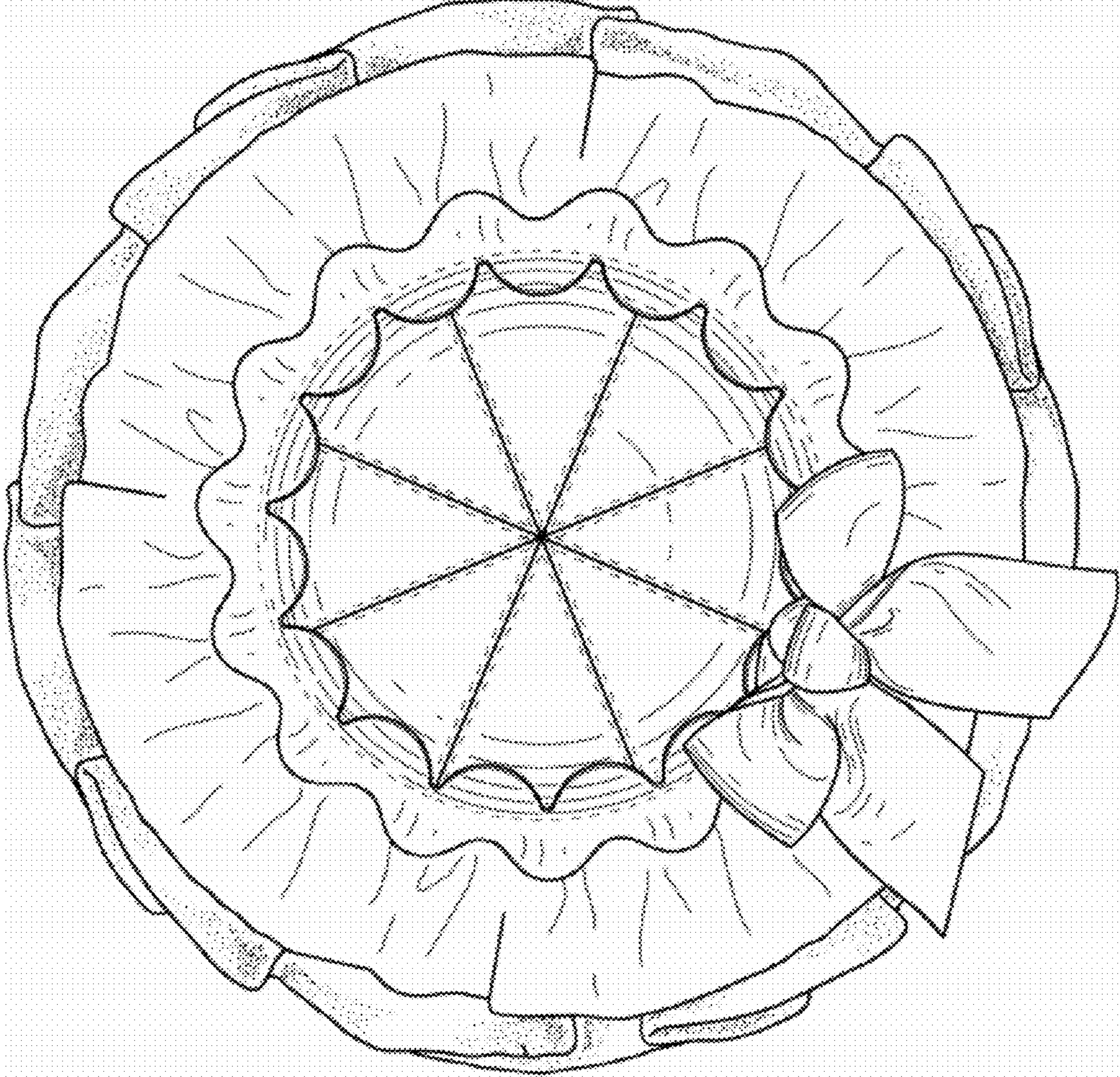

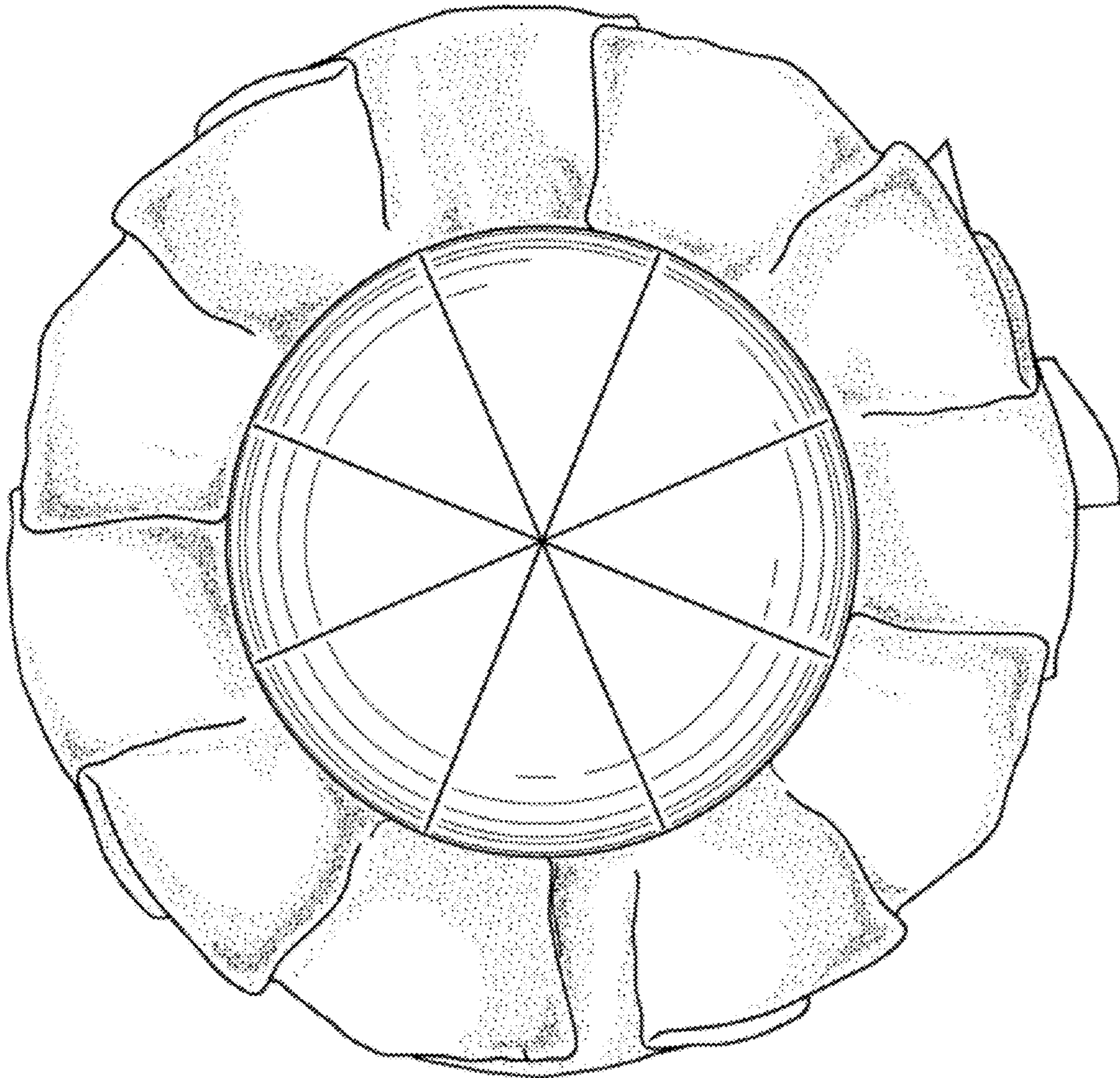
