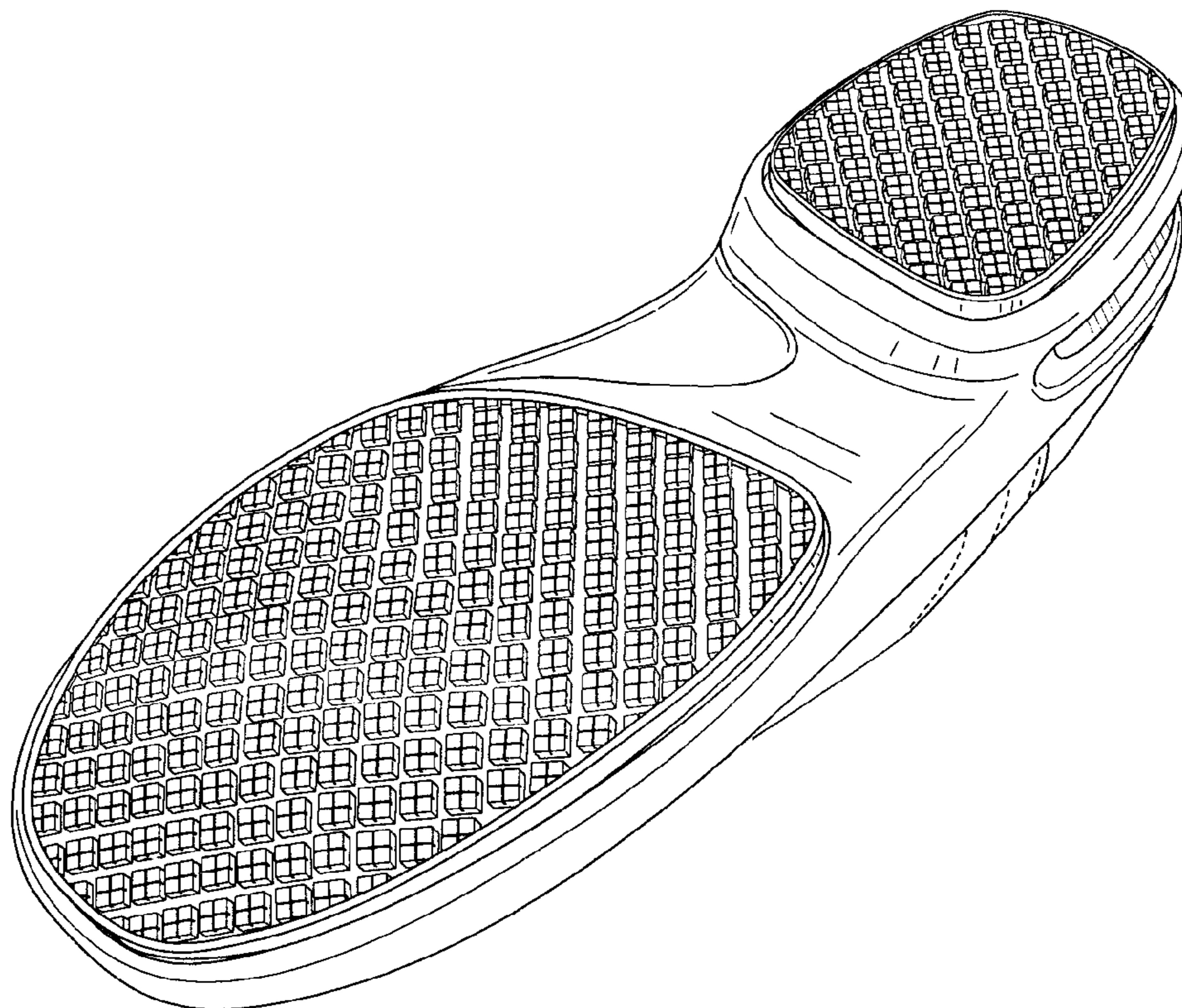
(57) **CLAIM**

The ornamental design for a clog shoe with air cushion, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a clog shoe with air cushion of the instant invention; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a front view thereof; and, FIG. 7 is a rear view thereof. The parts of the Figures shown in broken lines form no portion of the claimed design.

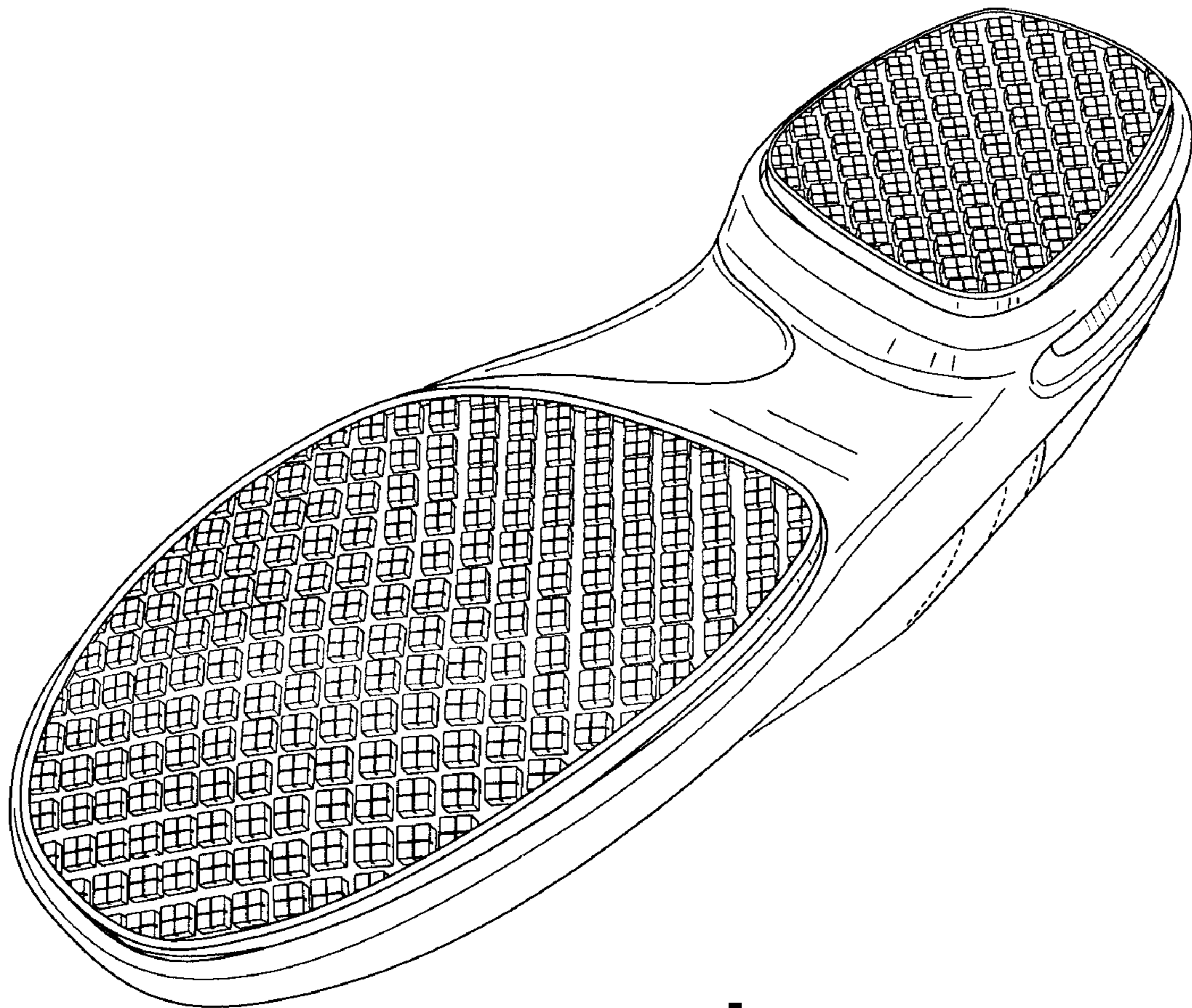

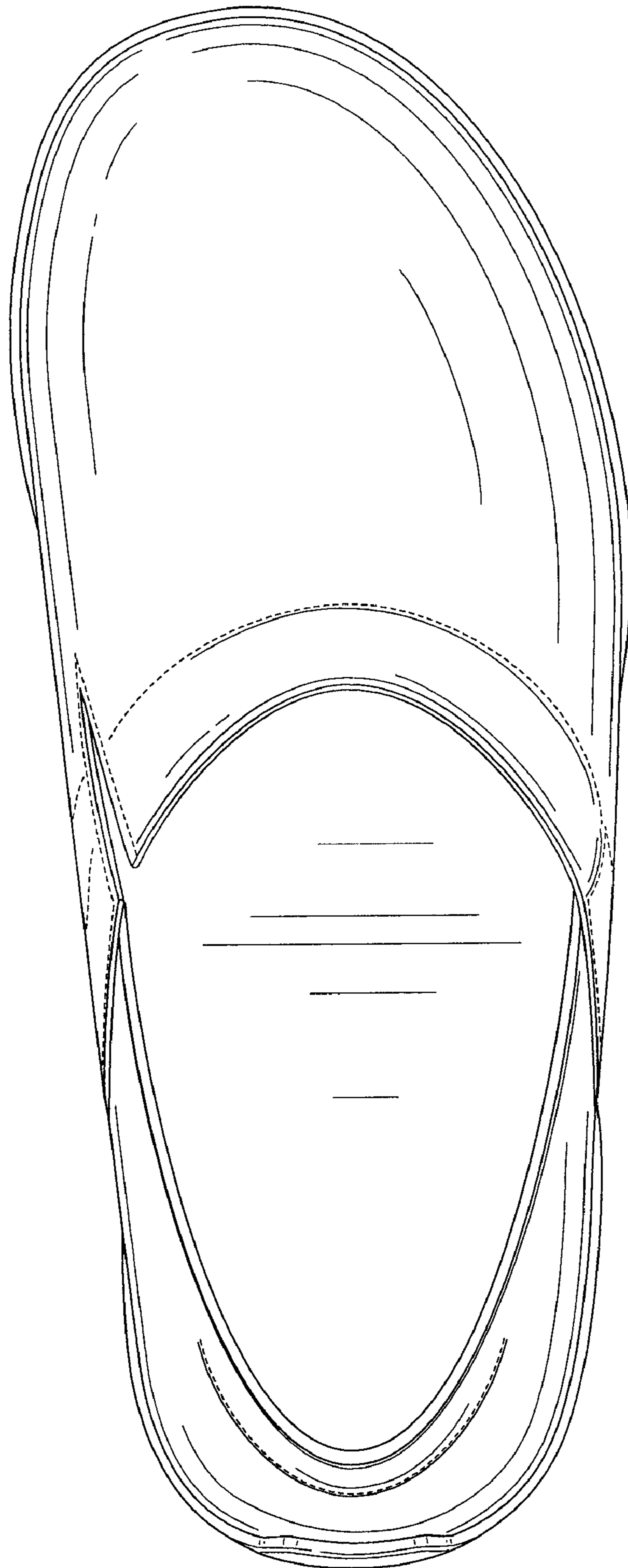

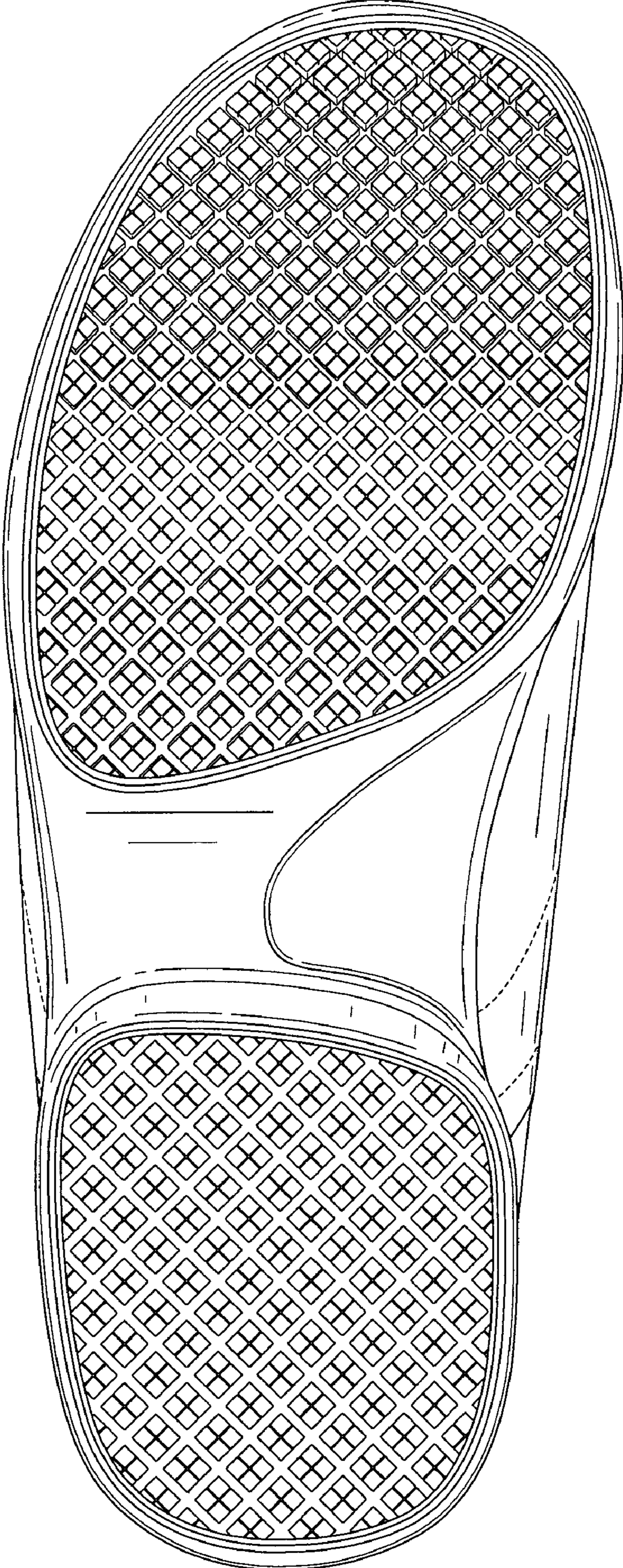

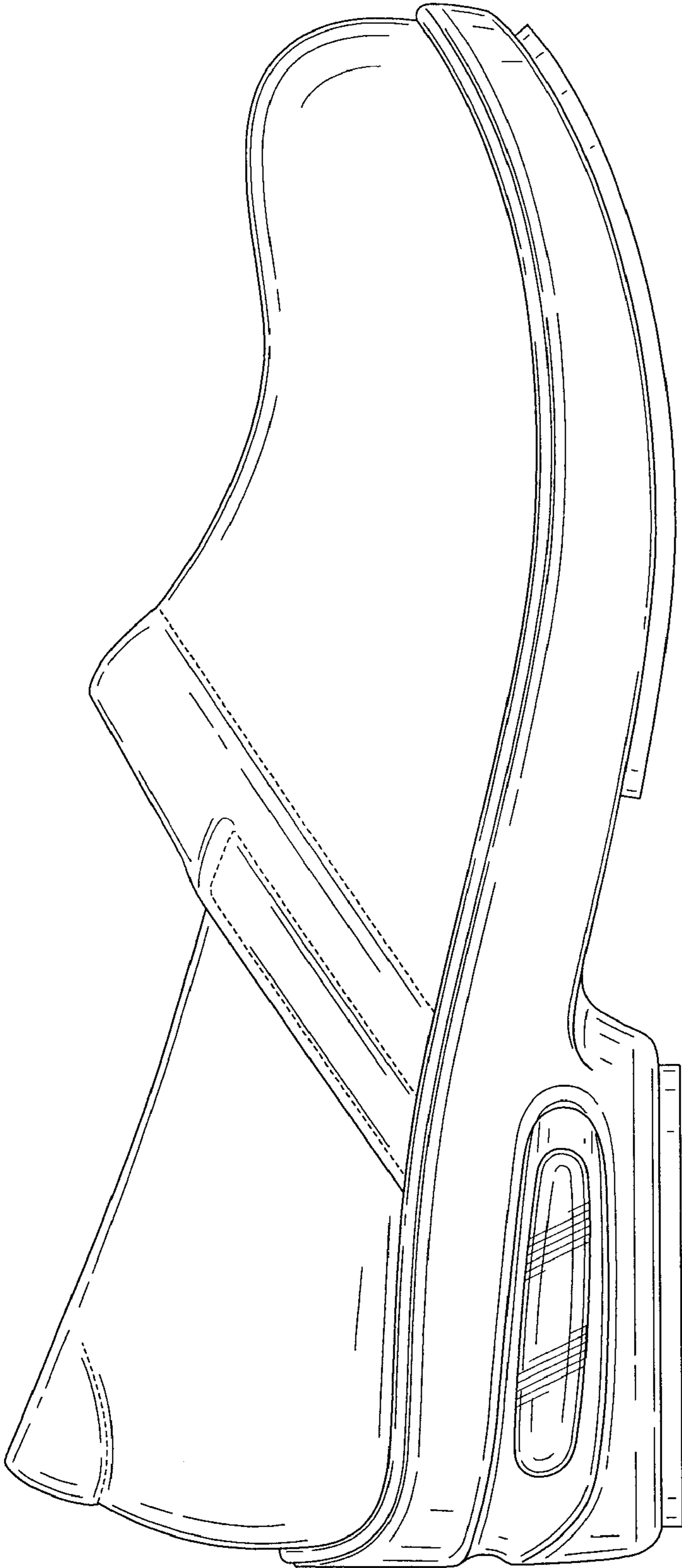

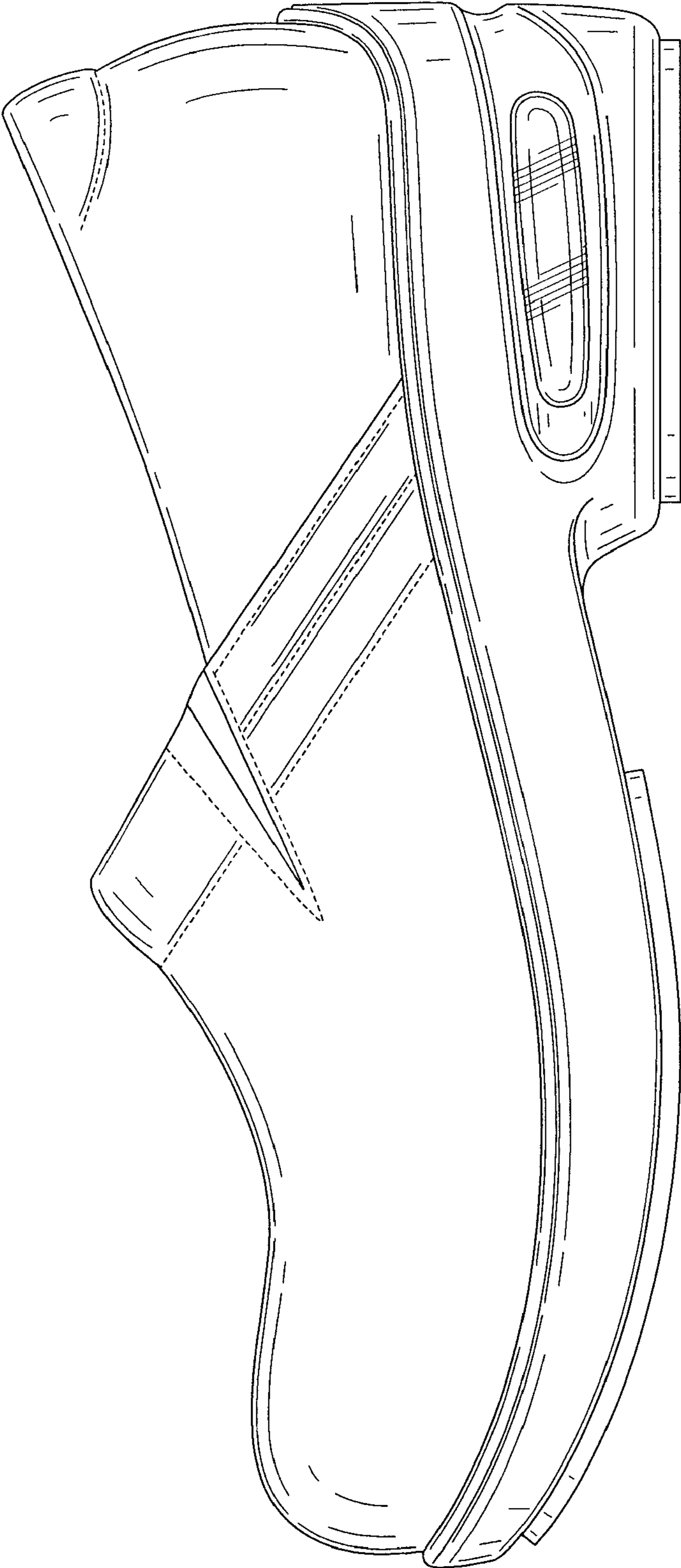

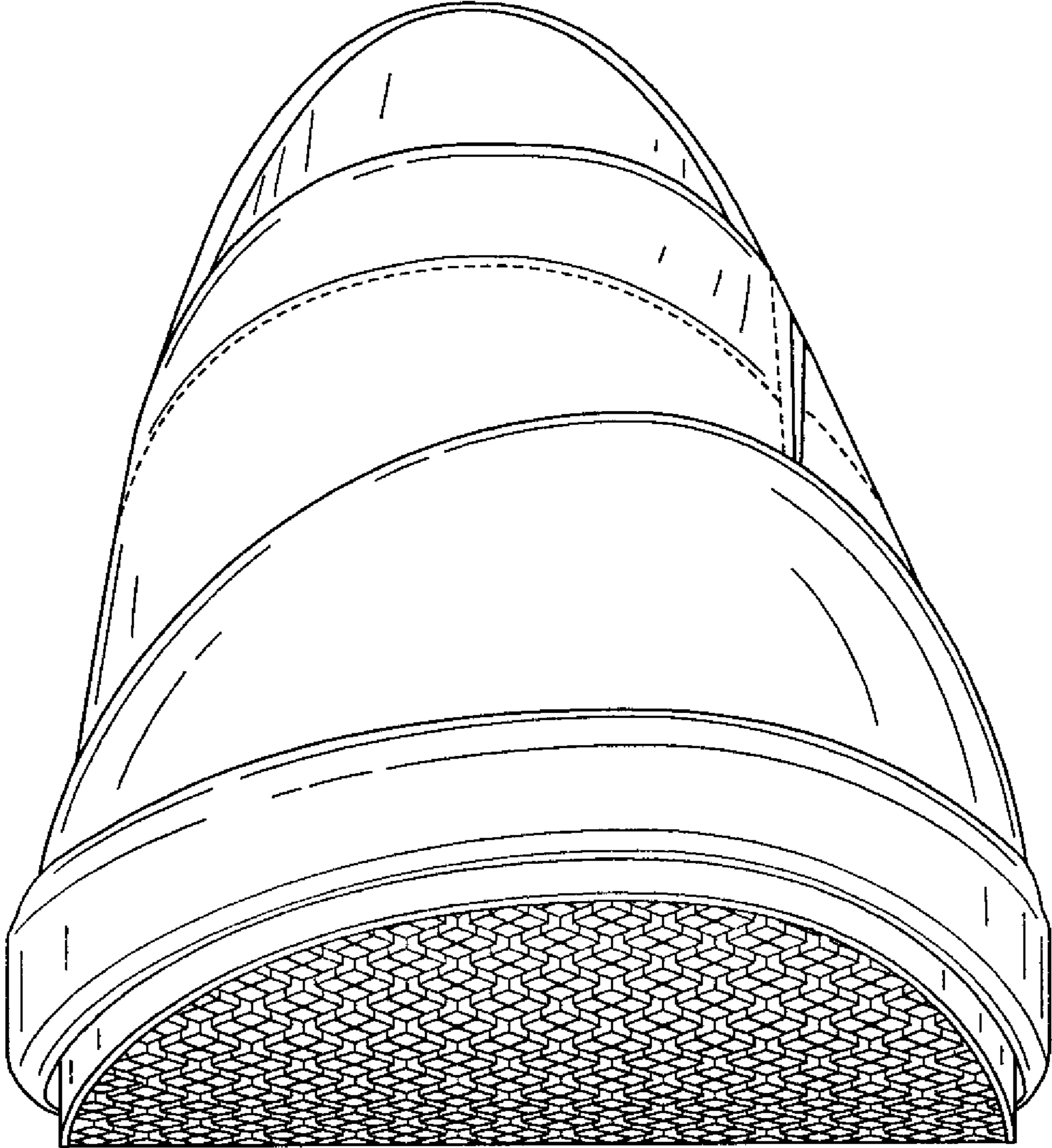

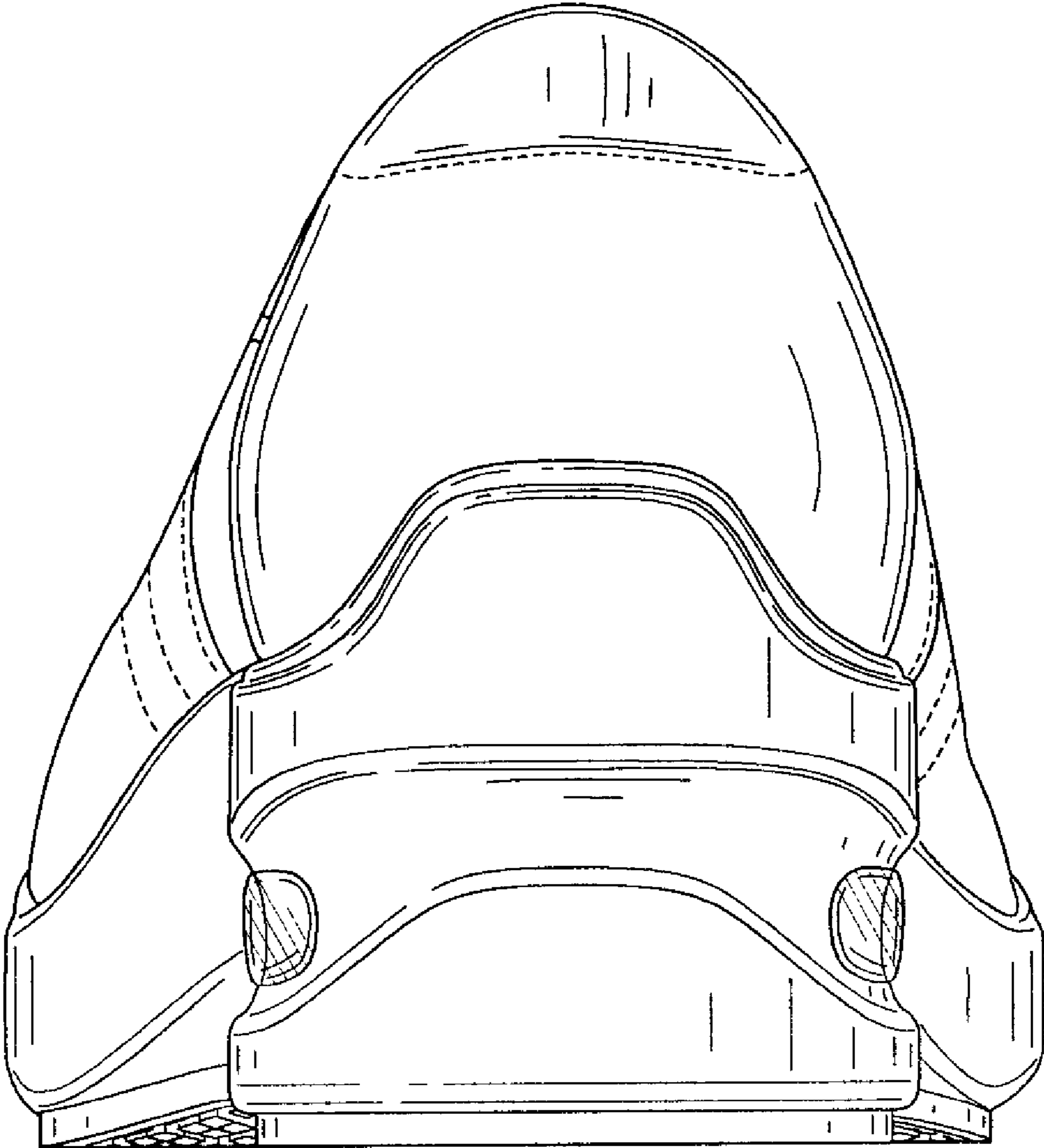
