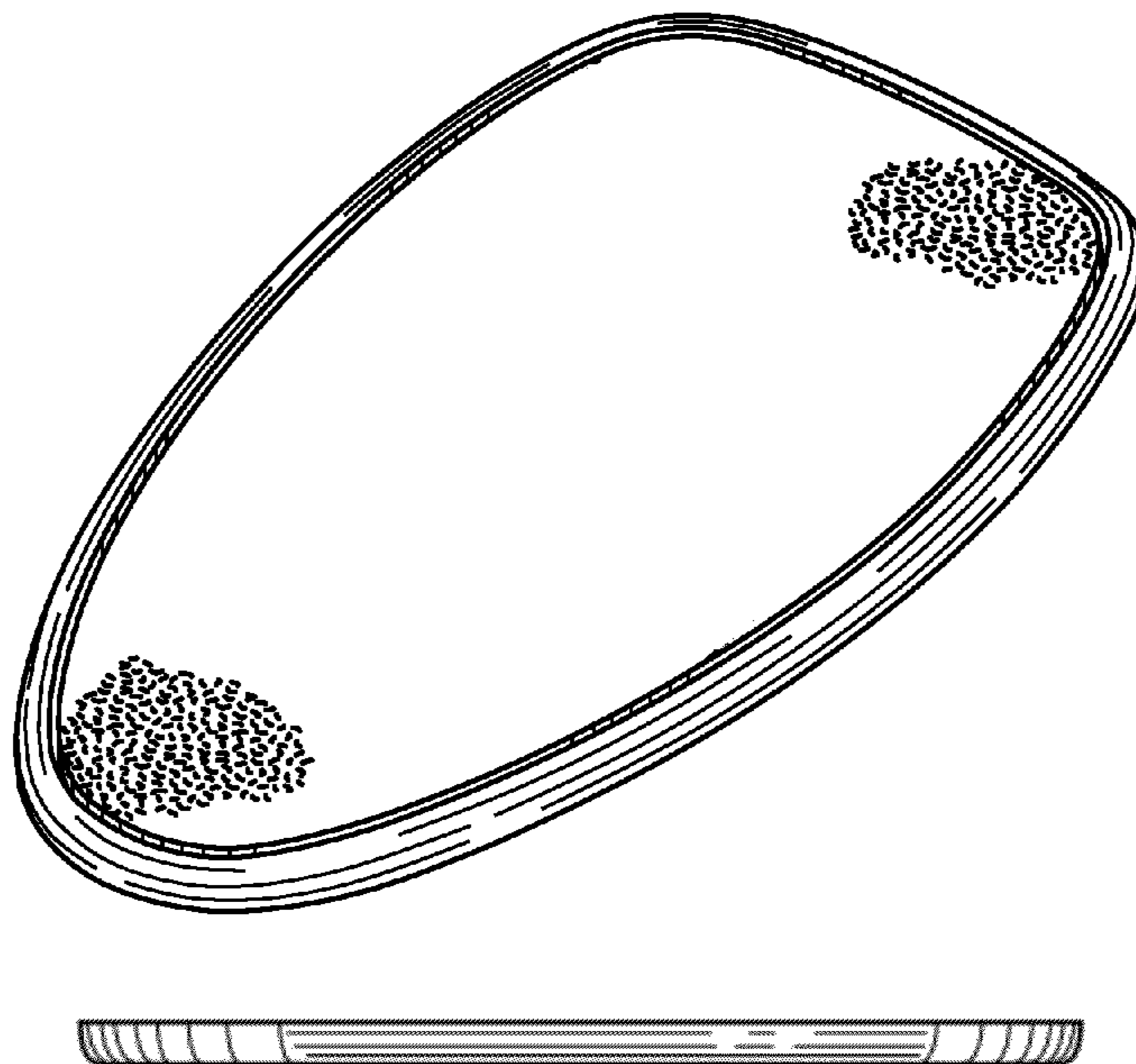
(57) **CLAIM**

The ornamental design for a toe outsole patch, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an ornamental design for a toe outsole patch according to the present invention; FIG. 2 is a bottom view thereof; FIG. 3 is a top view thereof; FIG. 4 is a first side view thereof; FIG. 5 is a second side view thereof; FIG. 6 is a third side view thereof; and, FIG. 7 is a fourth side view thereof. The stippling shown intermittingly on the top surface in FIGS. 1 and 2 illustrates surface treatment, and is understood to be applied to the entire surface upon which it occurs.

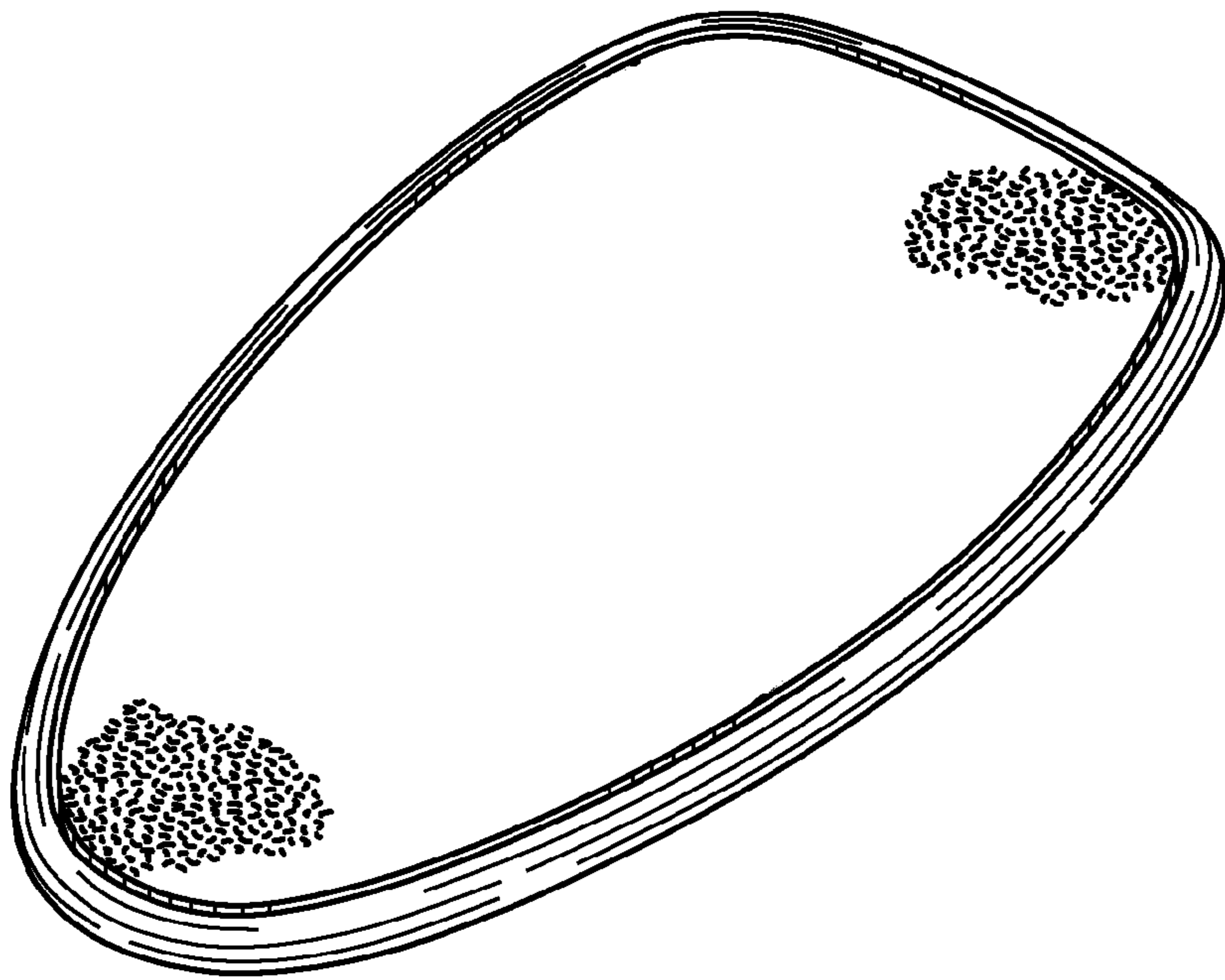

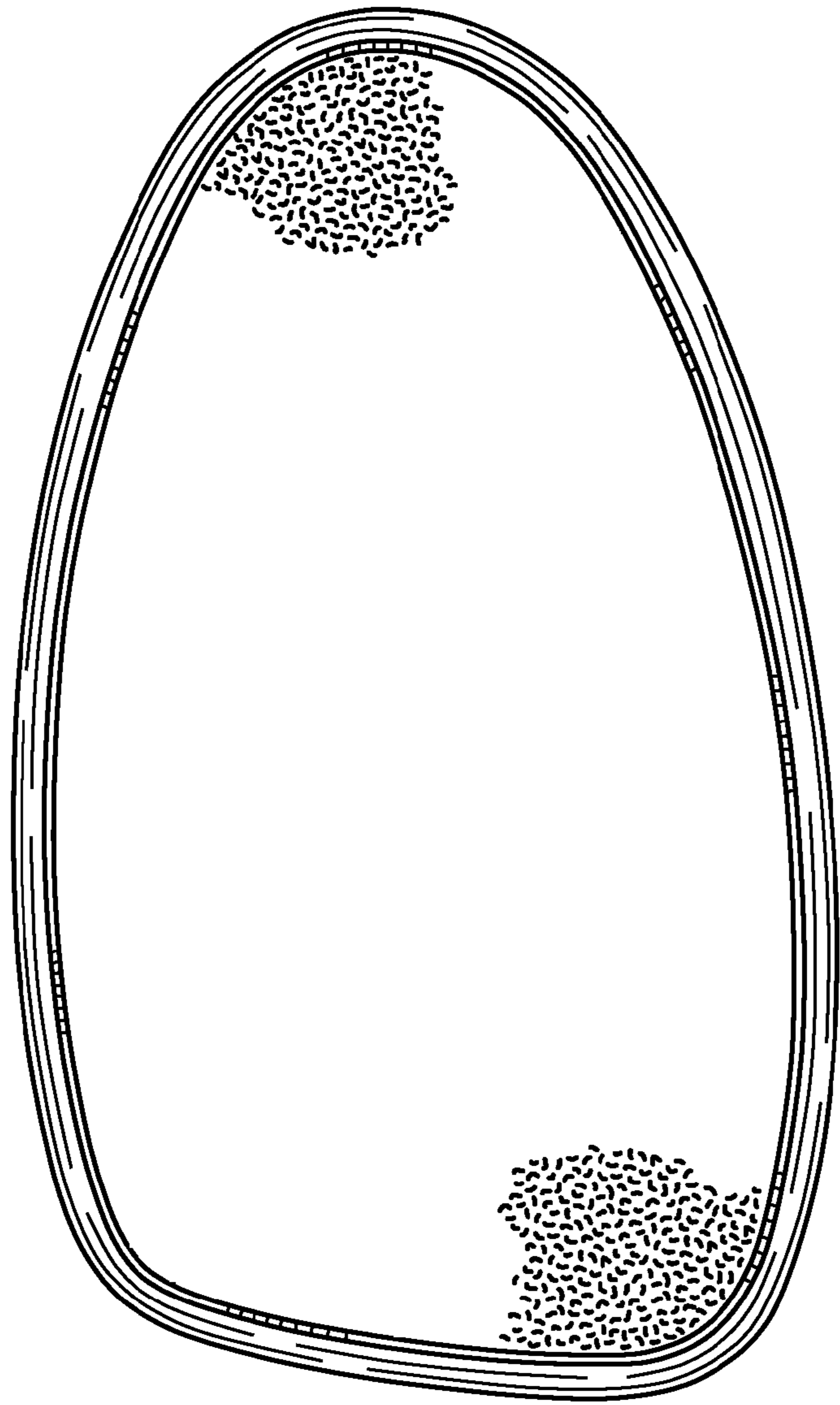

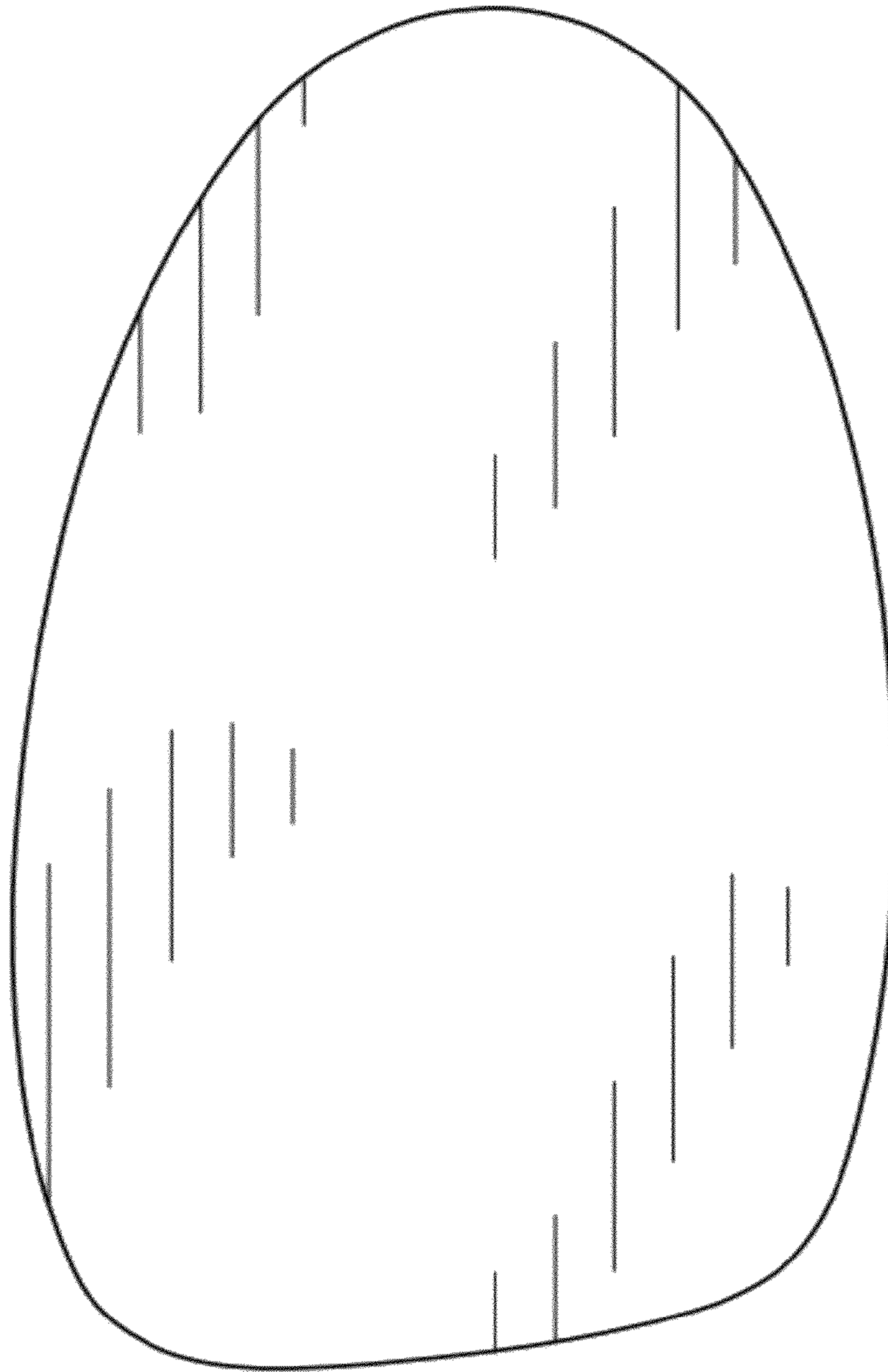
