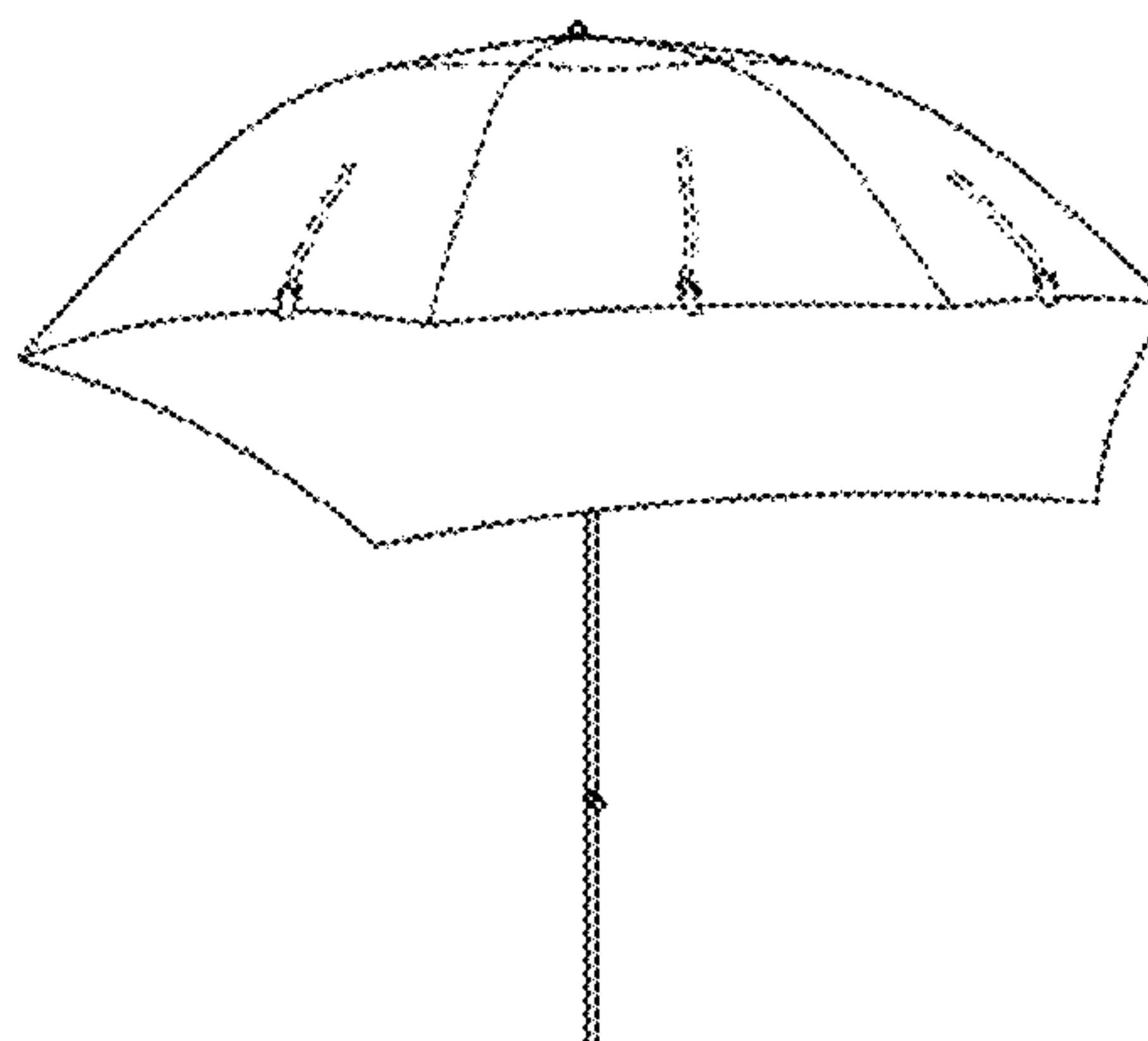
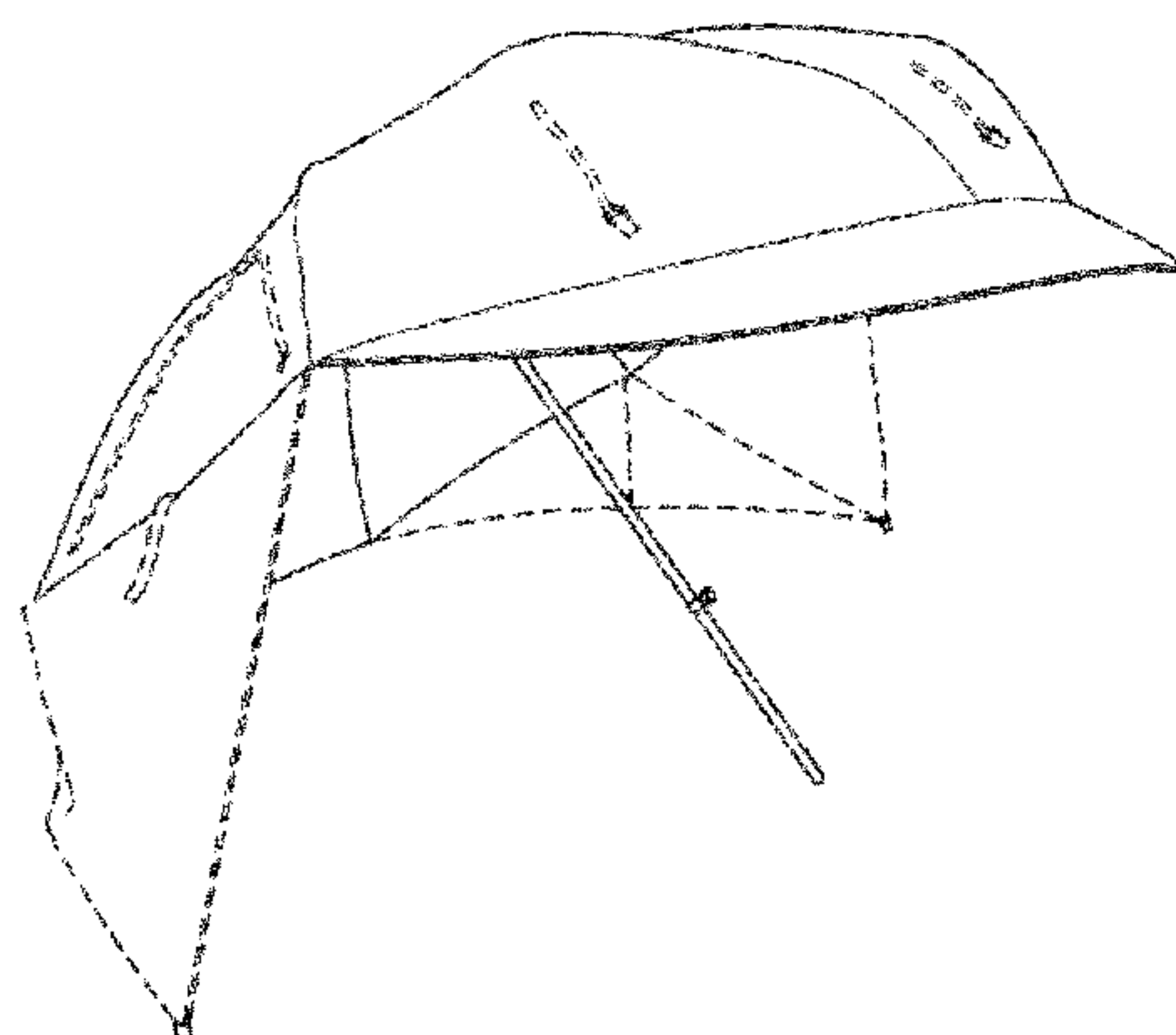
(57) **CLAIM**

We claim the ornamental design for a sports umbrella, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the sports umbrella;  
FIG. 2 is a left perspective view of the sports umbrella;  
FIG. 3 is a front view of the sports umbrella with a bill in a raised position;  
FIG. 4 is a front view of the sports umbrella with a bill in a lowered position;  
FIG. 5 is a top view of the sports umbrella; and,  
FIG. 6 is a bottom view of the self sports umbrella.  
The broken lines shown in the figures are for illustrative purposes only and form no part of the claimed design.

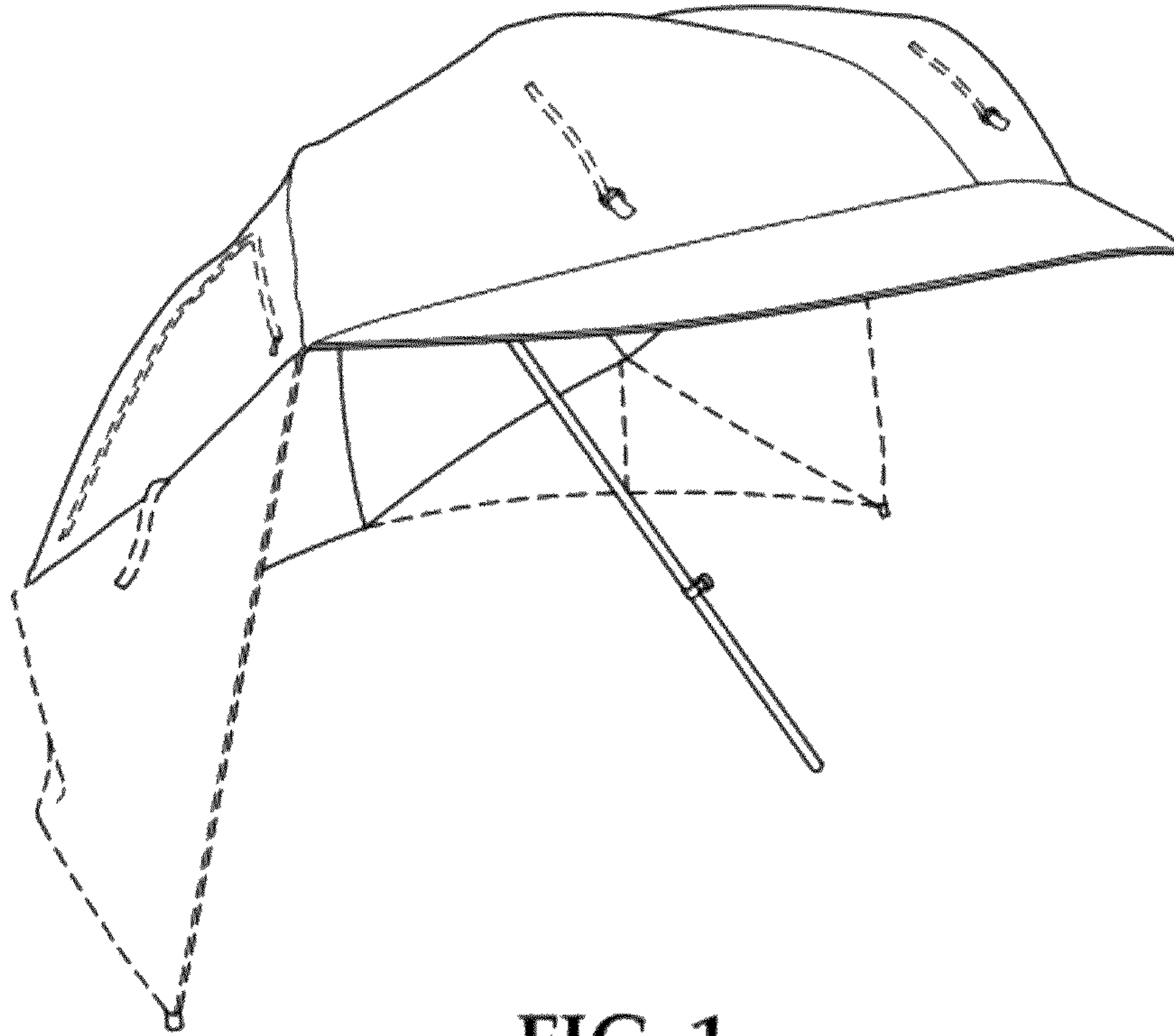

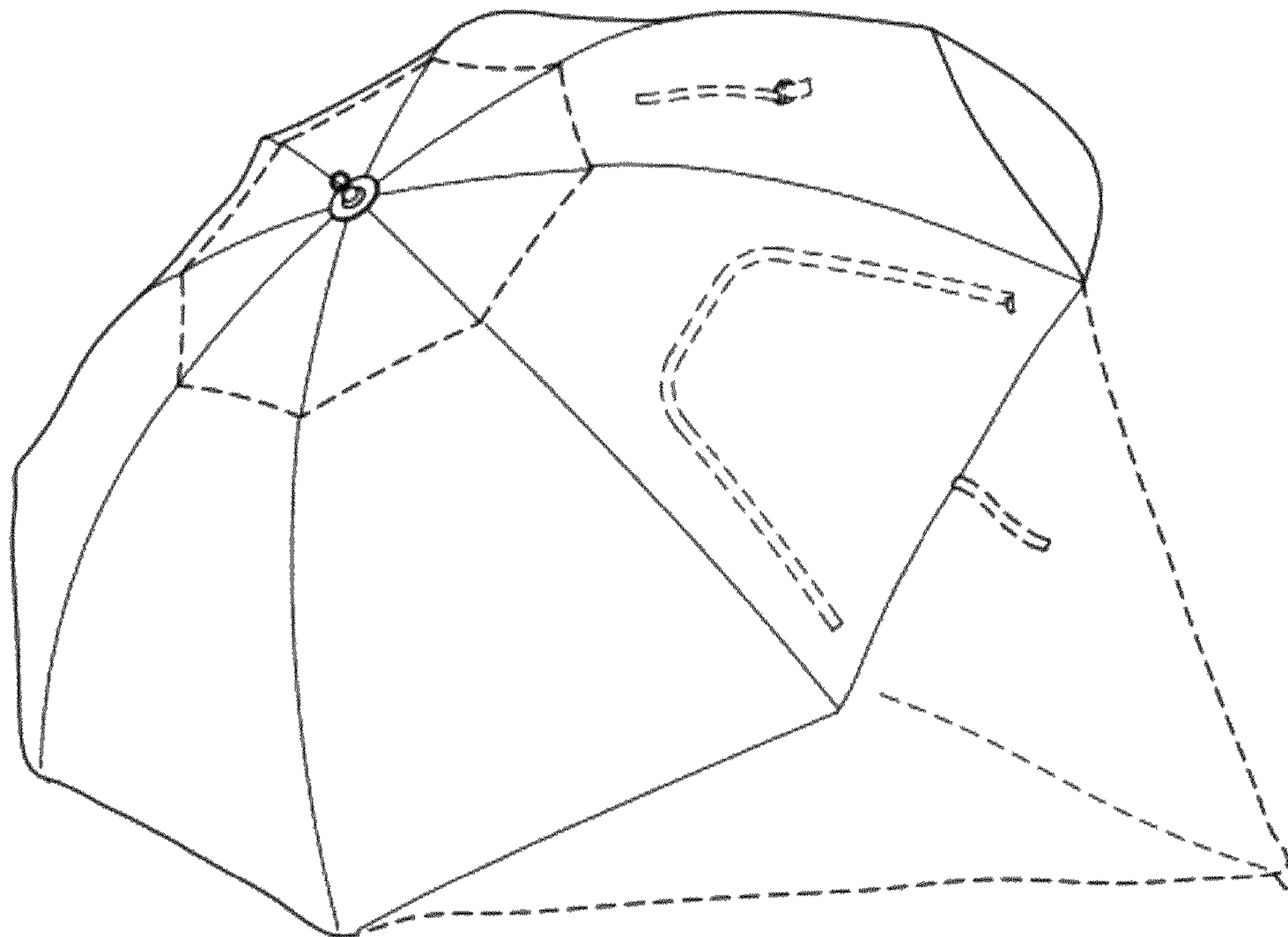

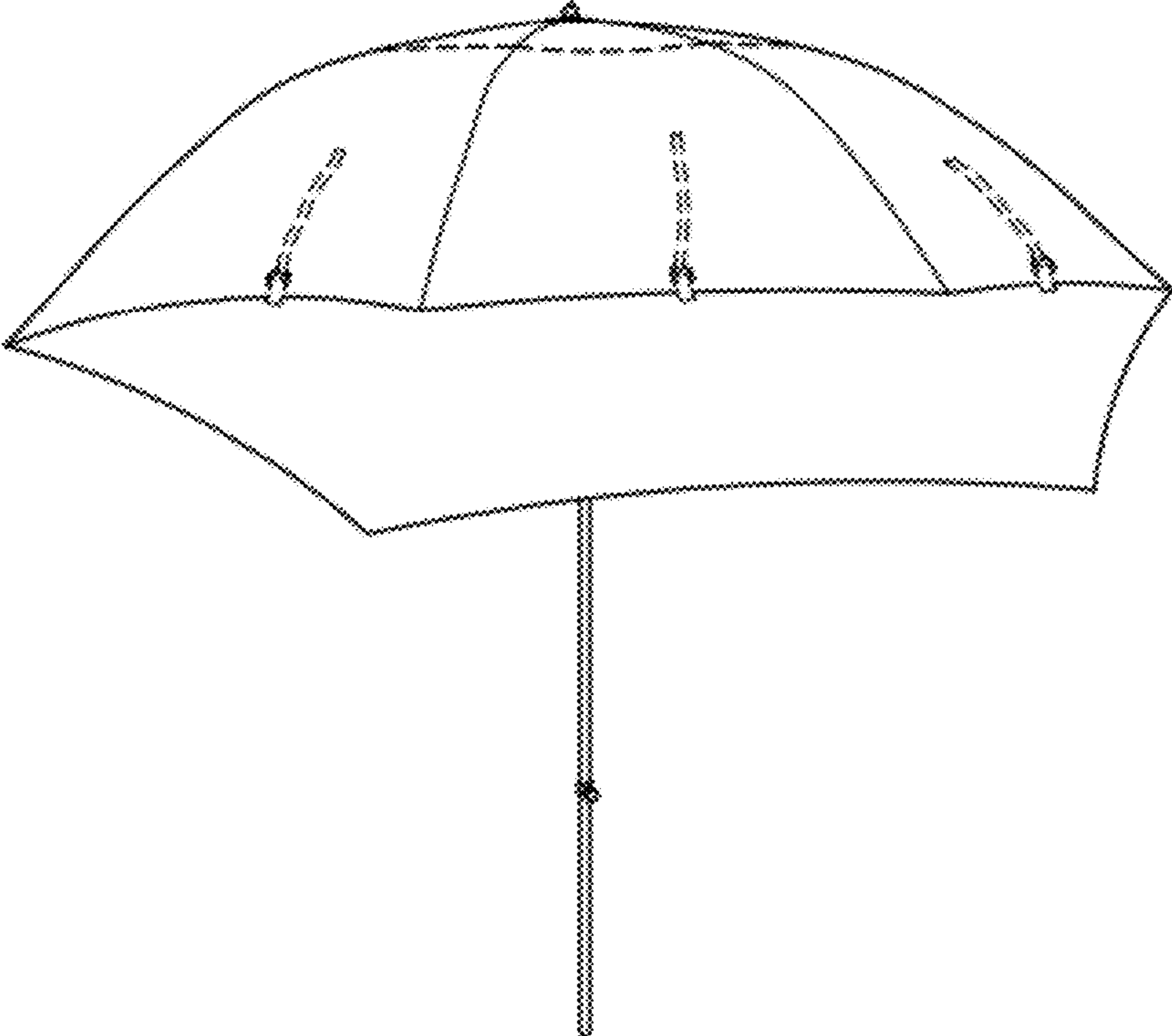

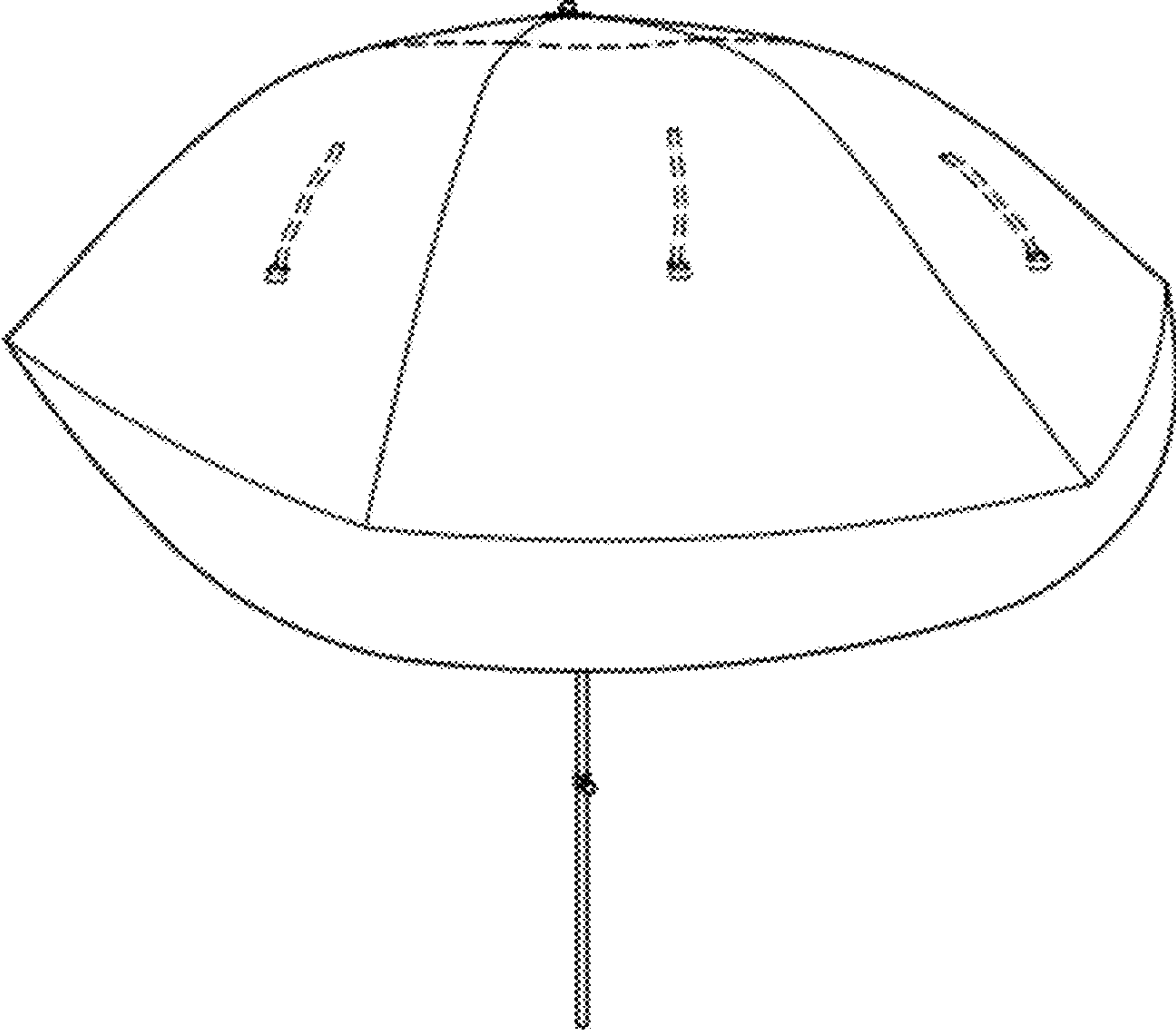

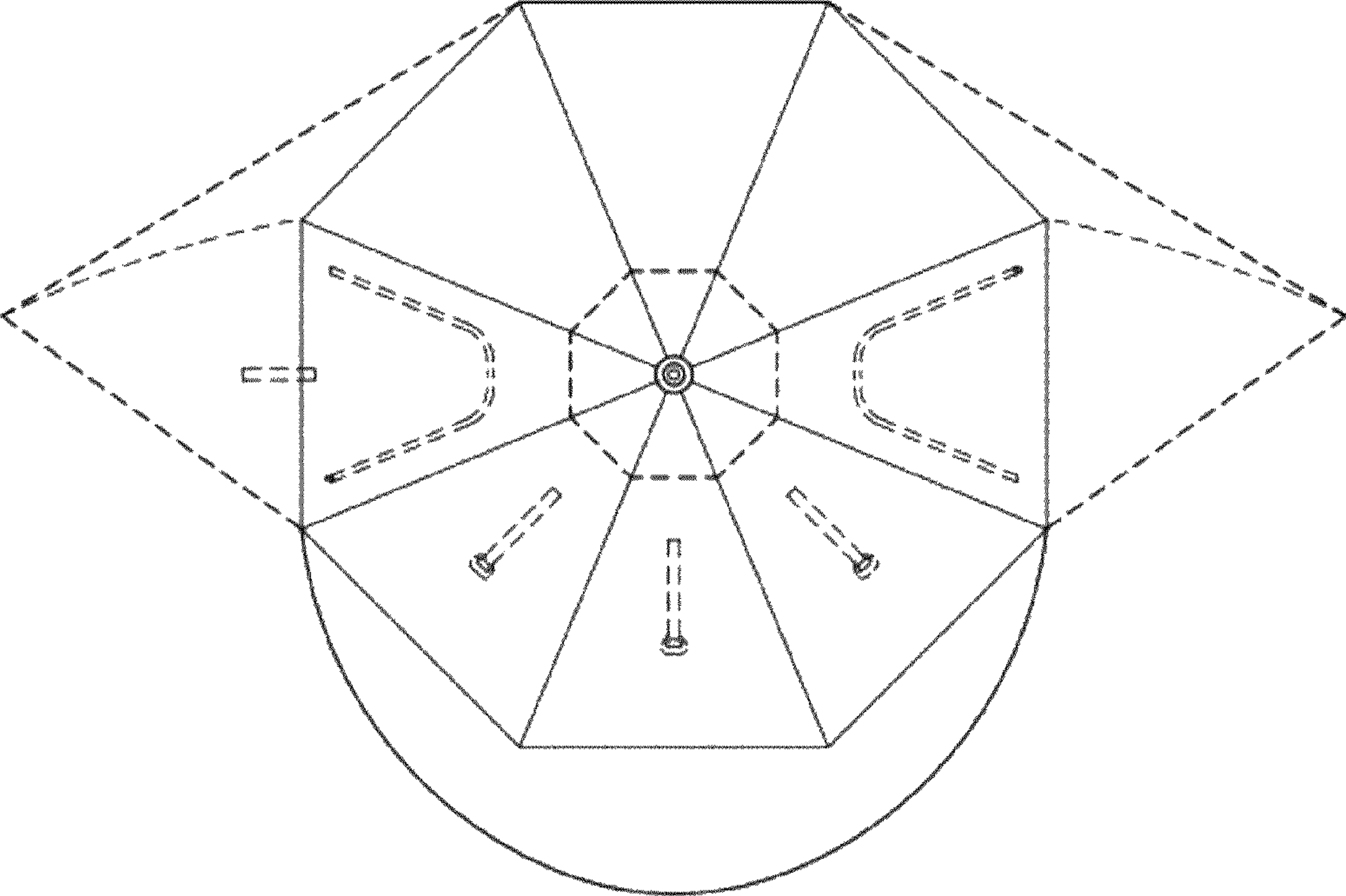

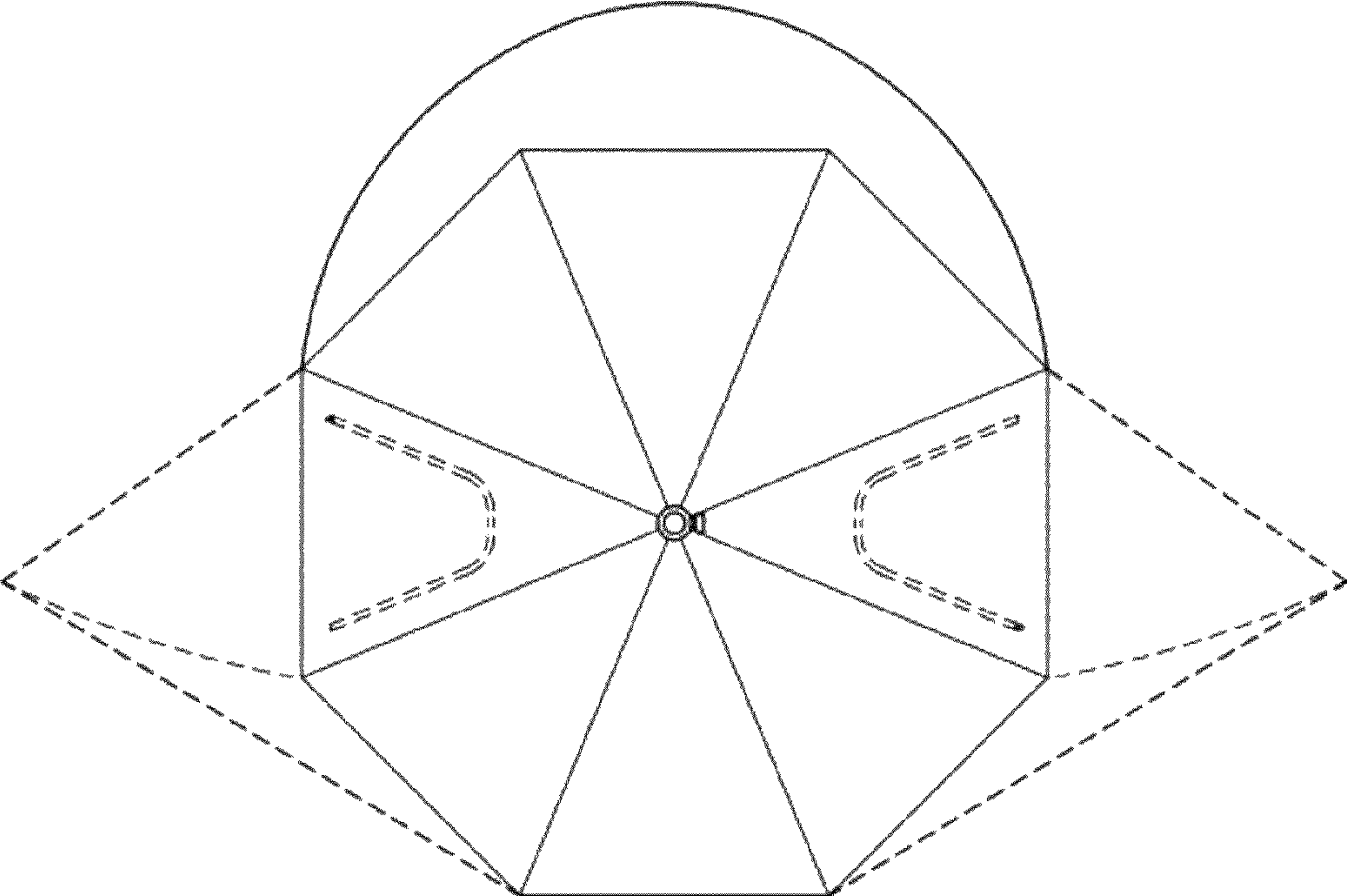
