(57) **CLAIM**

The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first design of the chair, illustrating my new design;

FIG. 2 is a front elevational view of the chair shown in FIG. 1;

FIG. 3 is a rear elevational view of the chair shown in FIG. 1;

FIG. 4 is a side elevational view of one side of the chair shown in FIG. 1, with FIG. 5 being a side elevational view of the other side of the chair shown in FIG. 1;

FIG. 6 is a top plan view of the chair shown in FIG. 1;

FIG. 7 is a perspective view of a second design of the chair, illustrating my design;

FIG. 8 is a front elevational view of the chair shown in FIG. 7;

FIG. 9 is a rear elevational view of the chair shown in FIG. 7;

FIG. 10 is a side elevational view of one side of the chair shown in FIG. 7, with FIG. 11 being a side elevational view of the other side of the chair shown in FIGS. 7; and,

FIG. 12 is a top plan view of the chair shown in FIG. 7.

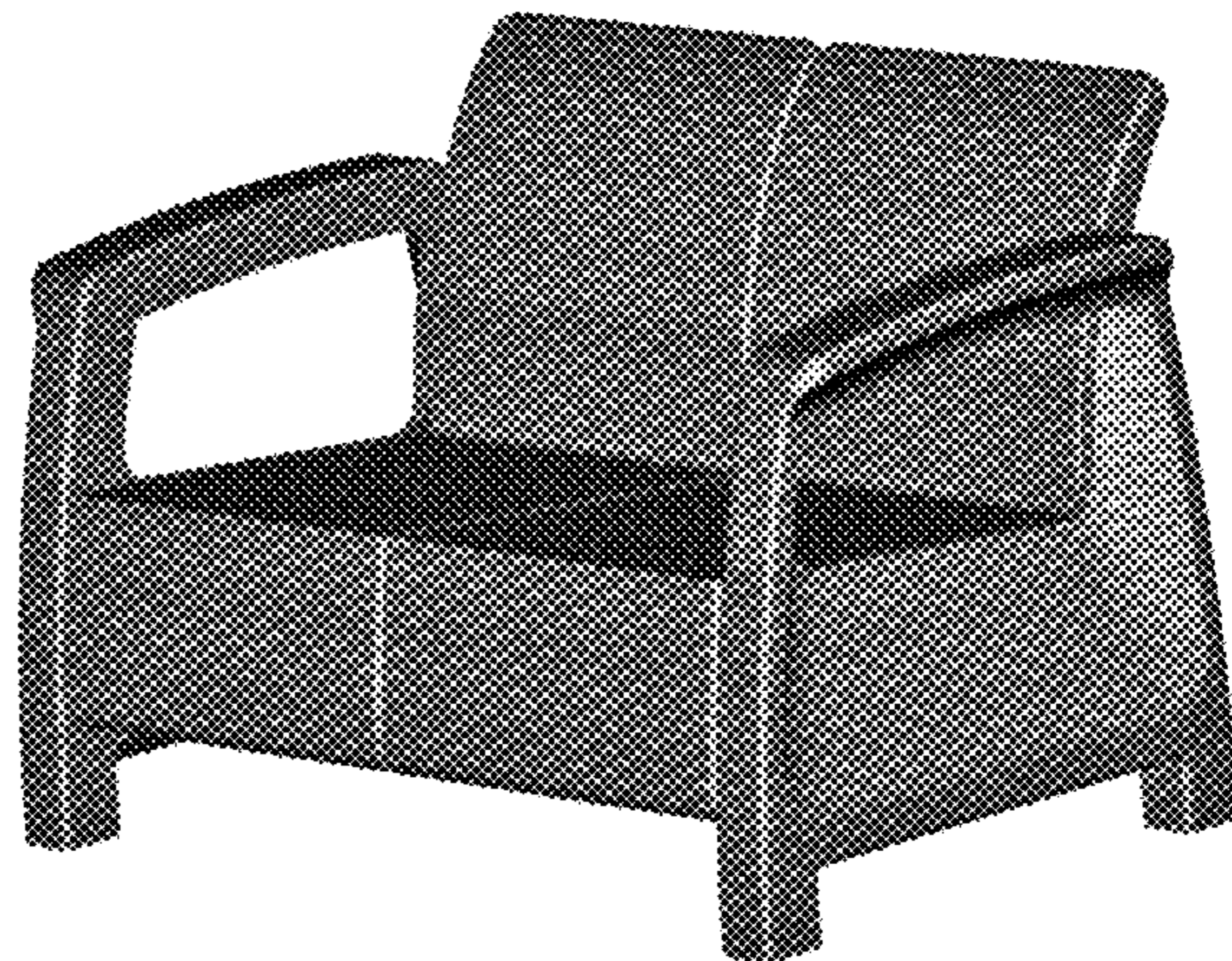
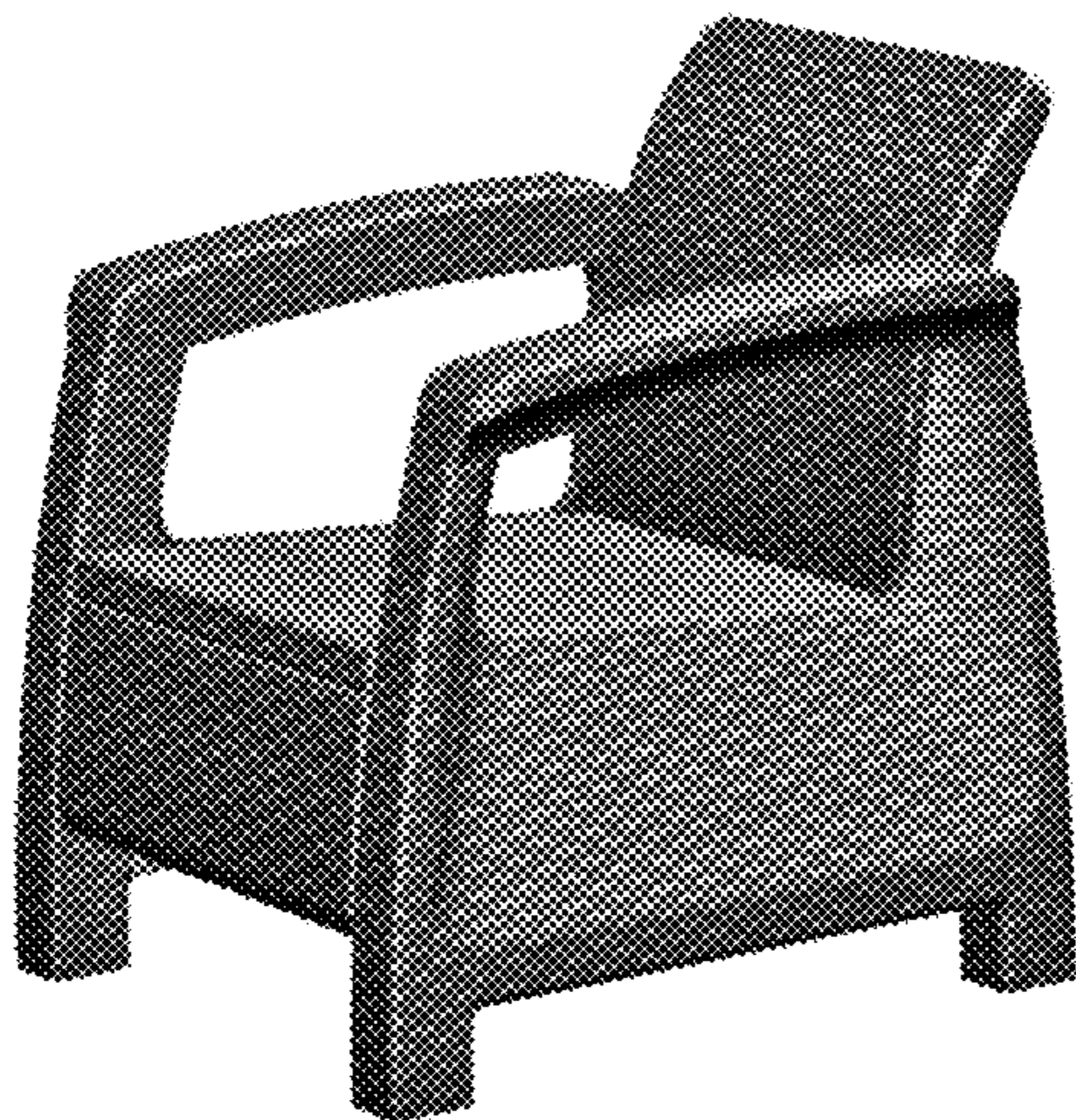

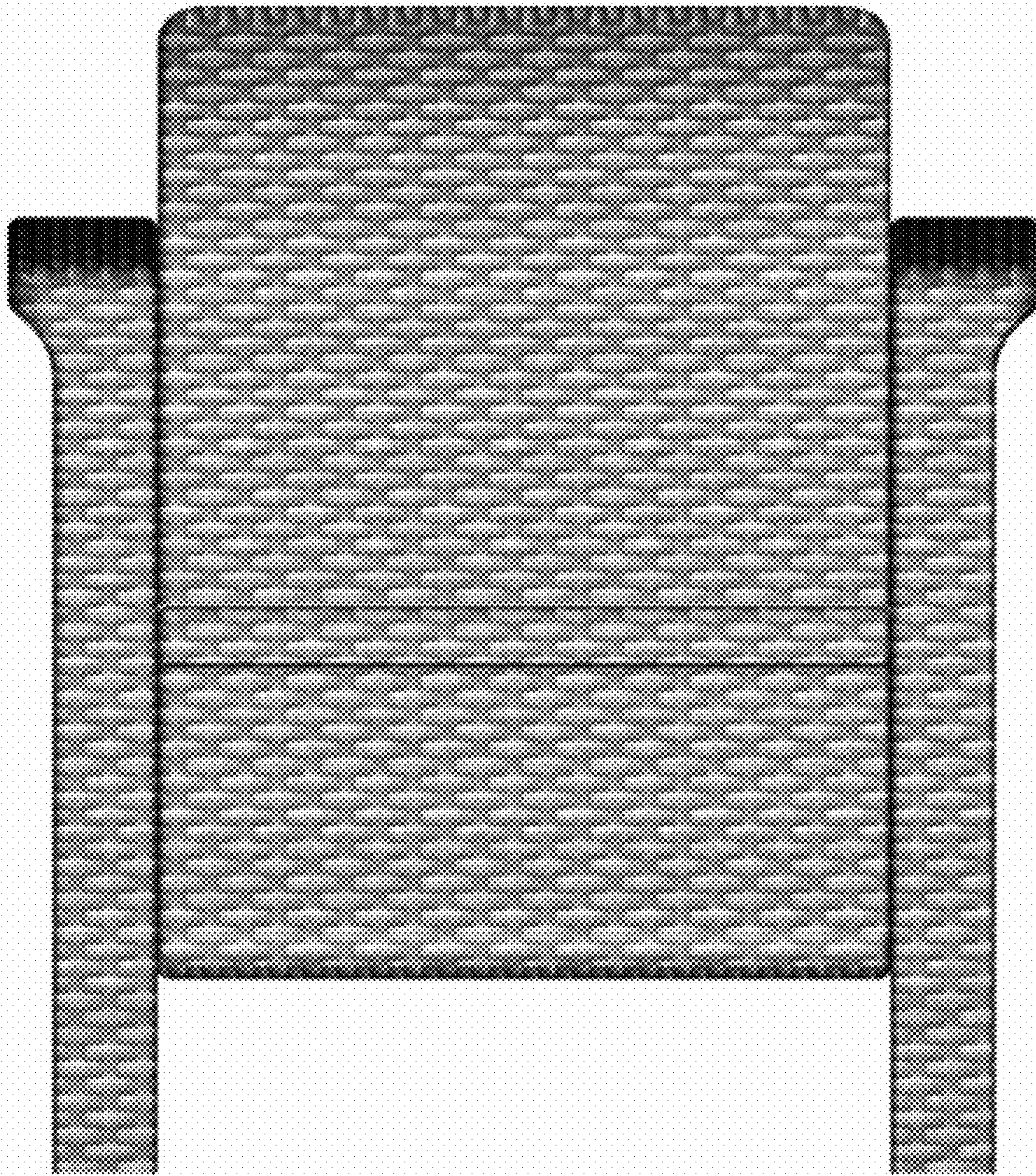

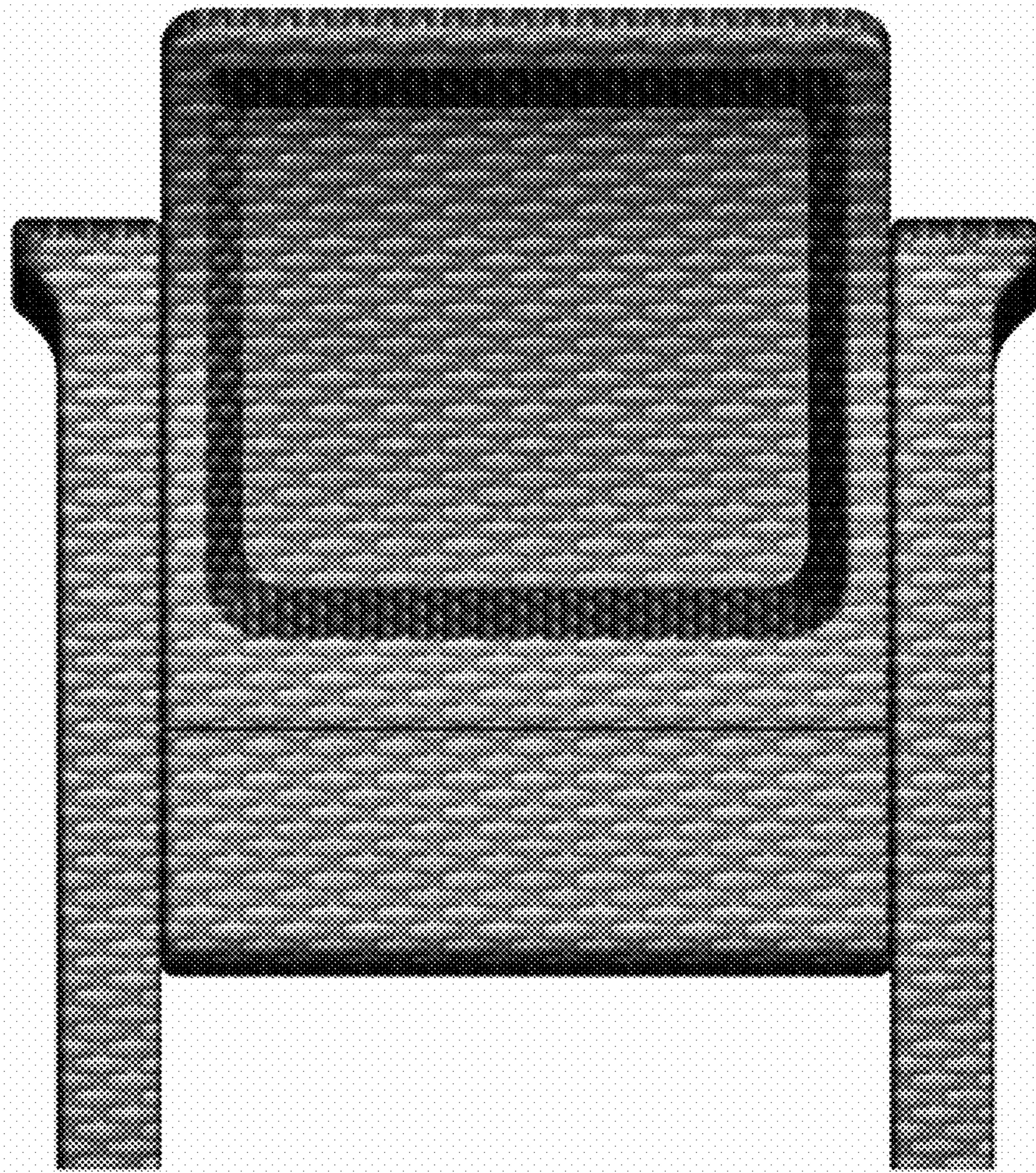

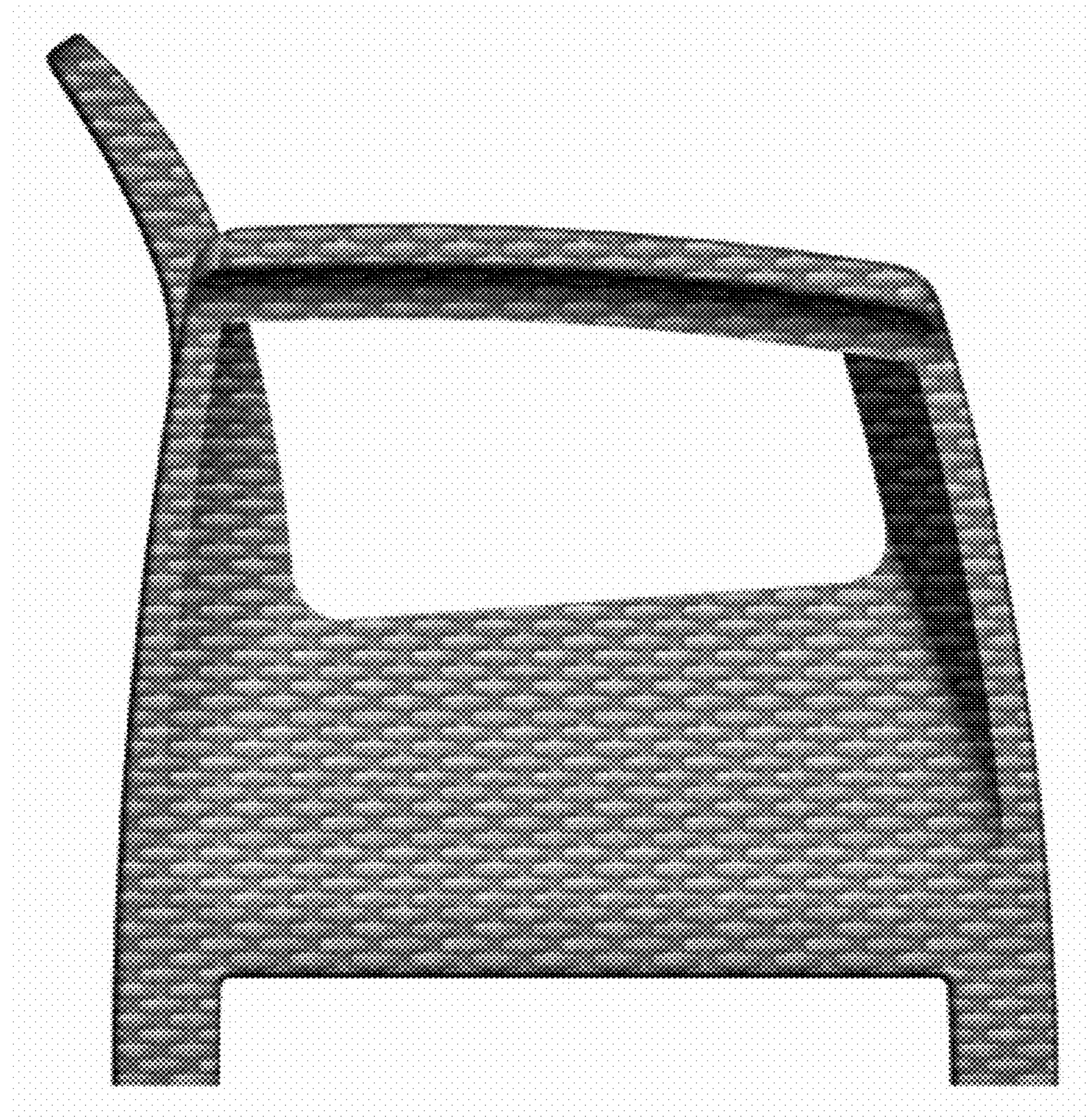

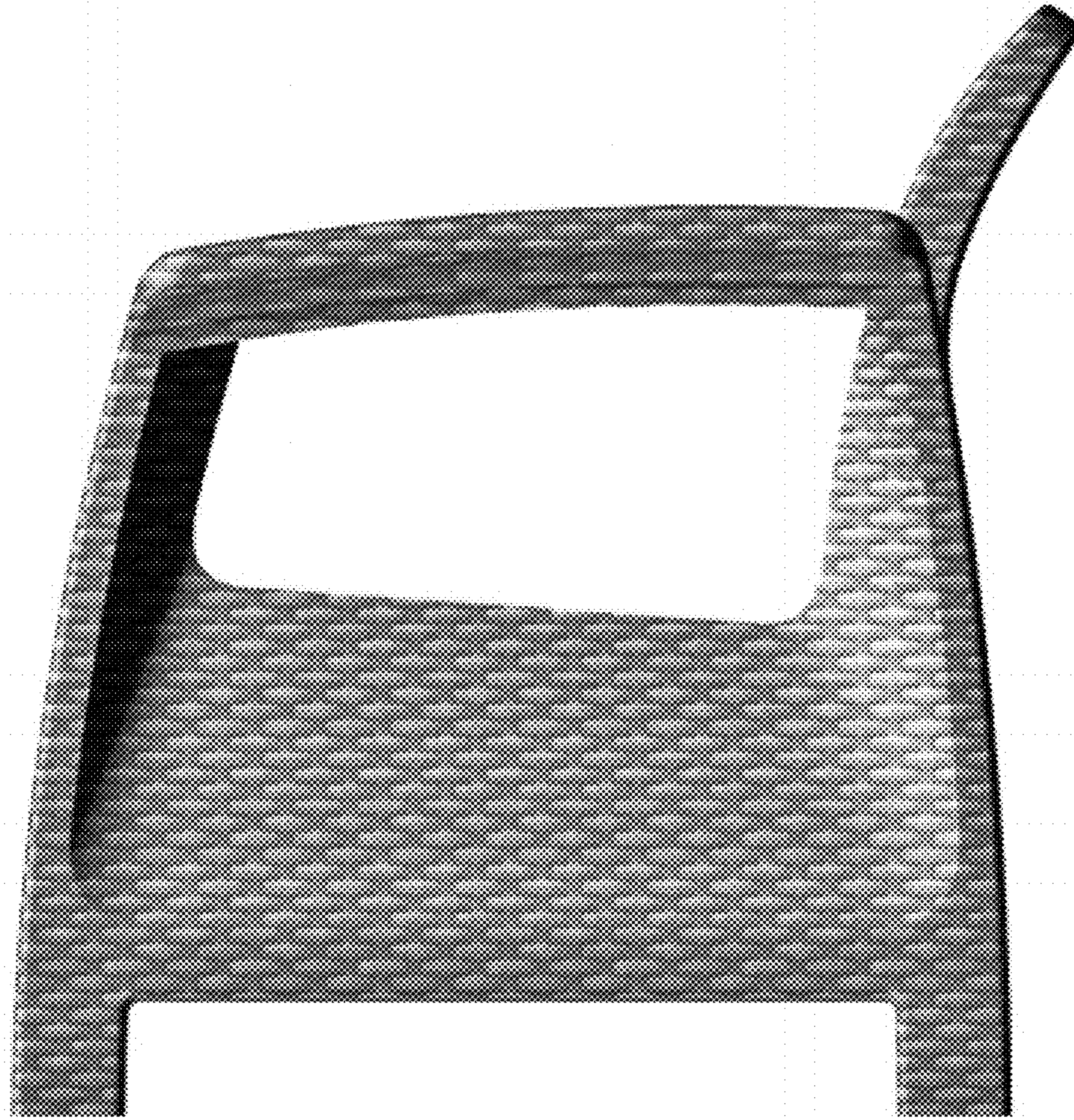

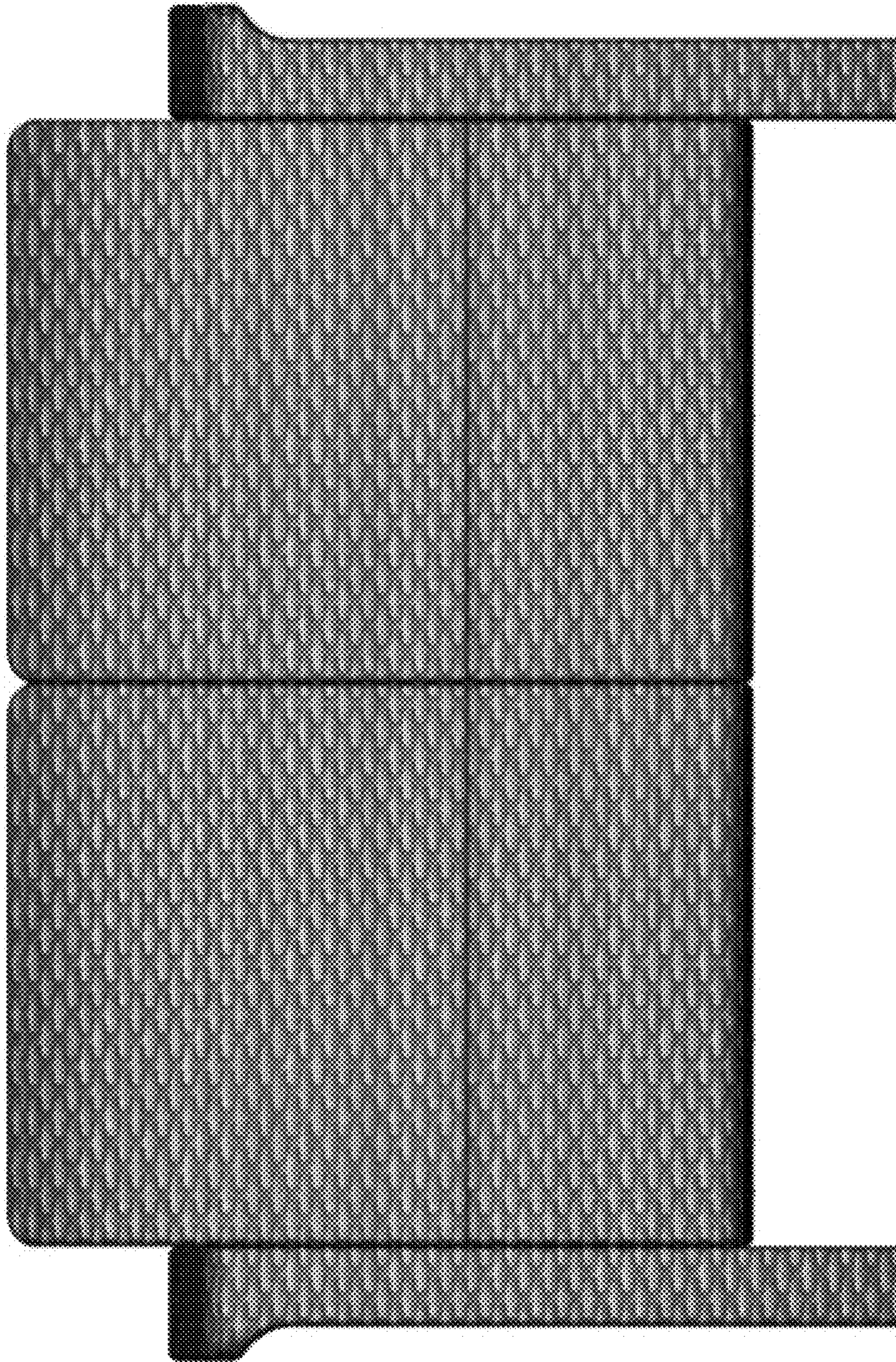

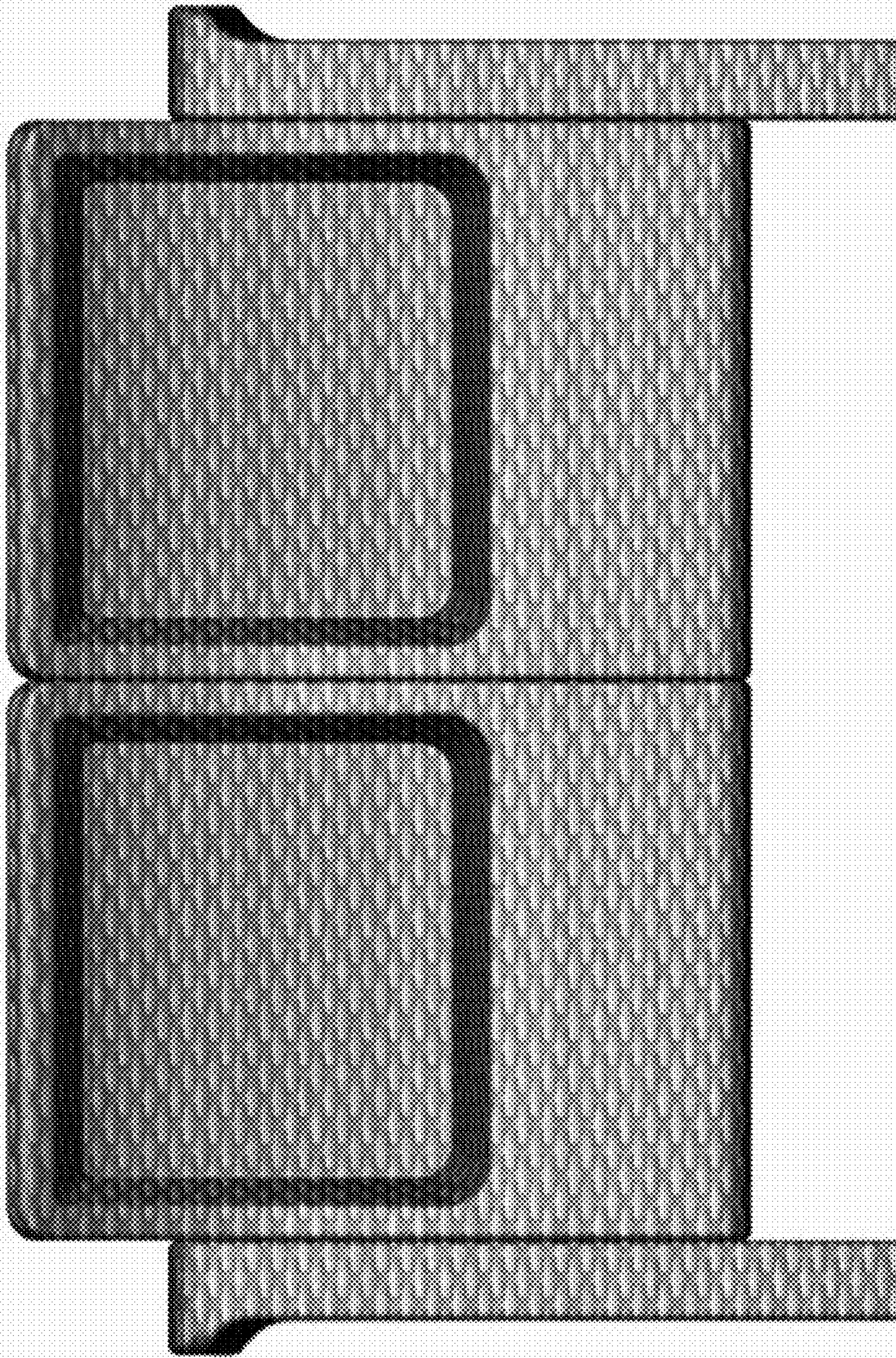

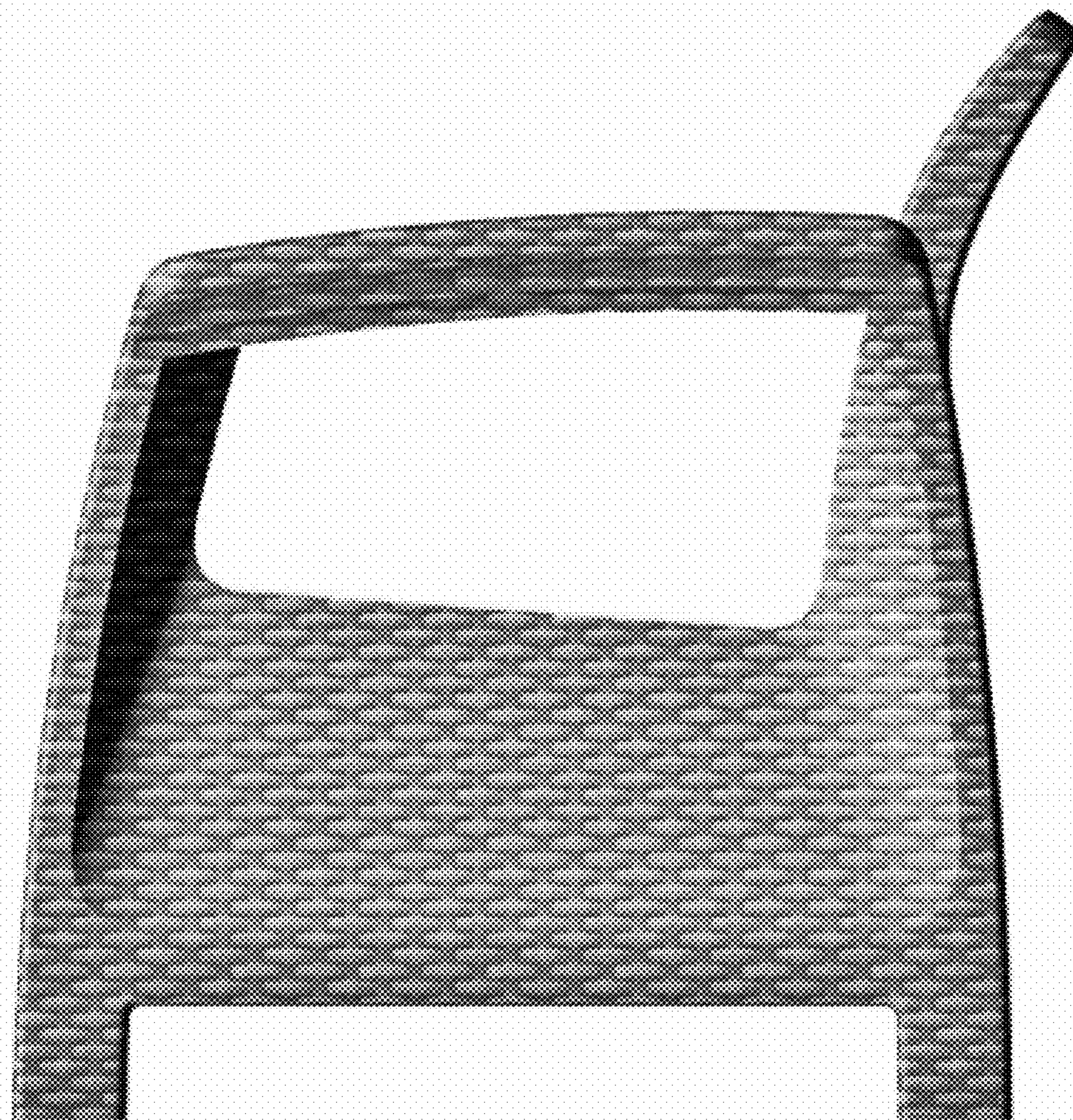

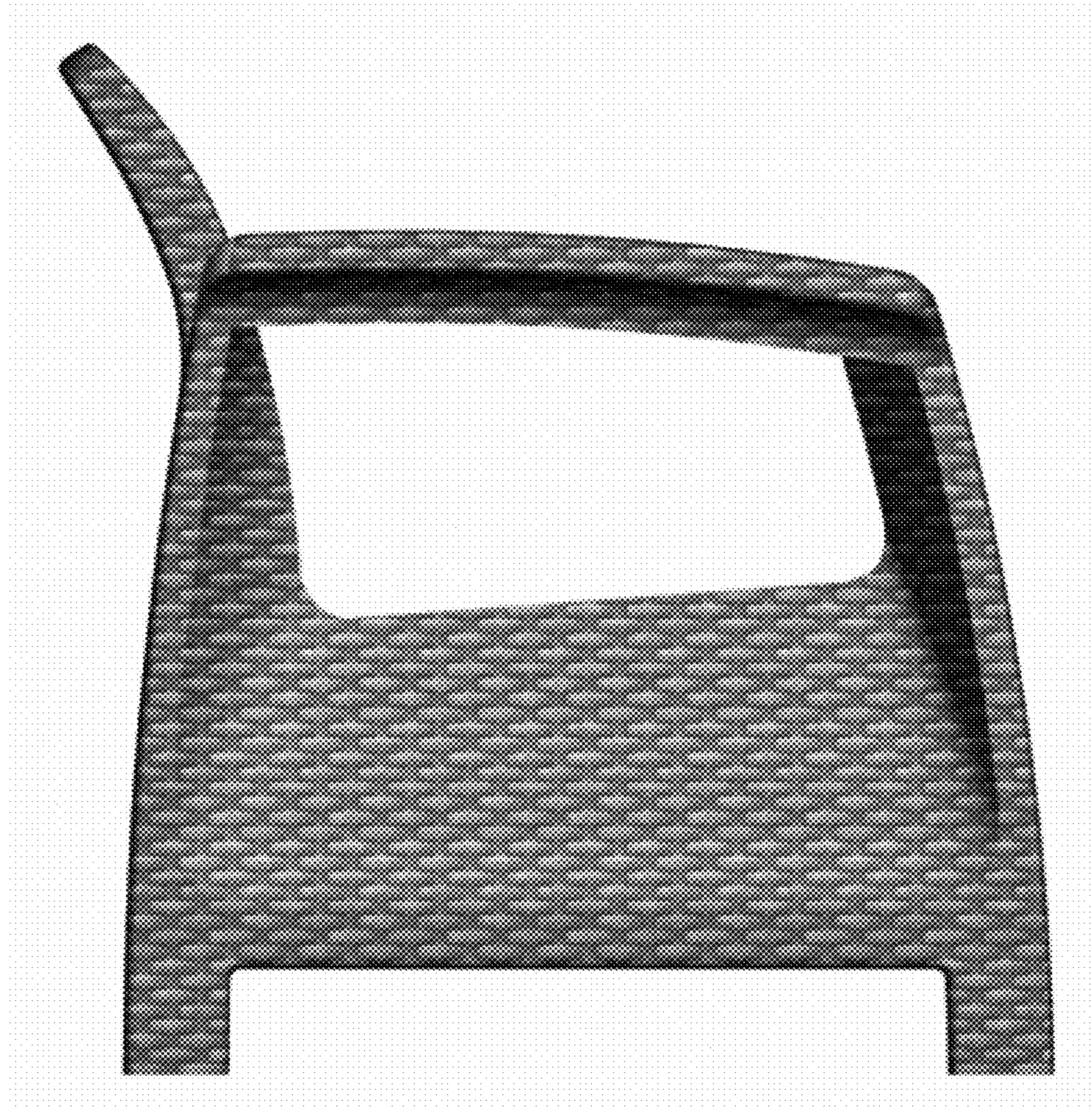

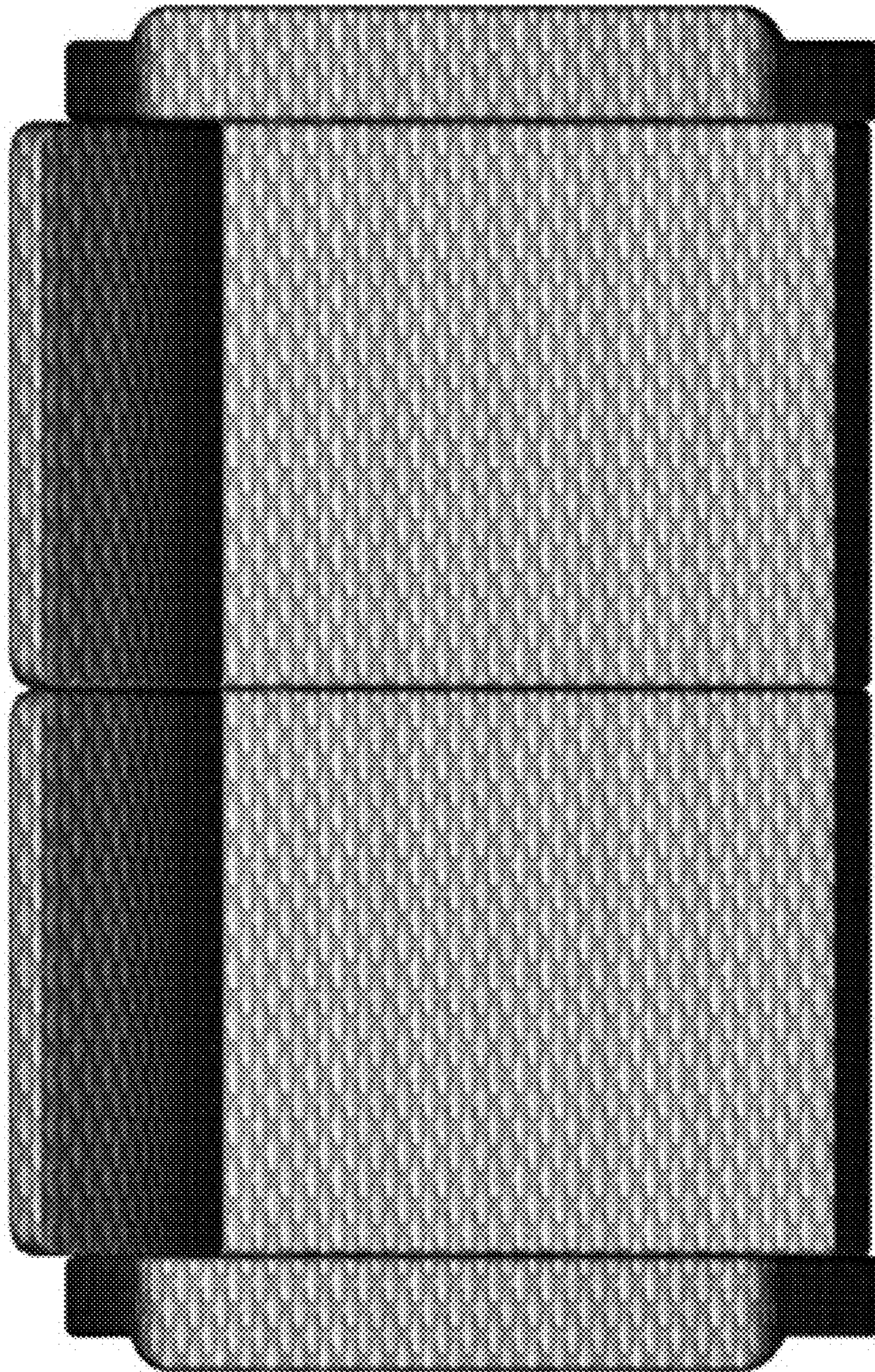
