FIG. 4 is a front side view thereof.

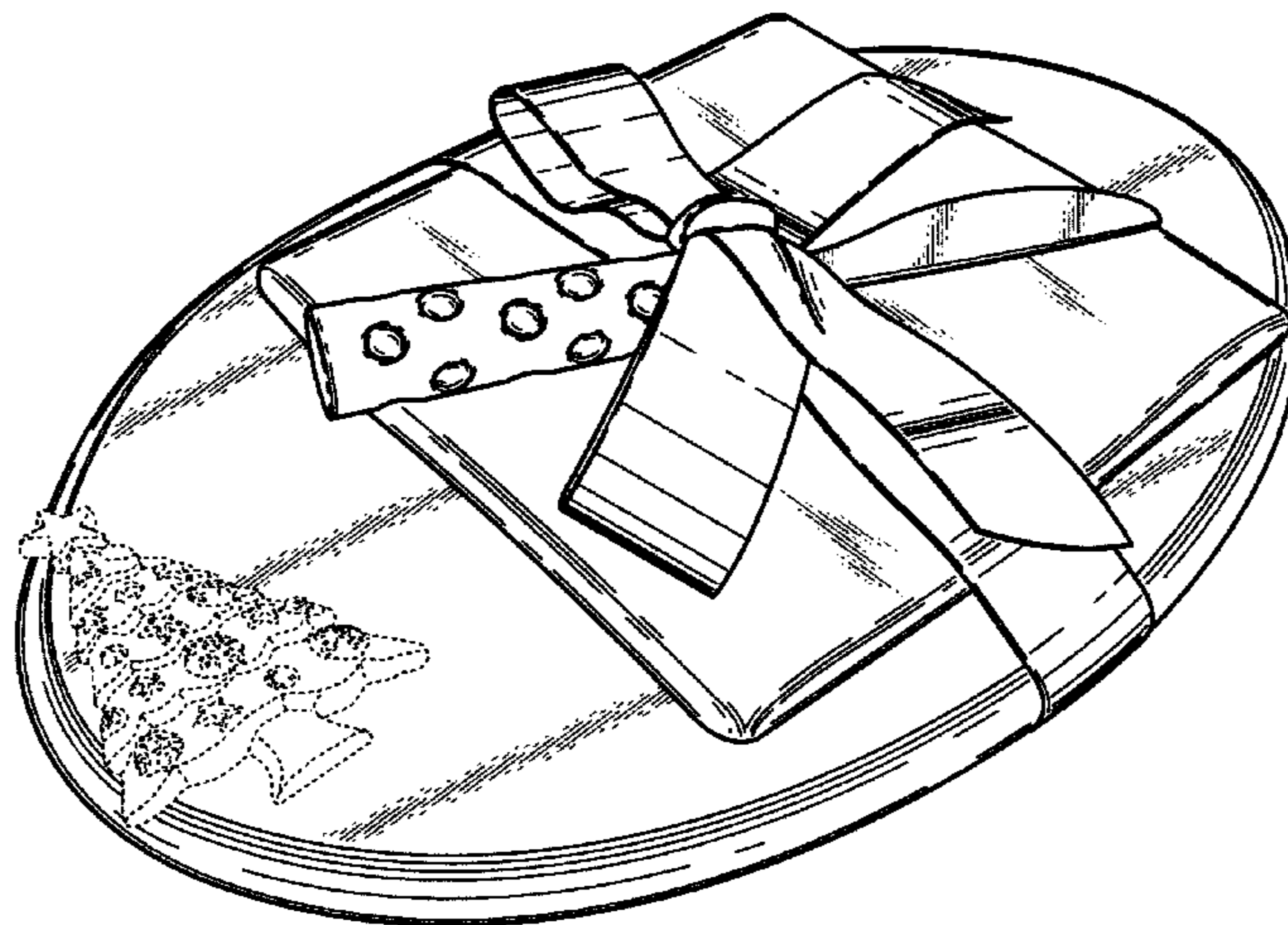
FIG. 5 is a back side view thereof.

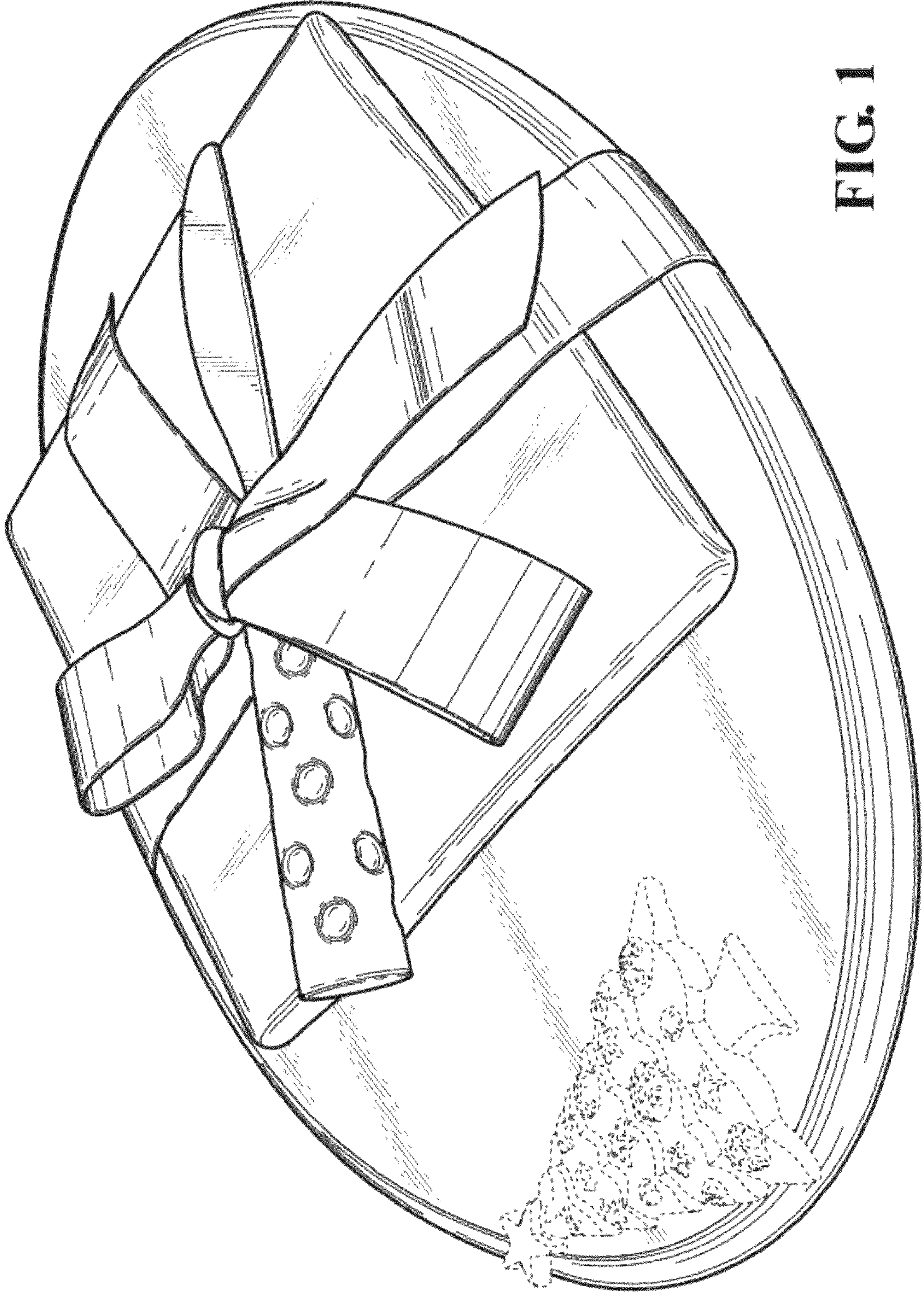

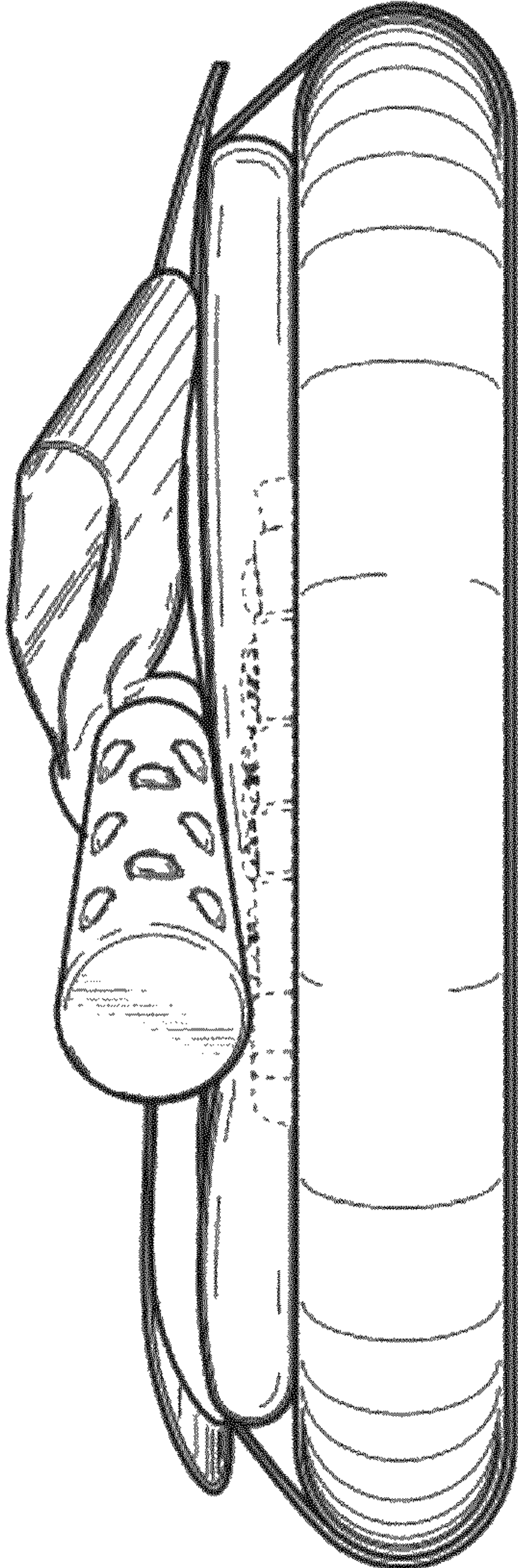

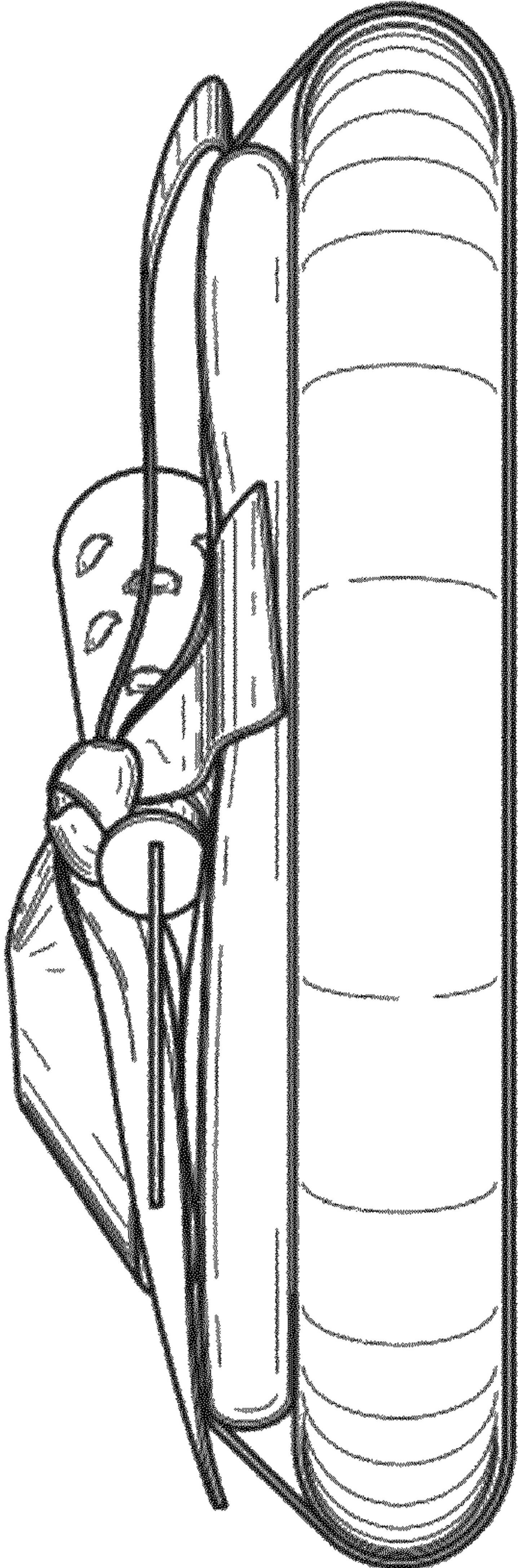

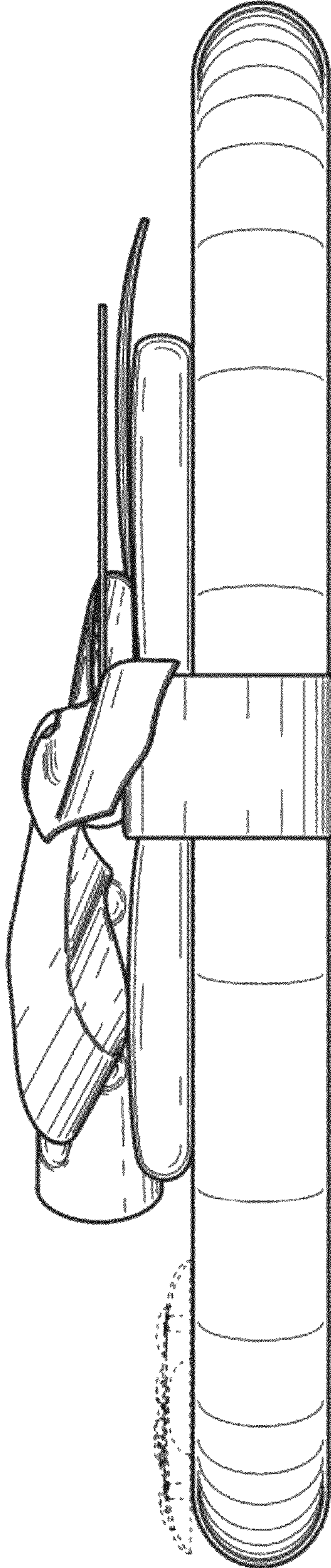

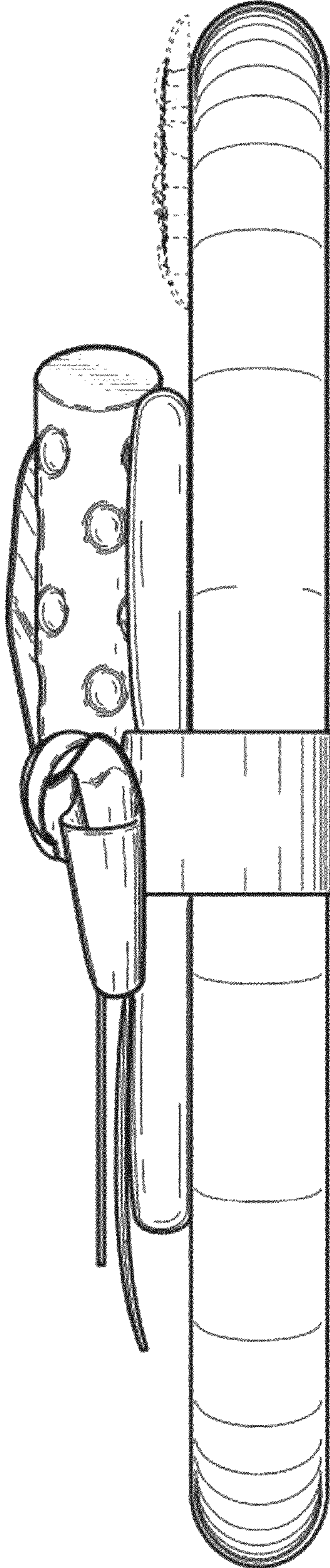

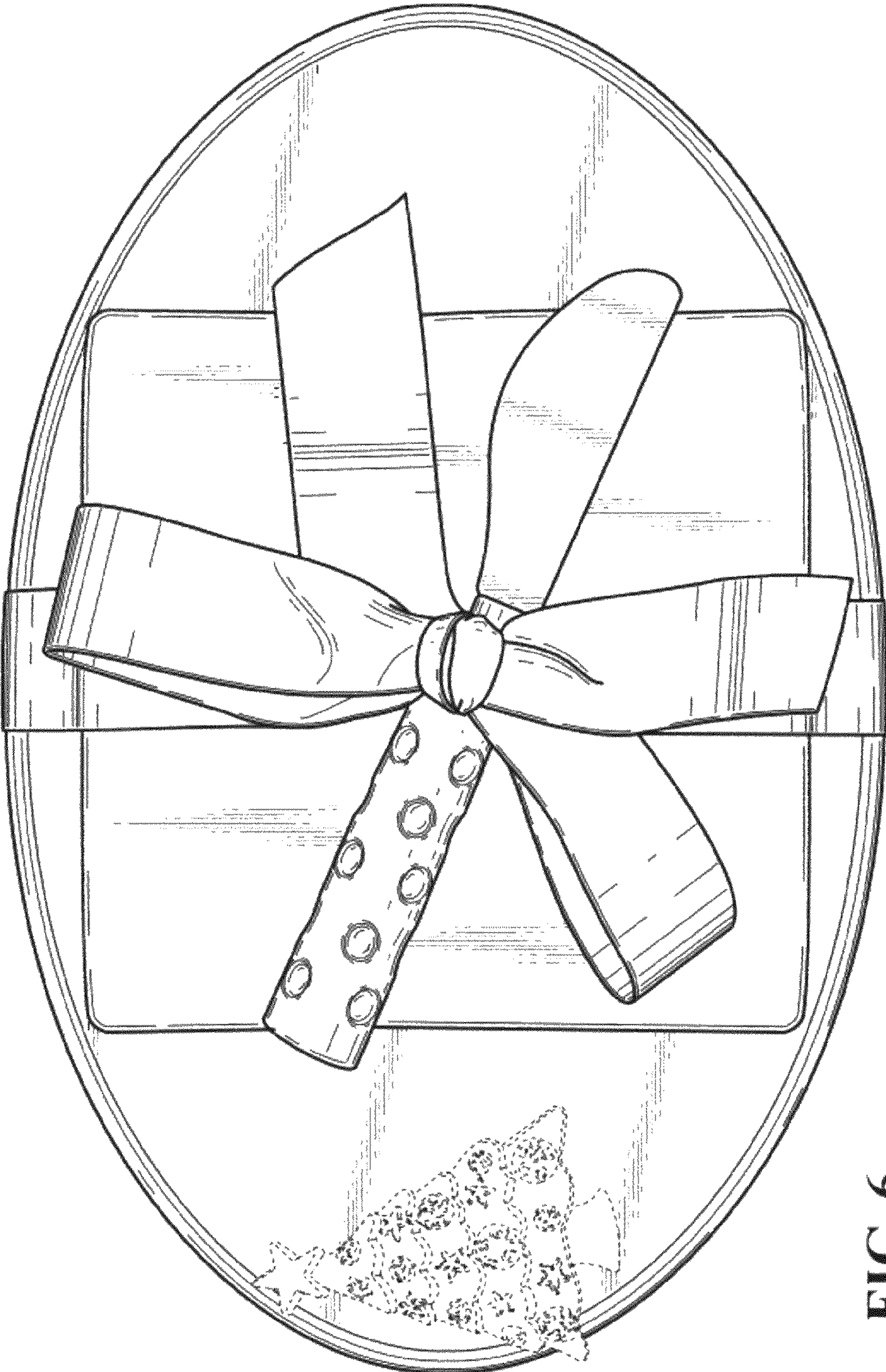

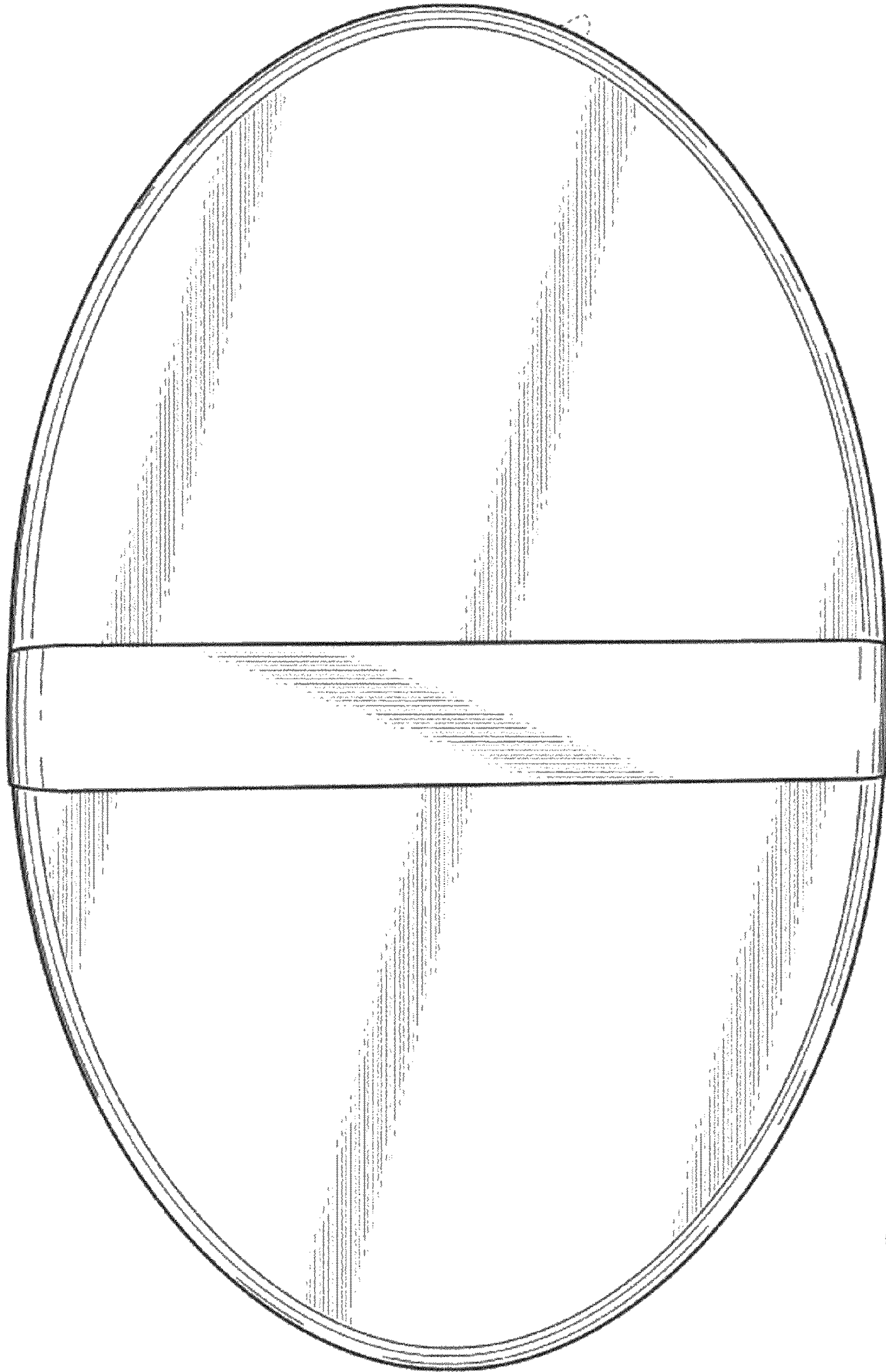
