FIG. 1 is a top, front, right side perspective view our new design;

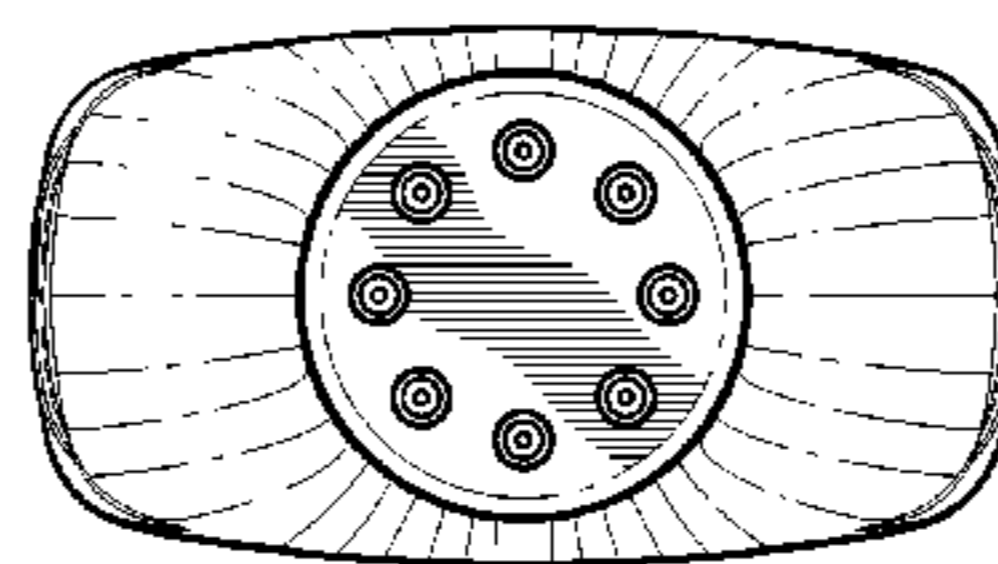
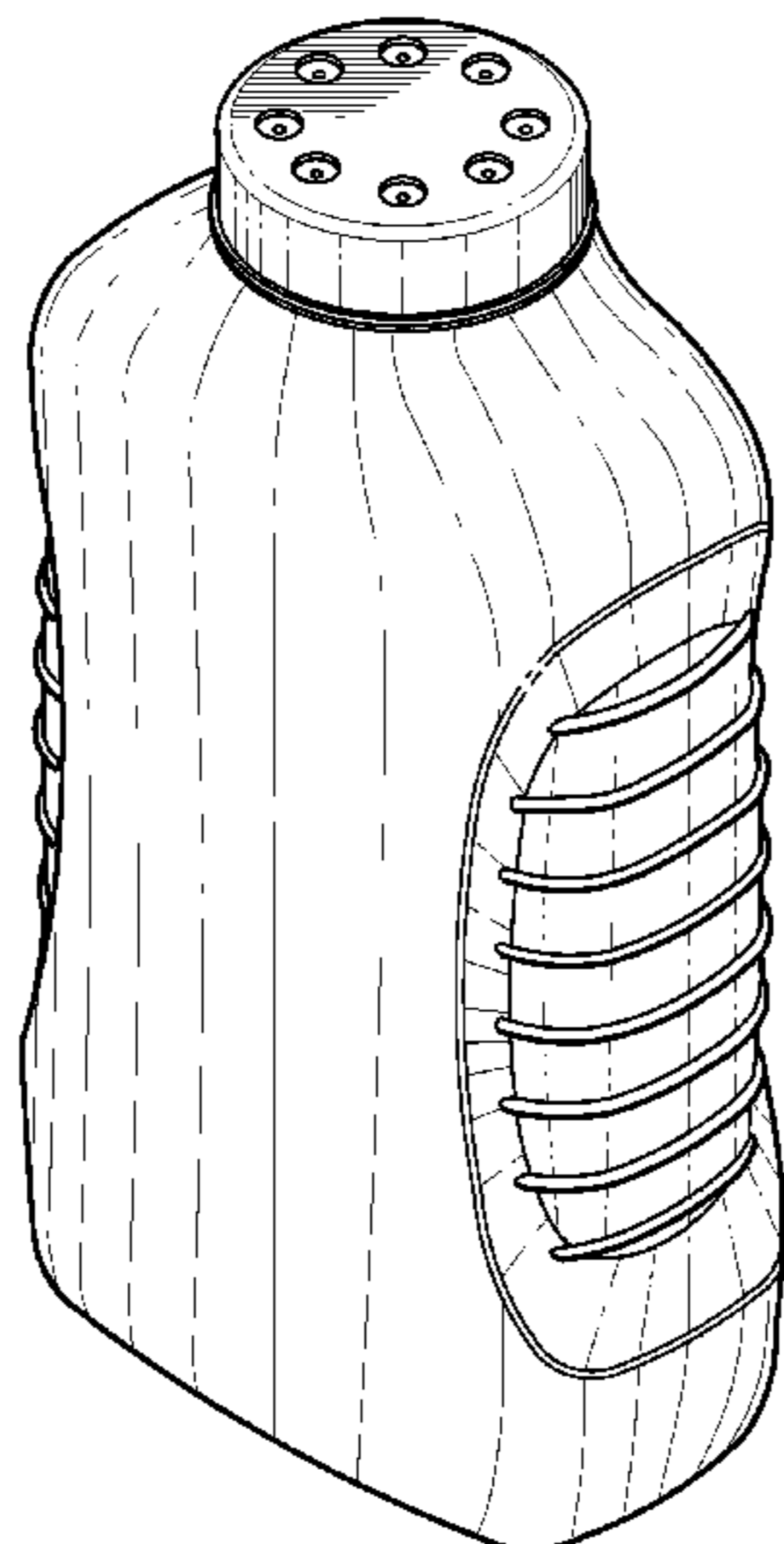
FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image;

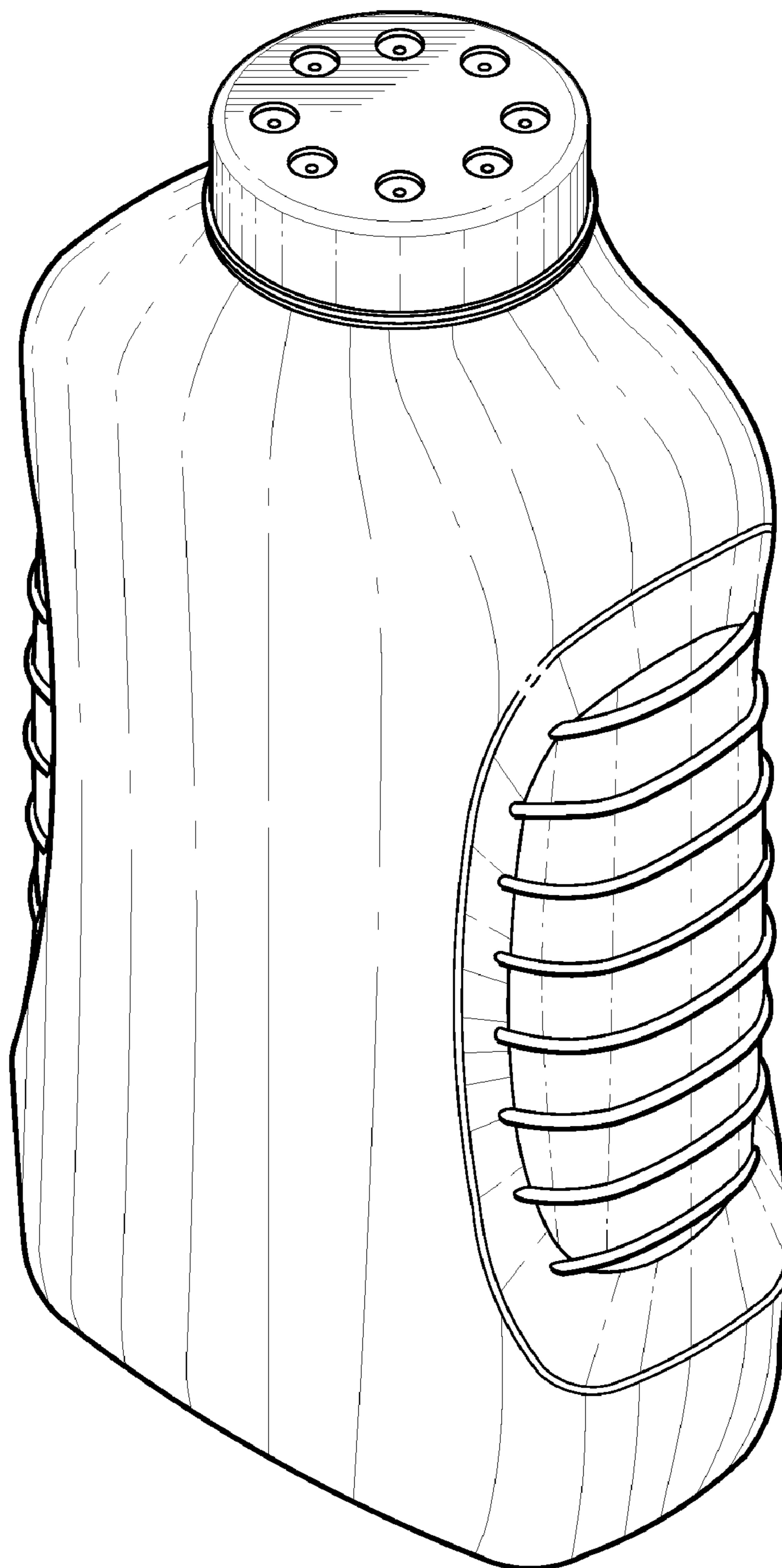

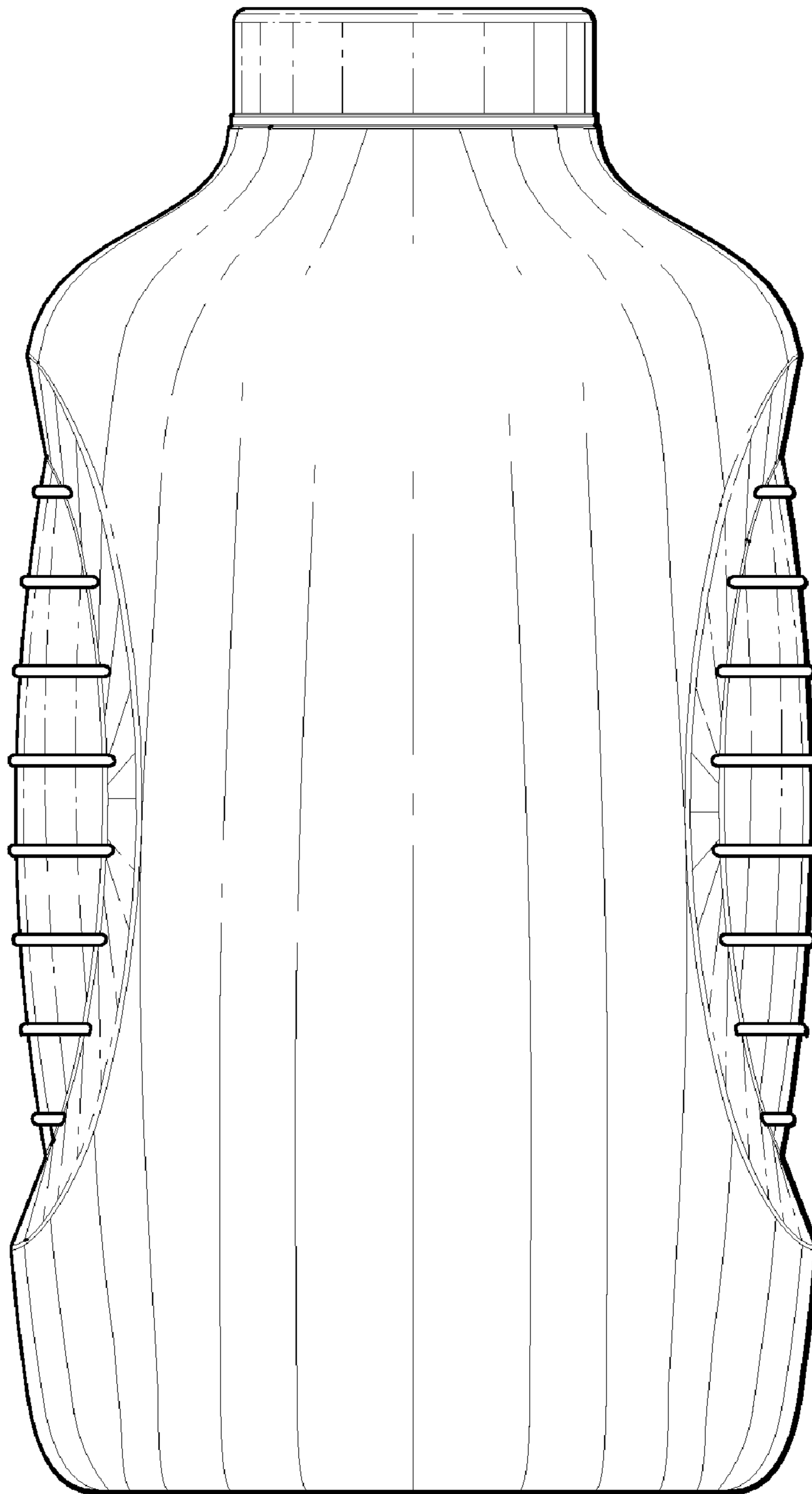

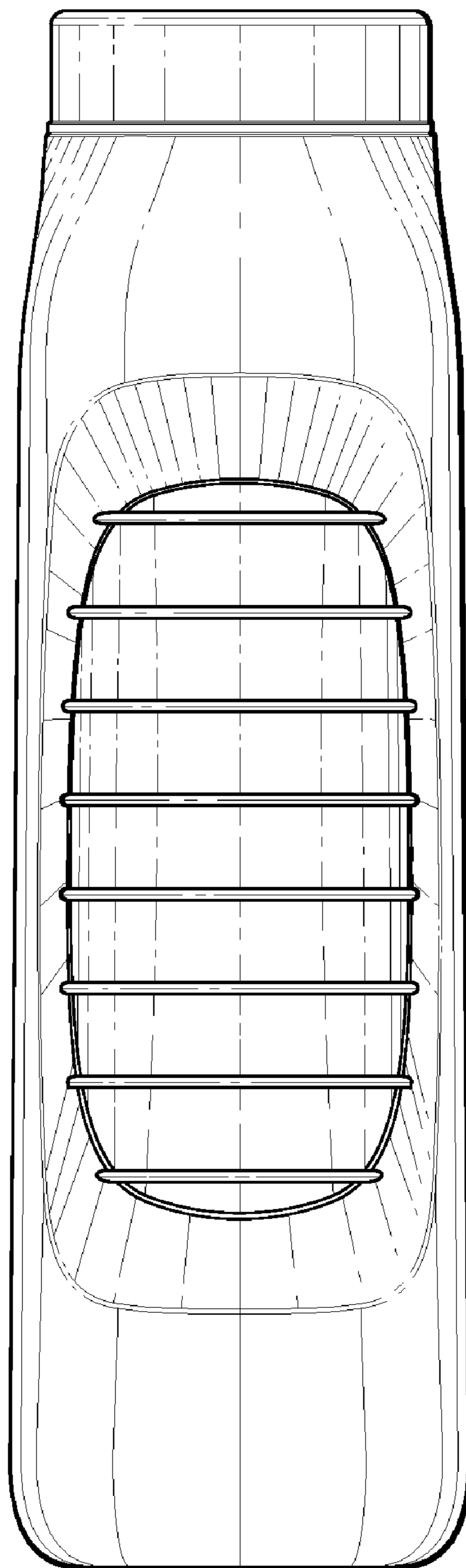

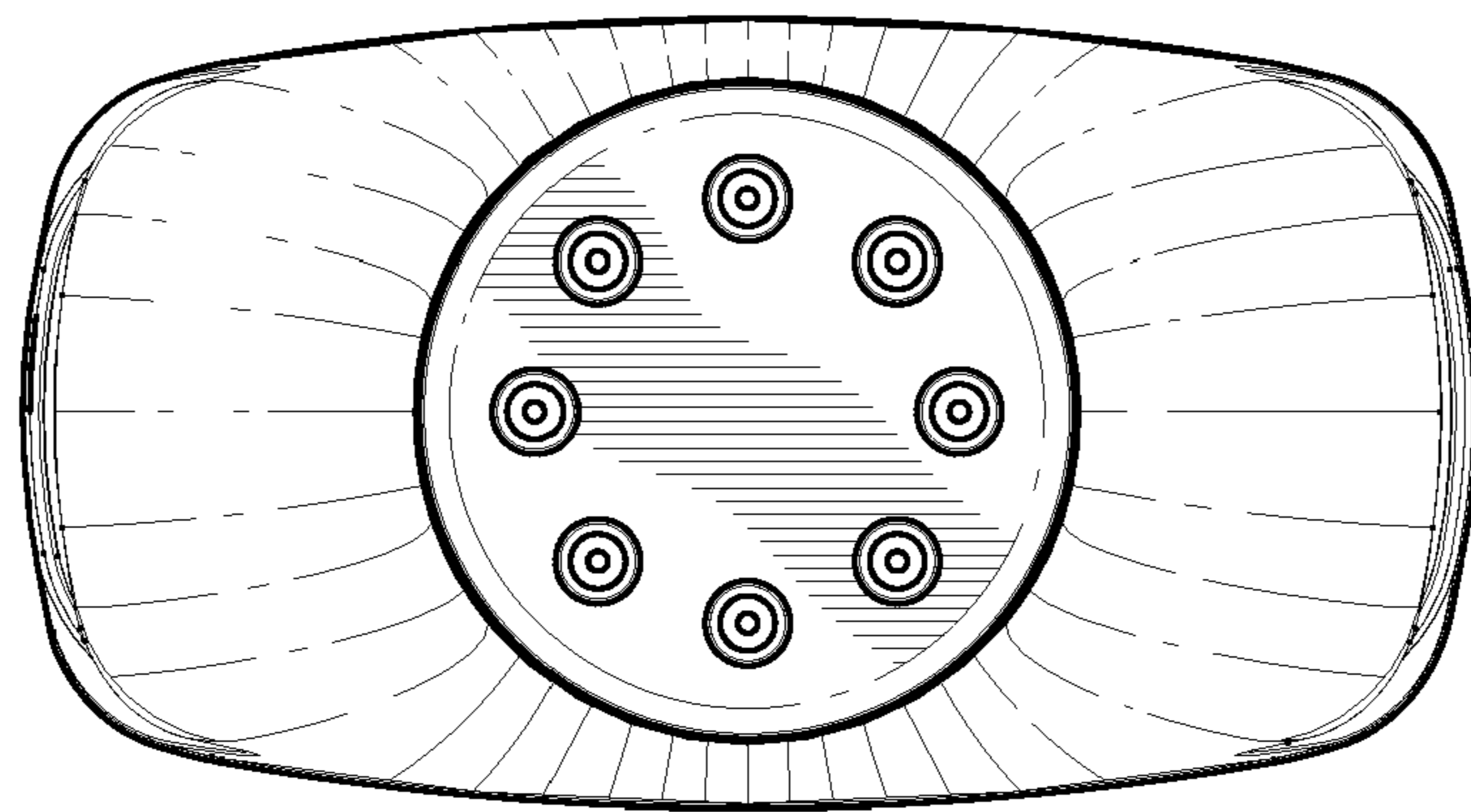

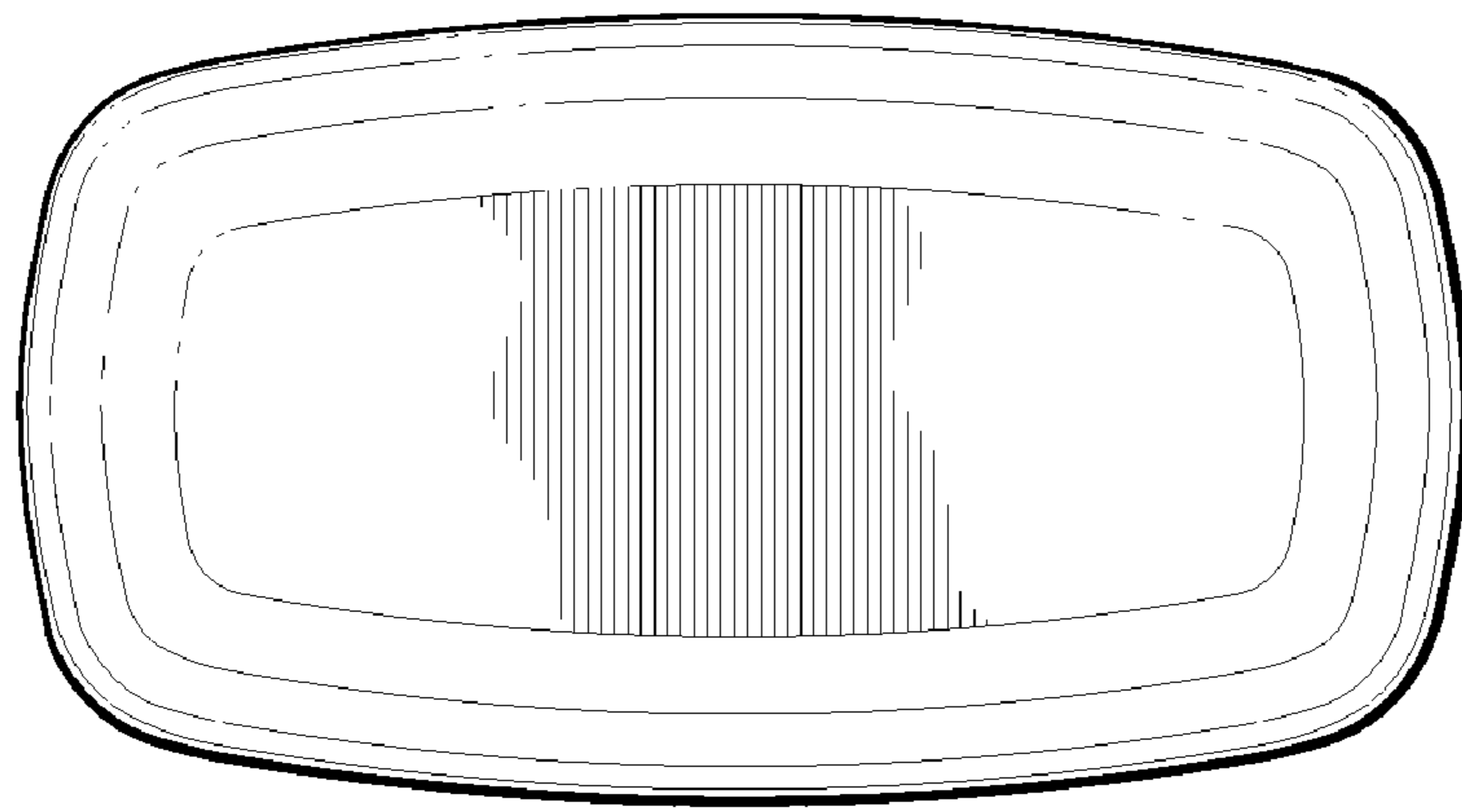
