(57) **CLAIM**

The ornamental design for a container for a personal hygiene product, as shown and described.

DESCRIPTION

FIG. 1 is left front perspective view a container constructed in accordance with the invention;

FIG. 2 is a front elevation view of the container illustrated in FIG. 1;

FIG. 3 is a top plan view of the container illustrated in FIG. 1;

FIG. 4 is a left side elevation view of the design illustrated in FIG. 1;

FIG. 5 is a right side elevation view of the design illustrated in FIG. 1;

FIG. 6 is a rear elevation view of the container illustrated in FIG. 1;

FIG. 7 is a bottom plan view of the container illustrated in FIG. 1;

FIG. 8 is left front perspective view of the container of FIG. 1, illustrating an internal cap design under its removable cap; and,

FIG. 9 is left front perspective view of an alternative embodiment of the container of FIG. 1 illustrating its removable cap, wherein the broken line portions are for illustrative purposes only and form no part of the claimed design.

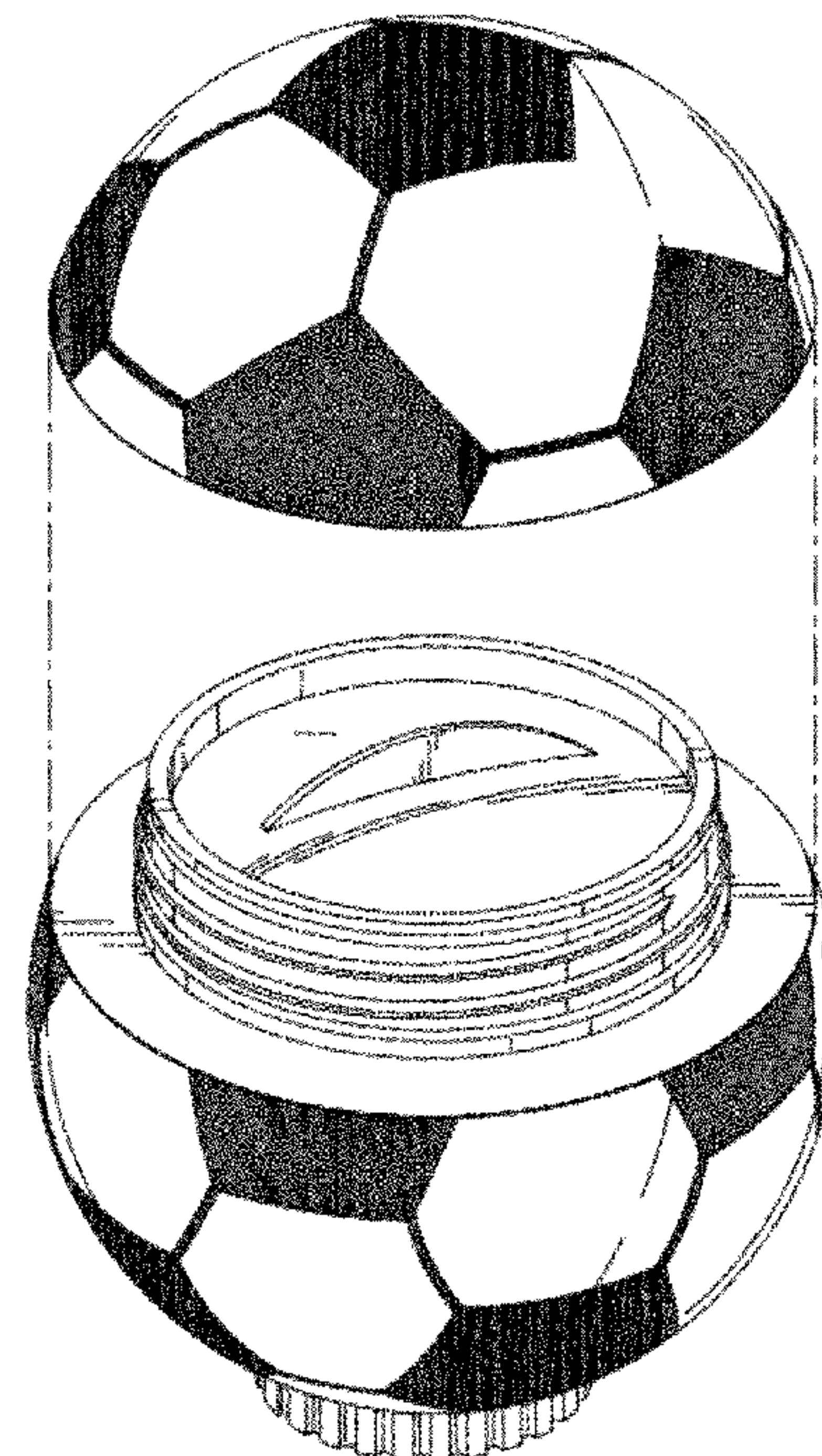

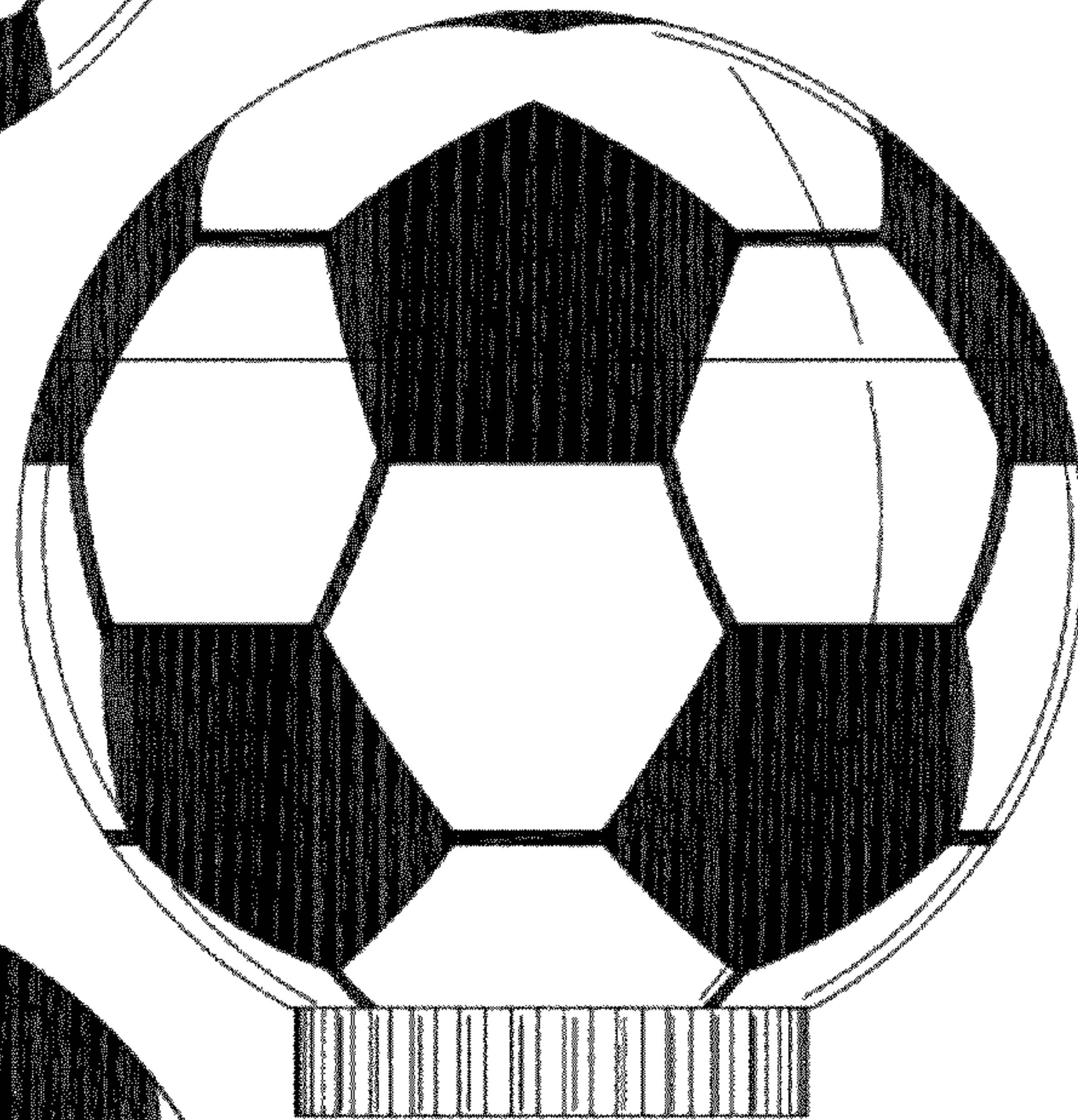

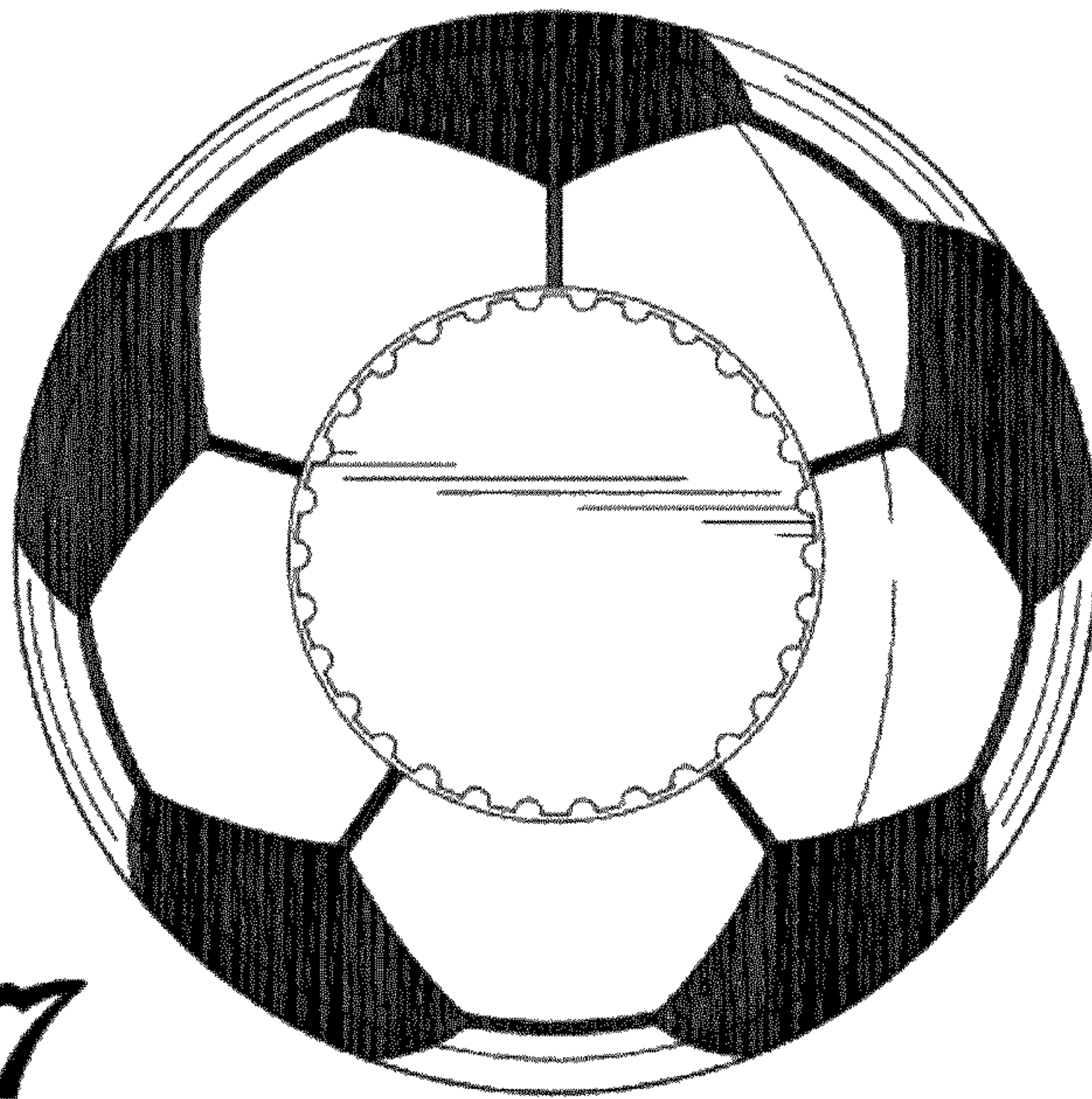

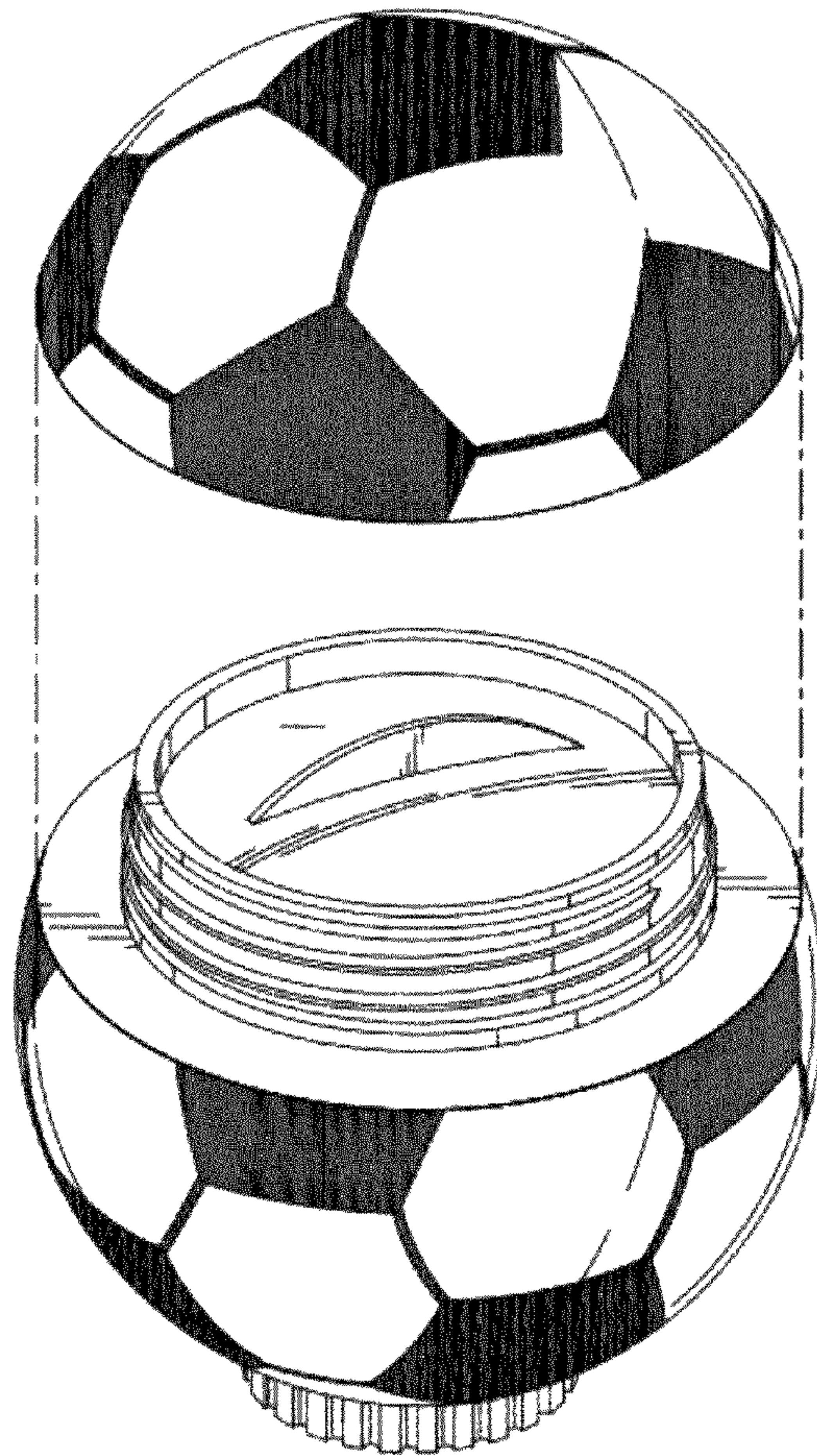

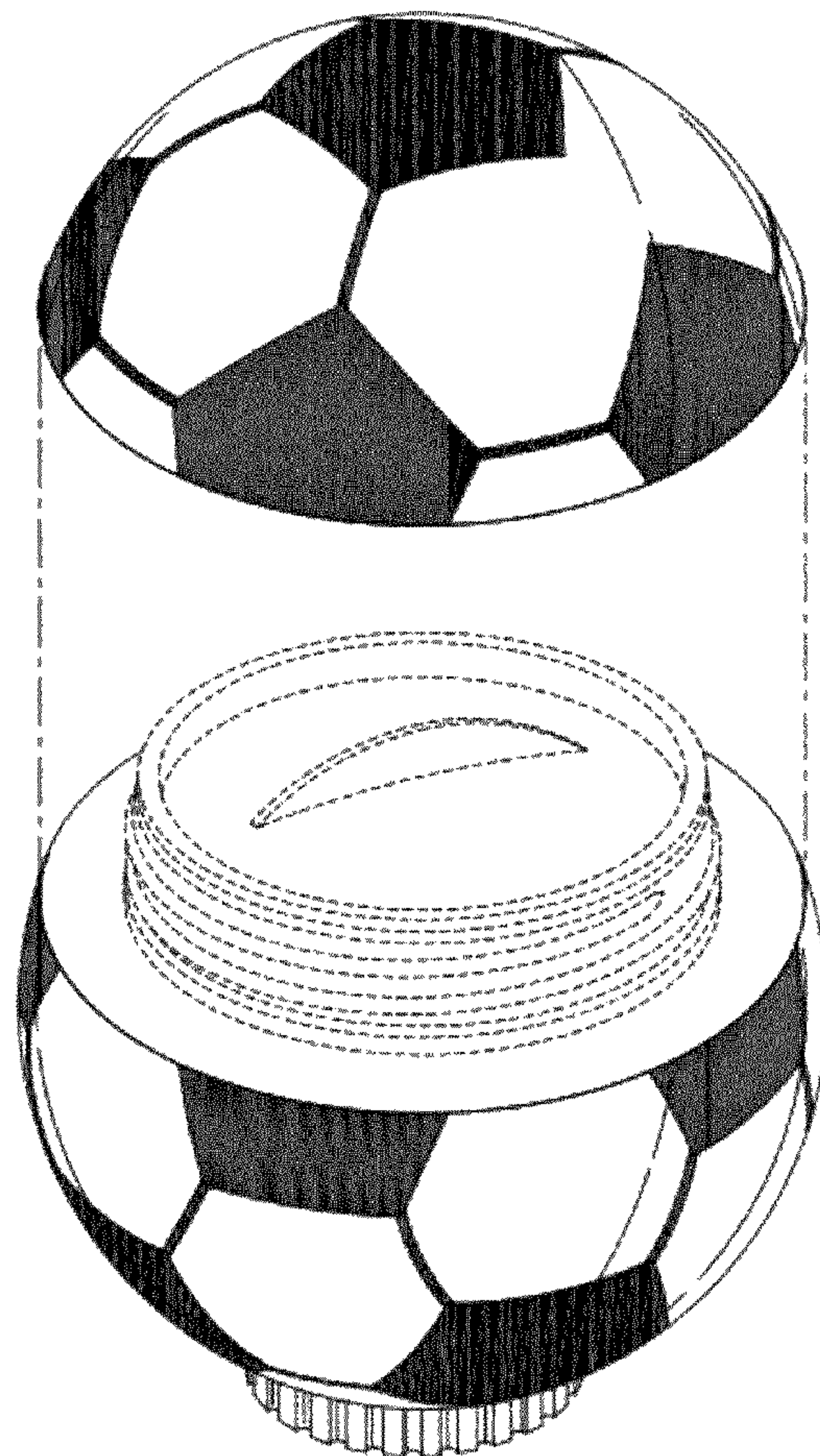
