(57) **CLAIM**

The ornamental design for a watch dial, as shown and described.

DESCRIPTION

FIG. 1 illustrates a perspective view of a watch dial employing an ornamental design in accordance with the present invention;

FIG. 2 illustrates a front plan view of the watch dial of FIG. 1; FIG. 3 illustrates a back plan view of the watch dial of FIG. 1; FIG. 4 illustrates a left side plan view of the watch dial of FIG. 1;

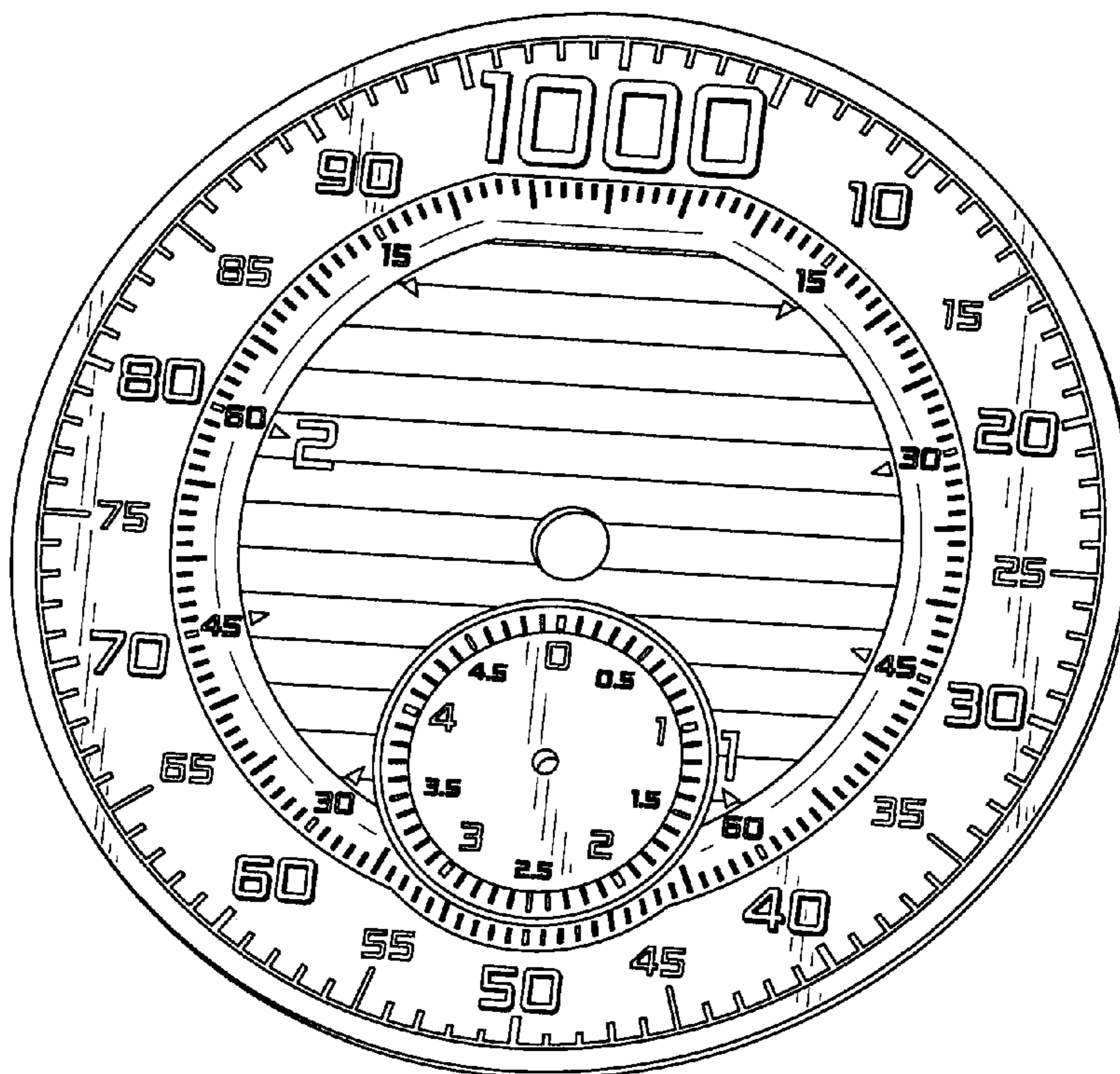
FIG. 5 illustrates a right side plan view of the watch dial of FIG. 1;

FIG. 6 illustrates a top plan view of the watch dial of FIG. 1; and,

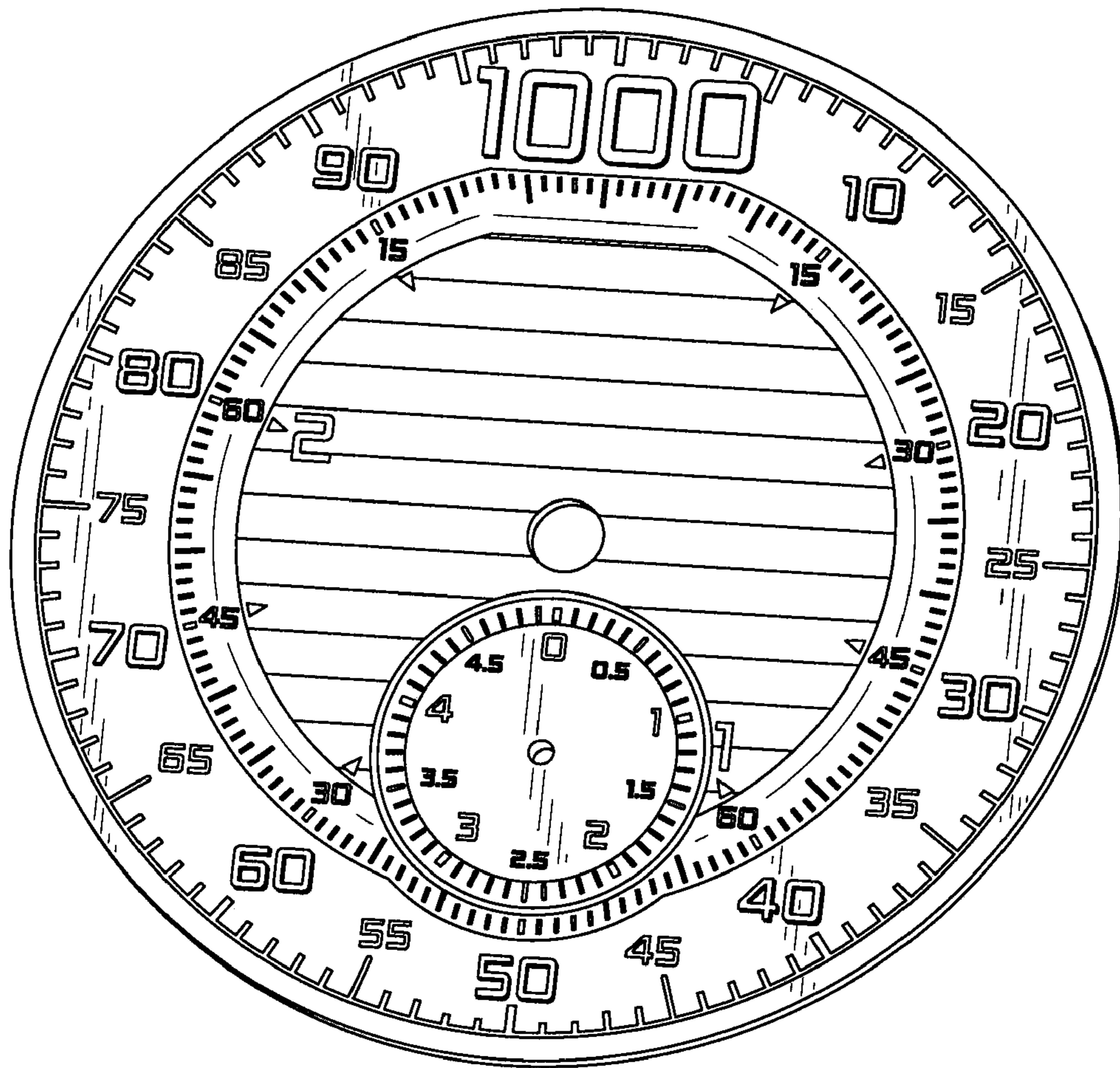

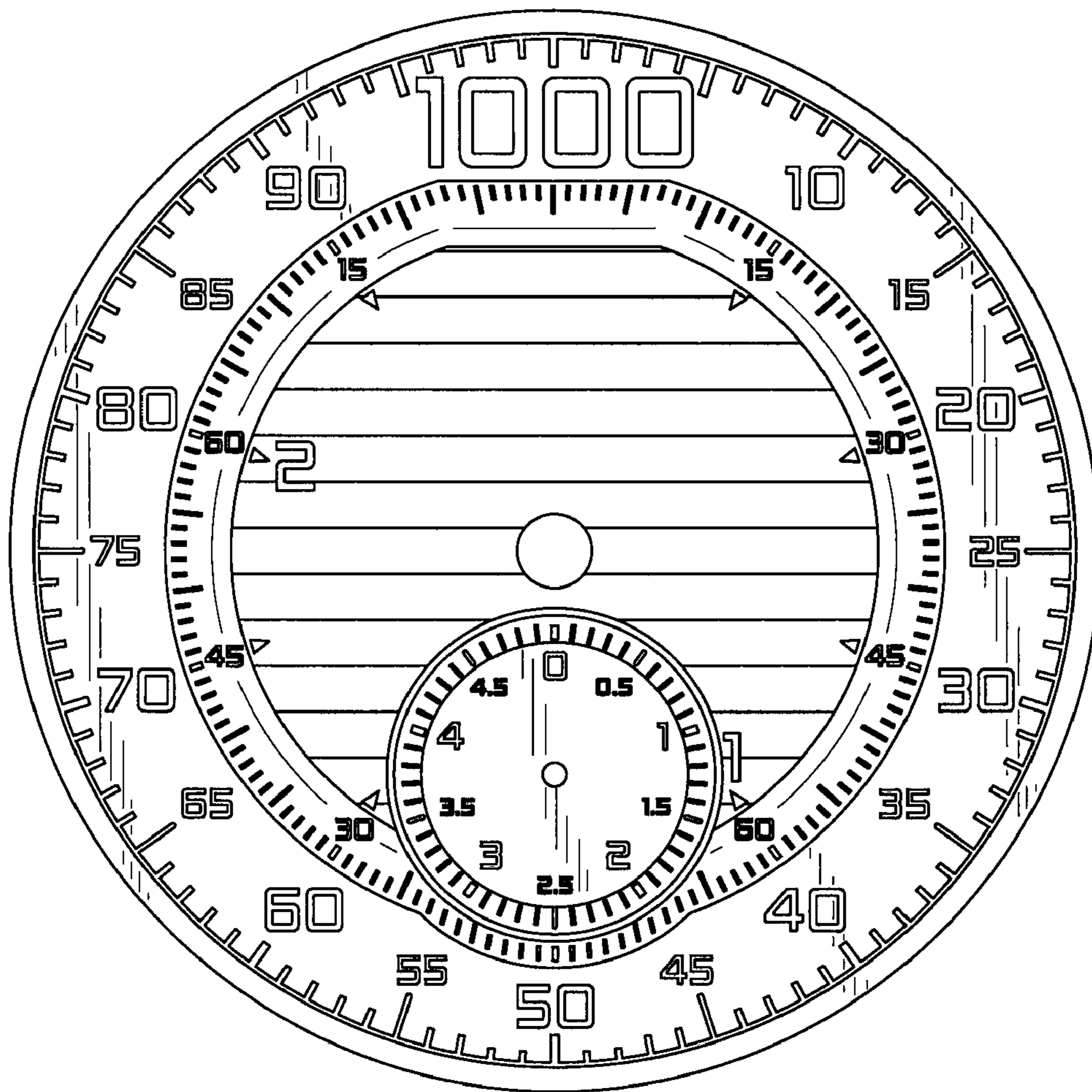

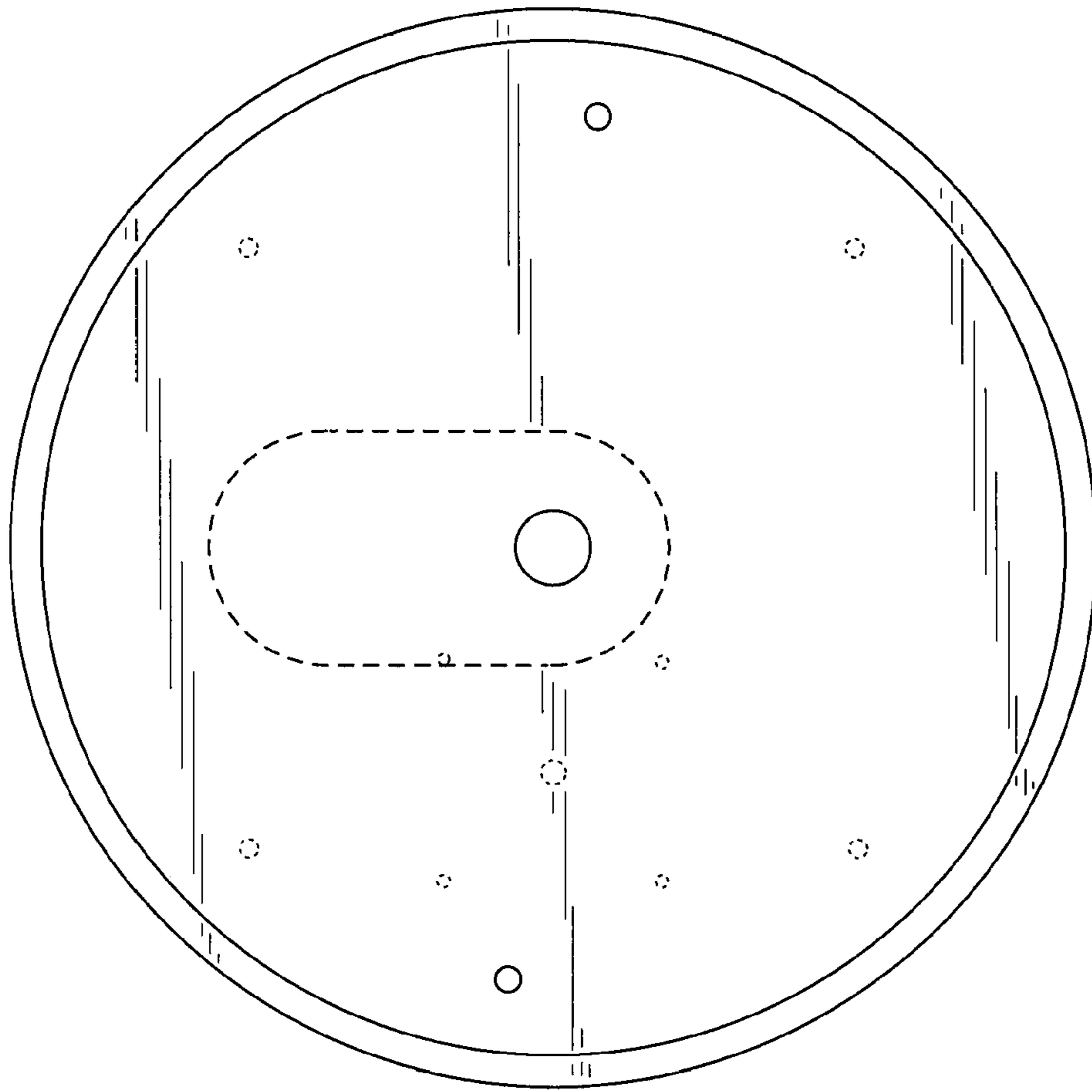

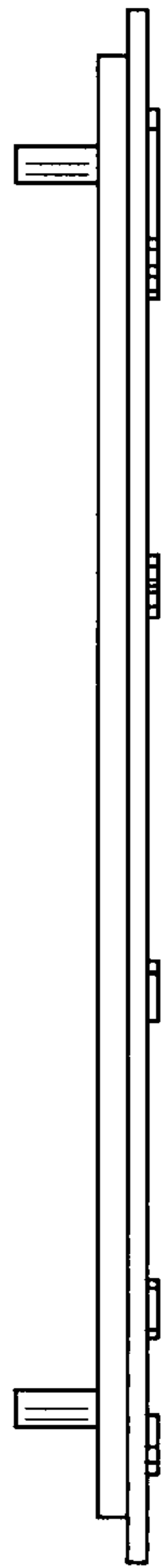

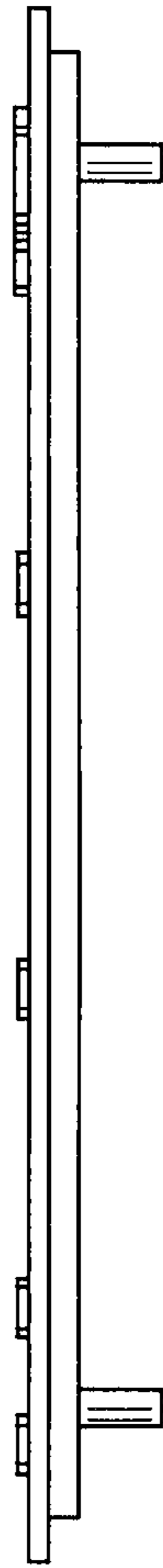

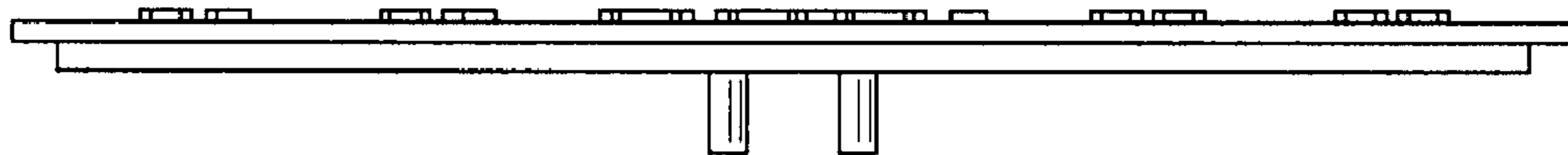

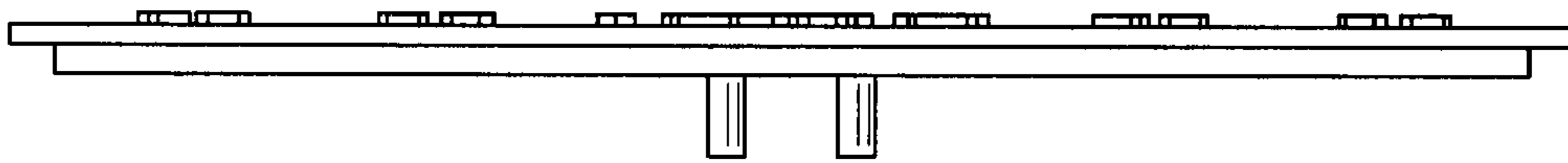
