(57) **CLAIM**

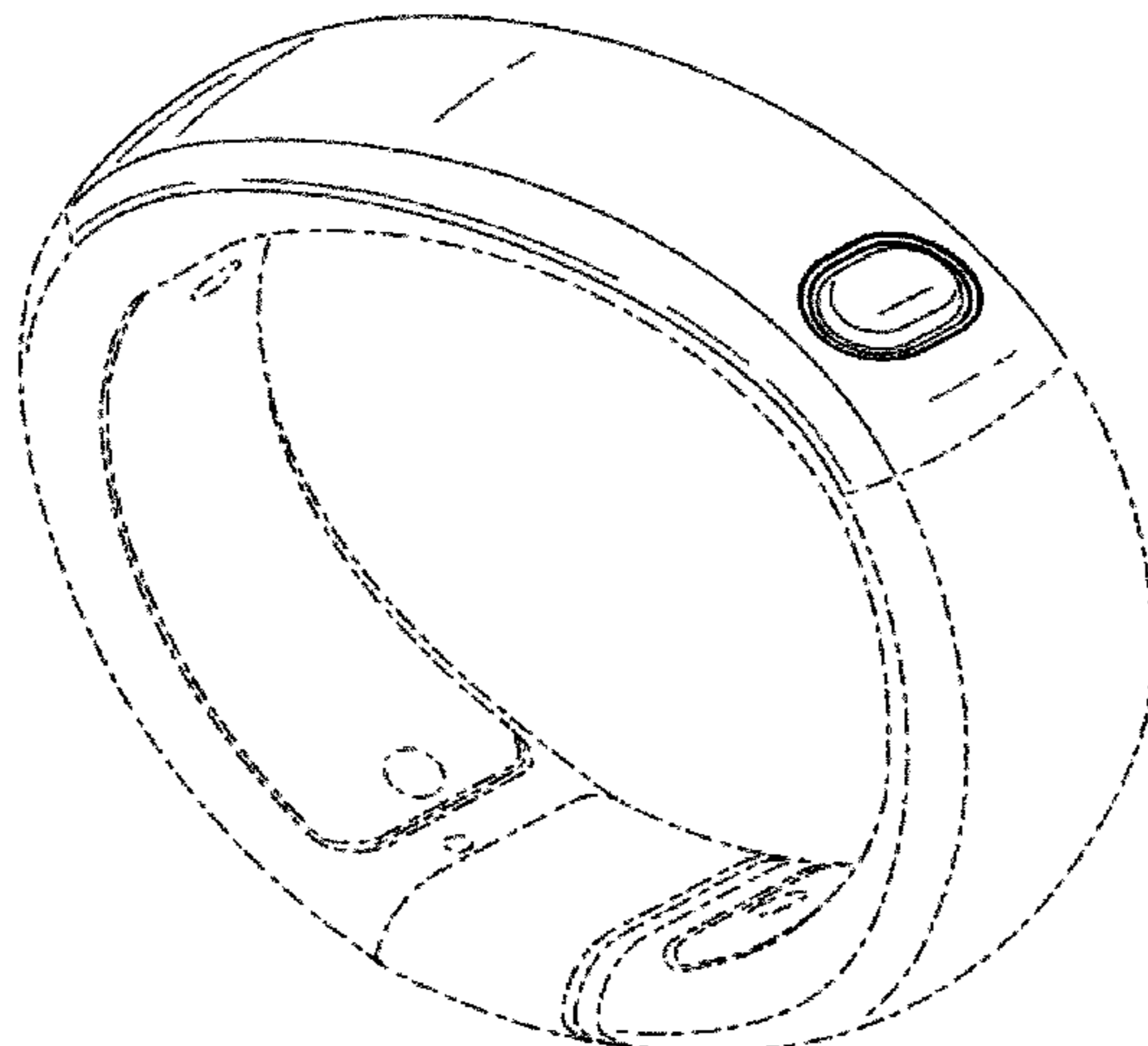
The ornamental design for a wristband, as shown and described.

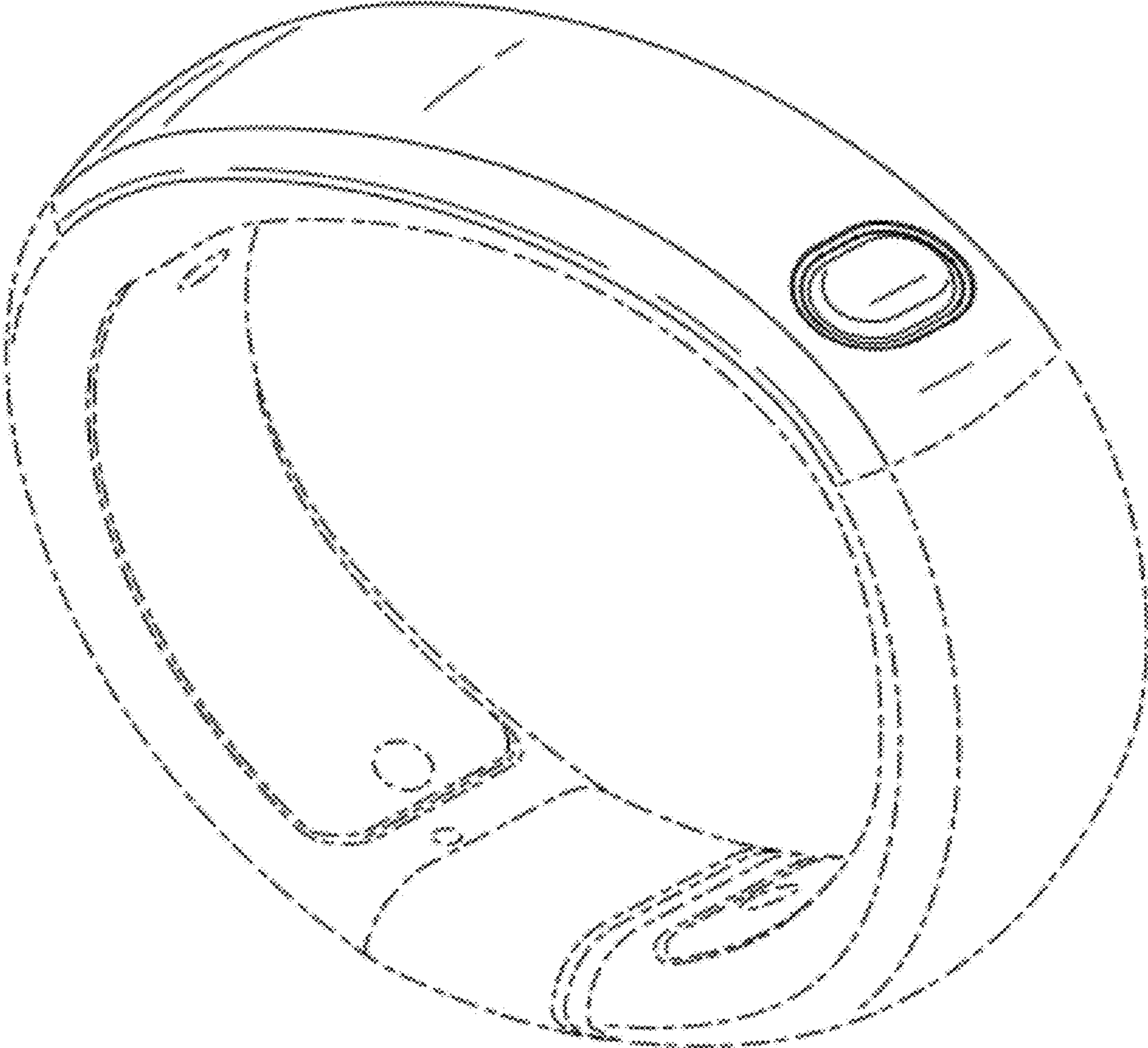

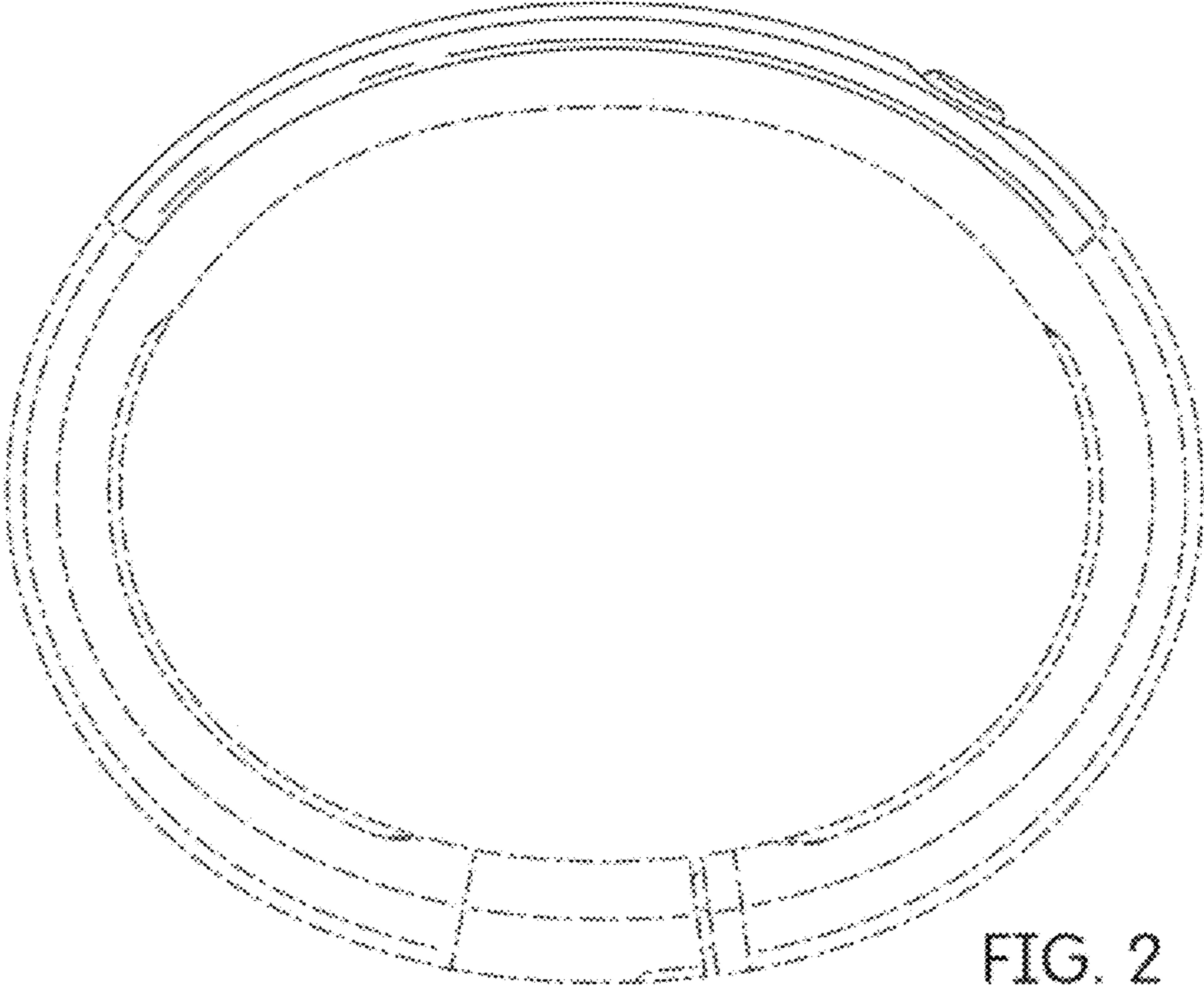

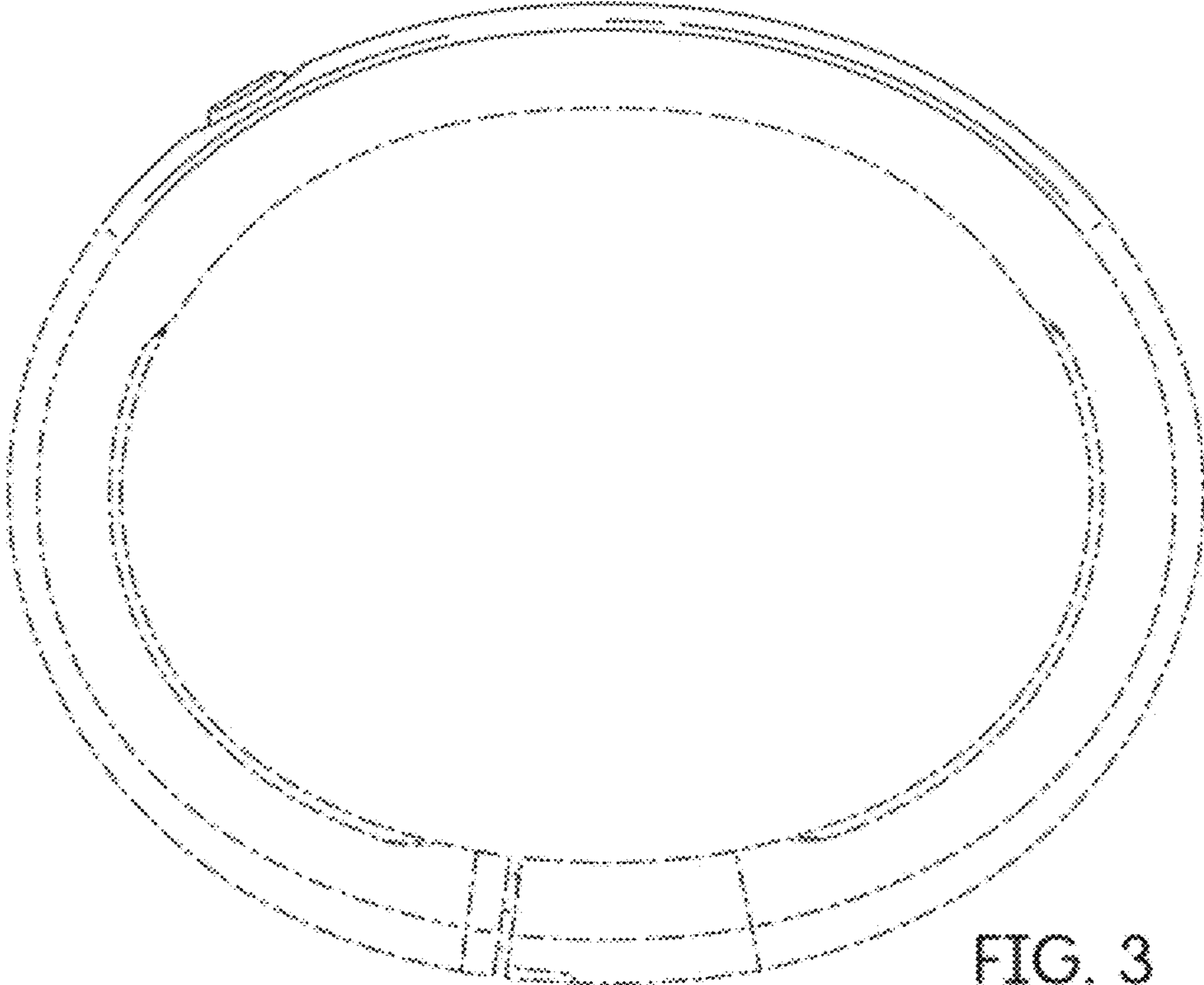

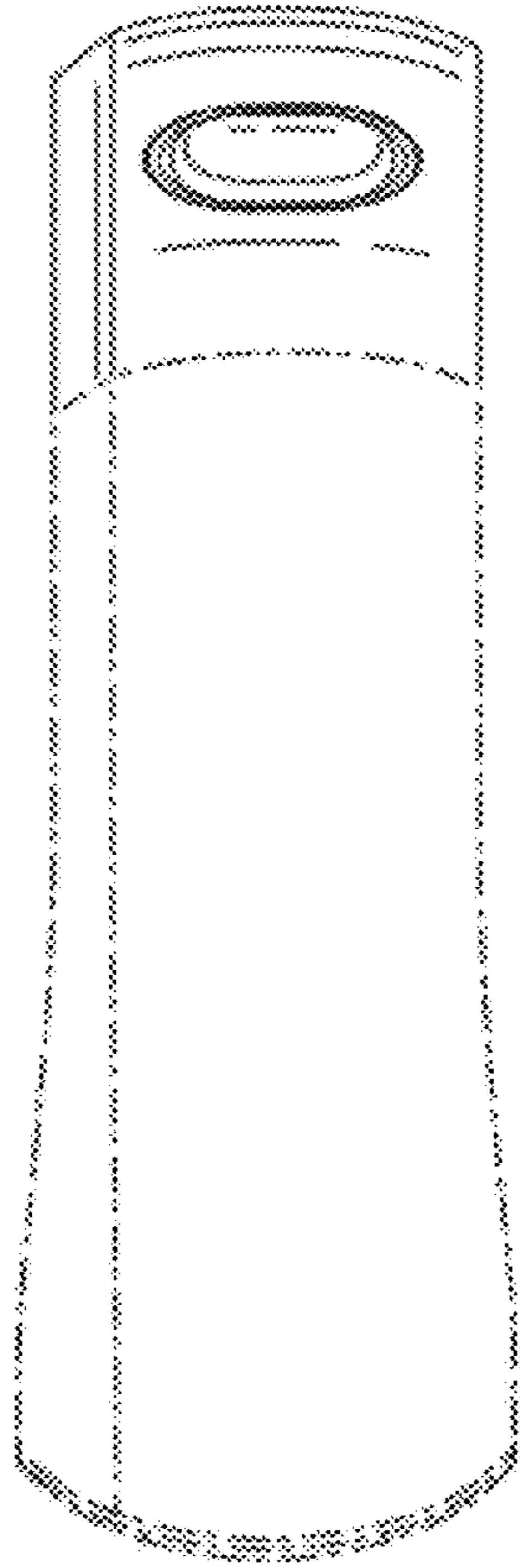

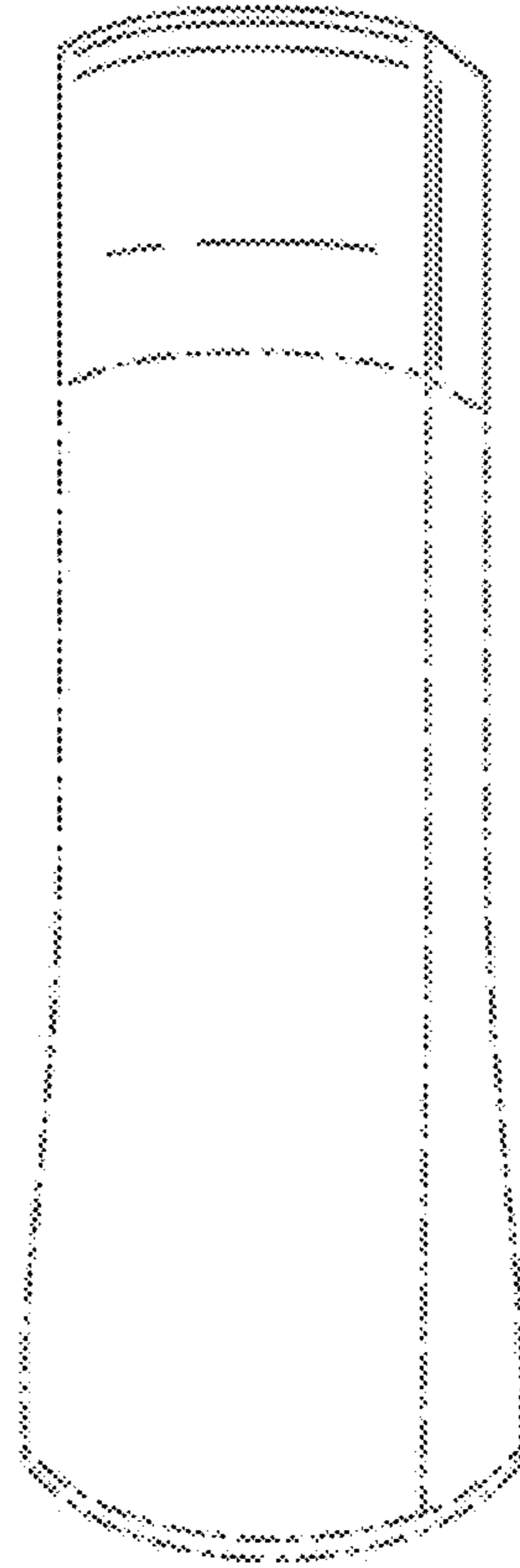

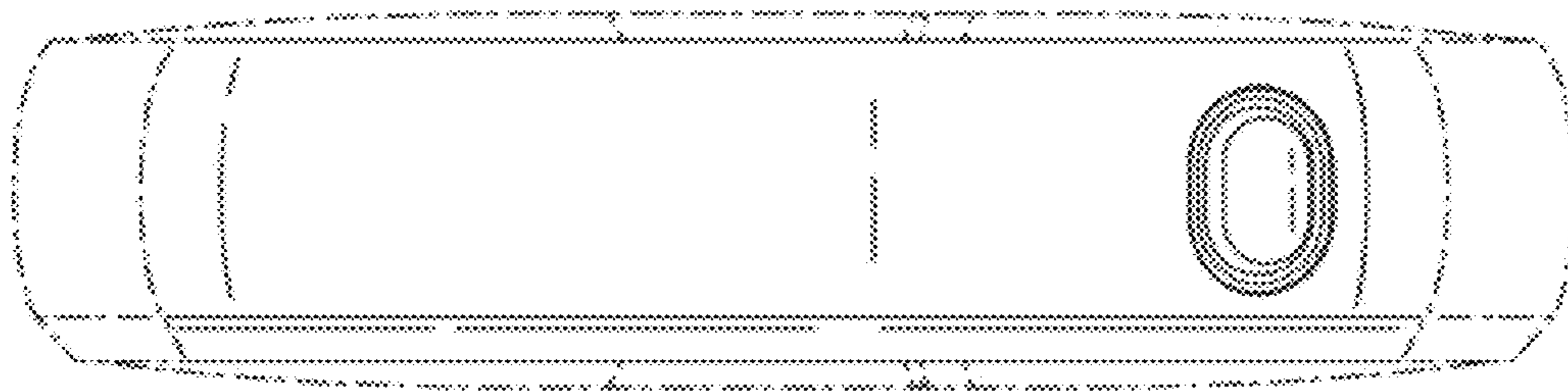
