FIG. 4 is a bottom view of the remote control for personal massager.

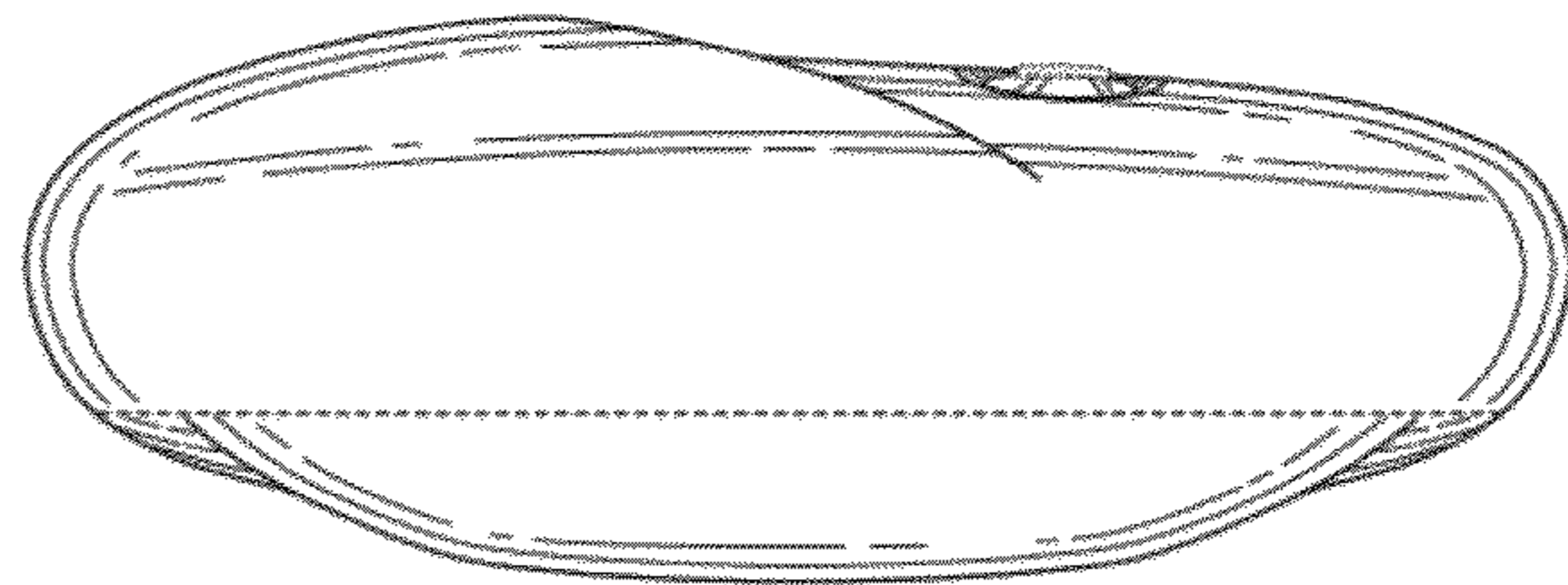
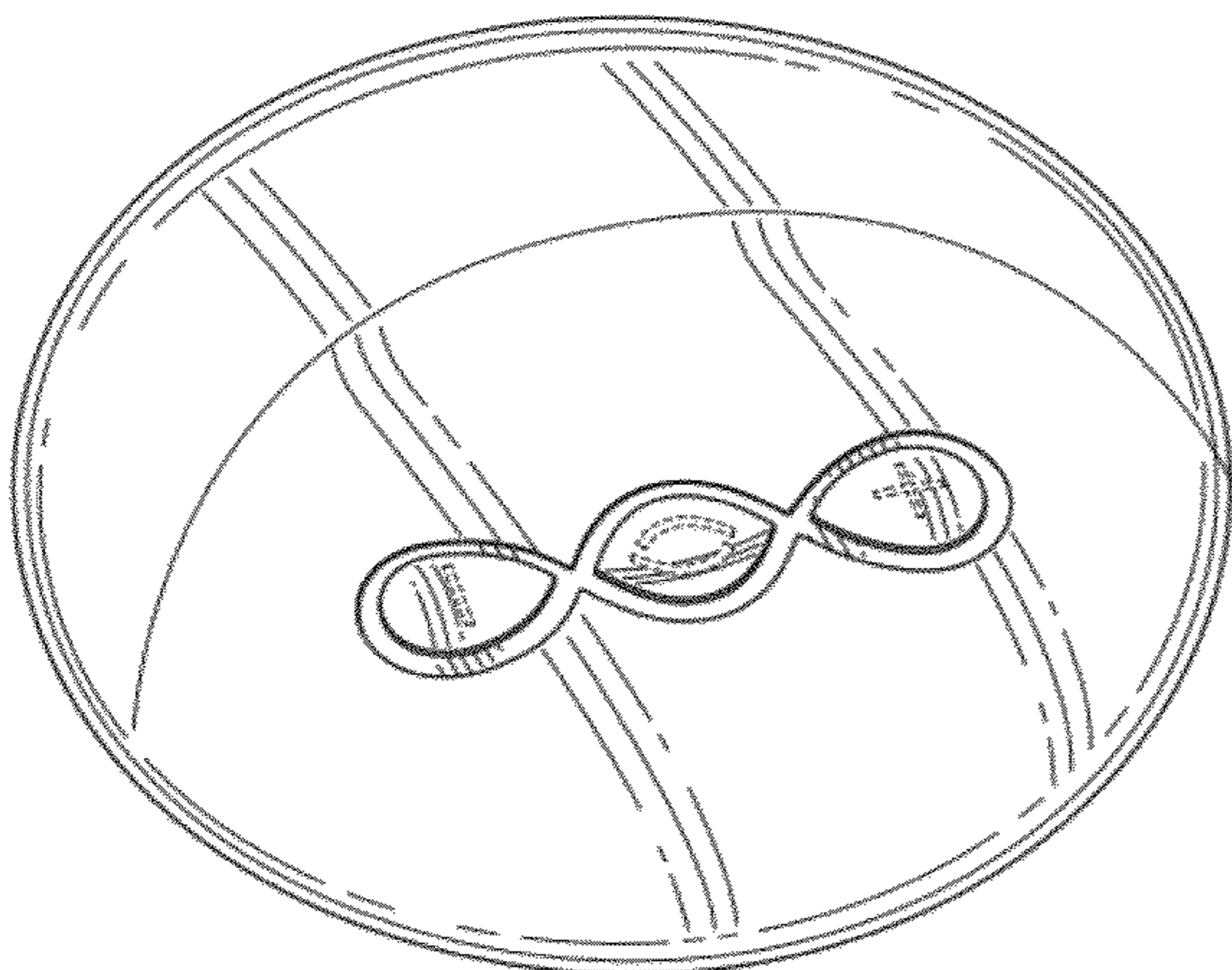
FIG. 5 is a front view of the remote control for personal massager.

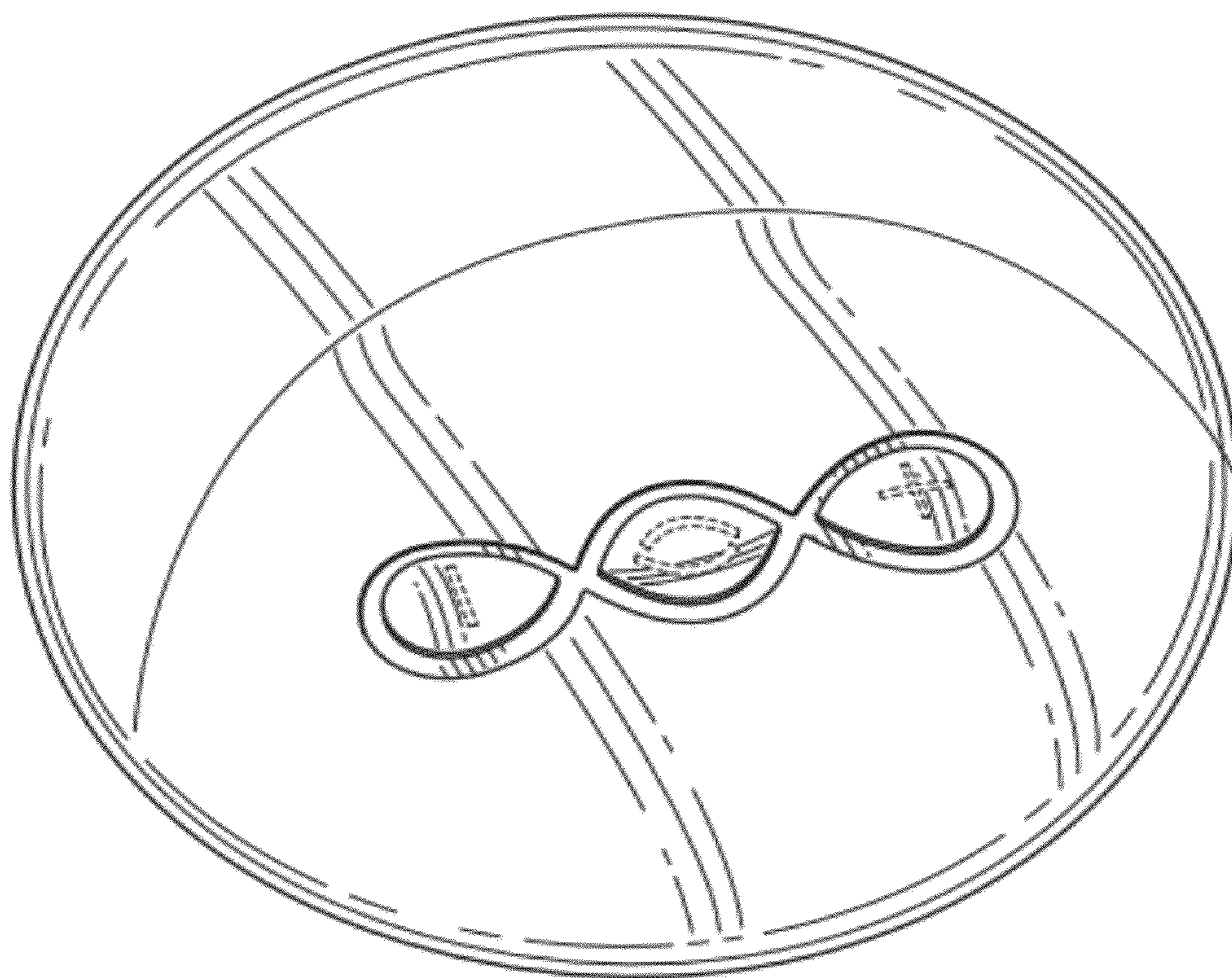

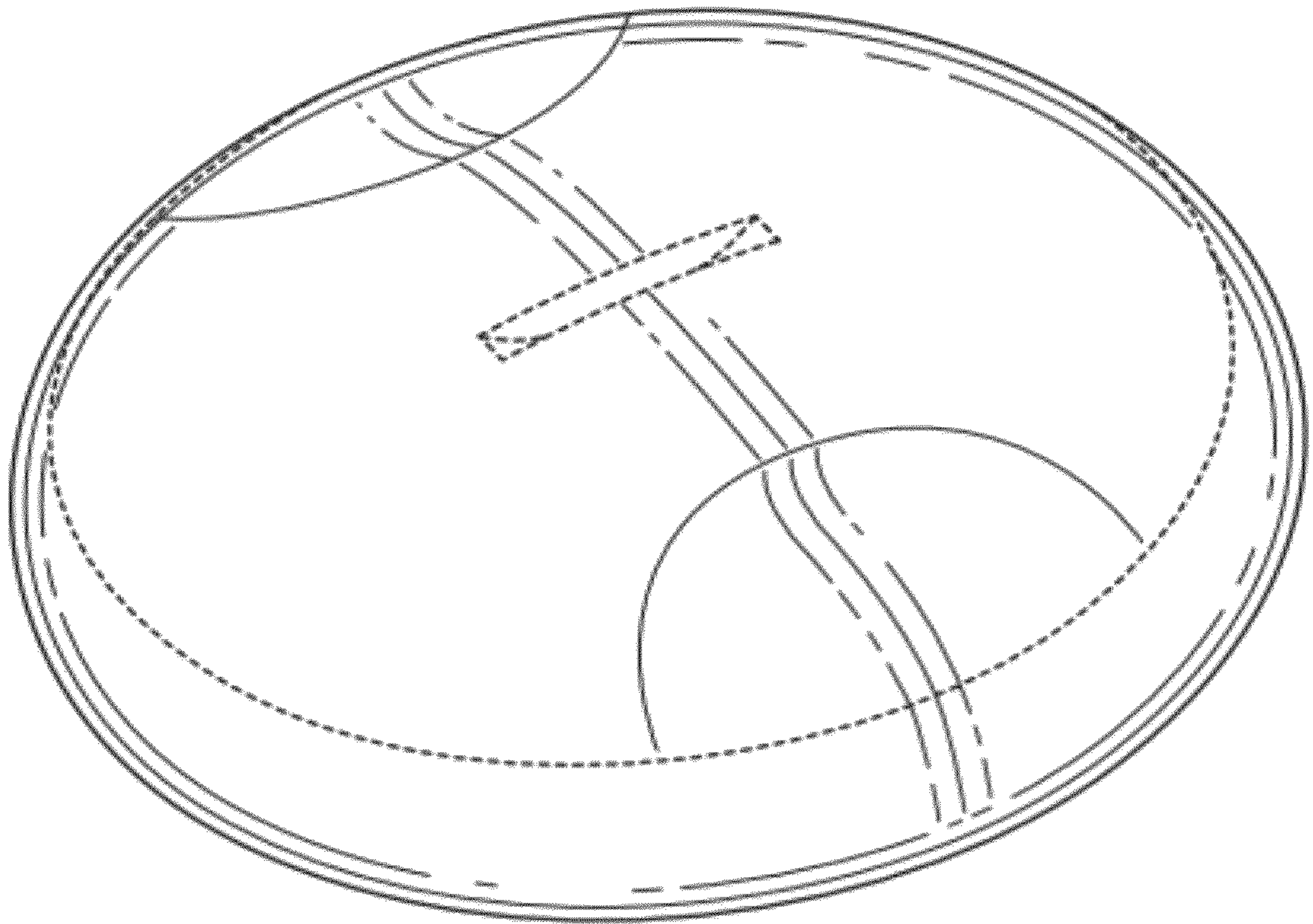

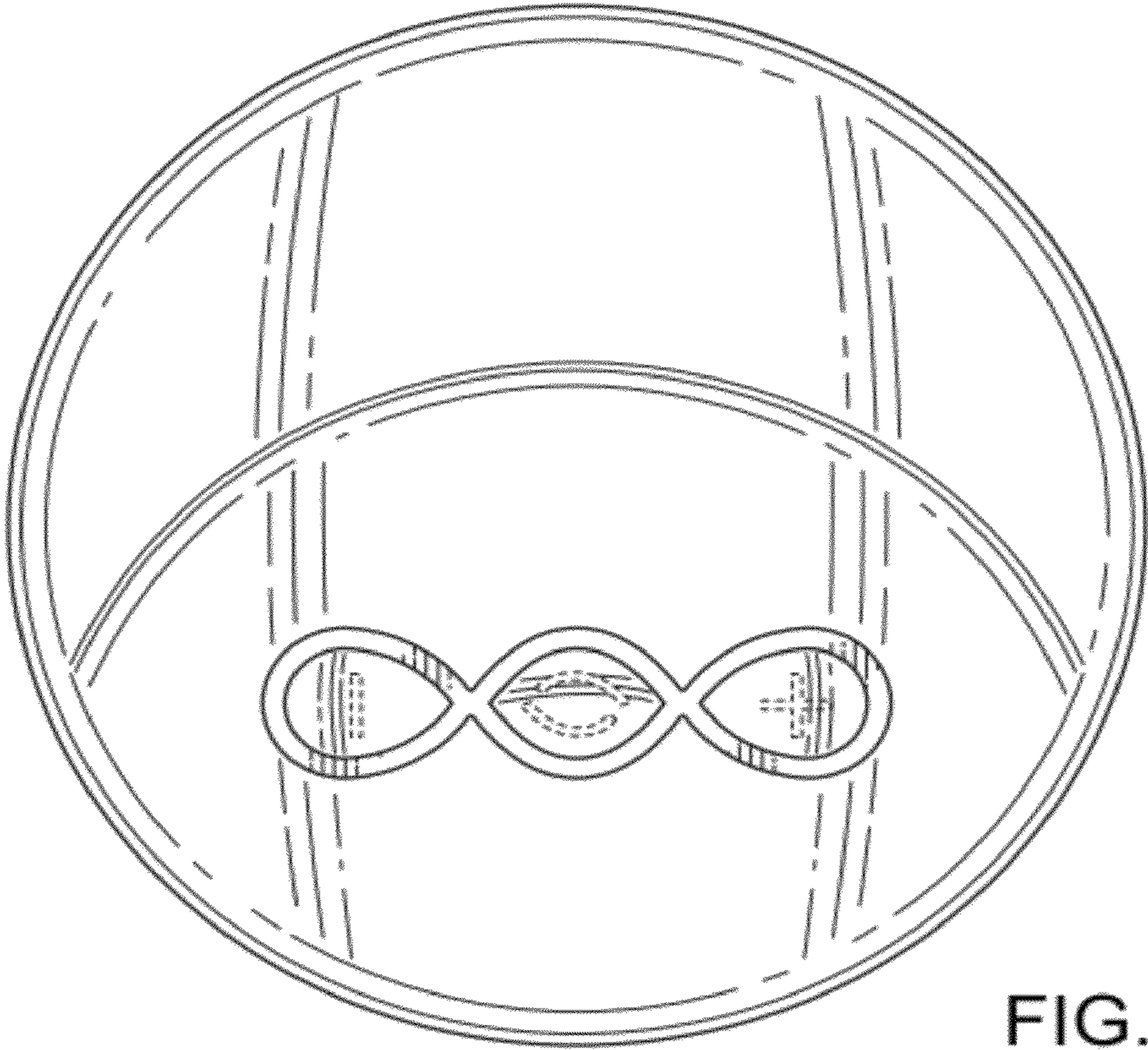

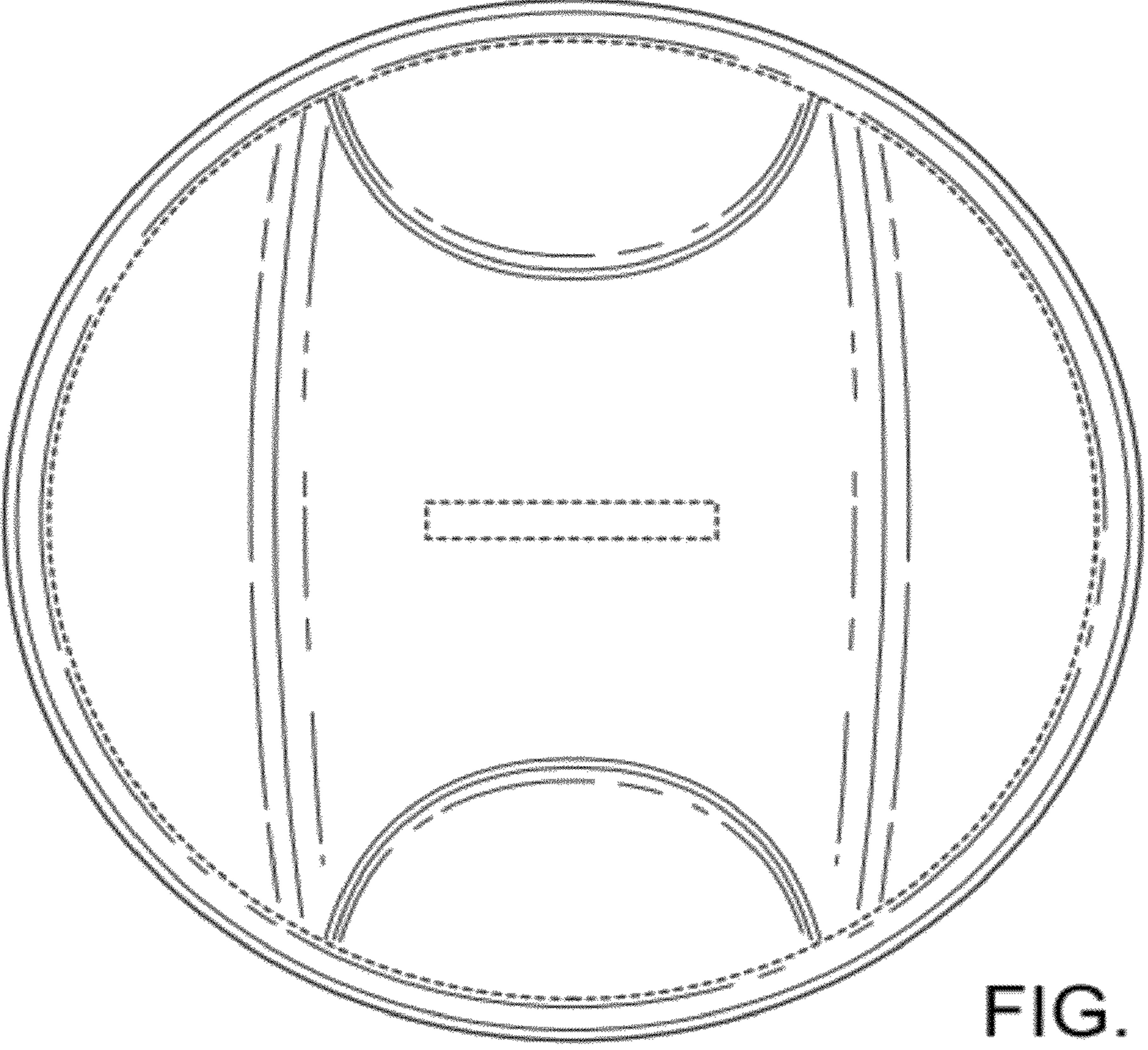

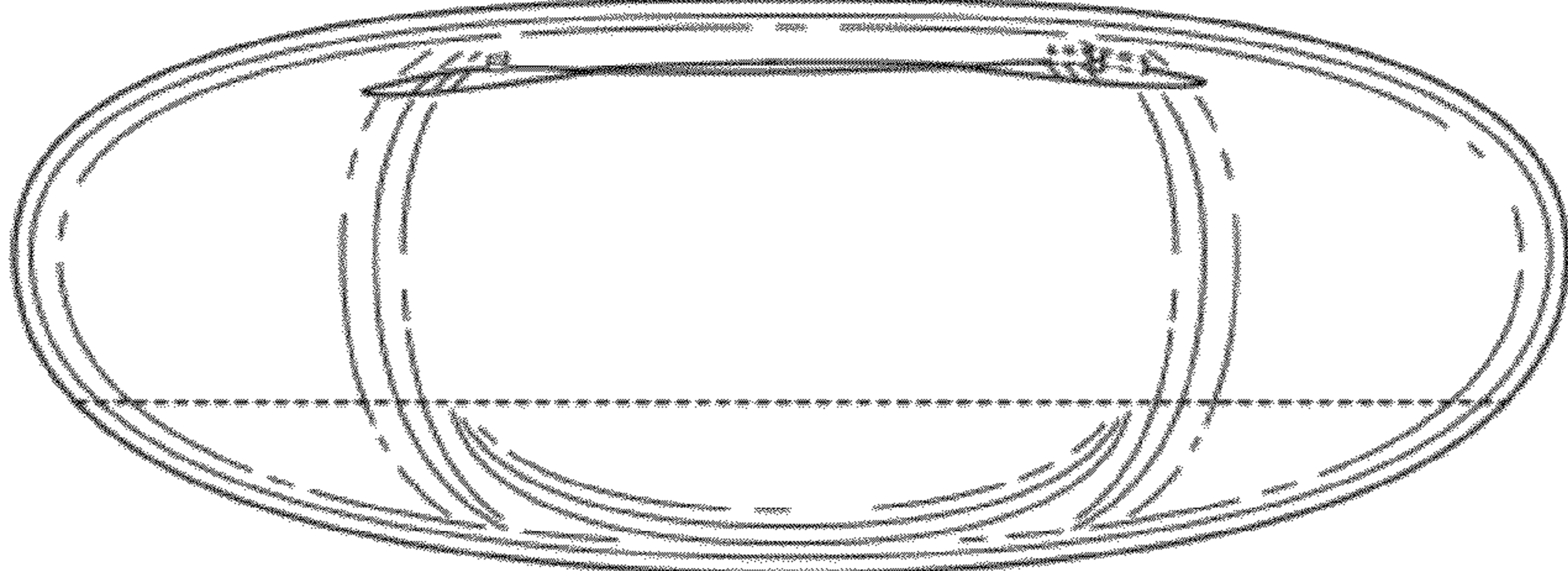

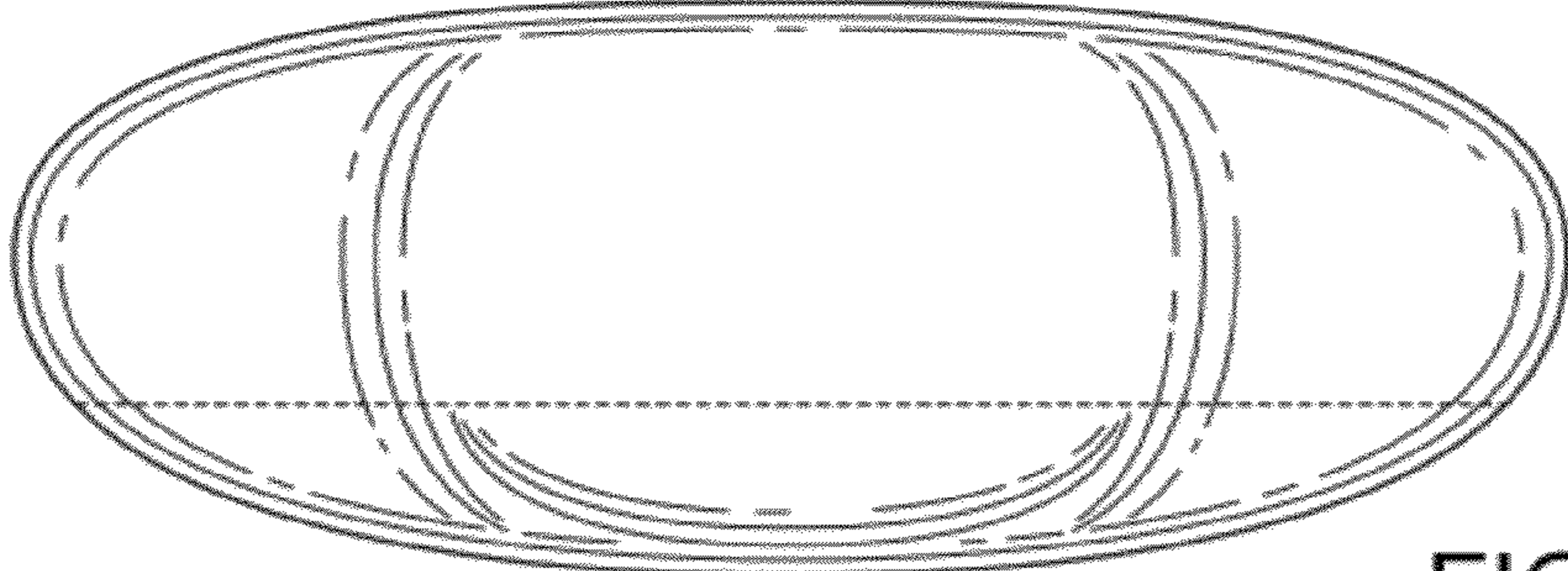

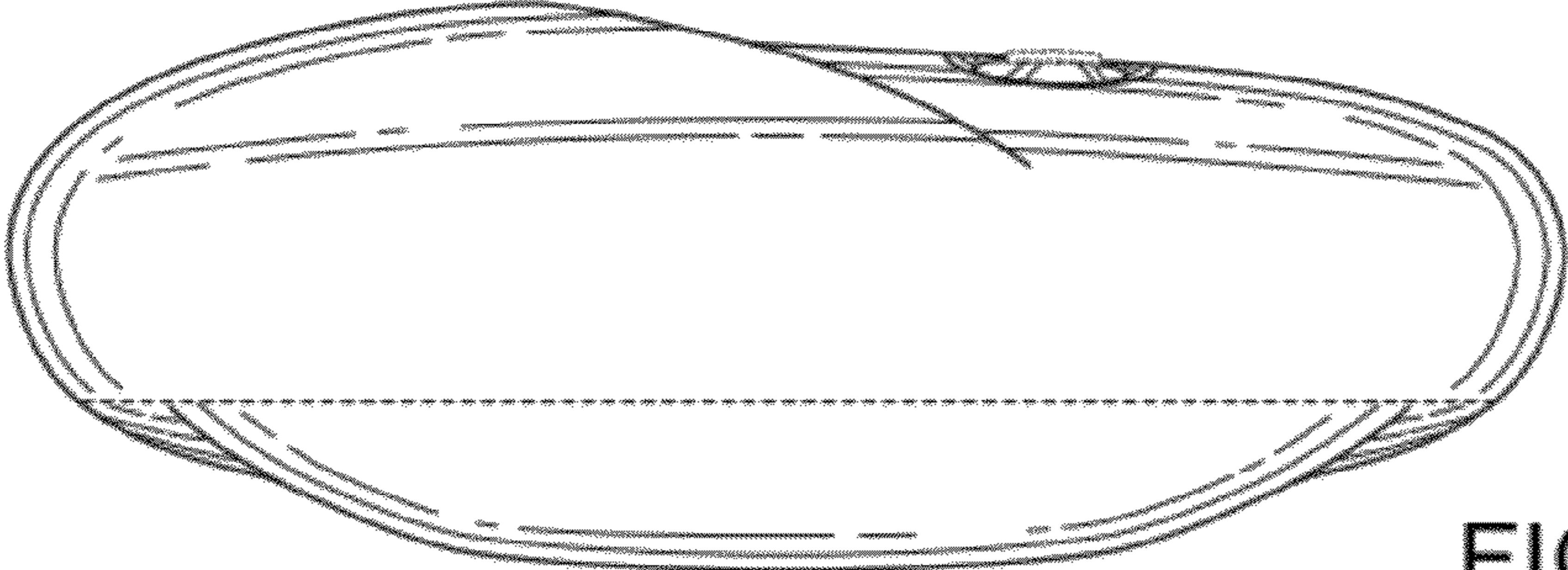

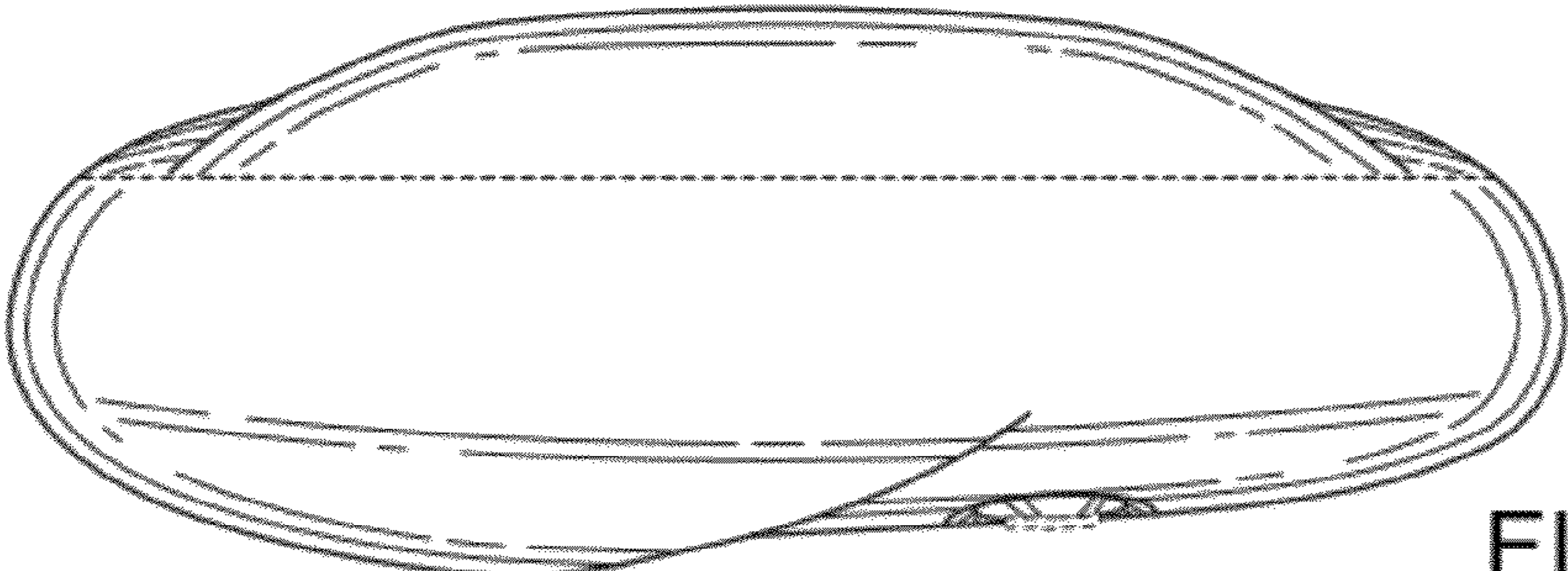
