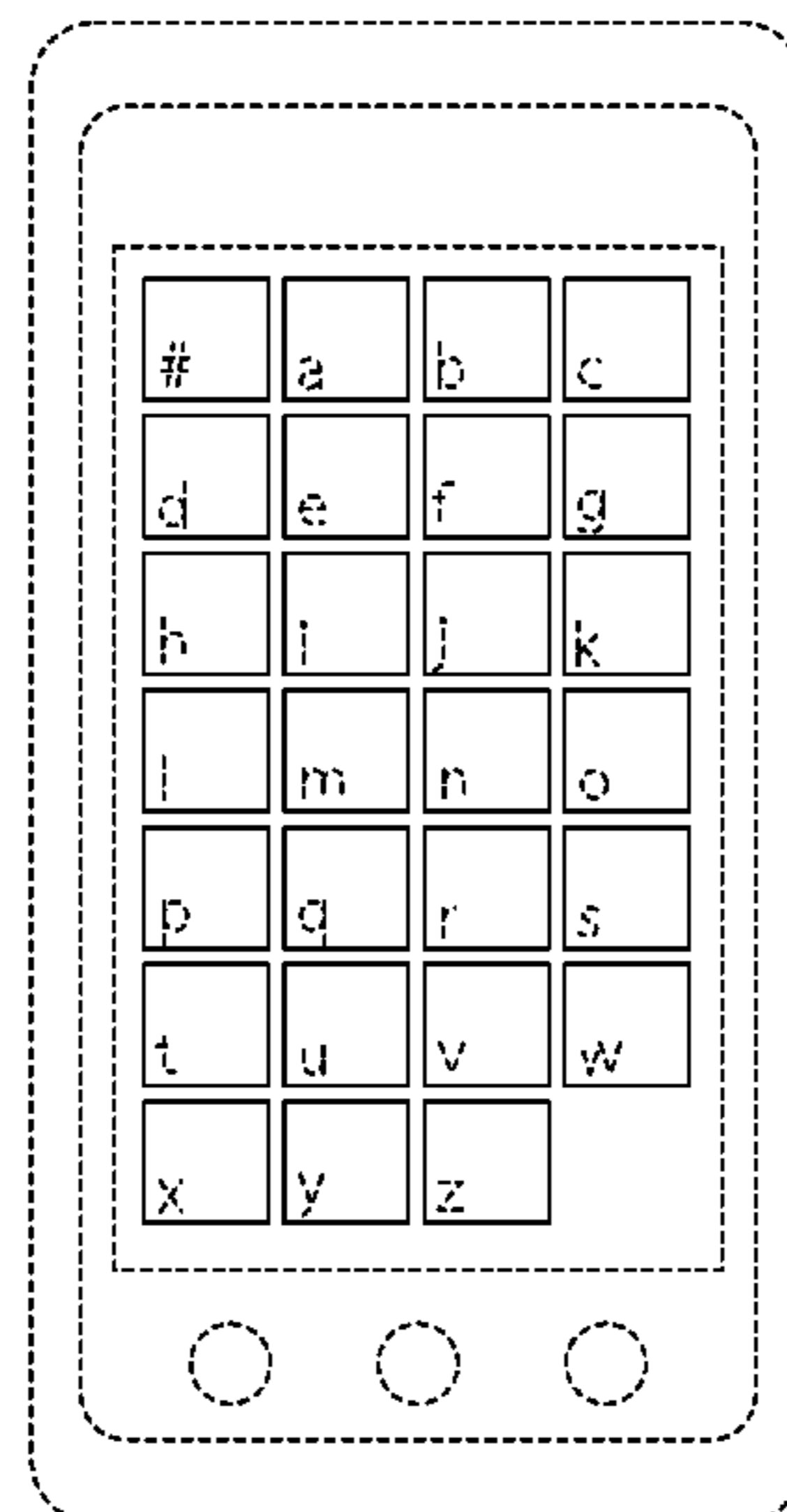
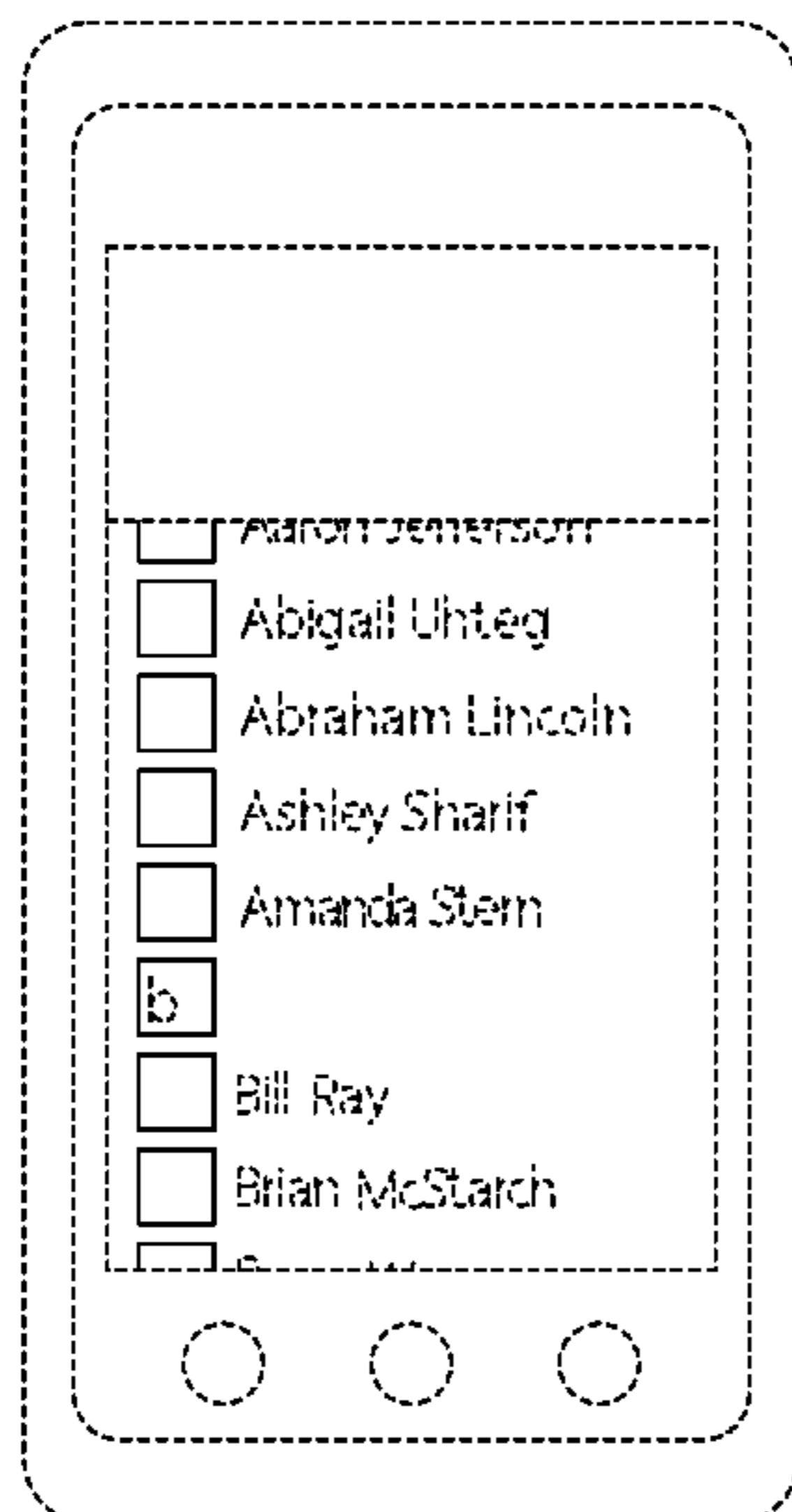
(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is the first image in a sequence for a display screen with animated graphical user interface showing my new design; FIG. 2 is the second image thereof; FIG. 3 is the third image thereof; FIG. 4 is the fourth image thereof; and FIG. 5 is the fifth image thereof; and, FIGS. 6-10 show the display screen with animated graphical user interface of FIGS. 1-5 on a device. The appearance of the animated user interface sequentially transitions between the images shown in FIGS. 1-5 and in FIGS. 6-10. The process or period in which one image transitions to another forms no part of the claimed design. The broken line showing of the display screen and of portions of the animated user interface in FIGS. 1-10 and the broken line showing of the device containing the display screen in FIGS. 6-10 illustrate the environment of the claimed design and form no part thereof.

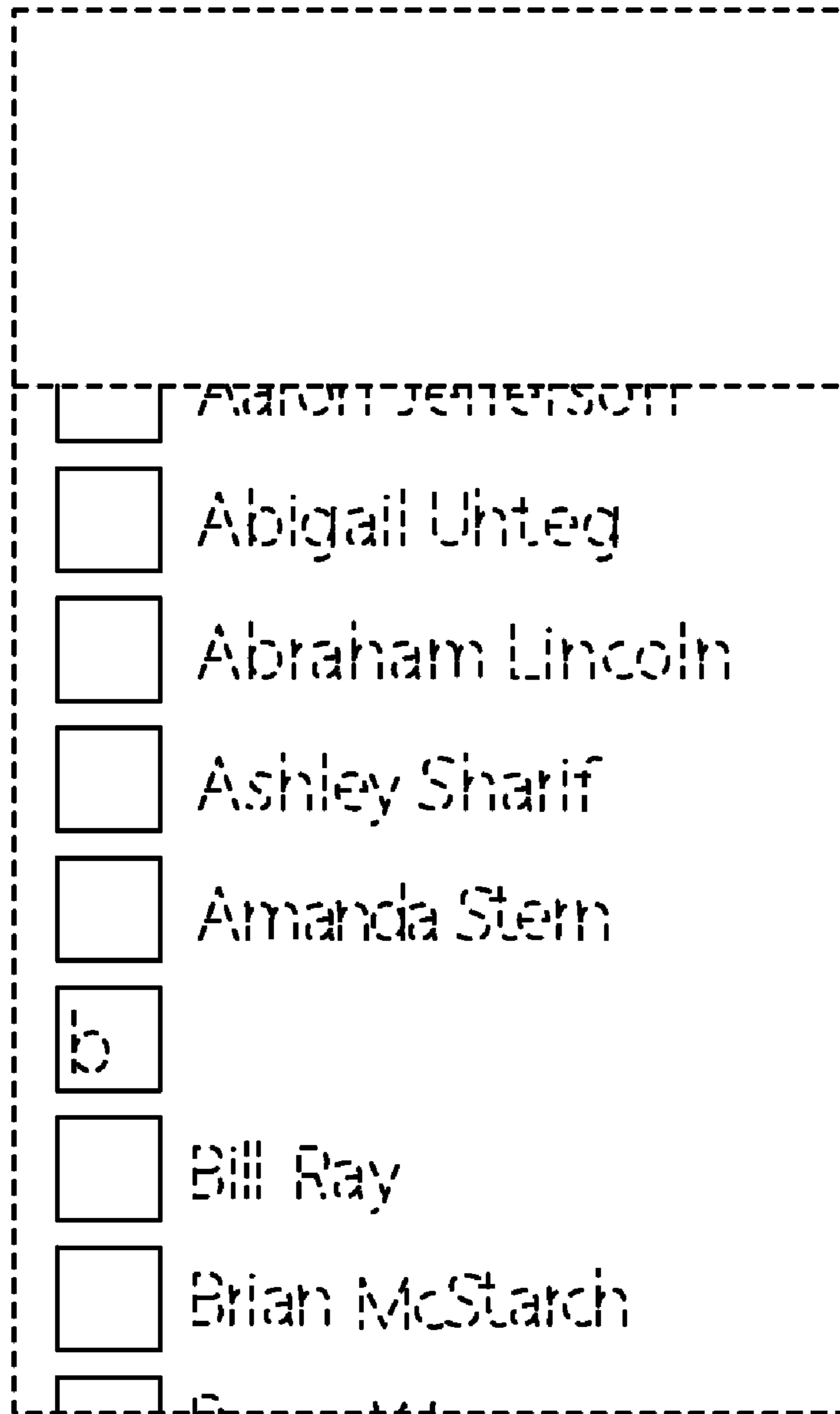

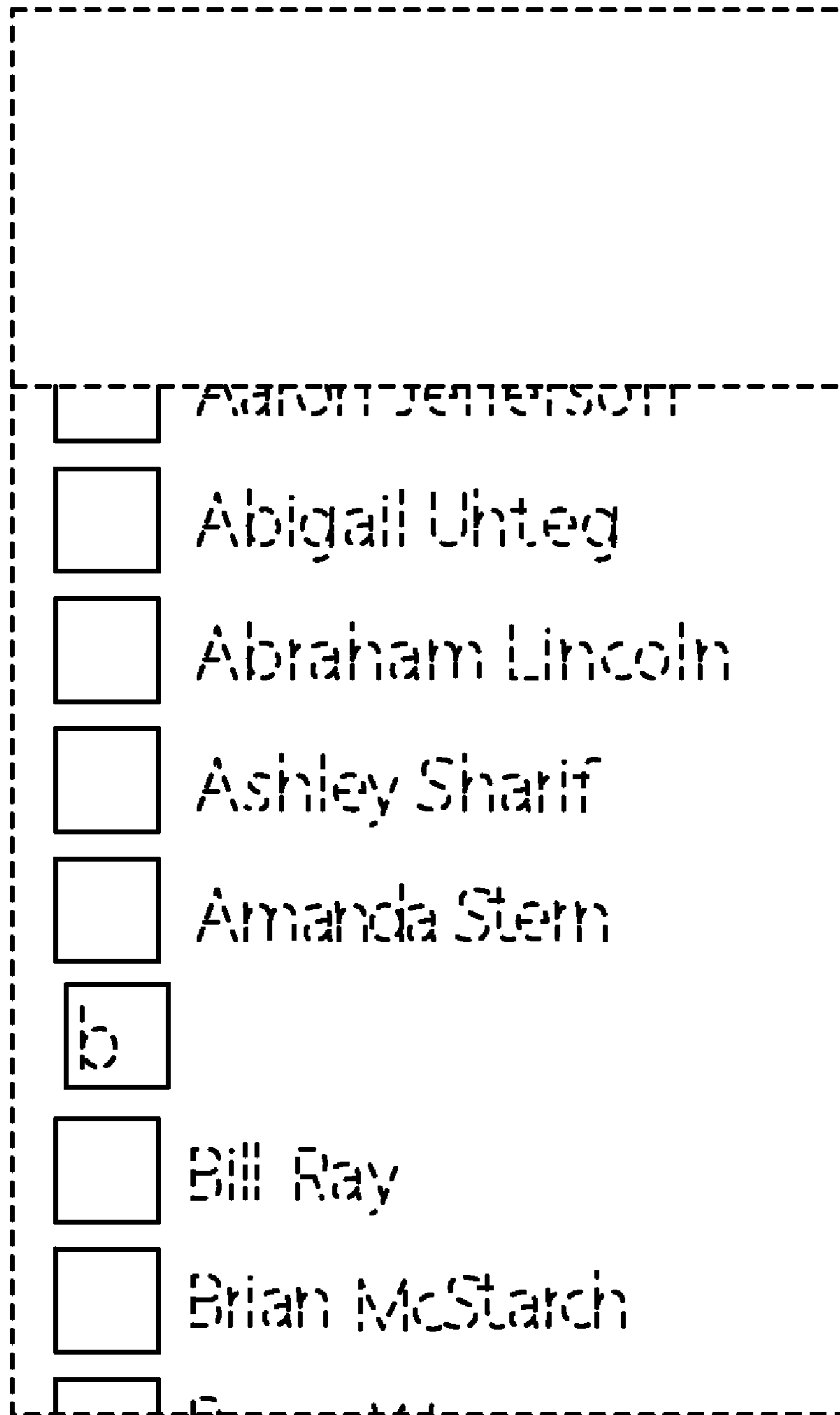

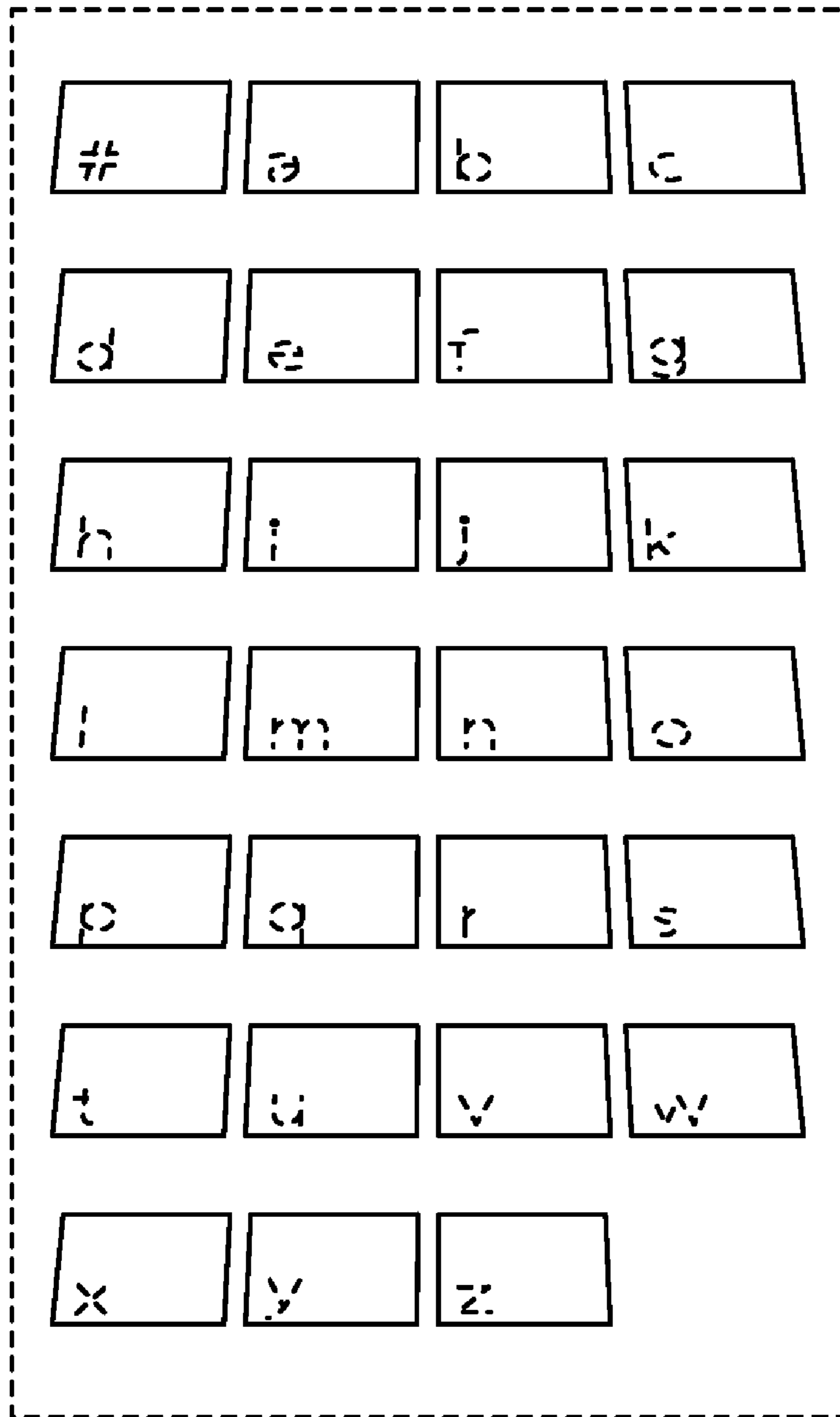

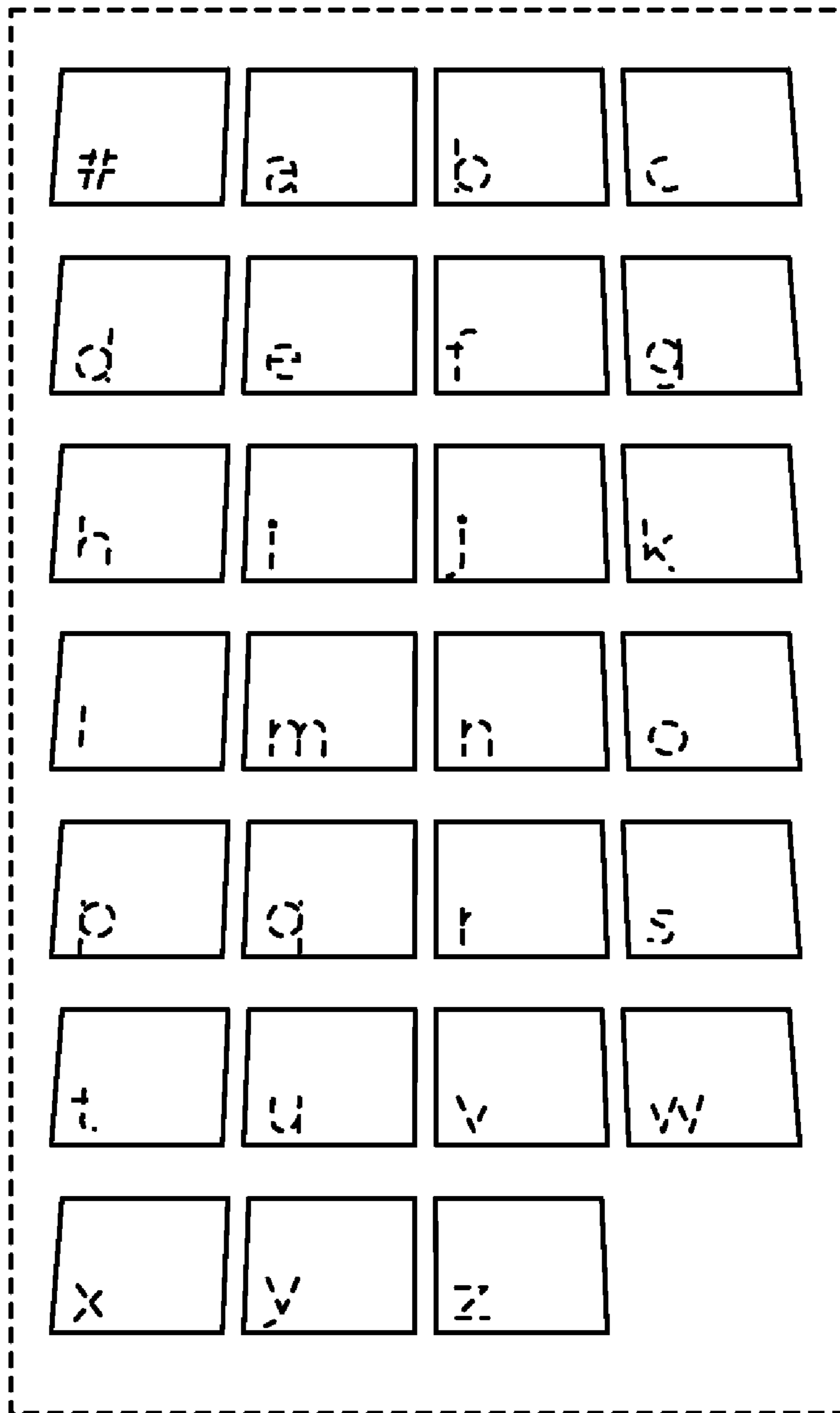

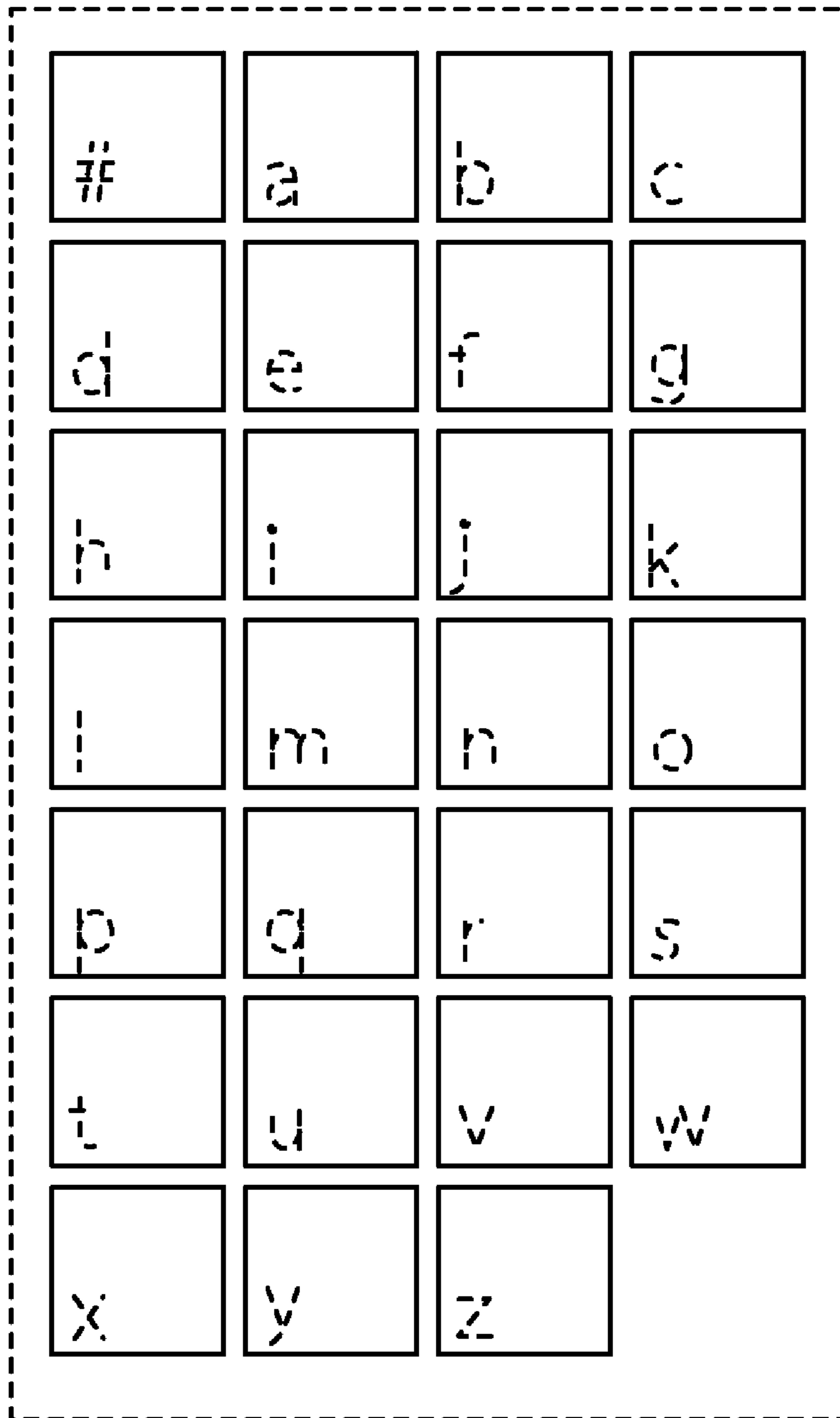

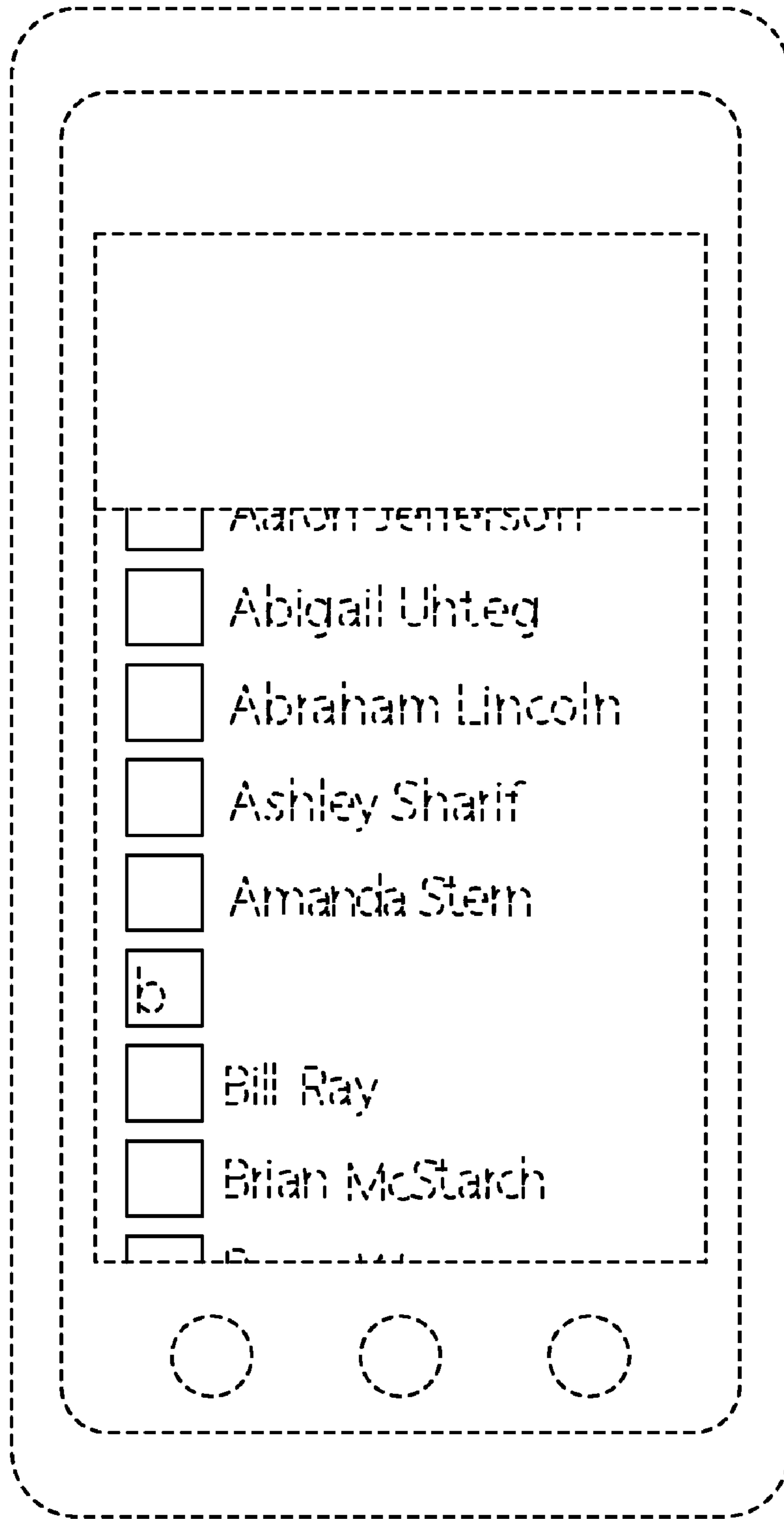

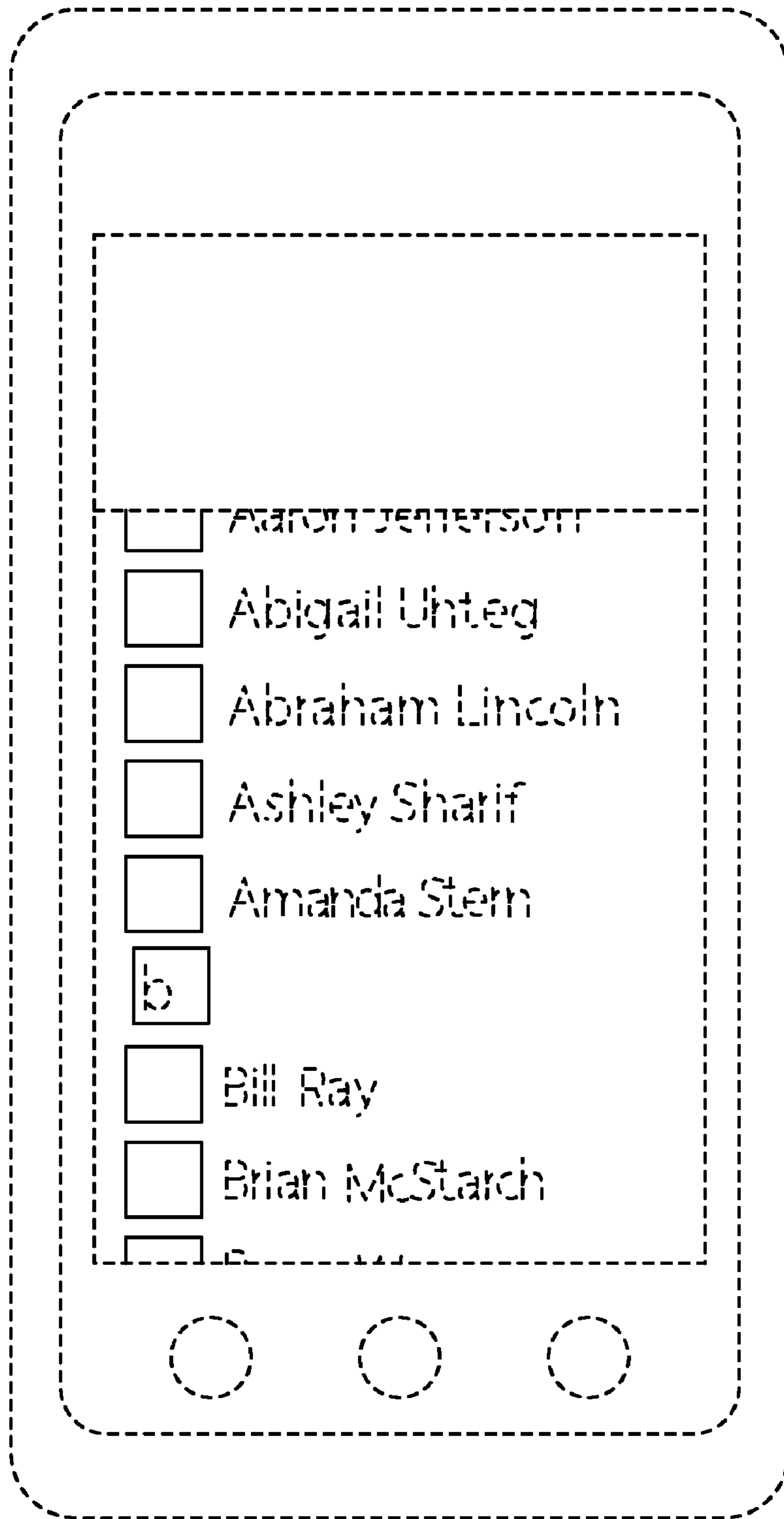

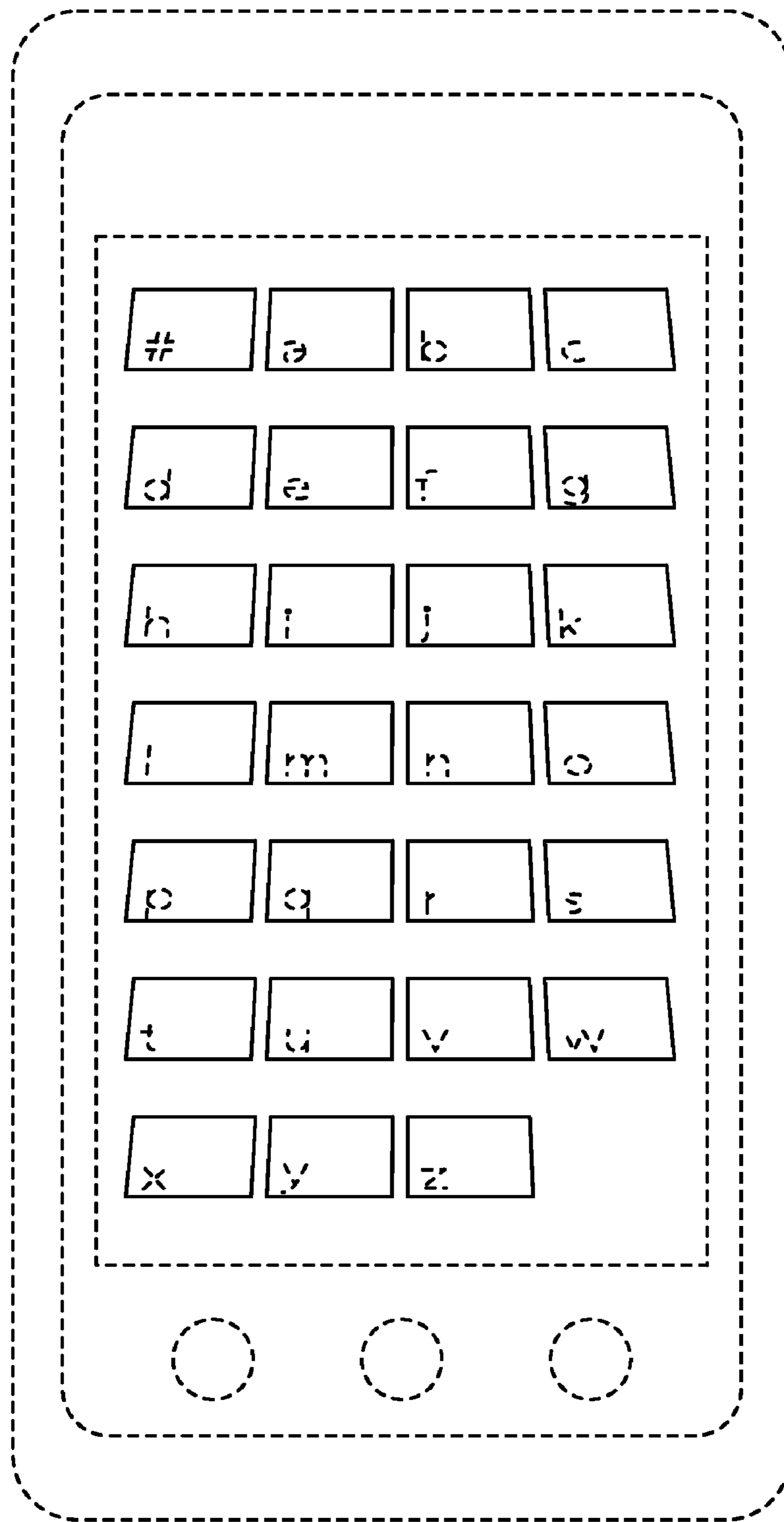

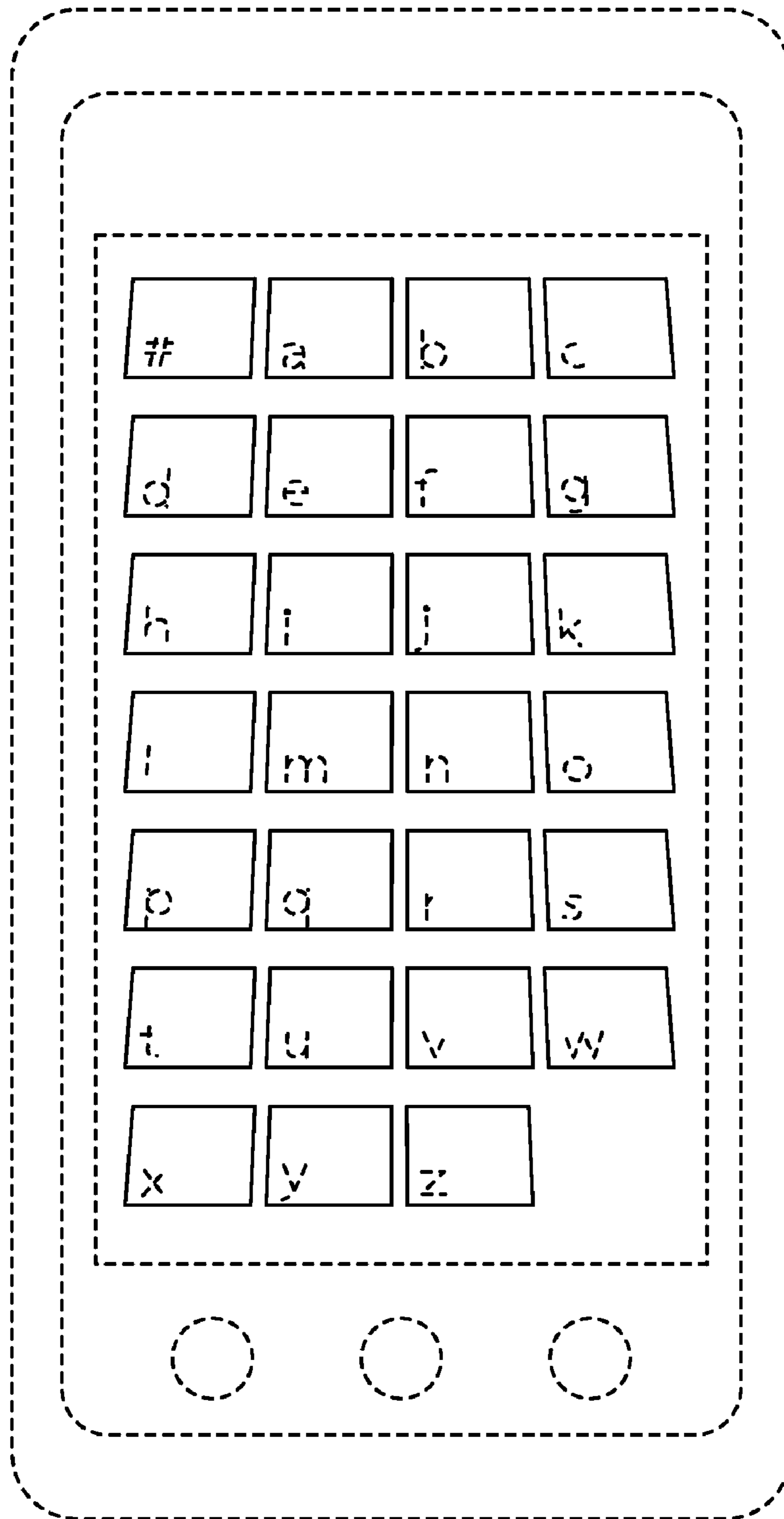

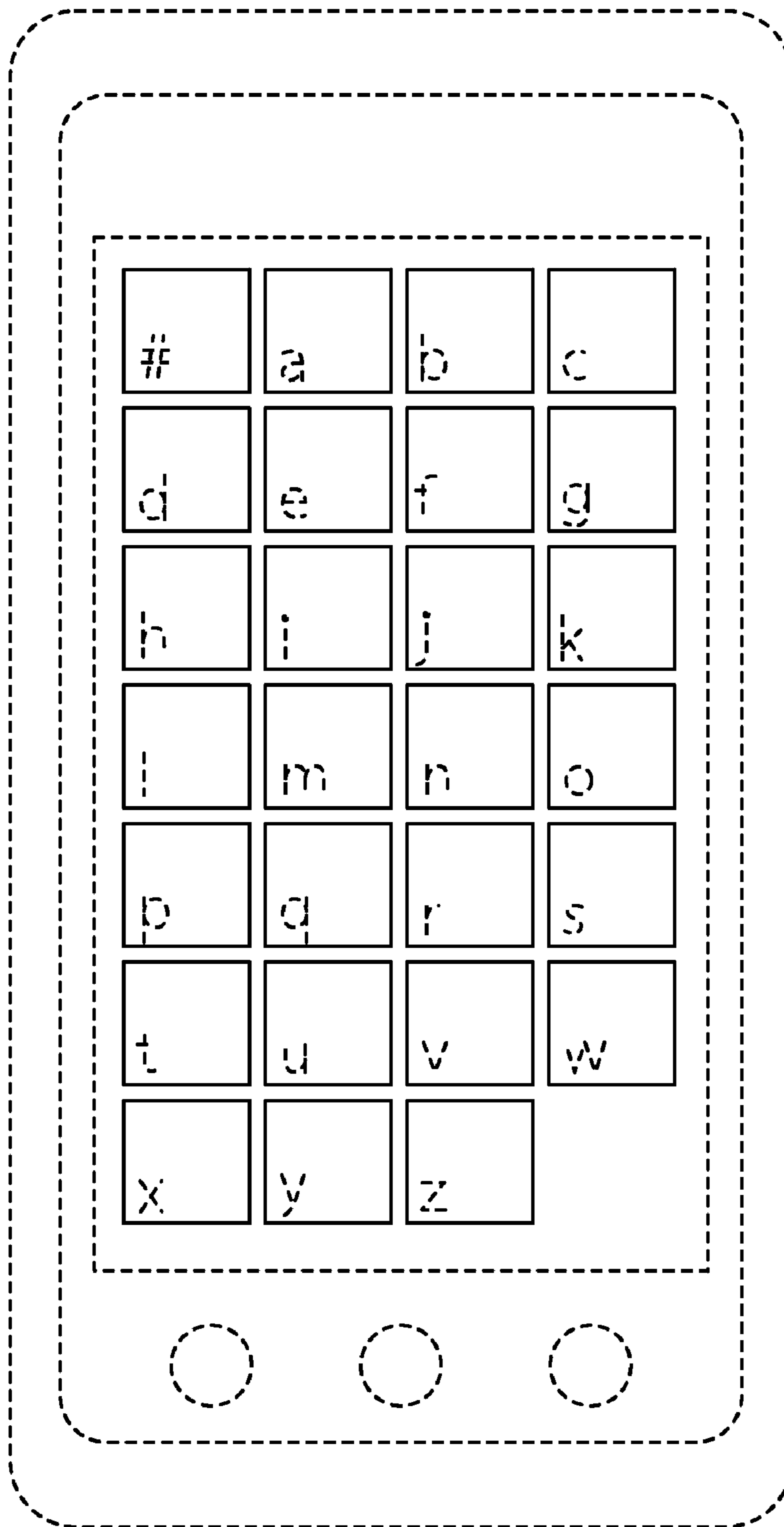
