FIG. 6 is the sixth image thereof;

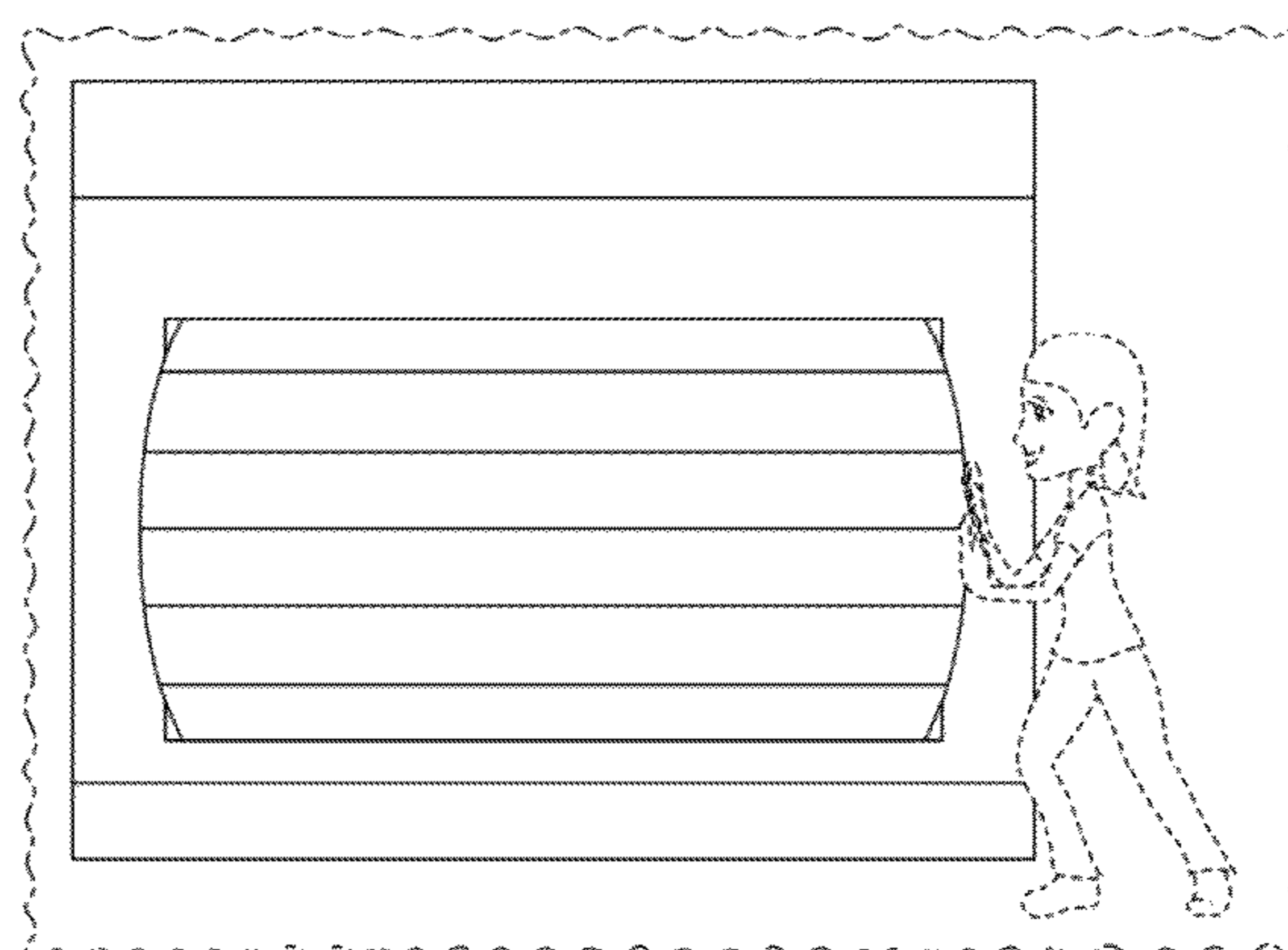
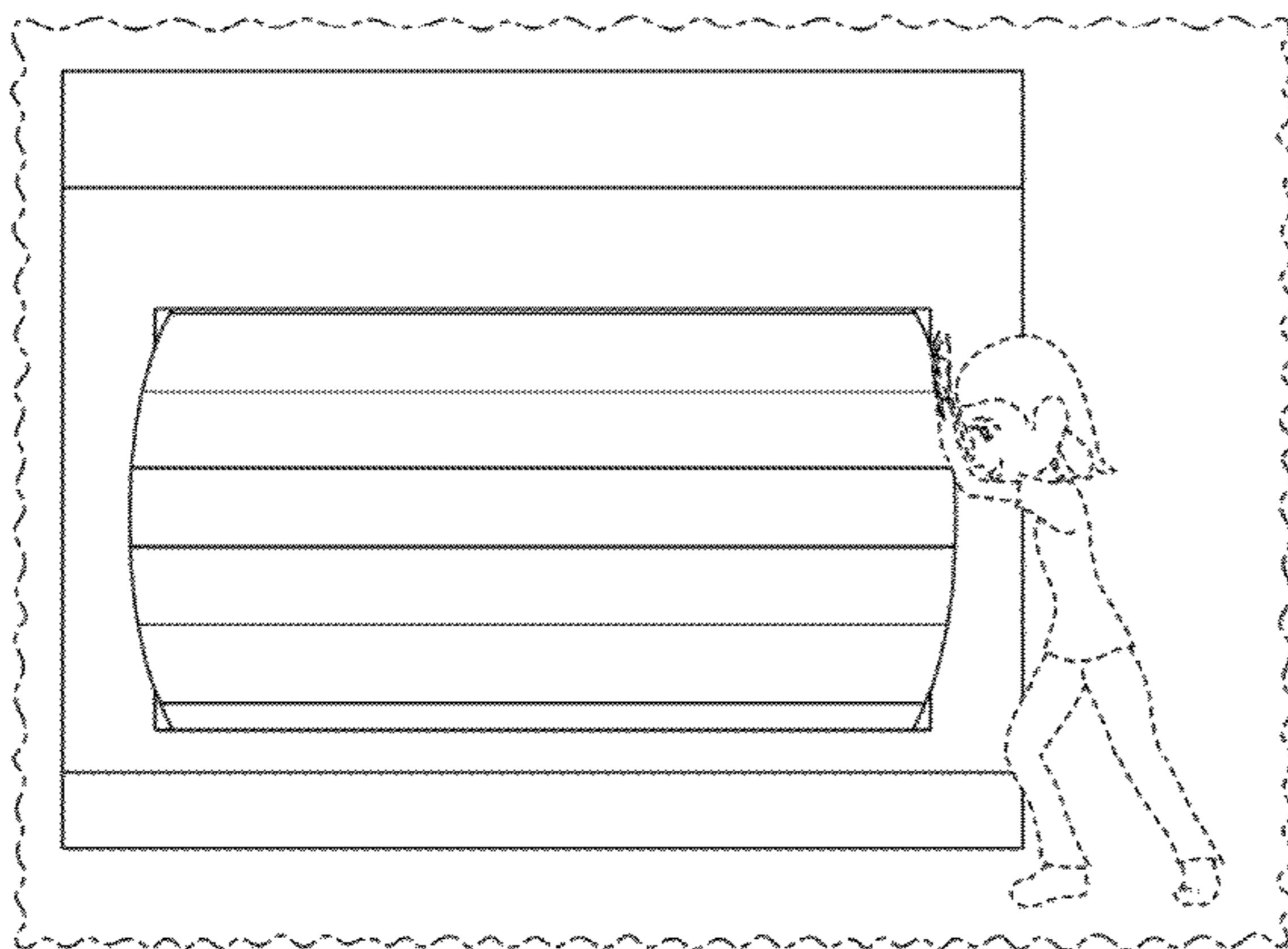
FIG. 7 is the seventh image thereof;

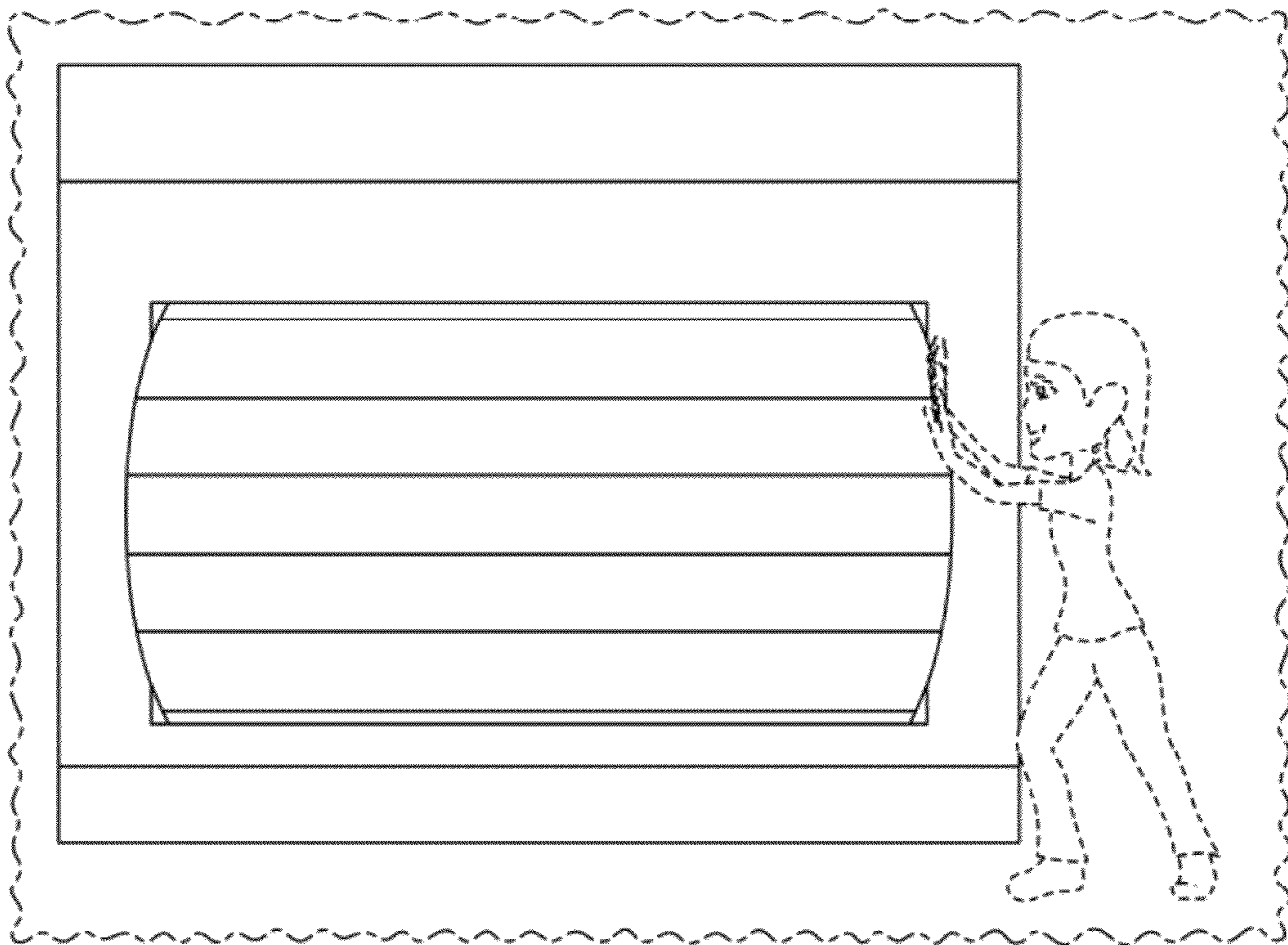

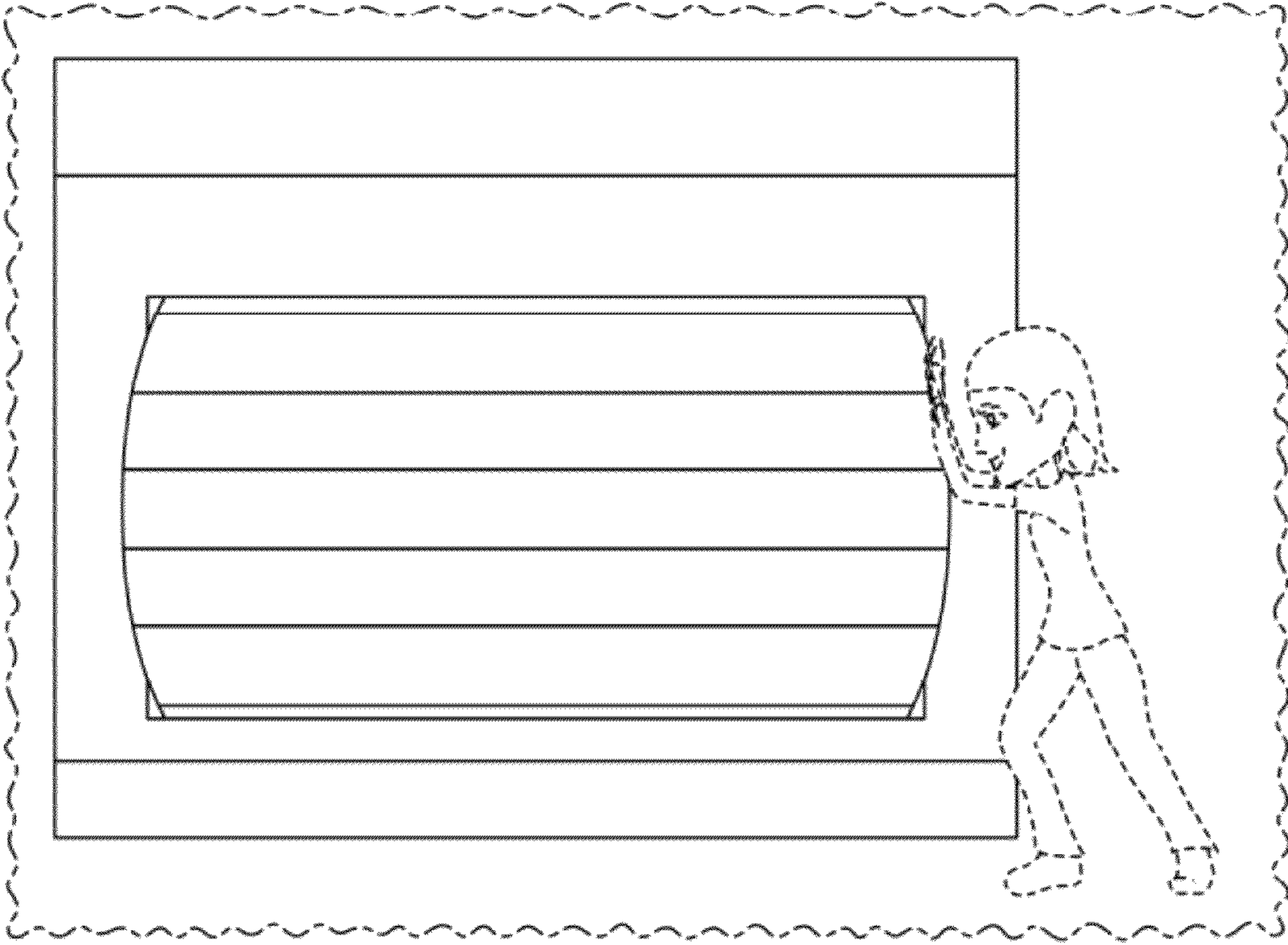

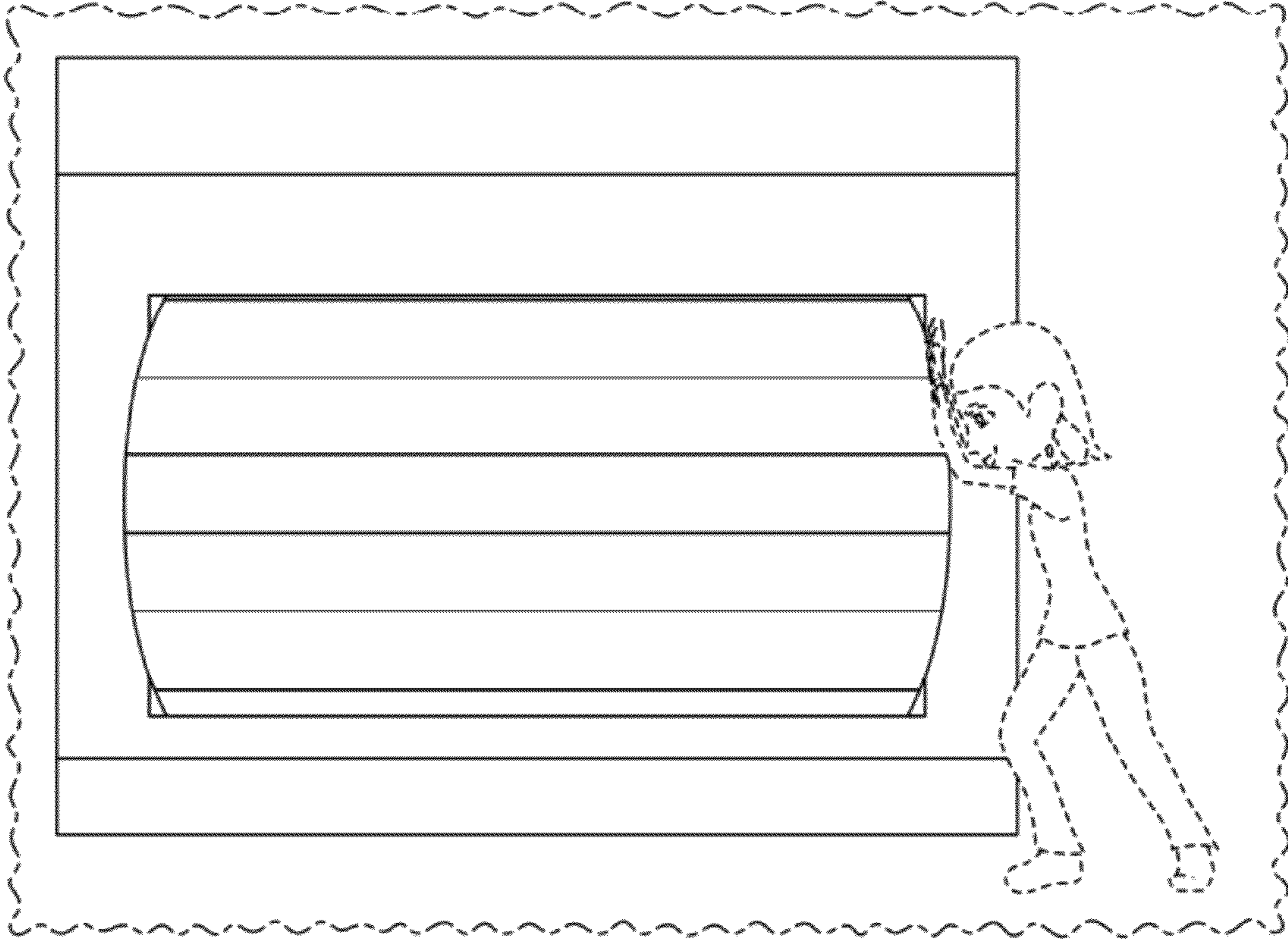

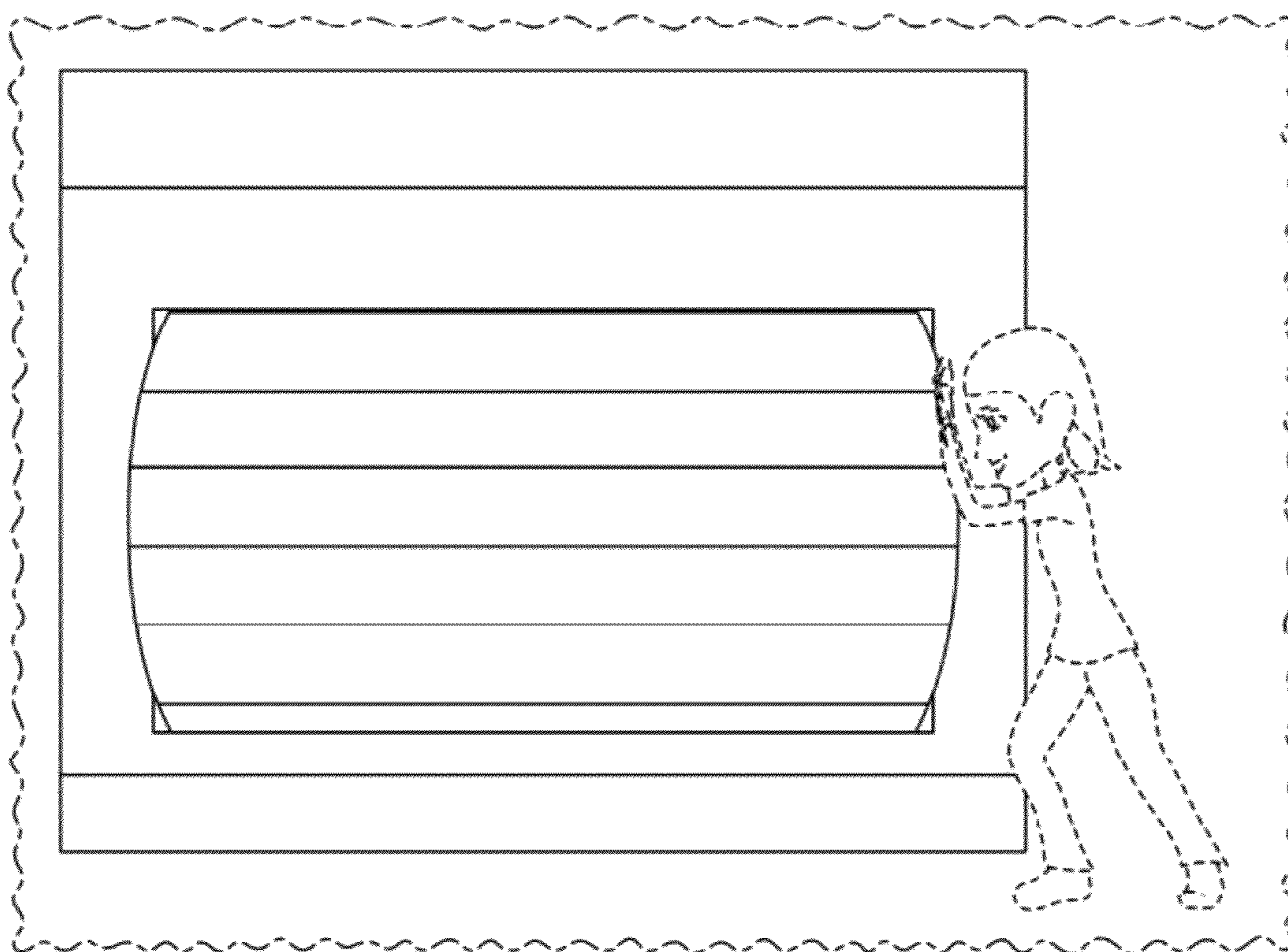

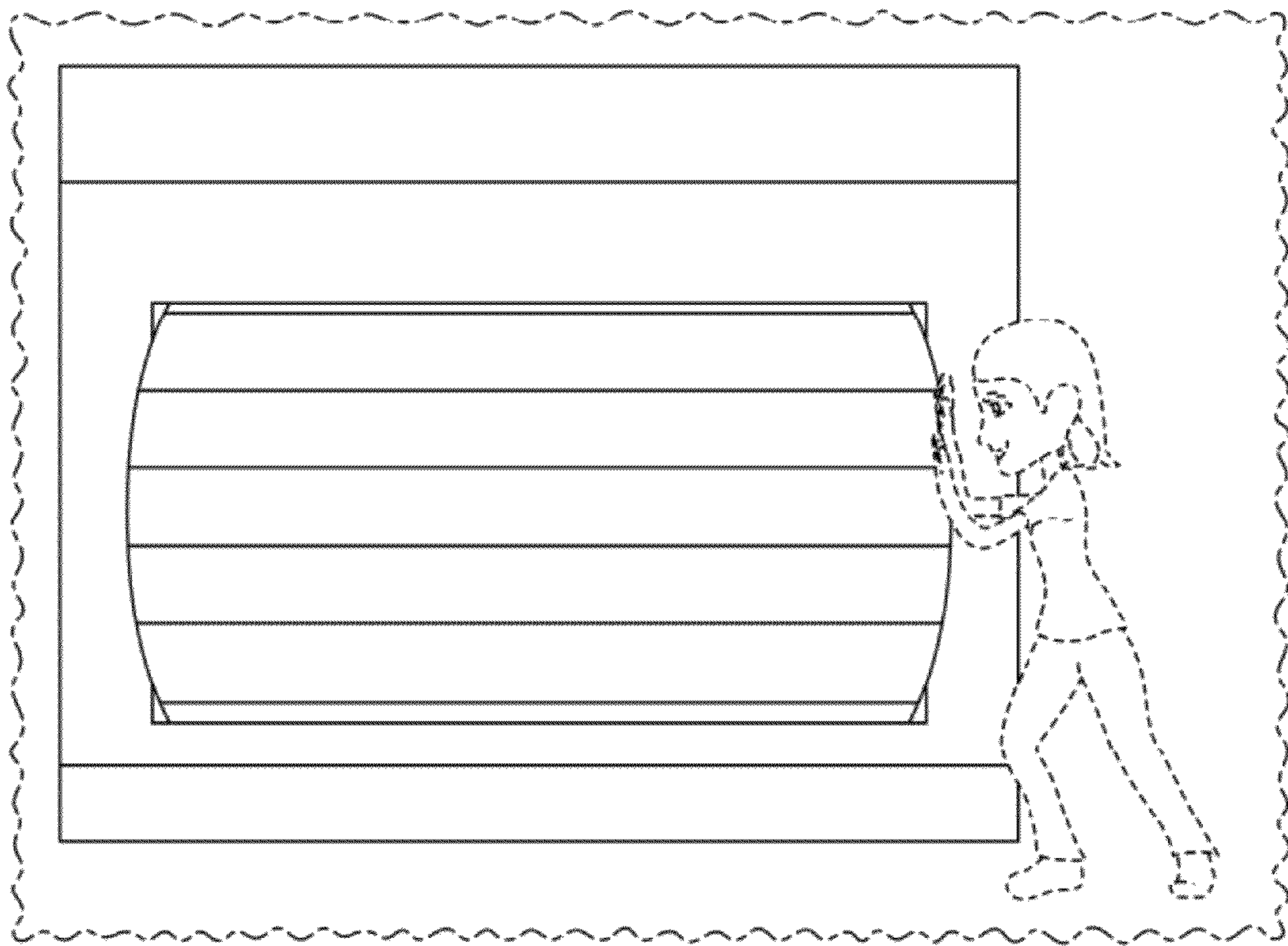

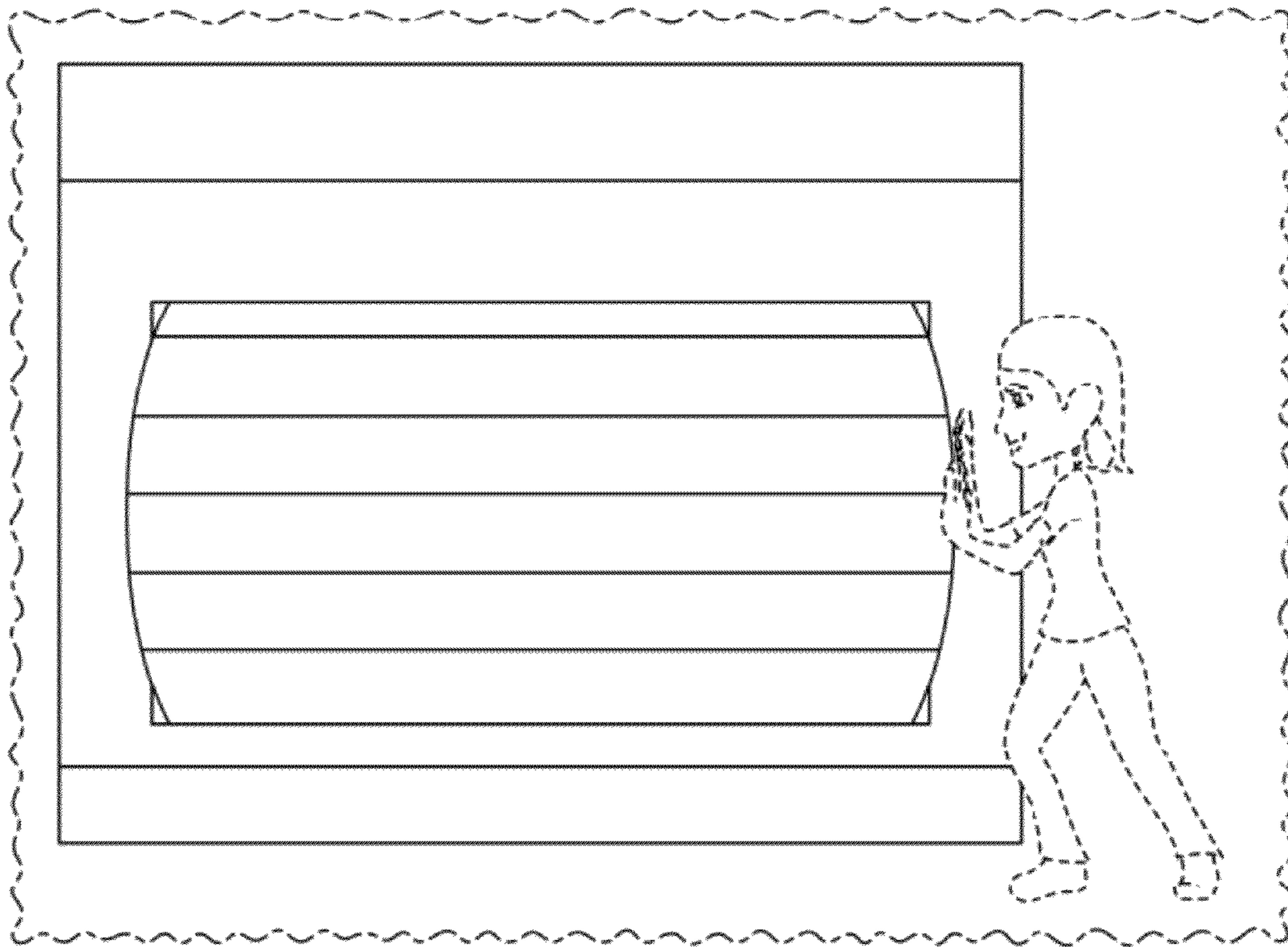

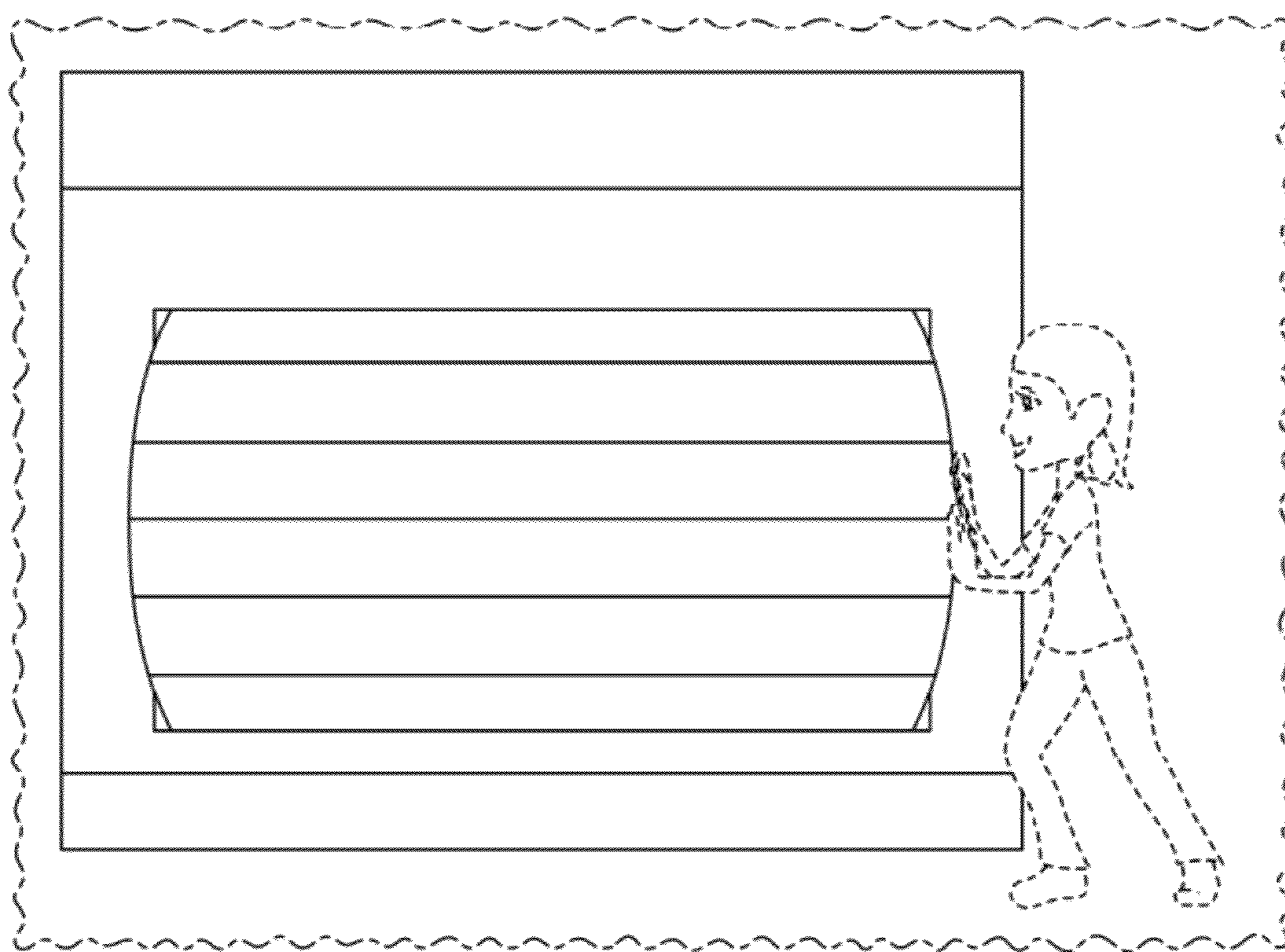

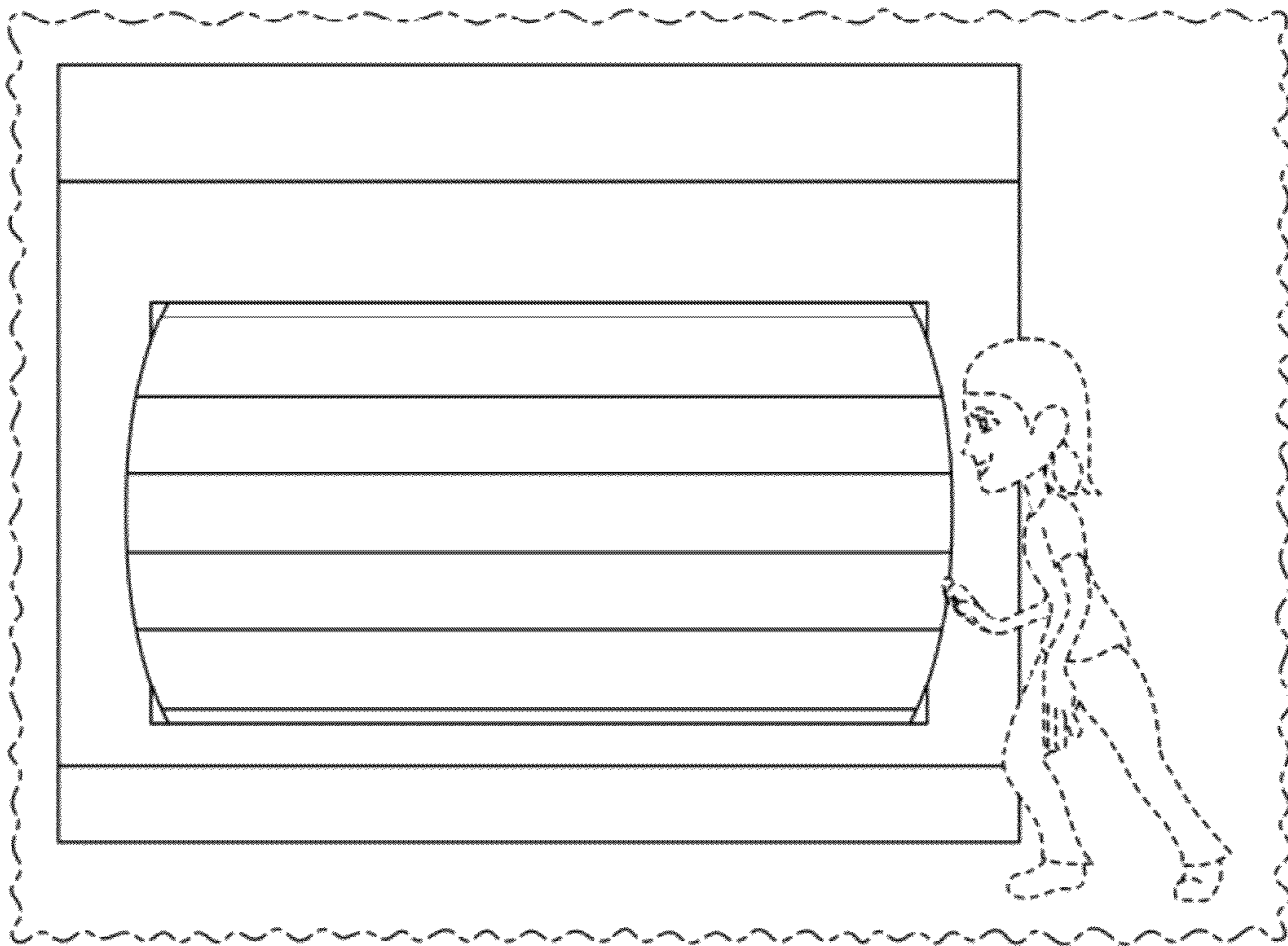

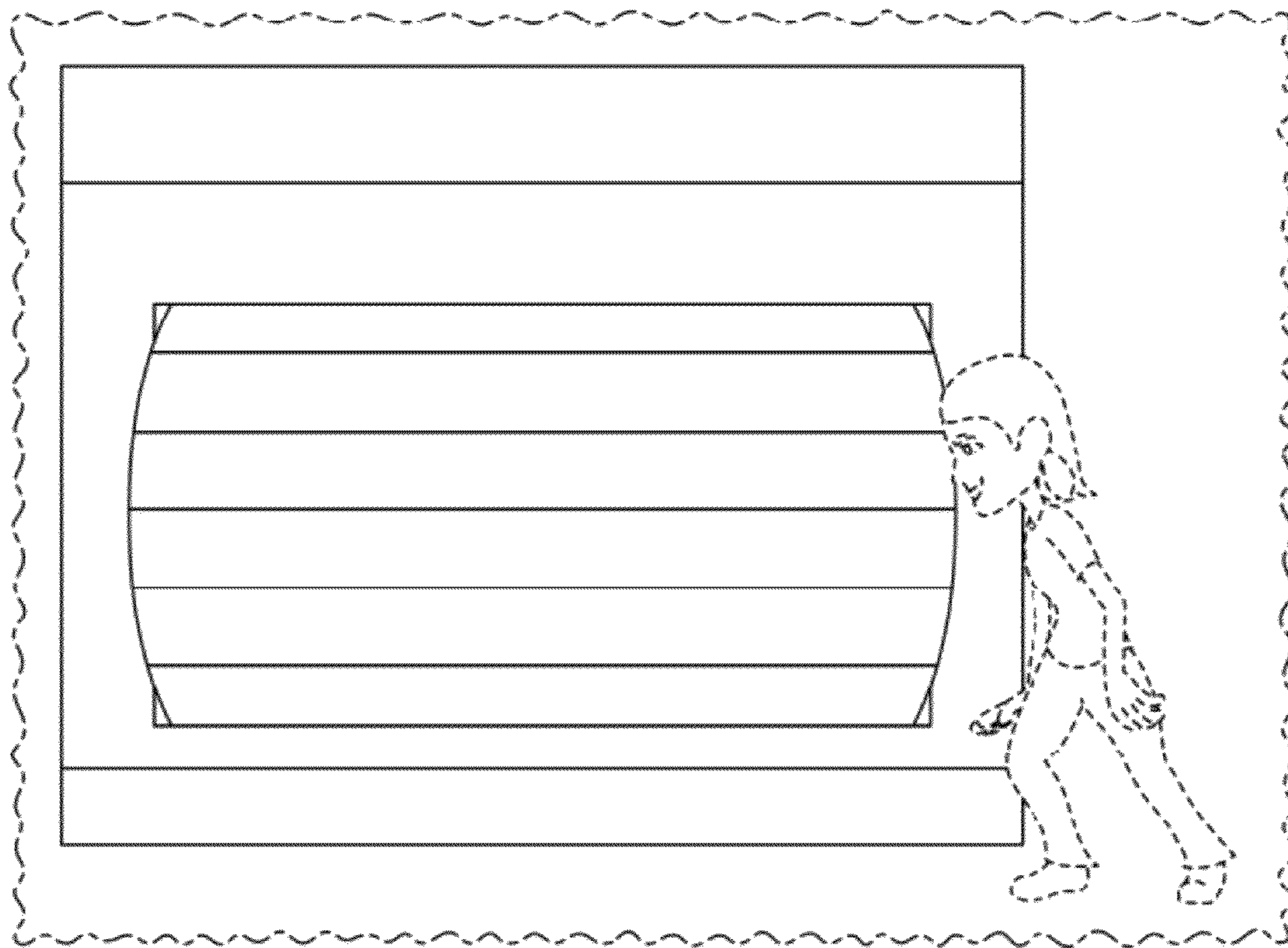
