We claim the ornamental design for a printer, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a top, front, and right side of a printer;

FIG. 2 is a front elevational view of the printer;

FIG. 4 is a right side elevational view of the printer;

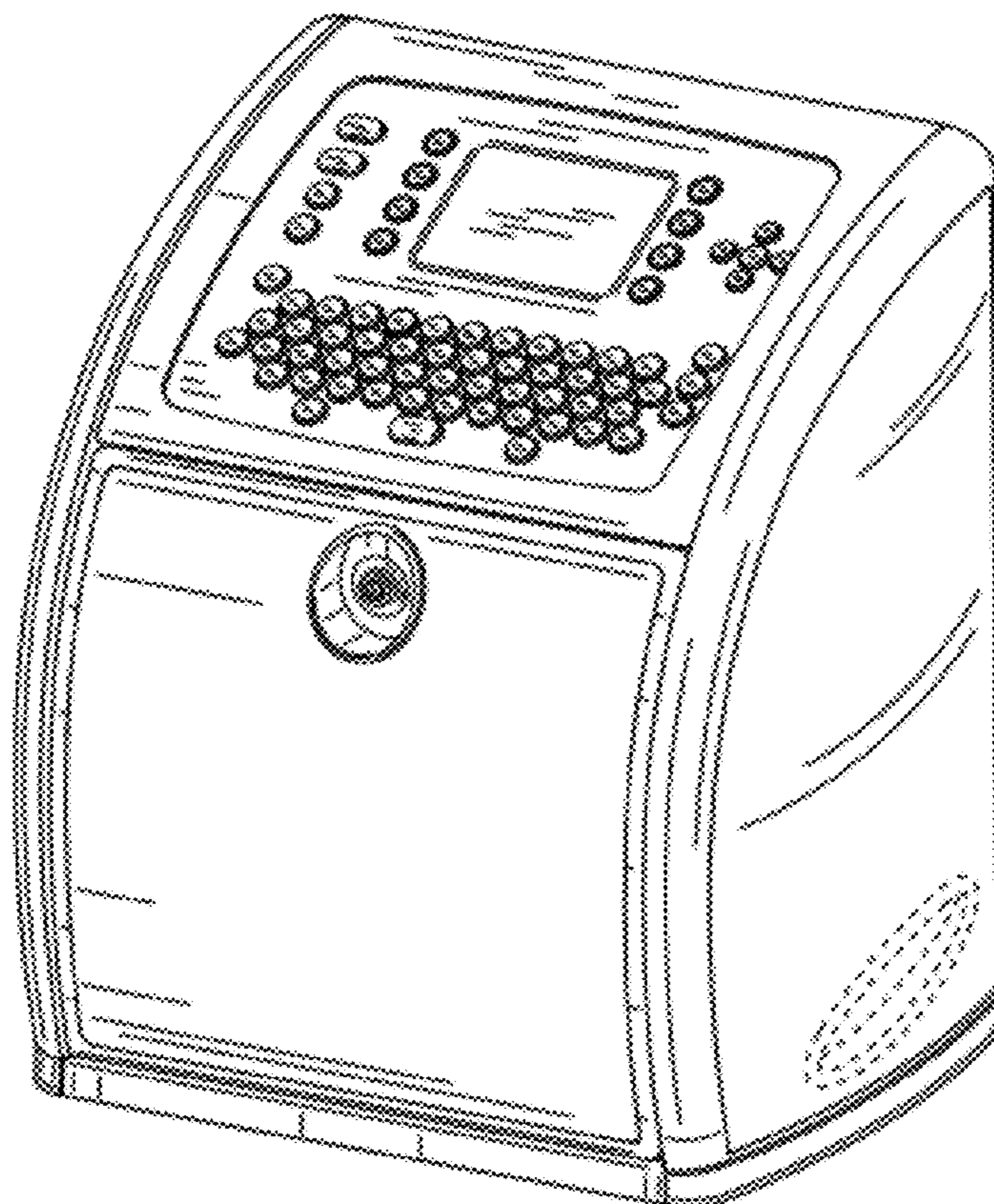
FIG. 5 is a left side elevational view of the printer;

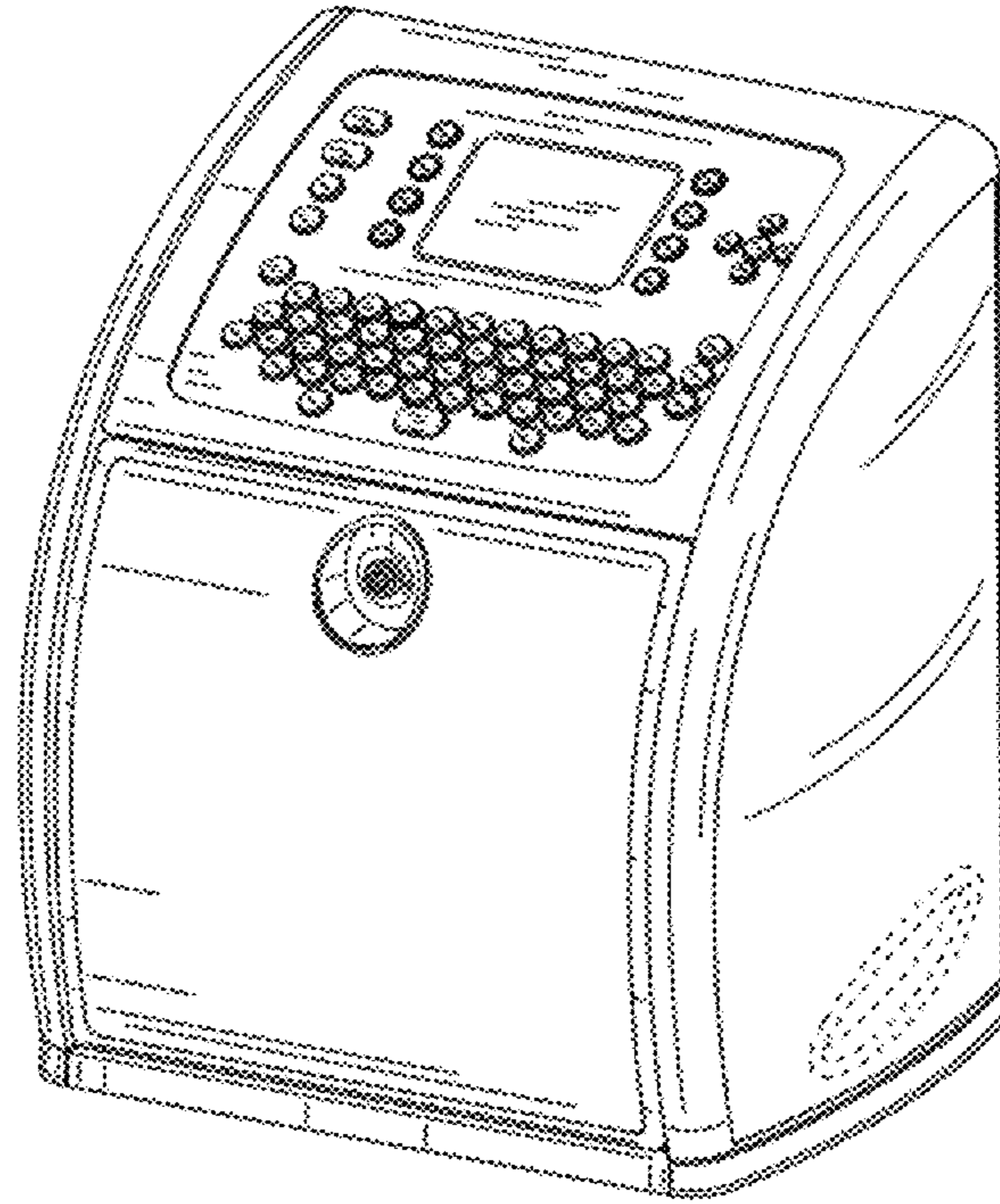

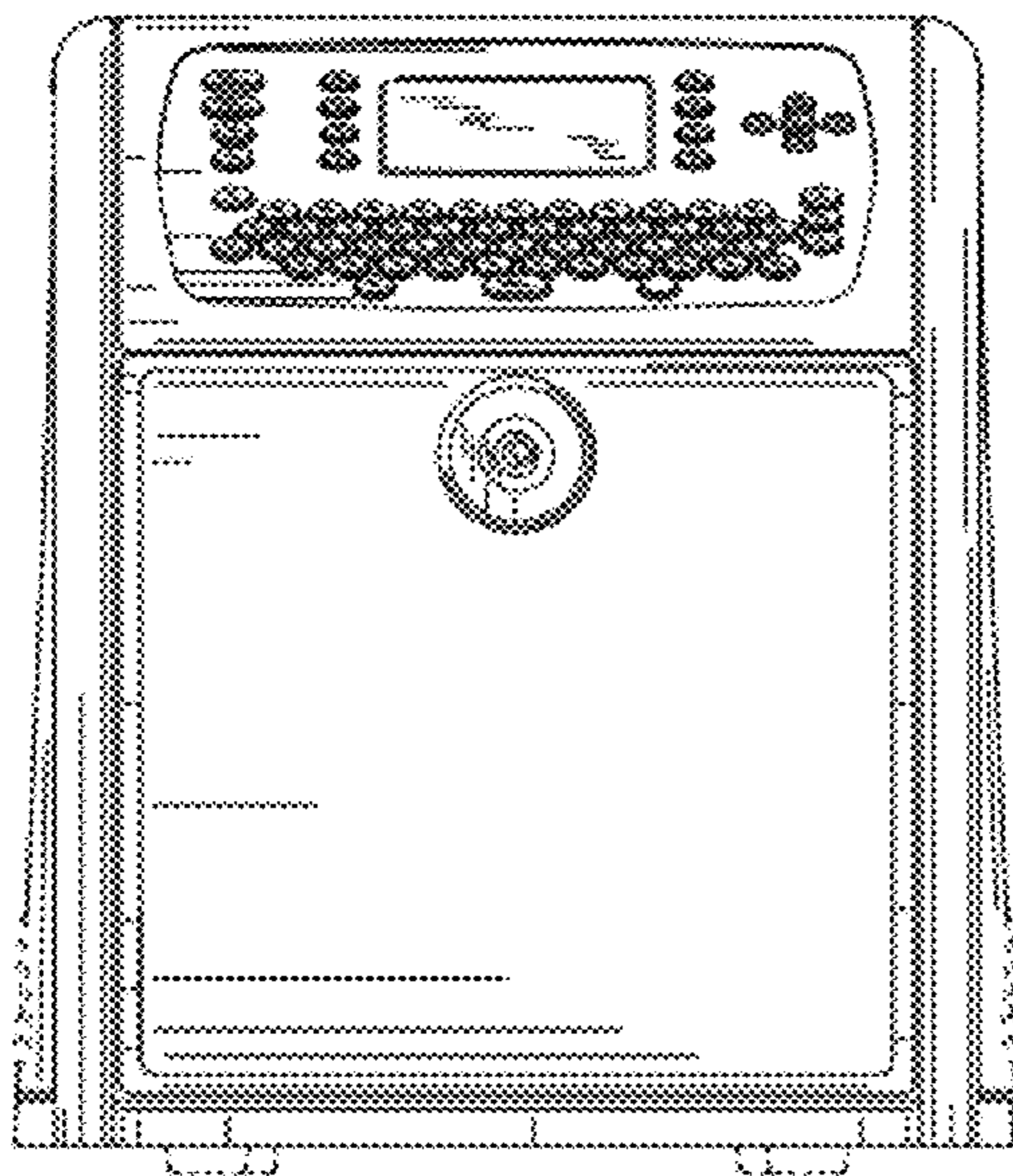

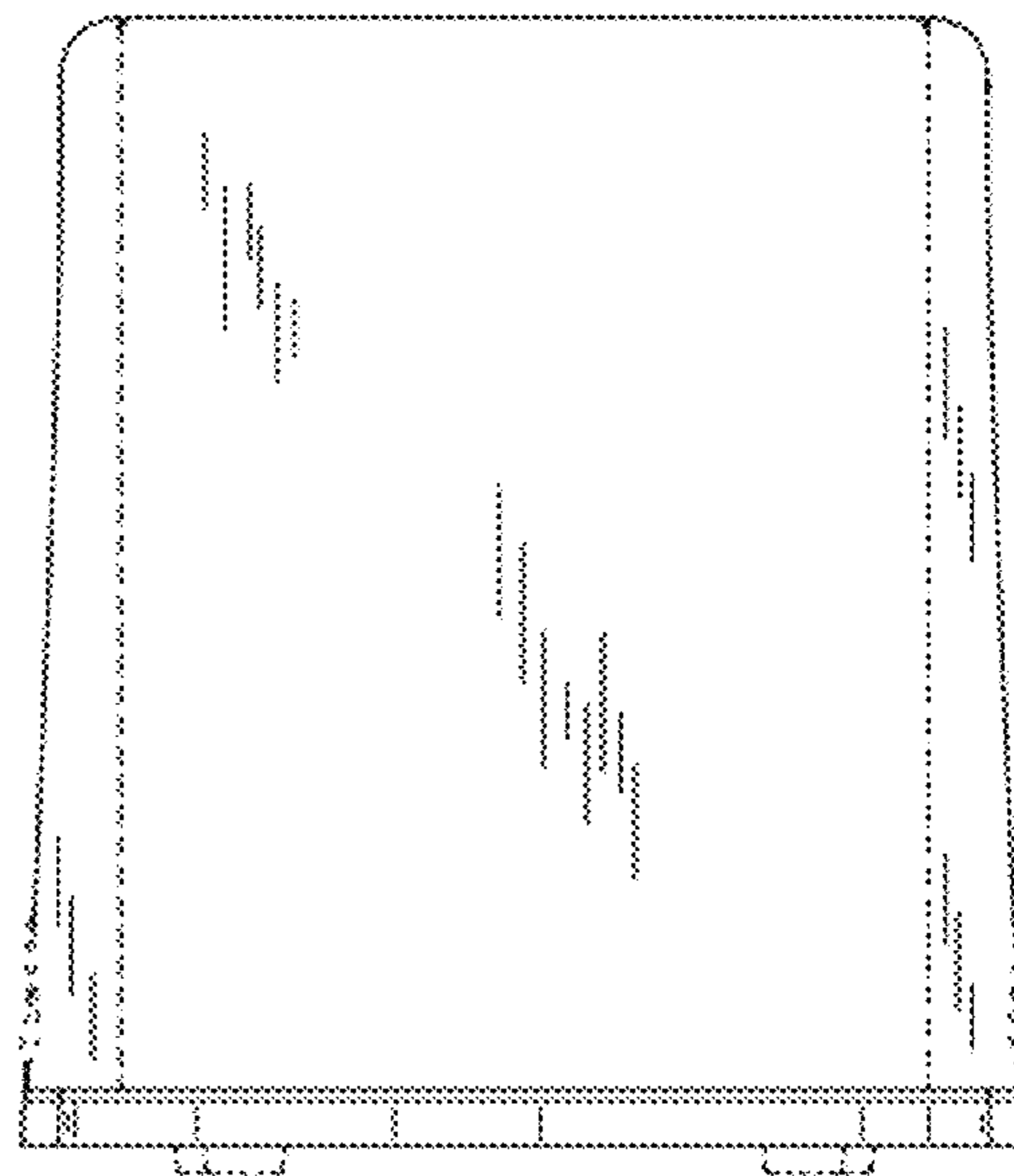

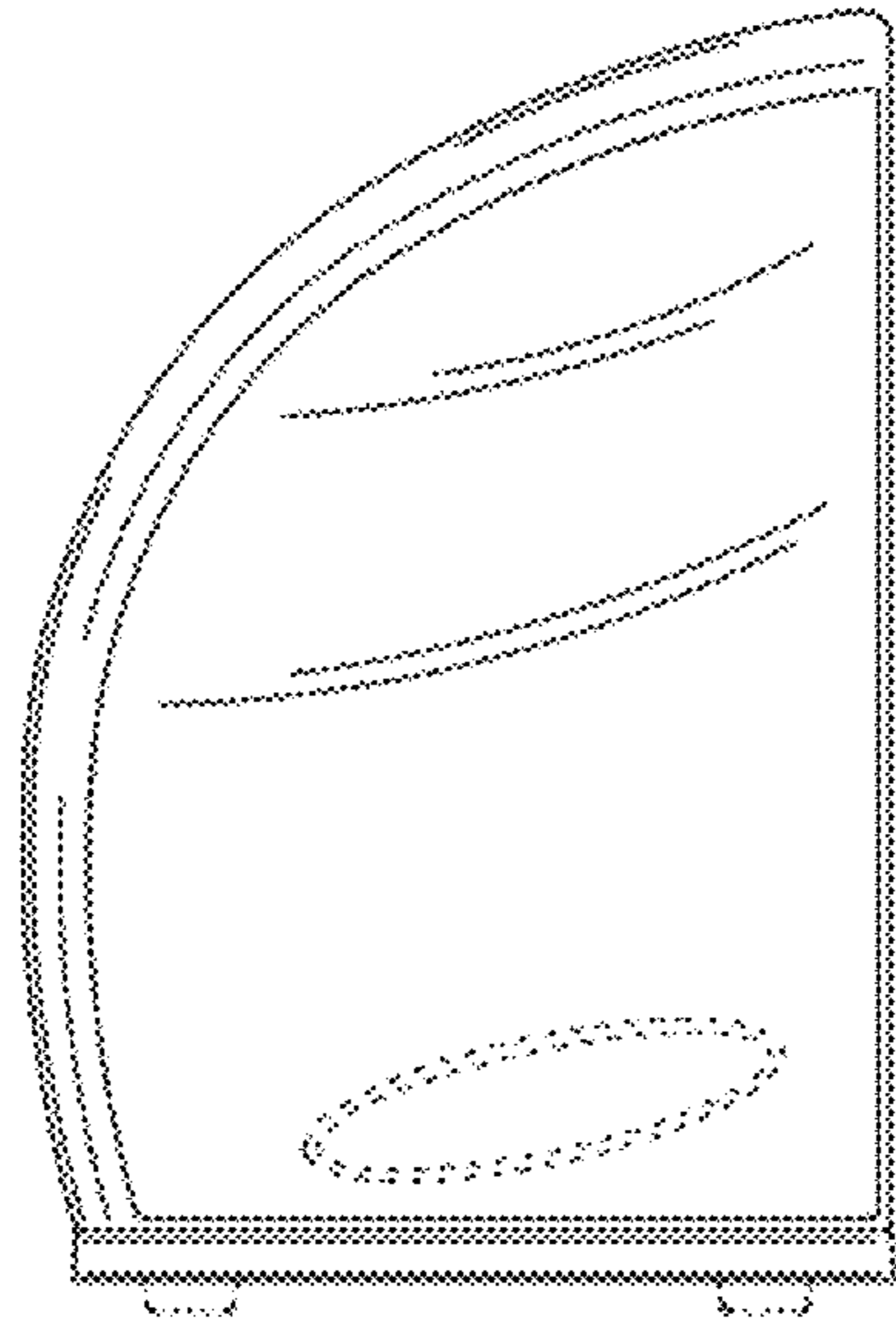

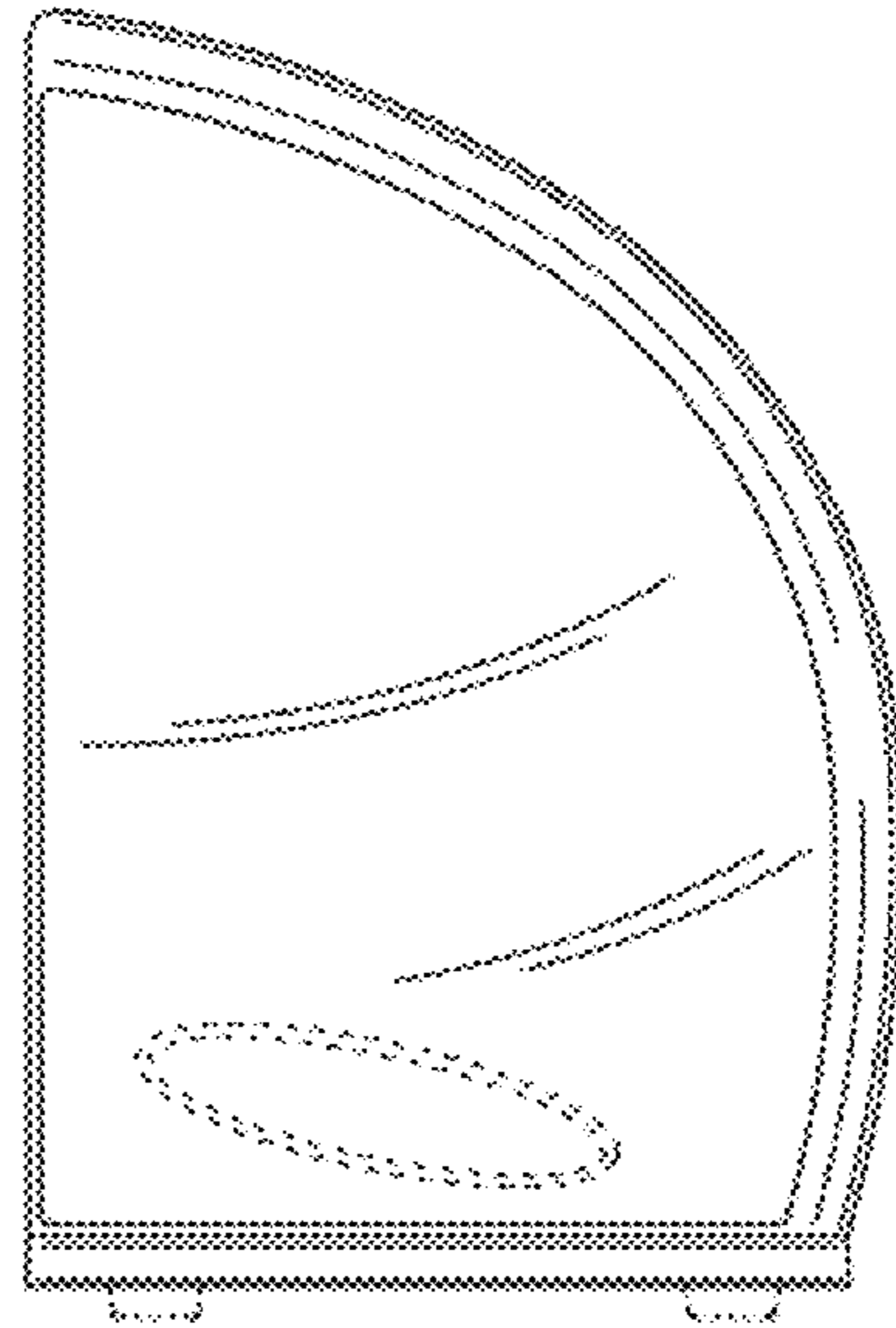

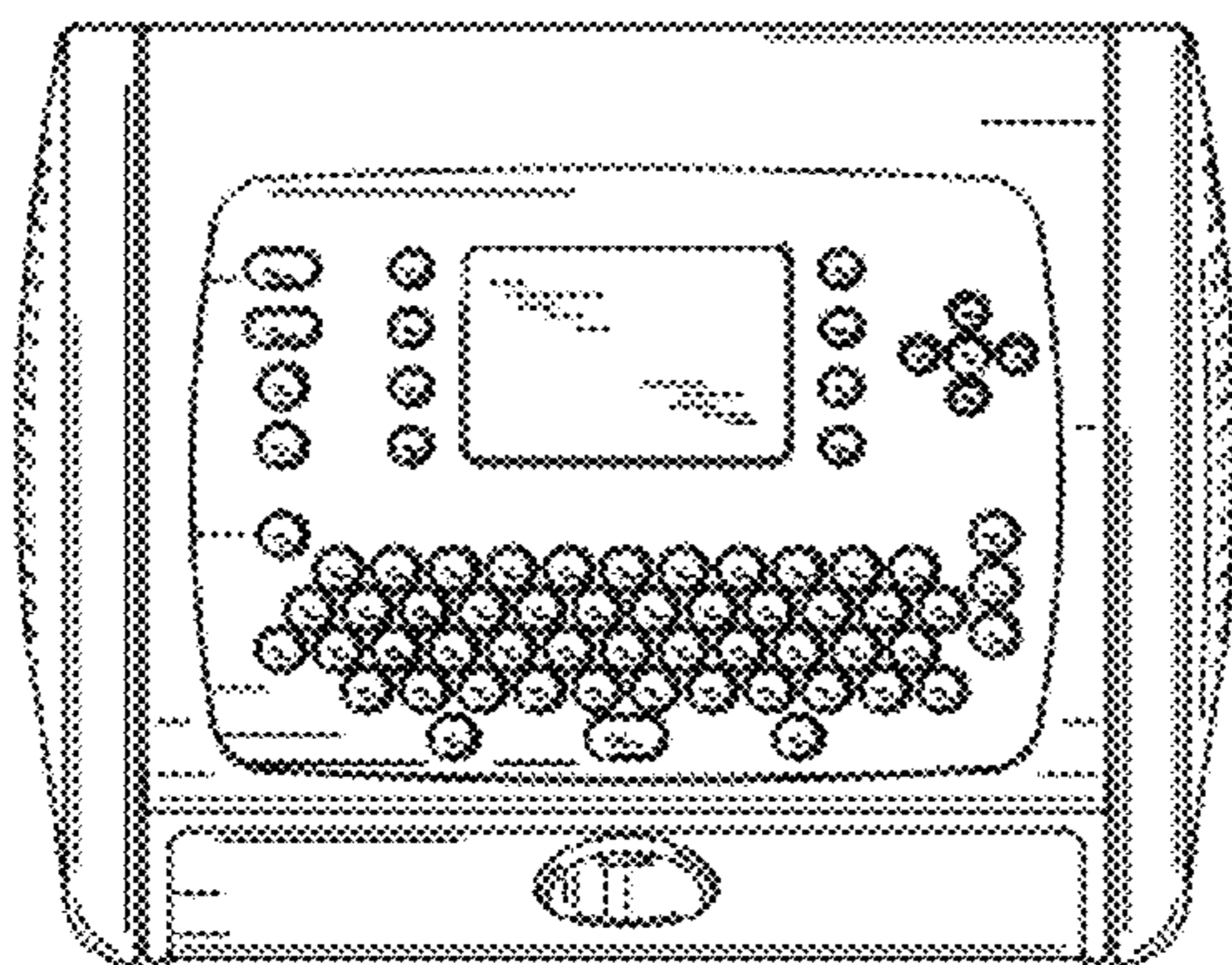

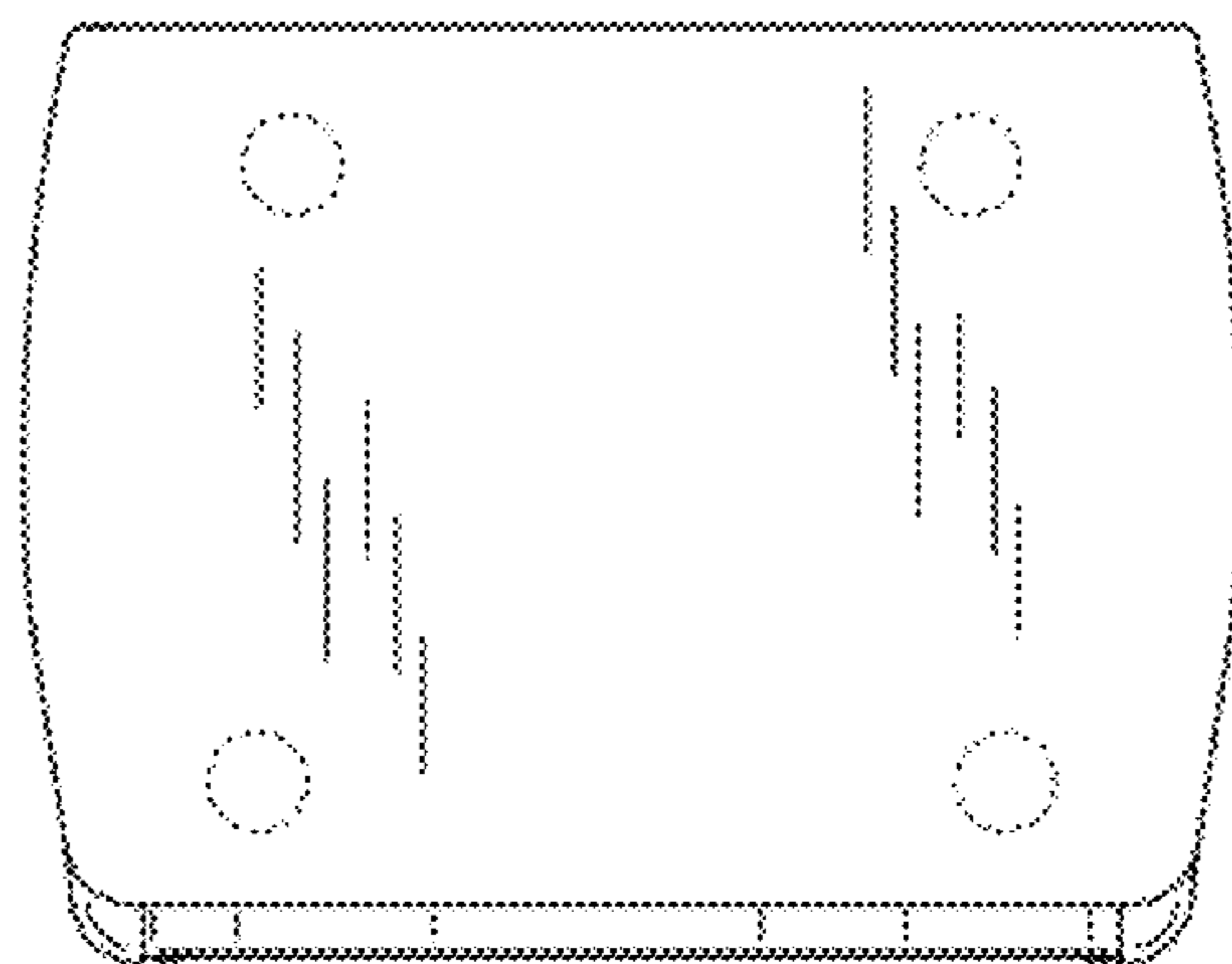
