DESCRIPTION

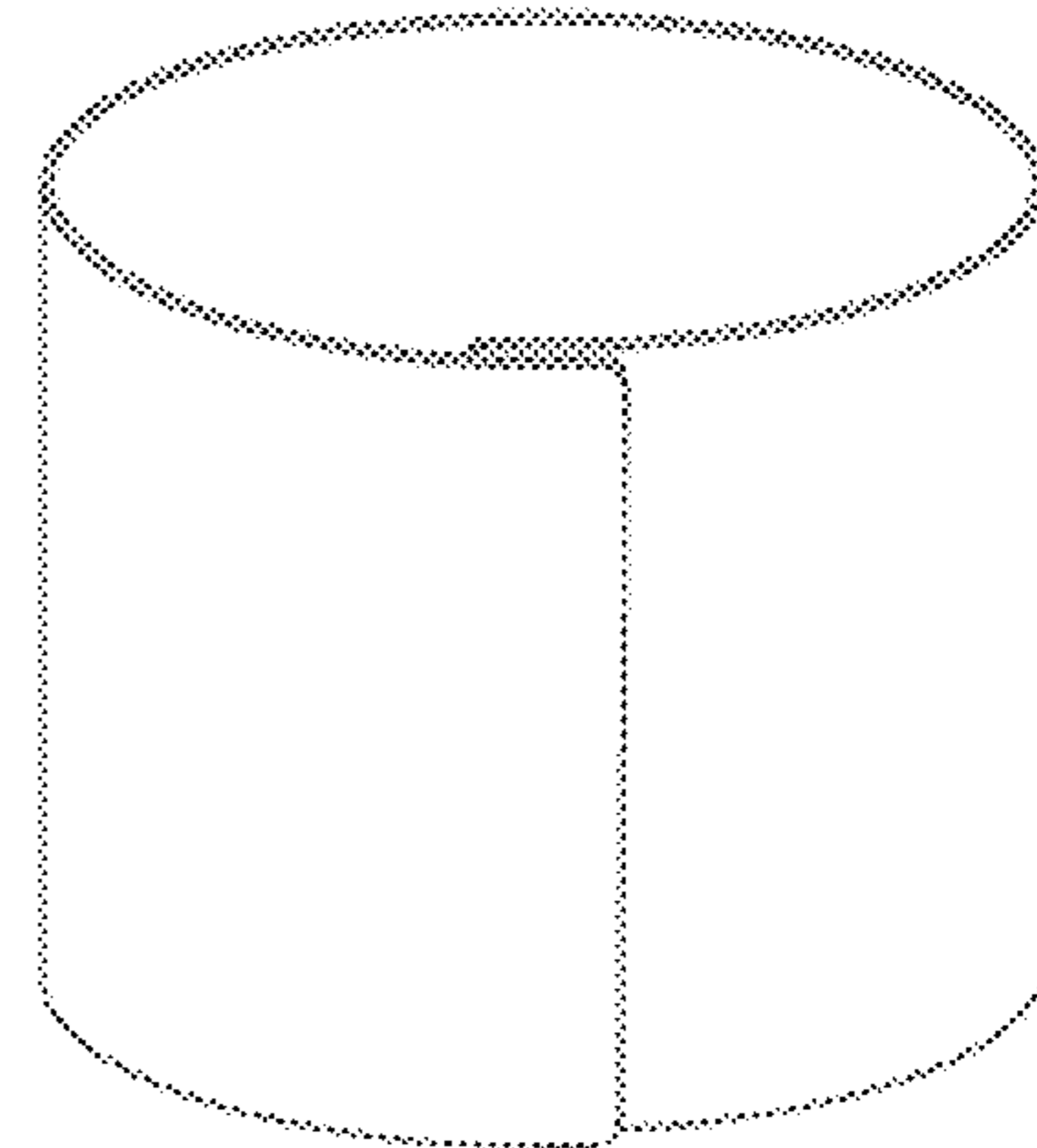

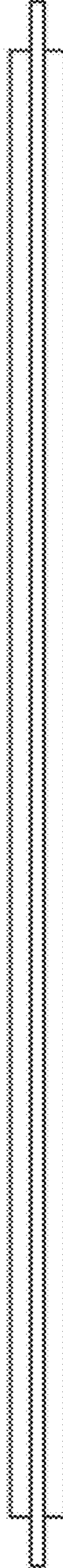

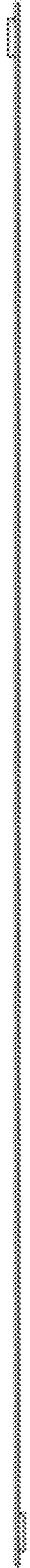

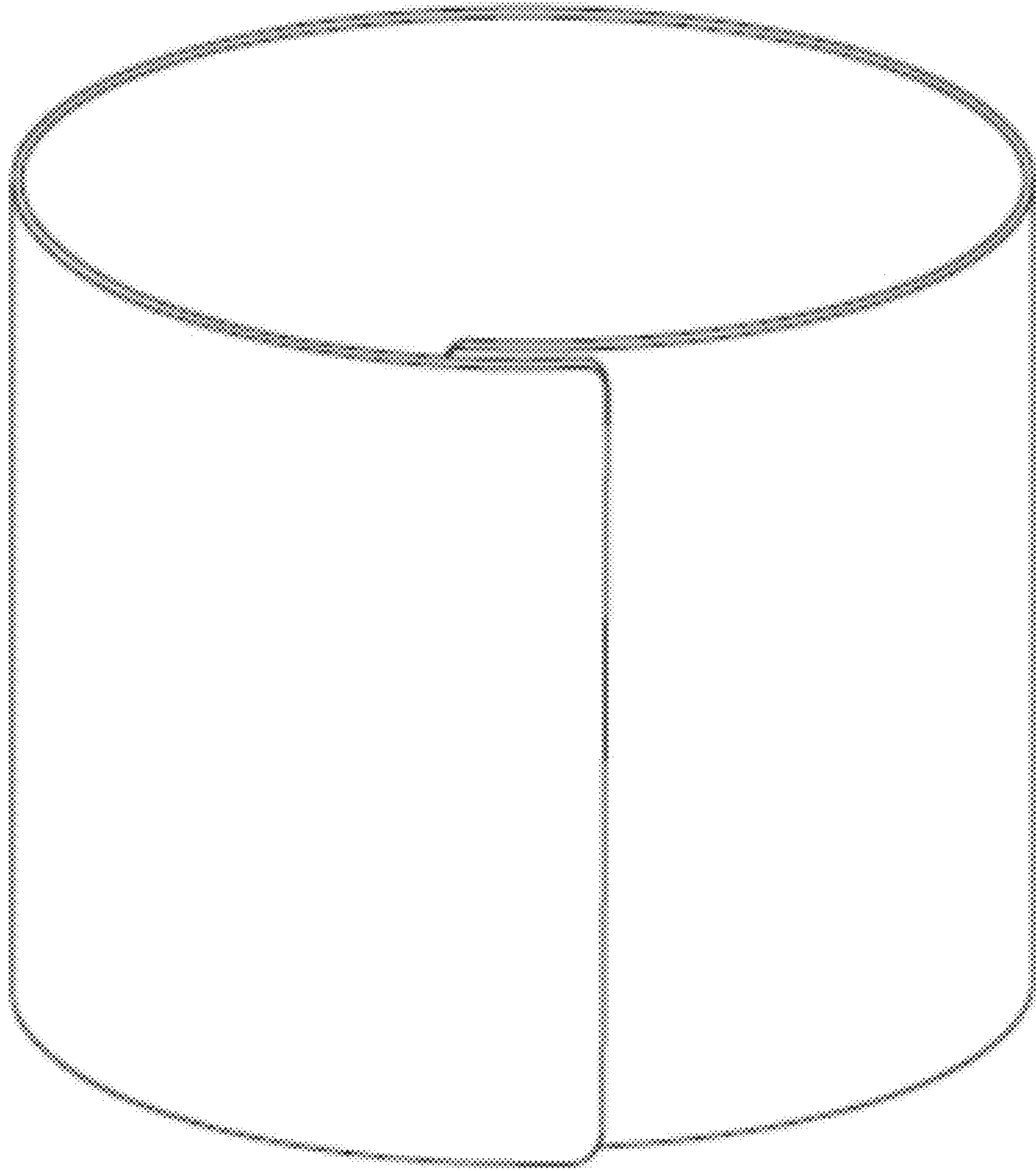
