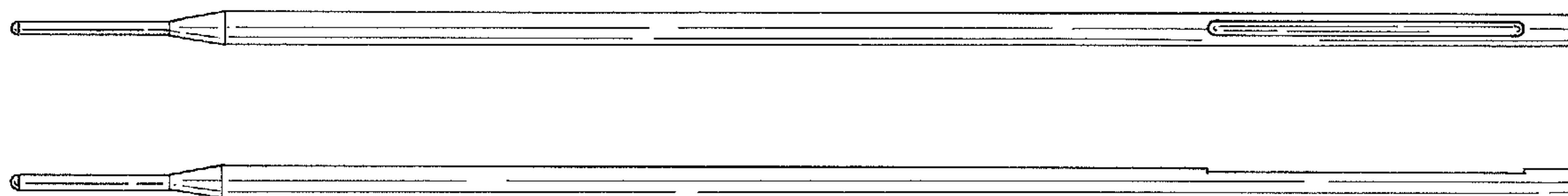

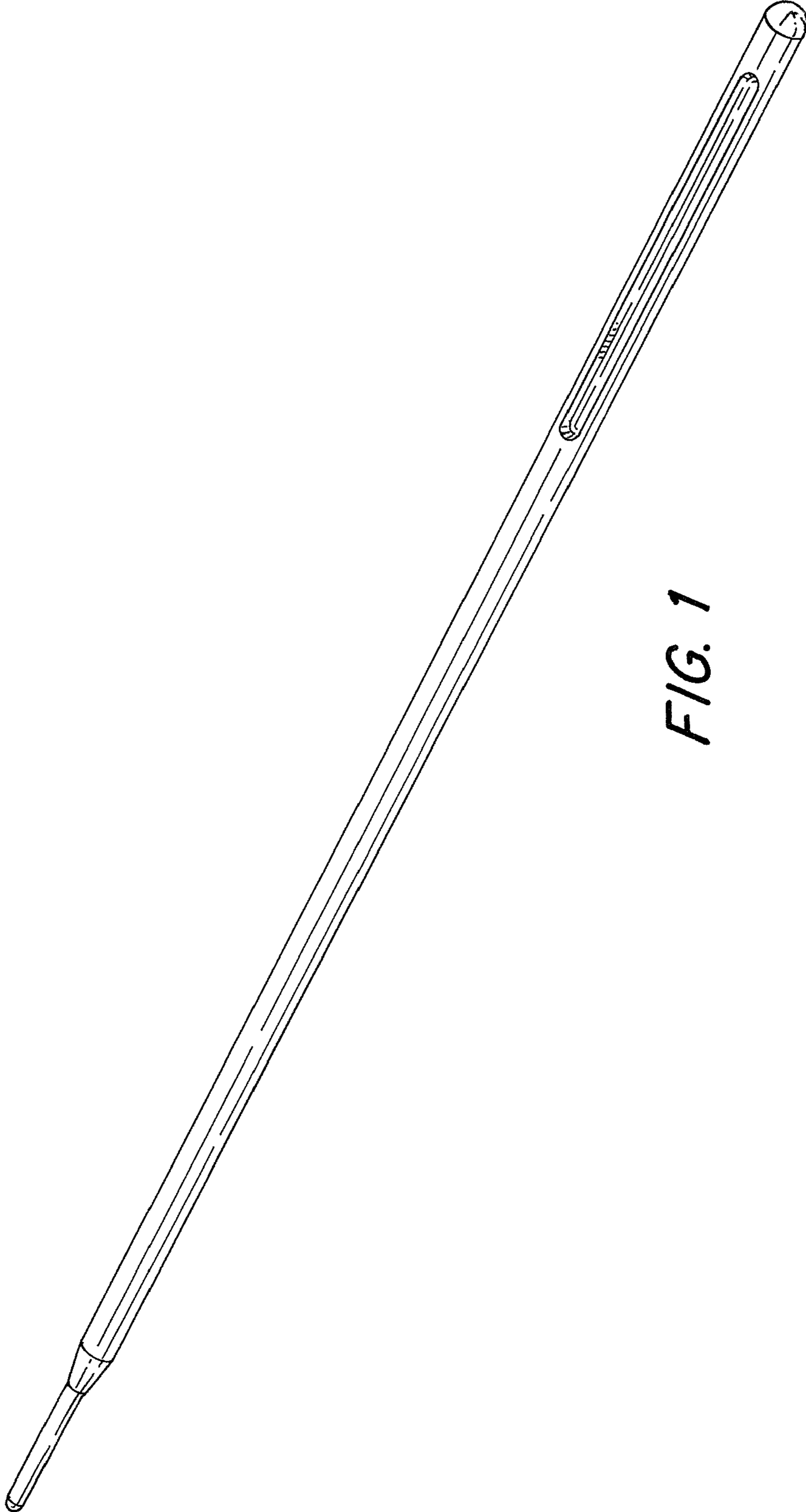
The ornamental design for a changing rod, as shown and described.

**DESCRIPTION**

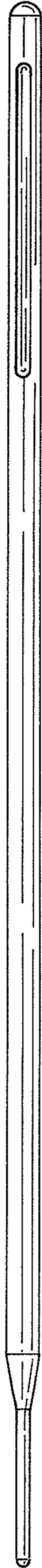
FIG. 1 1 is a top left side perspective view of a changing rod in accordance with the new design;

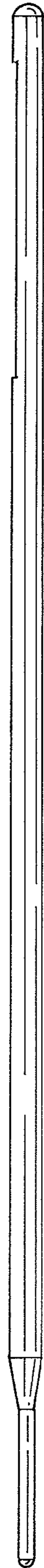

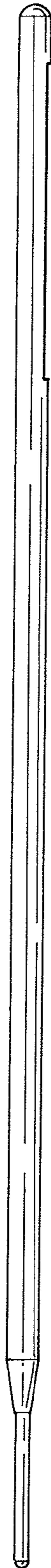

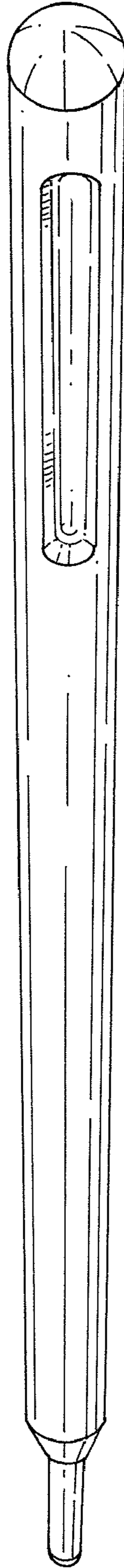

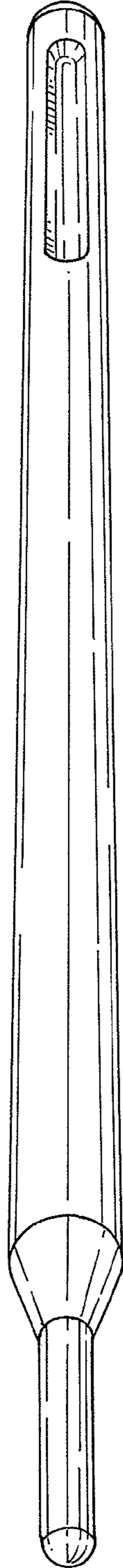
