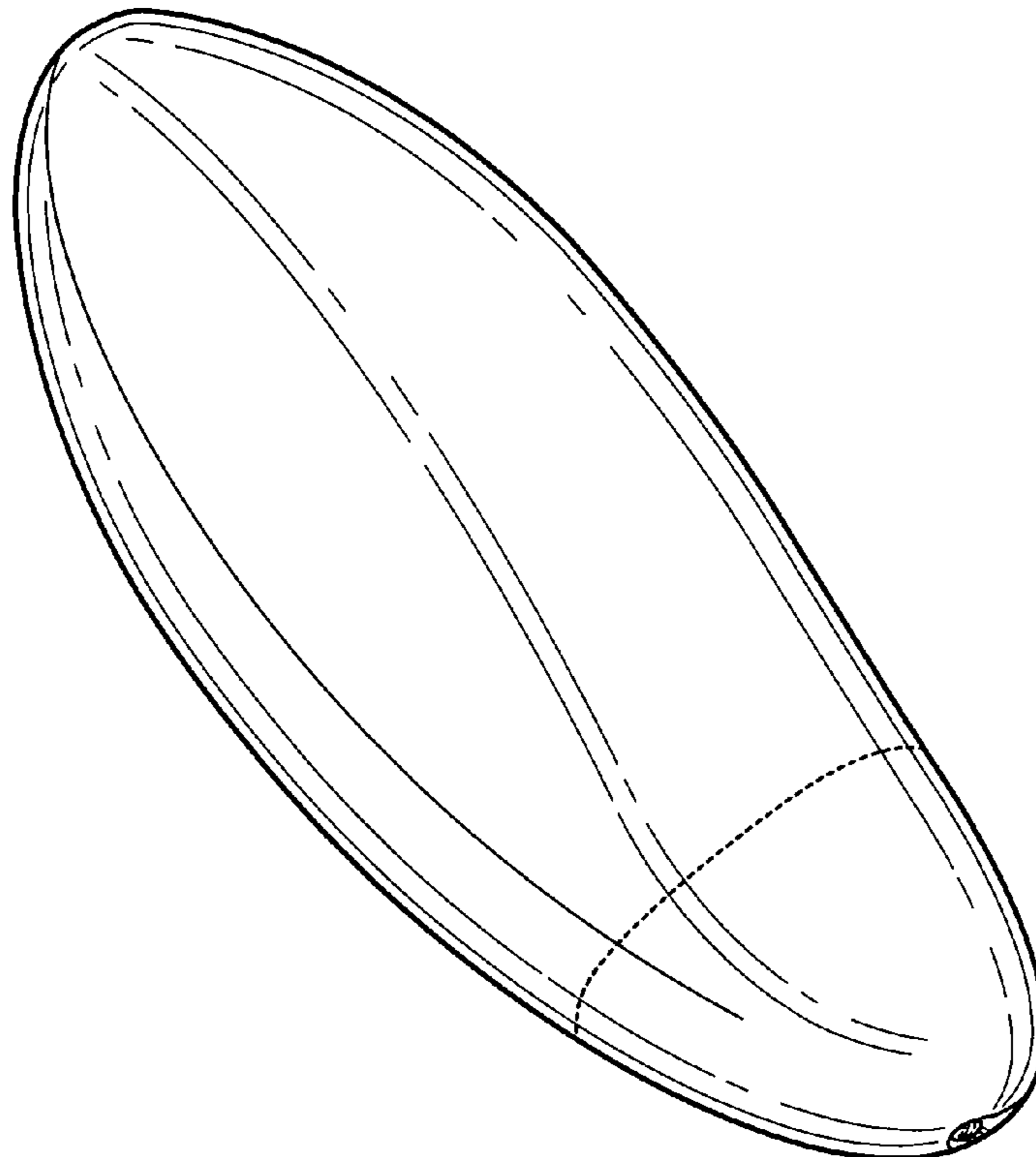
(57) **CLAIM**

I claim the ornamental design for a personal massager, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of a personal massager. FIG. 2 is a second perspective view of the personal massager. FIGS. 3 and 4 are right and left side views, respectively, of the personal massager. FIG. 5 is a top view of the personal massager. FIG. 6 is a bottom view of the personal massager. 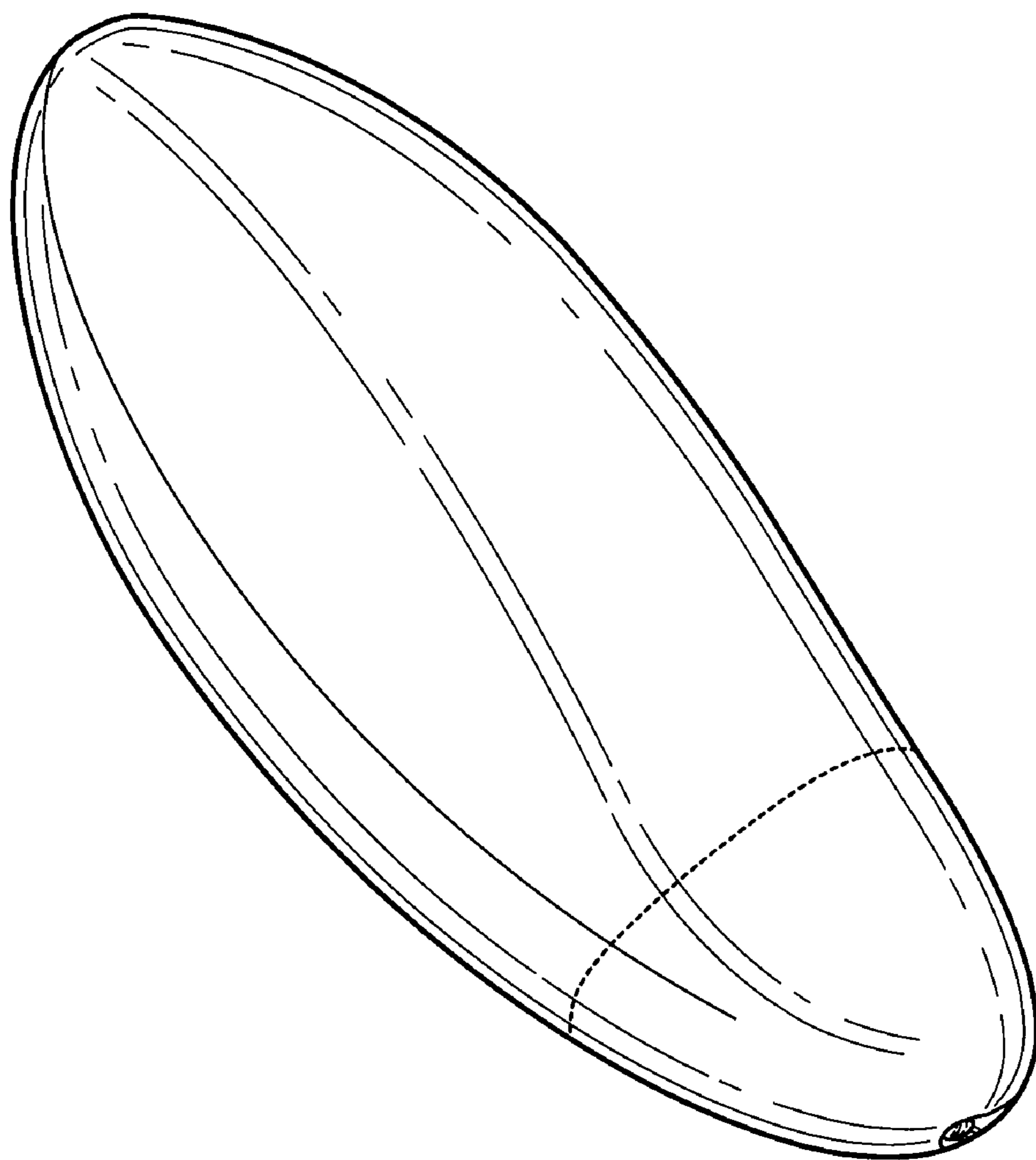

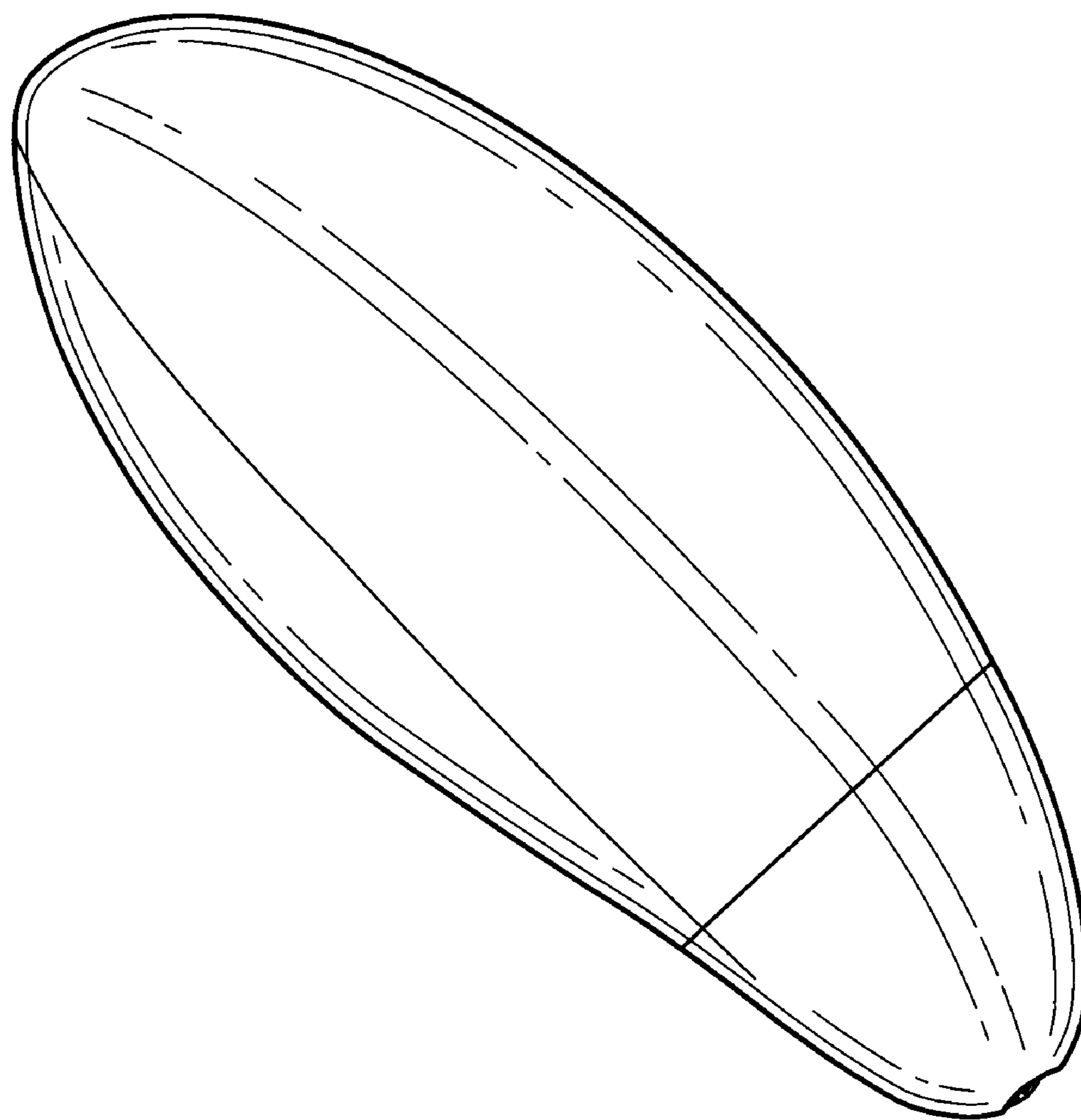

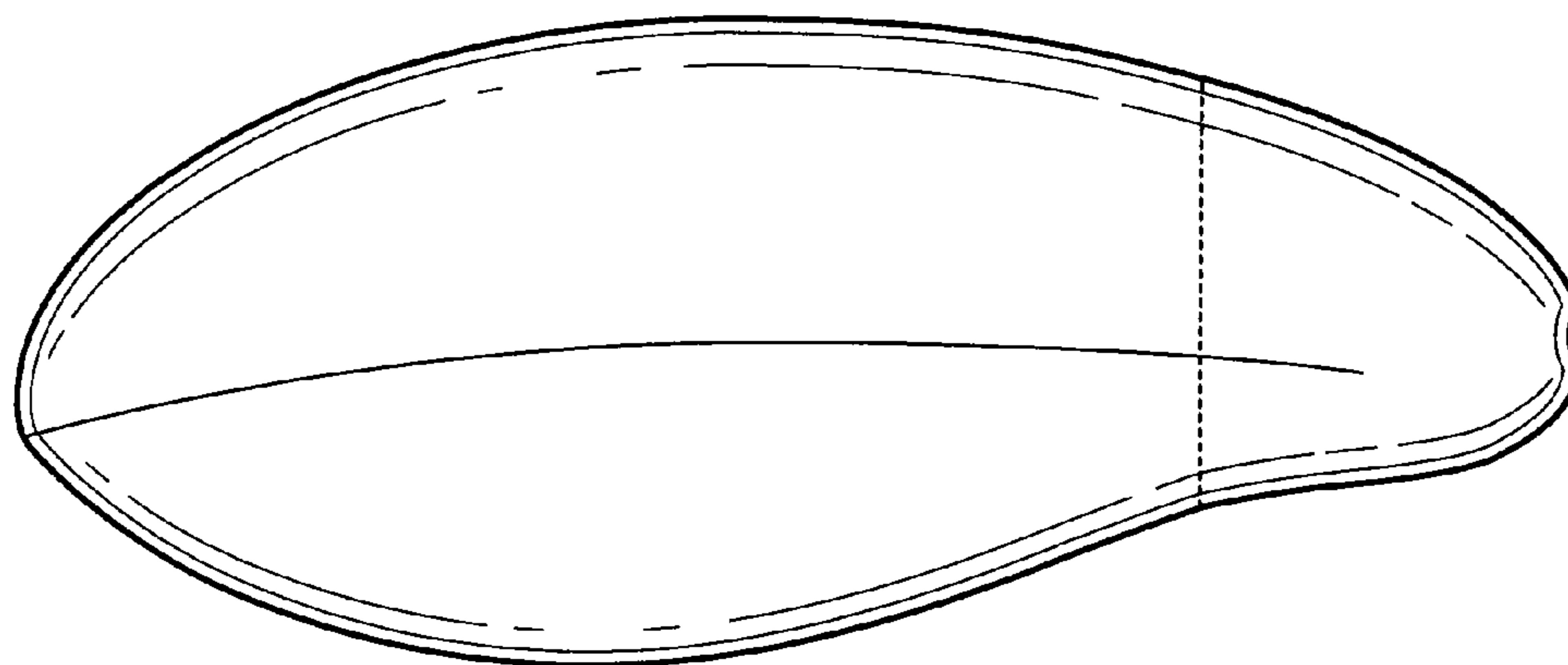

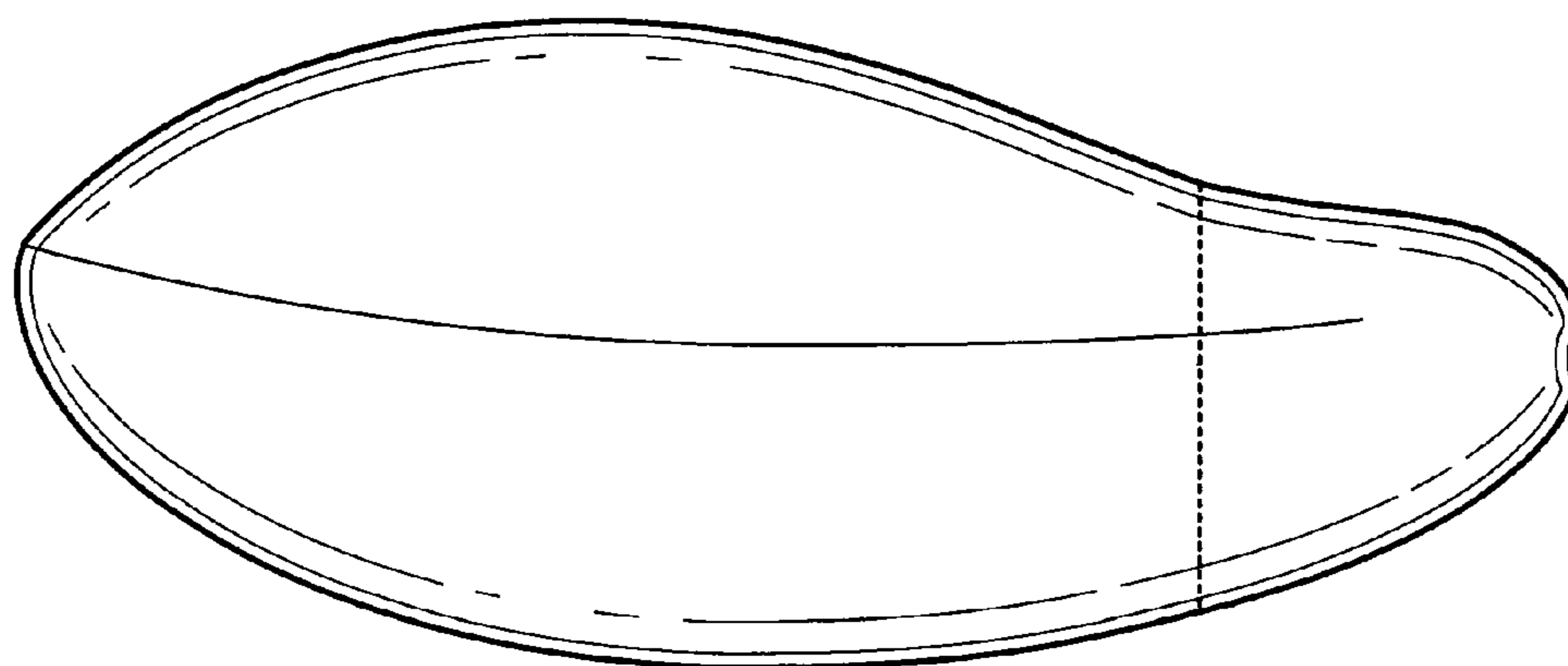

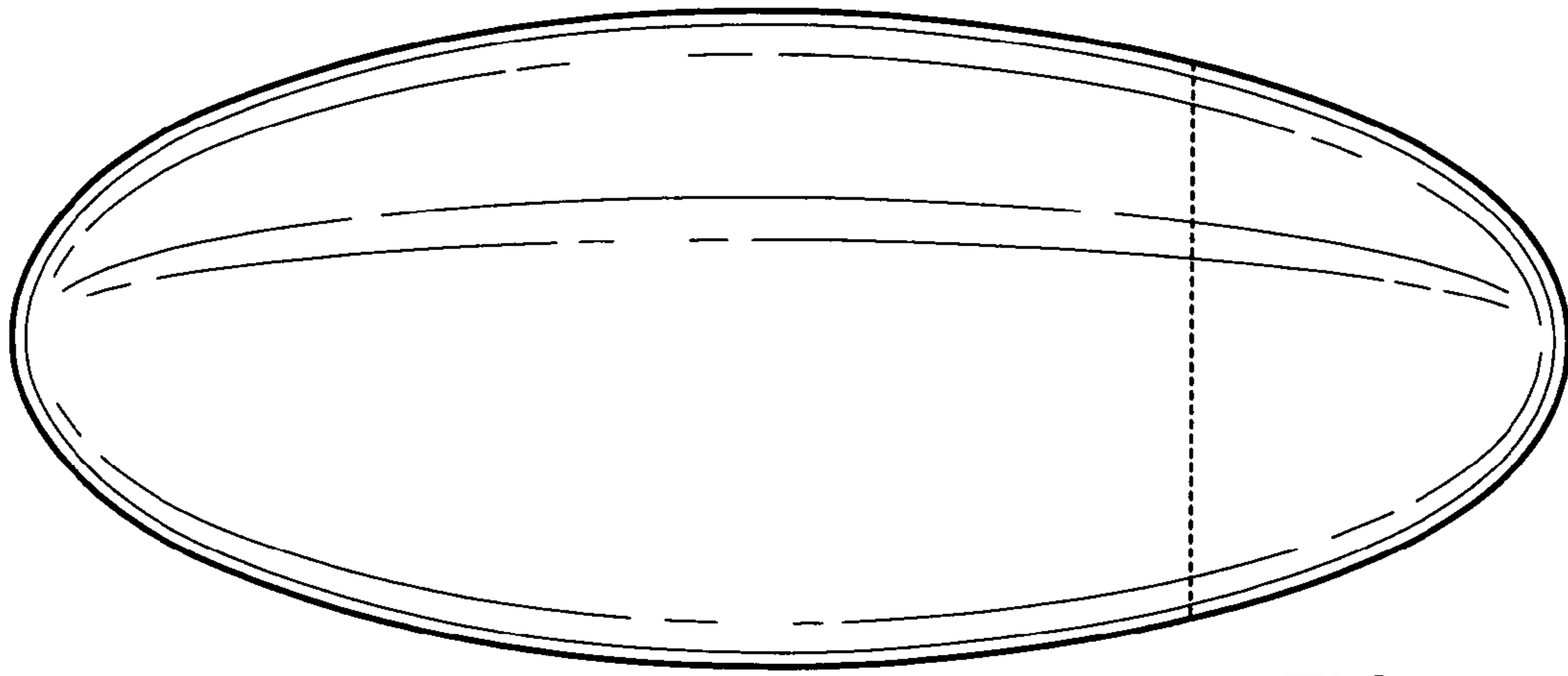

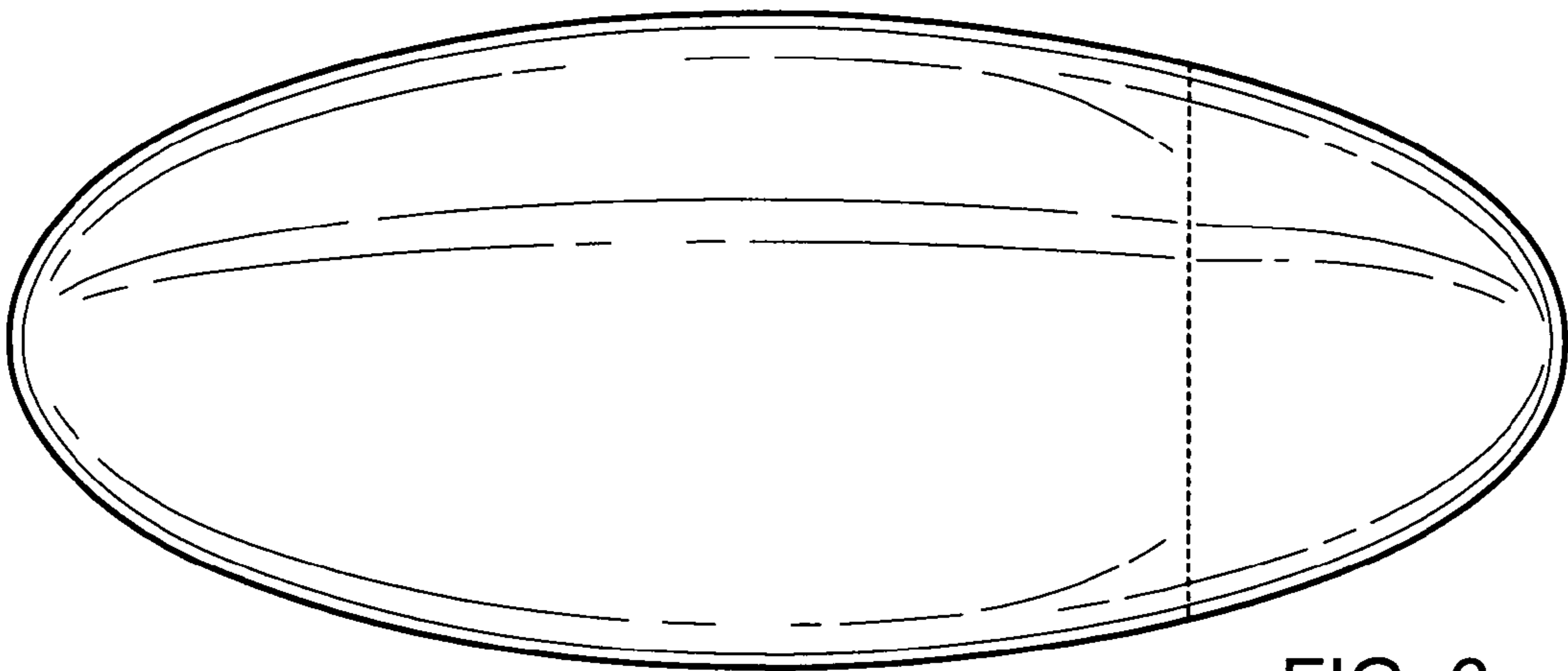

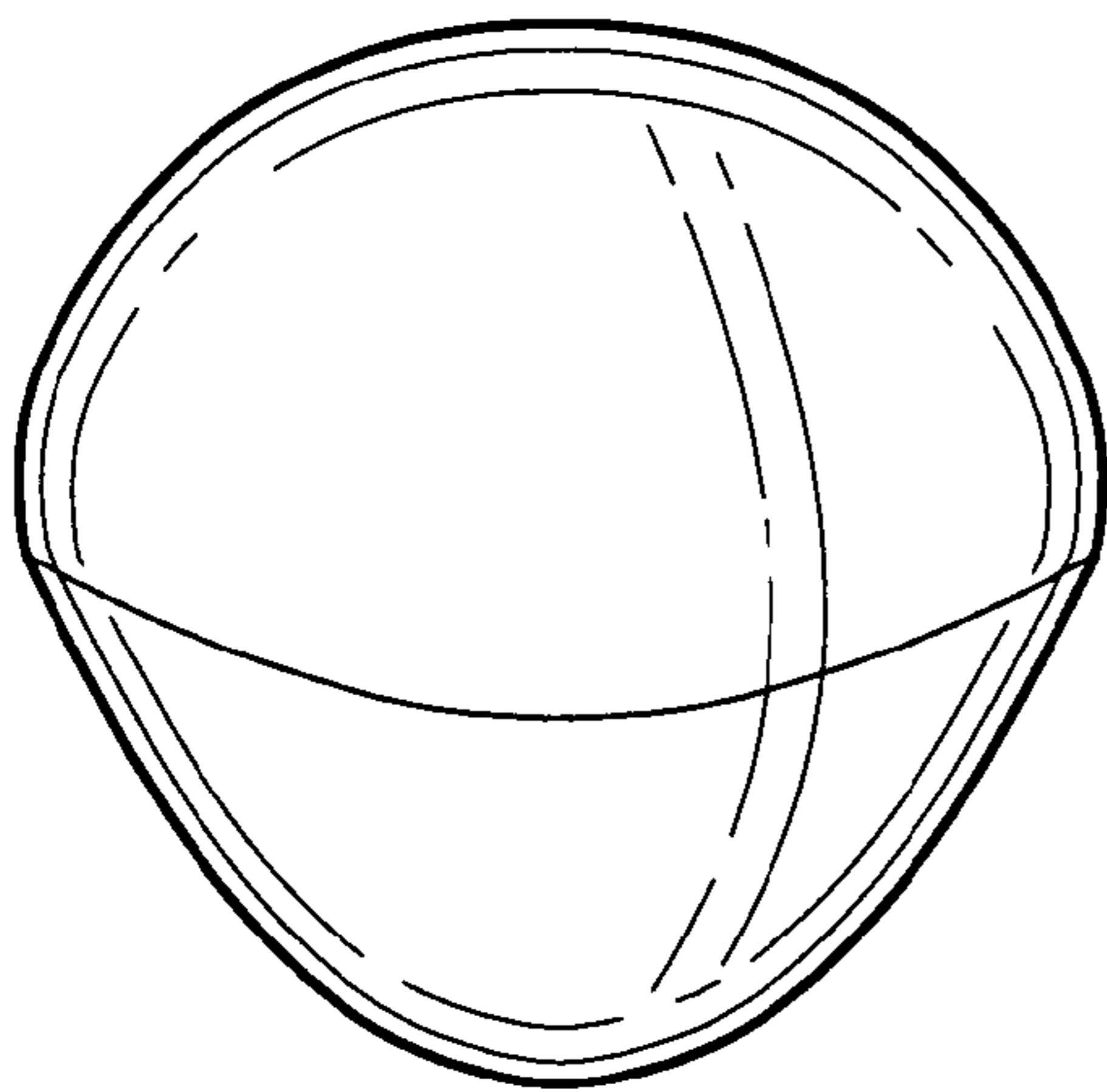

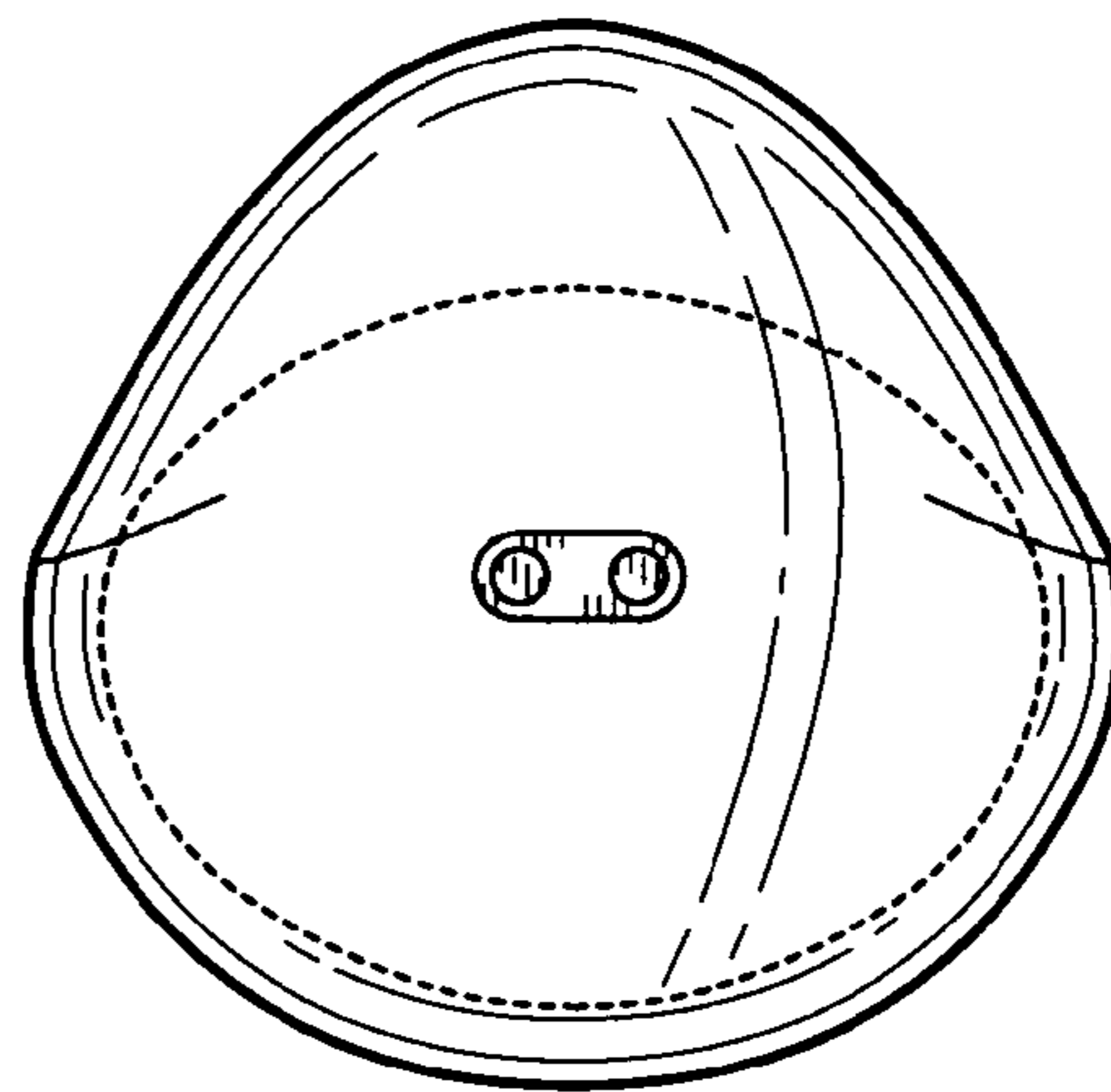
