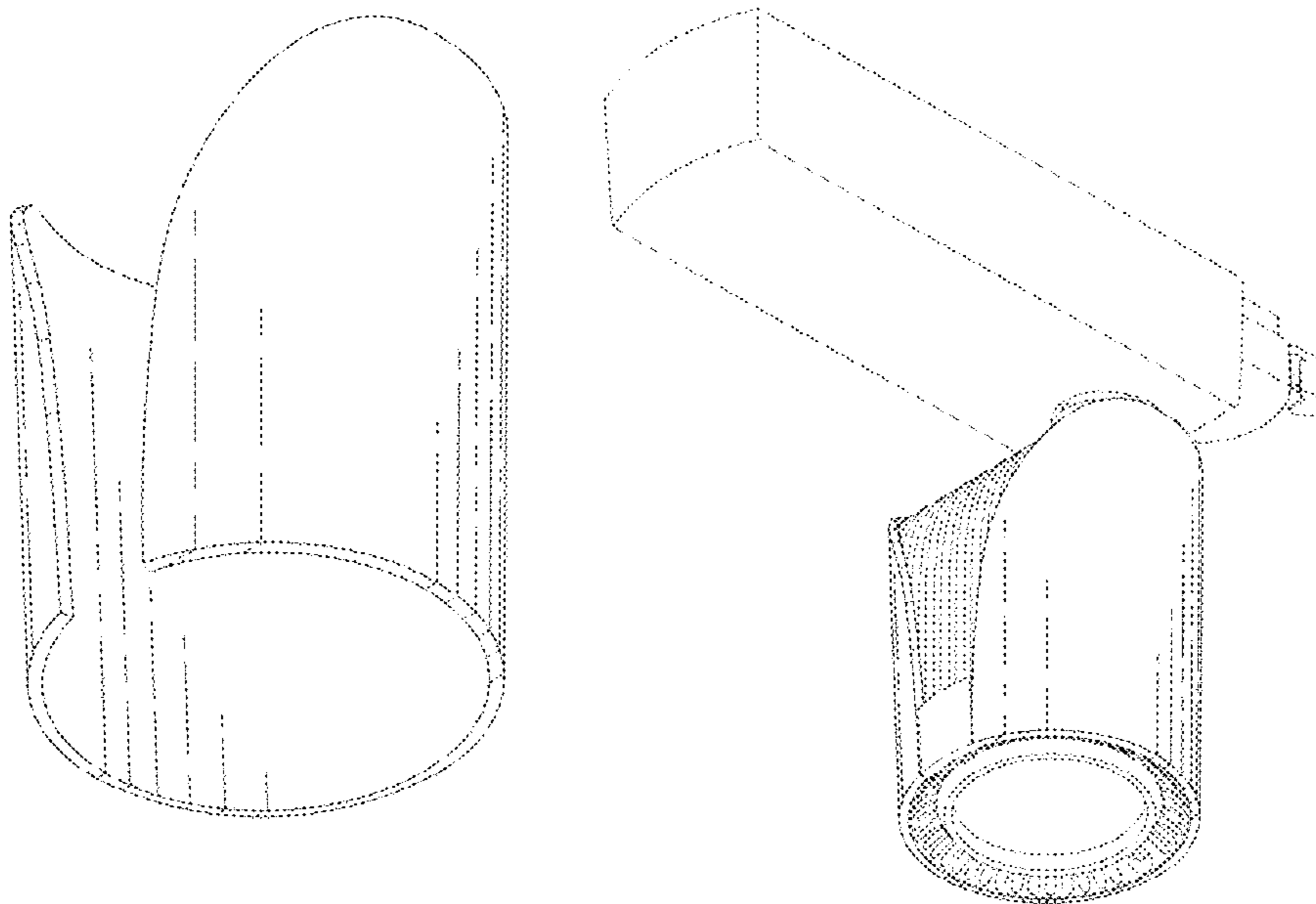
(57) **CLAIM**

The ornamental design for a lamp housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lamp housing, showing my new design;  
FIG. 2 is a front view of the lamp housing of FIG. 1;  
FIG. 3 is a rear view of the lamp housing of FIG. 1;  
FIG. 4 is a left-side view of the lamp housing of FIG. 1;

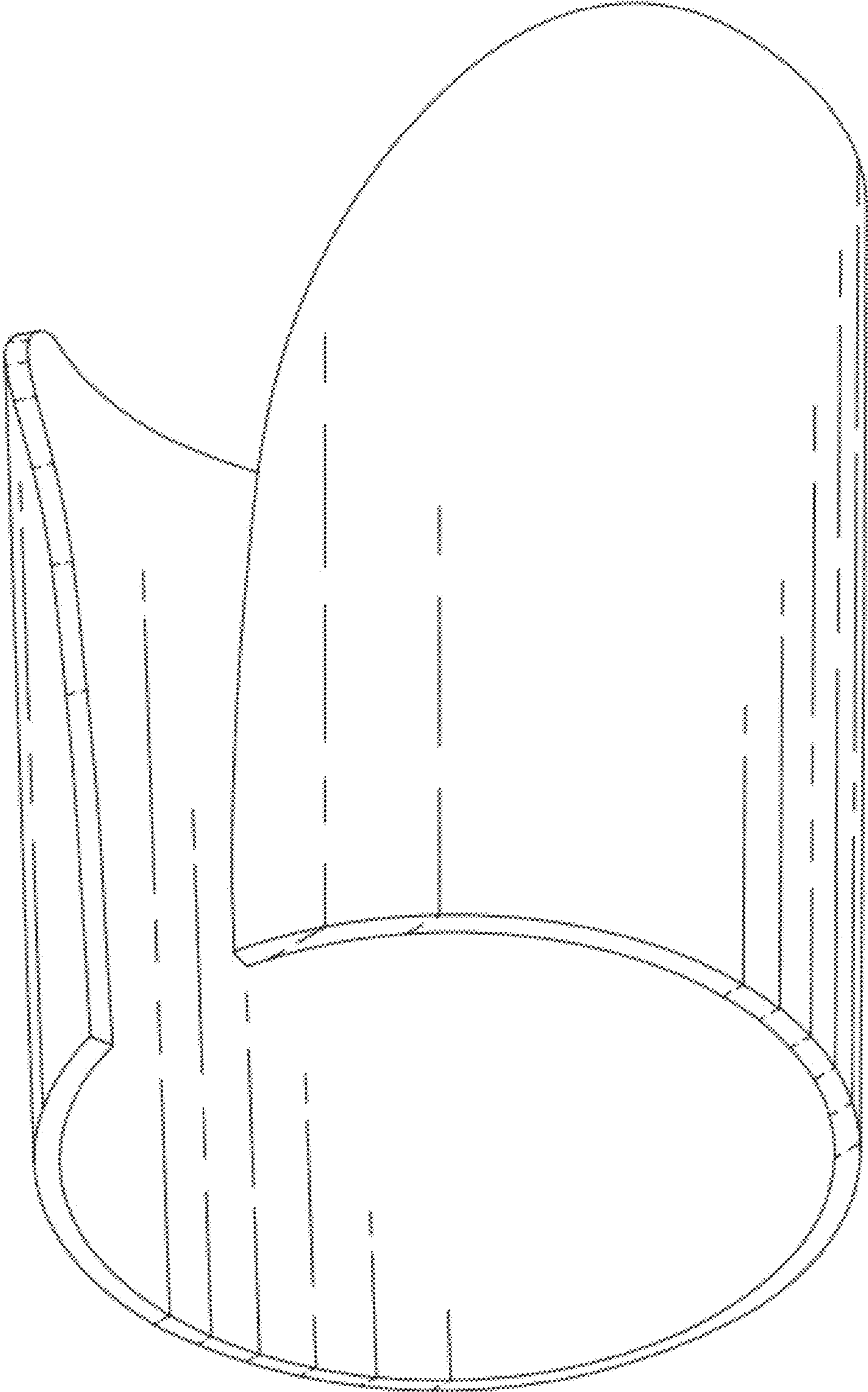

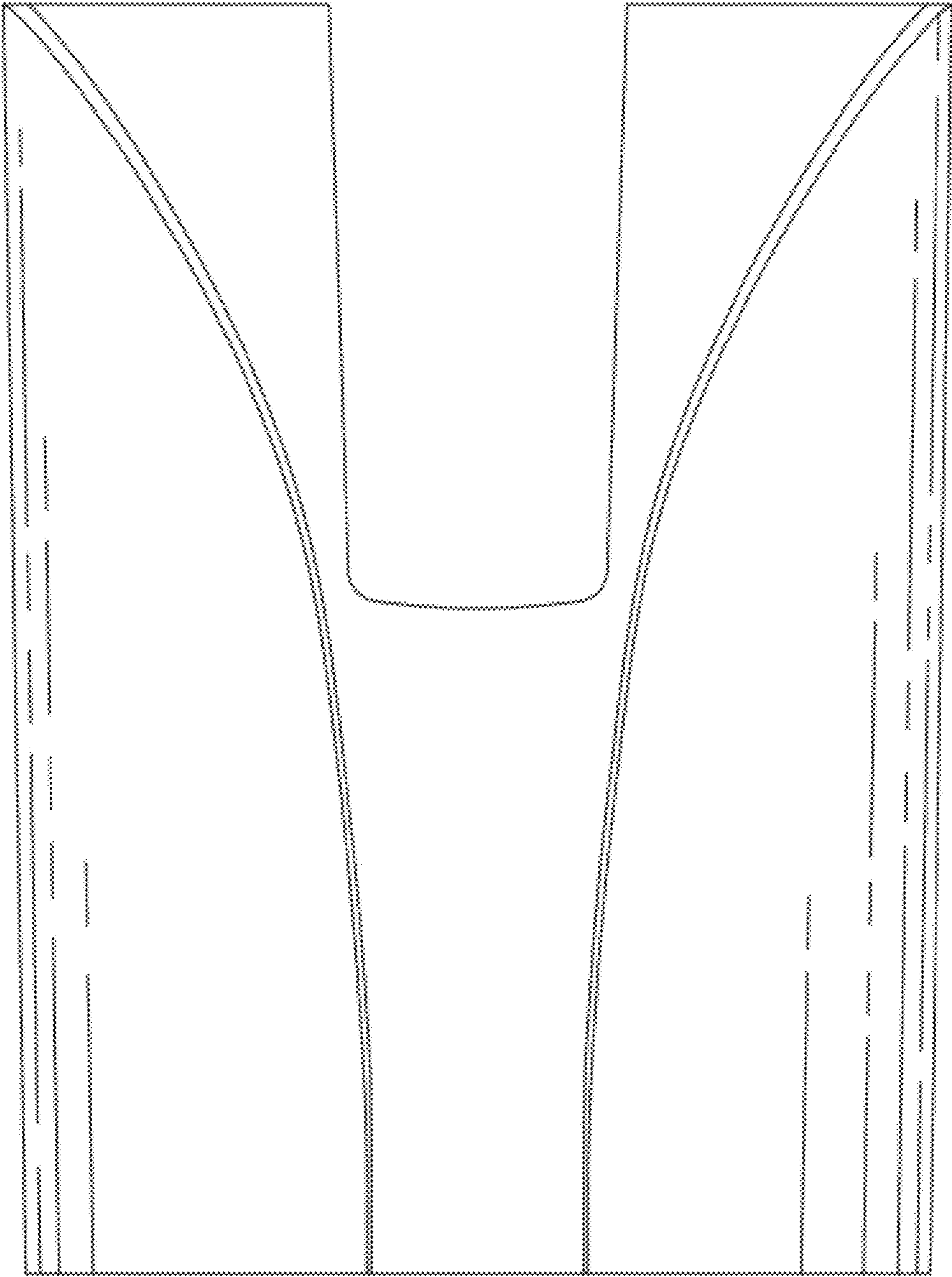

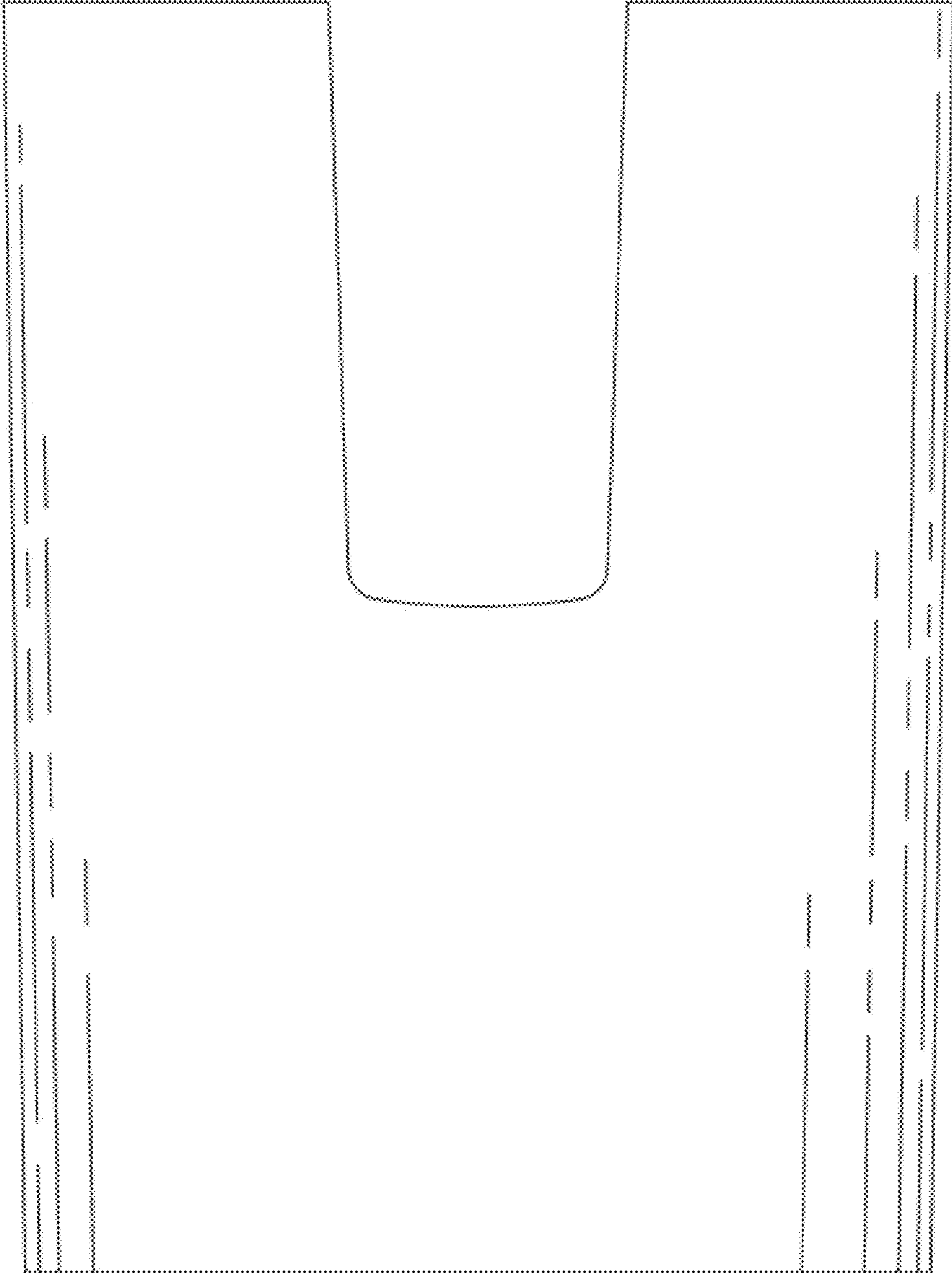

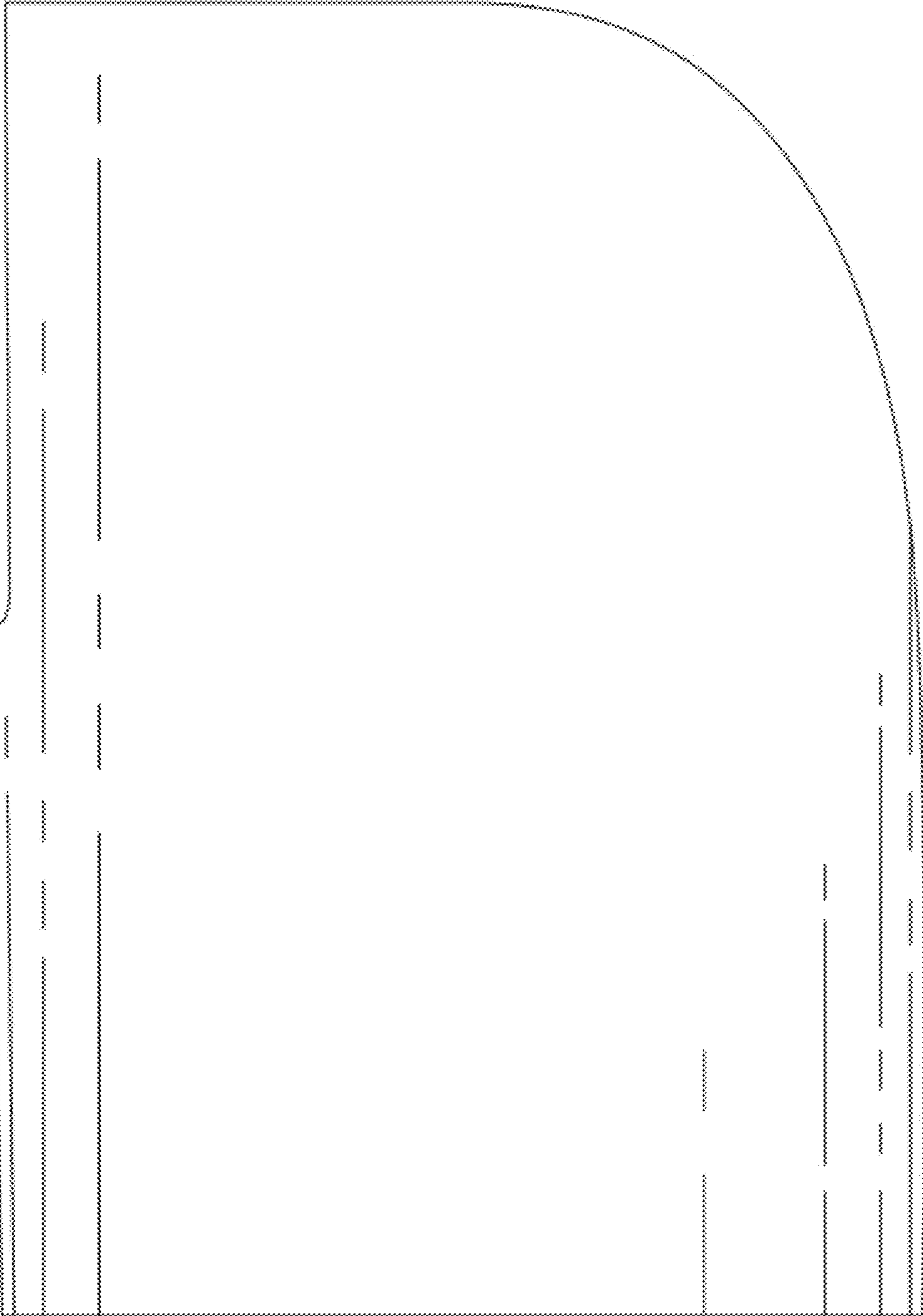

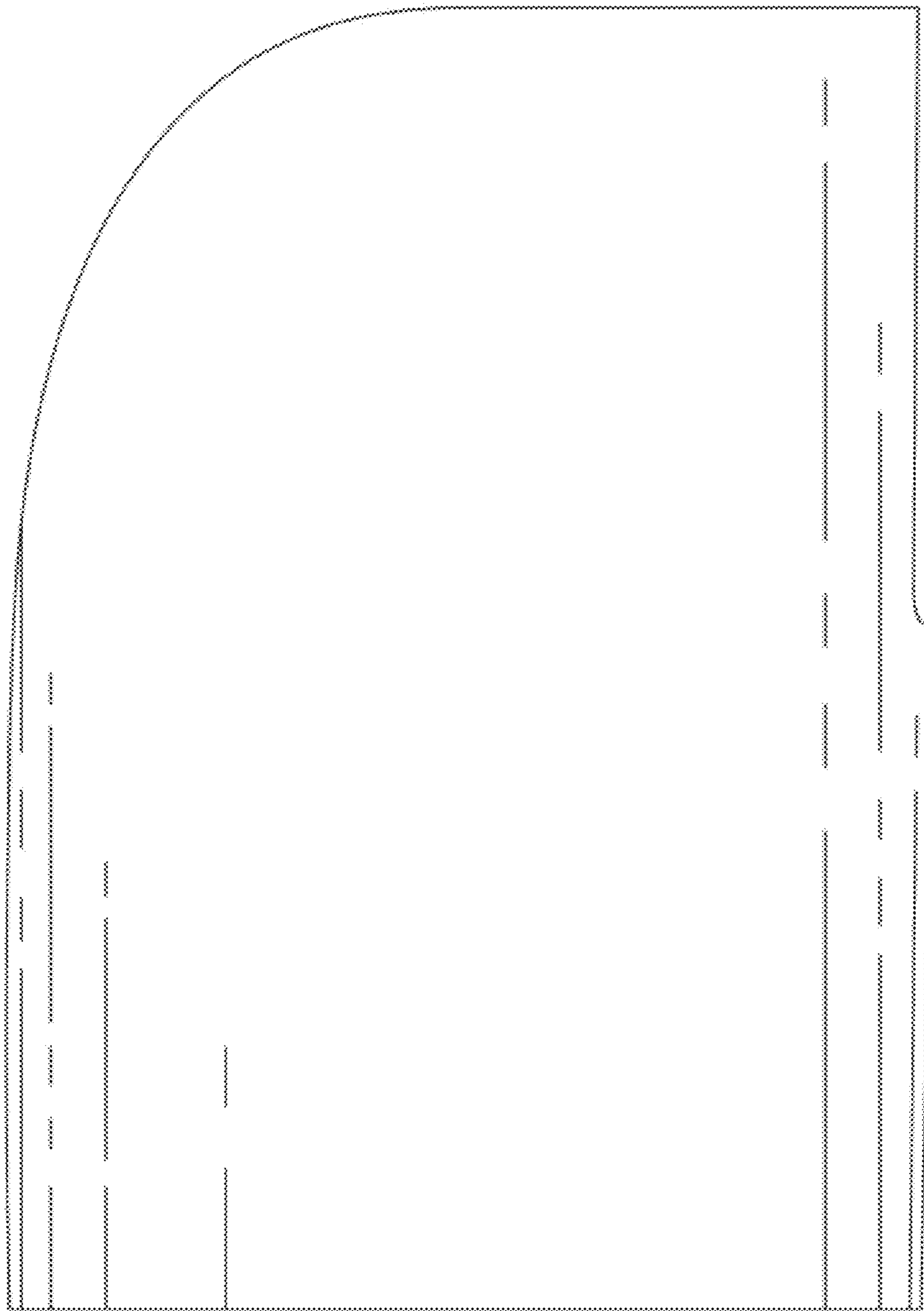

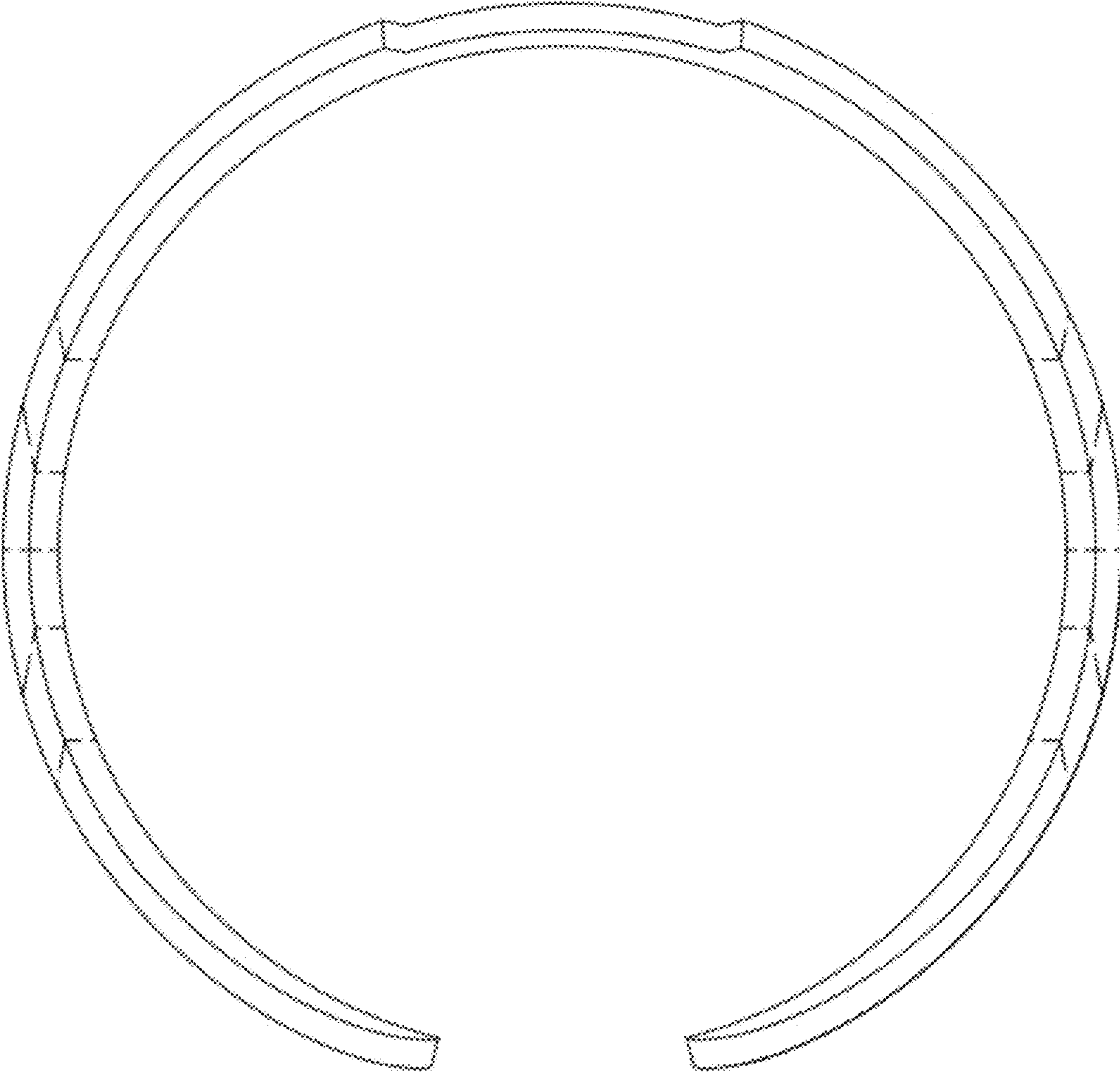

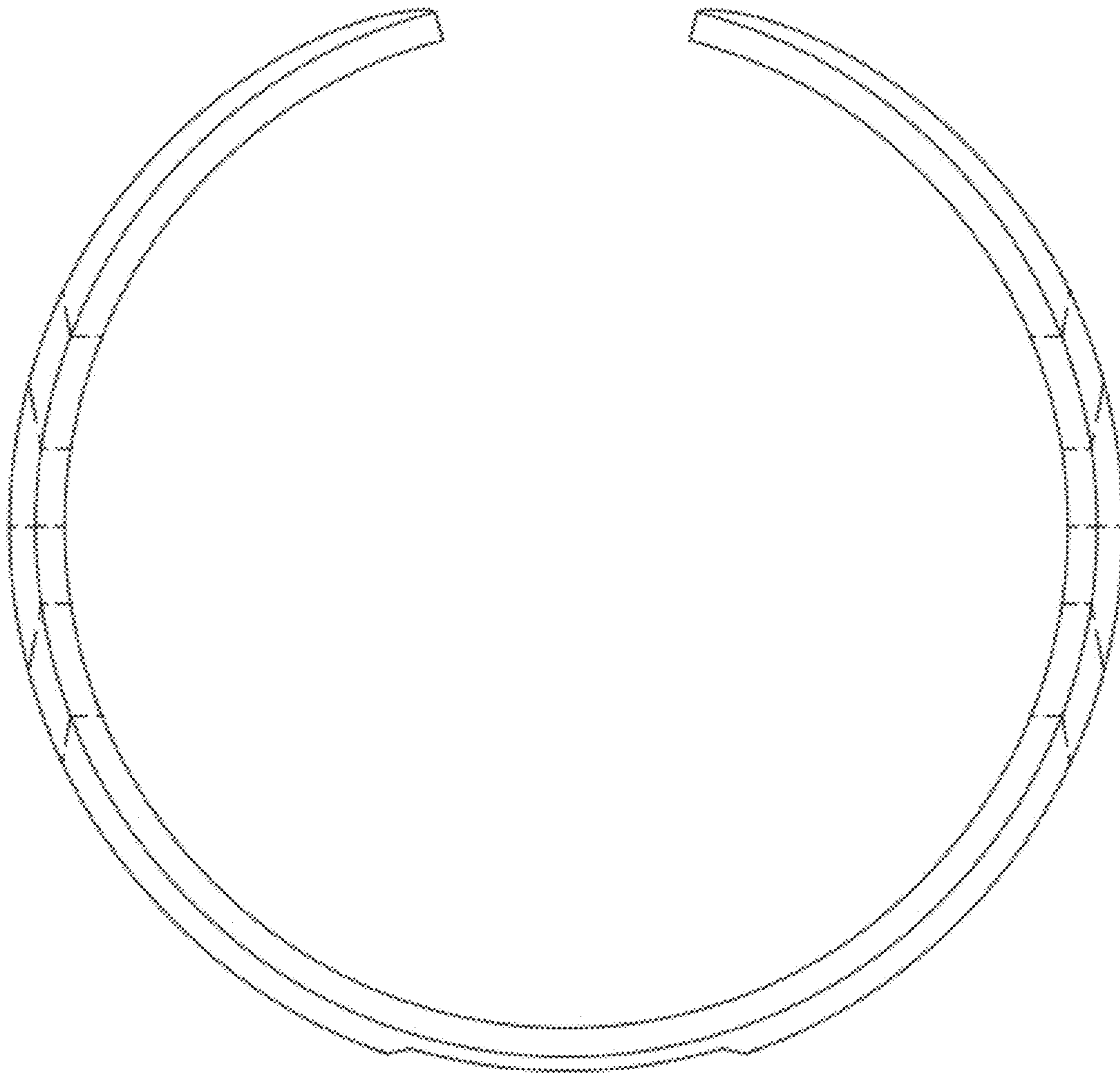
