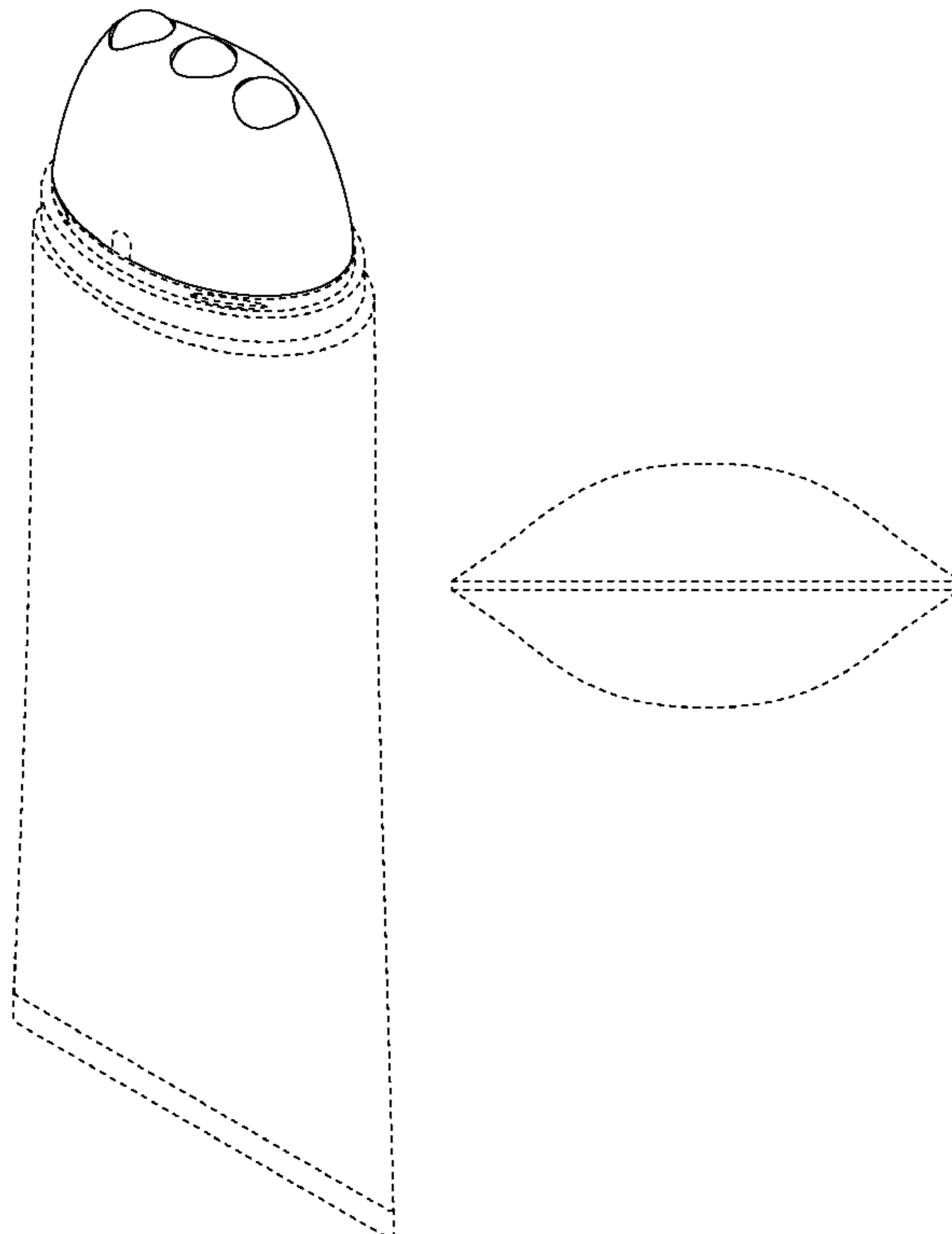
(57) **CLAIM**

The ornamental design for an applicator for cosmetics, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front perspective view of an applicator for cosmetics showing my new design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a right side view thereof;  
 FIG. 4 is a rear view thereof;  
 FIG. 5 is a left side view thereof;  
 FIG. 6 is a top view thereof;  
 FIG. 7 is a bottom view thereof;  
 FIG. 8 is a rear view of the applicator for cosmetics in which an upper portion of the applicator for cosmetics has been rotated 90 degrees; and,  
 FIG. 9 is a top perspective view thereof.

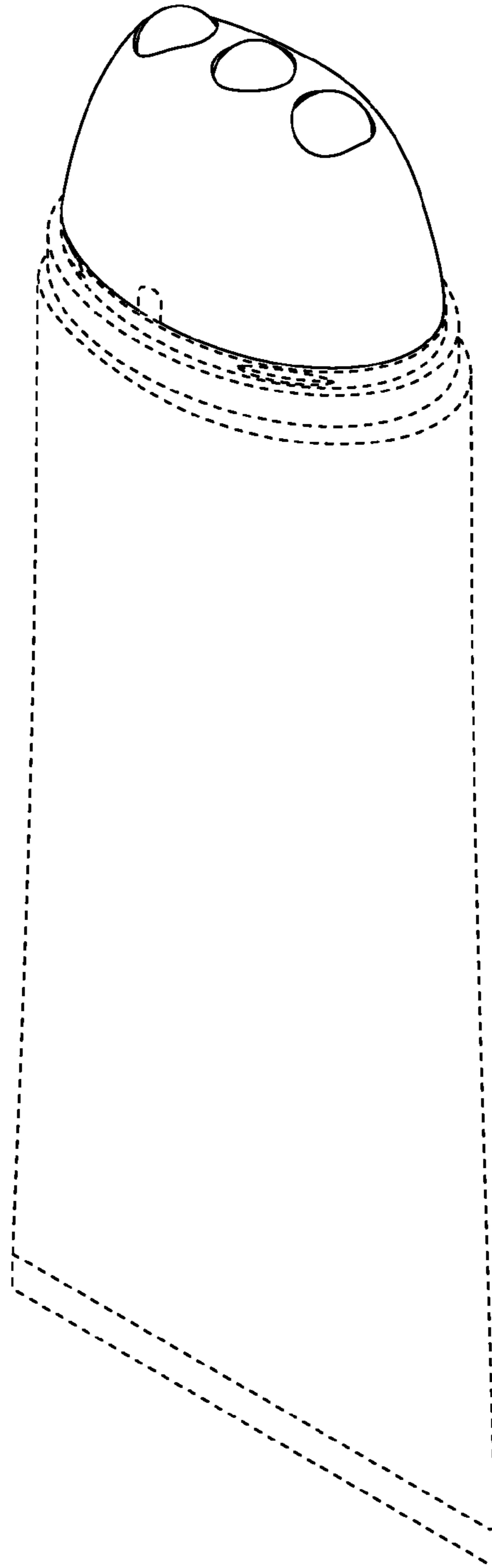

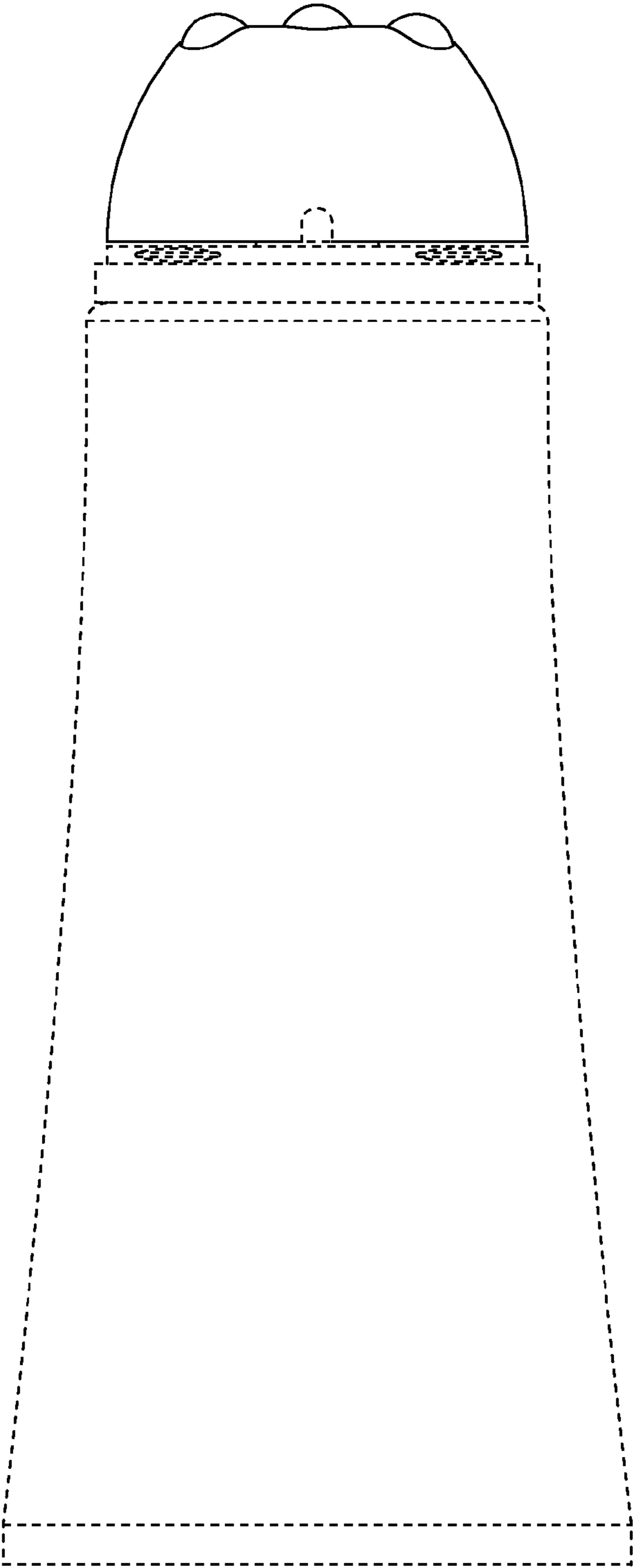

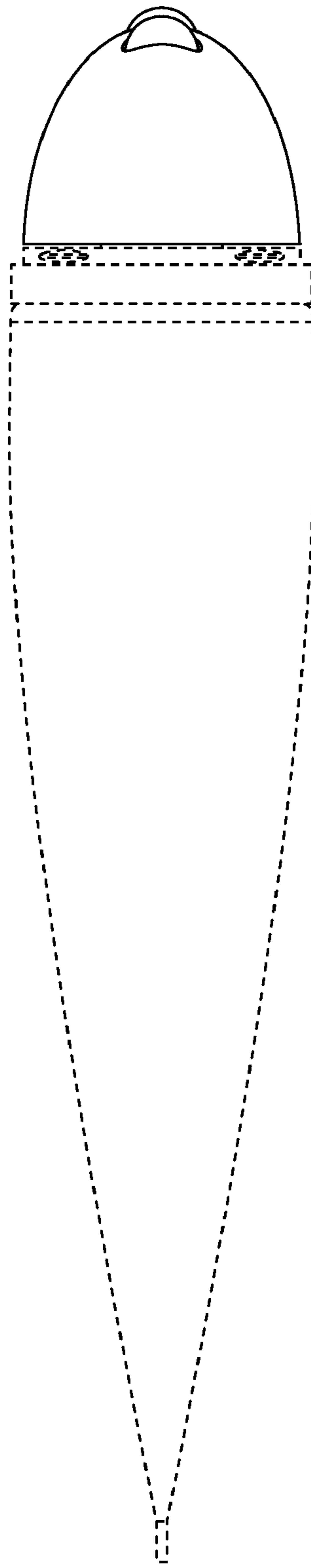

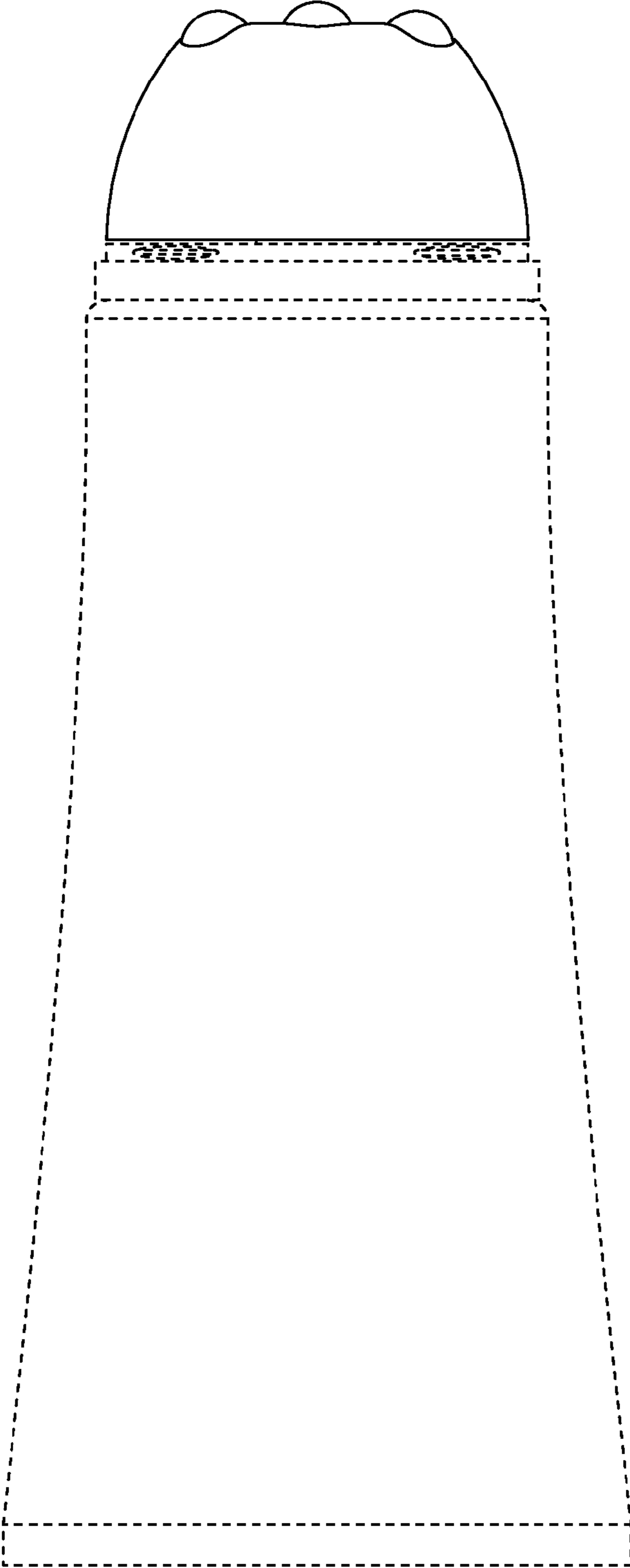

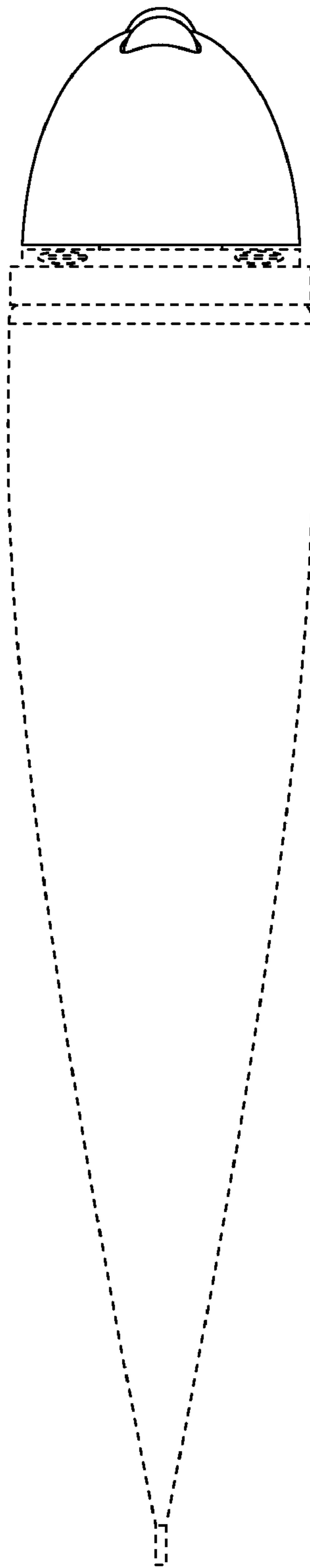

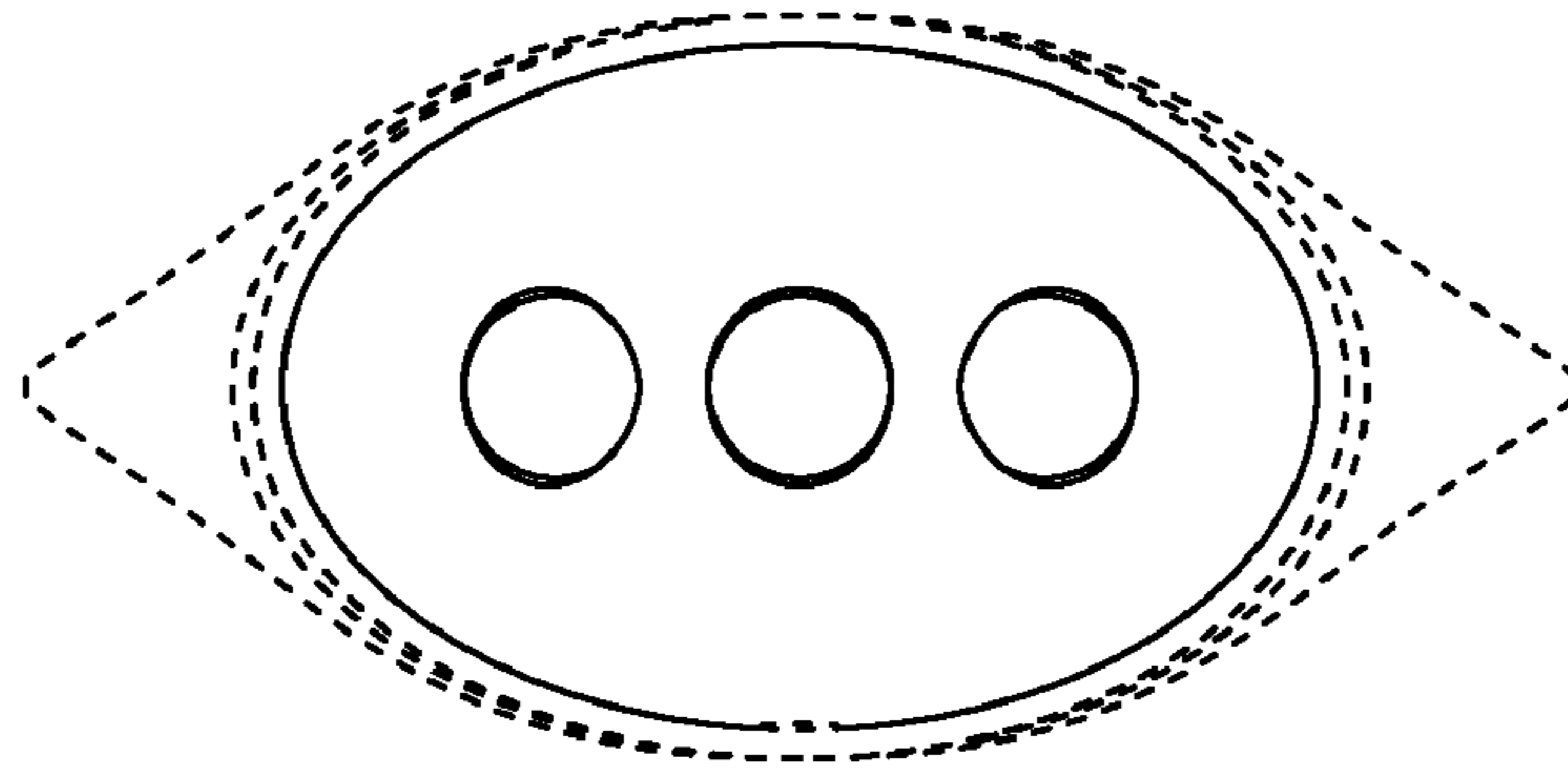

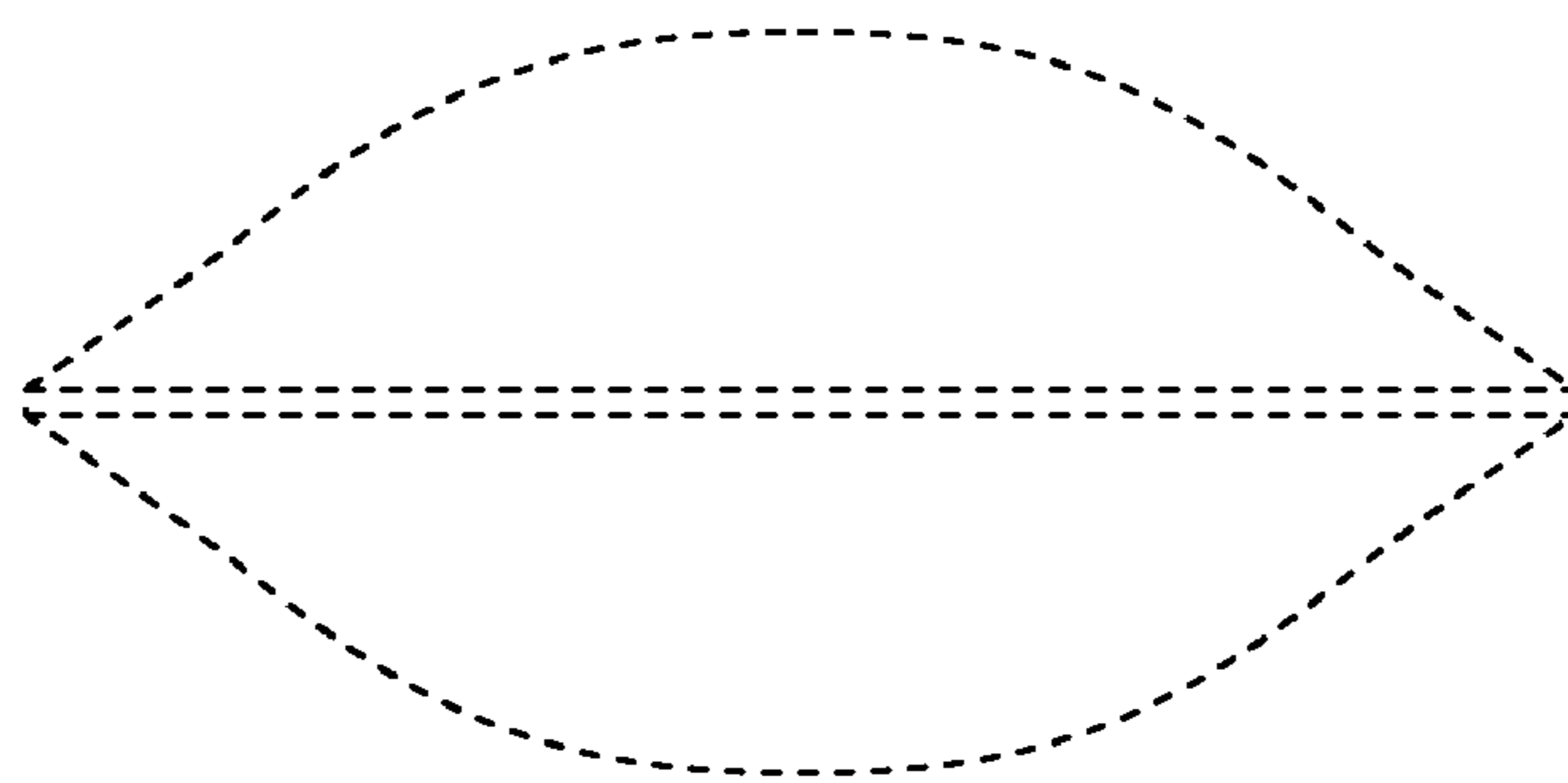

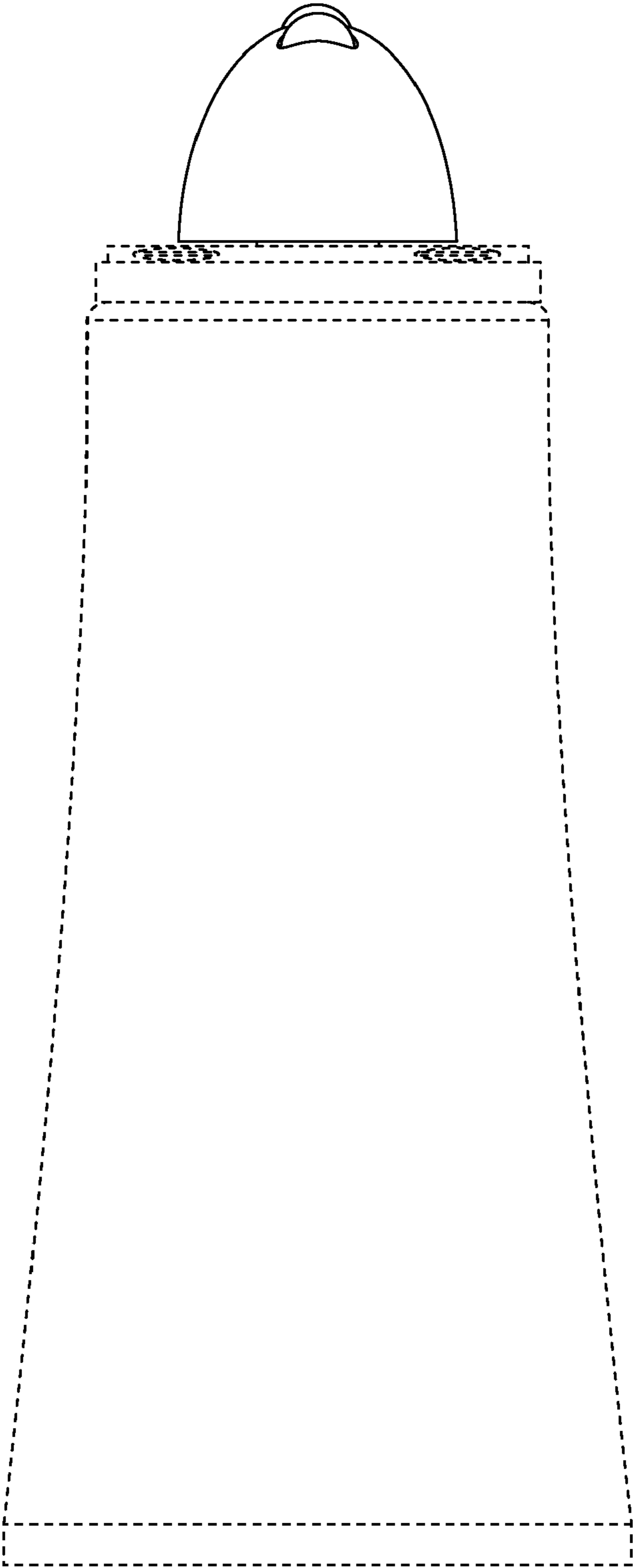

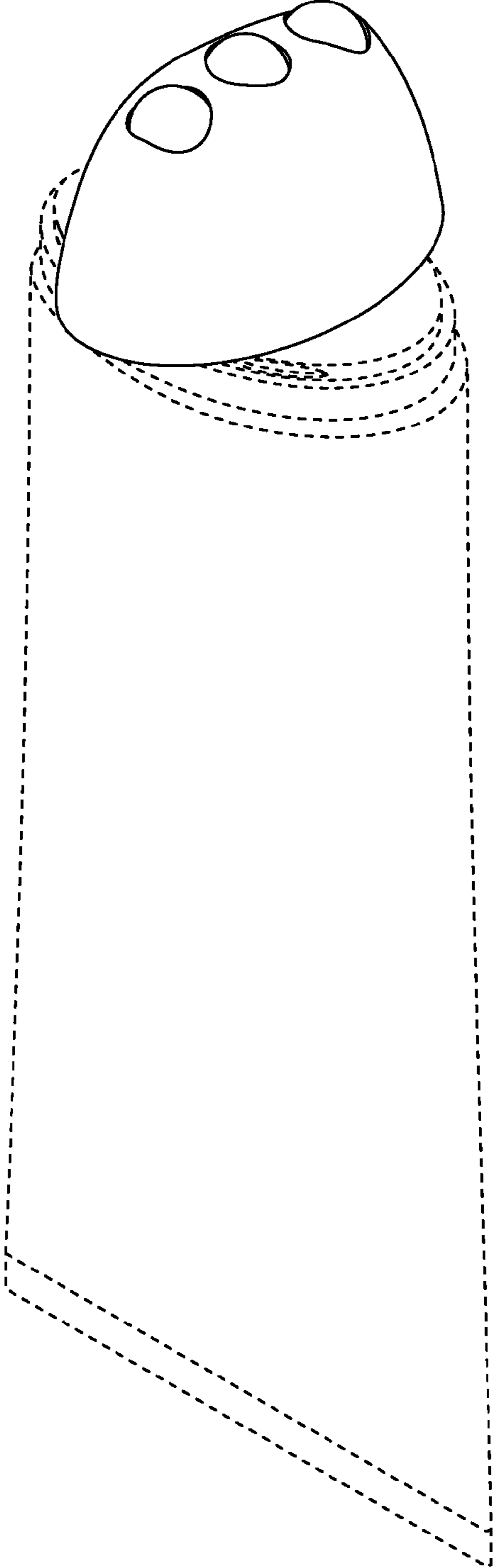
