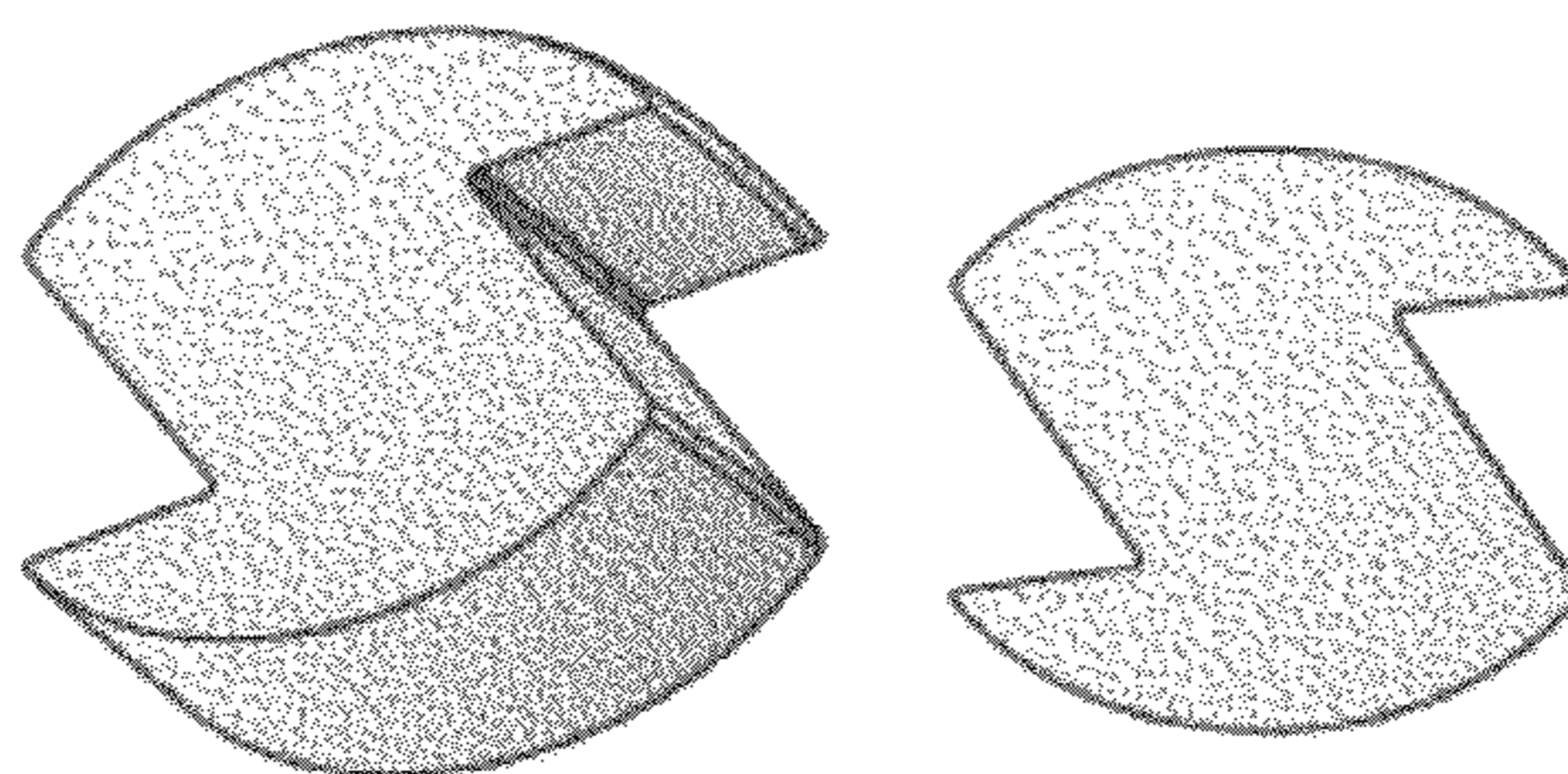
FIG. 1 is a perspective view of a edible product for companion animal embodying our new design;

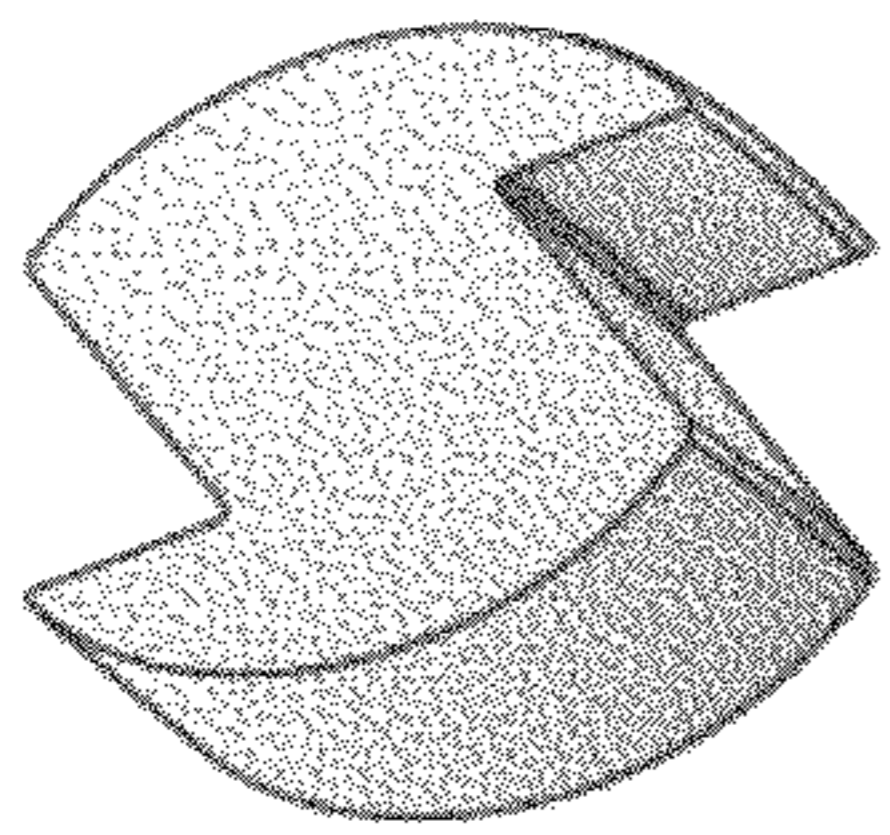

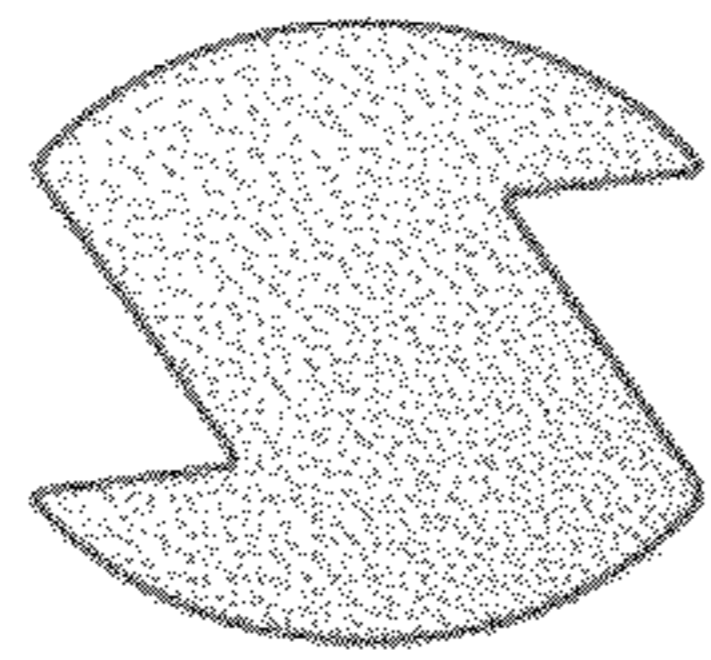

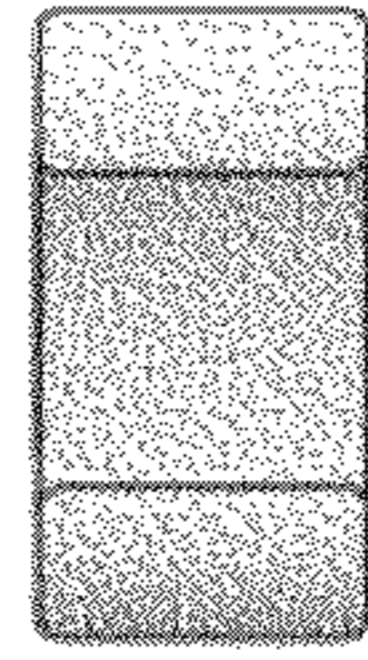

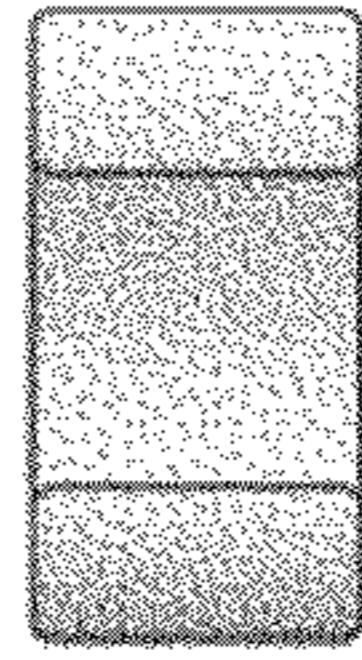

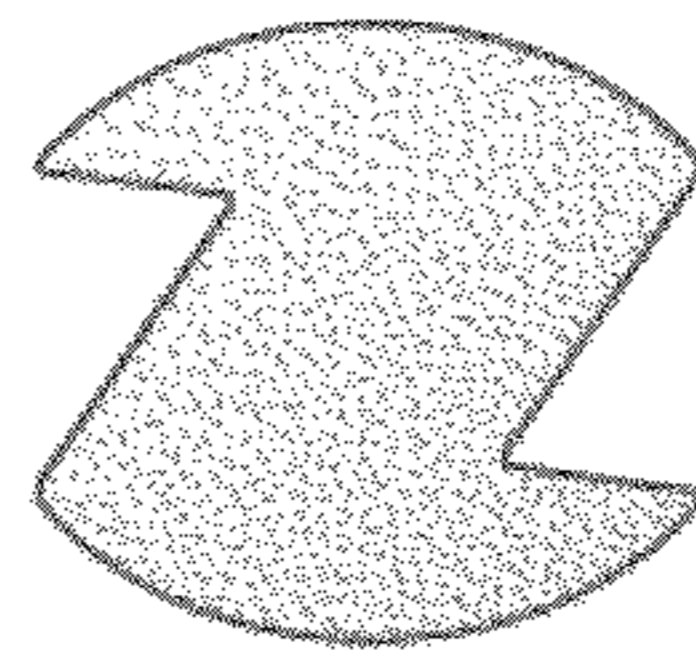

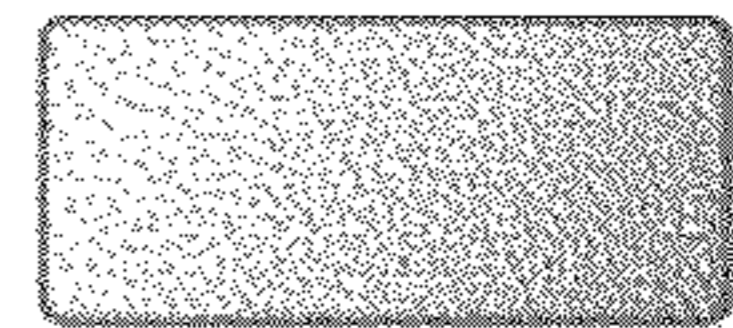

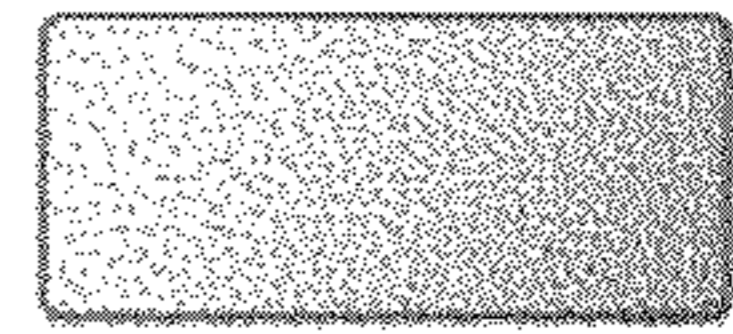

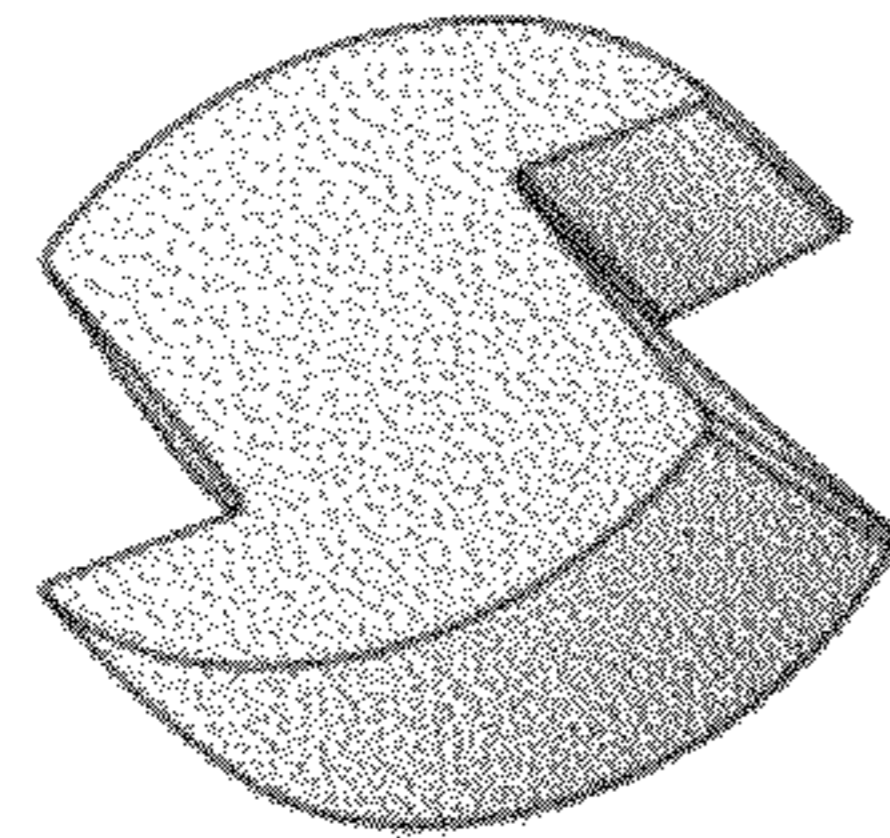

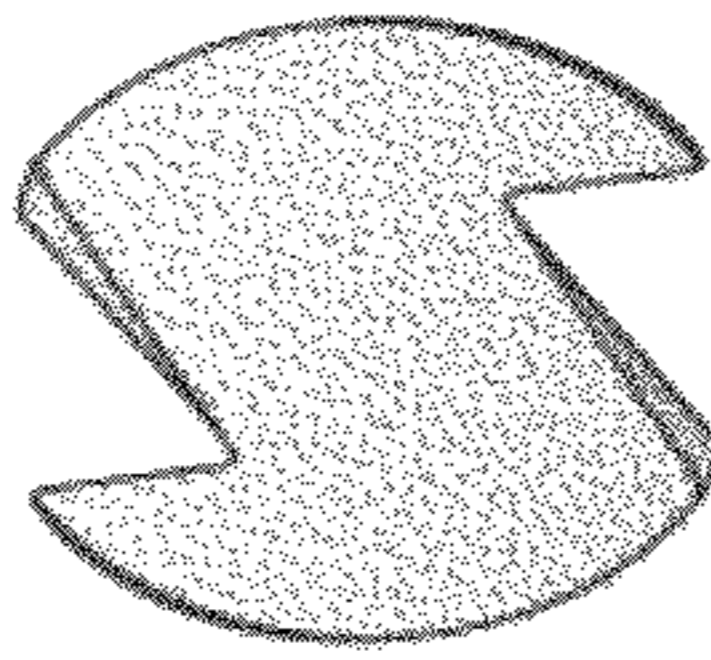

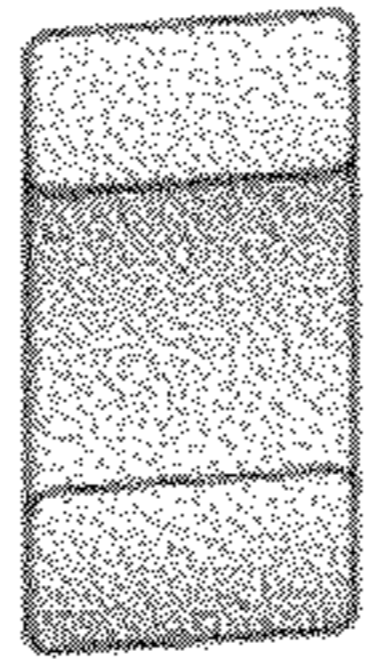

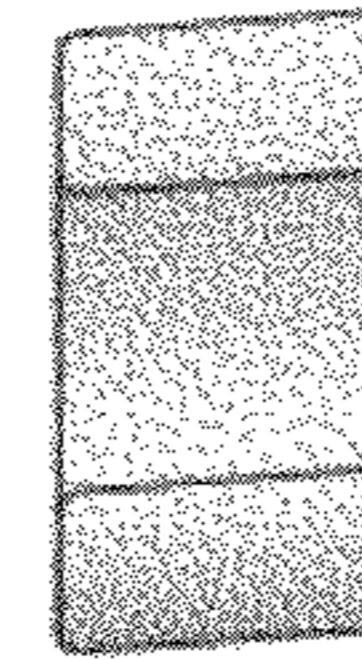

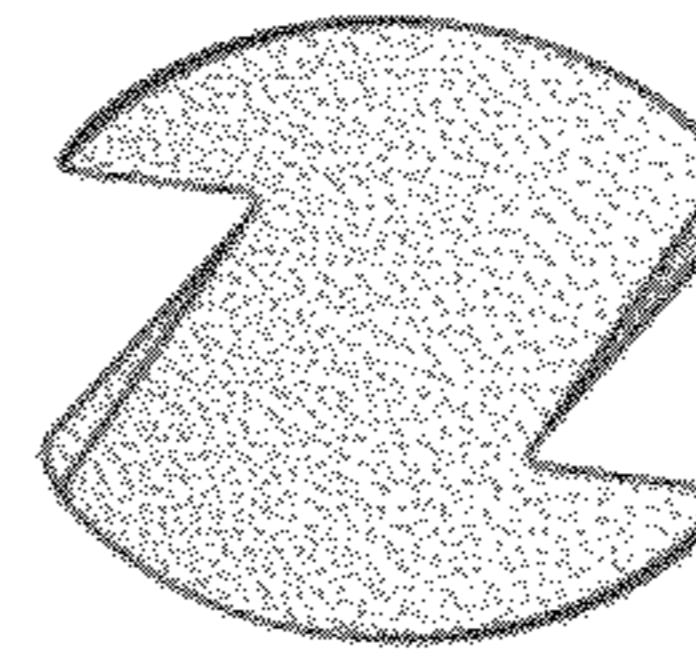

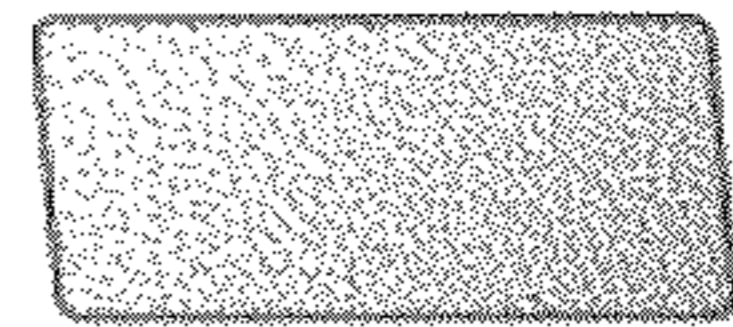

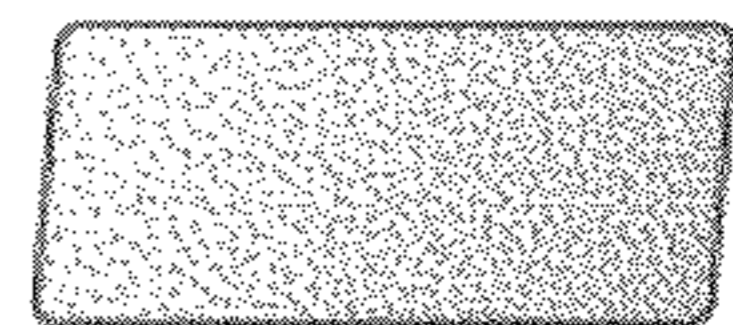

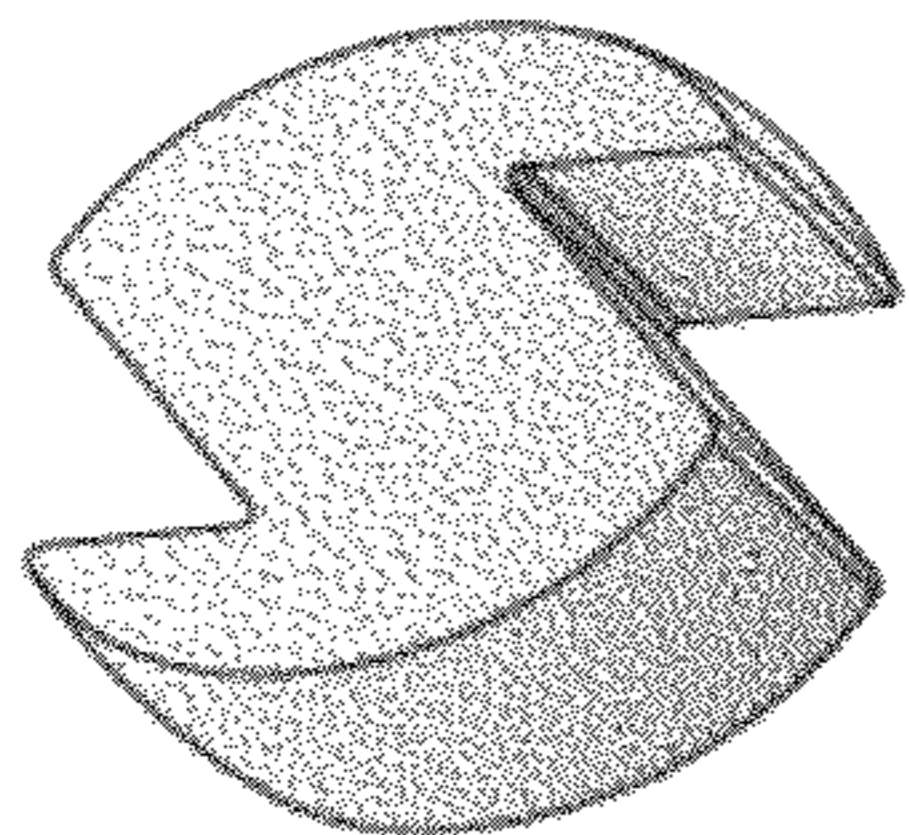

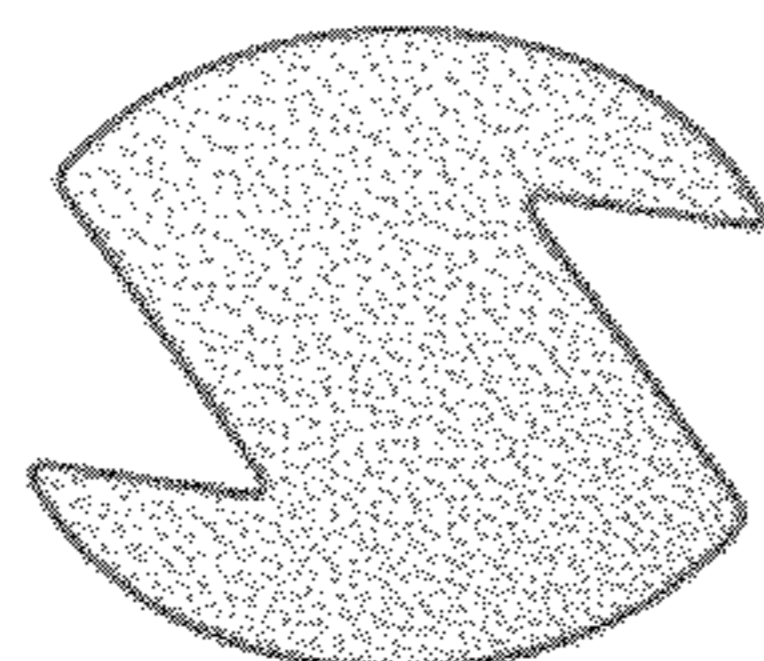

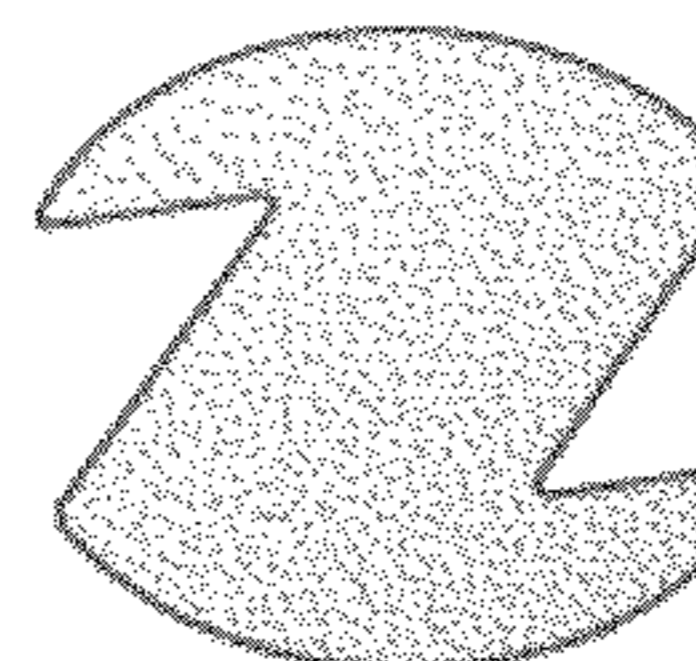

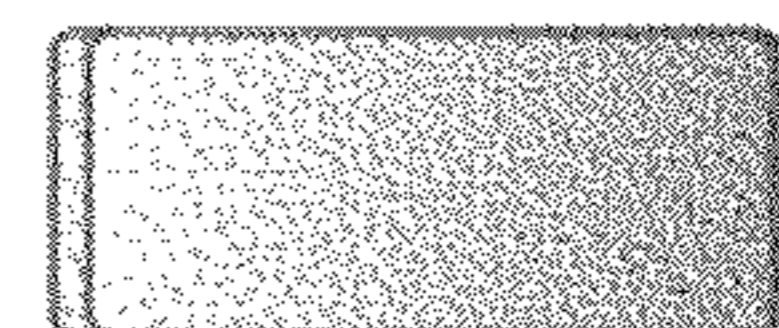

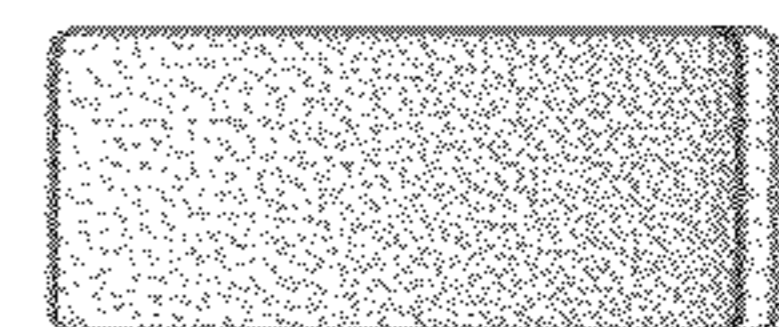
