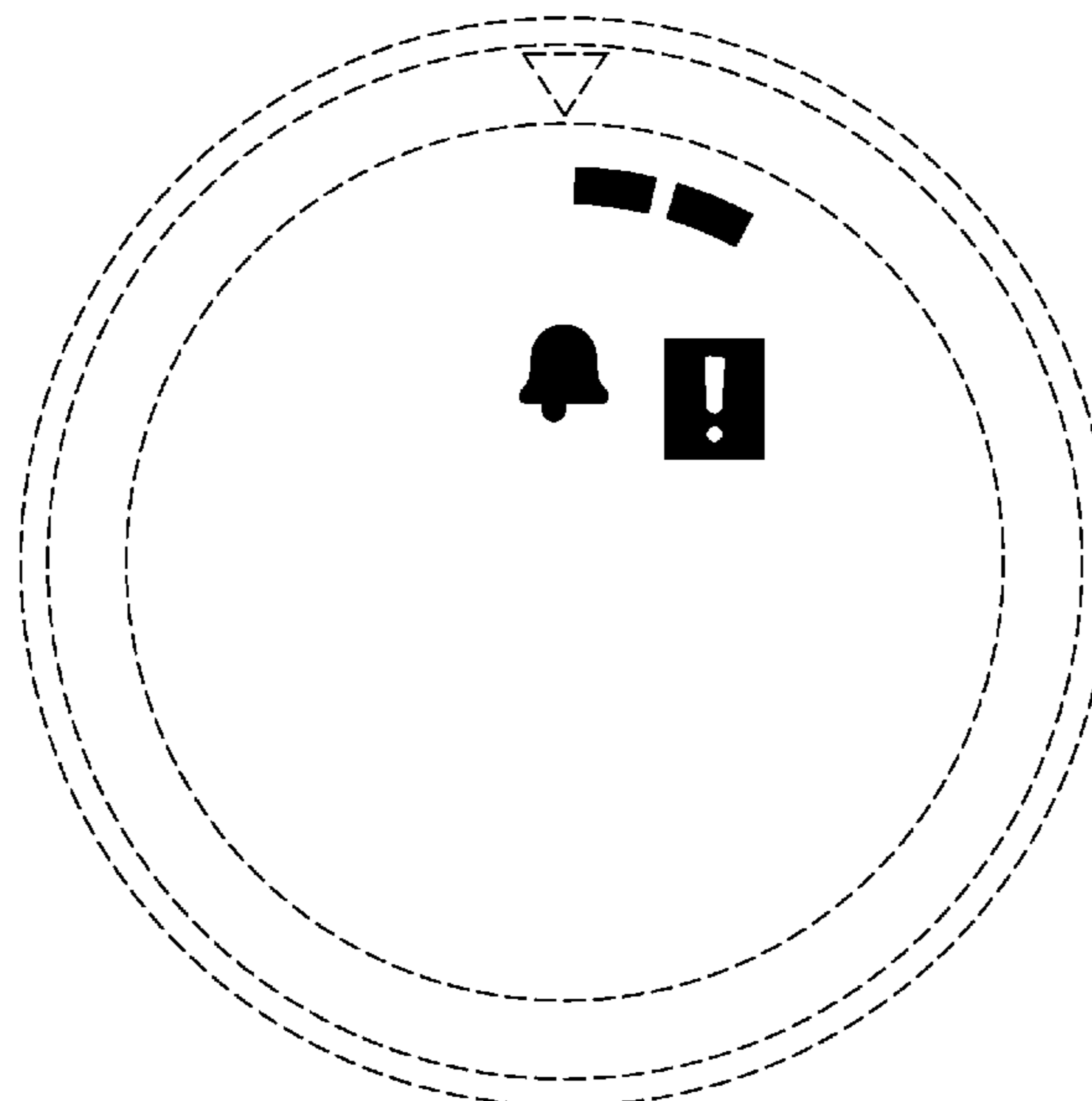
The ornamental design for a display screen for a pill dispenser, as shown and described.
