(57) **CLAIM**

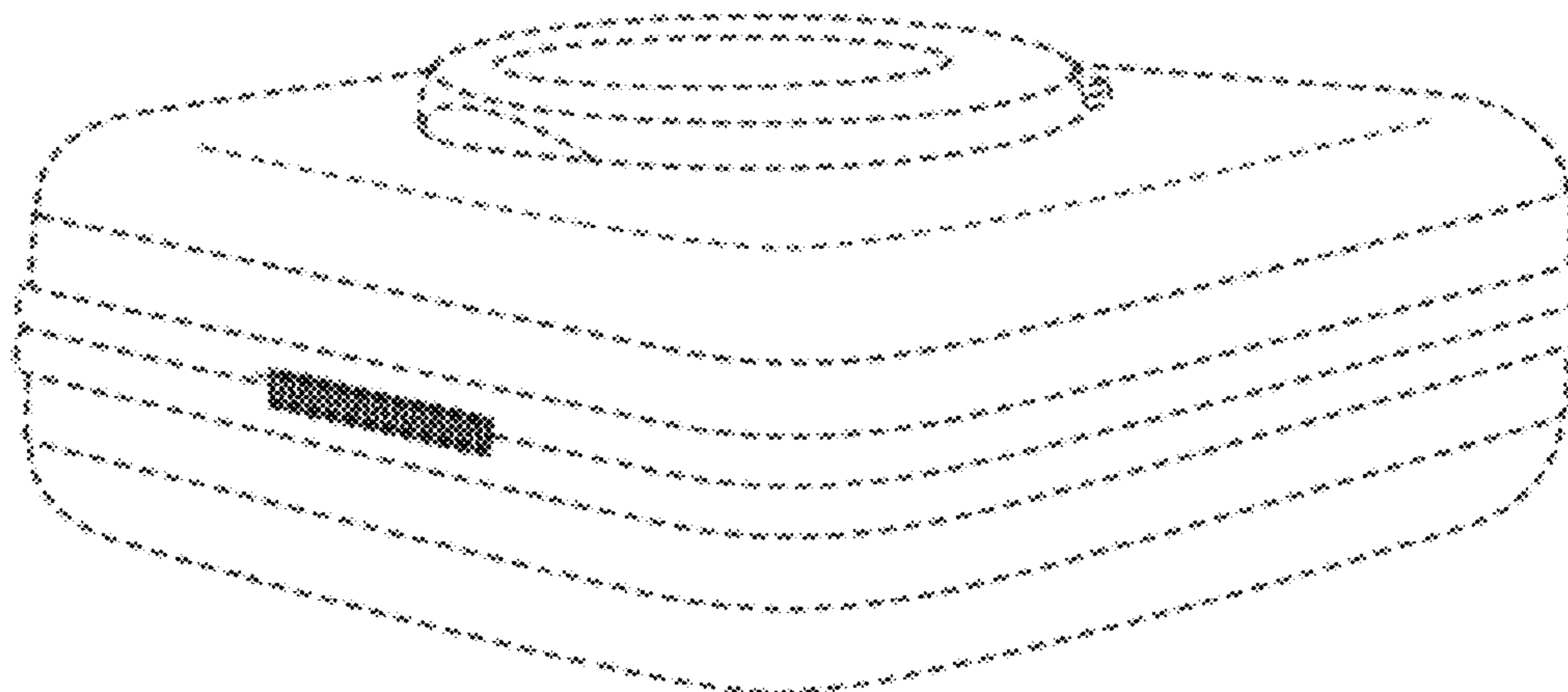
The ornamental design for a front face of a zipper portion of a wipes container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a front face of a zipper portion of a wipes container showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a side elevational view thereof; FIG. 5 is an opposite side elevational view thereof; FIG. 6 is top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

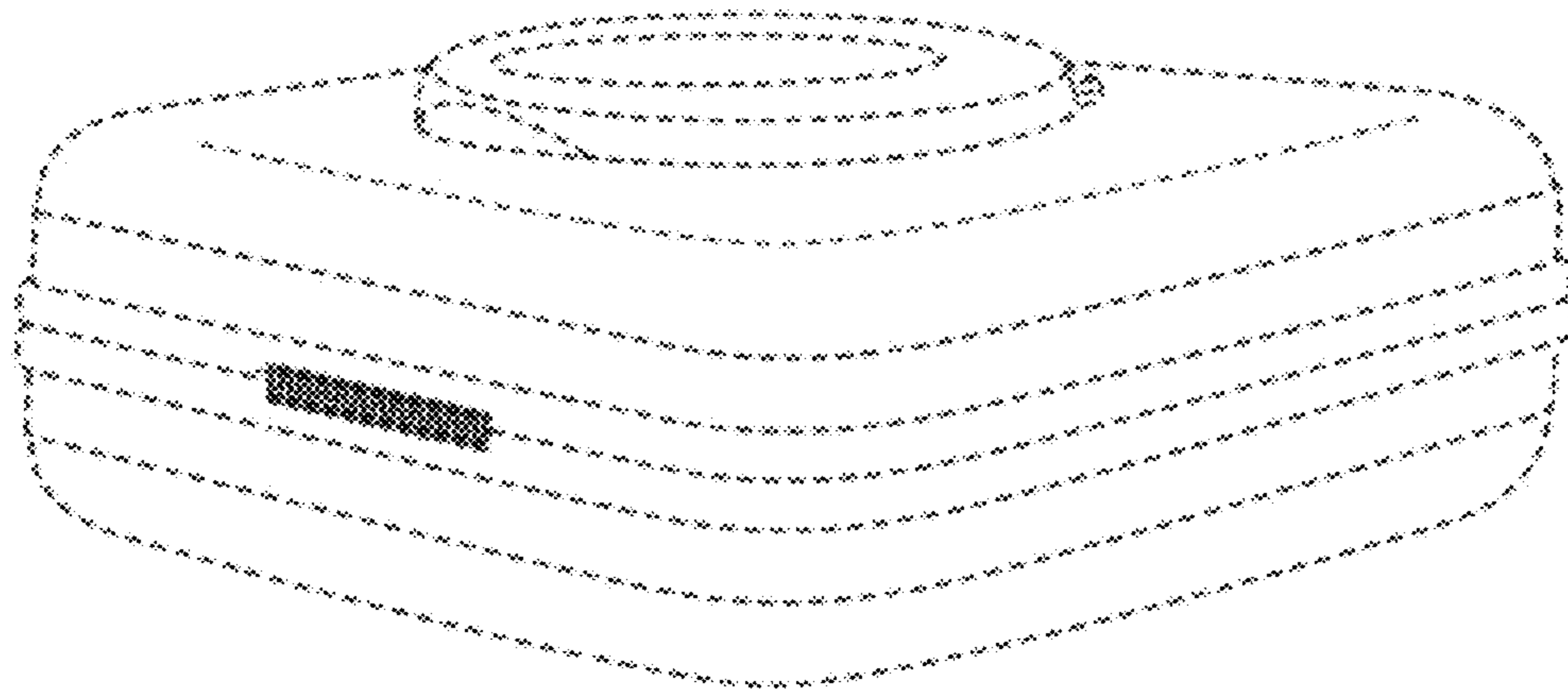

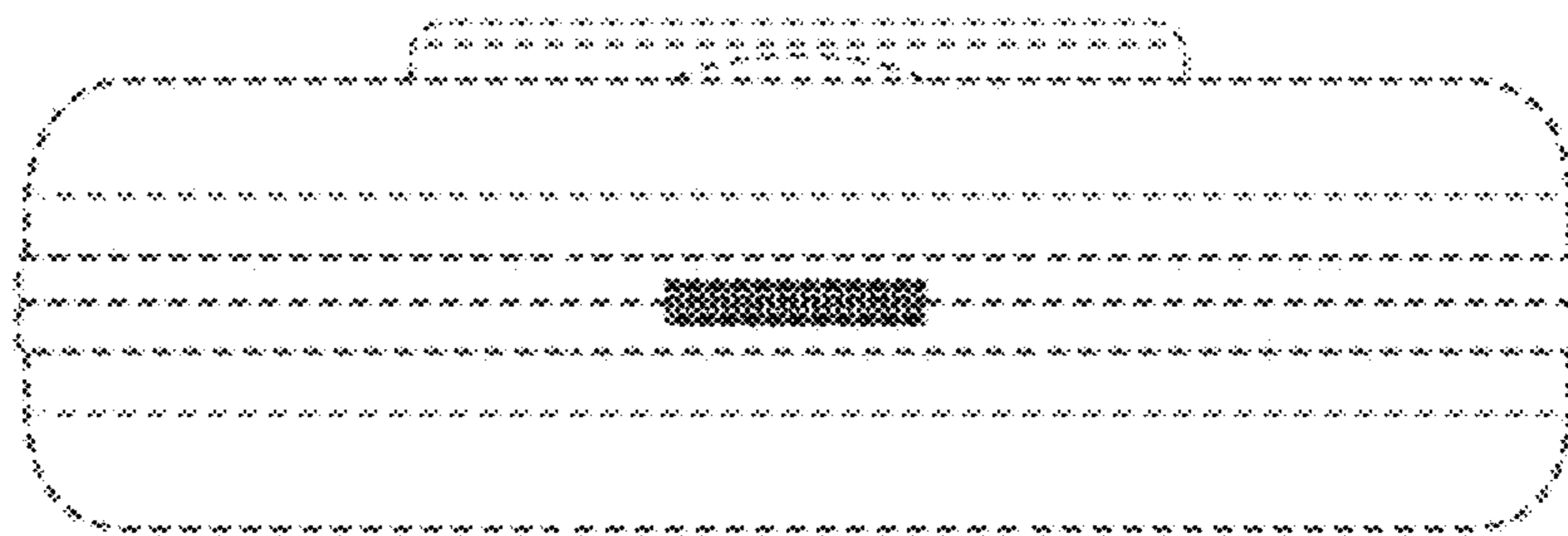

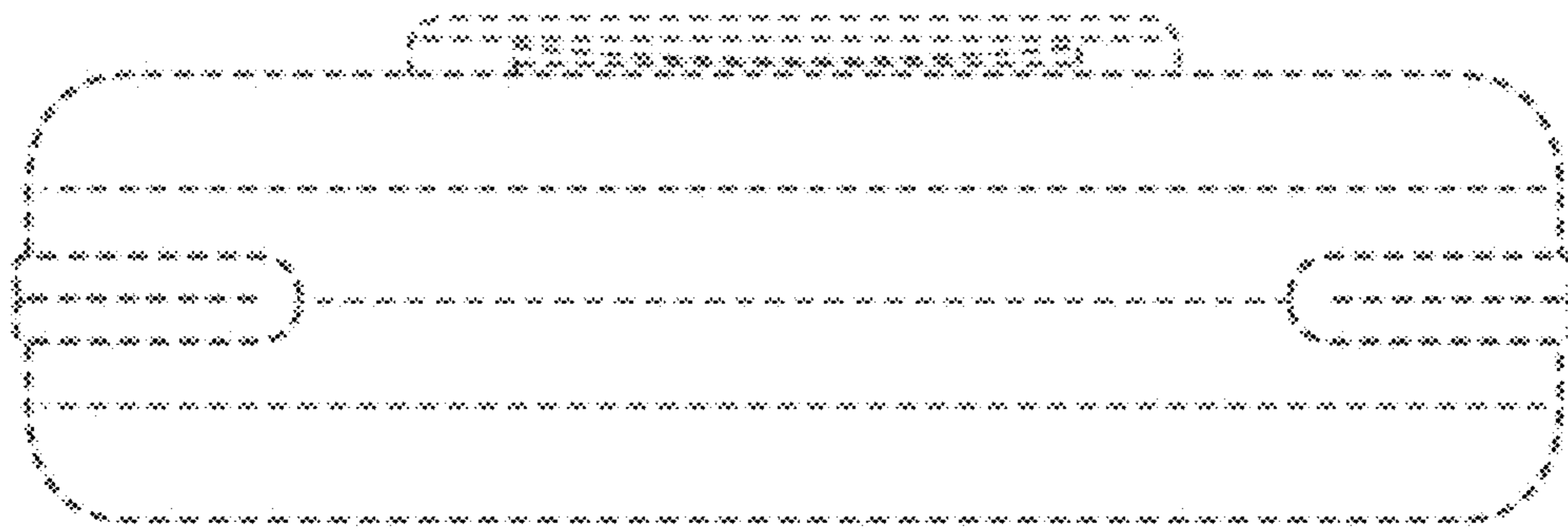

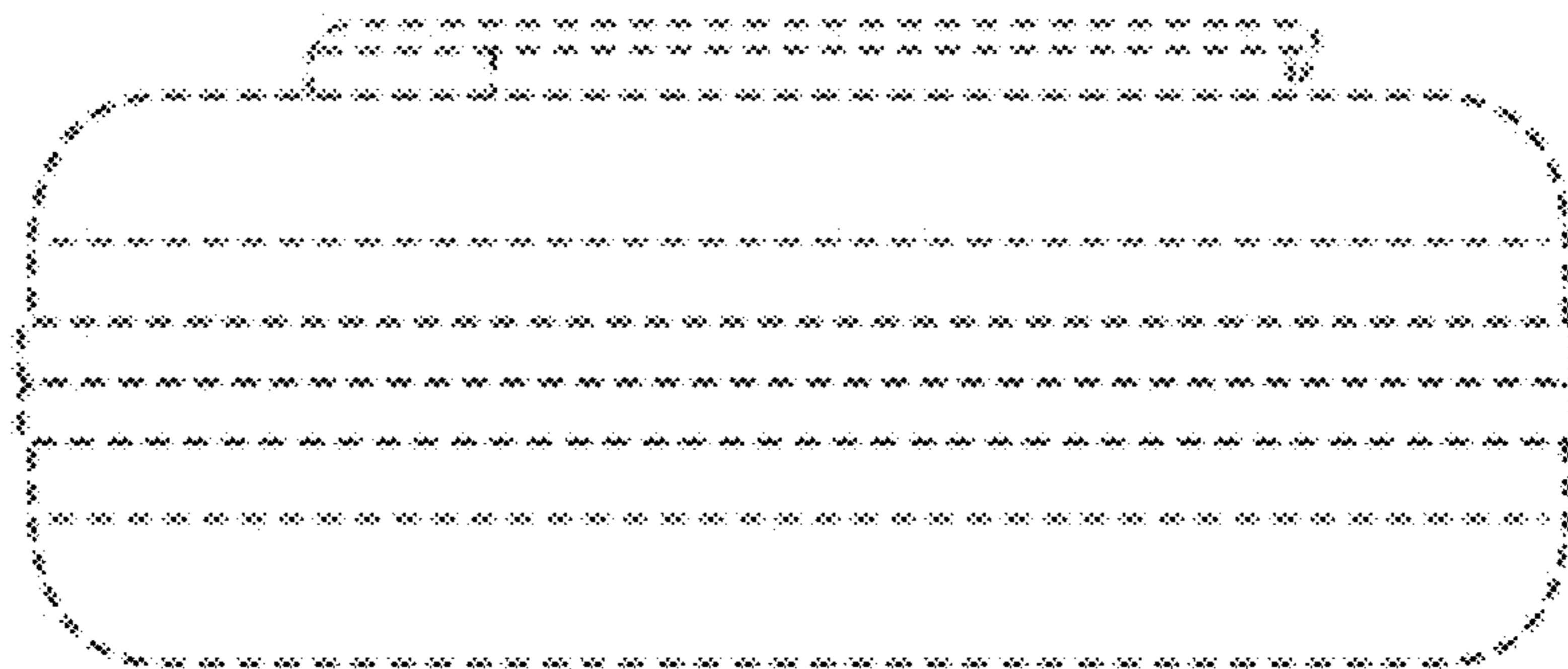

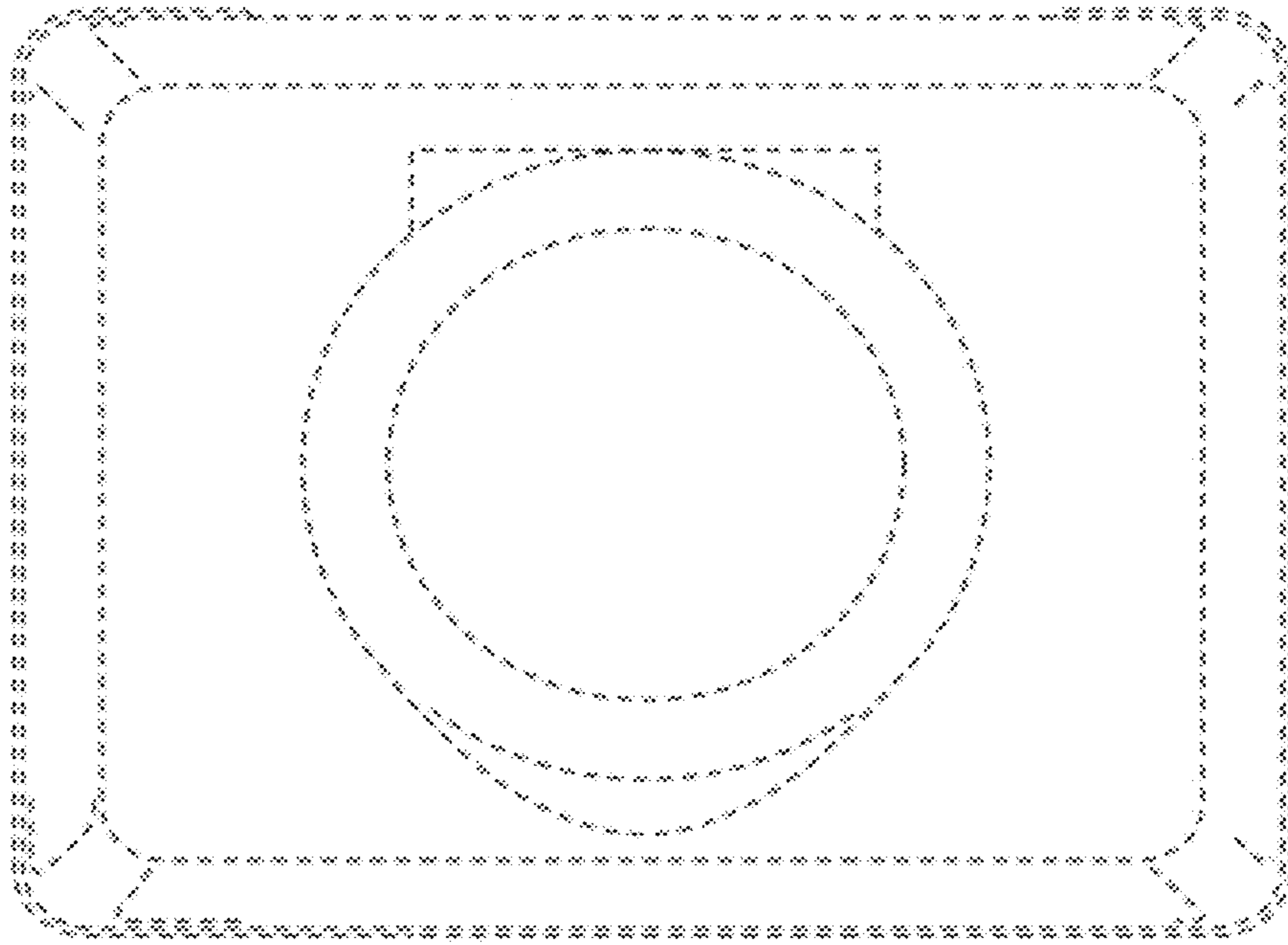
