DESCRIPTION

FIG. 4 is a right side elevational view of the sealable cup having storage of FIG. 1.

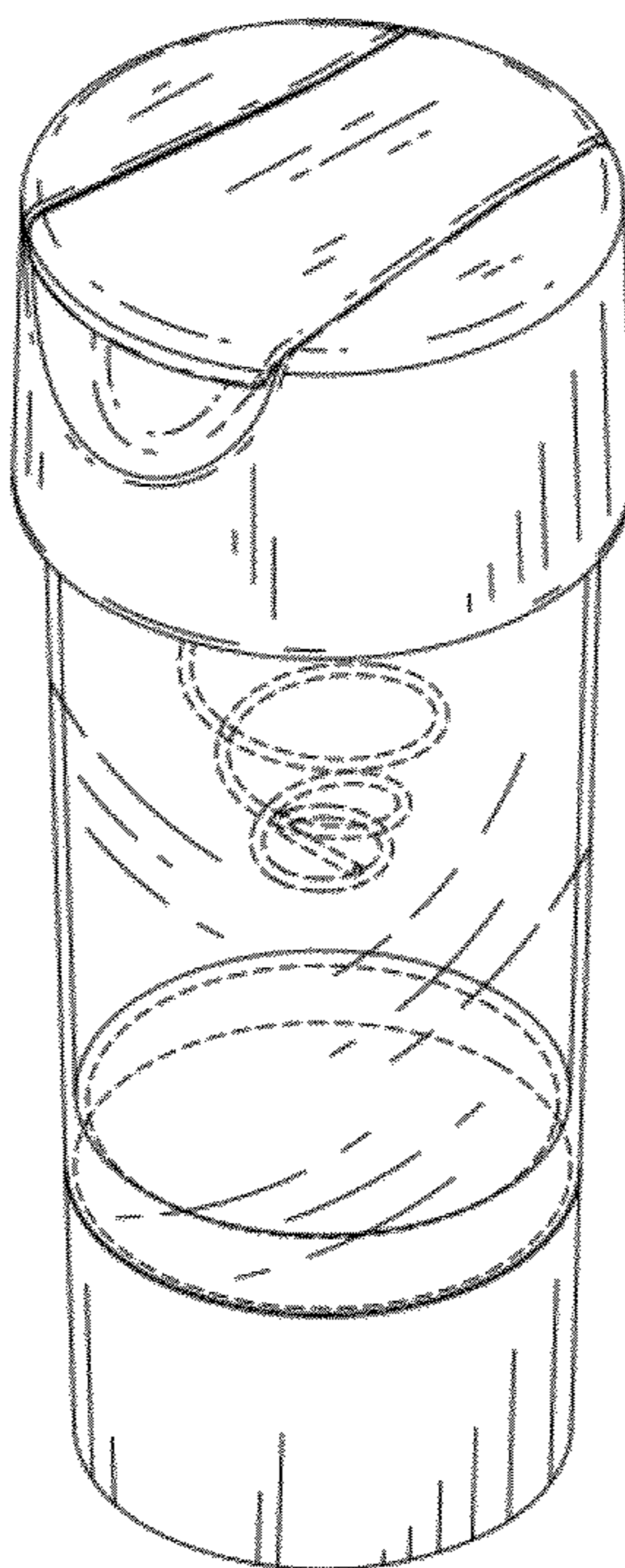
FIG. 5 is a left side elevational view of the sealable cup having storage of FIG. 1.

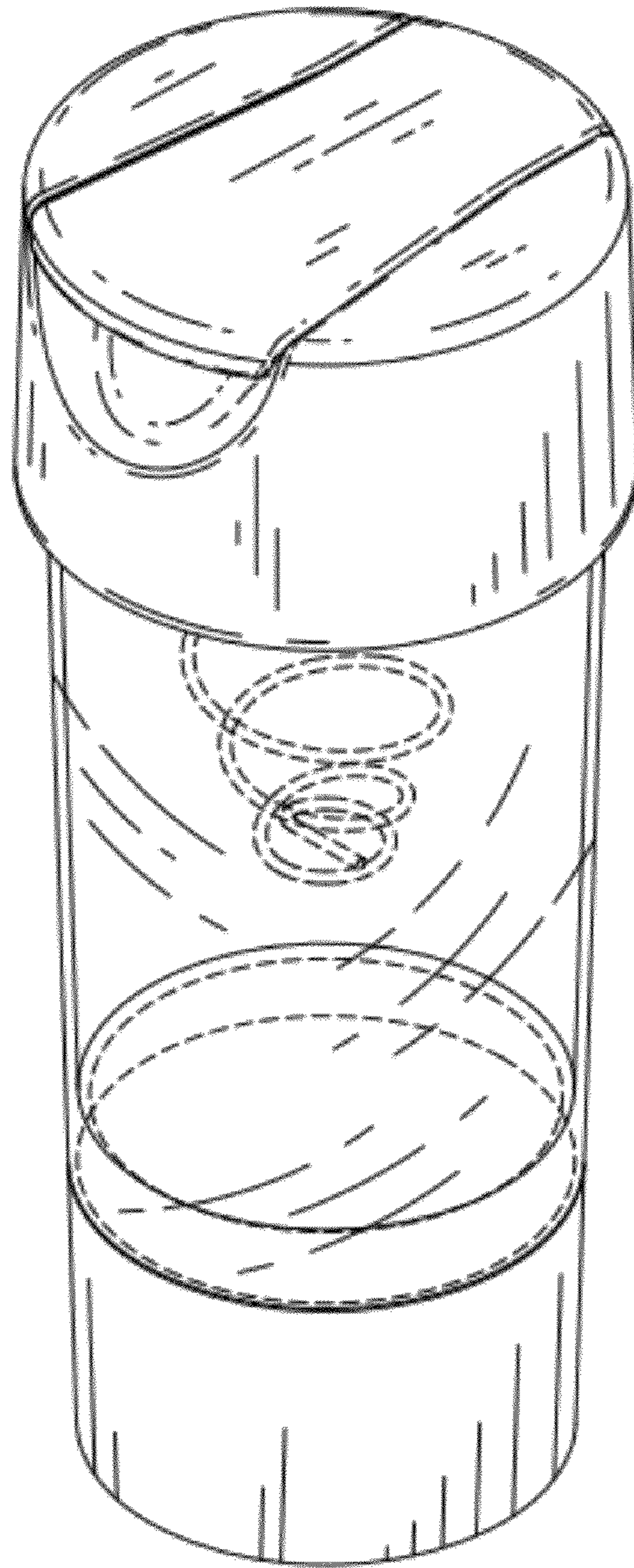

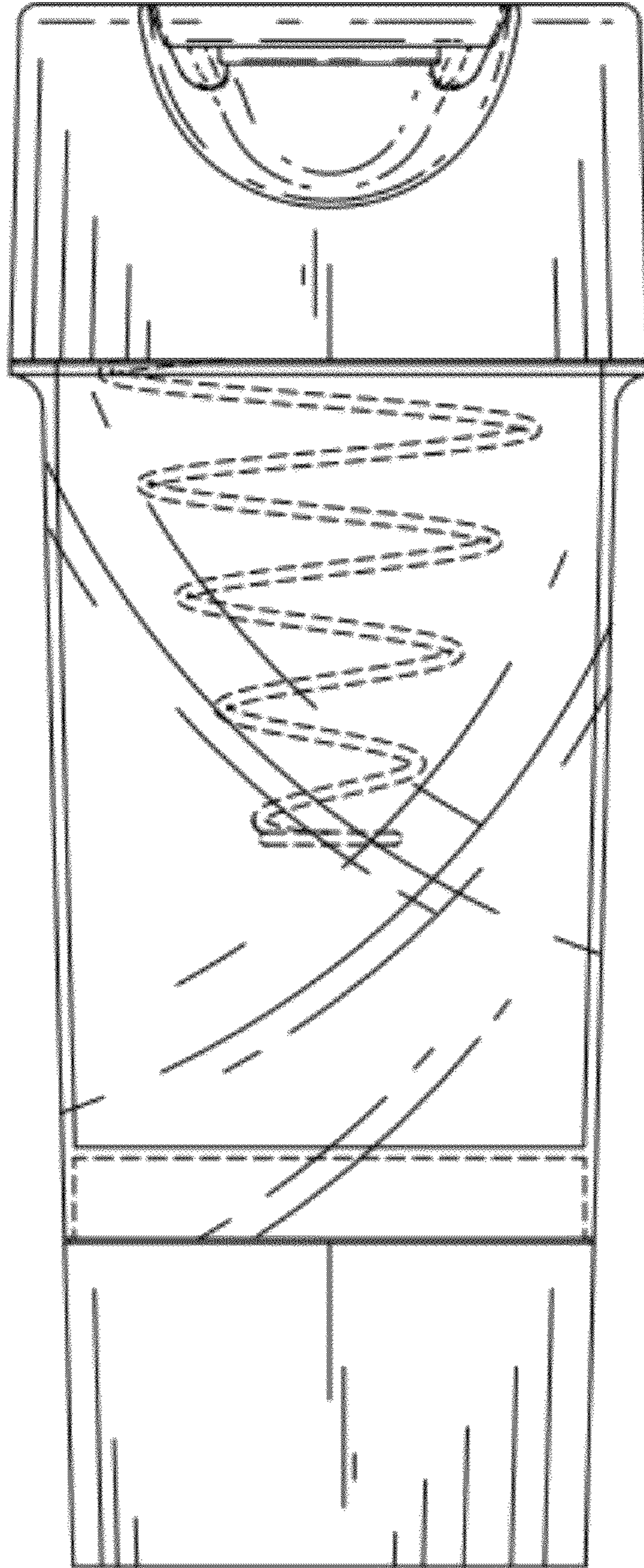

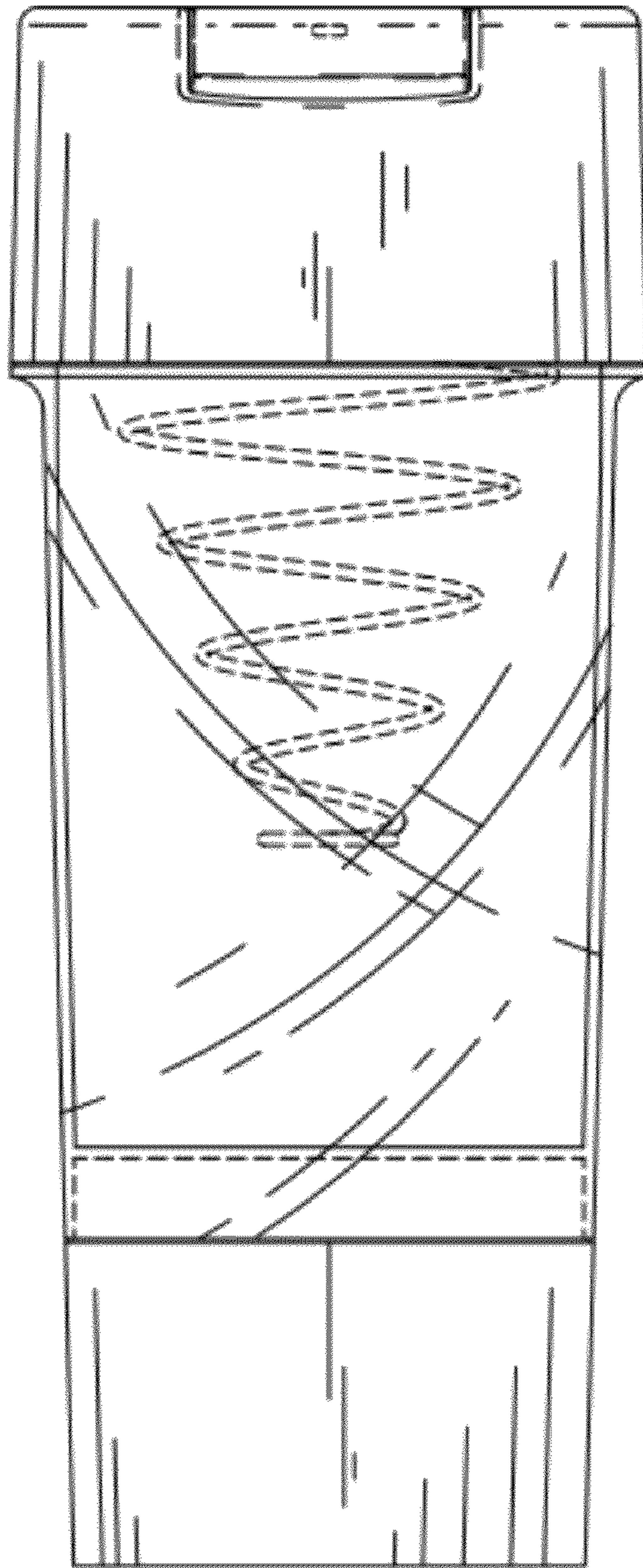

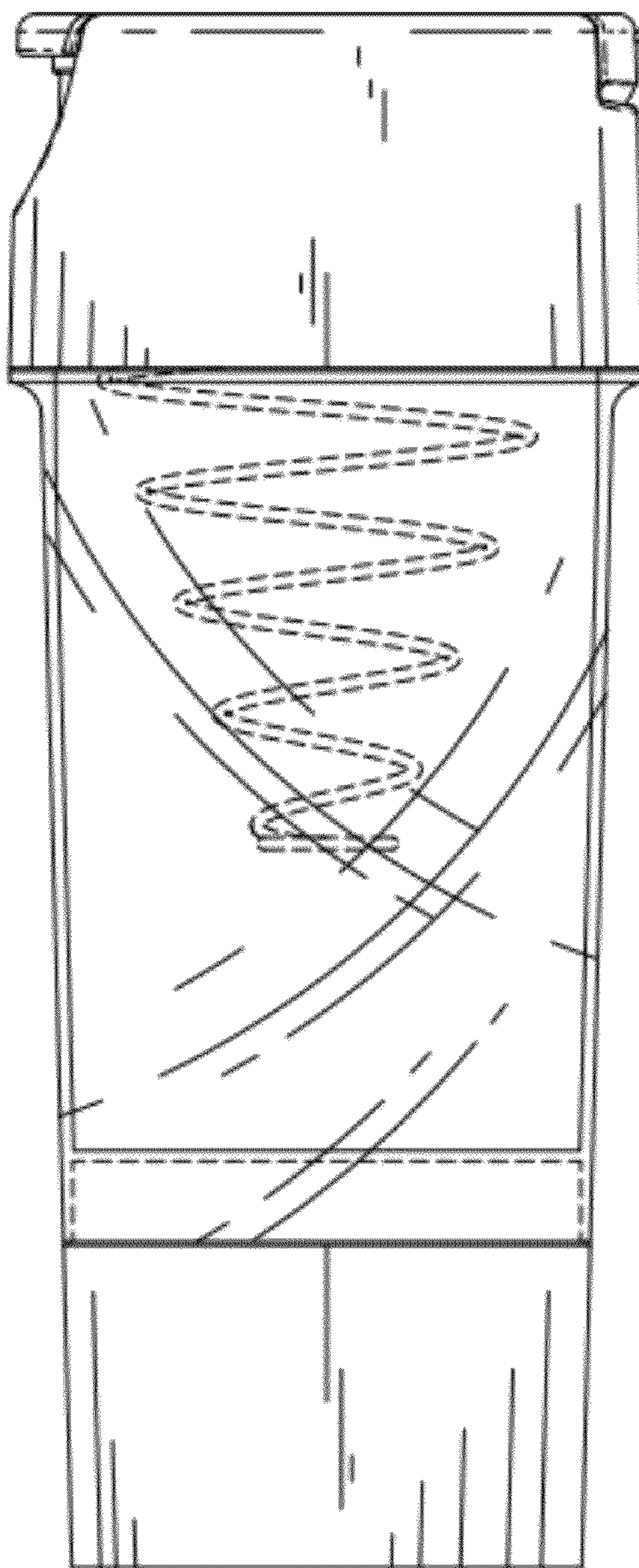

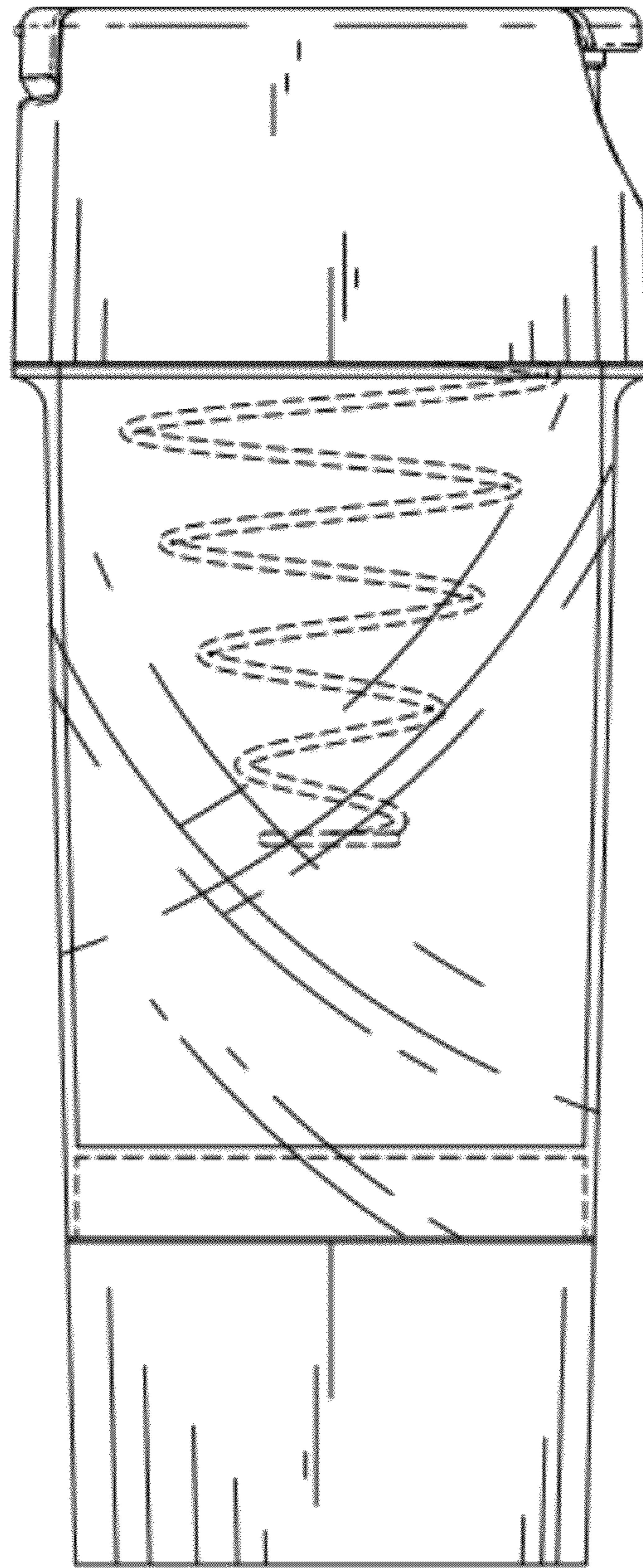

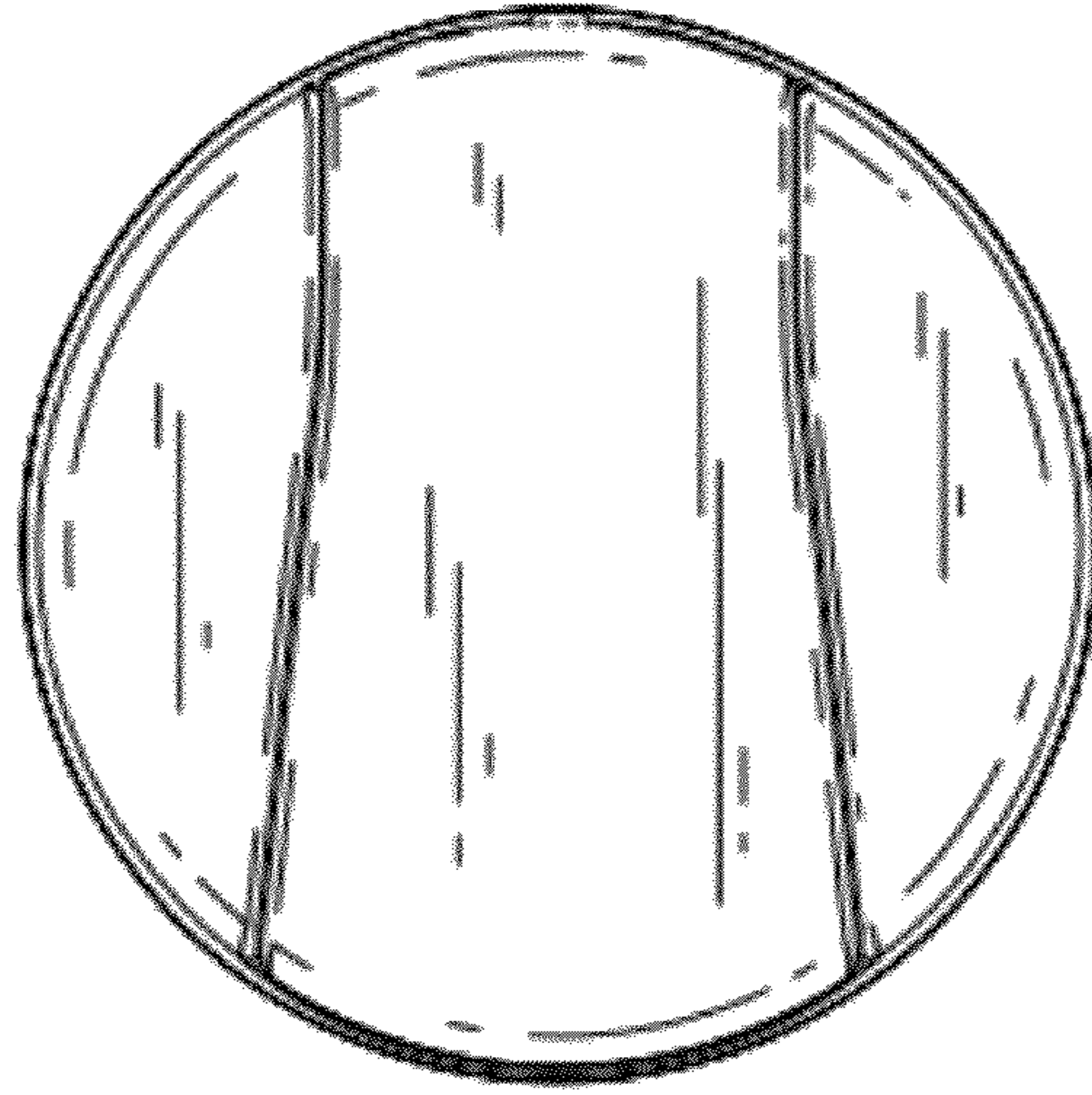

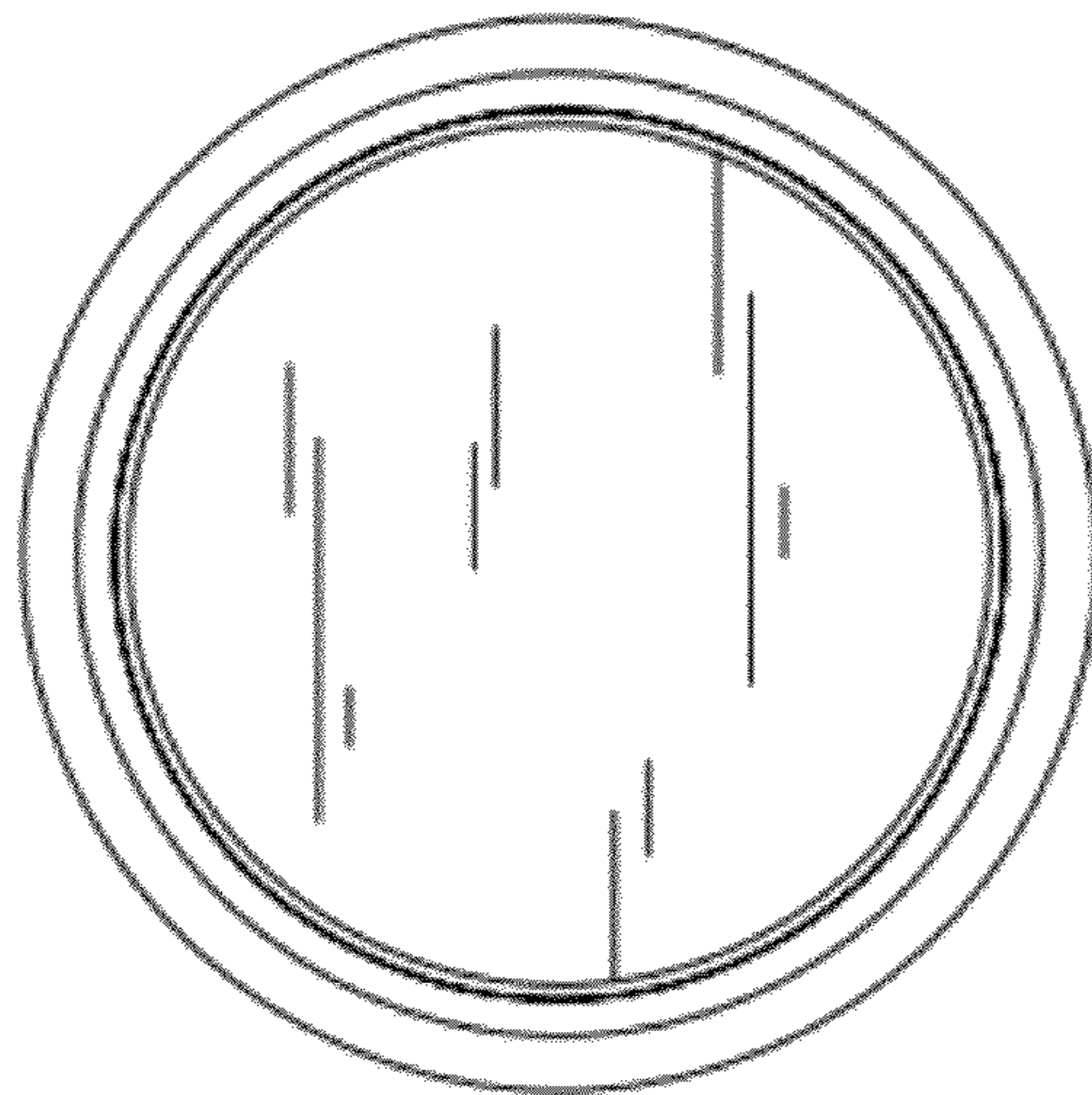
