FIG. 3 is a right view thereof.

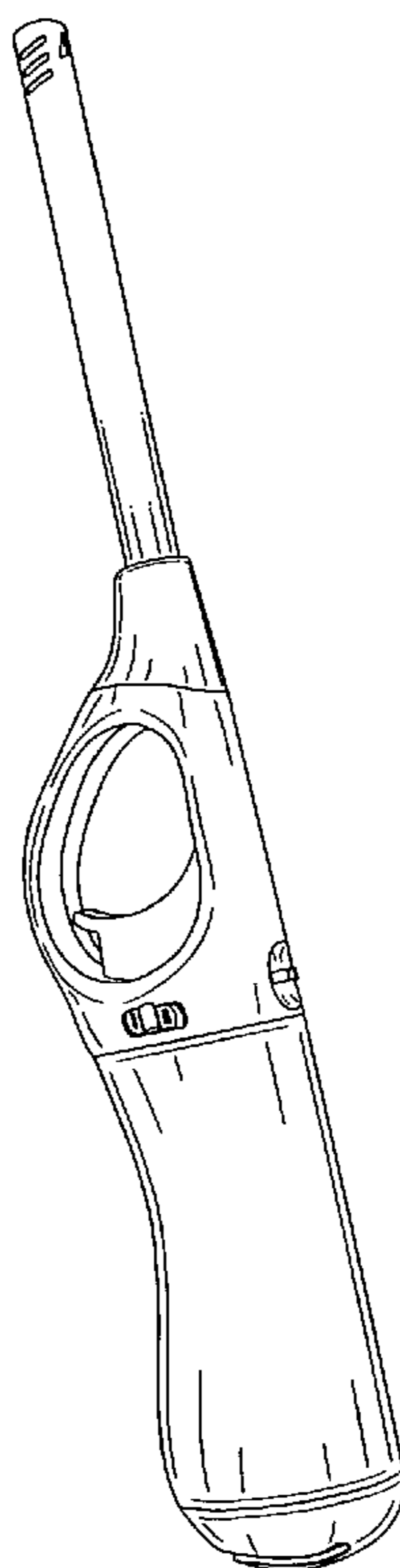
FIG. 4 is a bottom view thereof.

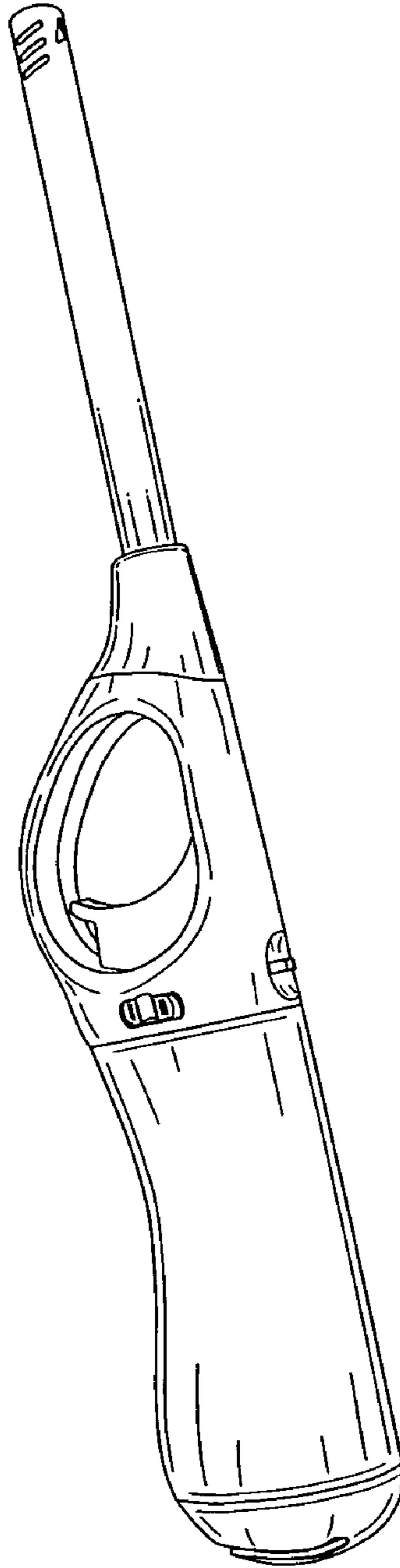

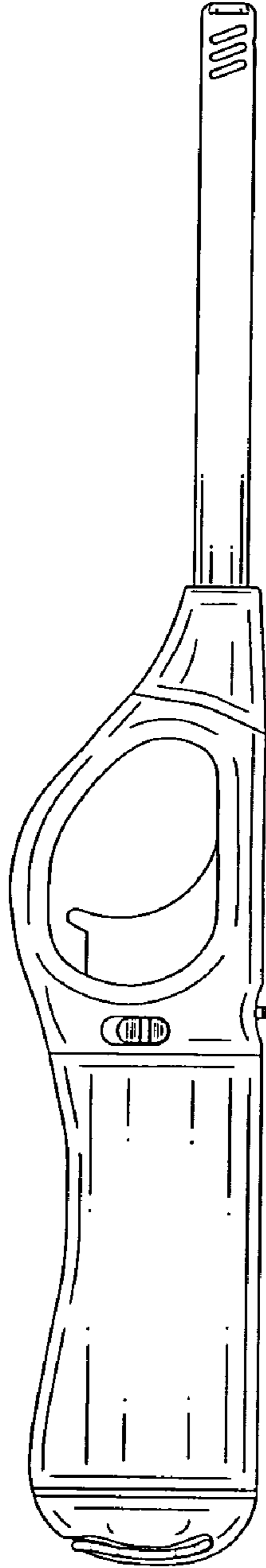

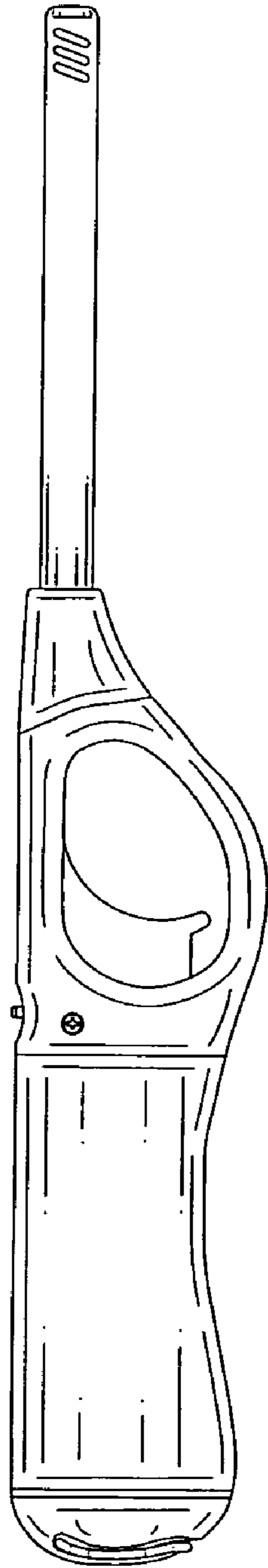

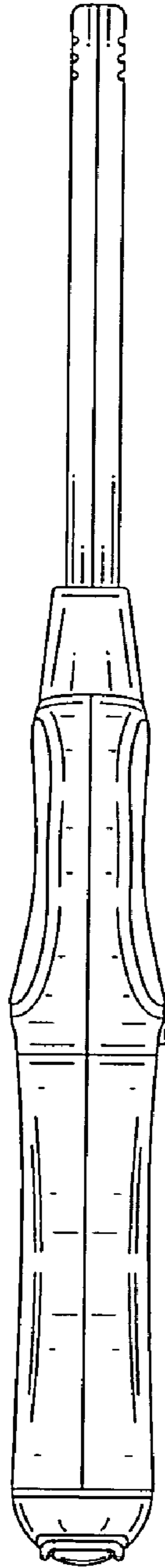

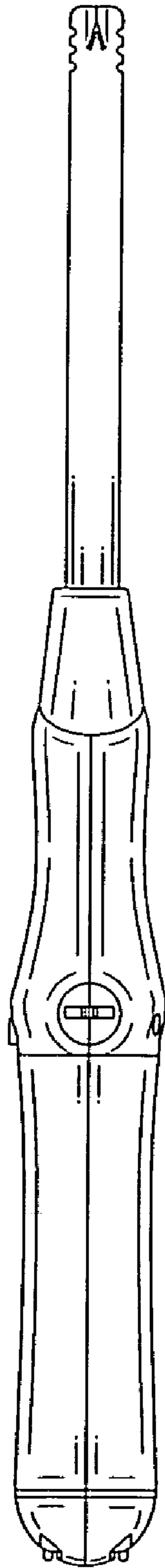

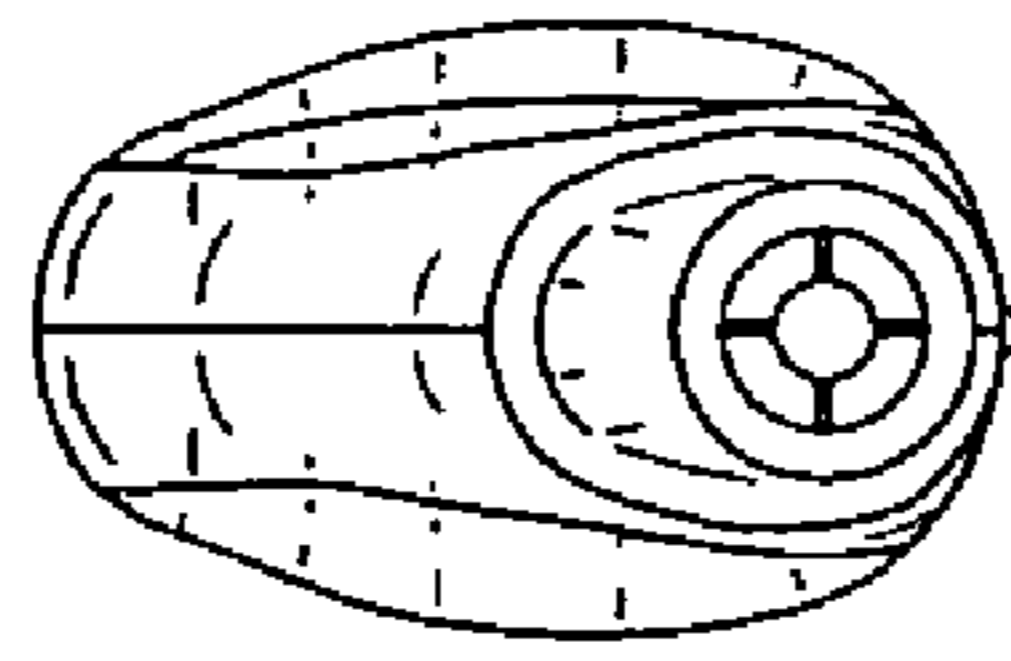

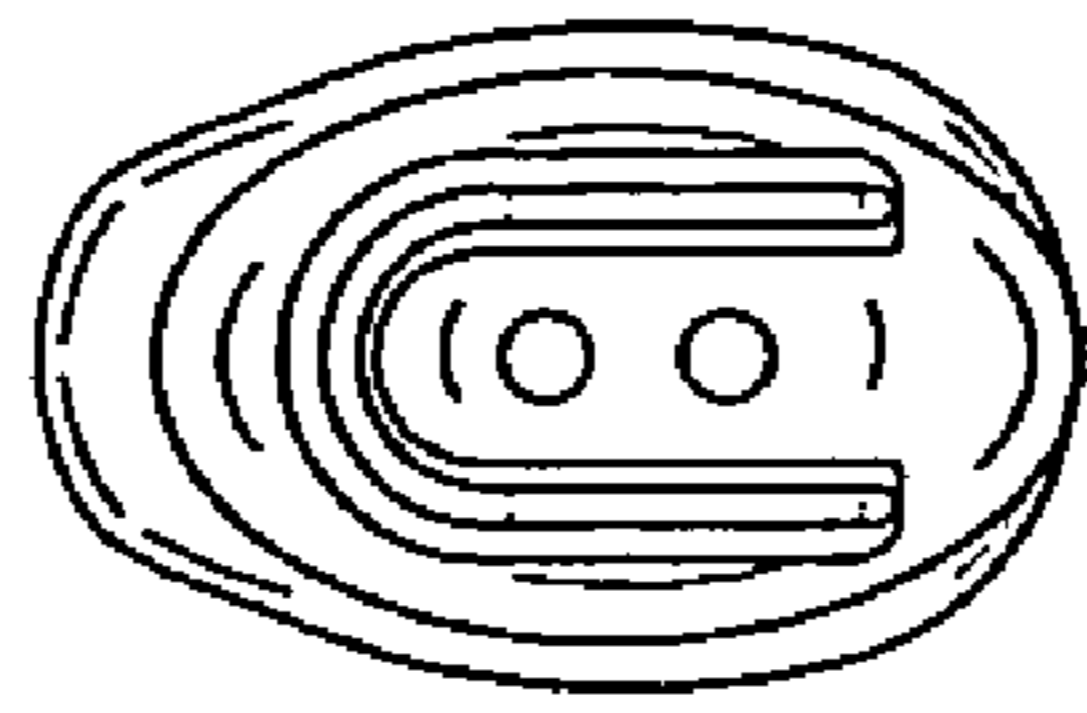
