DESCRIPTION

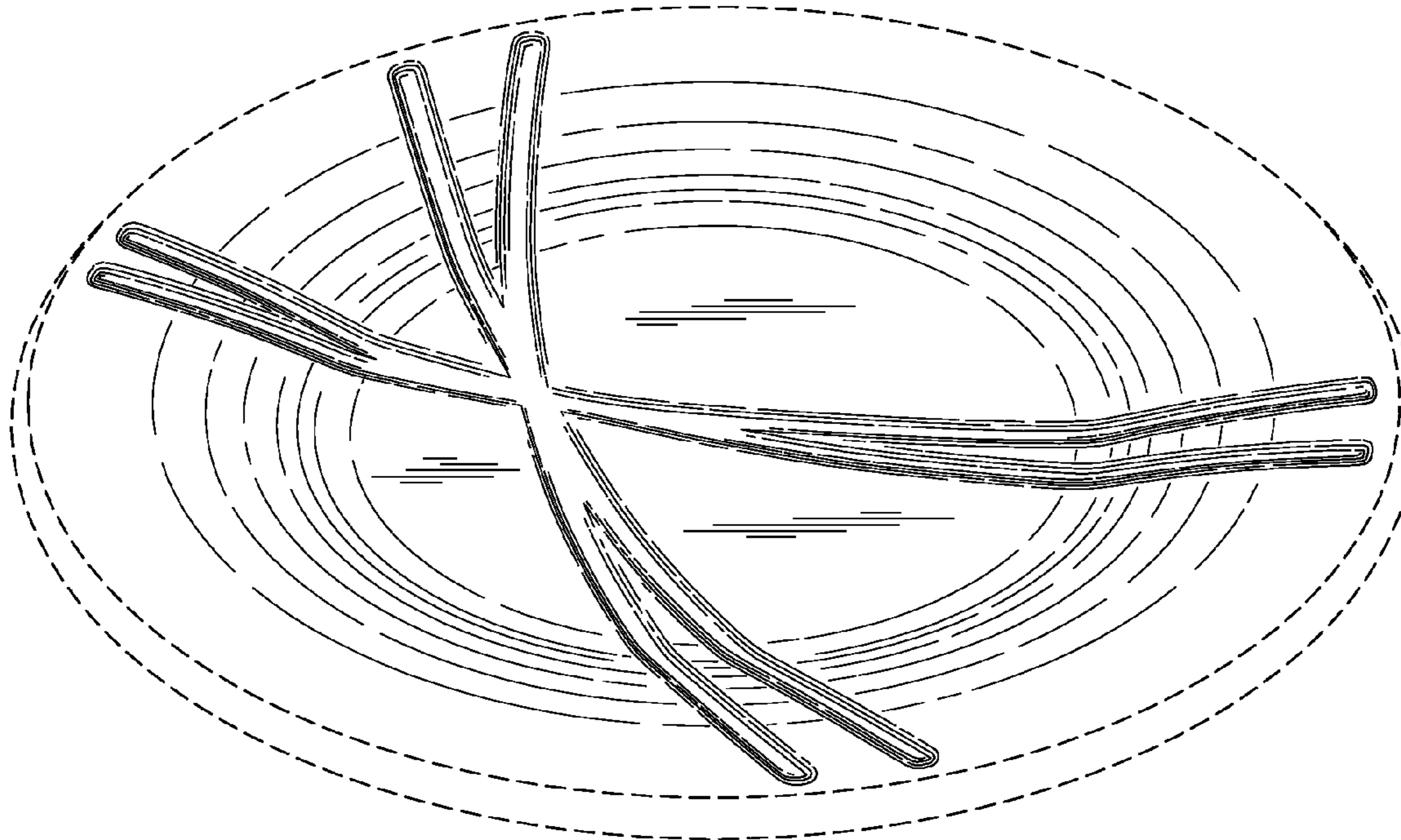
FIG. 1 is a perspective view of a portion-controlled dinnerware plate;

FIG. 2 is a top plan view of the portion-controlled dinnerware plate of FIG. 1; and,

FIG. 3 is a cross sectional view showing the depth of the surface of the portion controlled dinnerware plate taken along line 3-3 of FIG. 2.

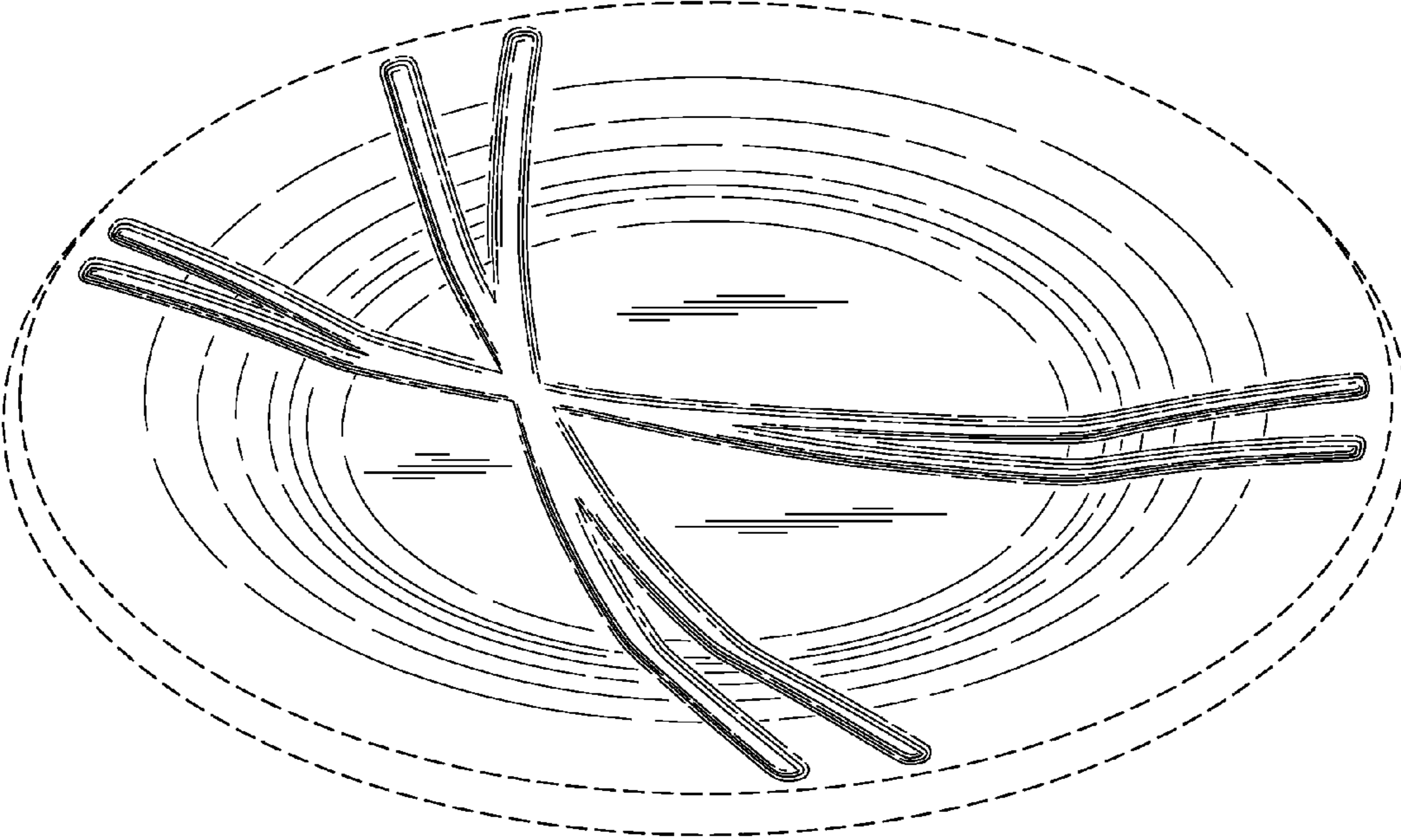

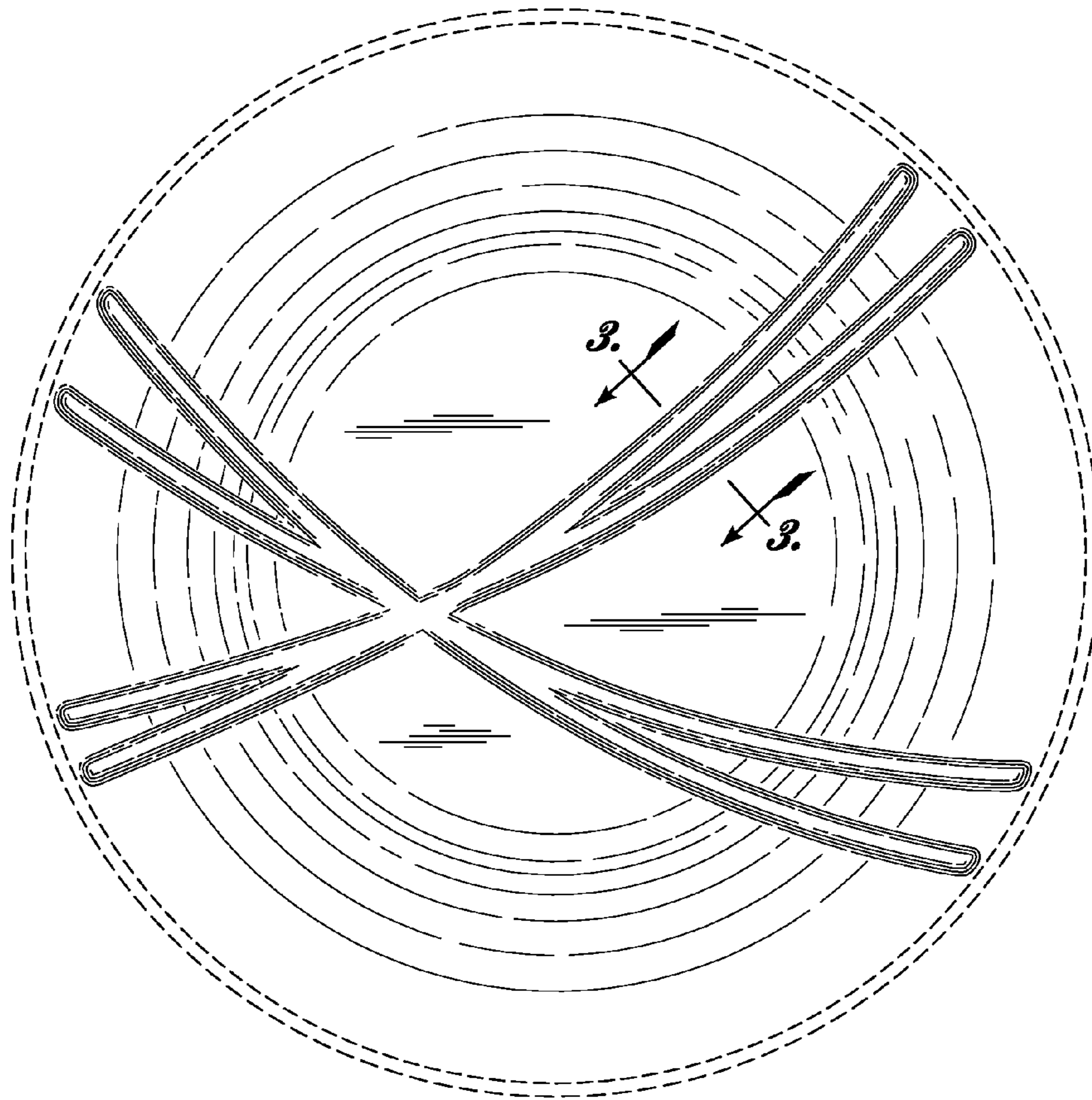

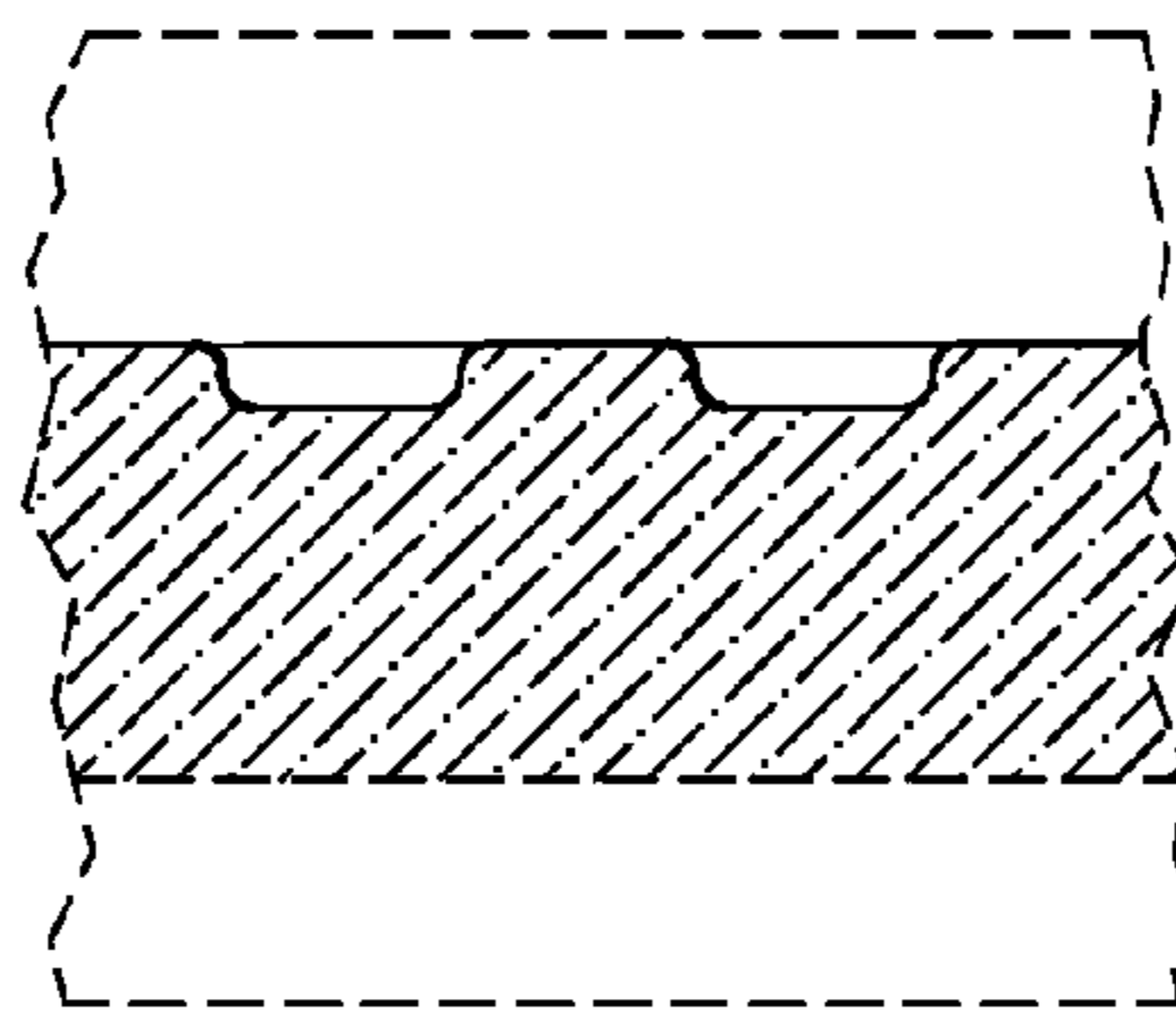
