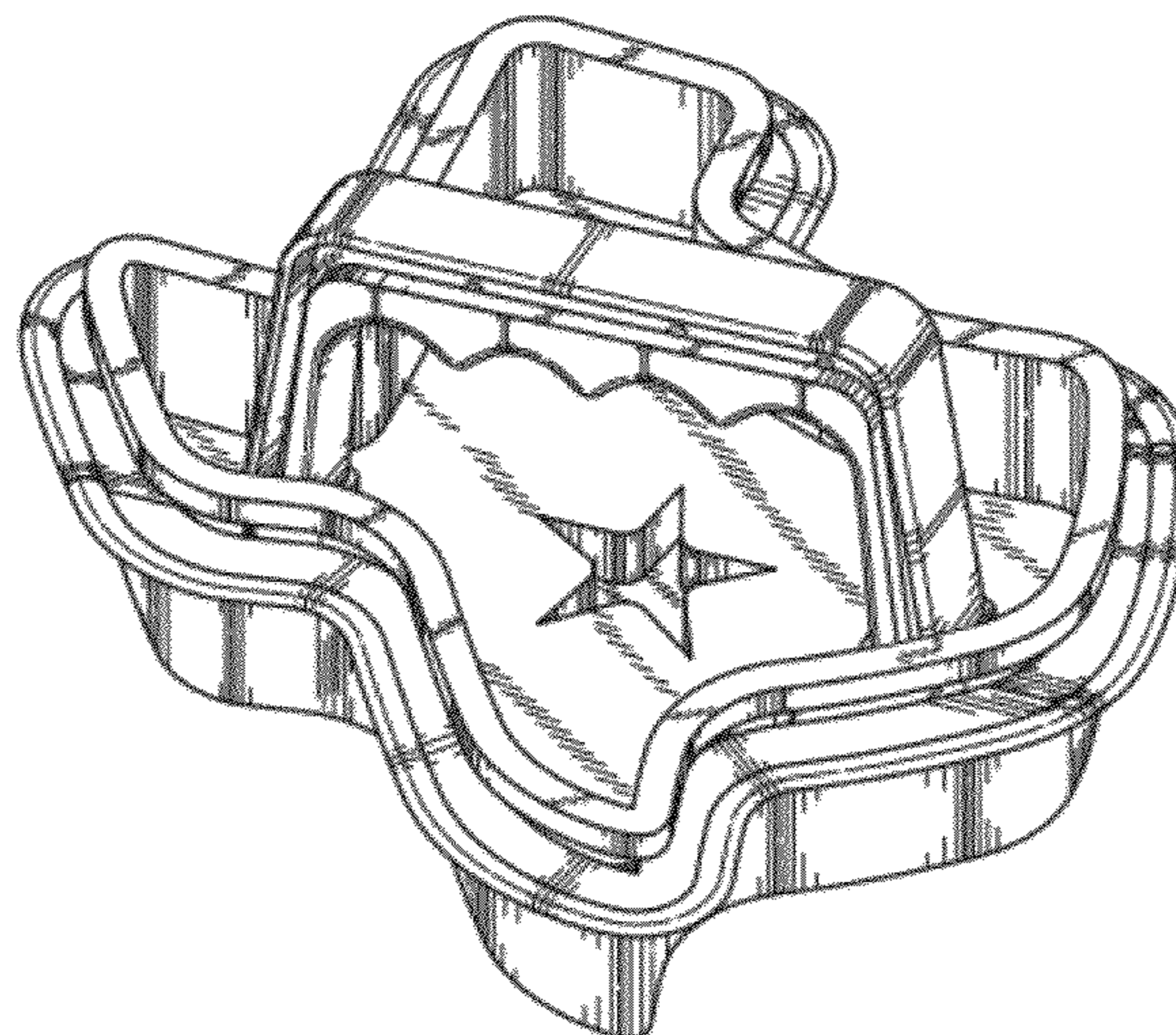
(57) **CLAIM**

The ornamental design for a hamburger press, as shown and described.

**DESCRIPTION**

FIG. 1 is a front side perspective view of a hamburger press in accordance with the present design;

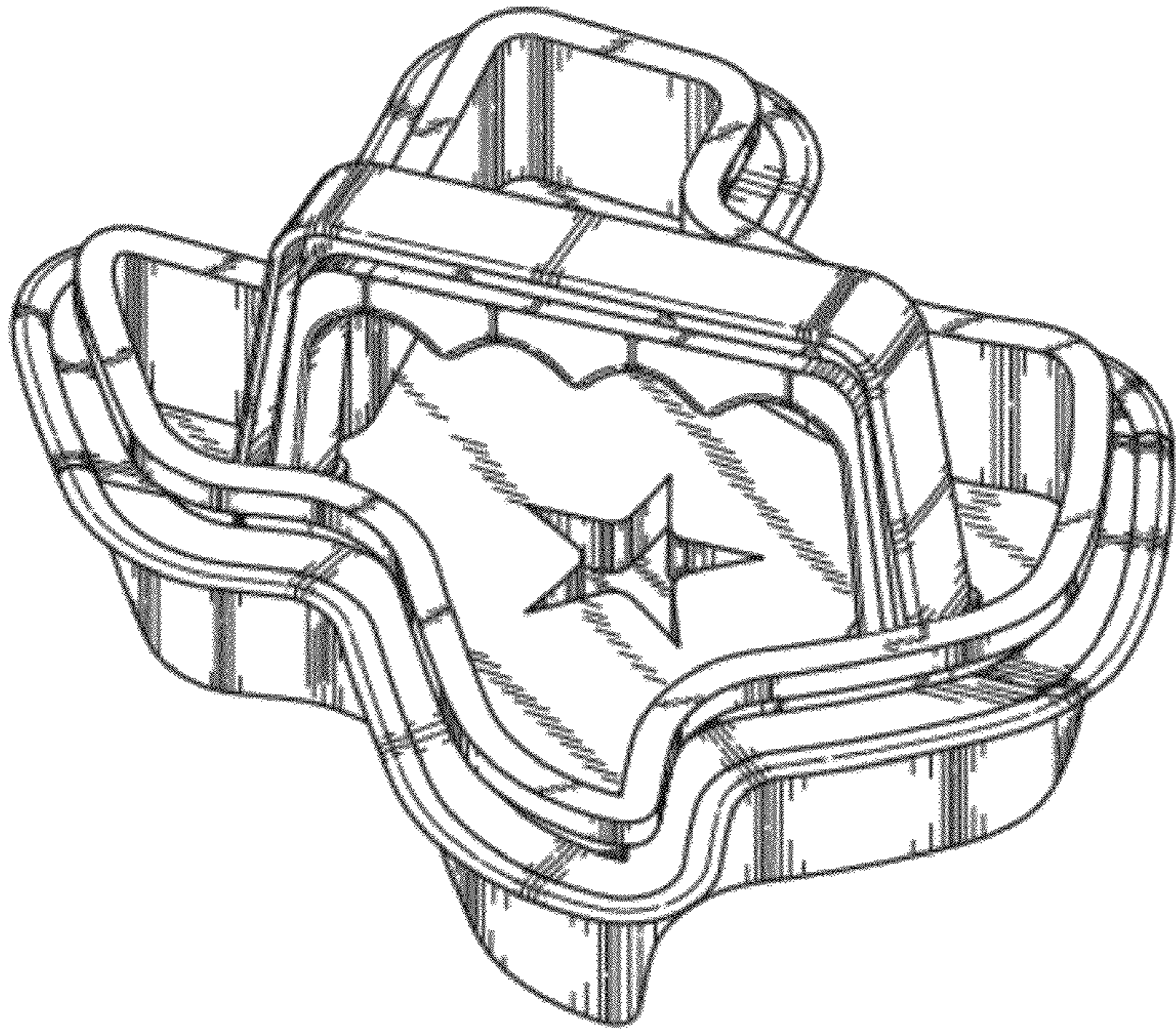

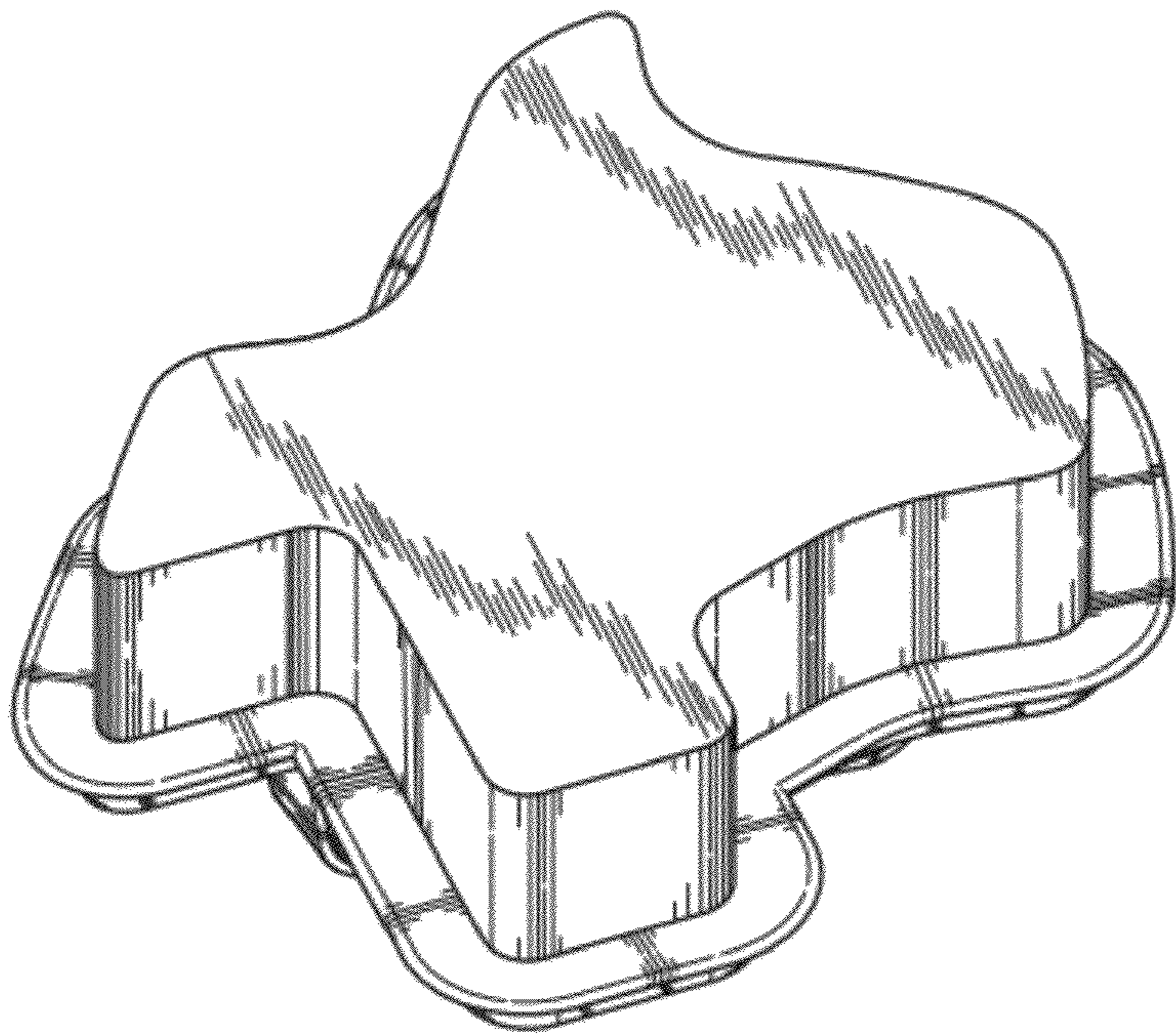

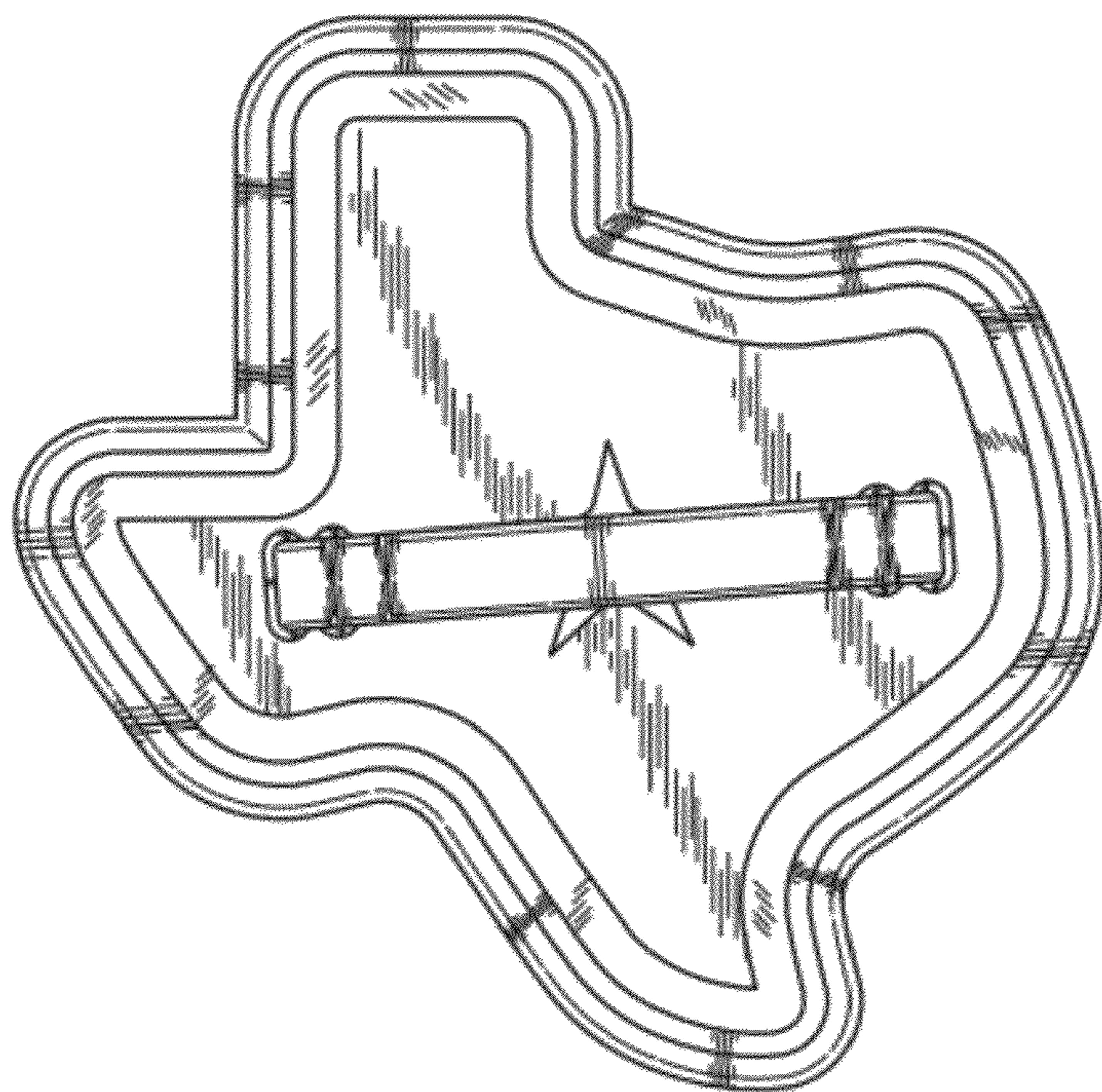

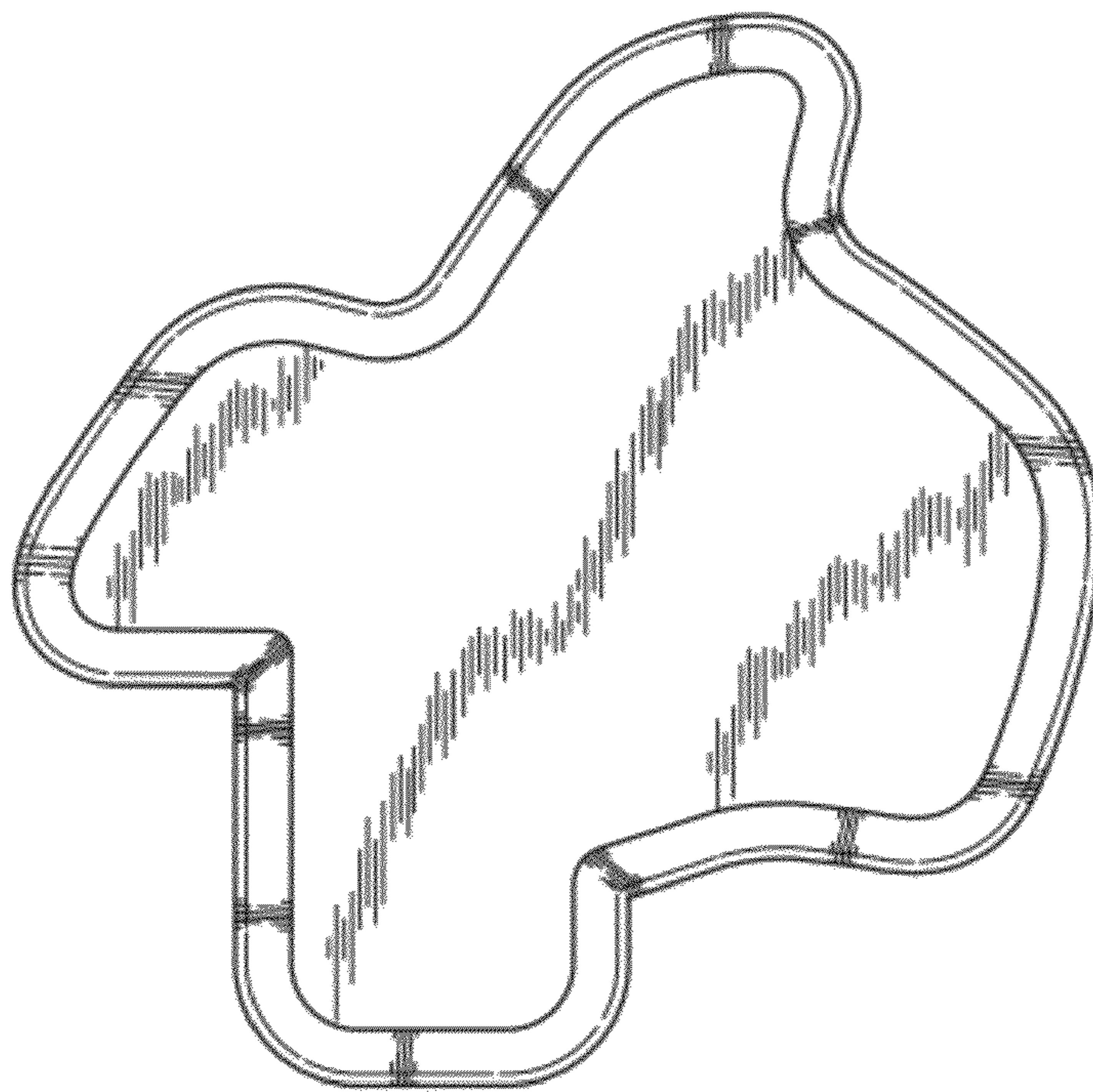

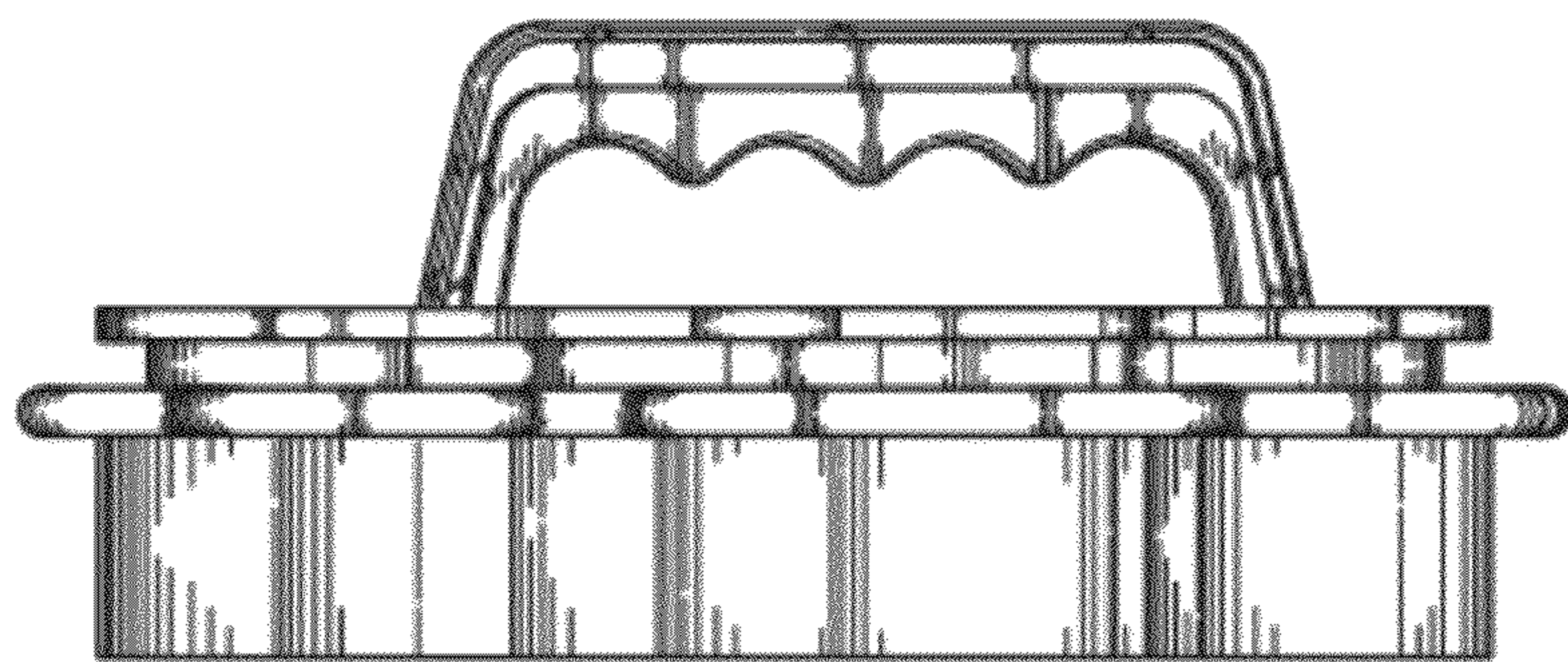

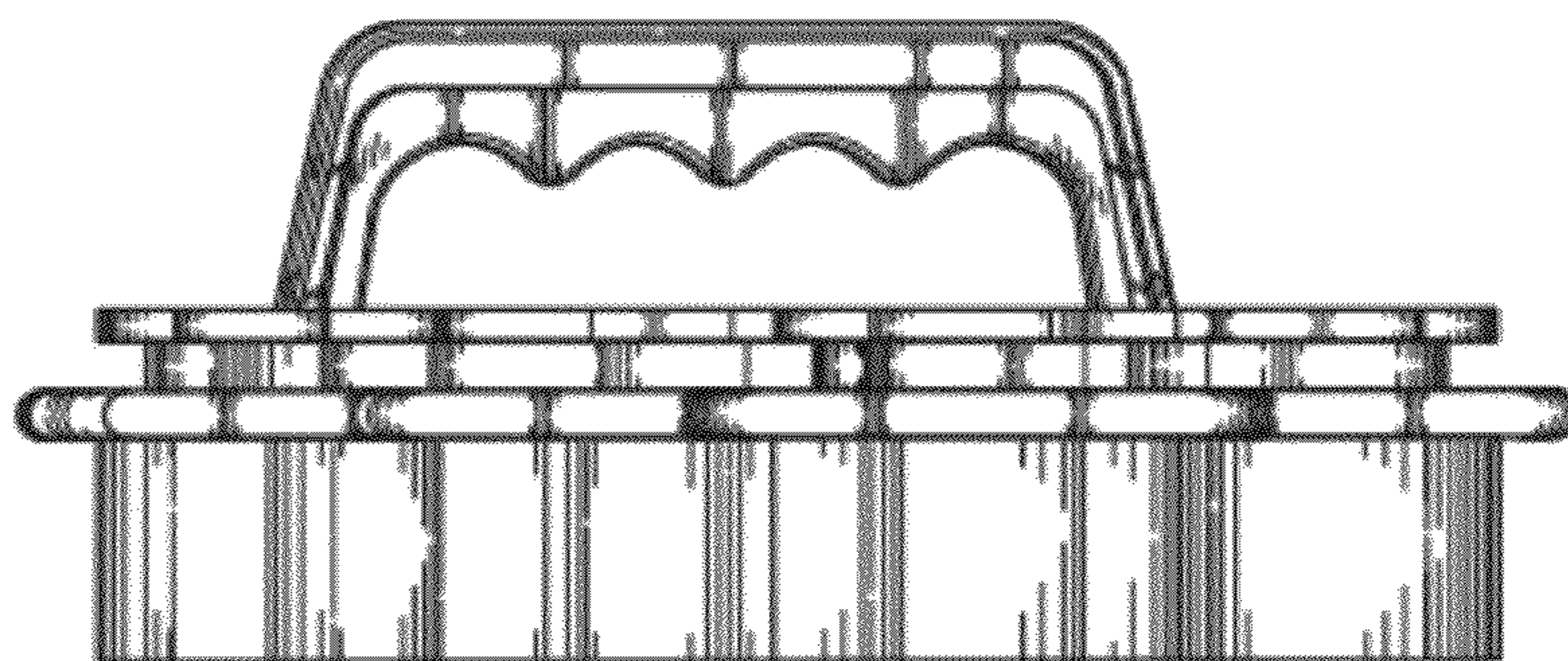

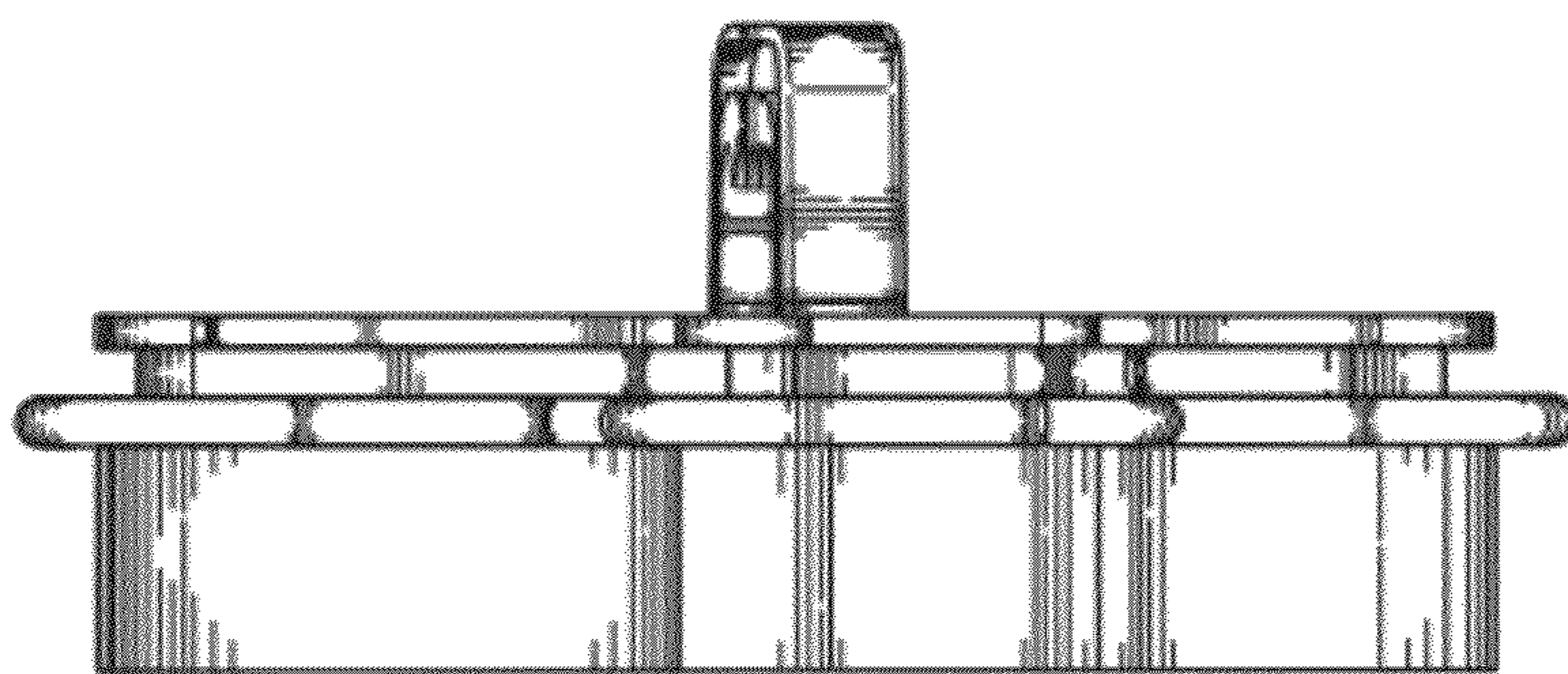

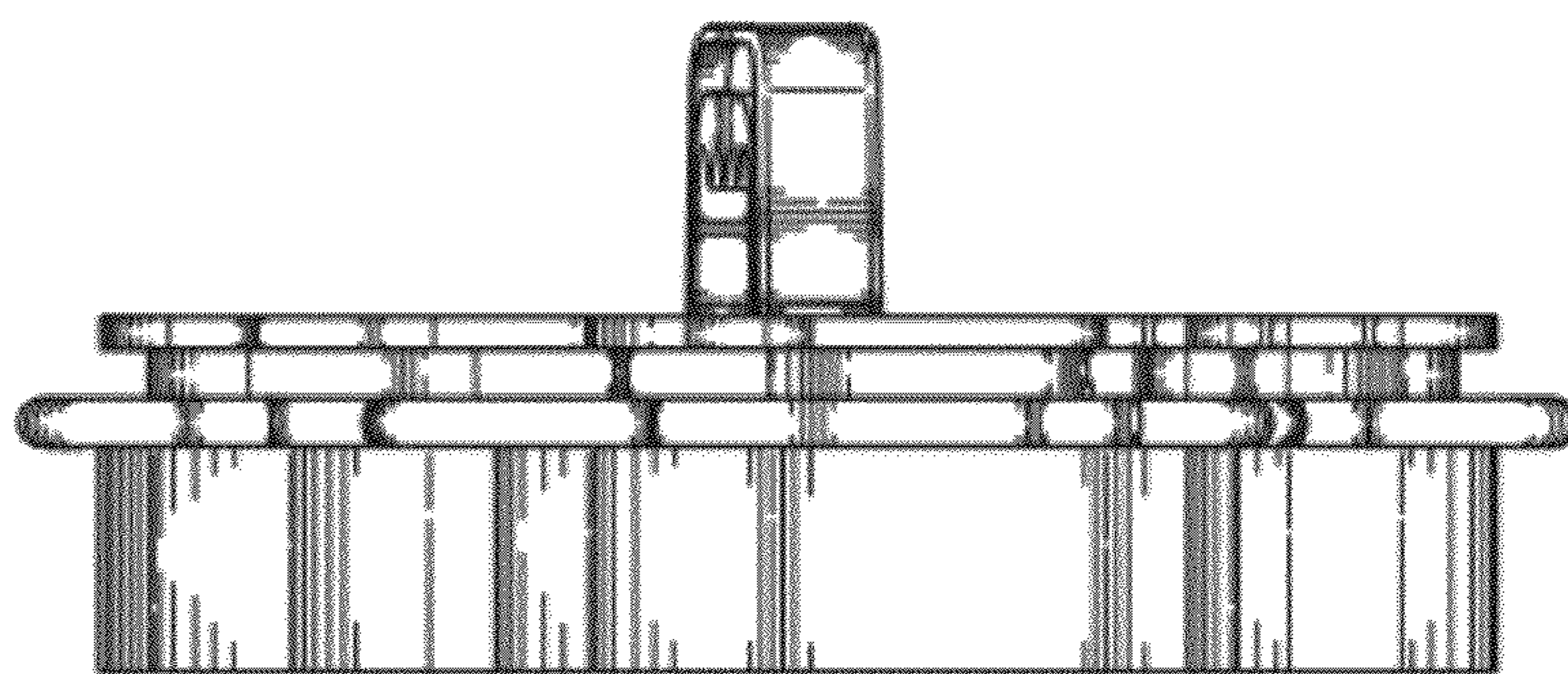

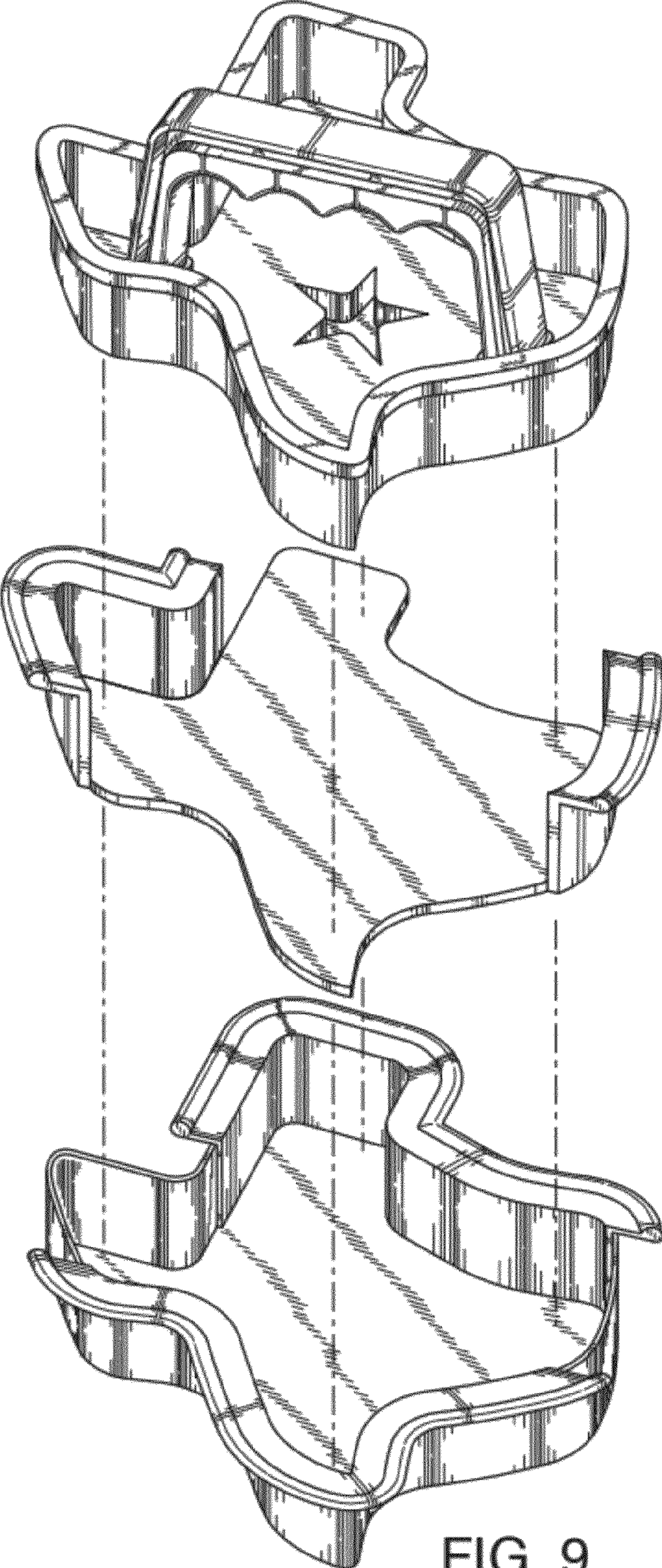

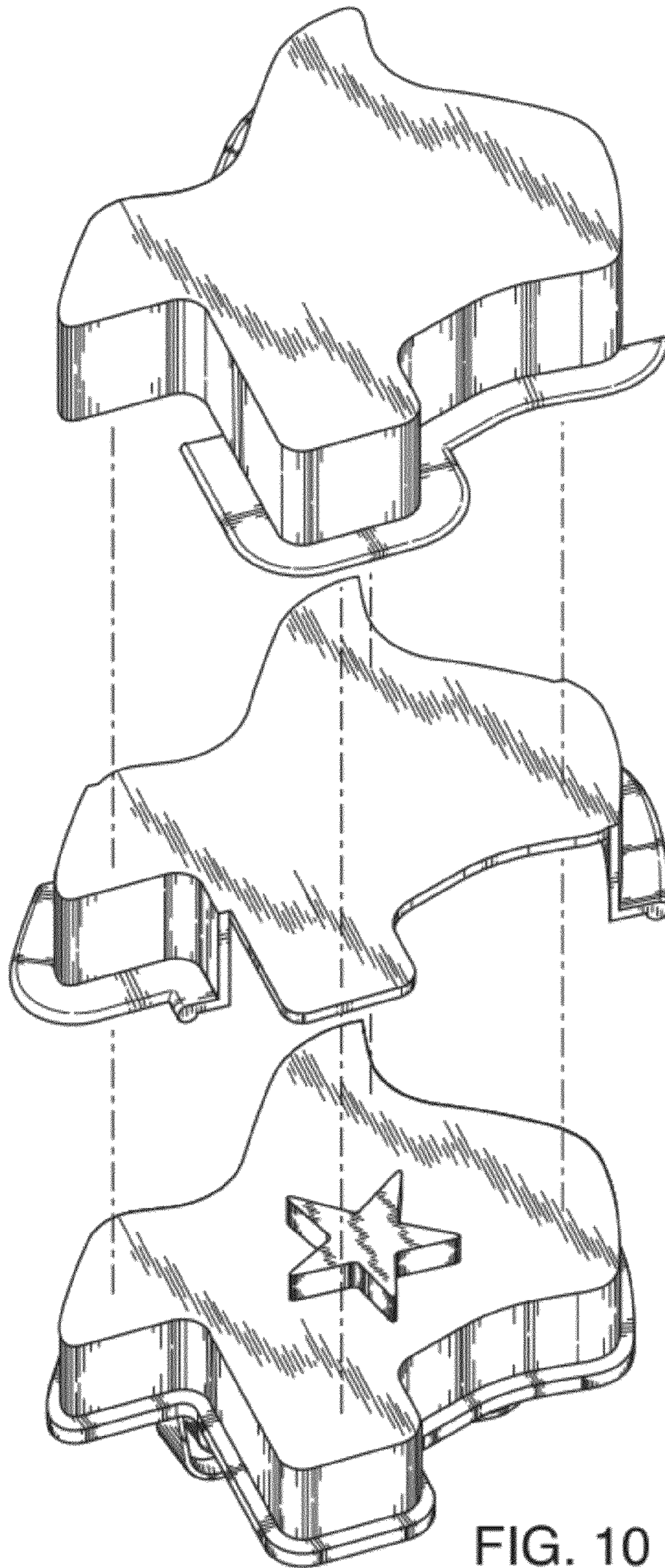

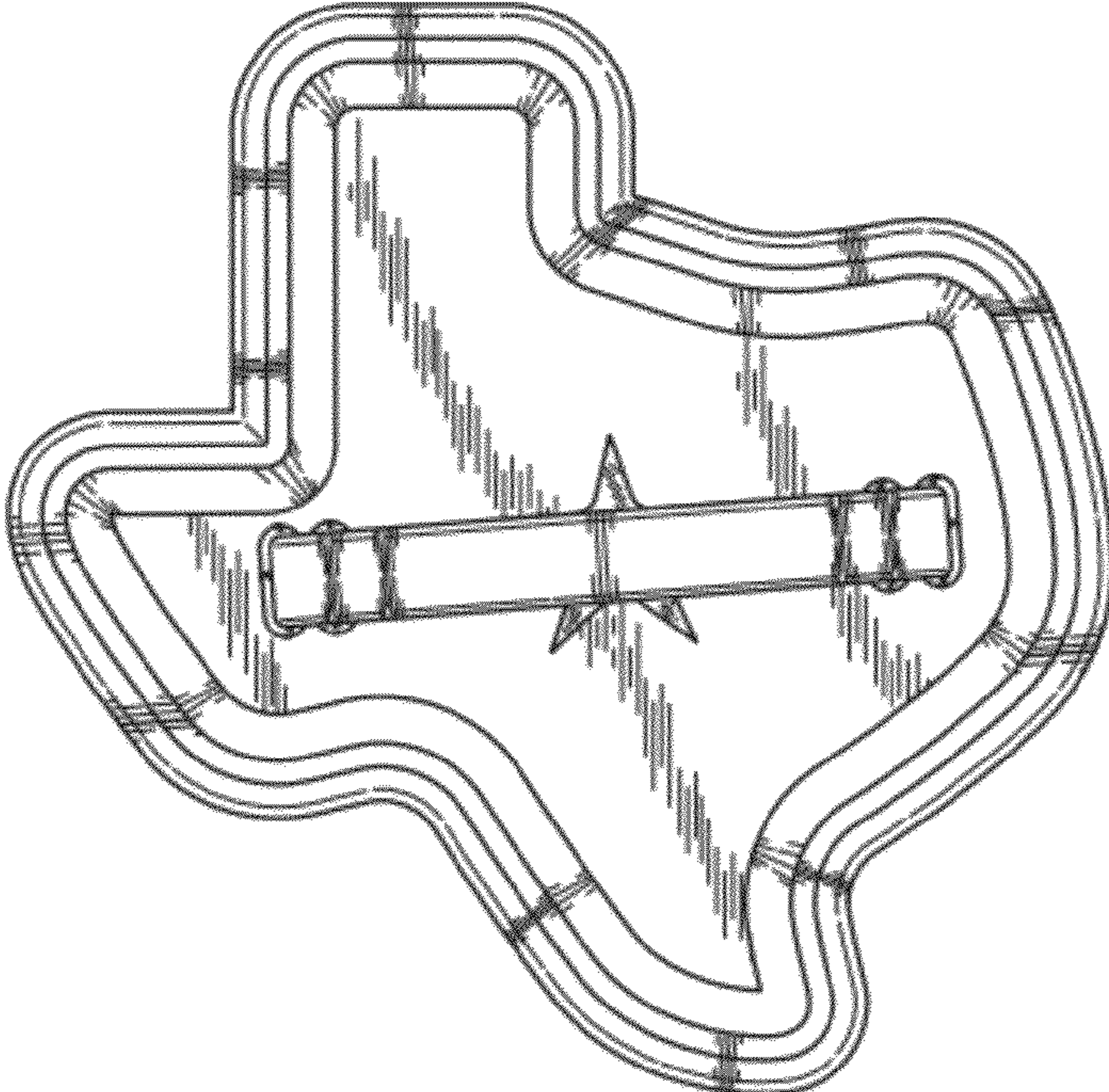

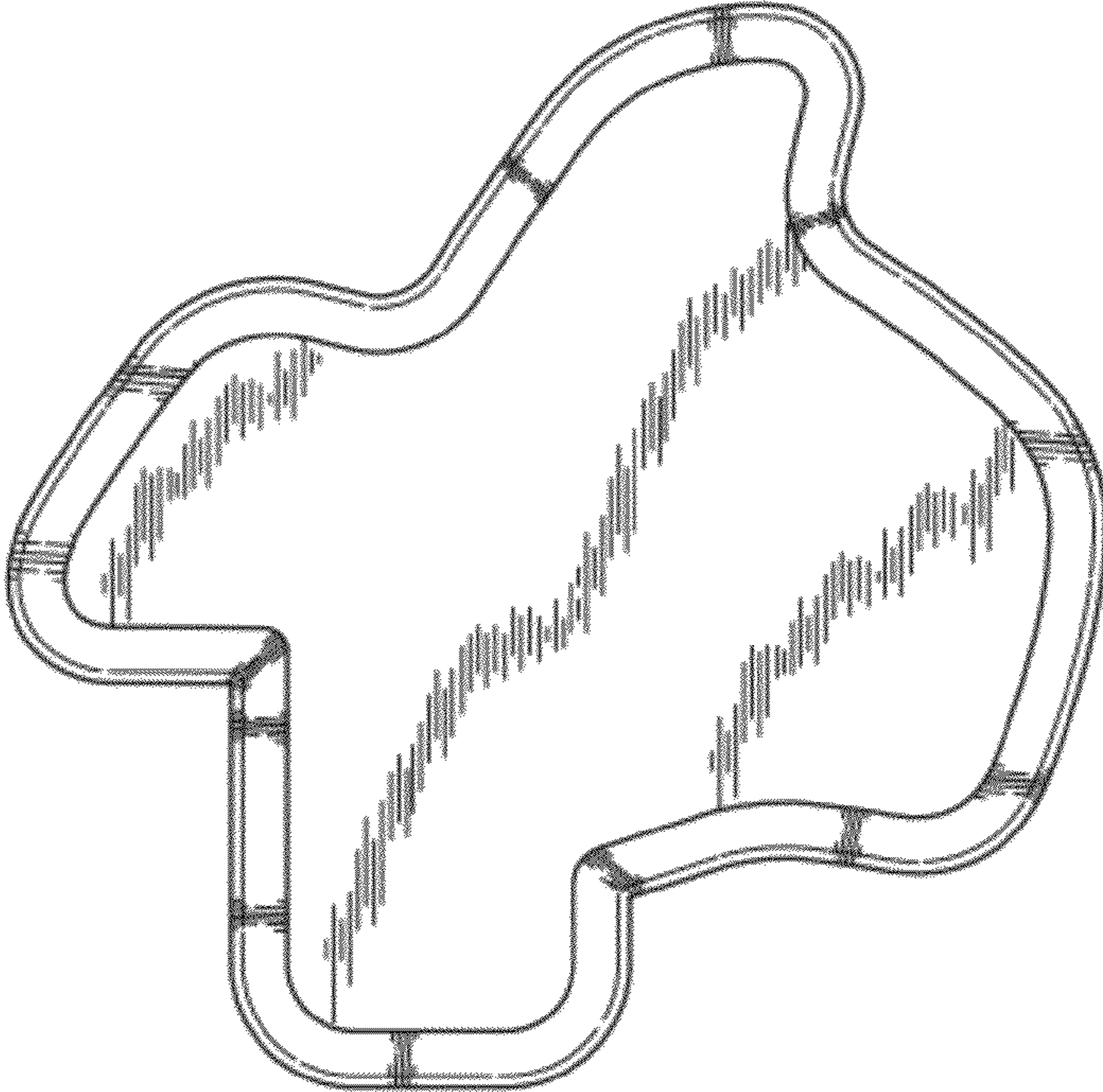

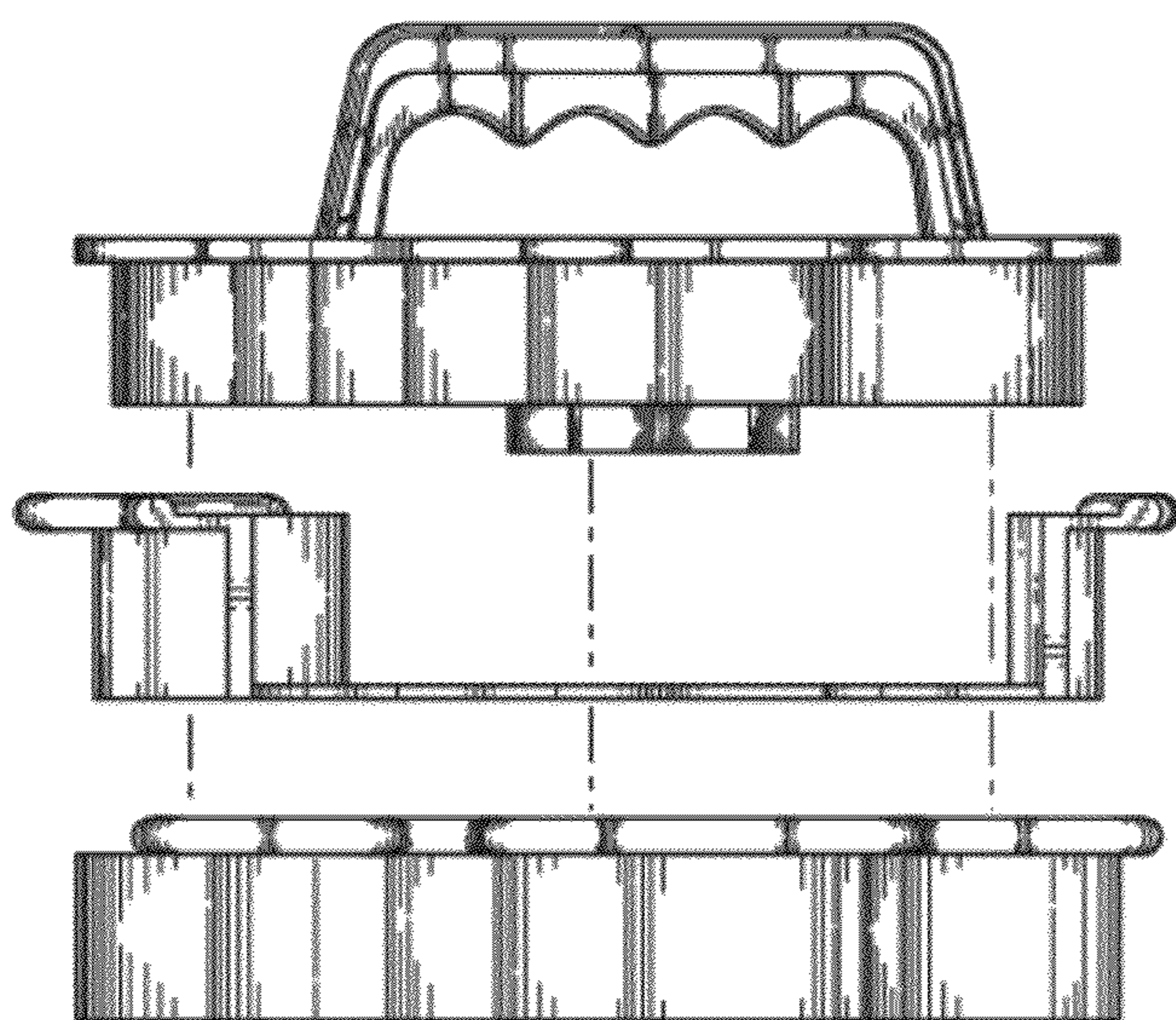

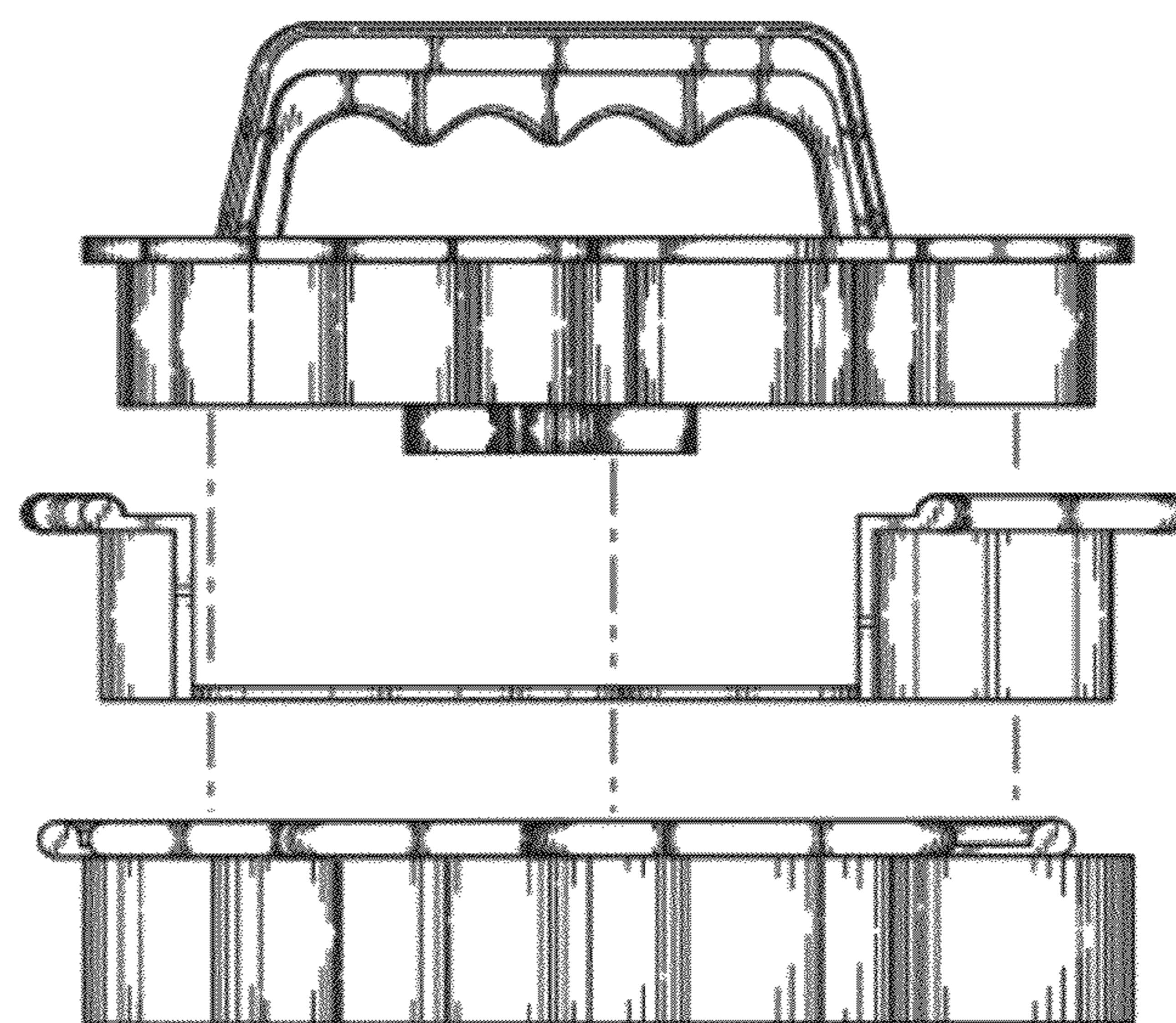

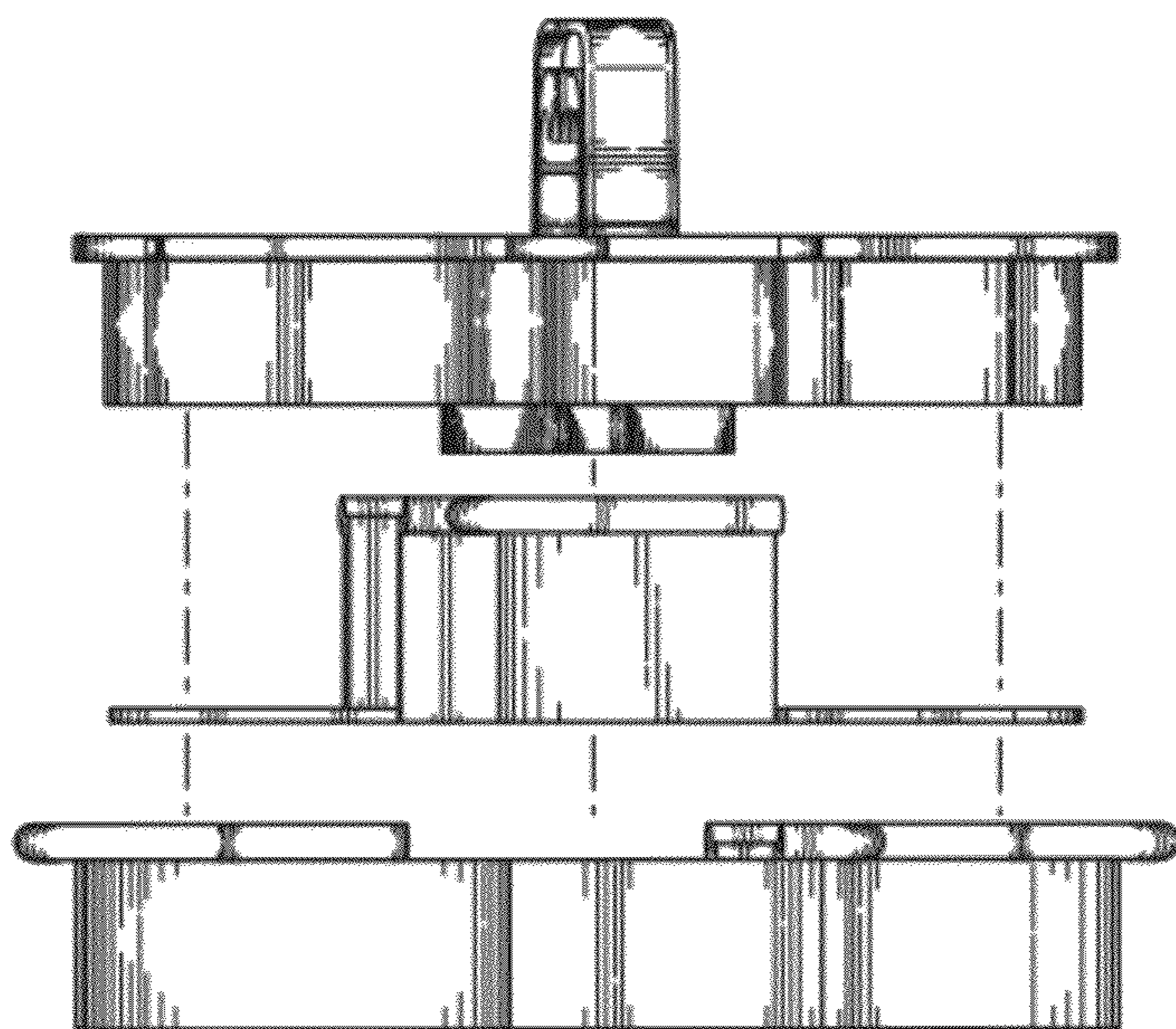

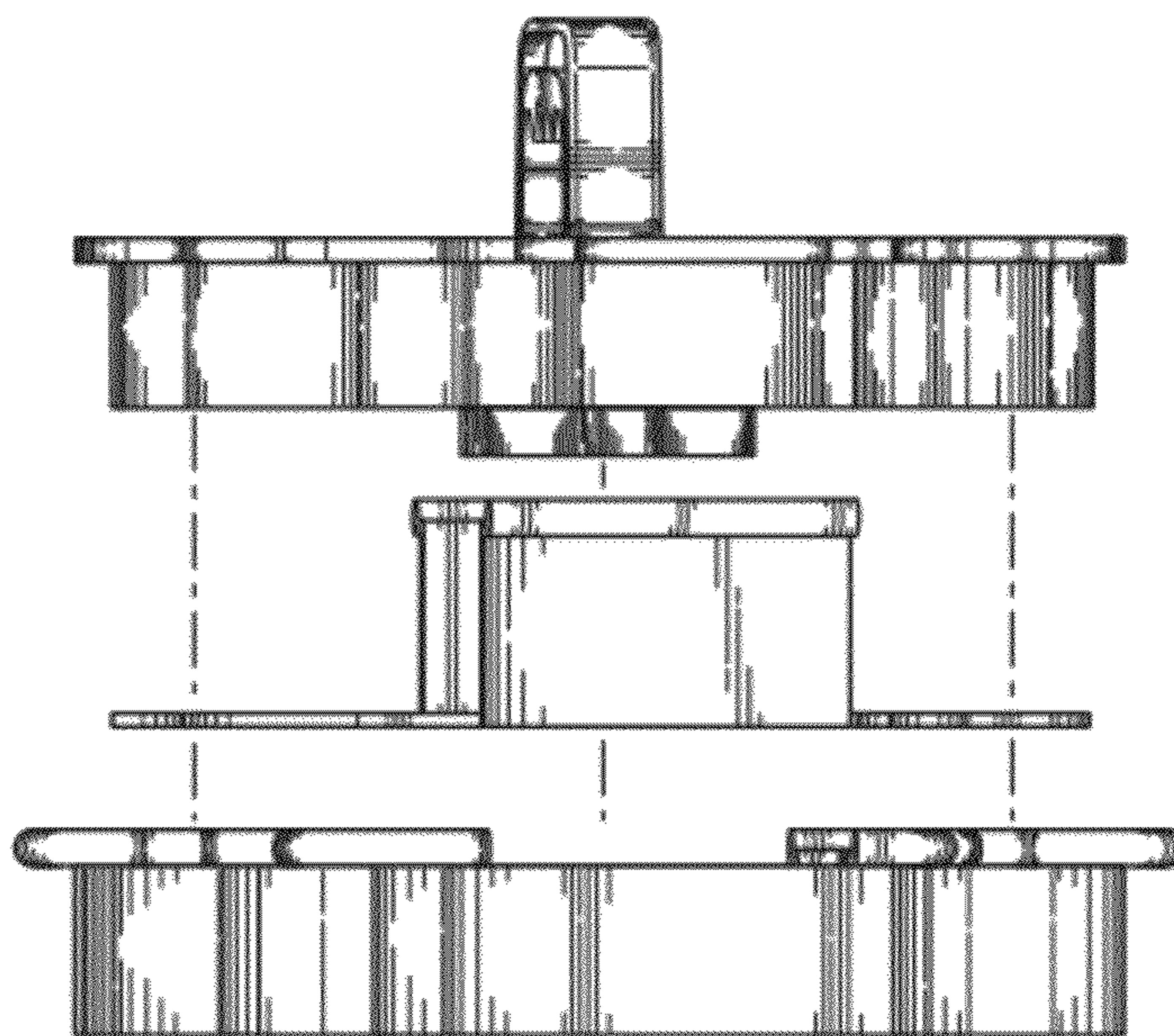
